The ornamental design for a nursing shawl, as shown and described.

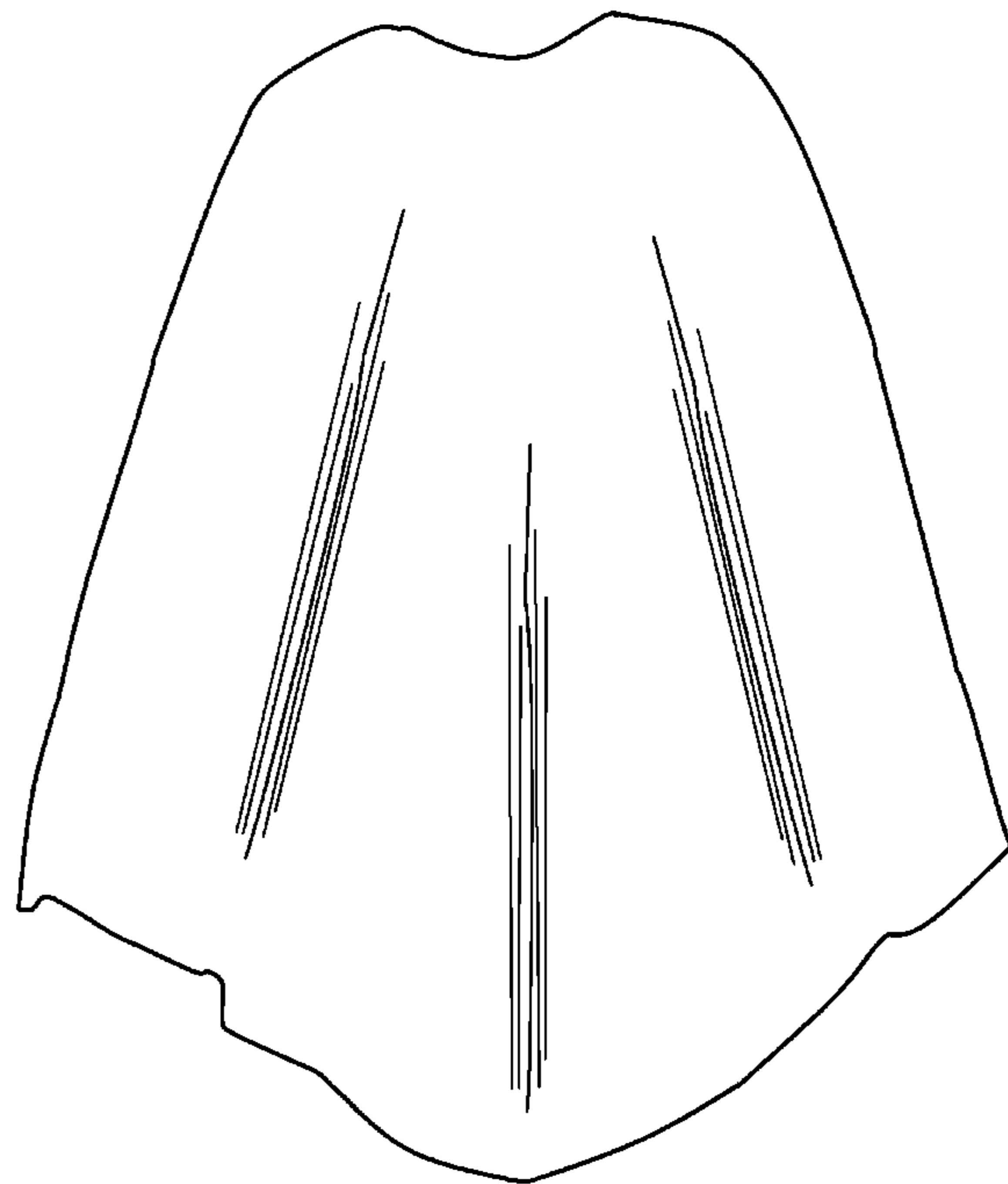
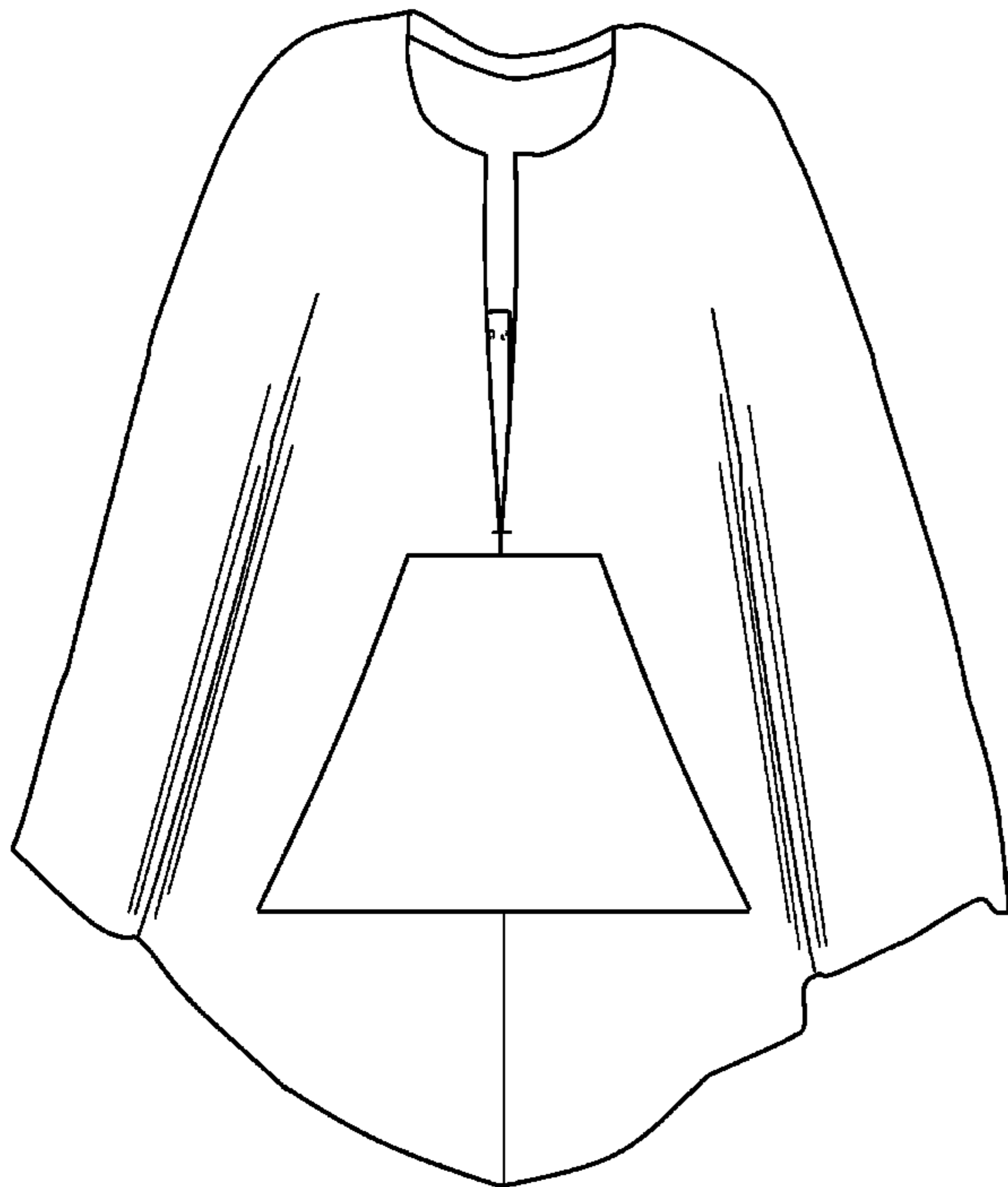
**DESCRIPTION**

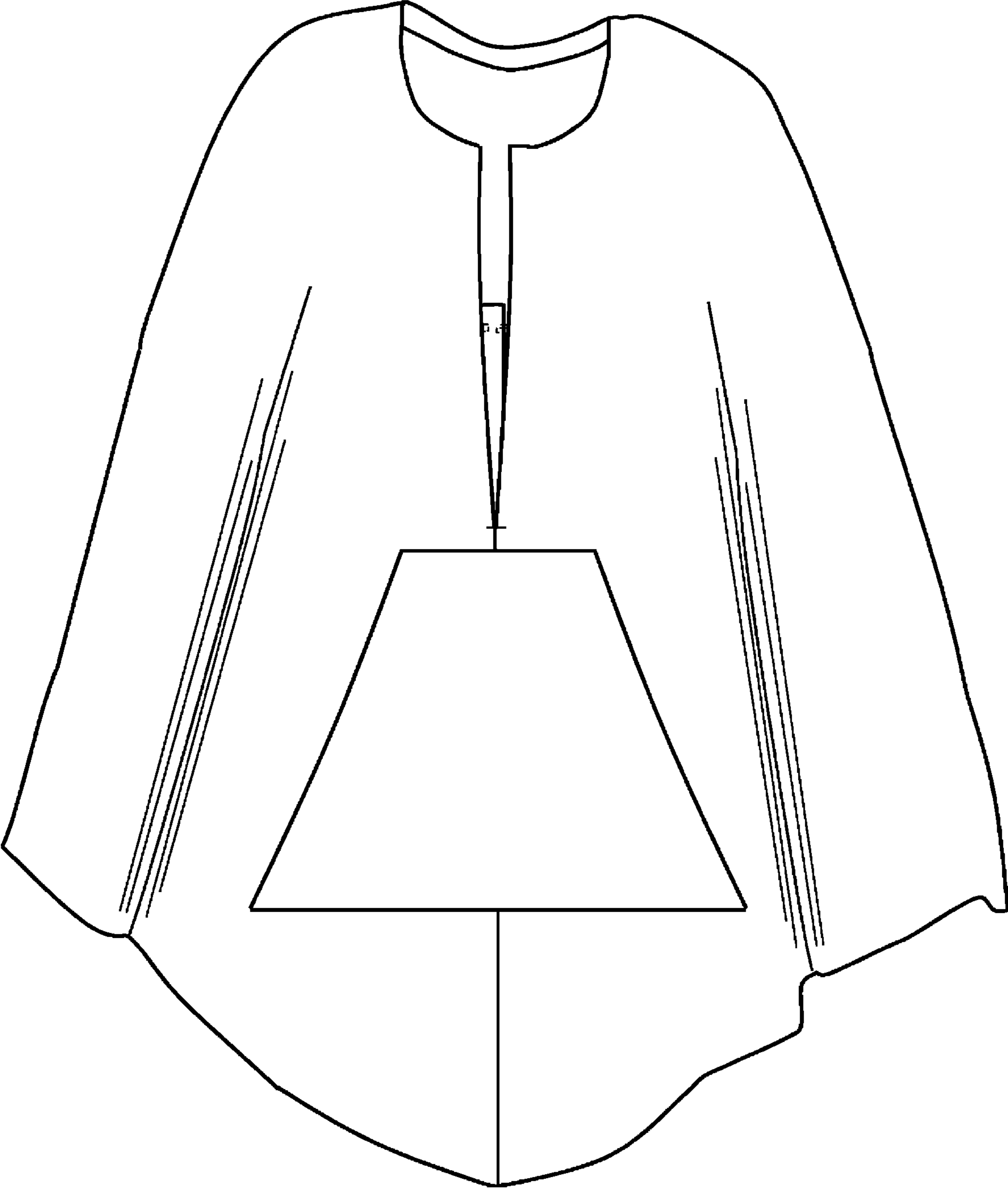

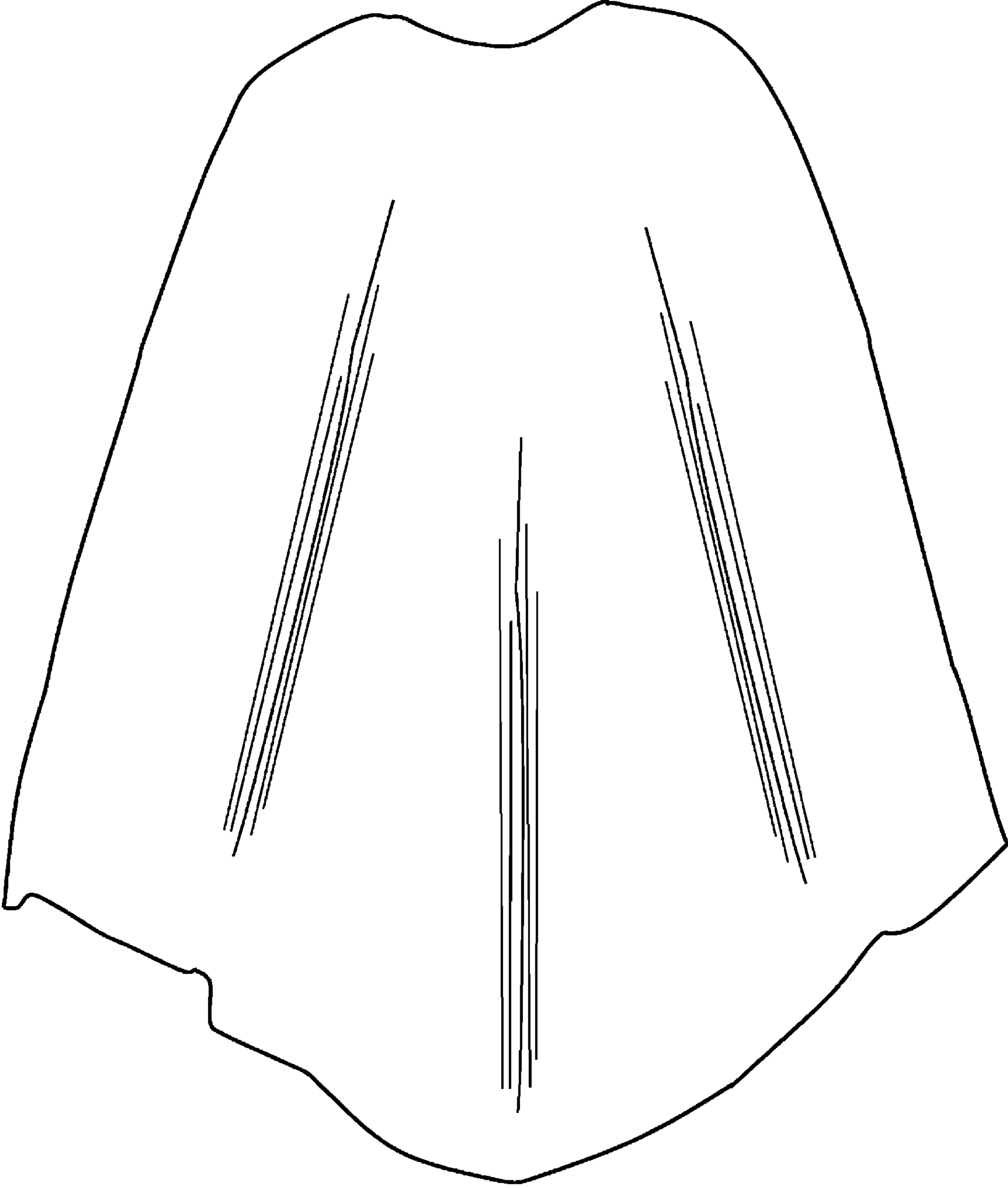
