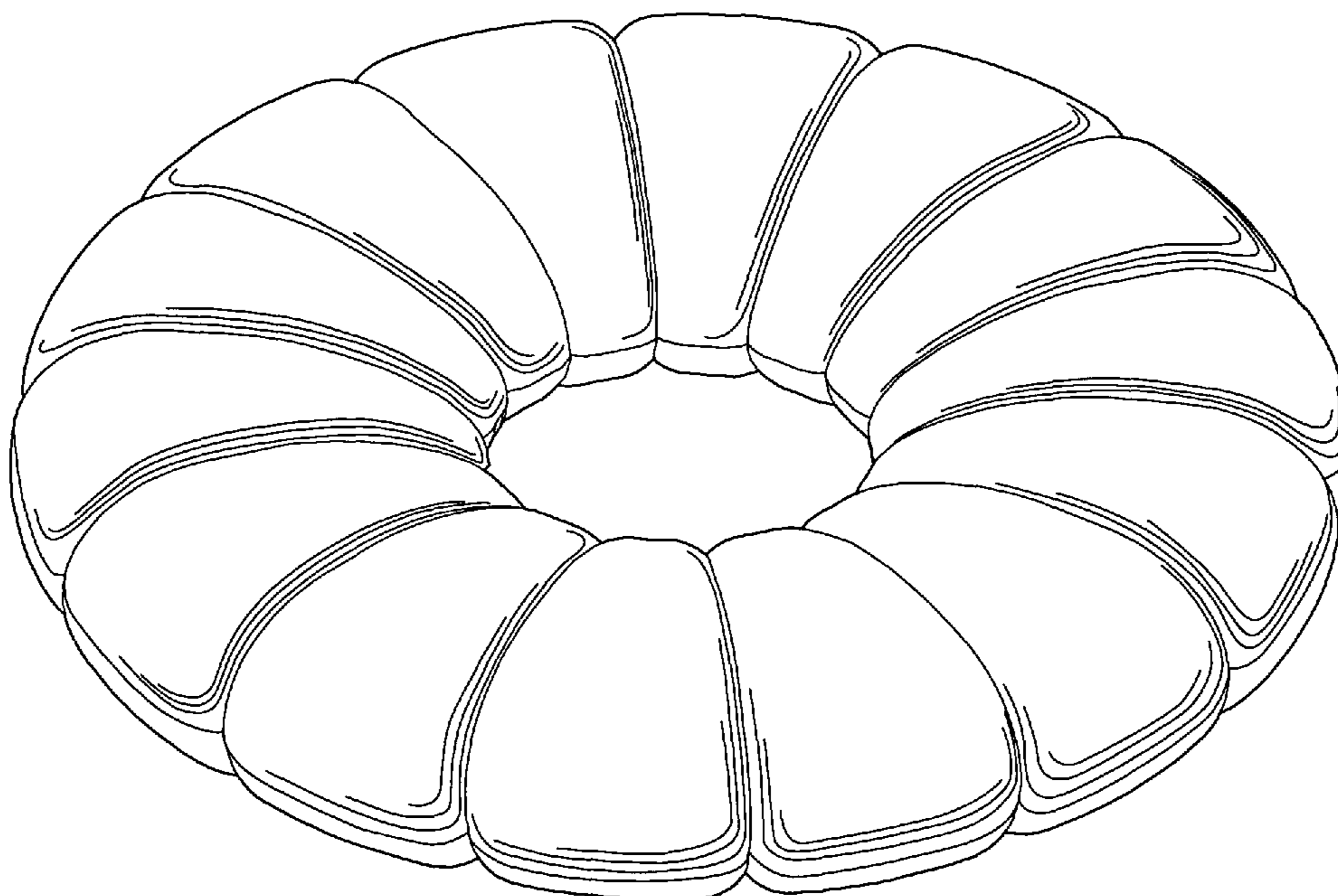
FIG. 1 is a perspective view of a cushion showing my new design;

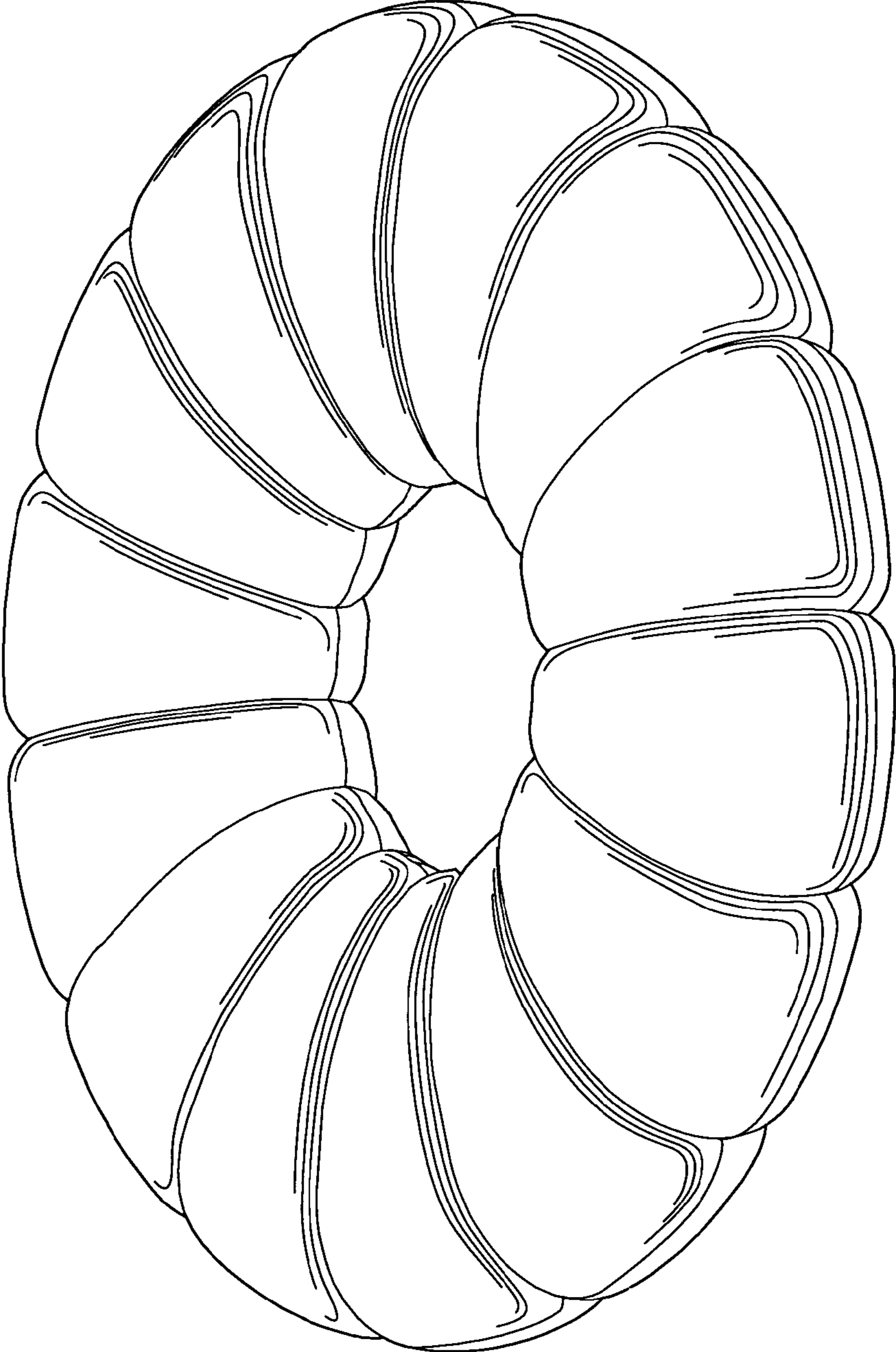

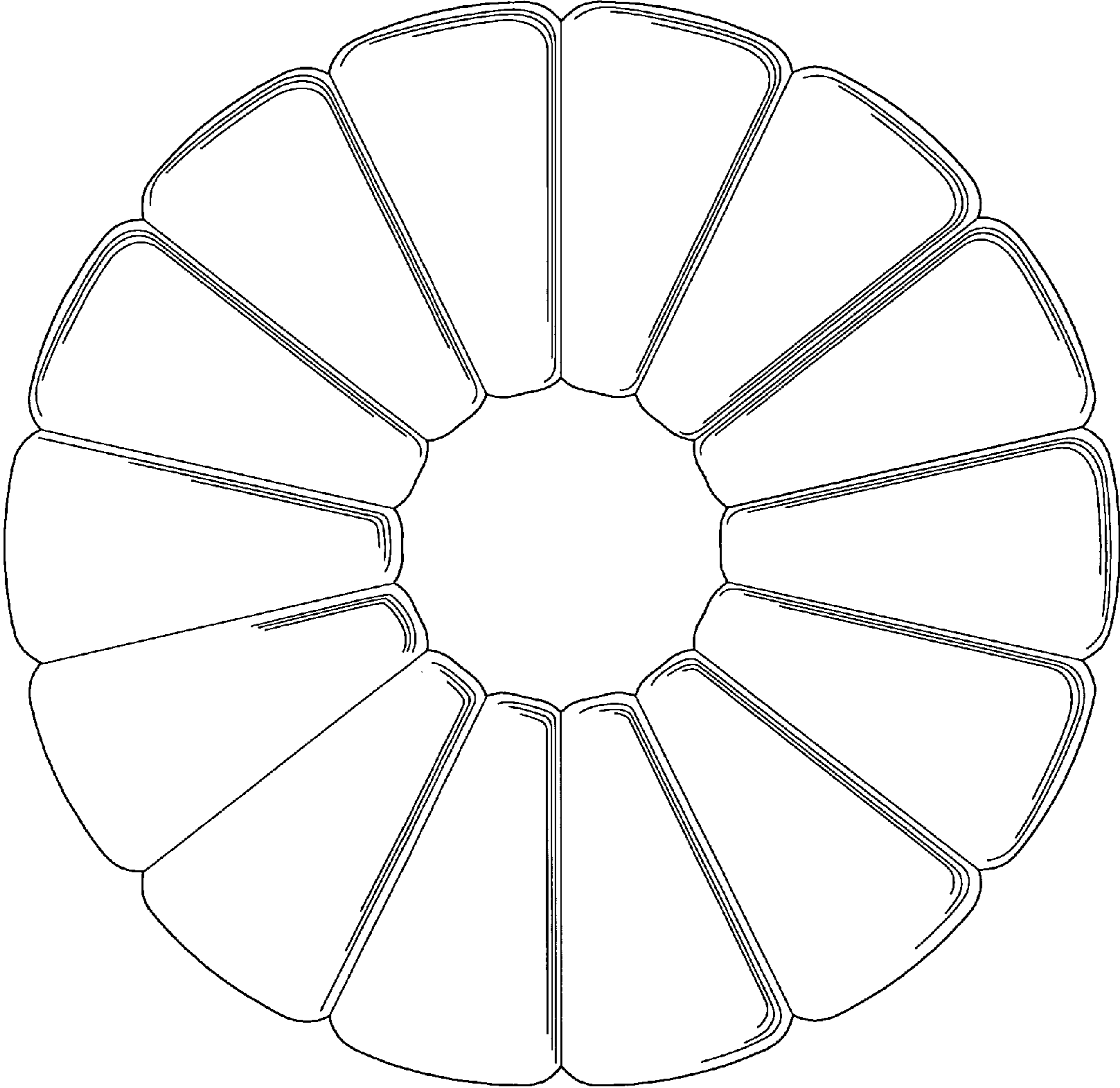

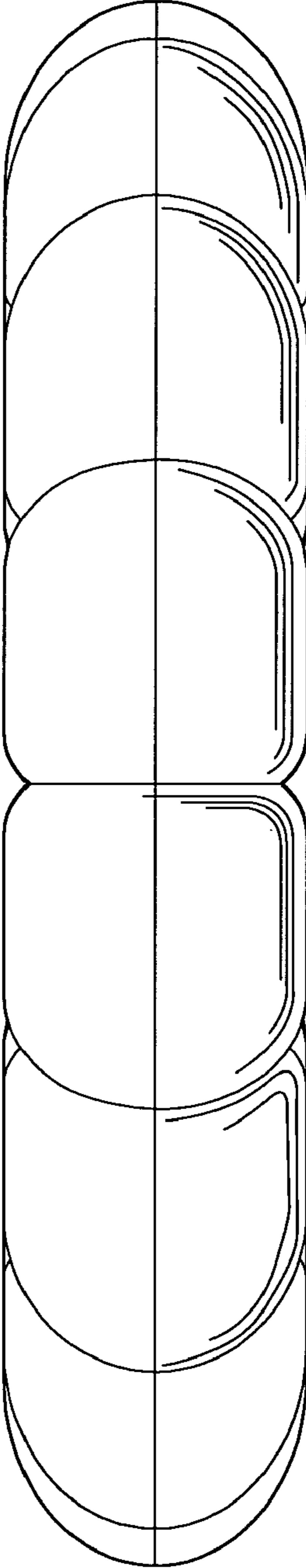

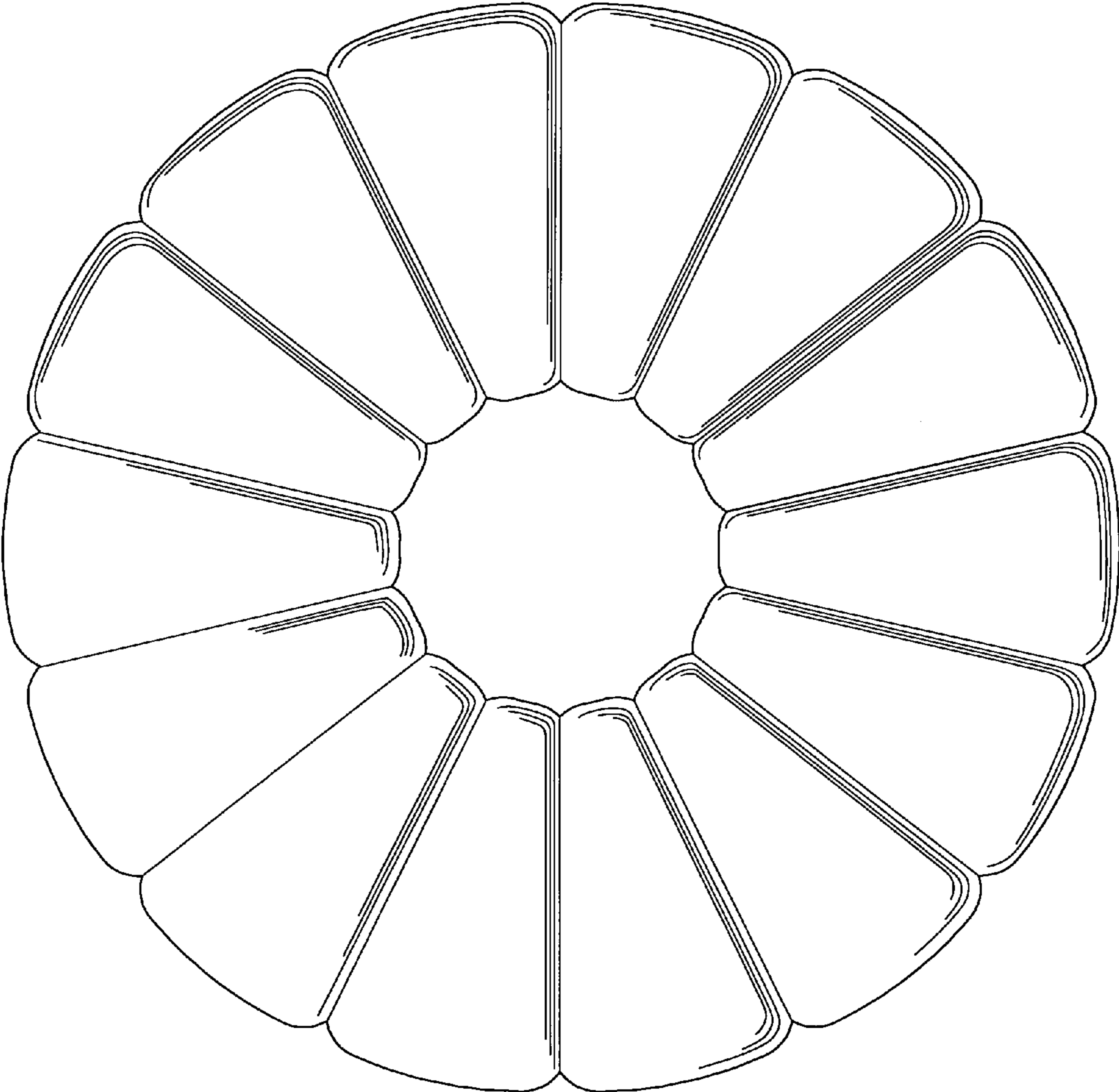
