FIG. 4 is a right side view thereof.

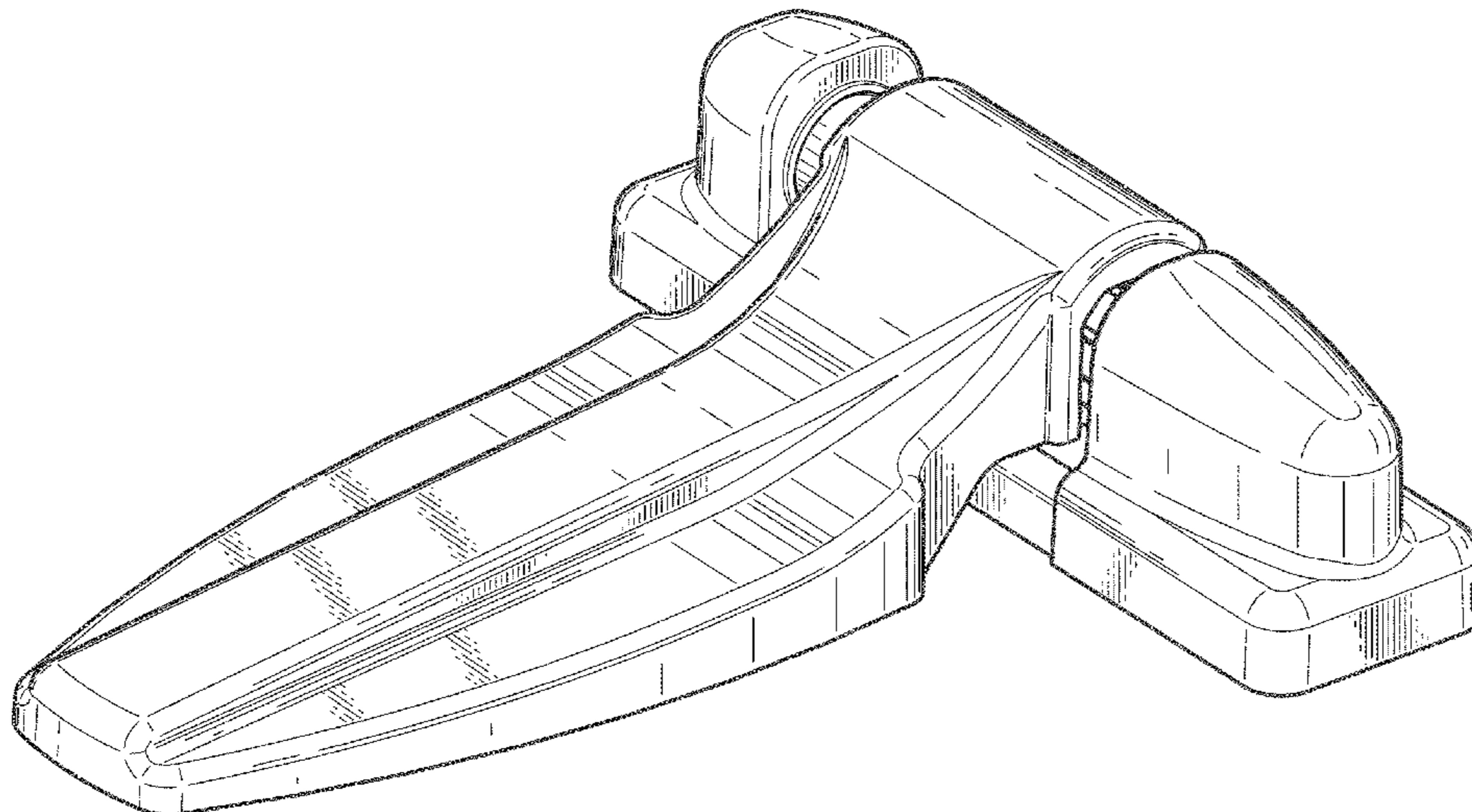
FIG. 5 is a top view thereof.

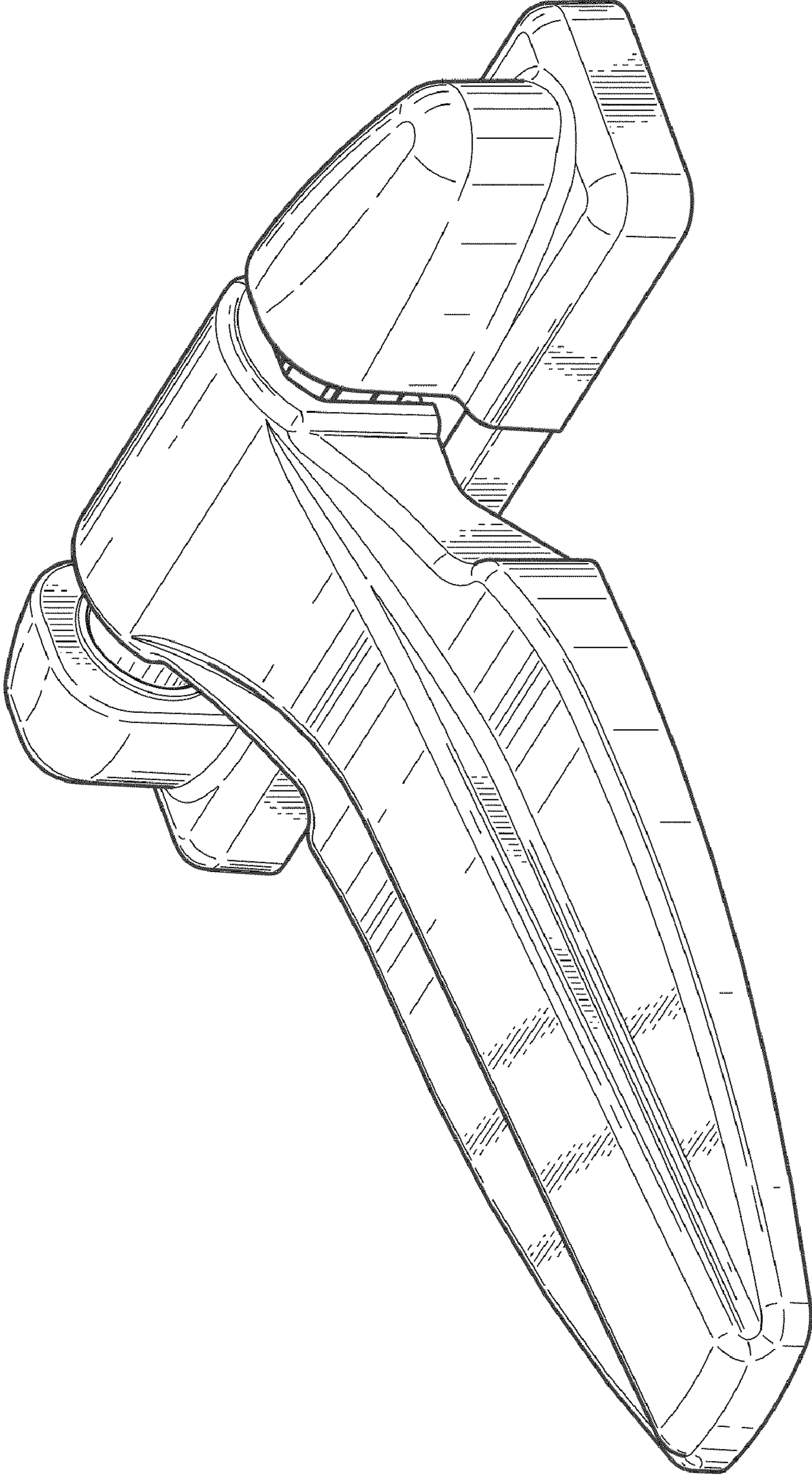
FIG. 6 is a bottom view thereof; and,

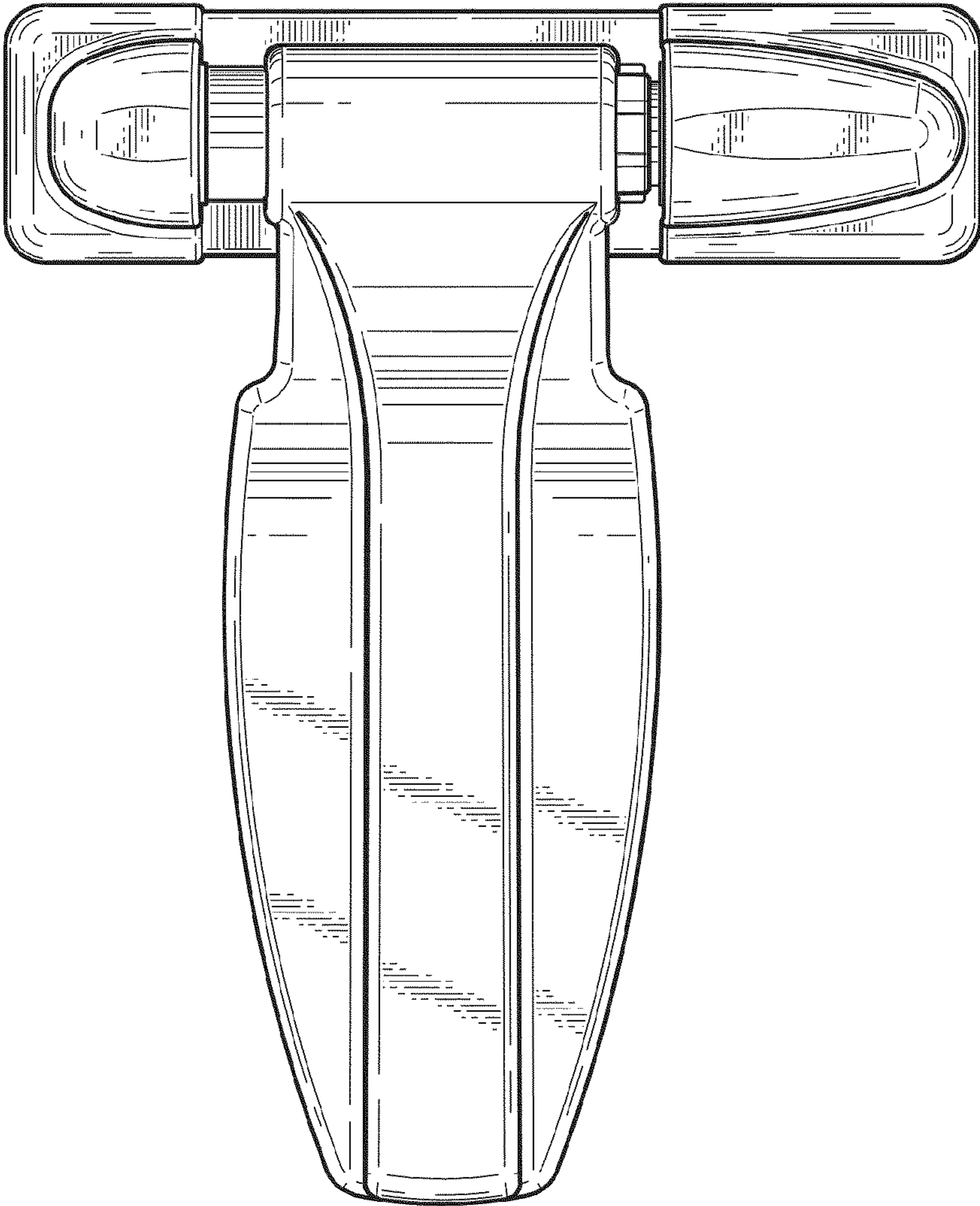

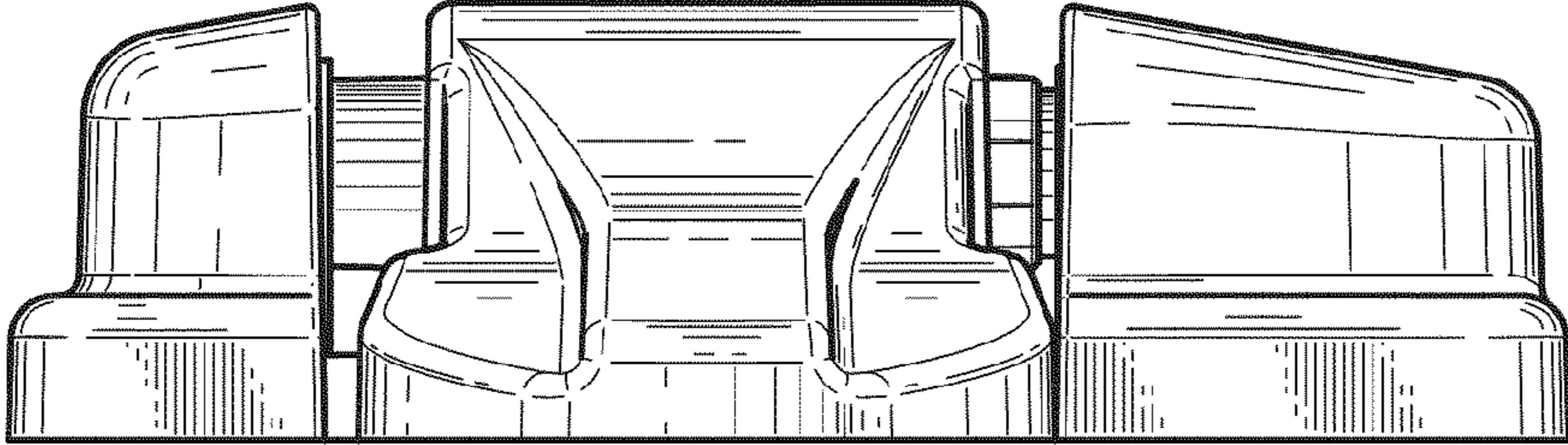

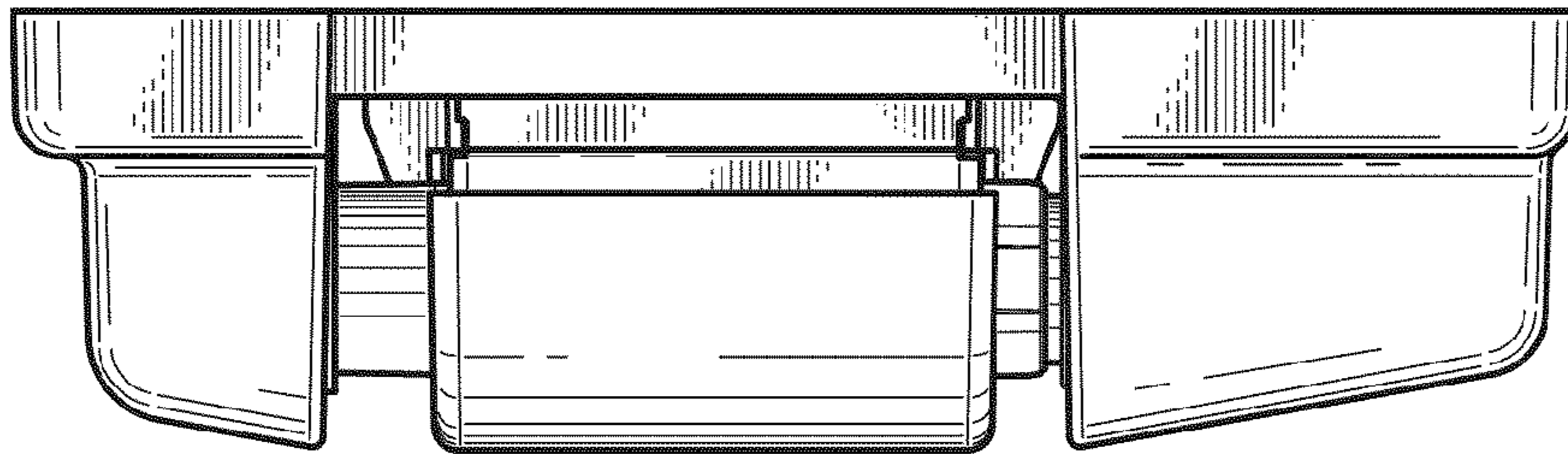

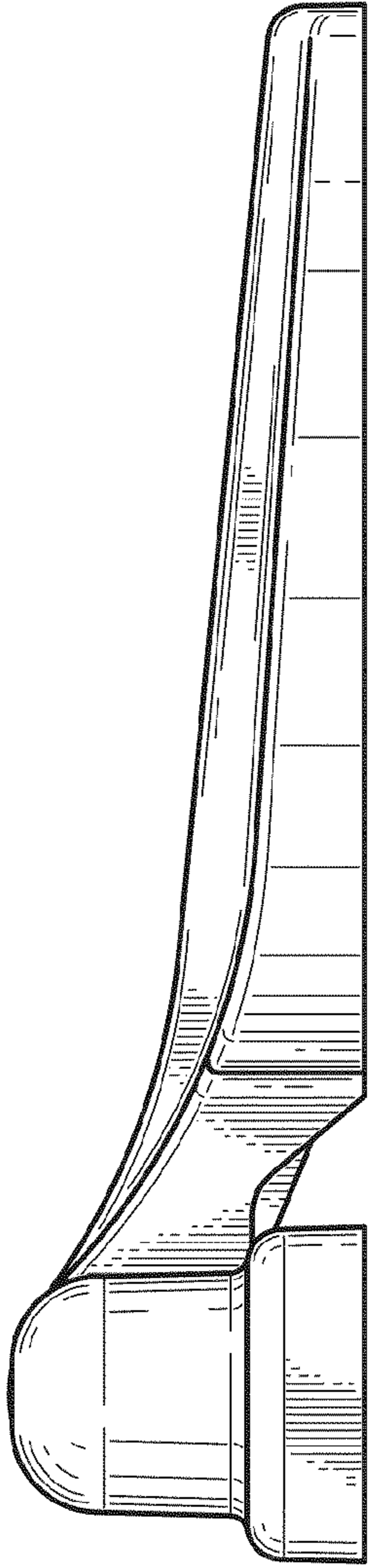

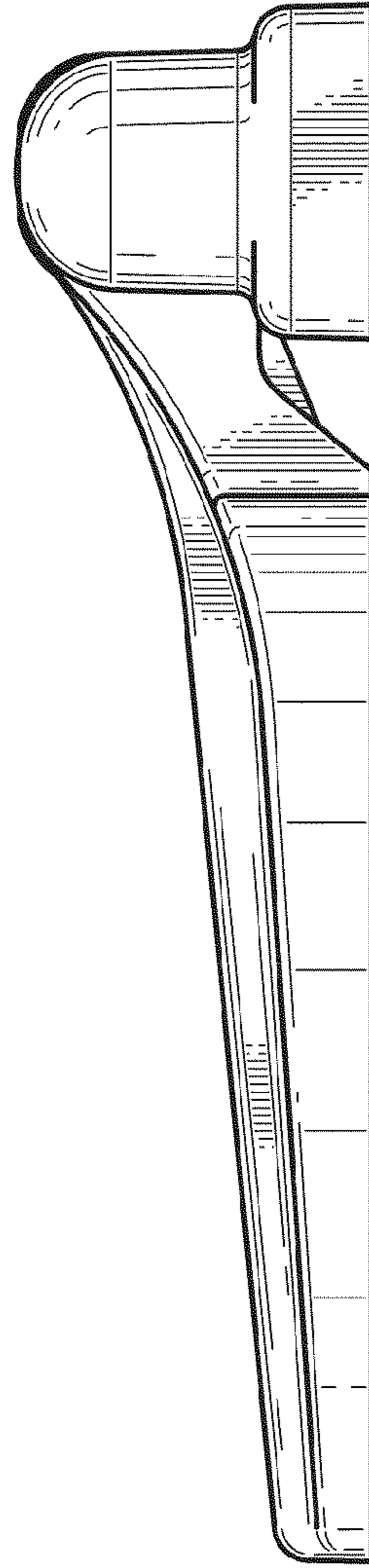
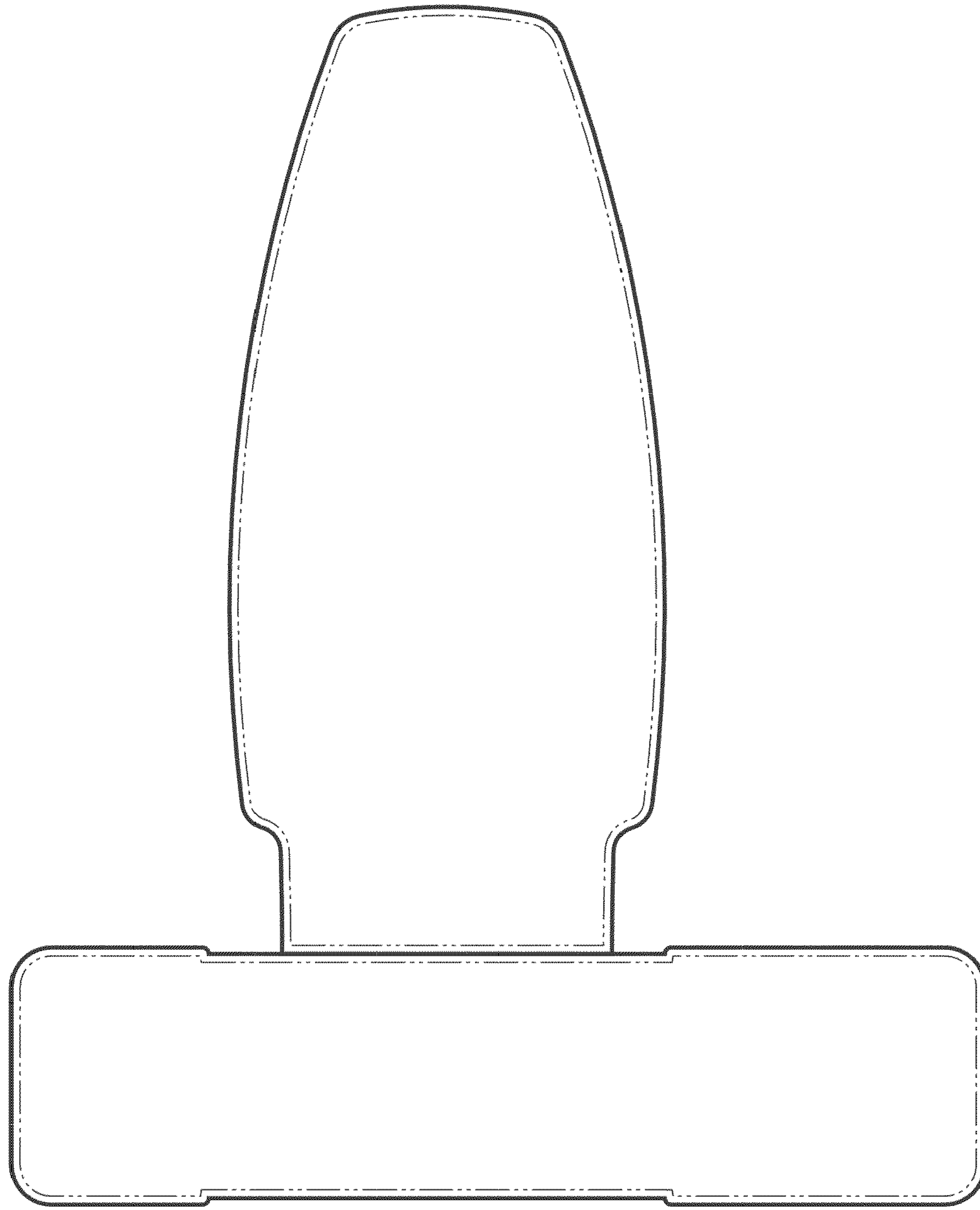
