The ornamental design for a cigarette packaging, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a cigarette packaging showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

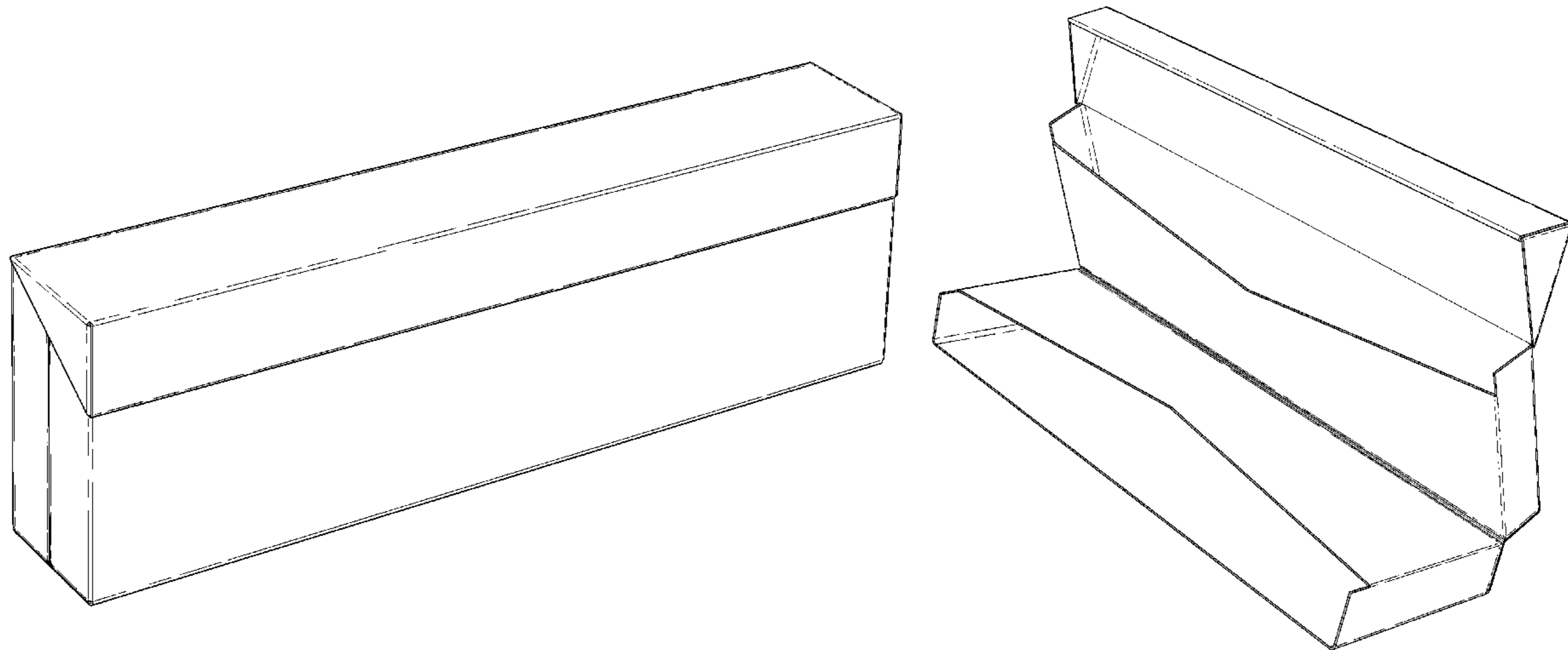
FIG. 4 is a top plan view thereof;

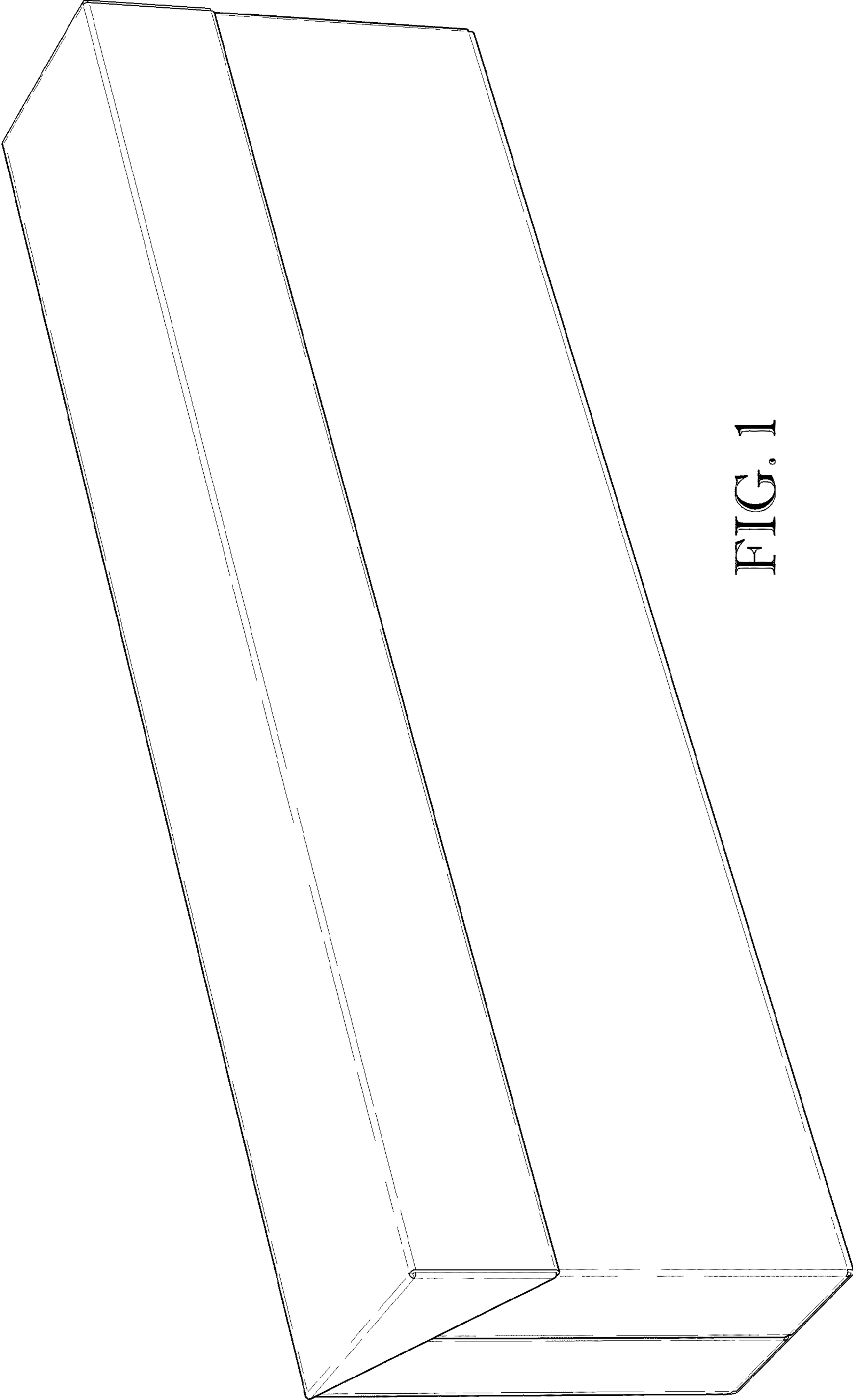

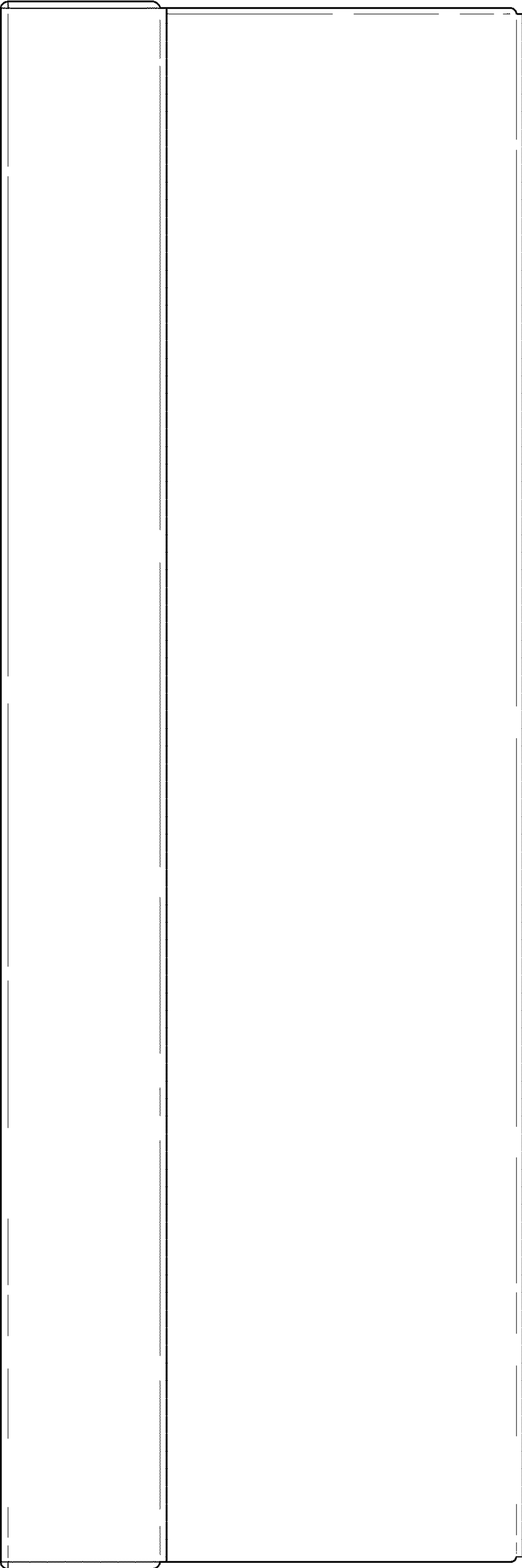

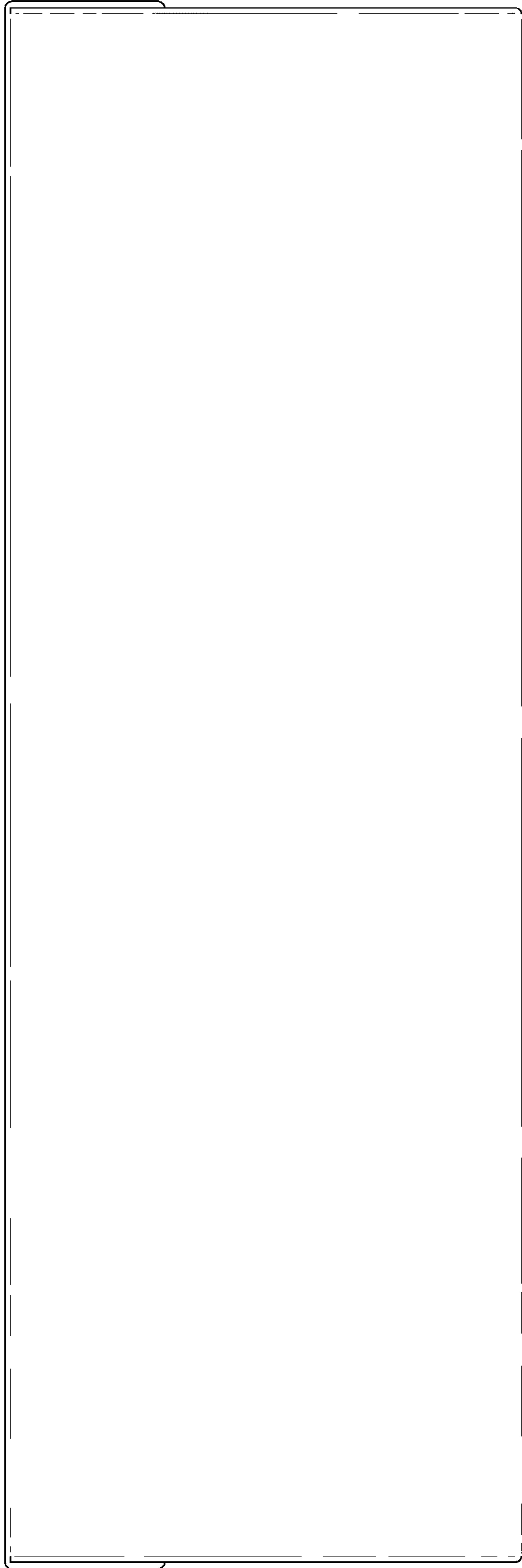

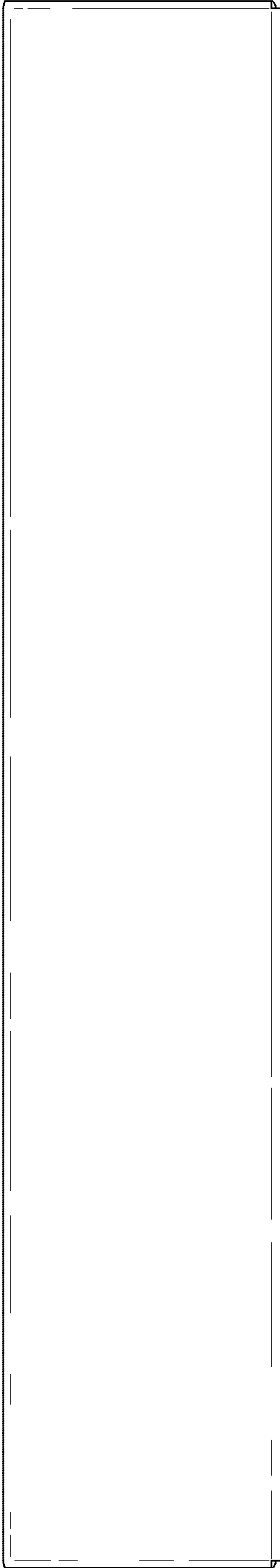

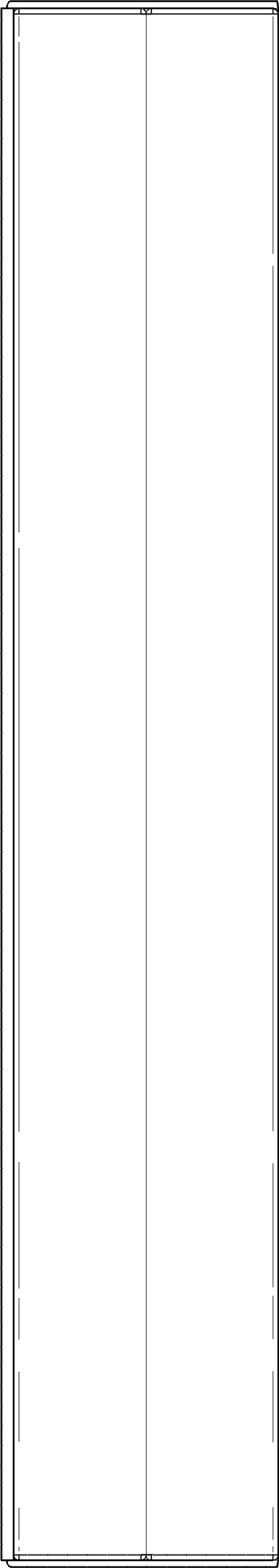

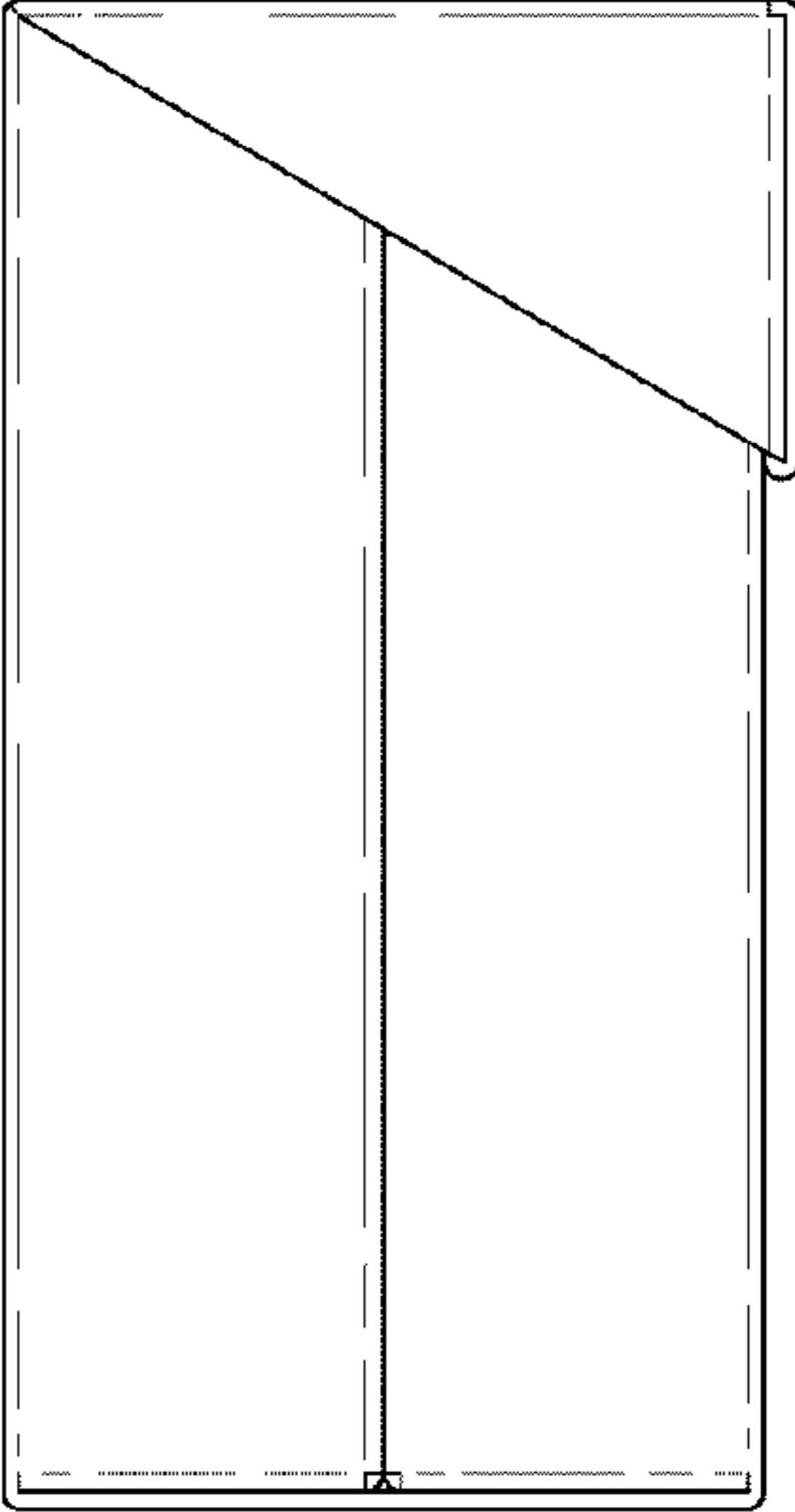
