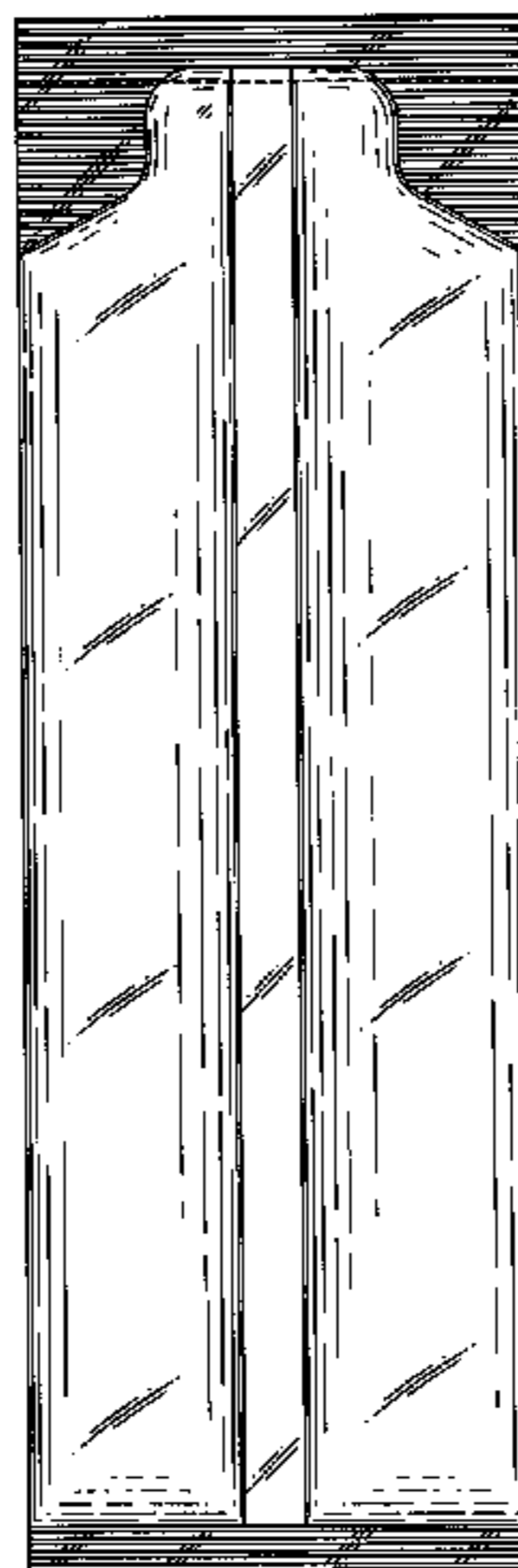
(57) **CLAIM**

The ornamental design for a dual pack wrapper, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment of a dual pack wrapper;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a front elevational view of a second embodiment of a dual pack wrapper;
FIG. 8 is a rear elevational view thereof;
FIG. 9 is a left side elevational view thereof;
FIG. 10 is a right side elevational view thereof;
FIG. 11 is a top plan view thereof; and,
FIG. 12 is a bottom plan view thereof.
The nature and intended use of the article of manufacture in which the design of the present invention is embodied is a dual pack wrapper, for example, a wrapper including two packs to carry food, or similar items.

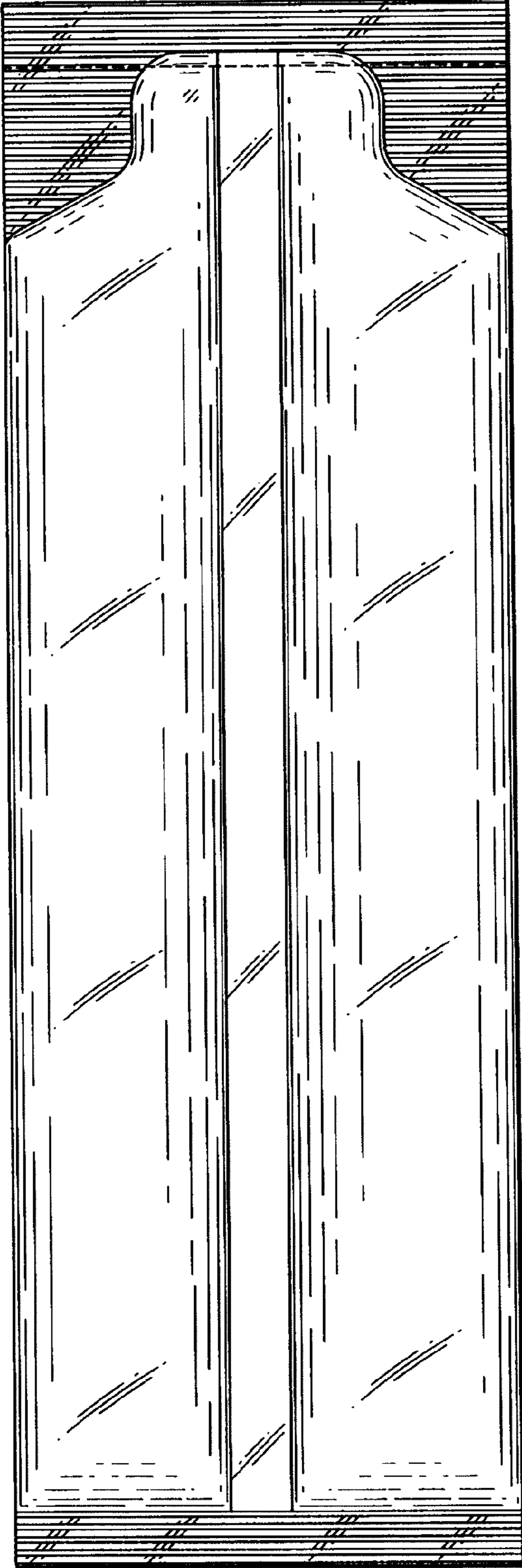

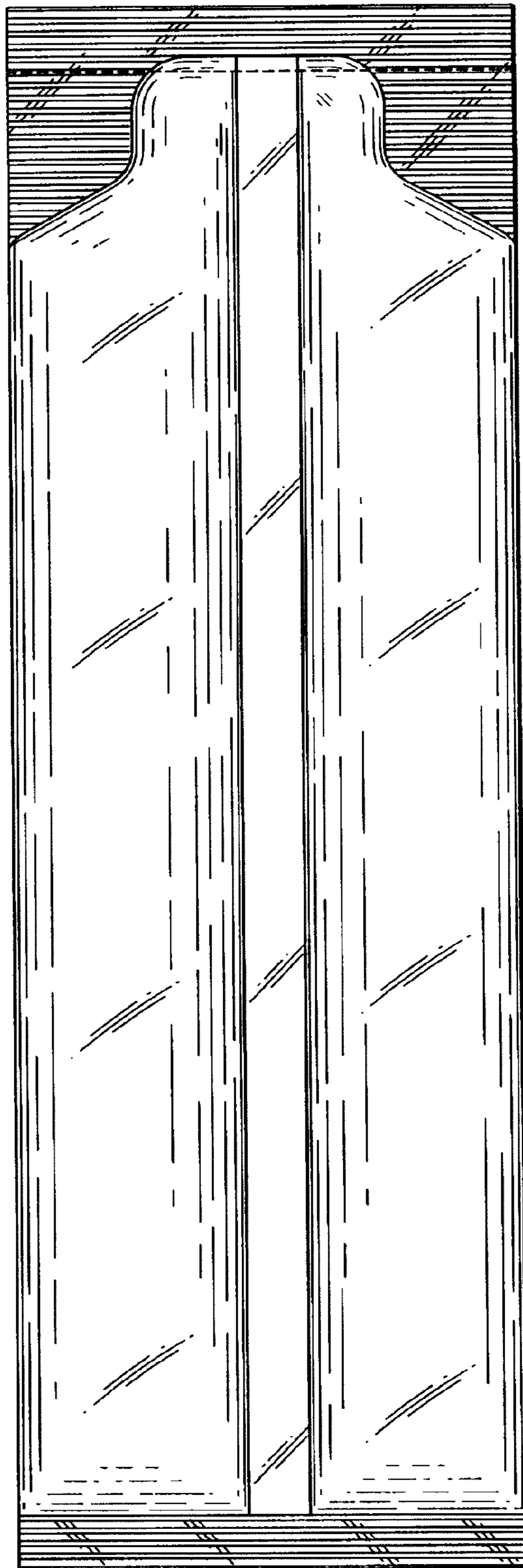

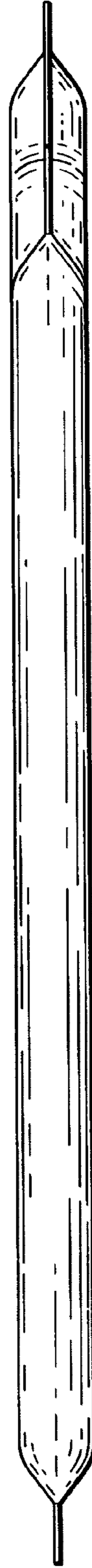

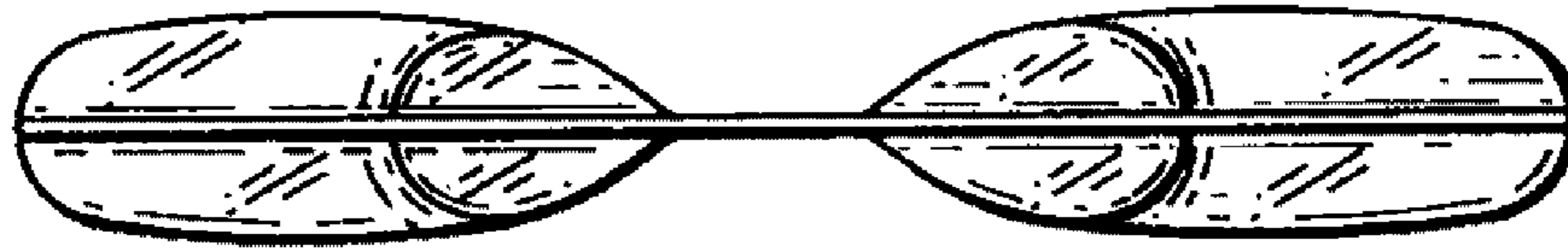

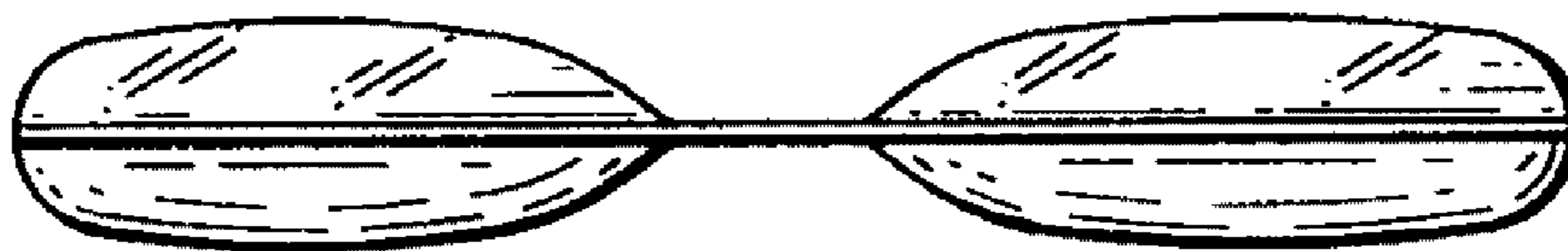

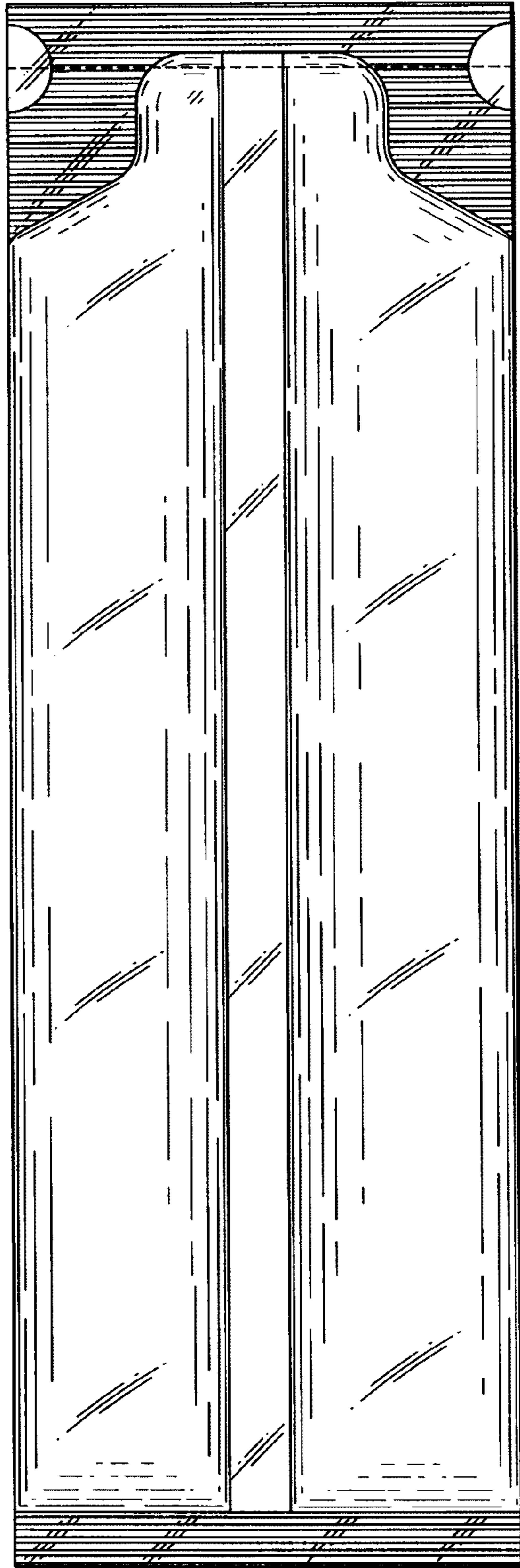

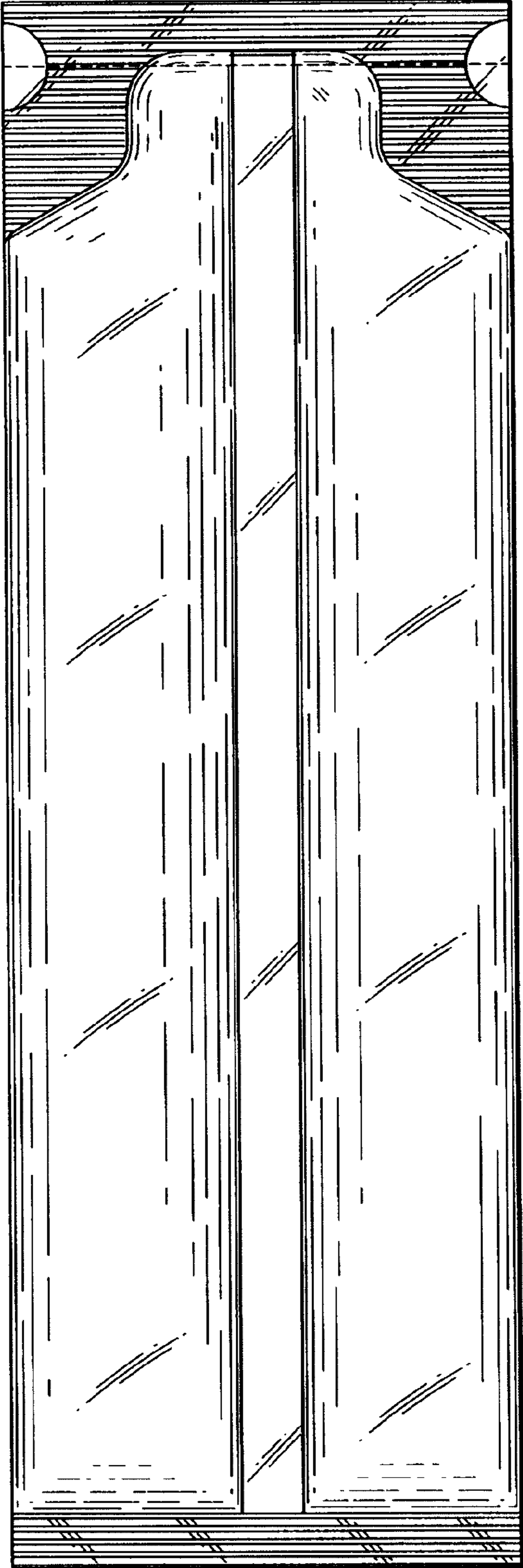

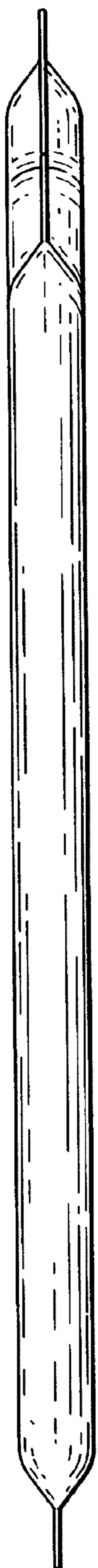

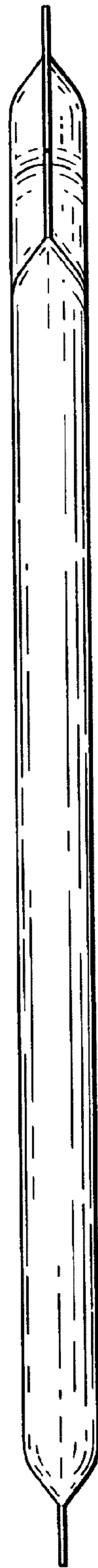

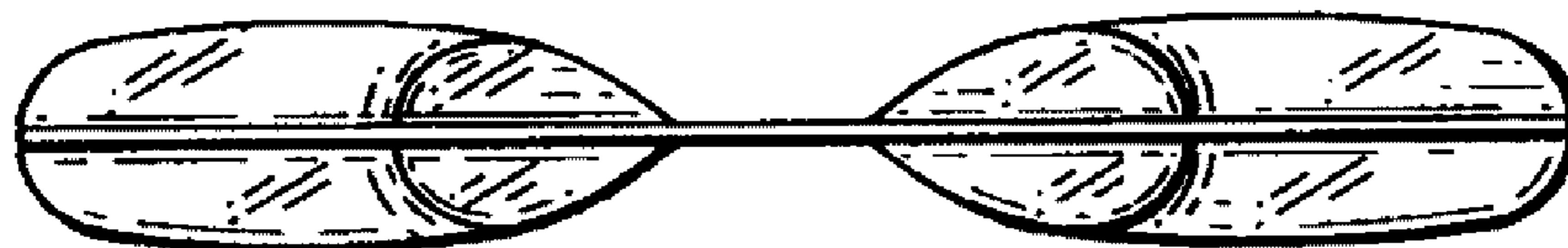

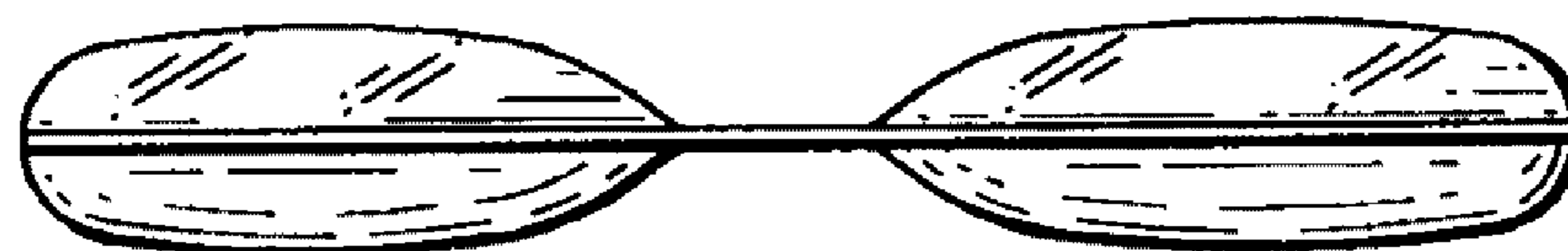
