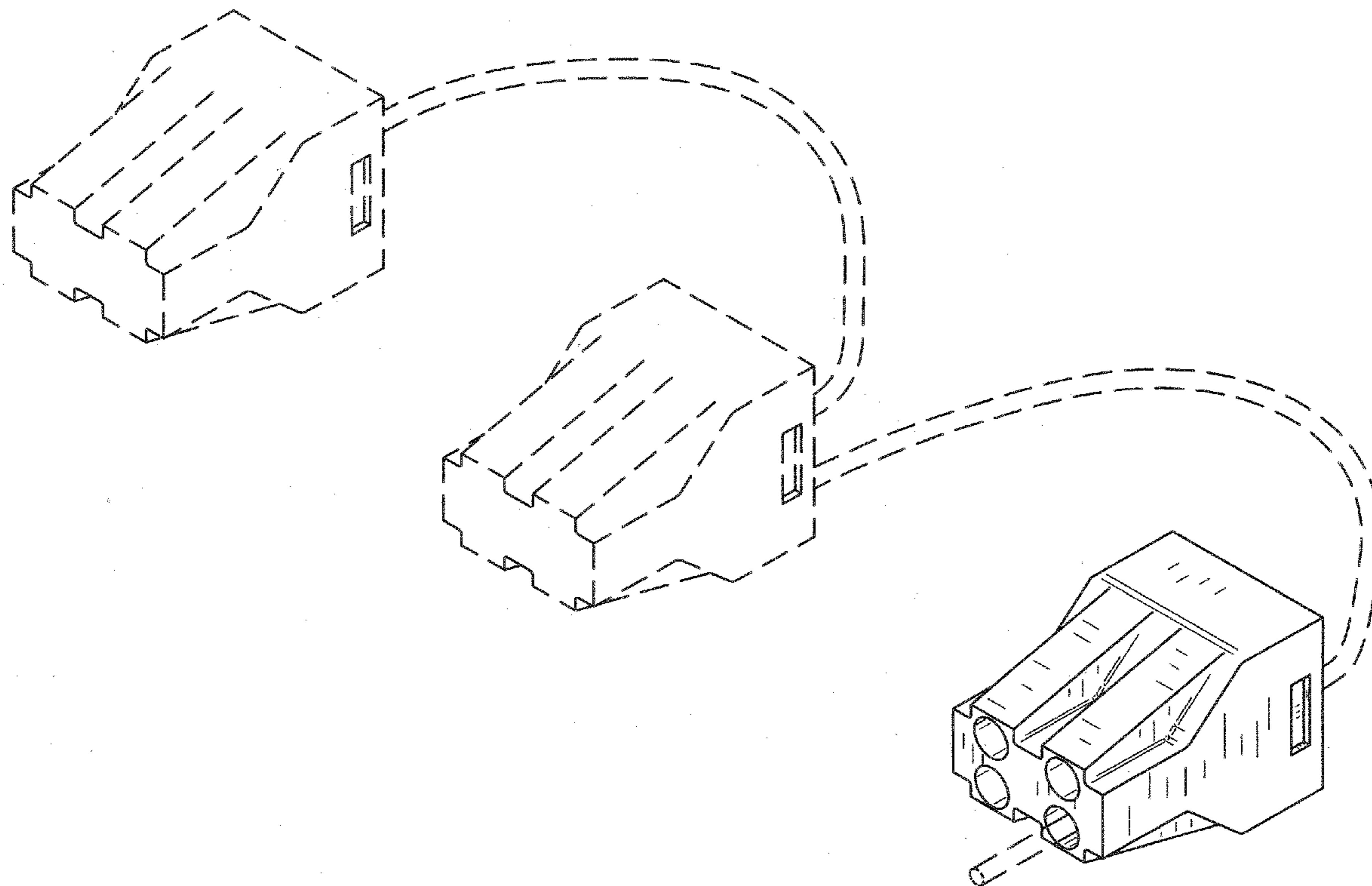
(57) **CLAIM**

The ornamental design for a grounding port connector with through hole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a grounding port connector with through hole showing my new design; FIG. 2 is a front view thereof; FIG. 3 is a back view thereof; FIG. 4 is a side elevation view thereof, the opposite side elevation view is a mirror image thereto; and, FIG. 5 is a top plan view thereof, the bottom plan view is a mirror image thereto. The broken lines shown in FIG. 1 are included for the purpose of illustrating environment and form no part of the claim.

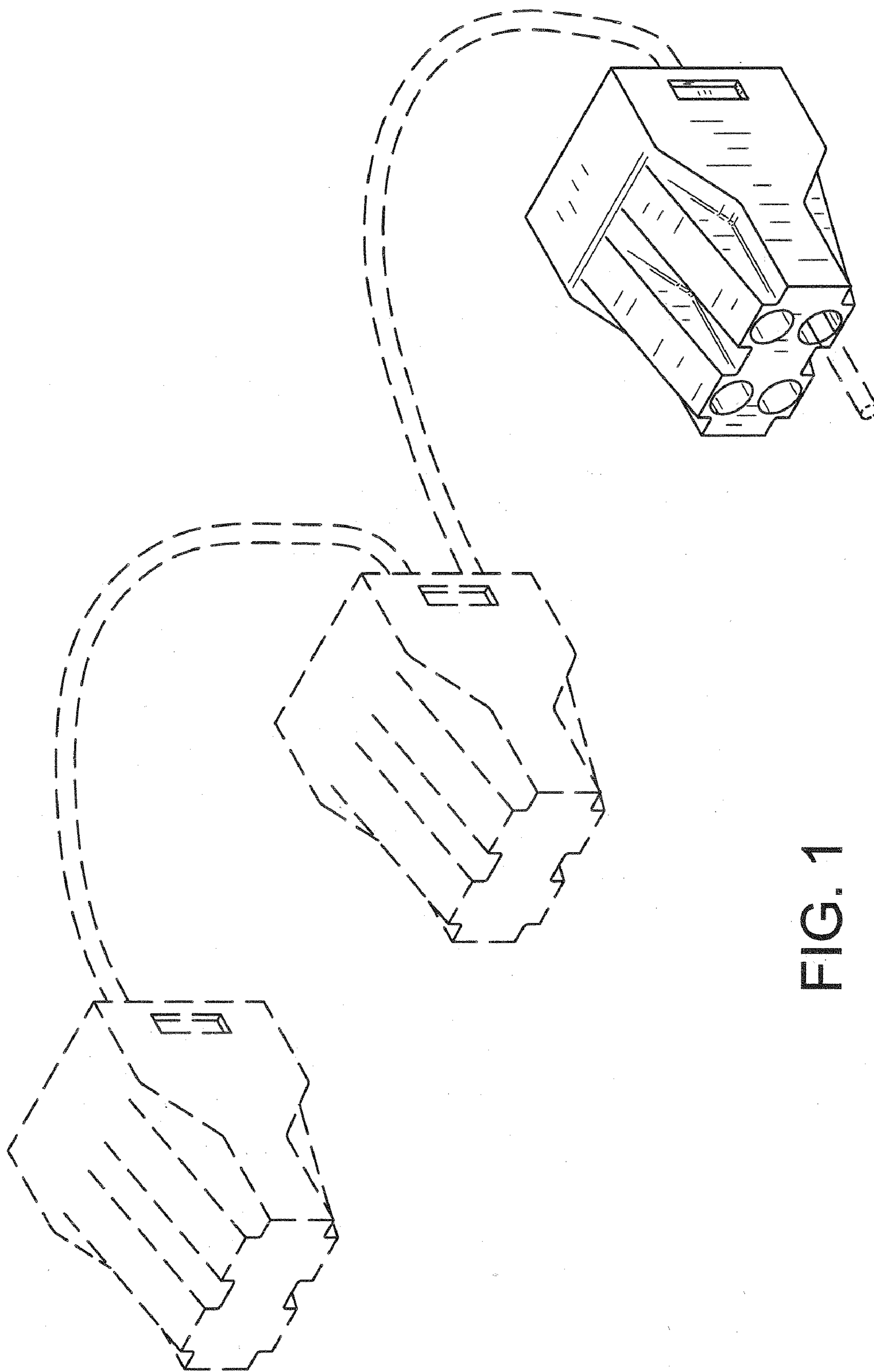

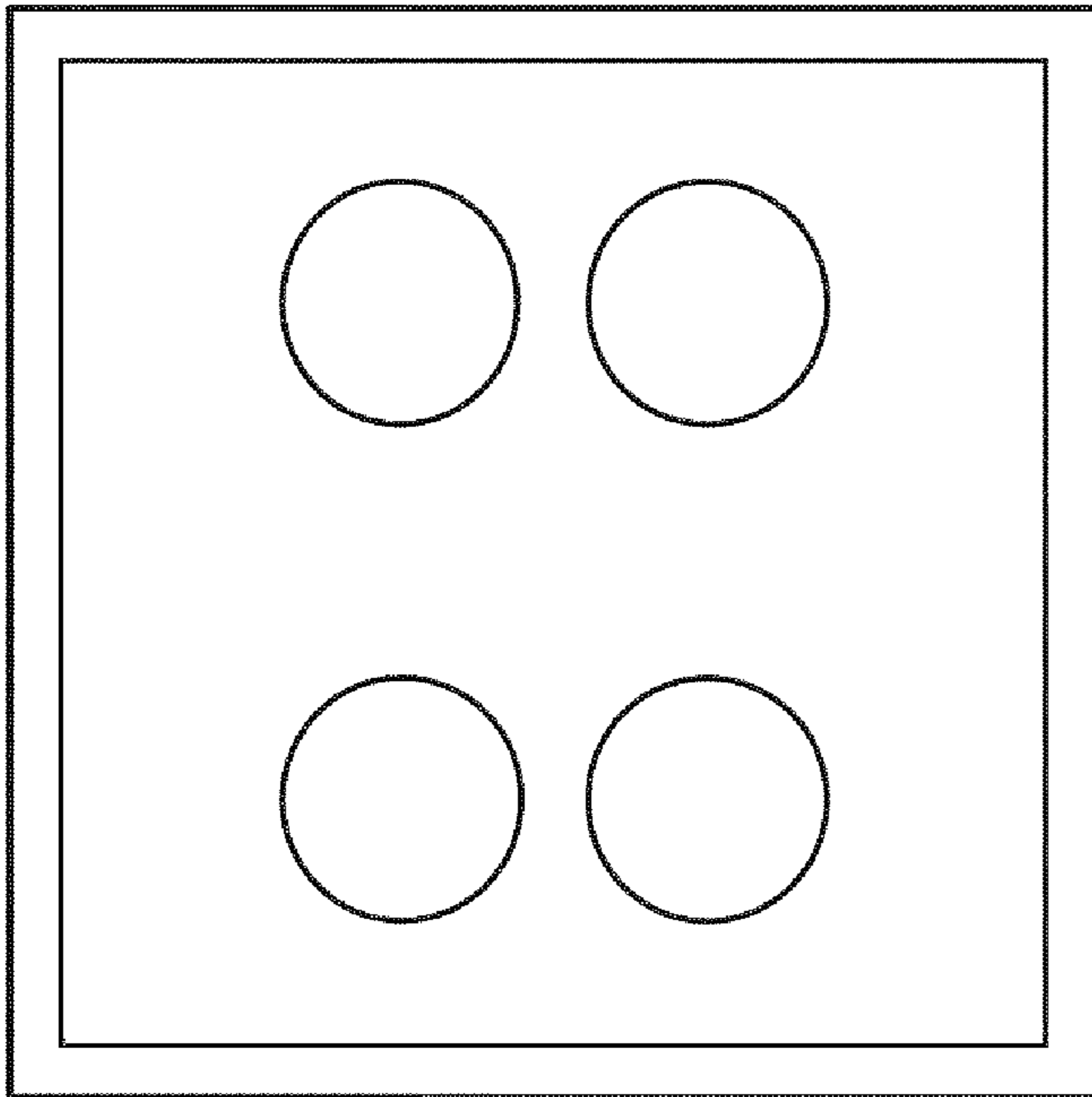

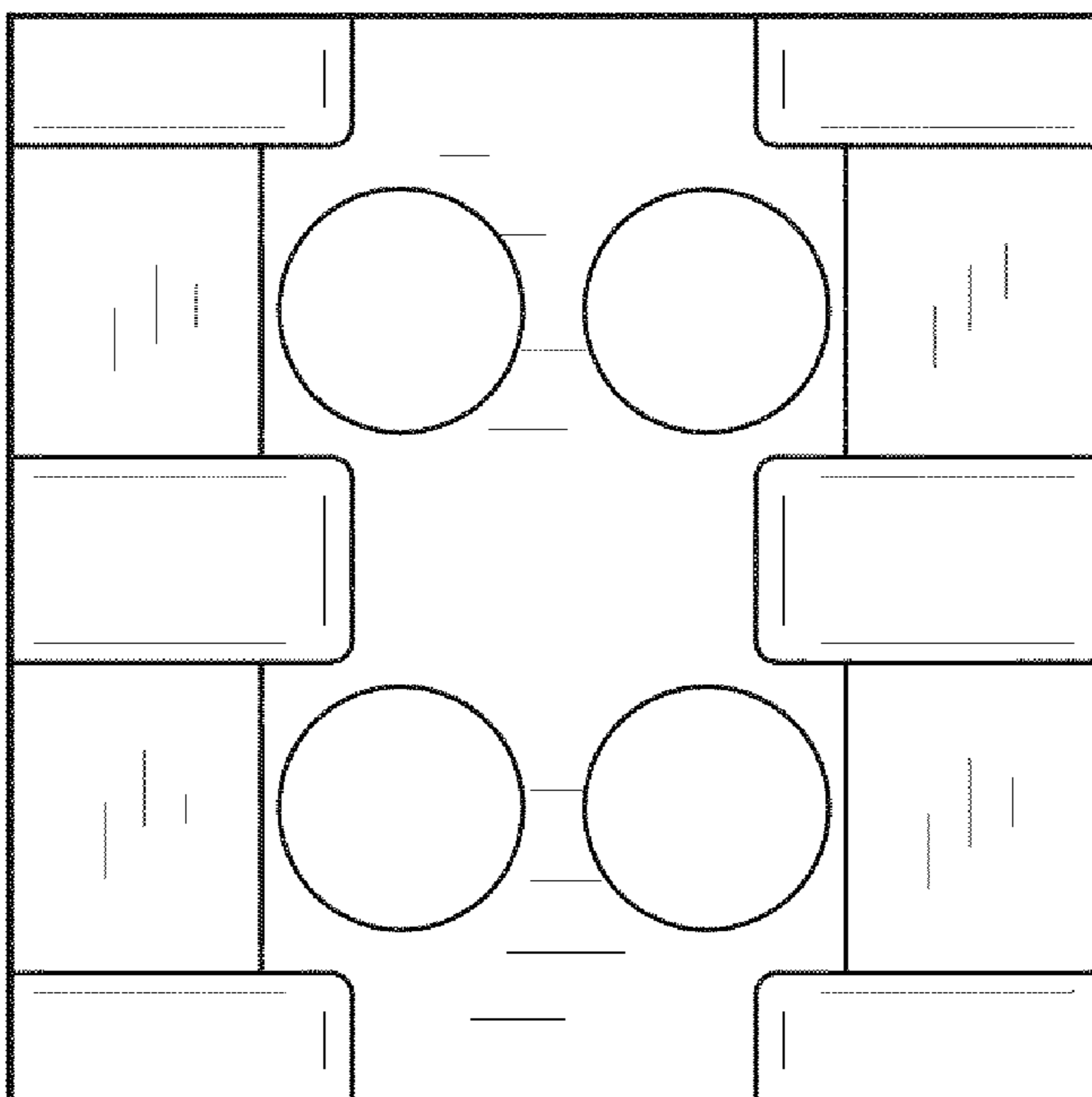

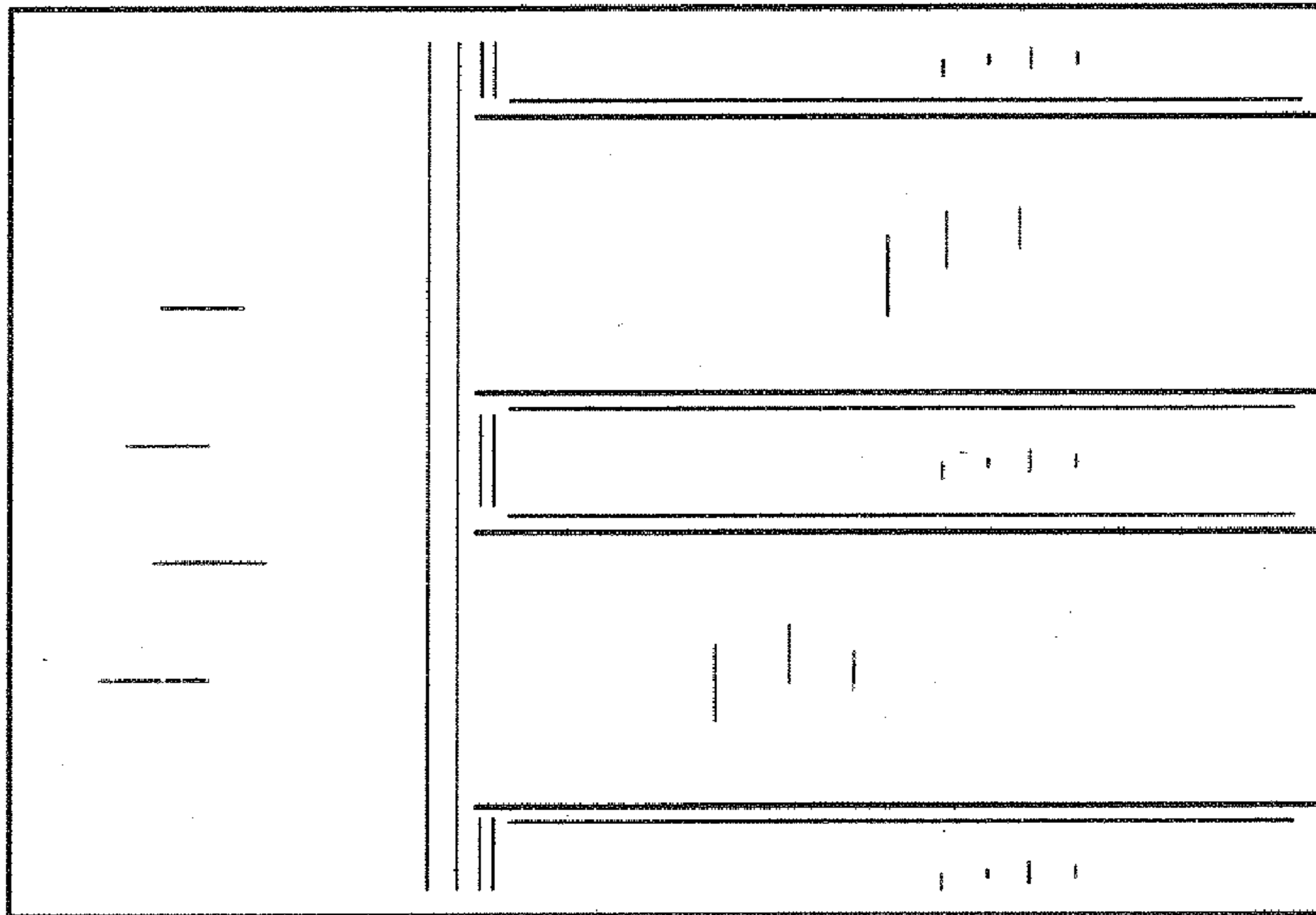

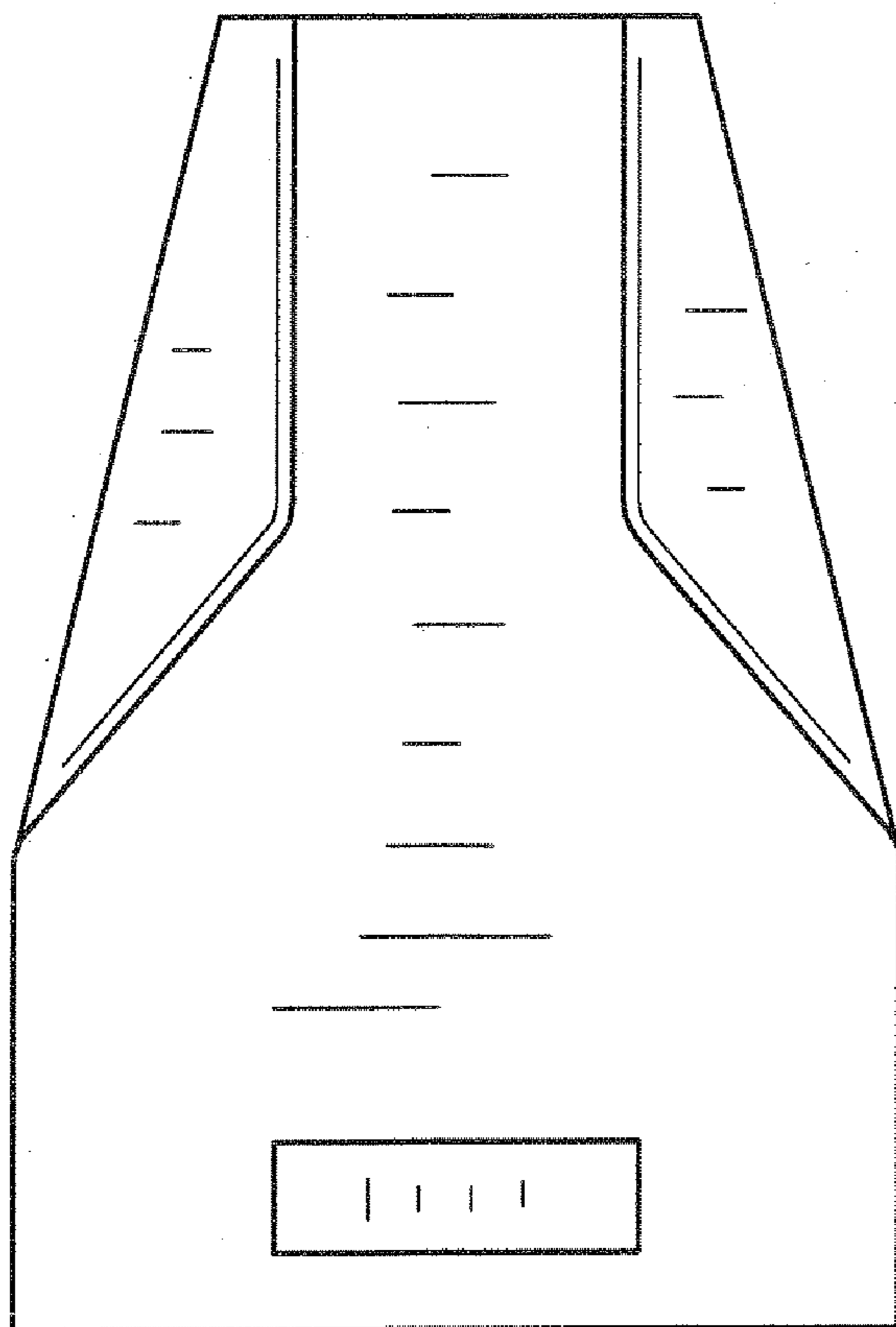
