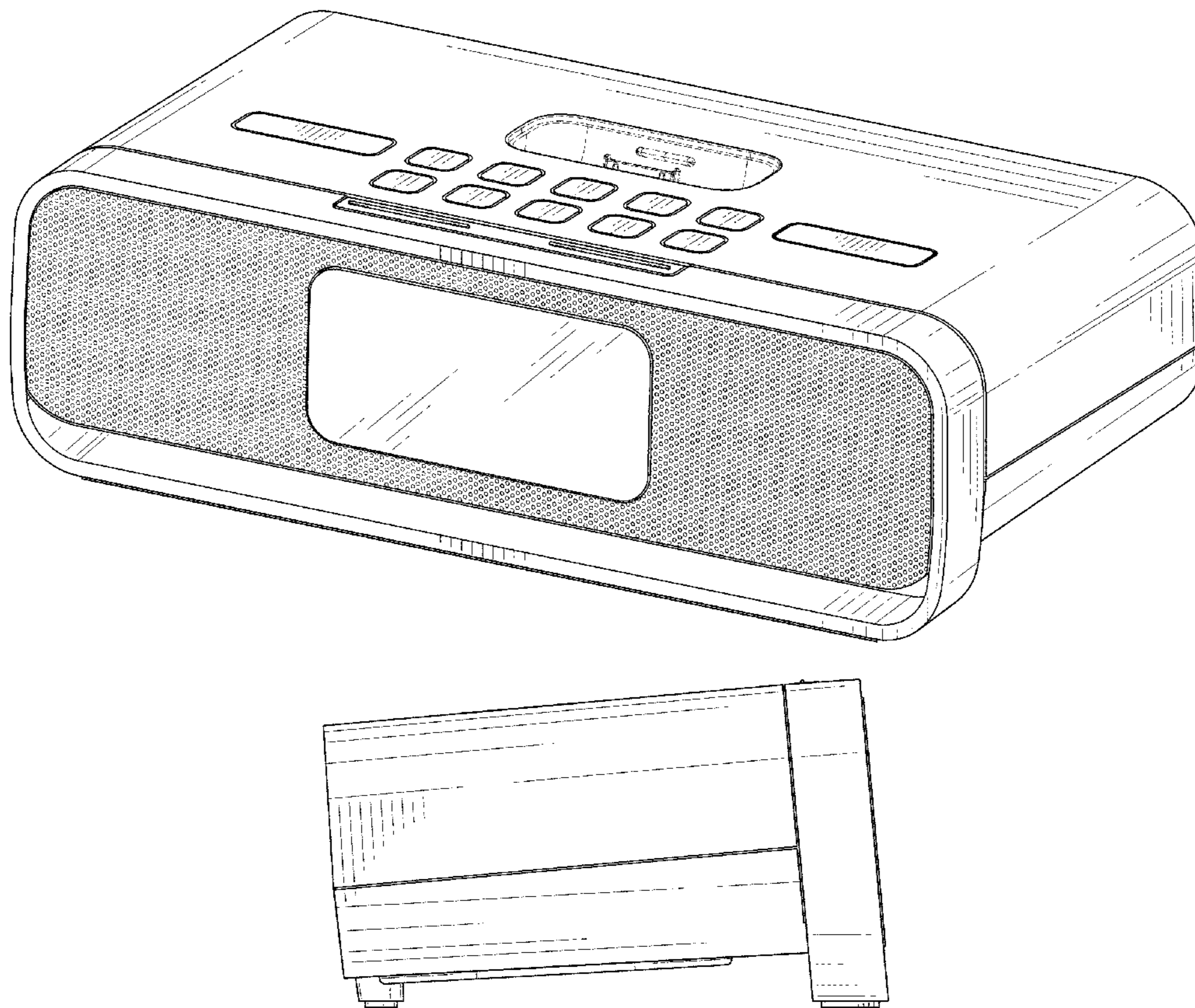
(57) **CLAIM**

The ornamental design for a docking media player clock radio, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, side, perspective view of a docking media player clock radio showing my new design;  
 FIG. 2 is a front view thereof;  
 FIG. 3 is a rear view thereof;  
 FIG. 4 is a top view thereof;  
 FIG. 5 is a bottom view thereof;  
 FIG. 6 is a side view thereof, the opposite side view being a mirror image;  
 FIG. 7 is a cross-sectional view along line 7-7 in FIG. 4; and,  
 FIG. 8 is a cross-sectional view along line 8-8 in FIG. 4.

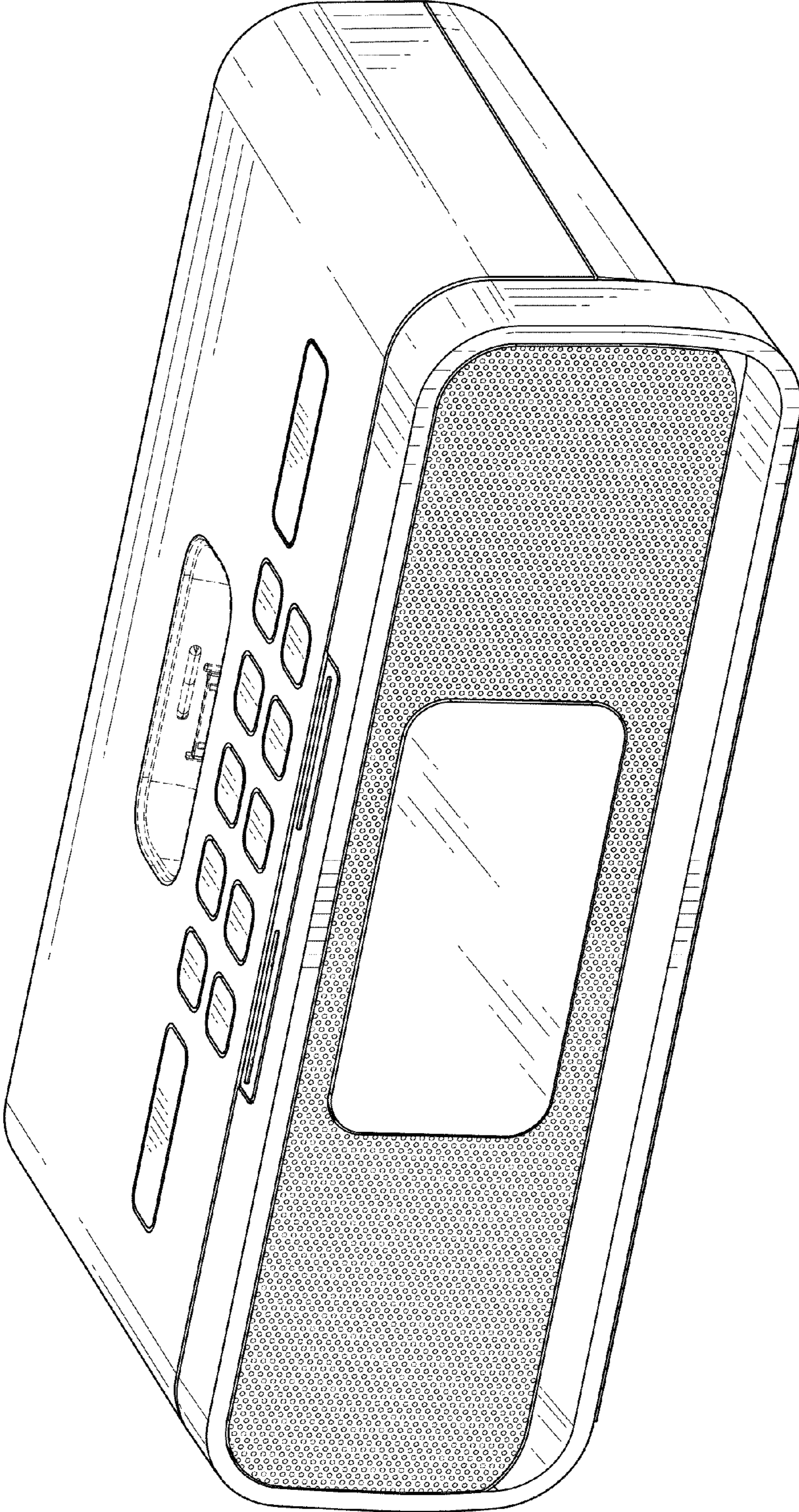

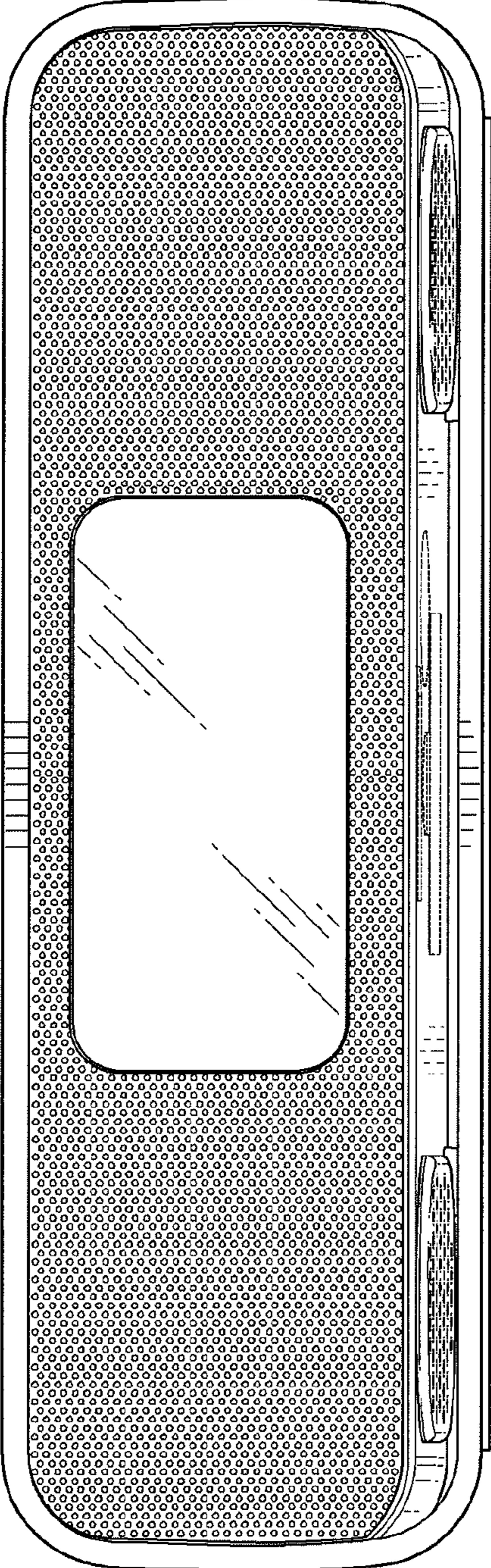

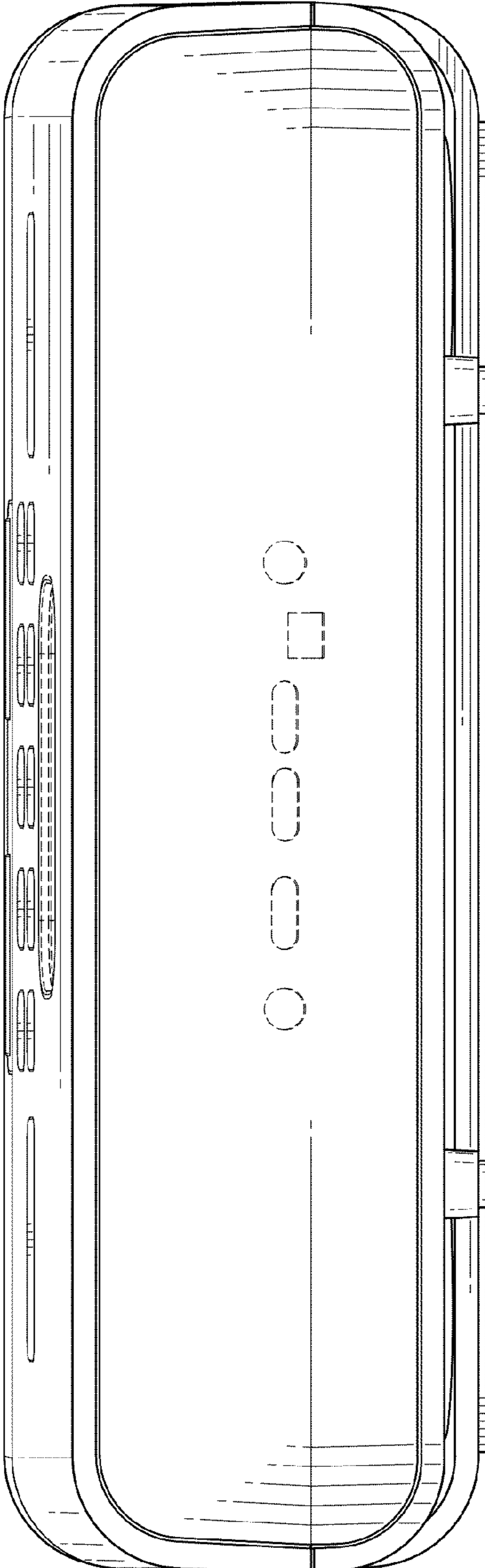

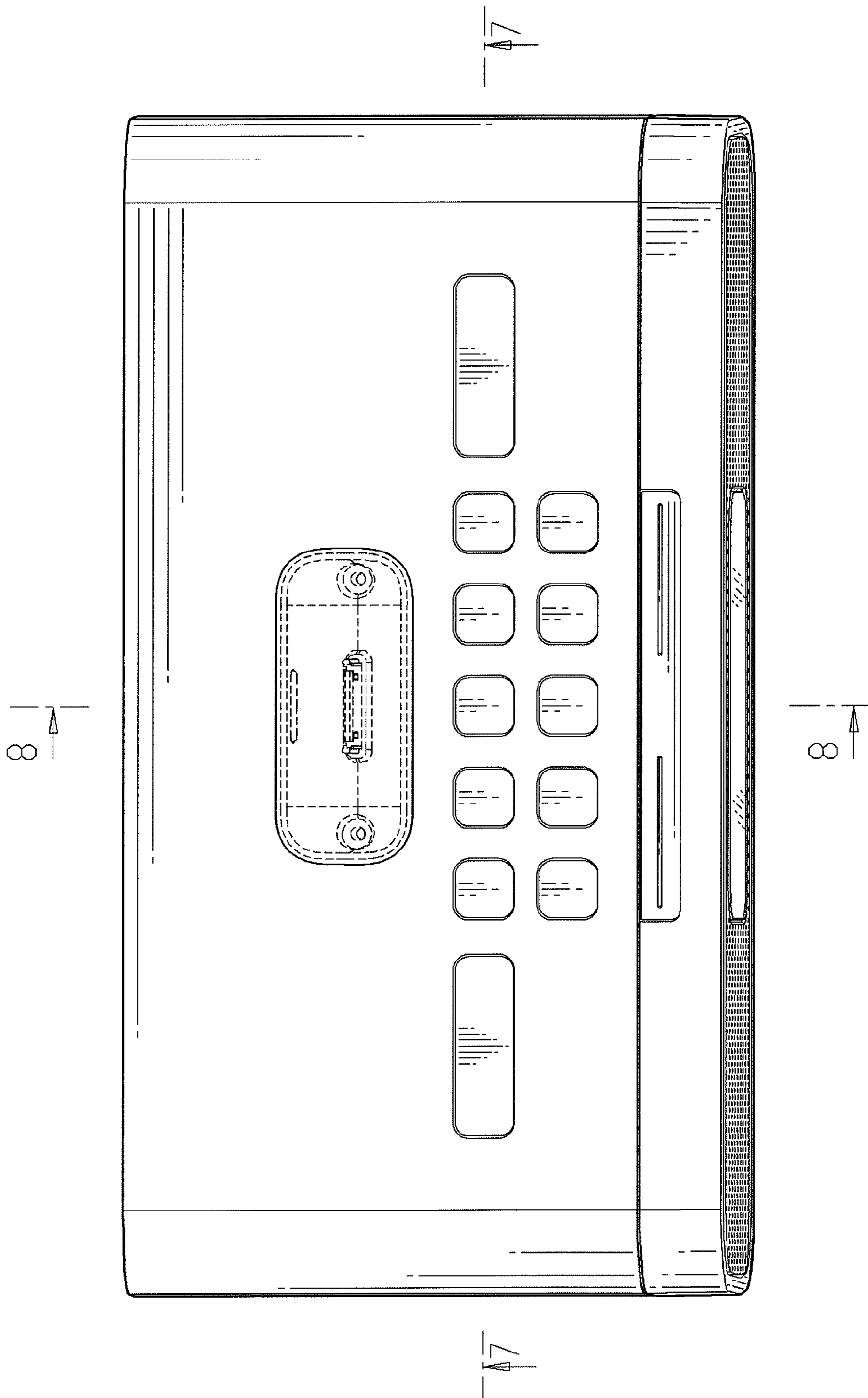

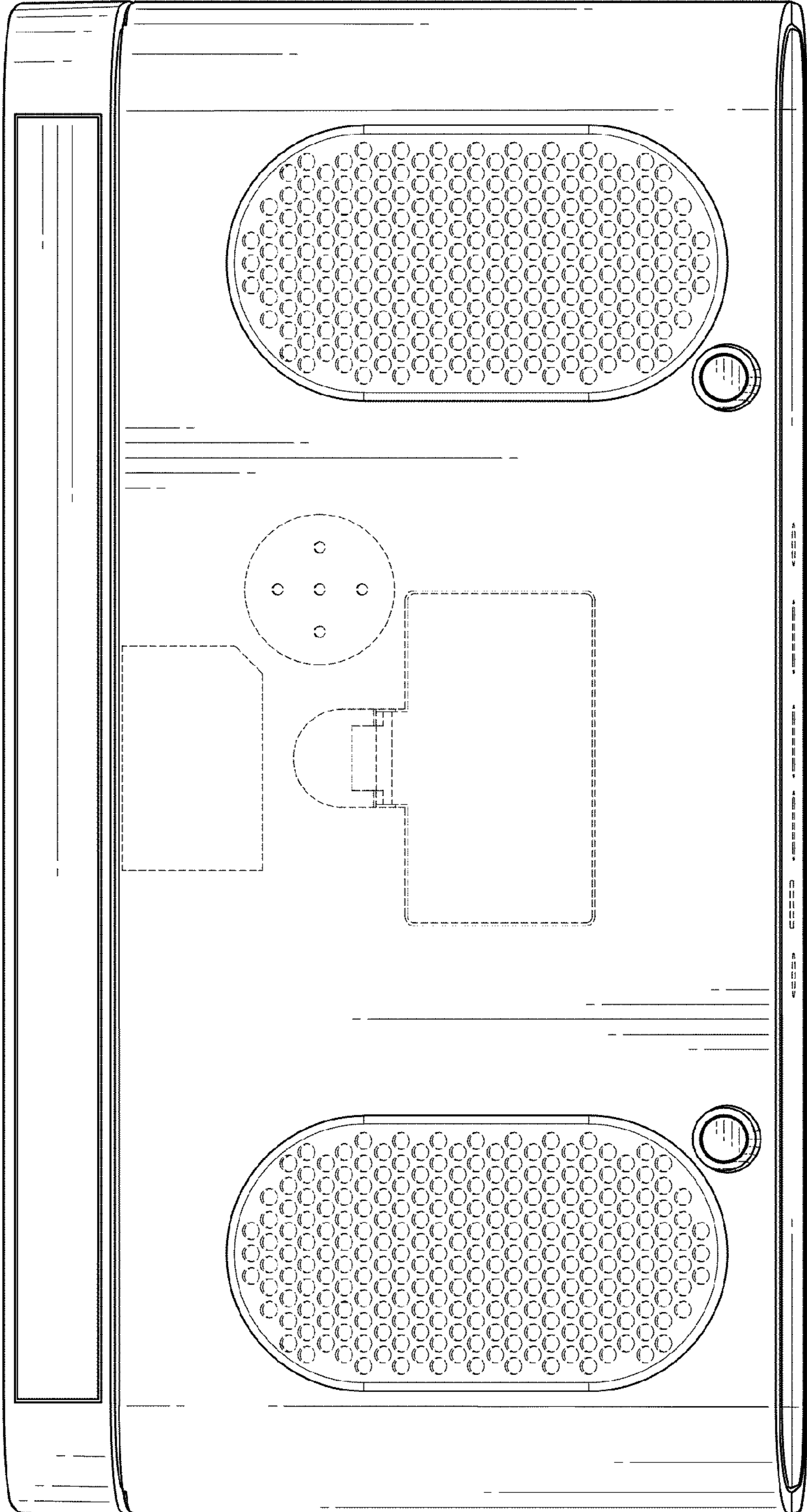

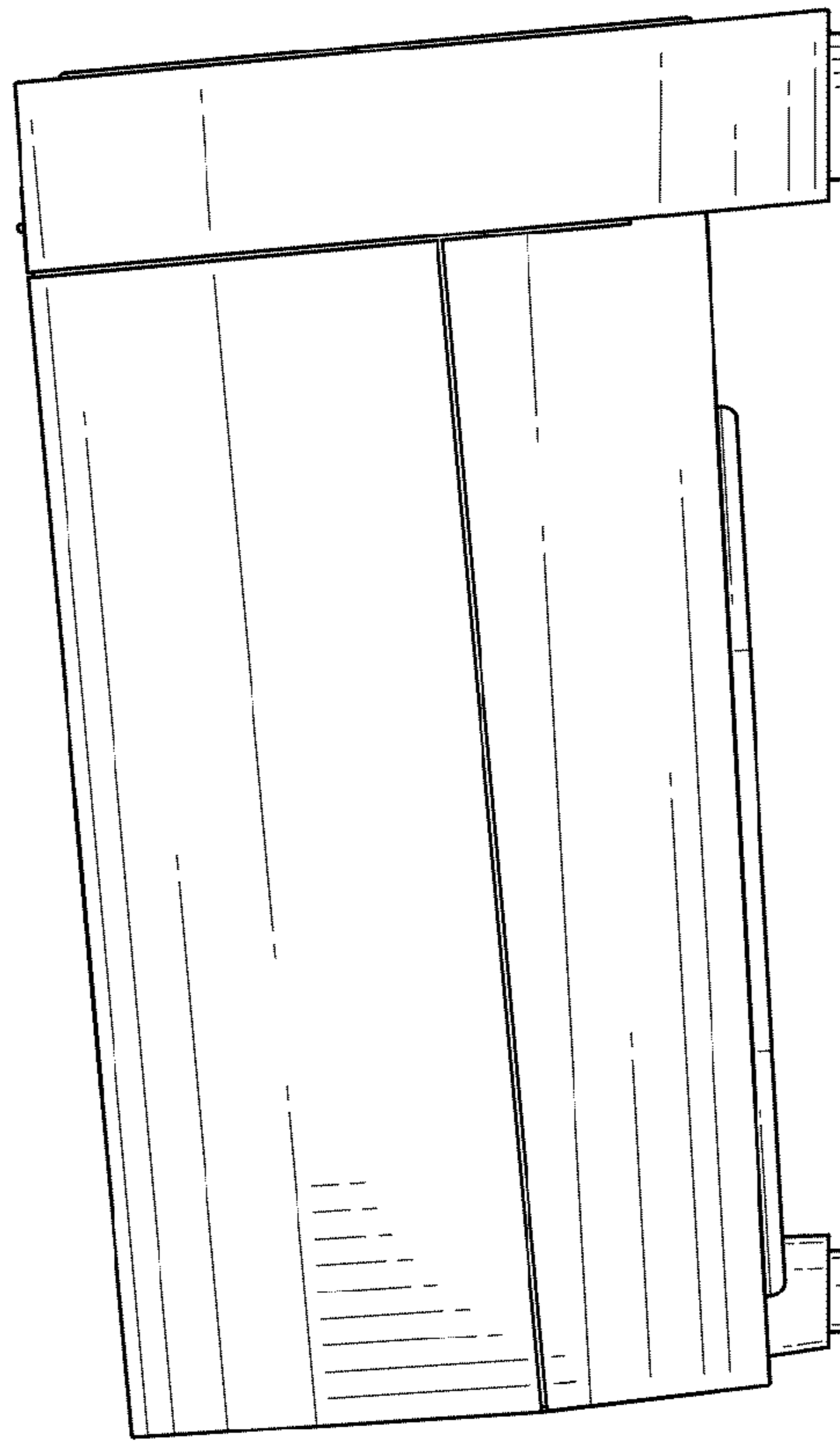

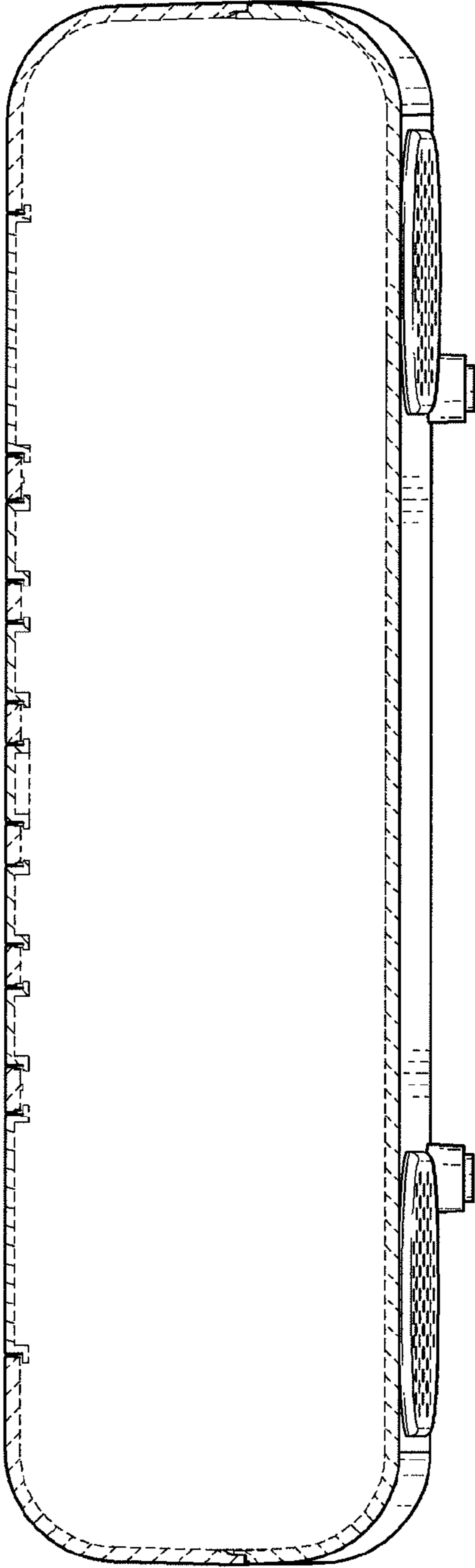

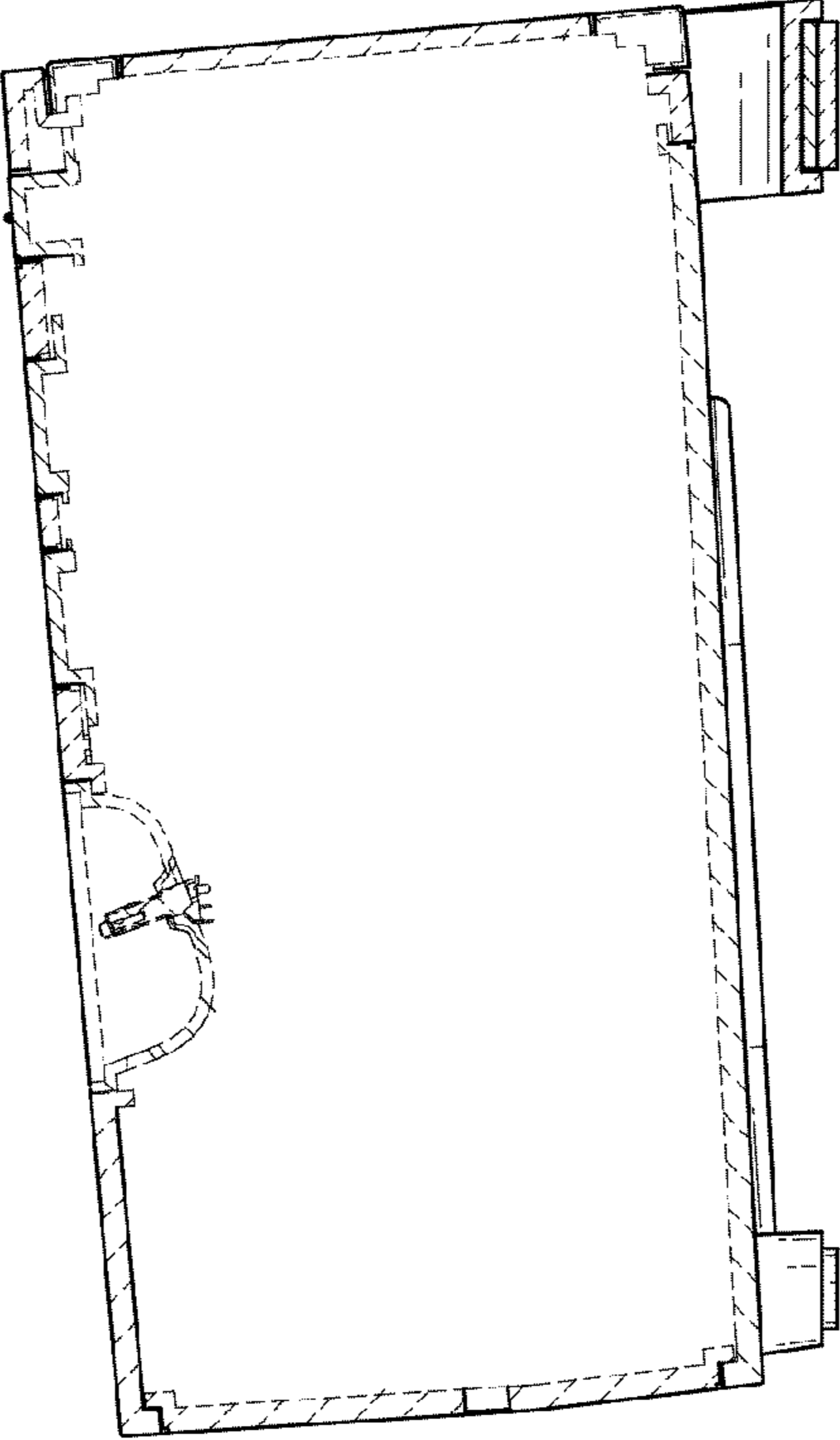
