(57) **CLAIM**

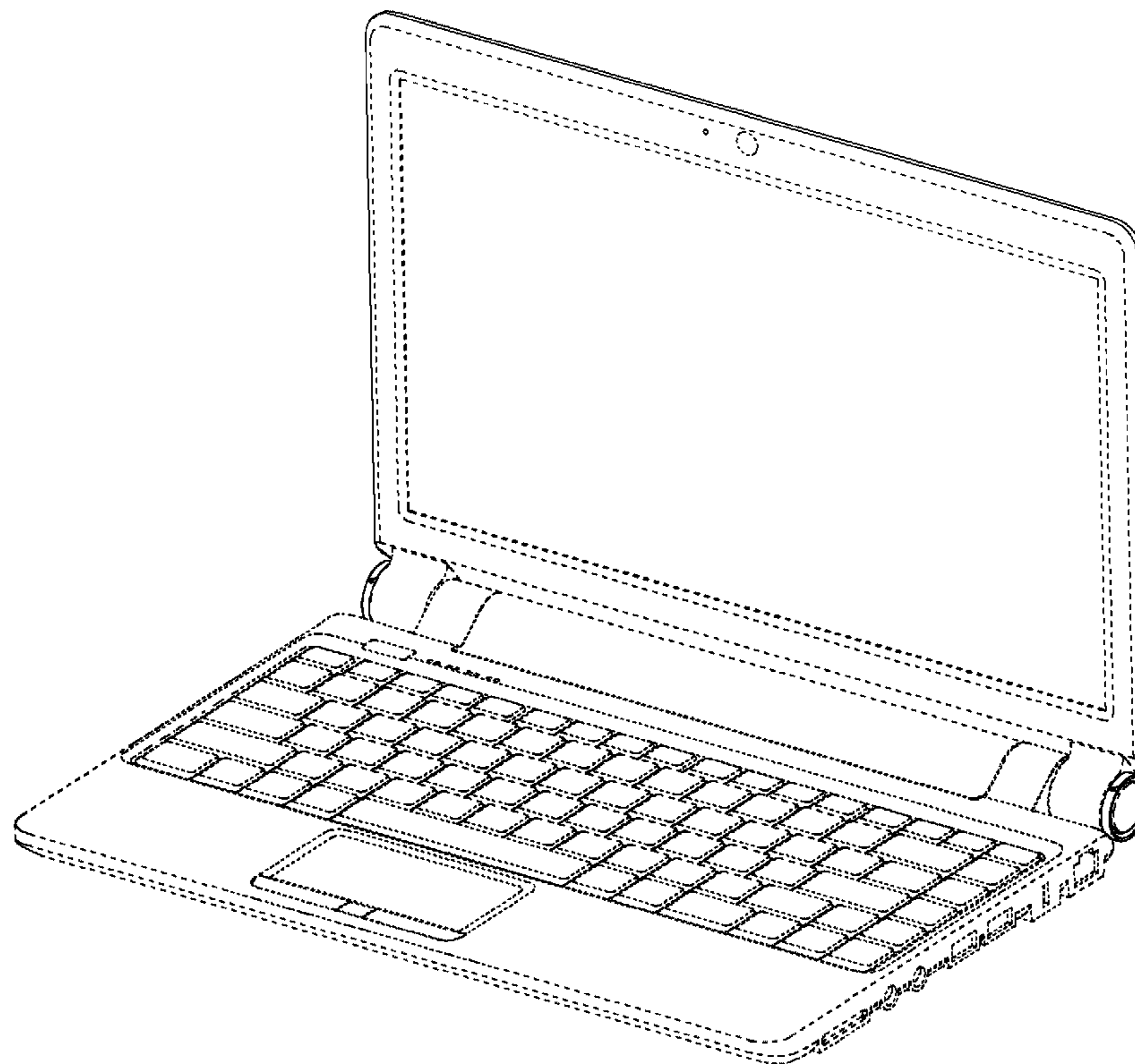
The ornamental design for a portable computer, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a portable computer;

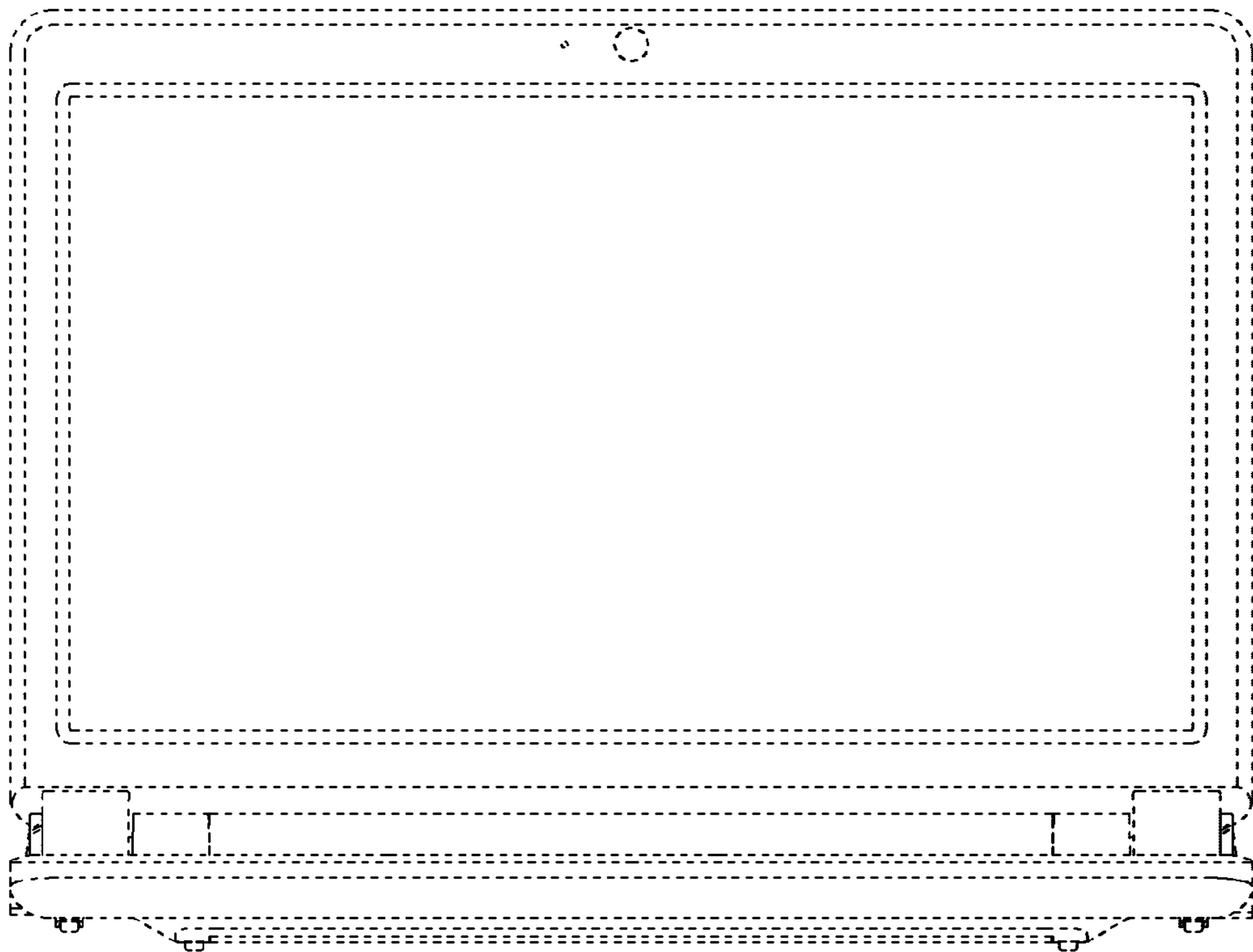

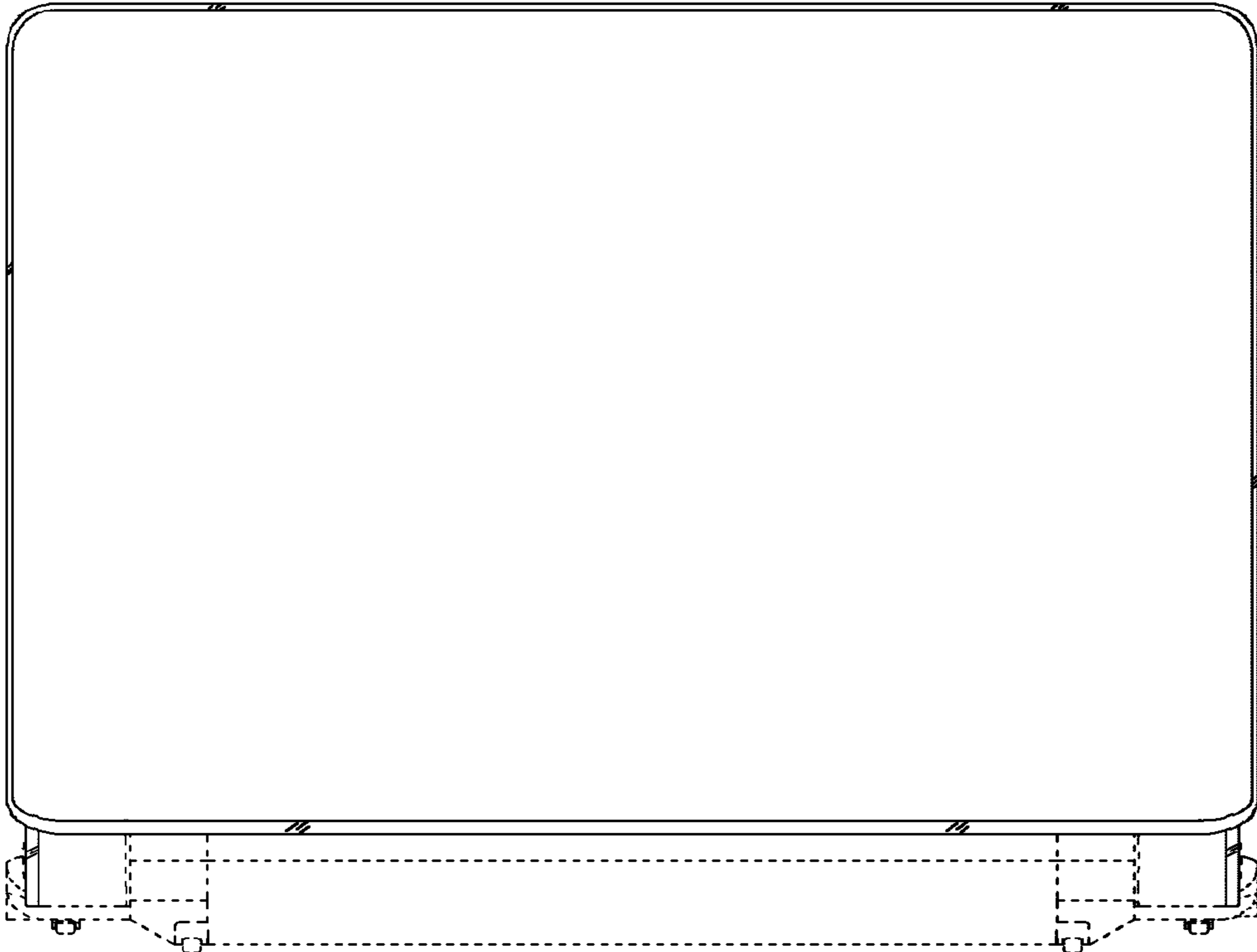

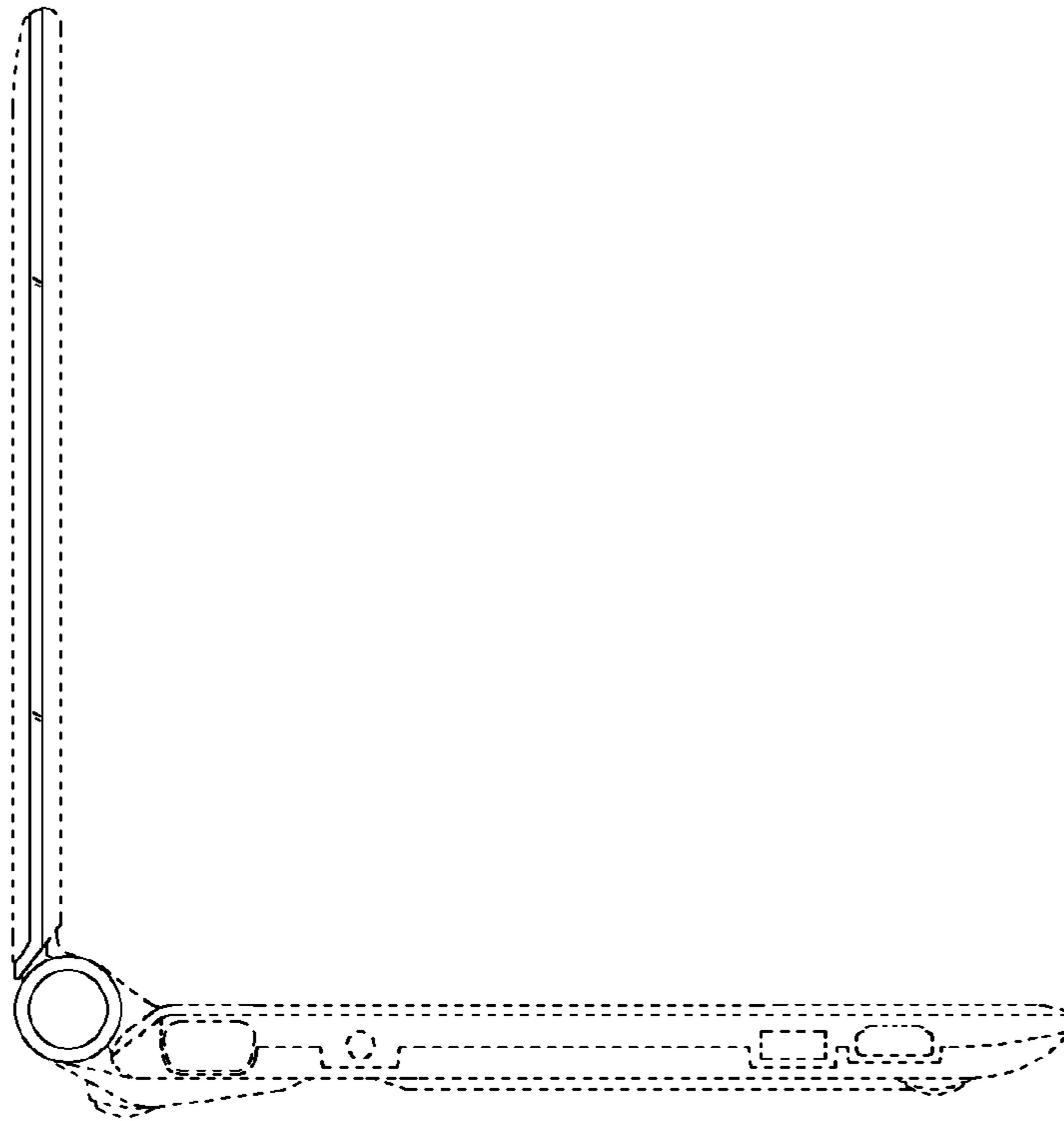

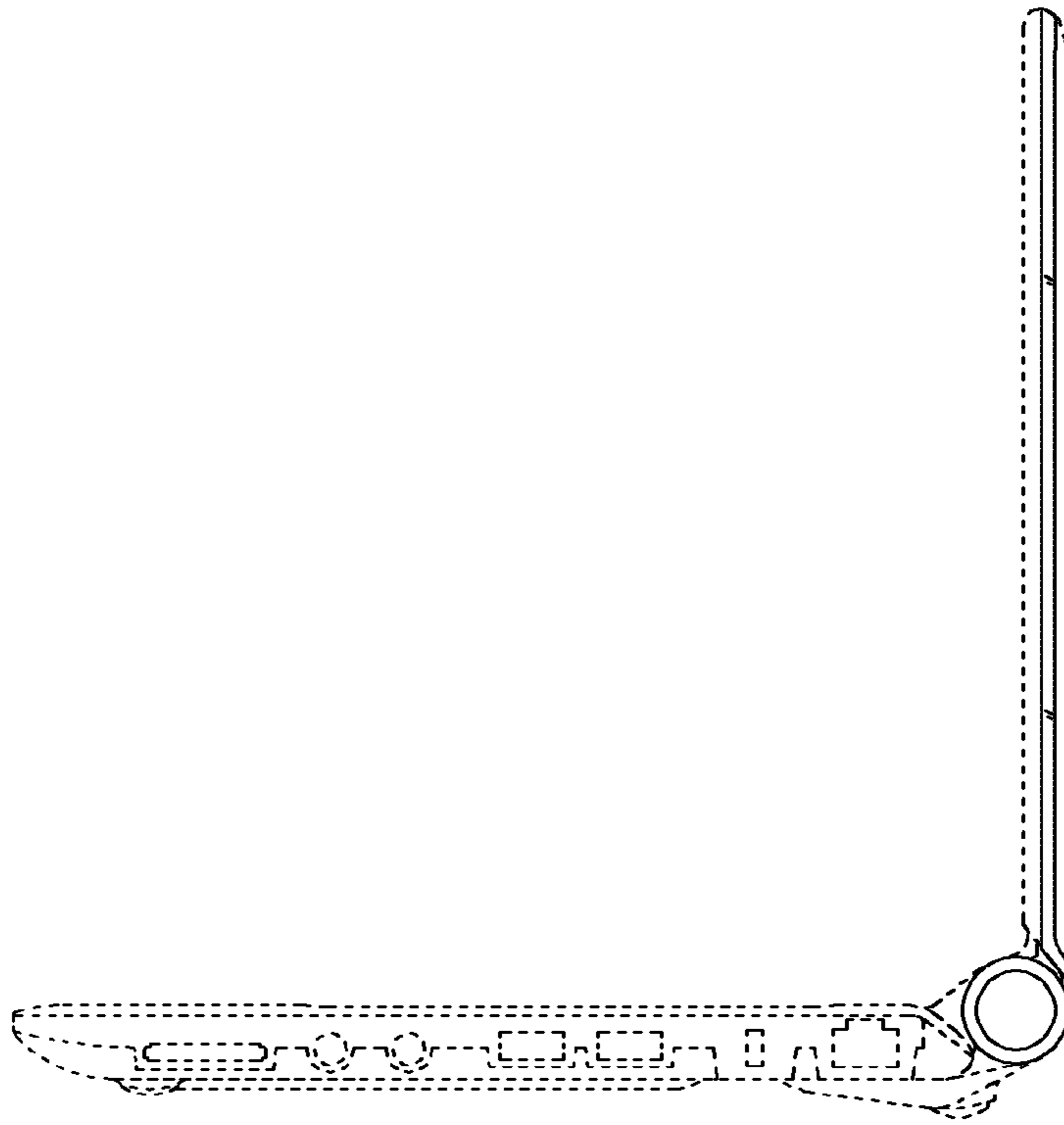

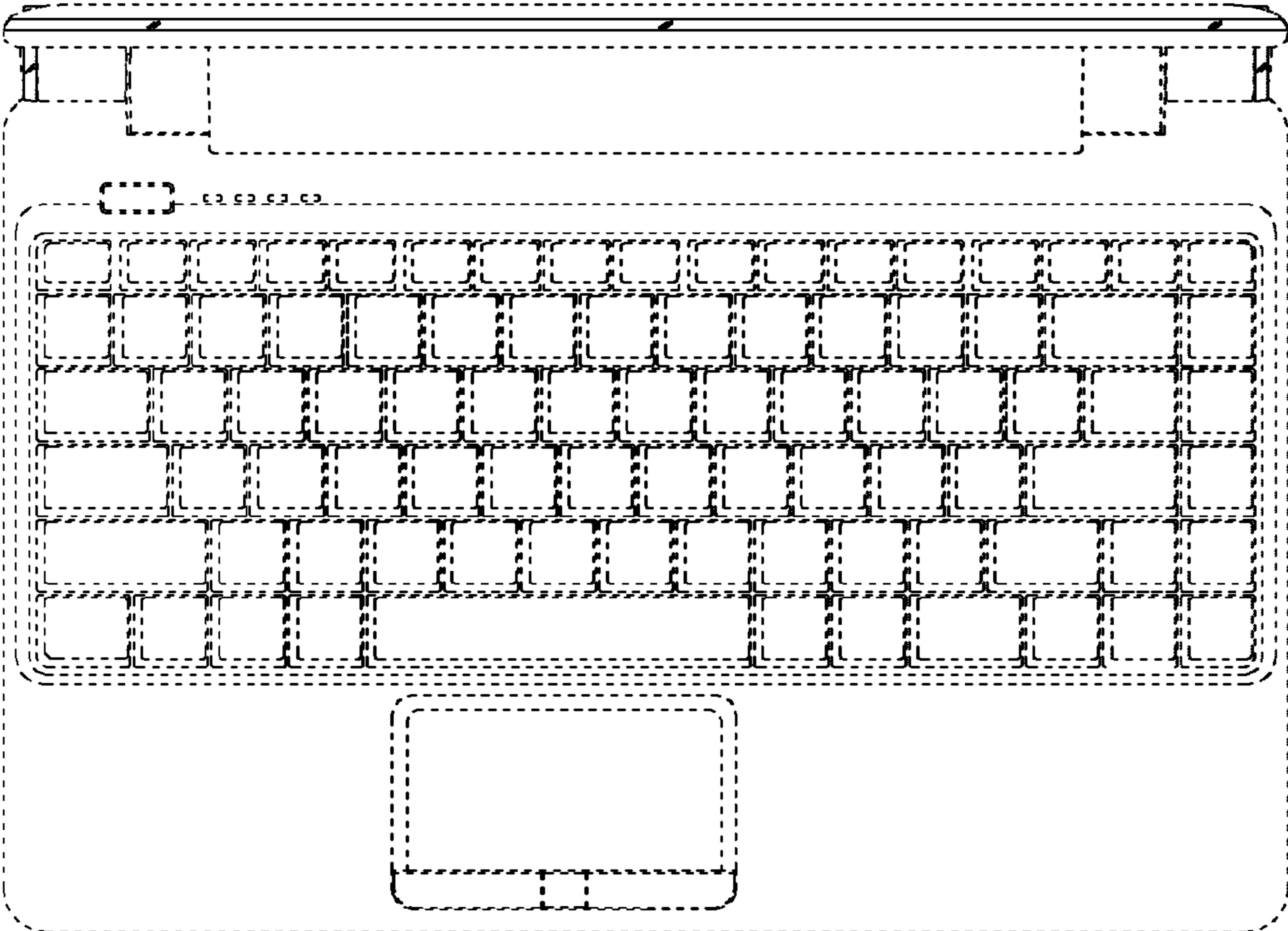

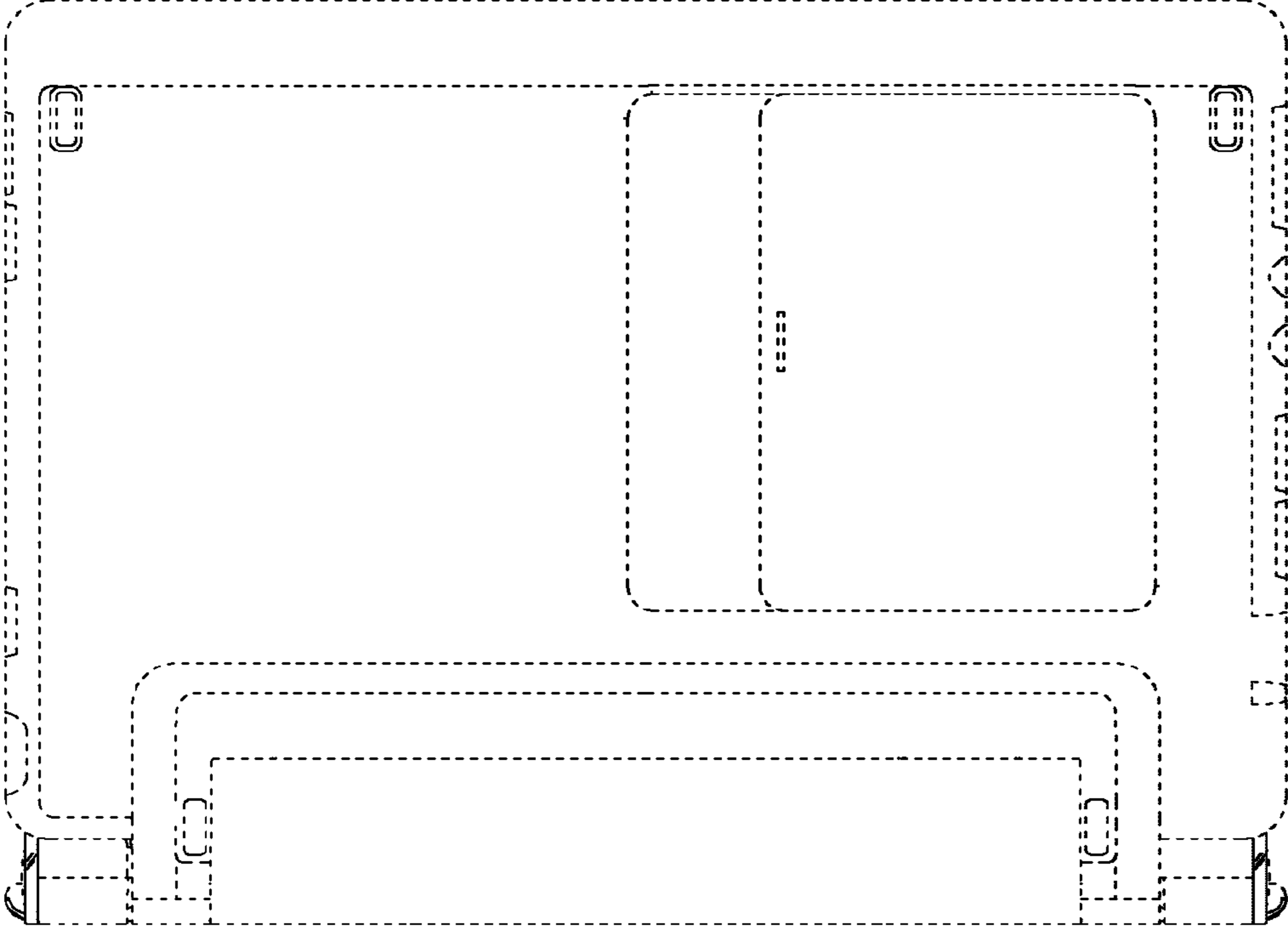

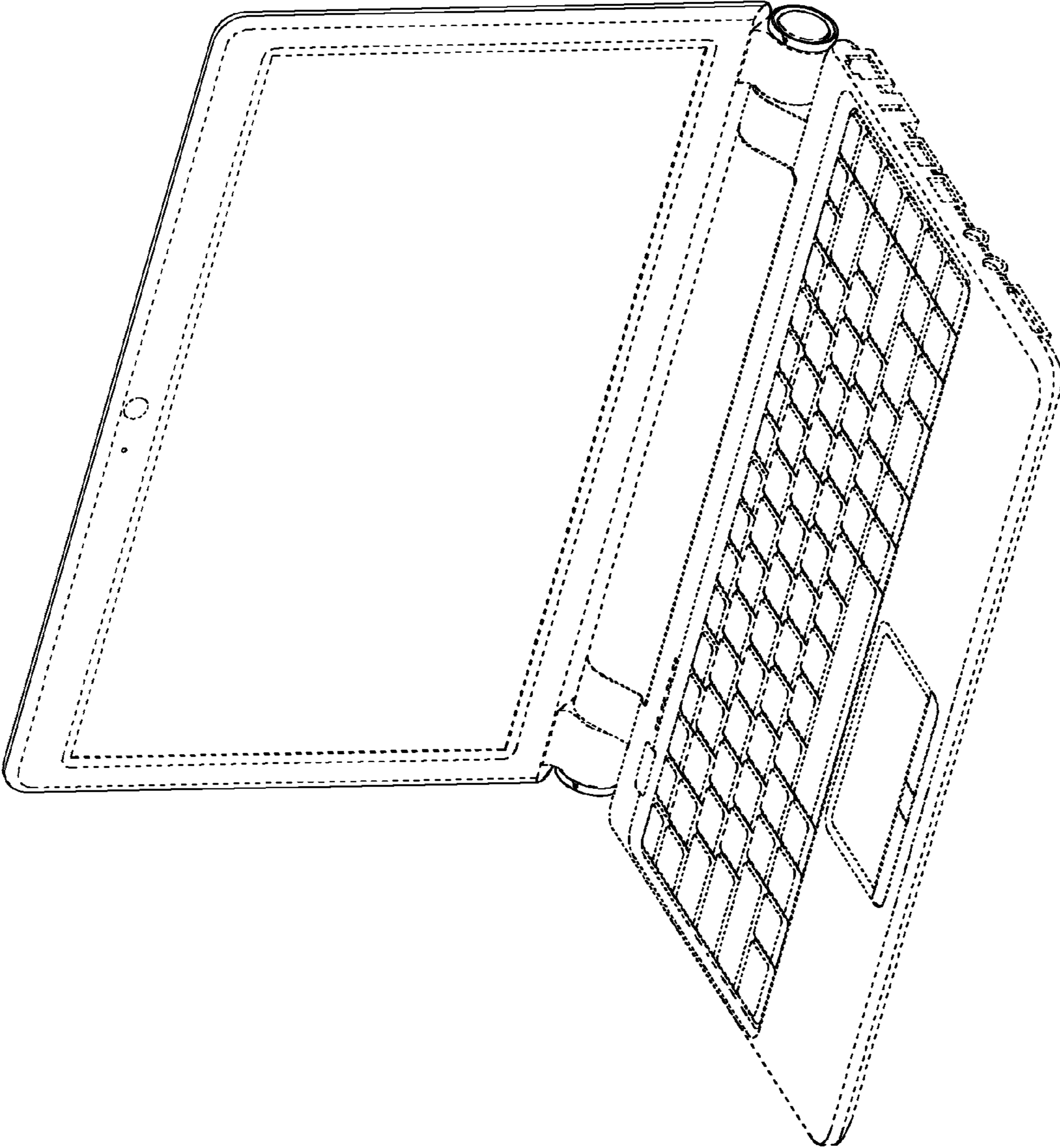

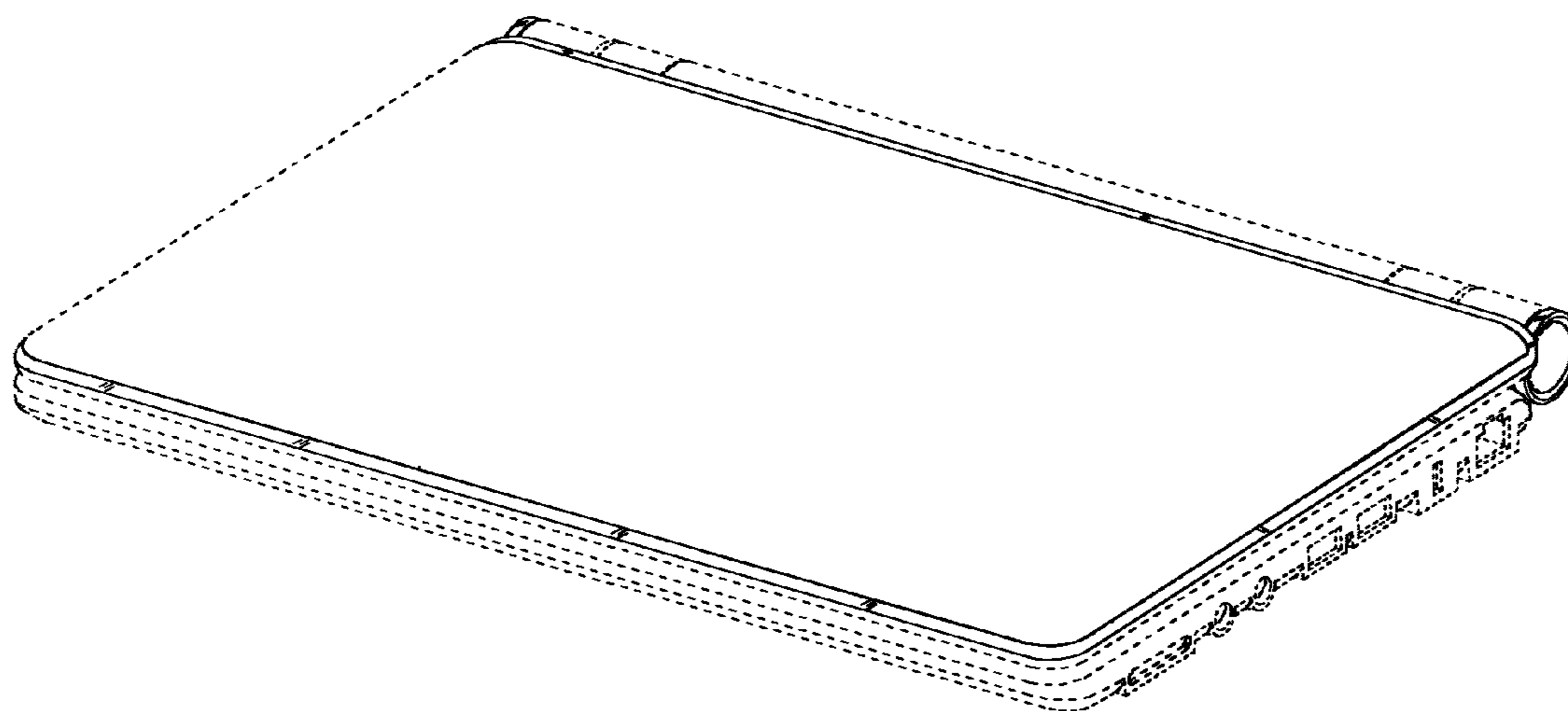
