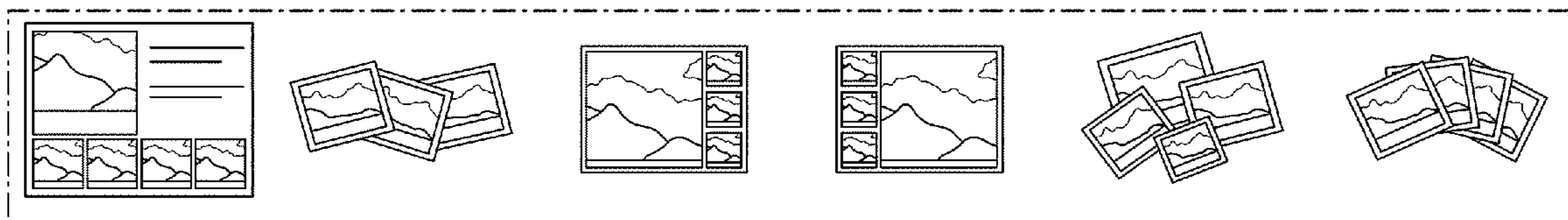
The ornamental design for a display screen with a group of  
icons, as shown and described.

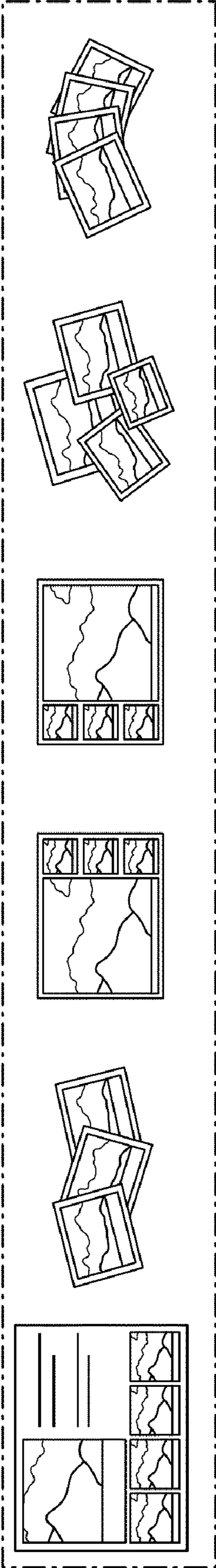
**DESCRIPTION**
