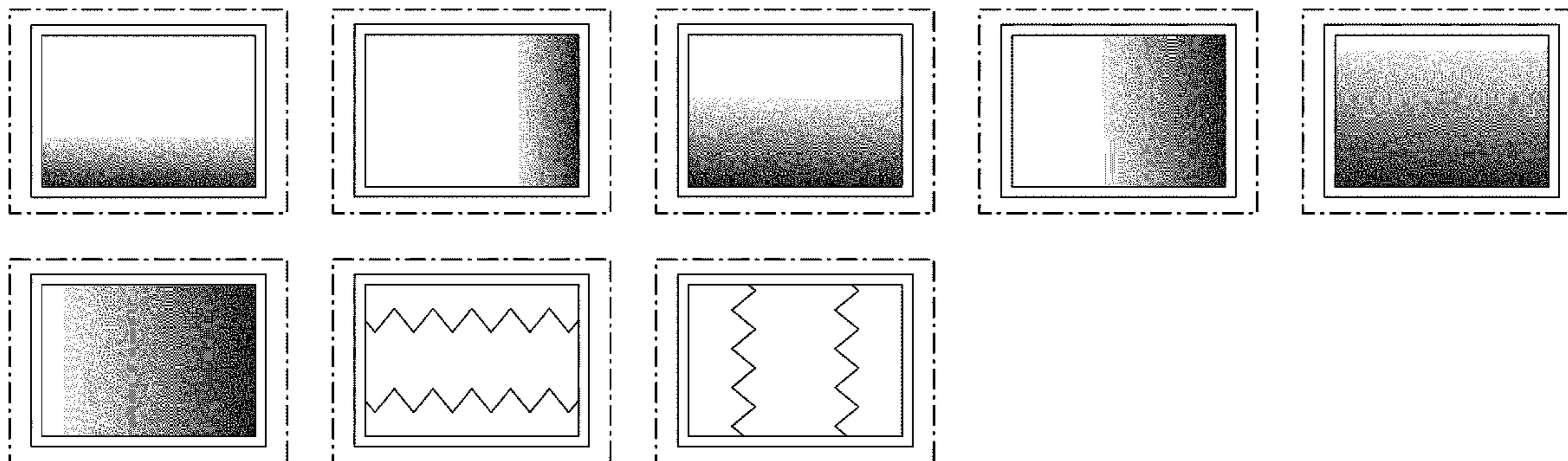
The ornamental design for a display screen with a set of icons, as shown and described.

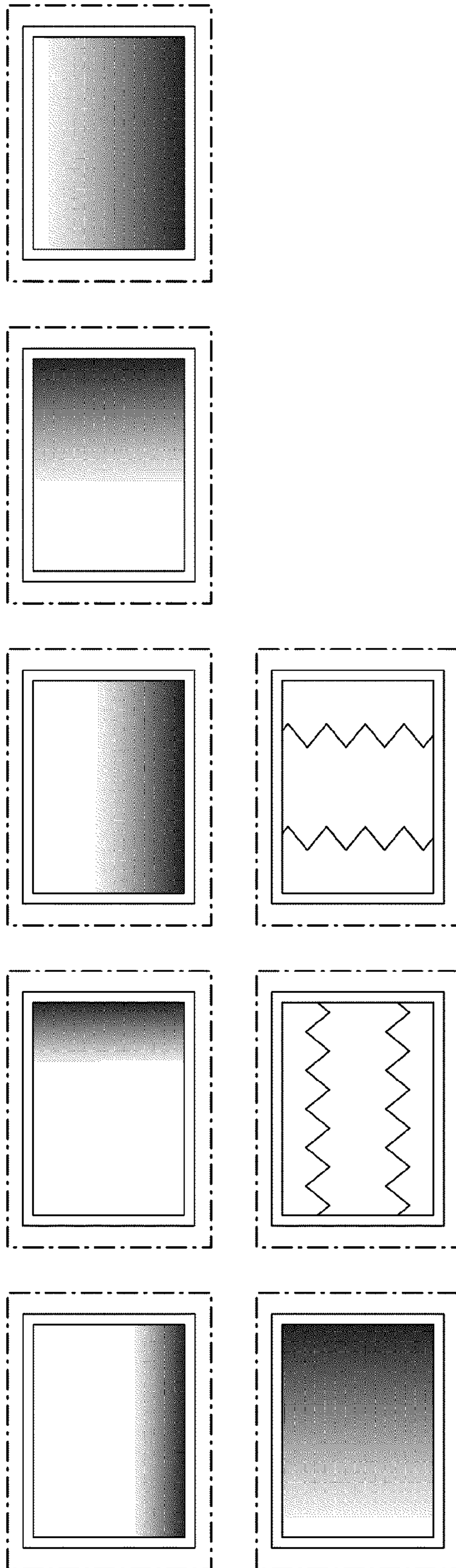
**DESCRIPTION**
