DESCRIPTION

FIG. 1 is a front view of a golf ball including a first embodiment of our design;

FIG. 4 is a bottom view thereof;

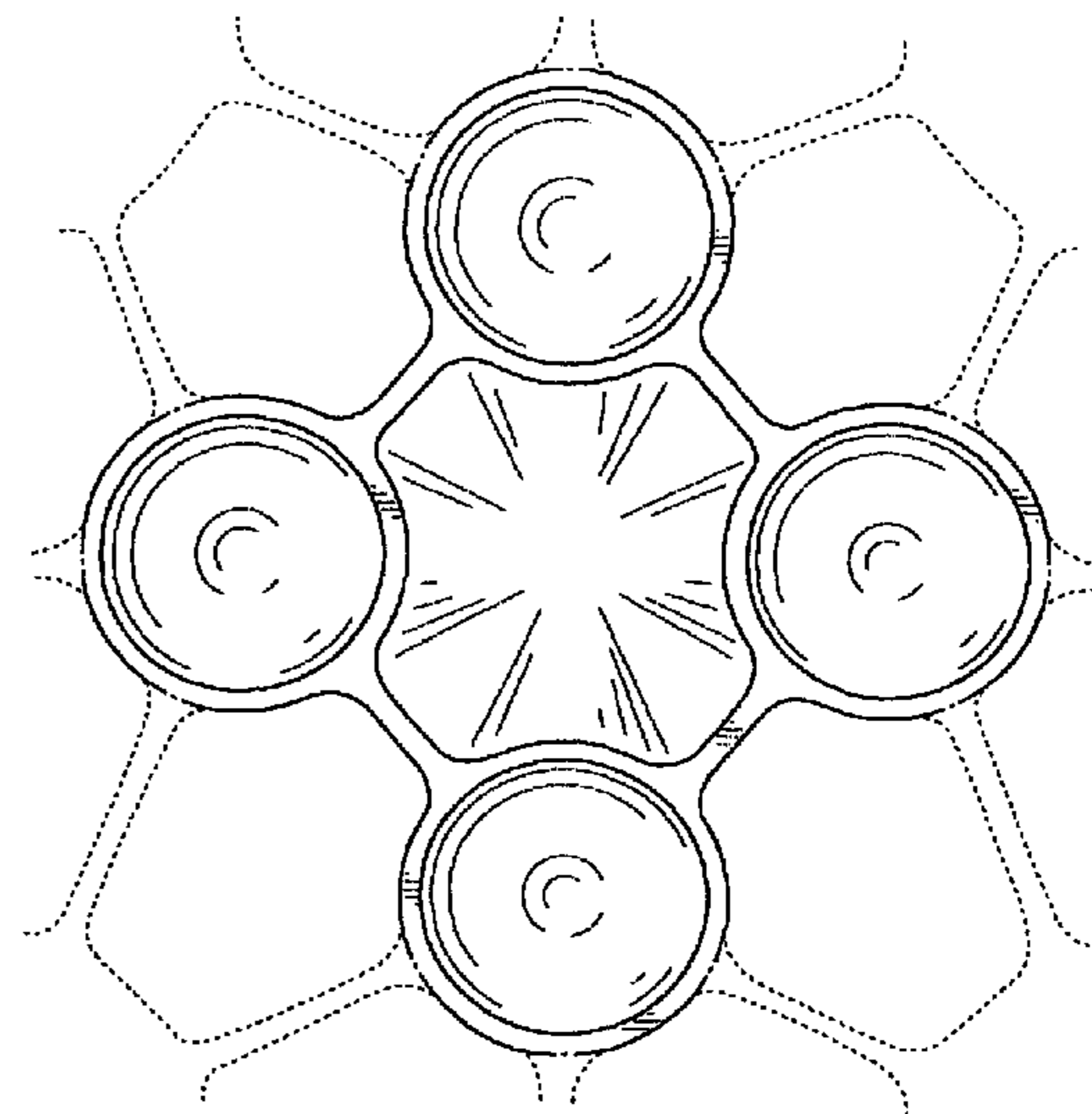
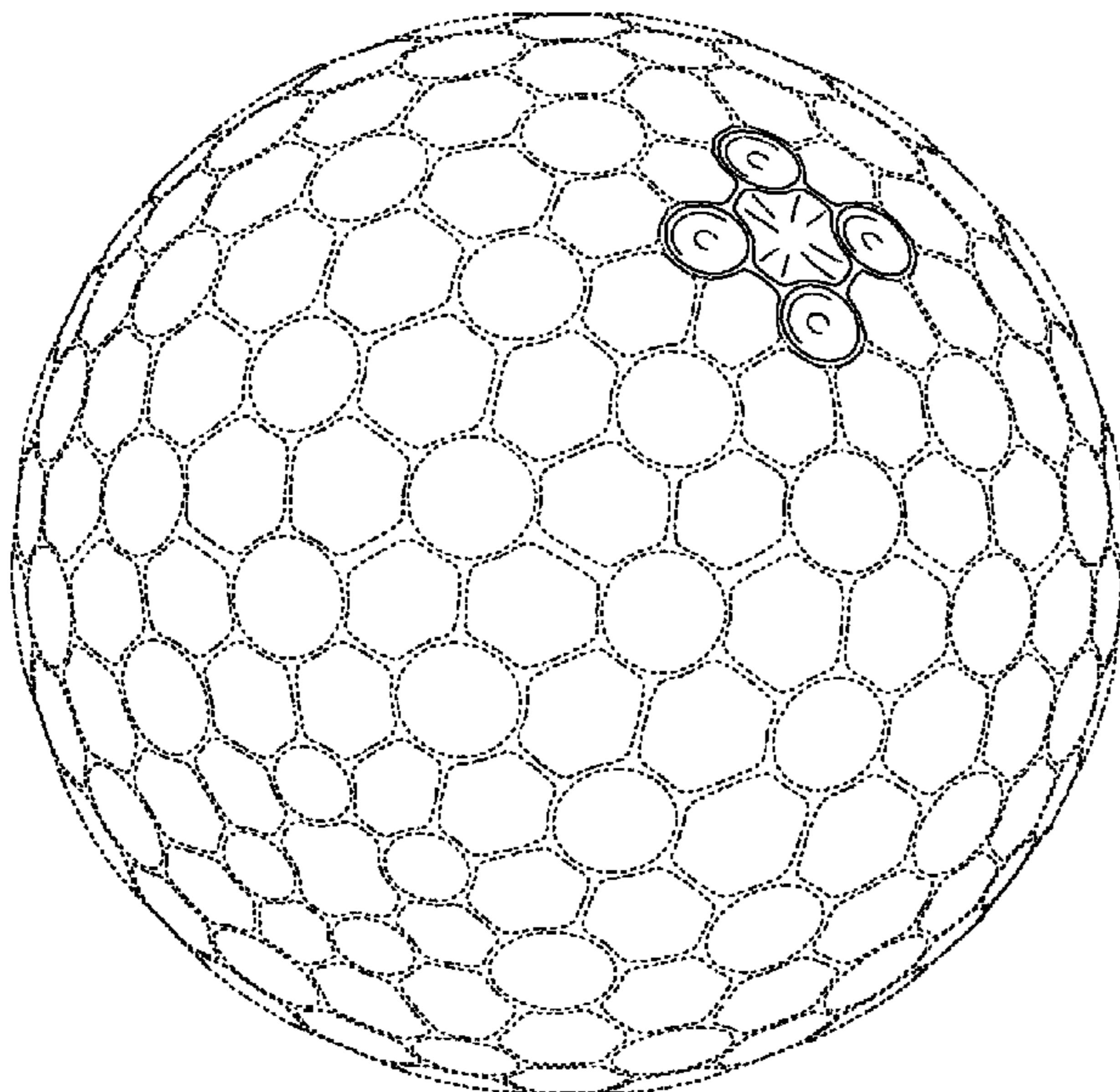
FIG. 5 is a left side view thereof;

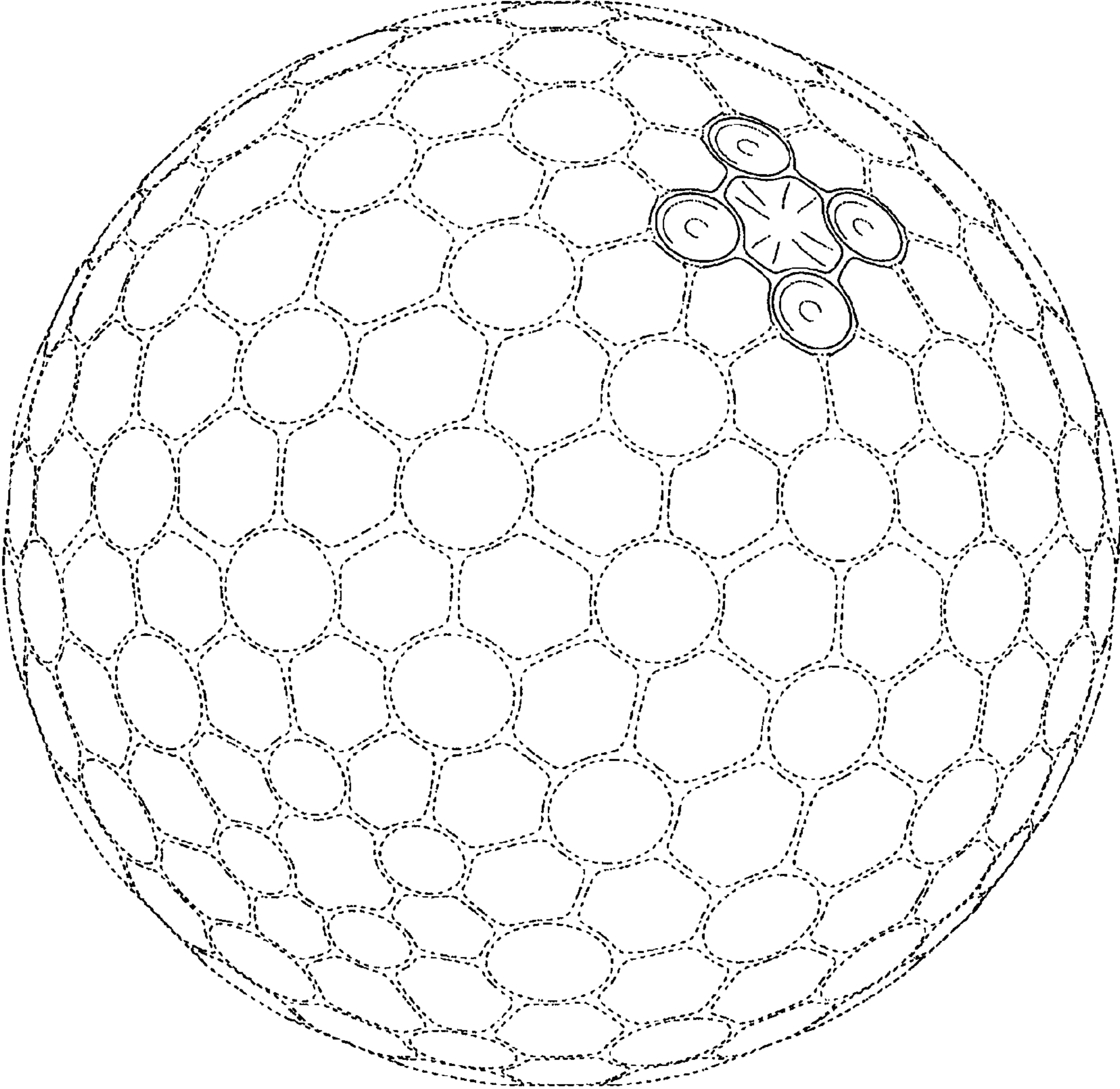

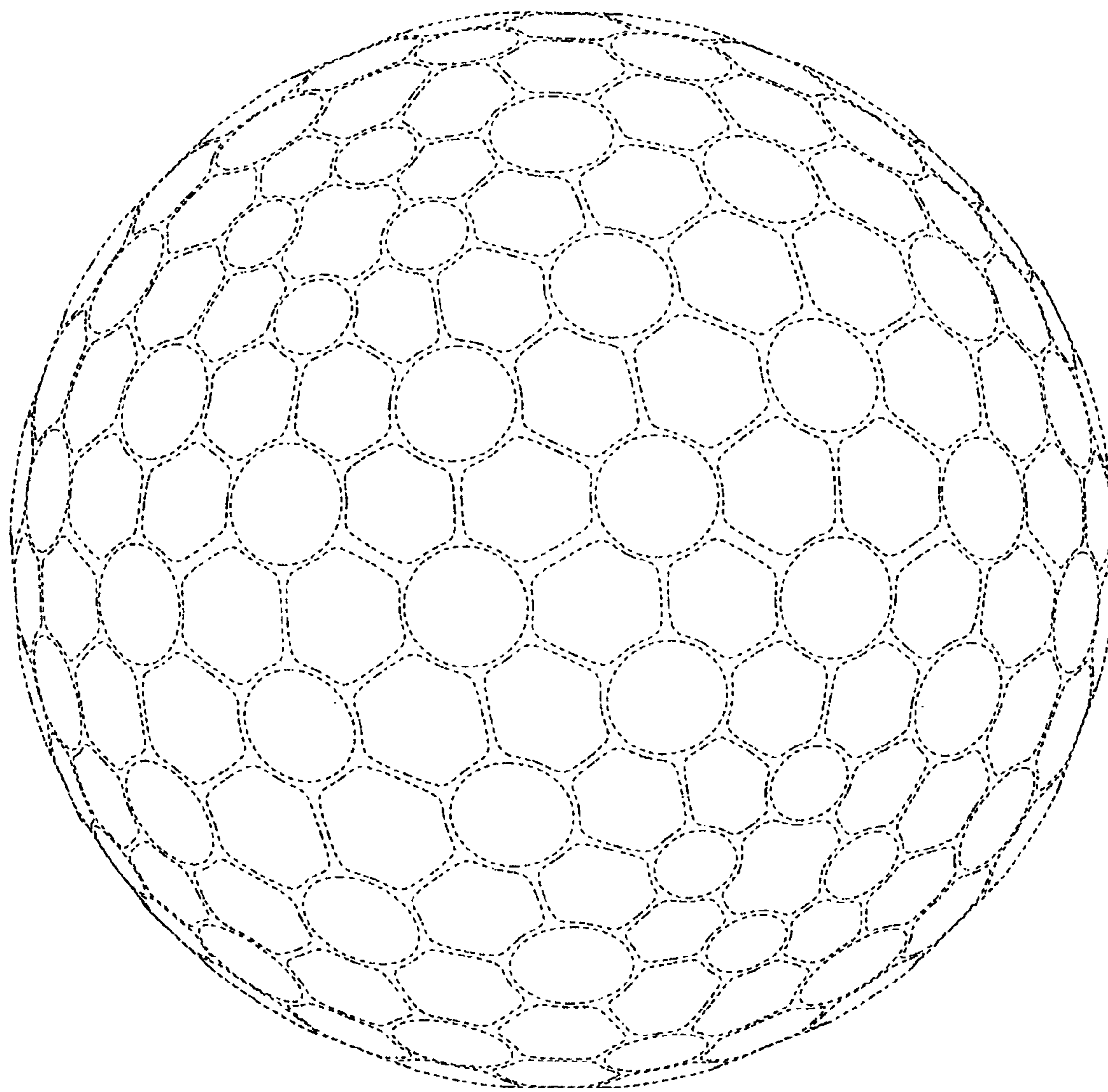

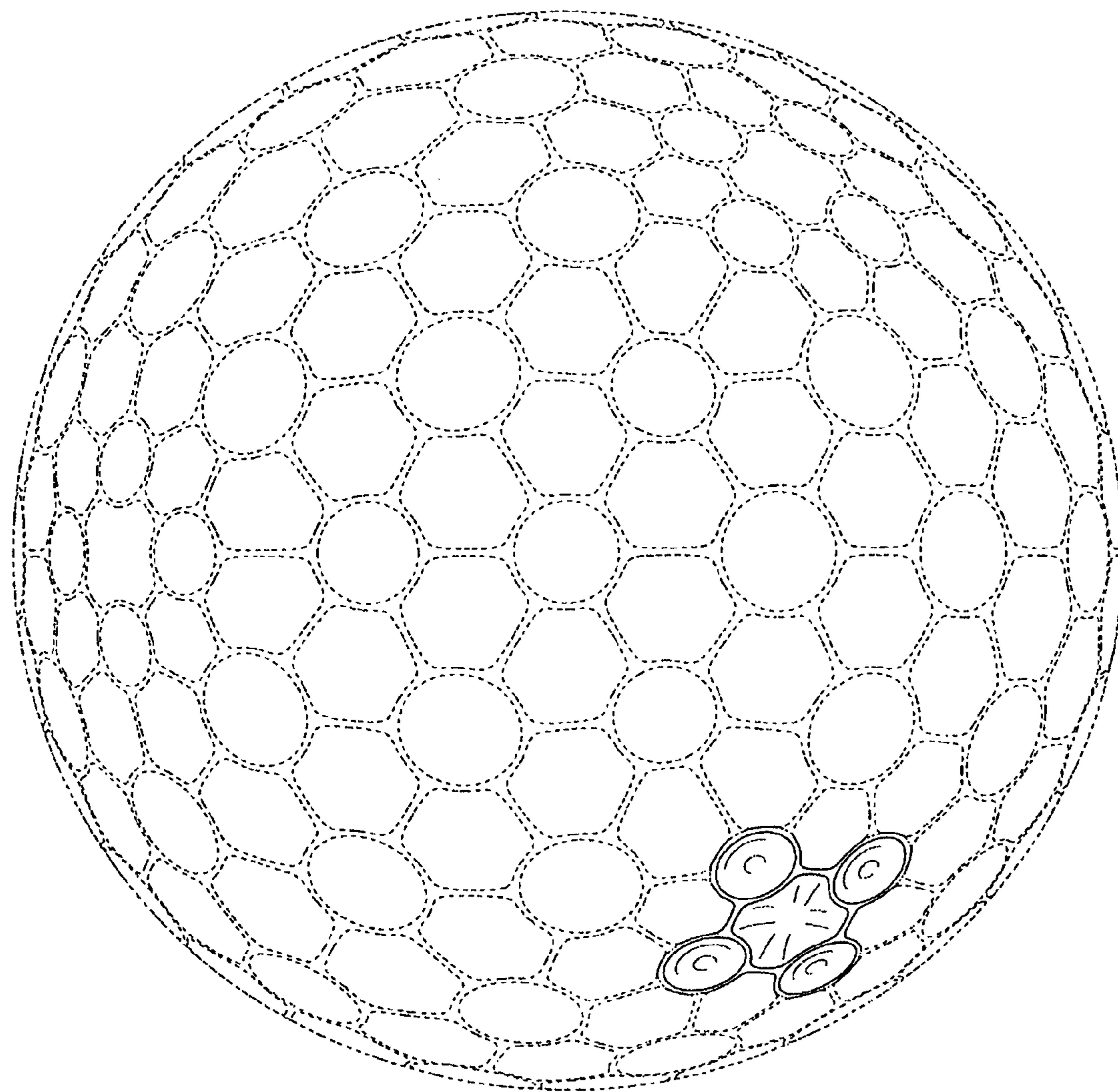

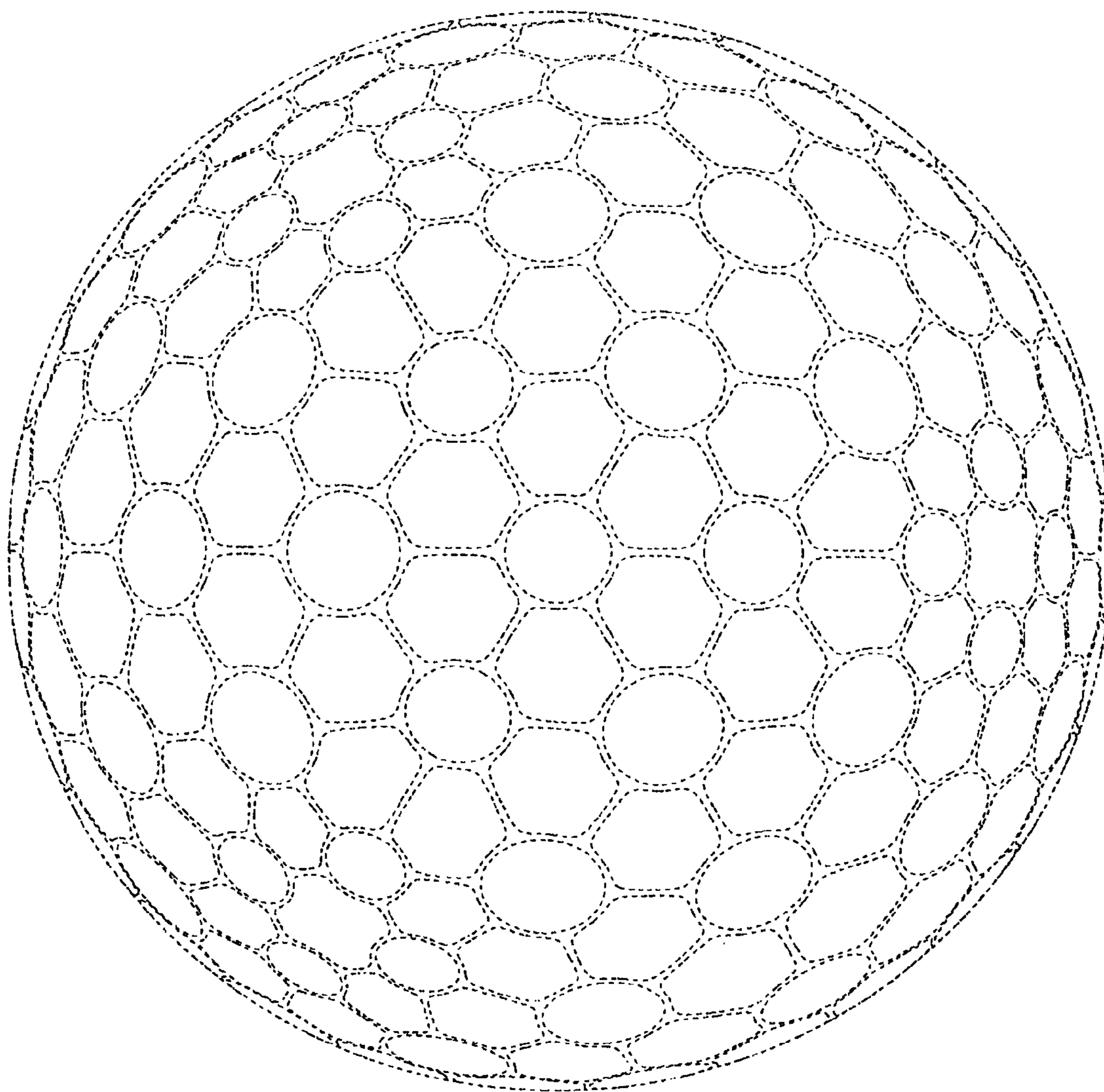

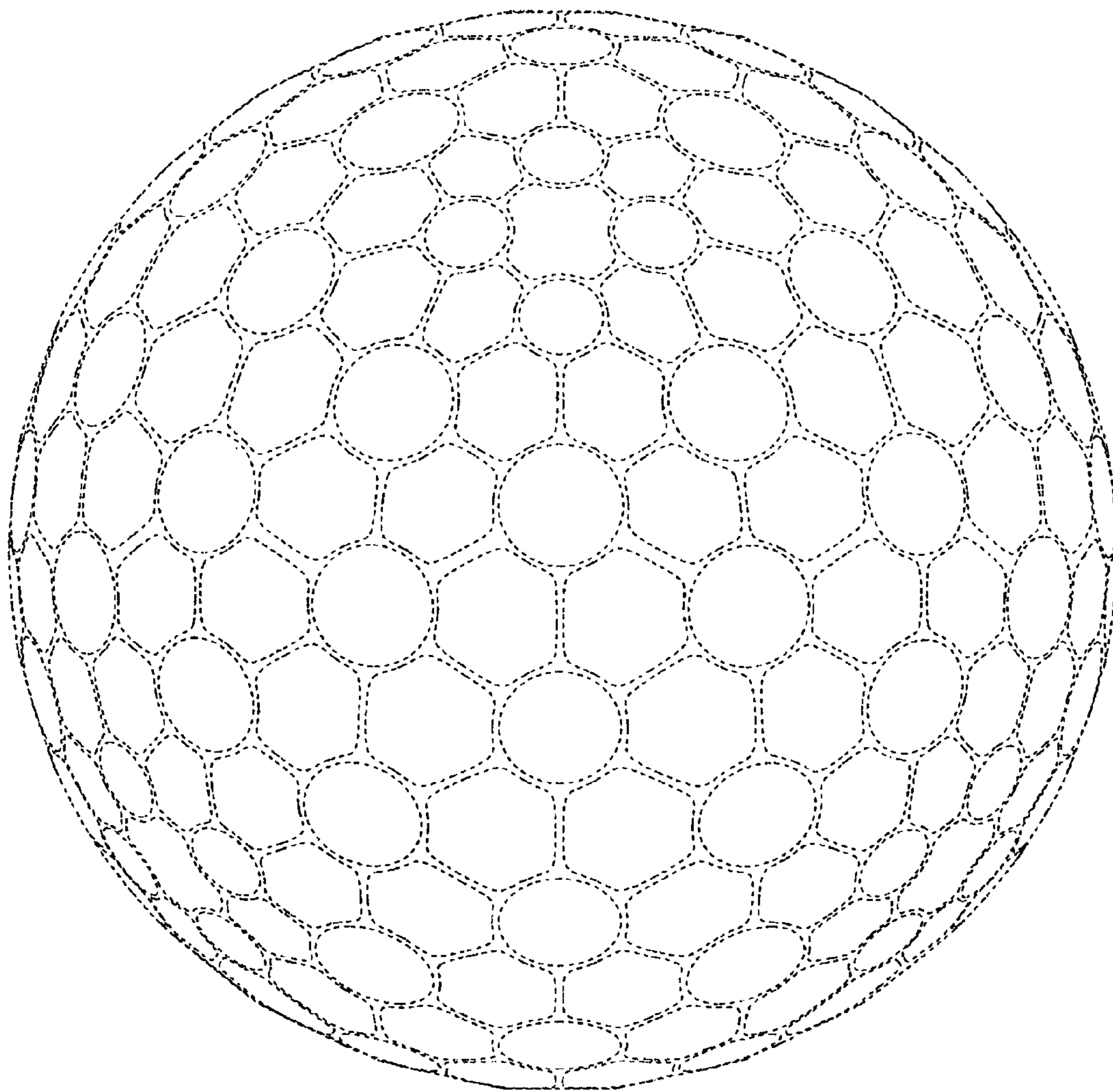

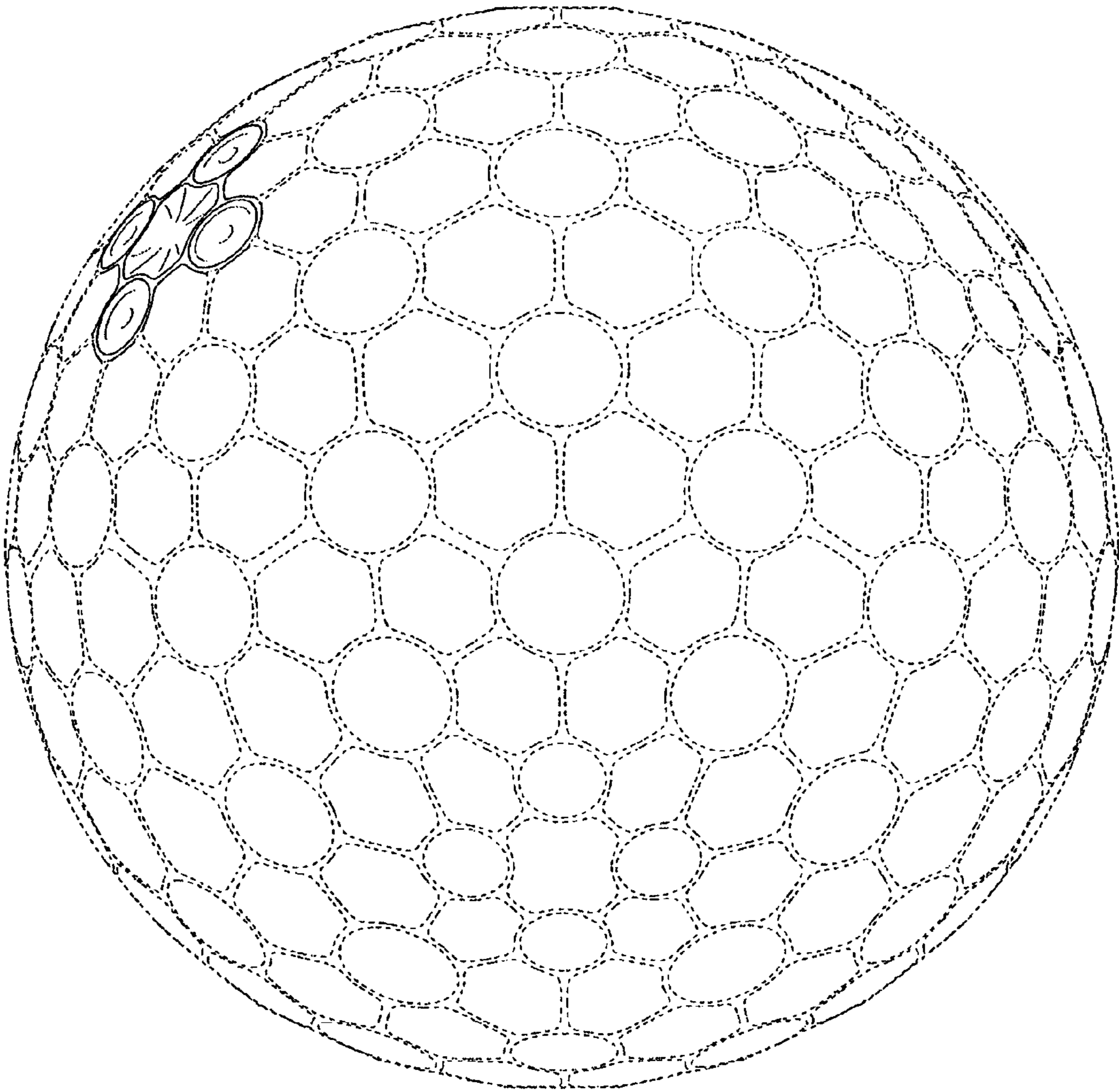

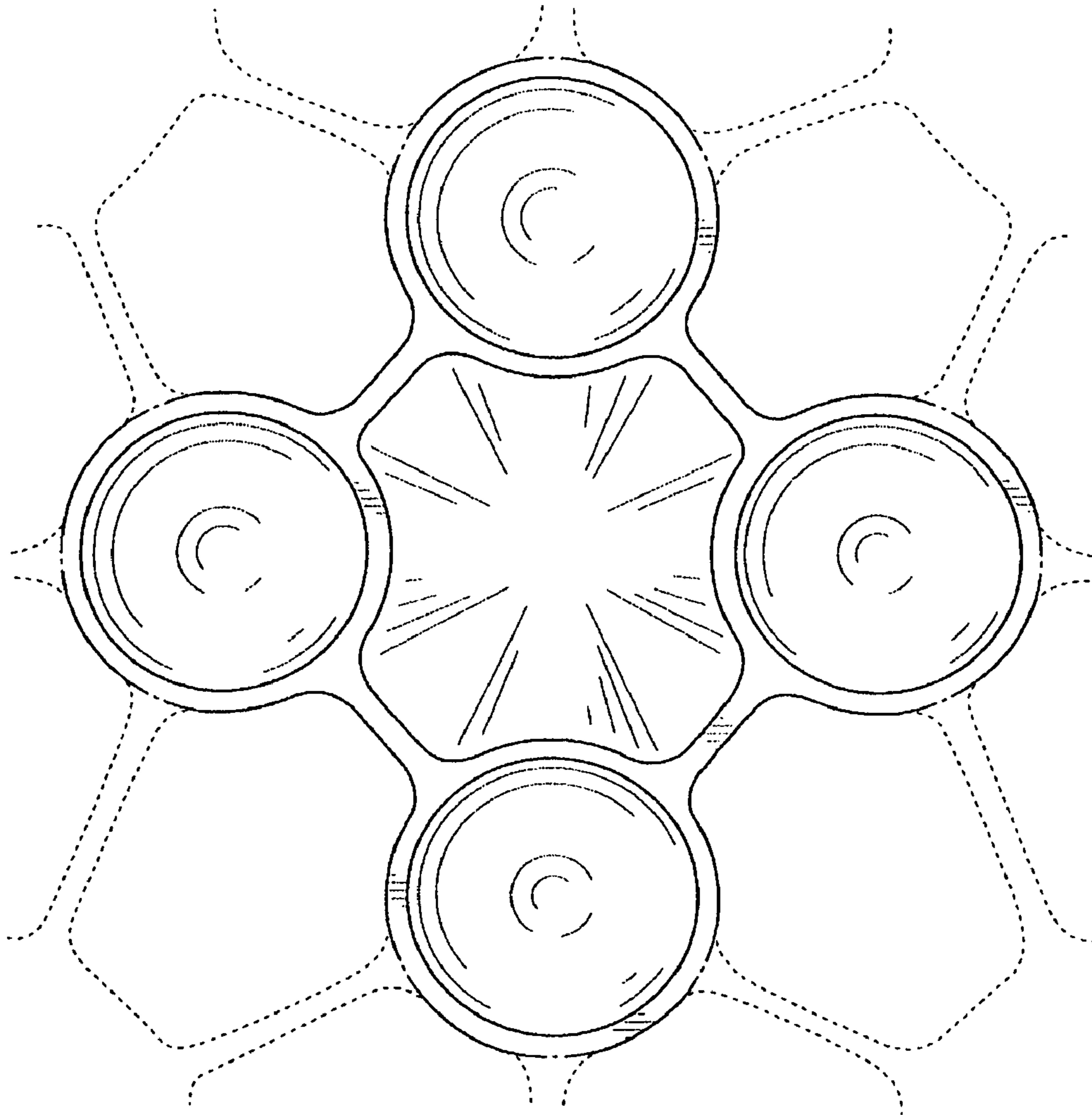
