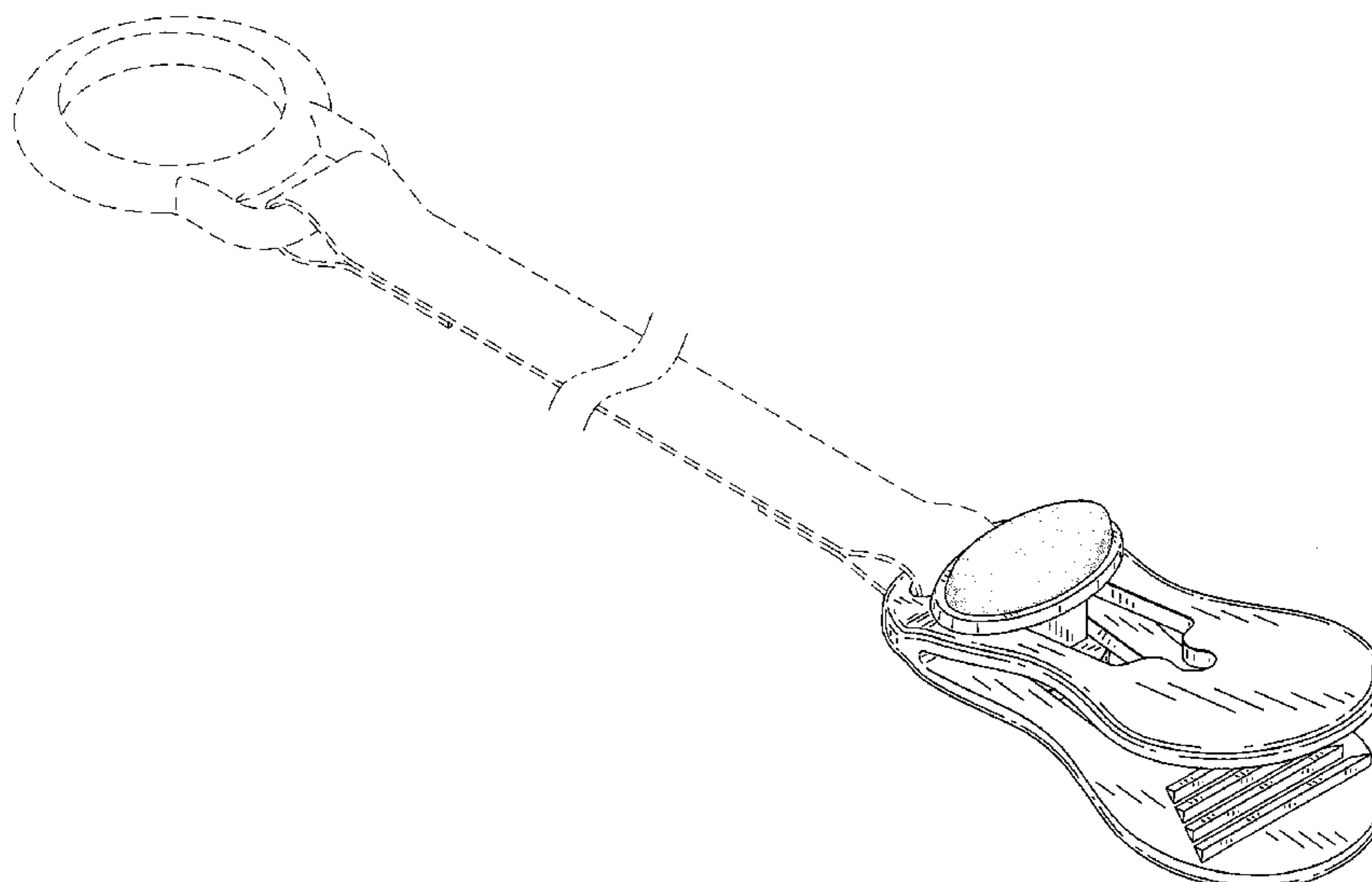
(57) **CLAIM**

The ornamental design for a securing device for a teether or pacifier, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a securing device for a teether or pacifier according to the present disclosure; FIG. 2 is a bottom perspective view of the securing device of FIG. 1; FIG. 3 is a top view of the securing device of FIG. 1; FIG. 4 is a bottom view of the securing device of FIG. 1; FIG. 5 is a side view of the securing device of FIG. 1, the opposite side being a mirror image thereto; FIG. 6 is a front view of the securing device of FIG. 1; and, FIG. 7 is a rear view of the securing device of FIG. 1. The broken lines in the drawings illustrating environmental structure or boundaries that form no part of the claimed design.

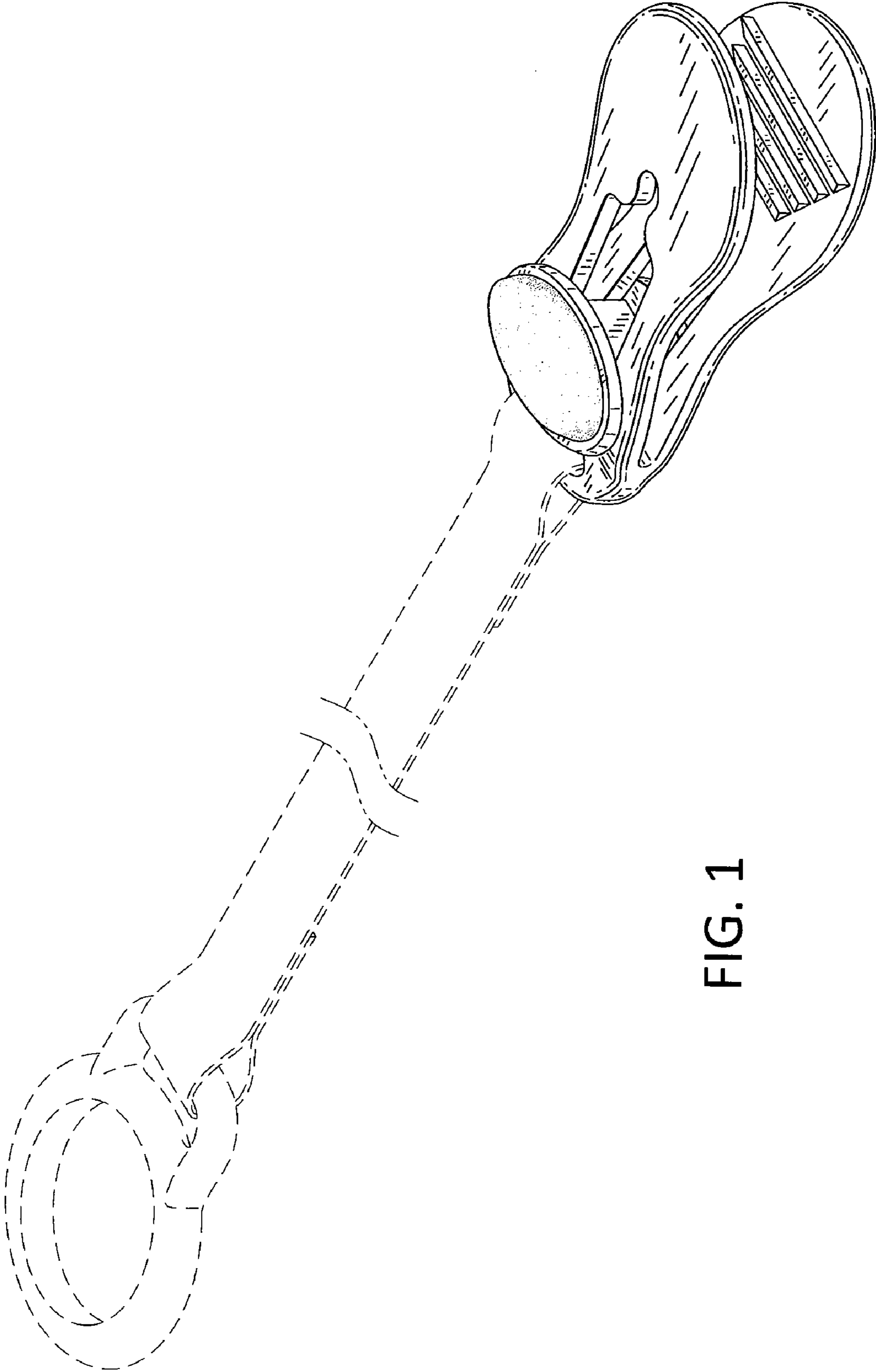

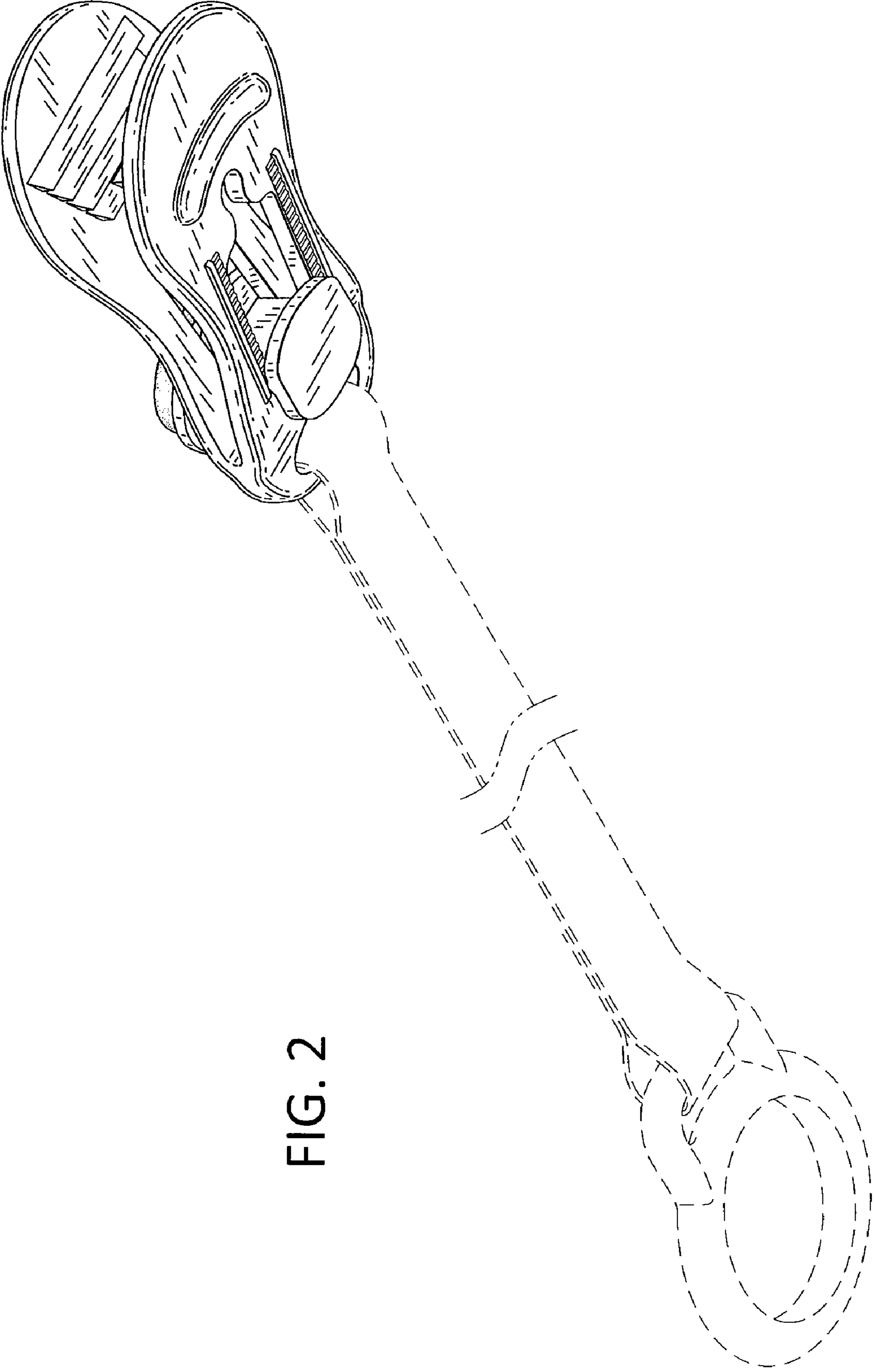

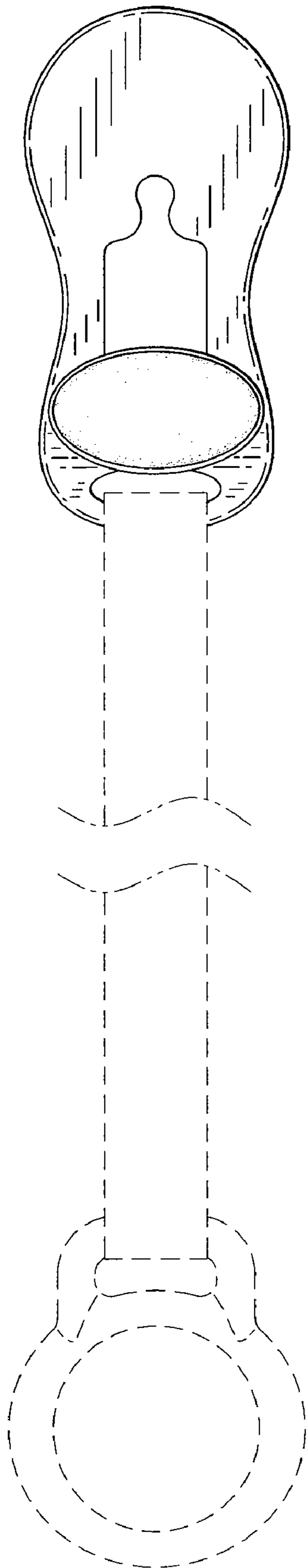

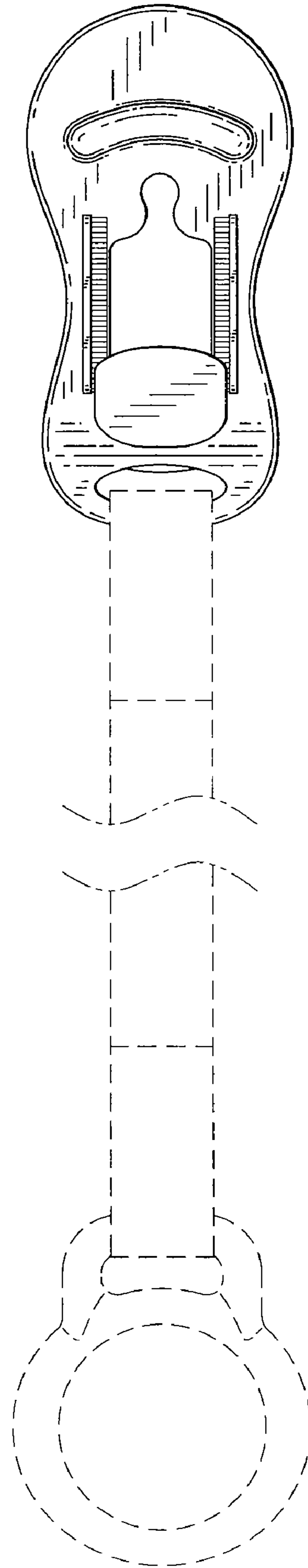

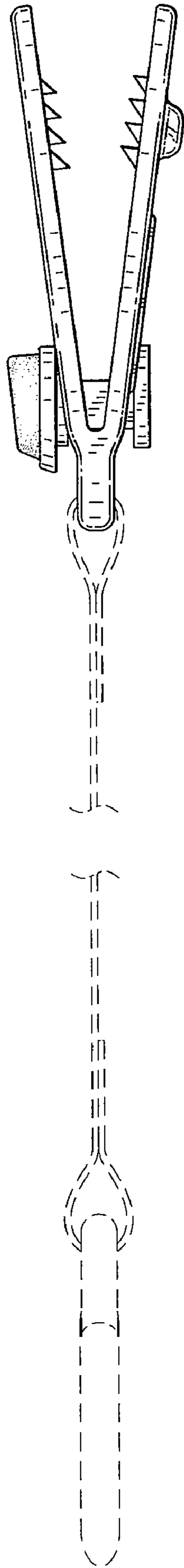

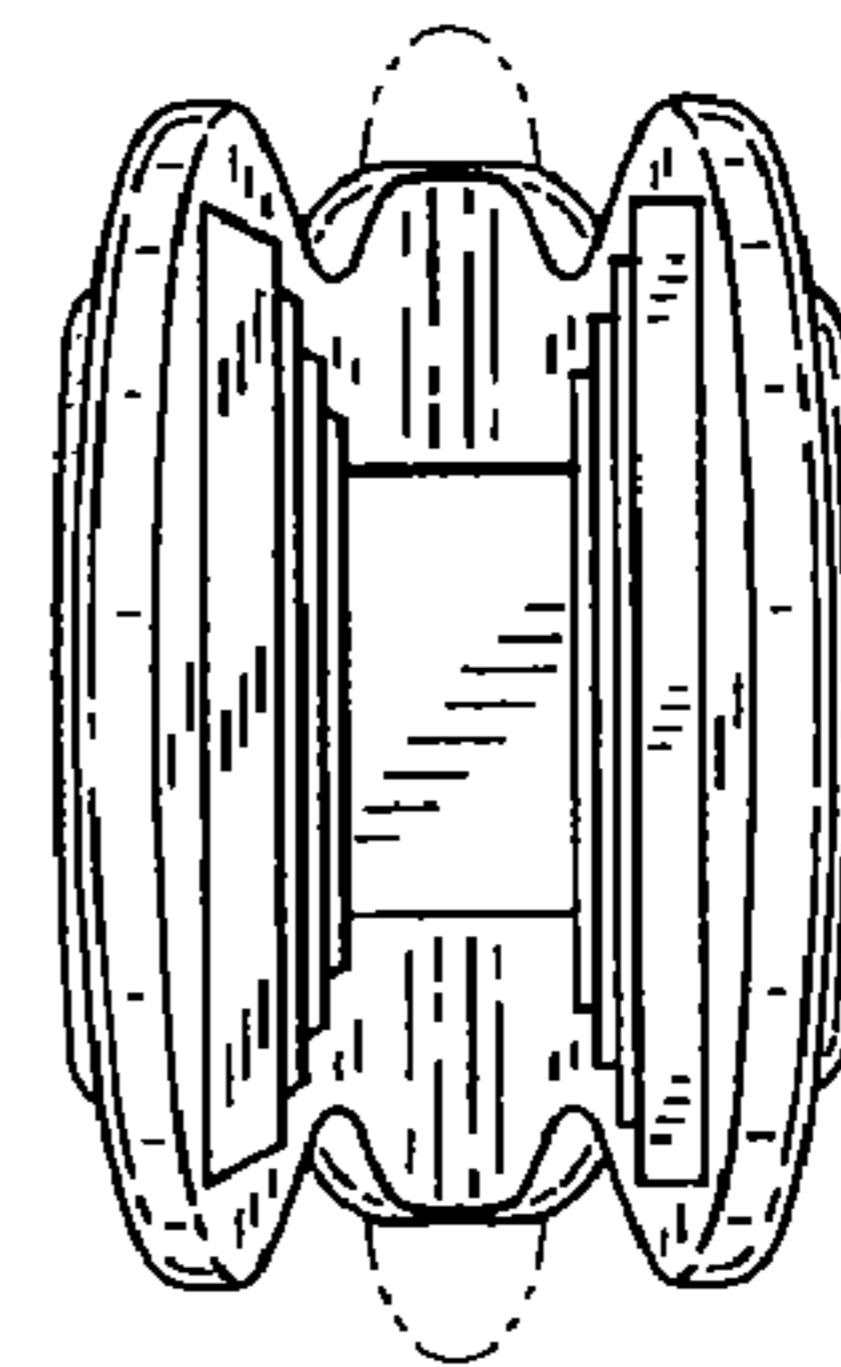

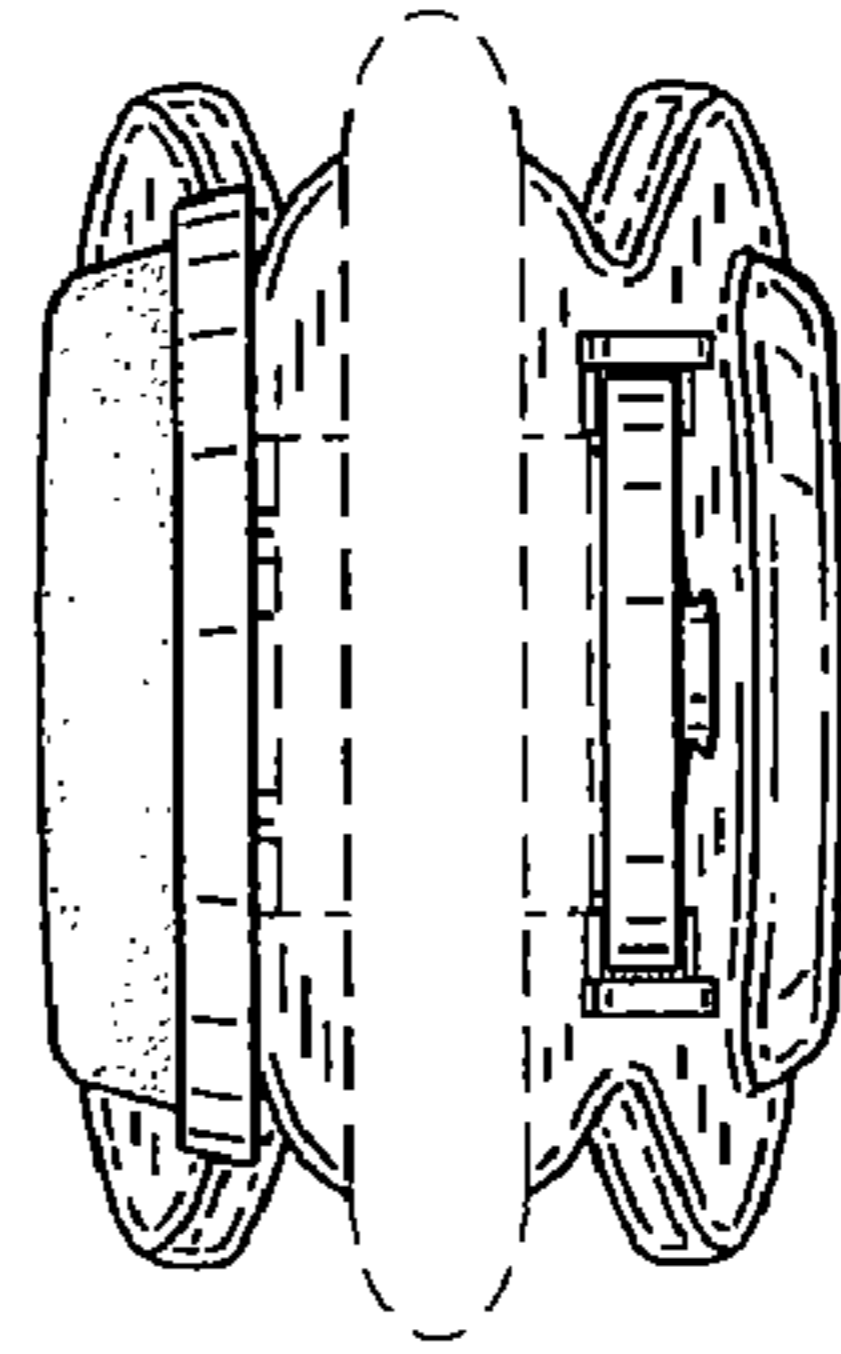
