FIG. 4 is a rear elevation view of the vacuum cleaner.

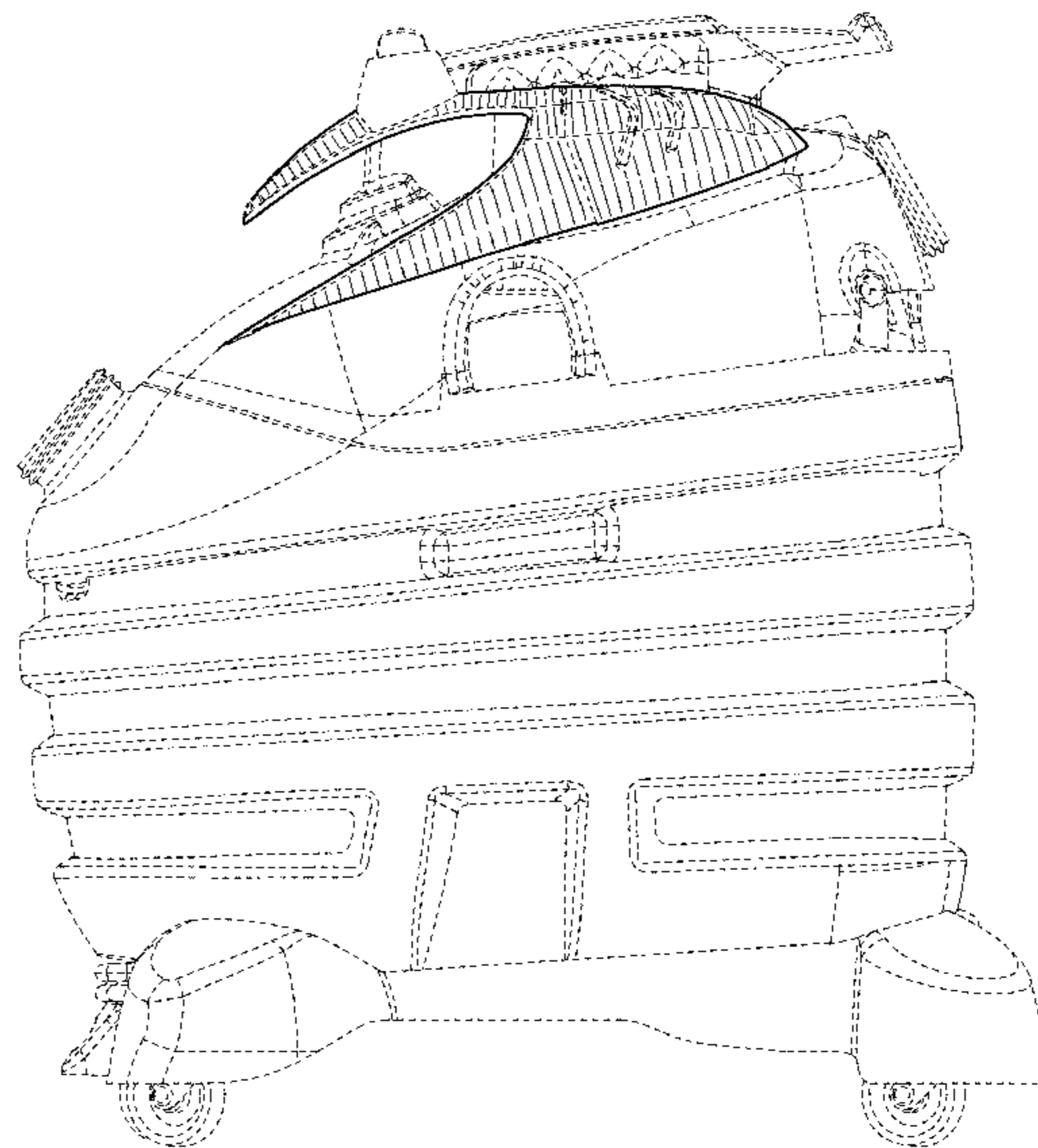
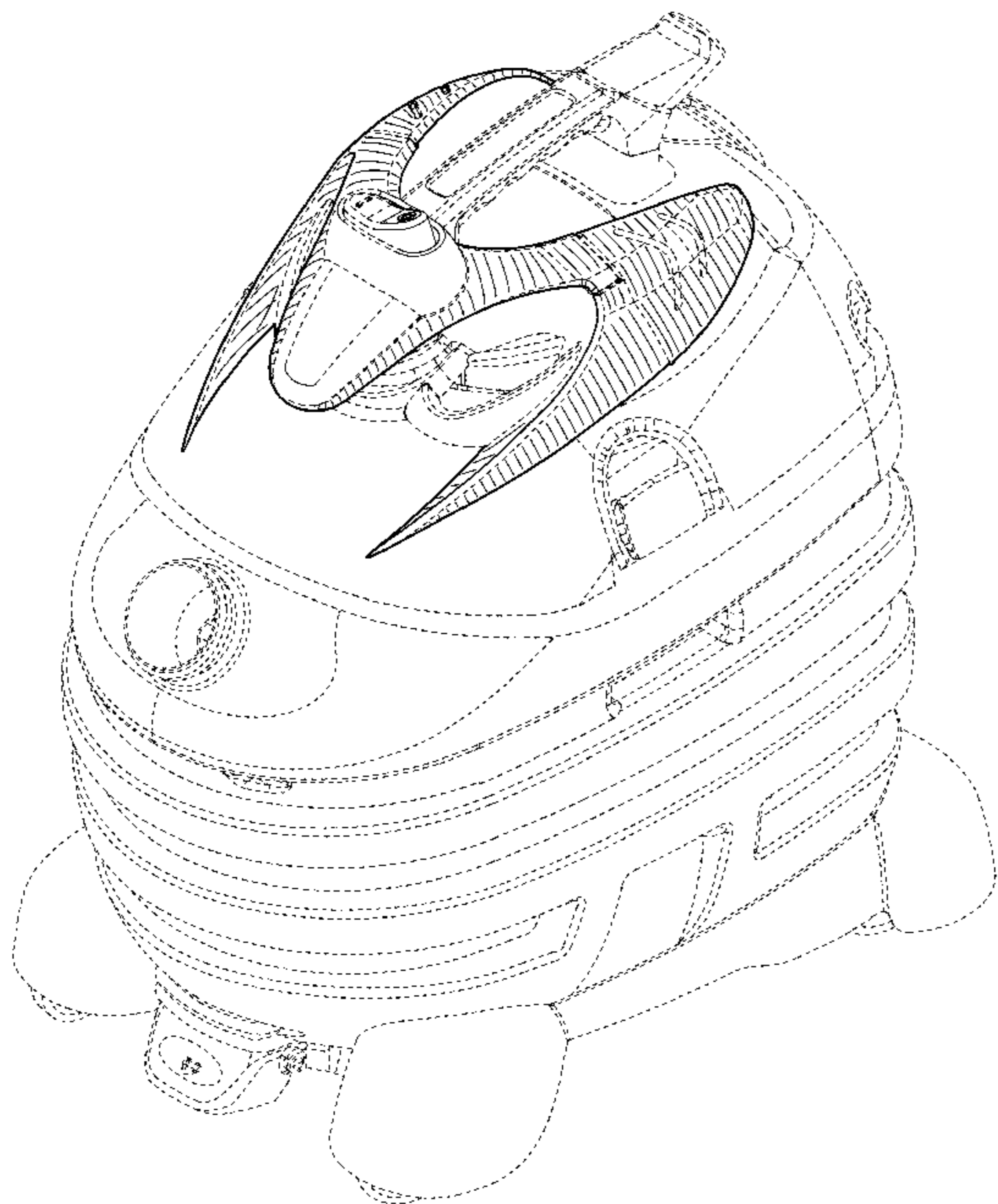
FIG. 5 is a right side elevation view of the vacuum cleaner.

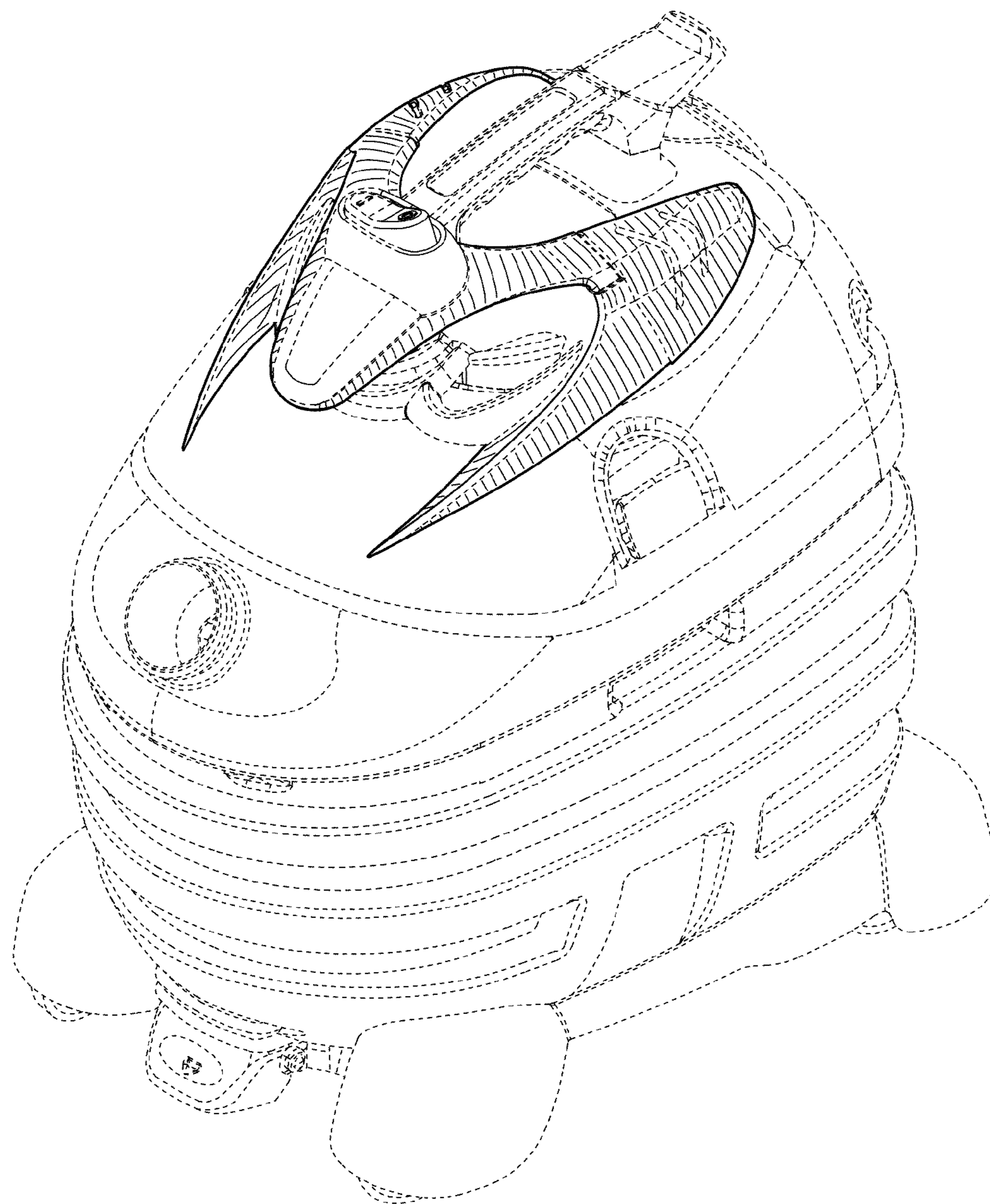

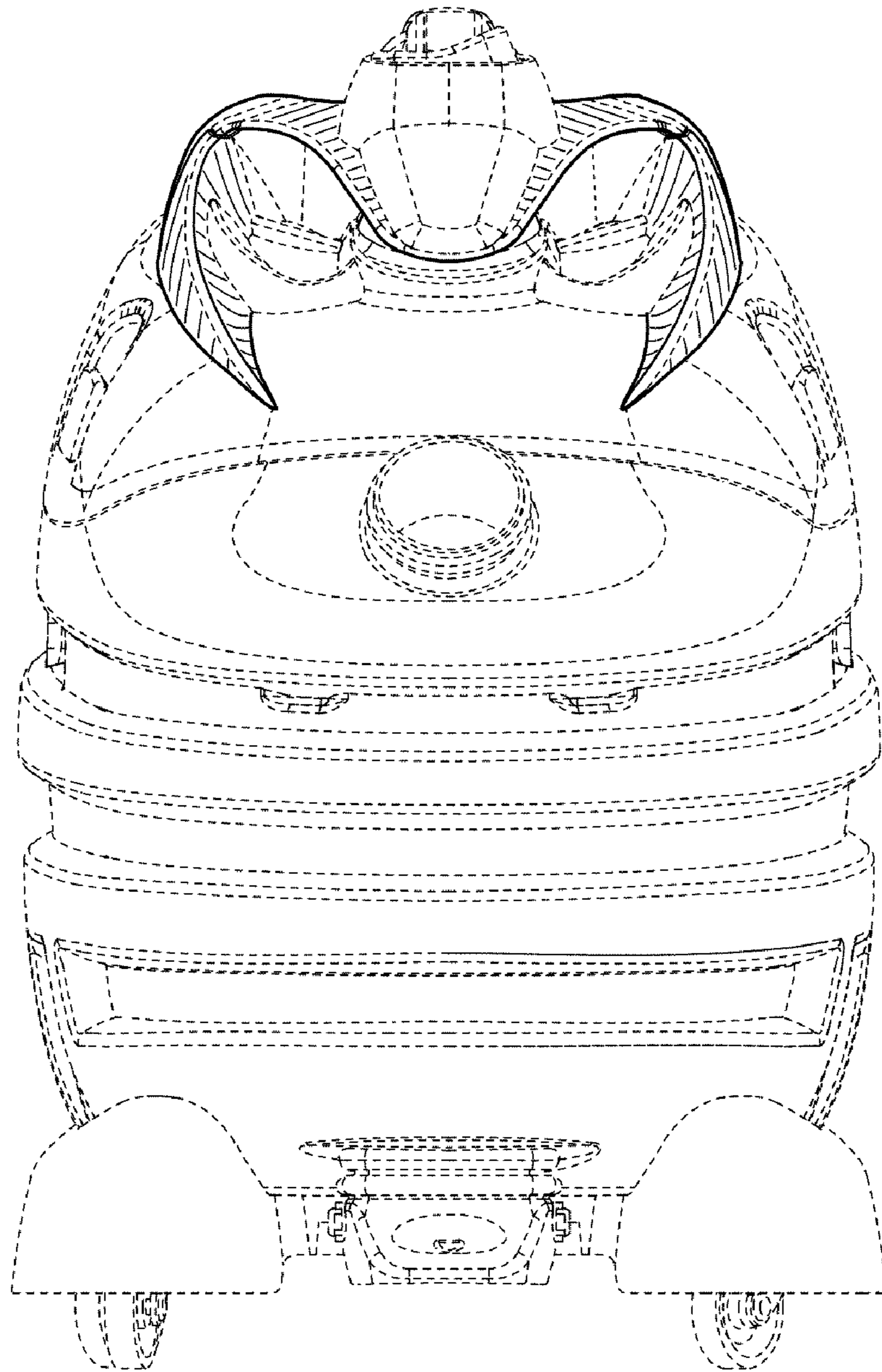

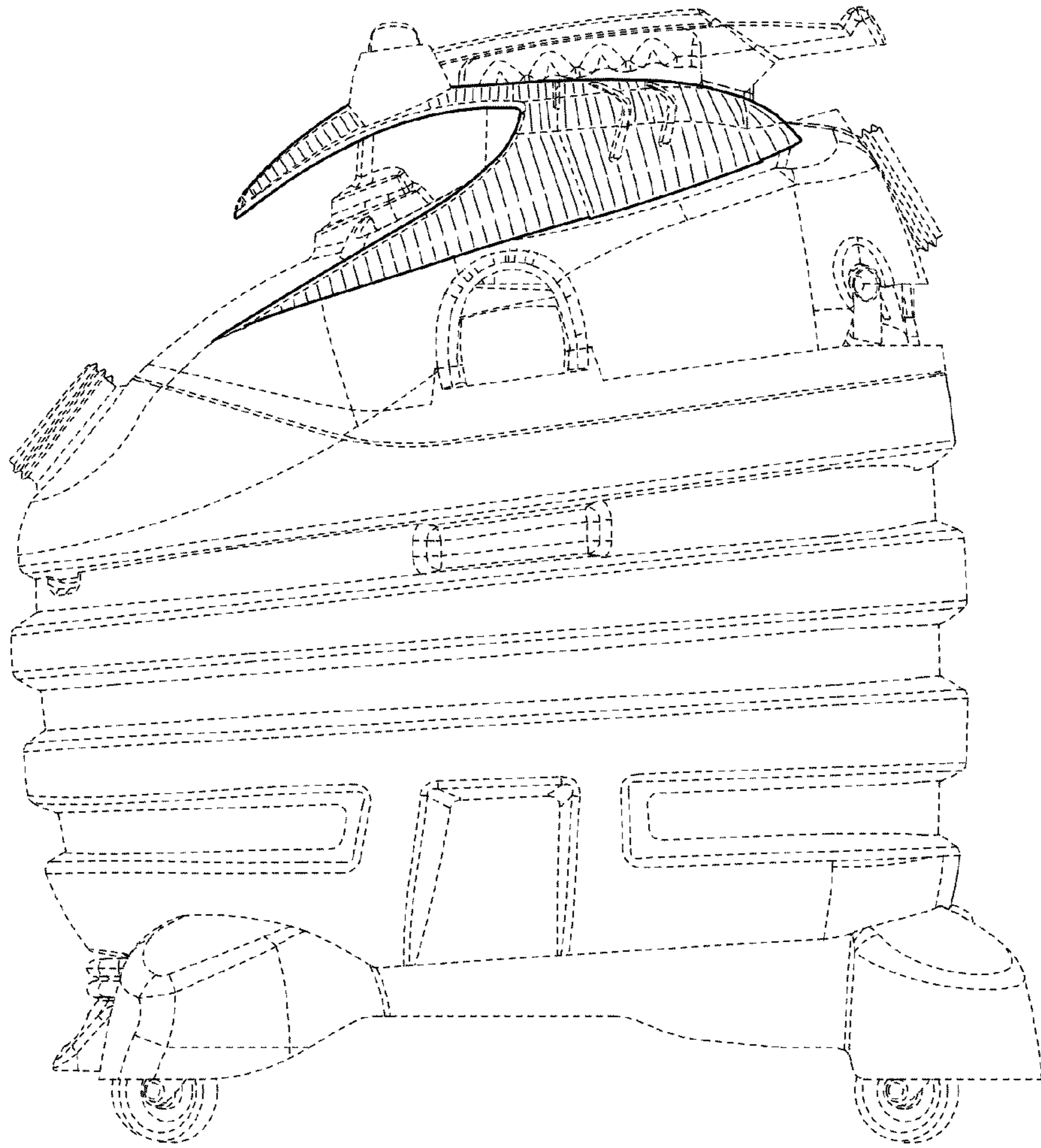

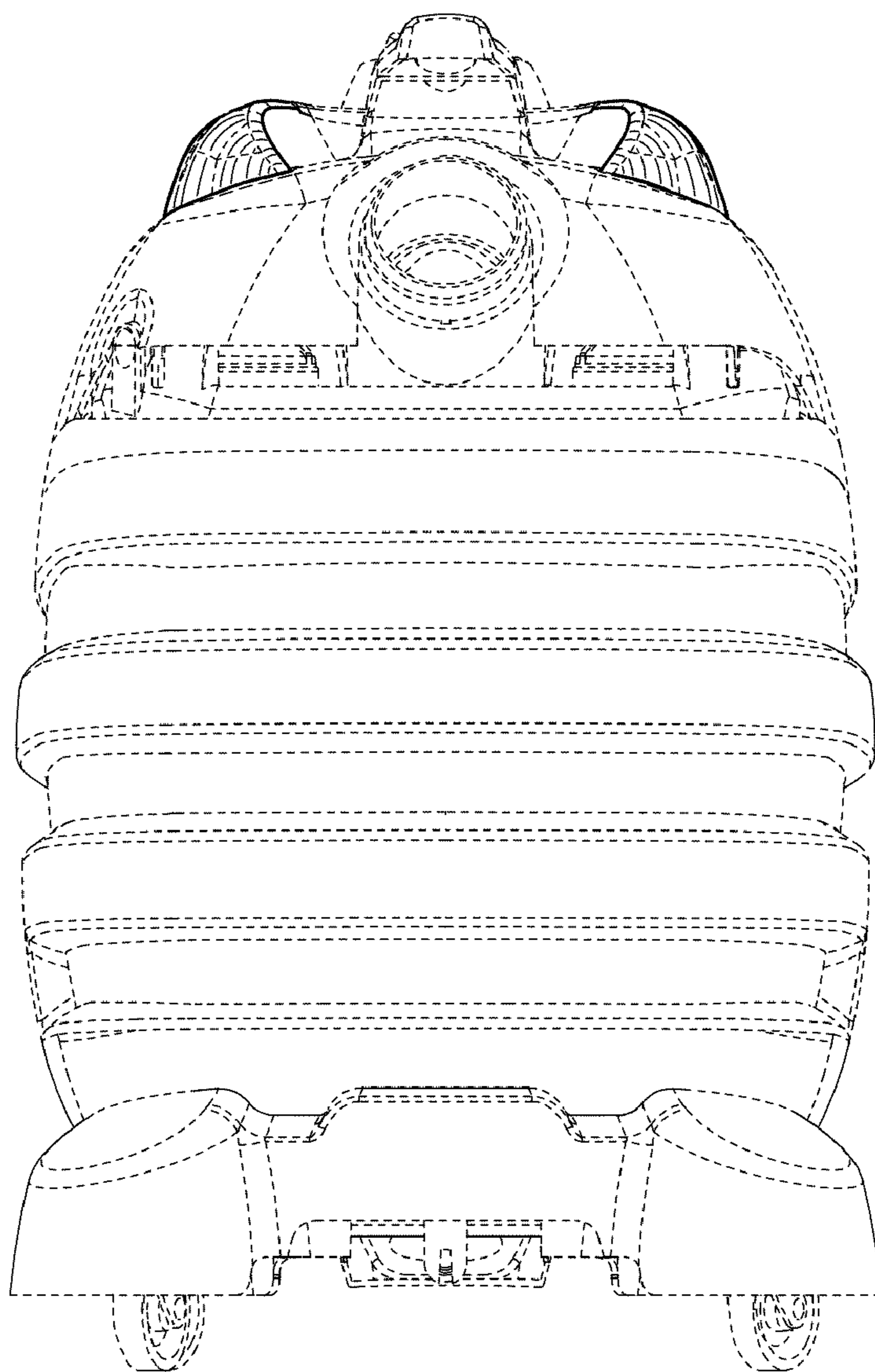

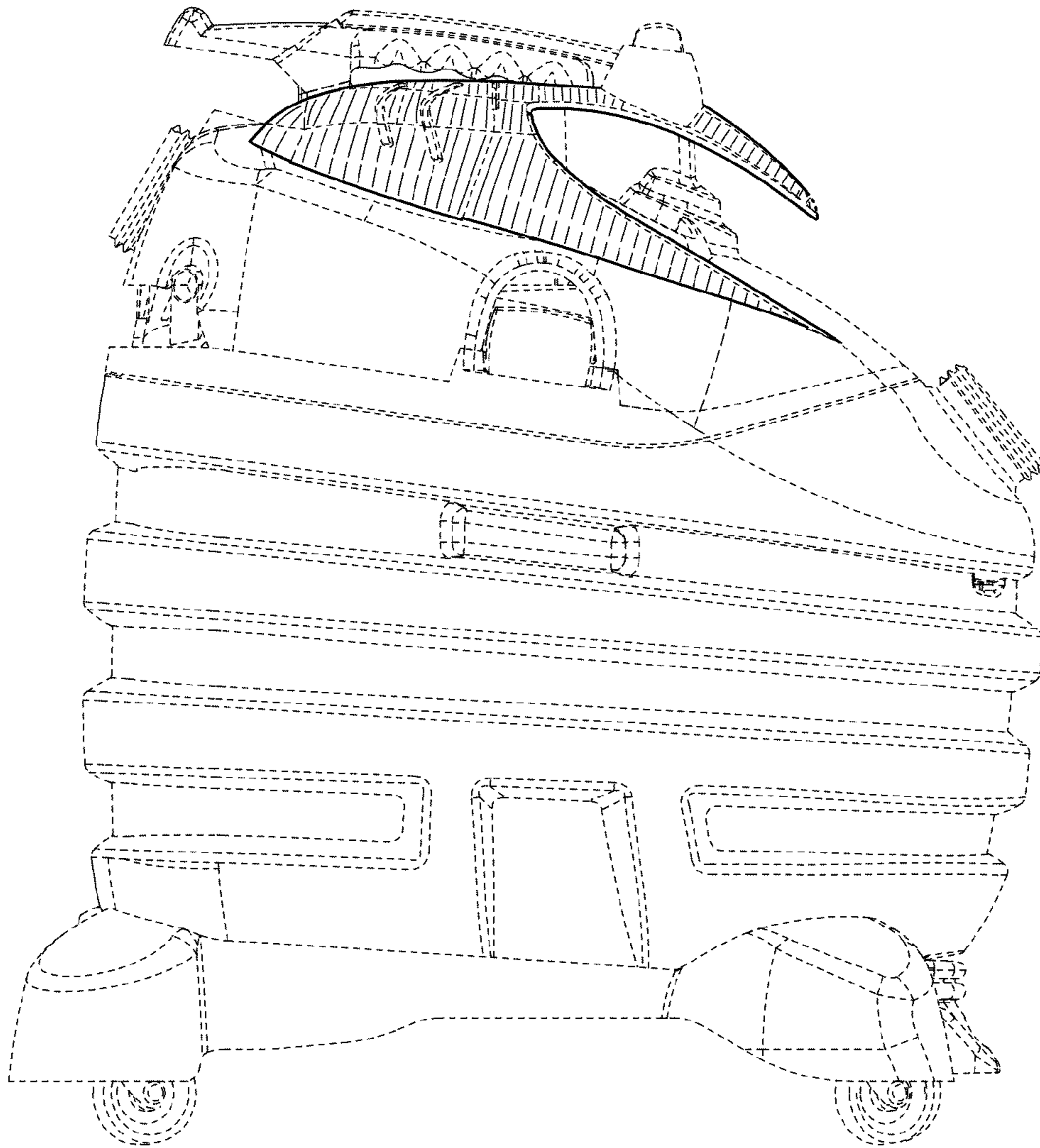

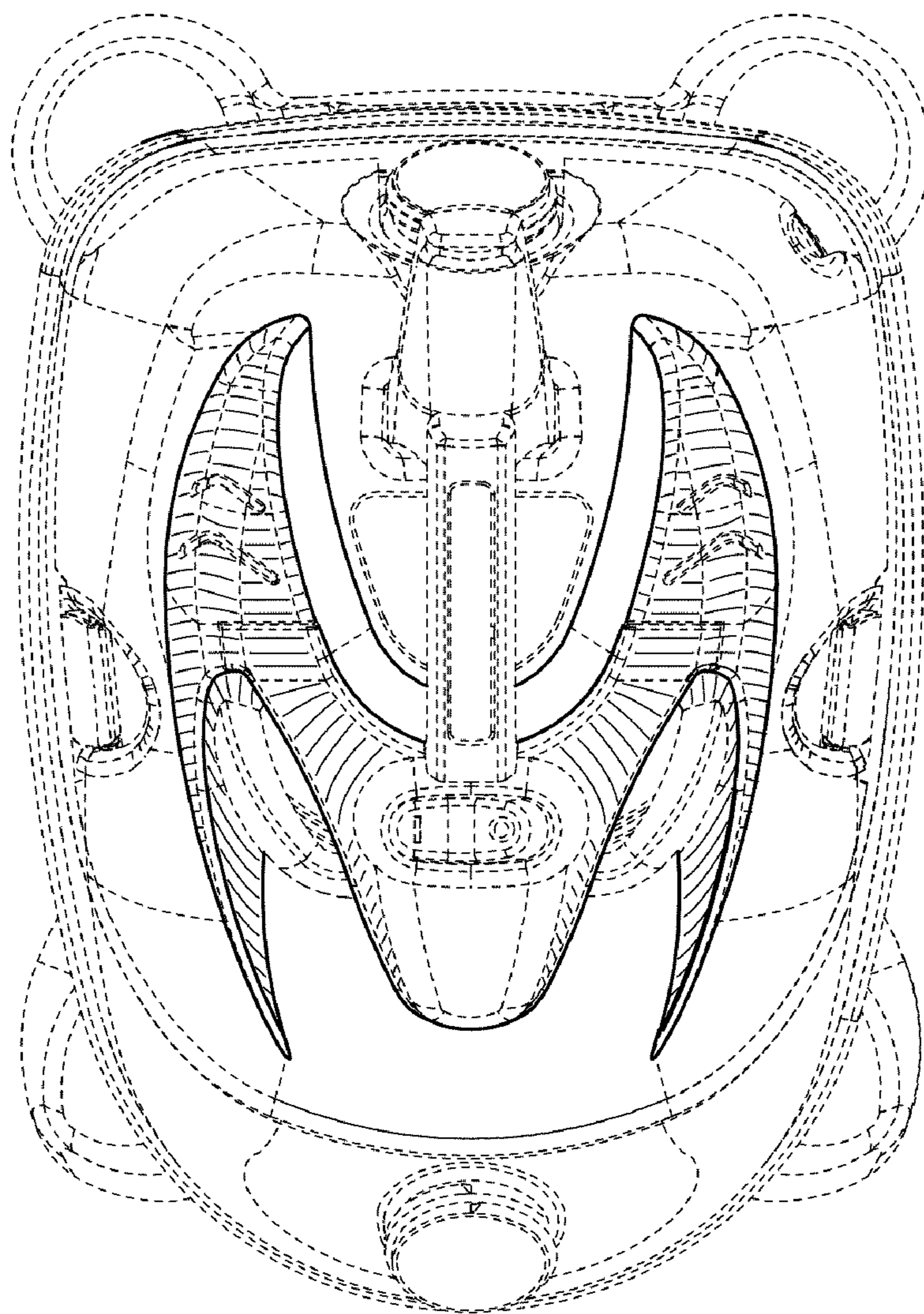

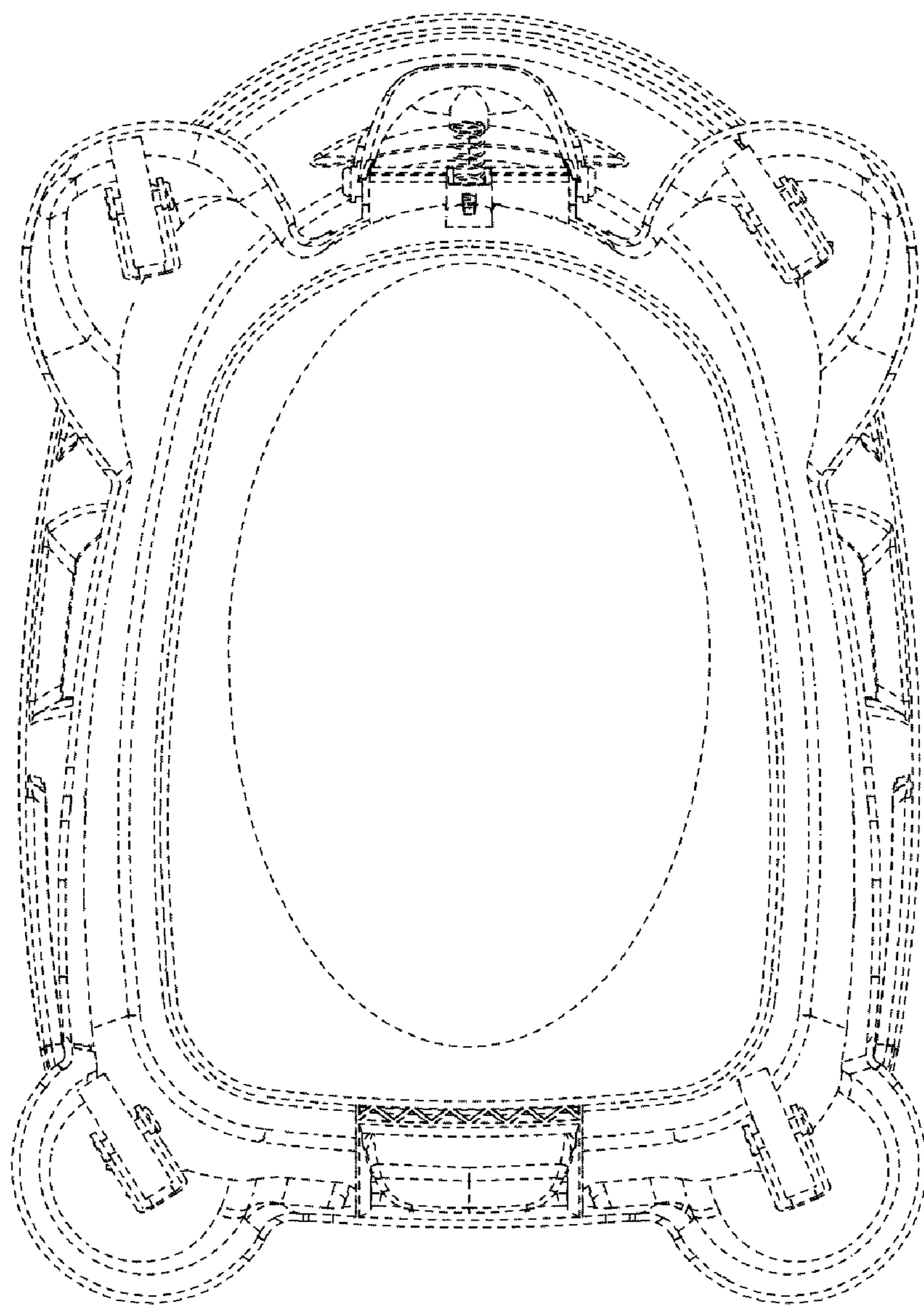
