(57) **CLAIM**

The ornamental design for shopping cart, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective rear view of the shopping cart; FIG. 2 is a perspective front view of the shopping cart; FIG. 3 is a front view of the shopping cart; FIG. 4 is a rear view of the shopping cart; FIG. 5 is a right hand side view of the shopping cart; FIG. 6 is a top view of the shopping cart; FIG. 7 is a top view of the shopping cart; and, FIG. 8 is a bottom view of the shopping cart.

The broken lines in the drawings are included for the purpose of illustrating environment and forms no part of the claimed design.

The design consists of the features of shape and configuration of the seat part of the shopping cart shown in continuous lines in the drawings.

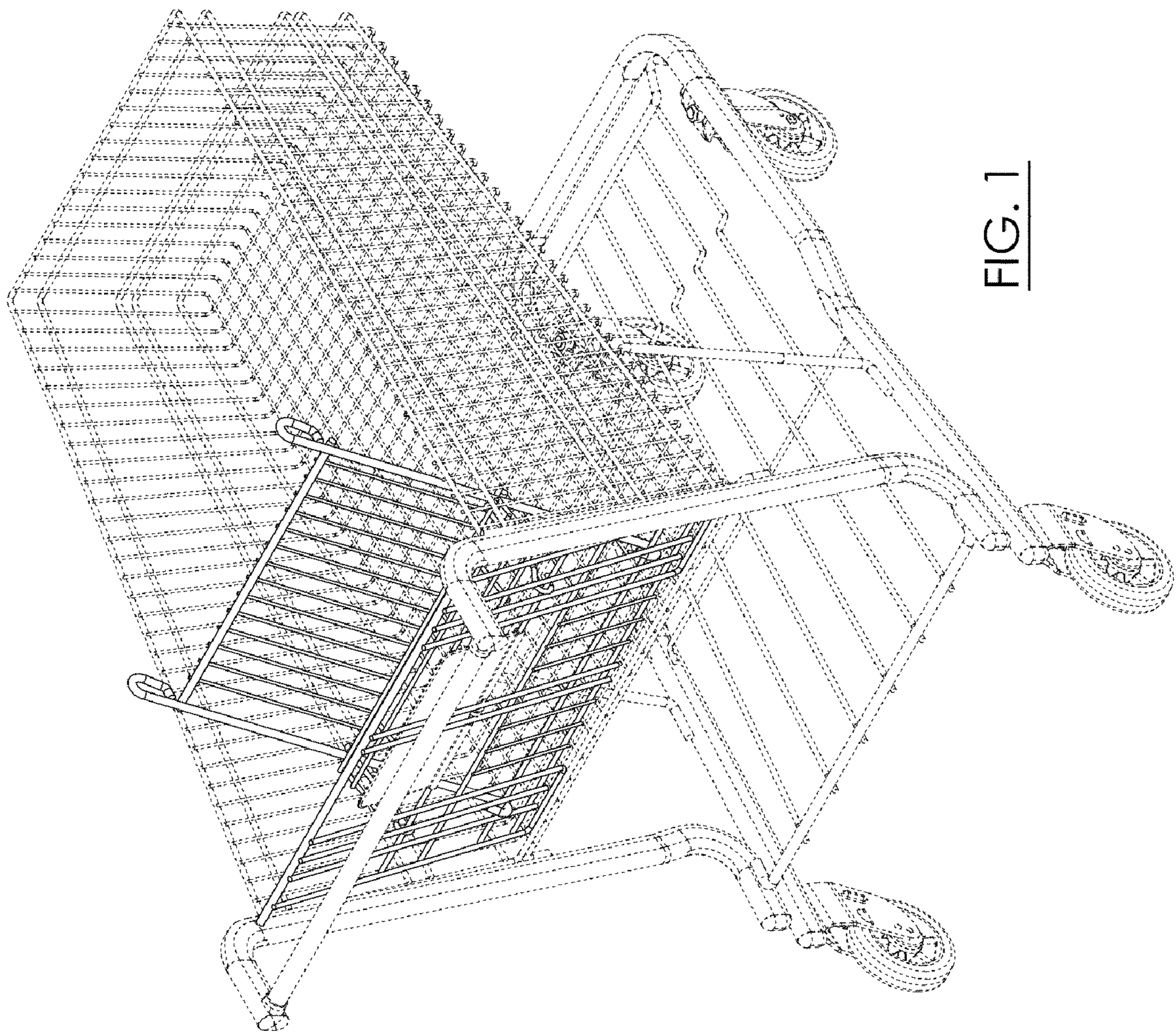

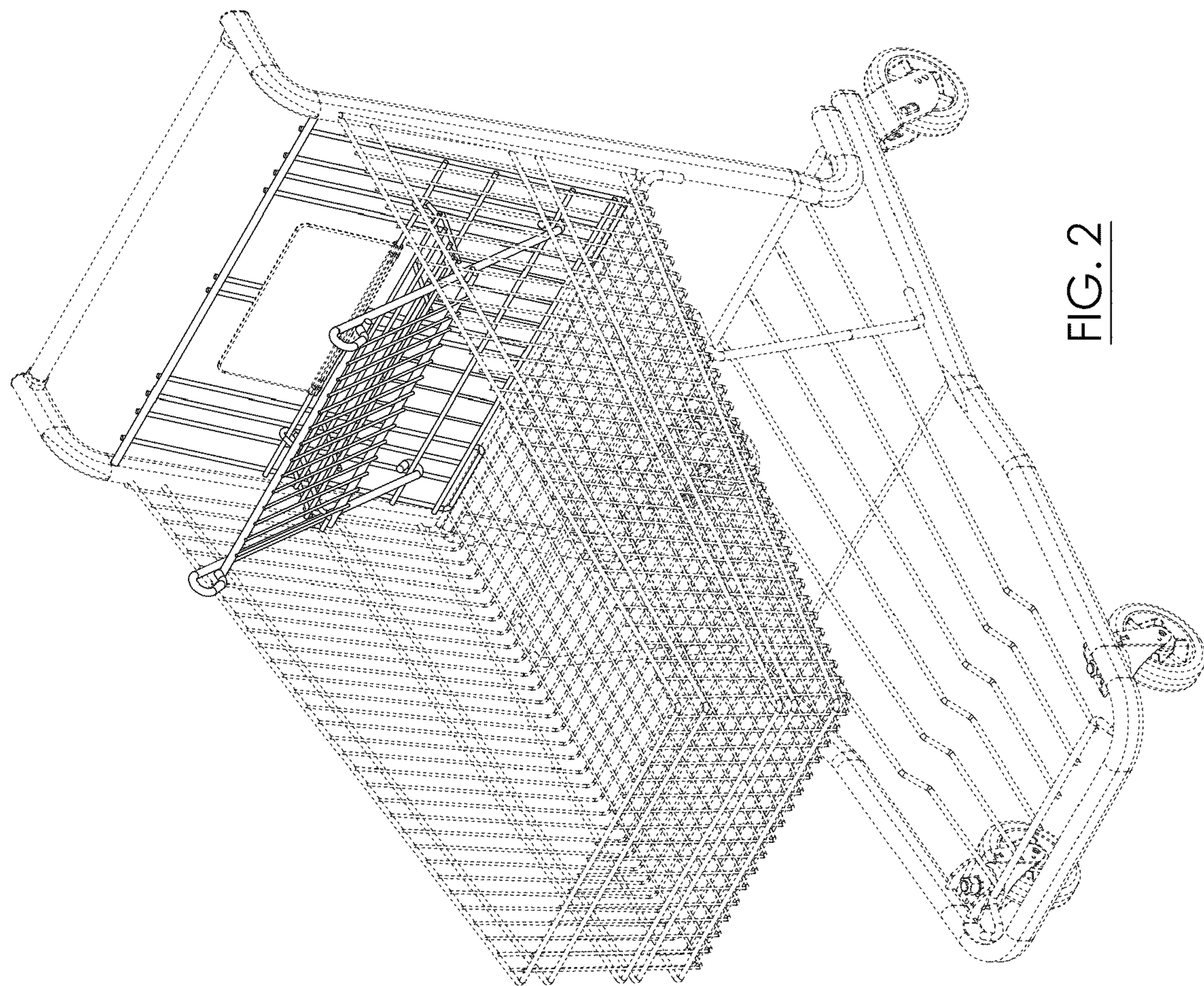

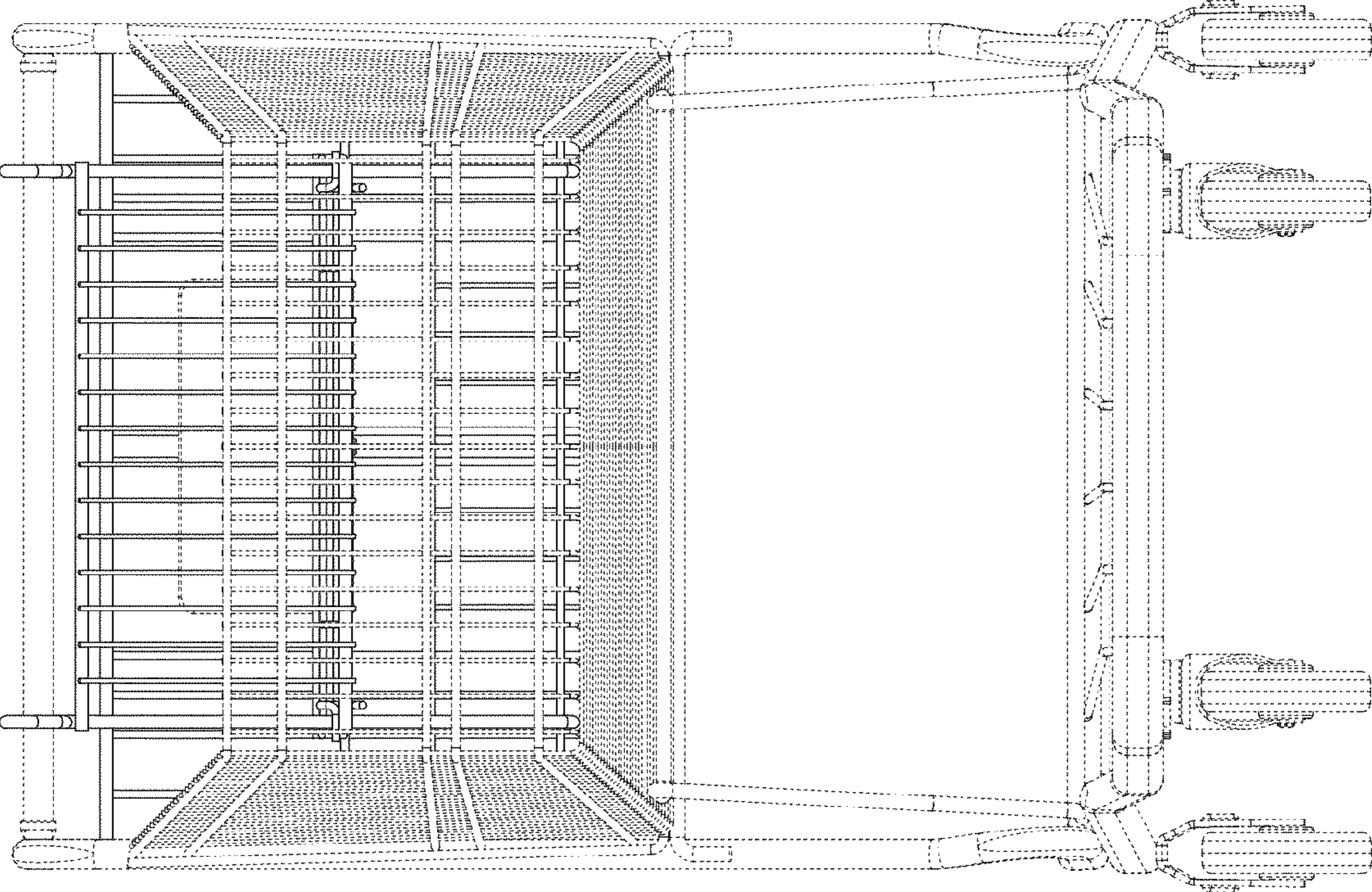

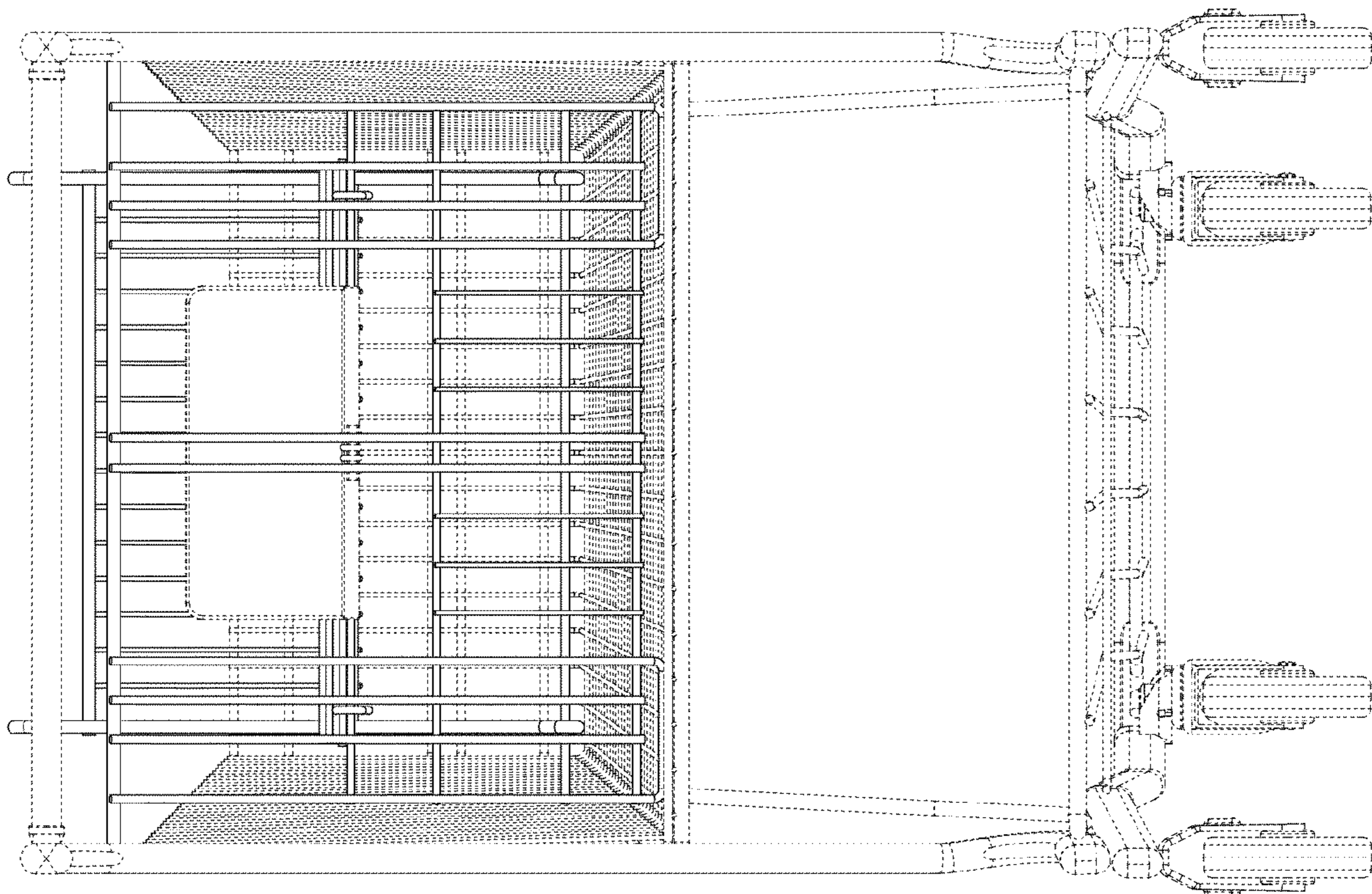

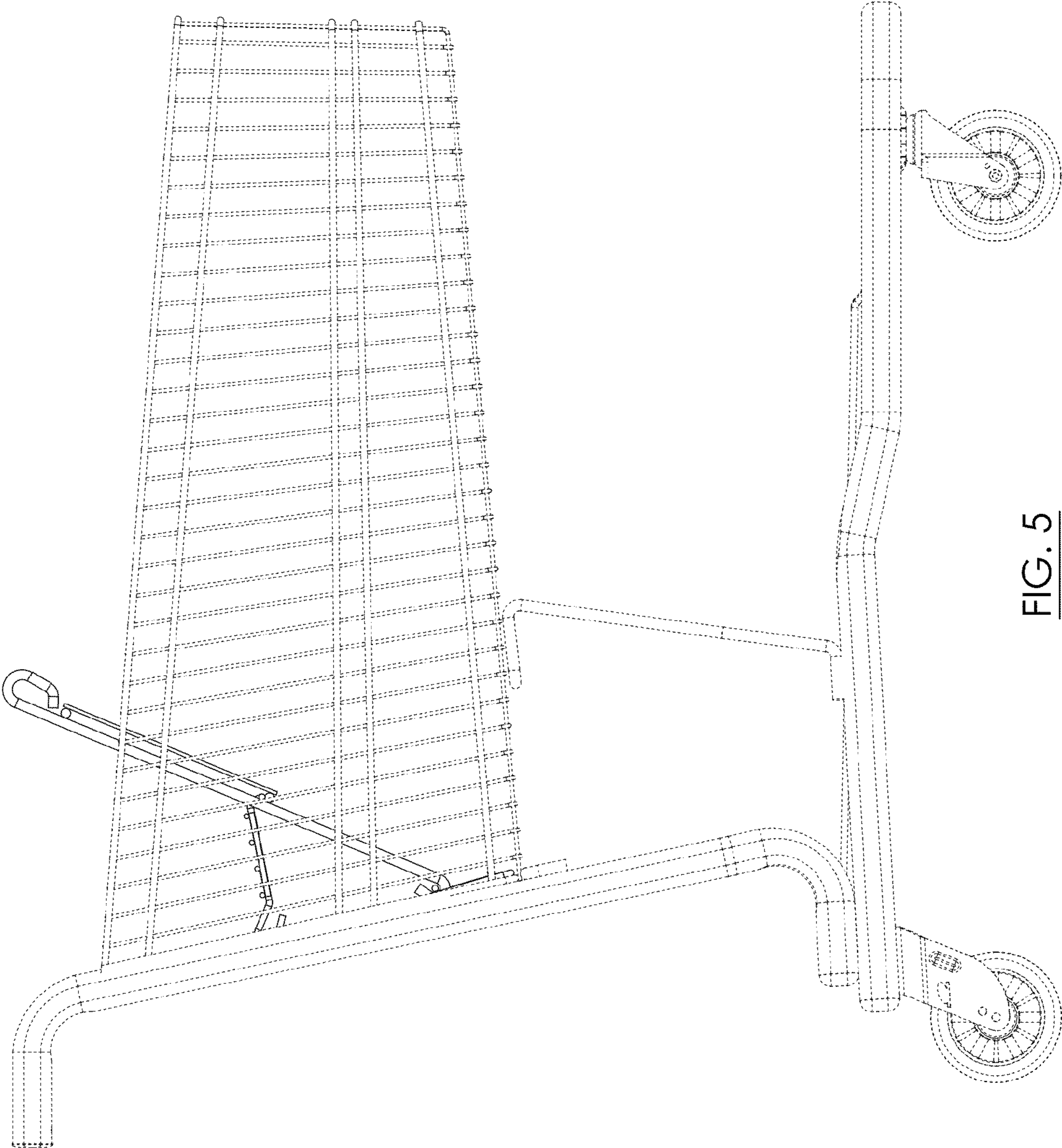

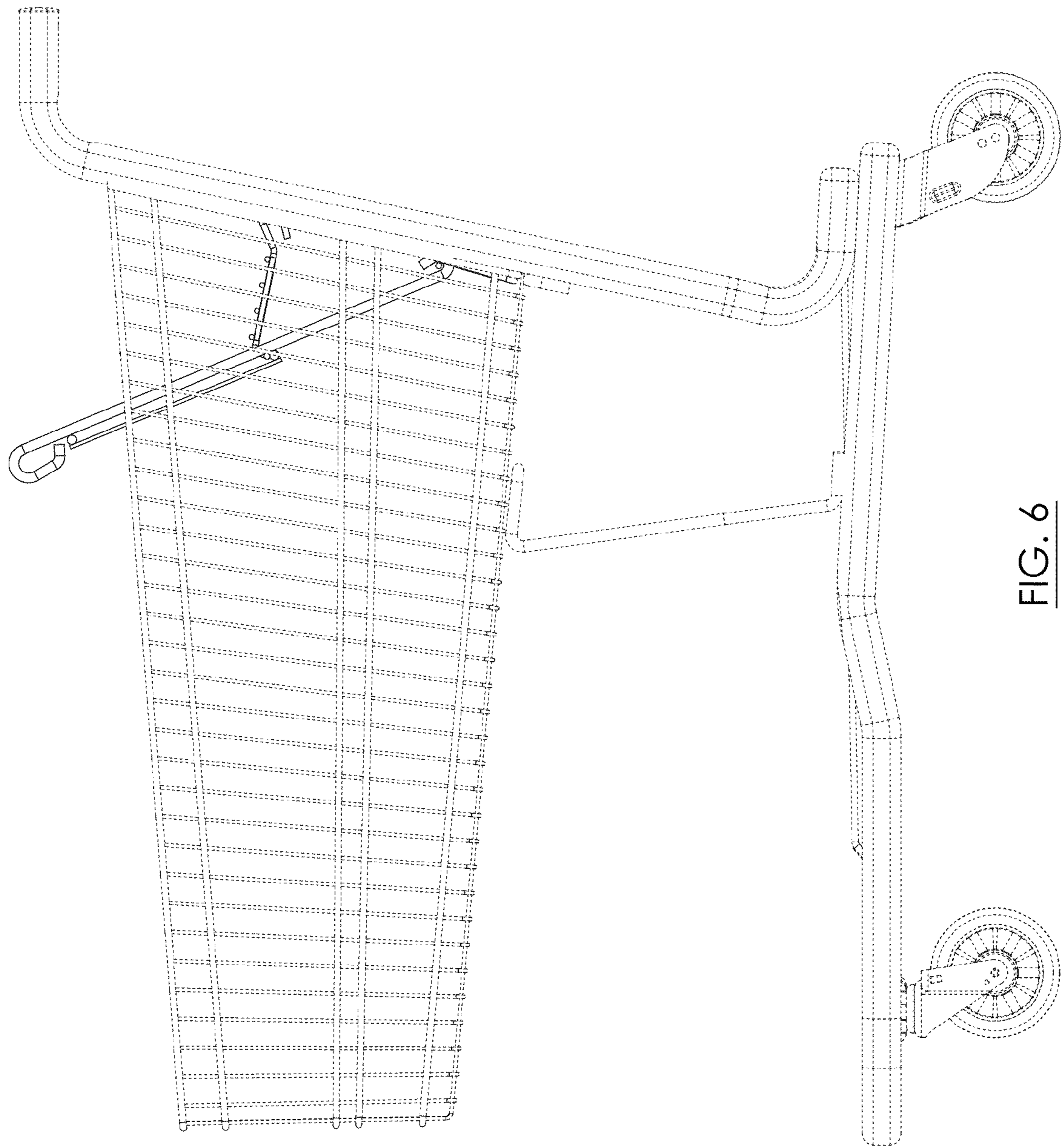

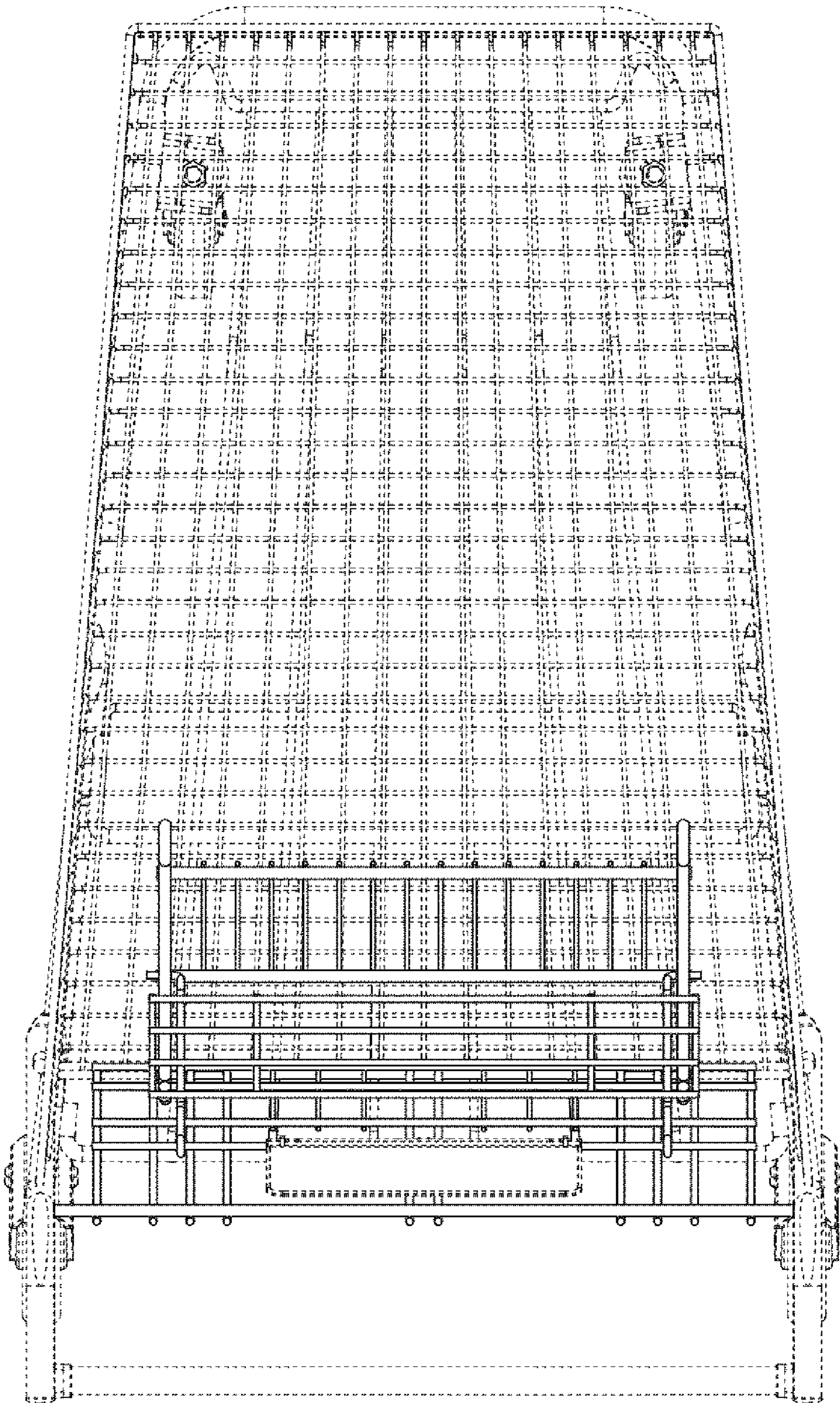

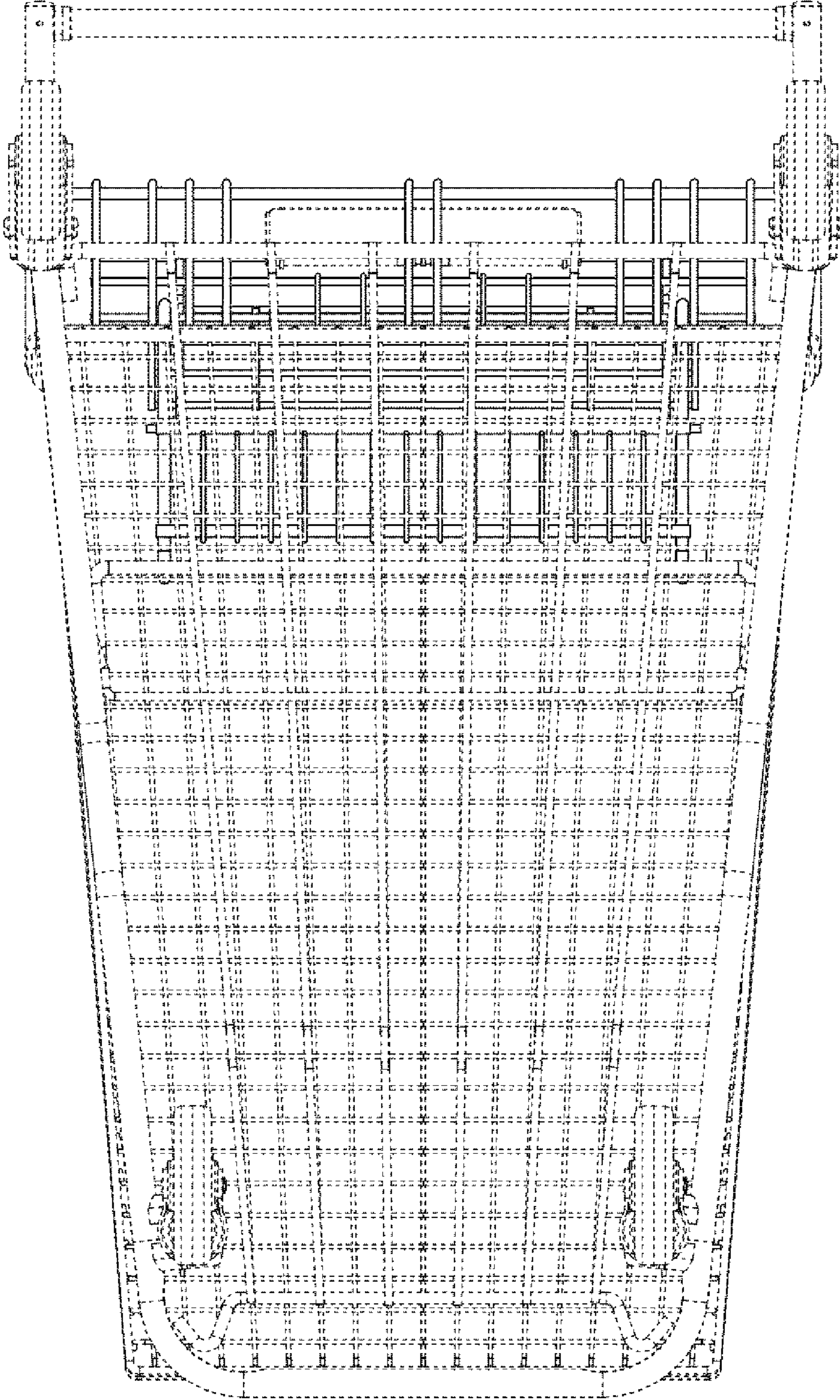
