FIG. 25 is a front perspective view of a fifth embodiment of the new ornamental cinch bag shown in an unopened configuration;

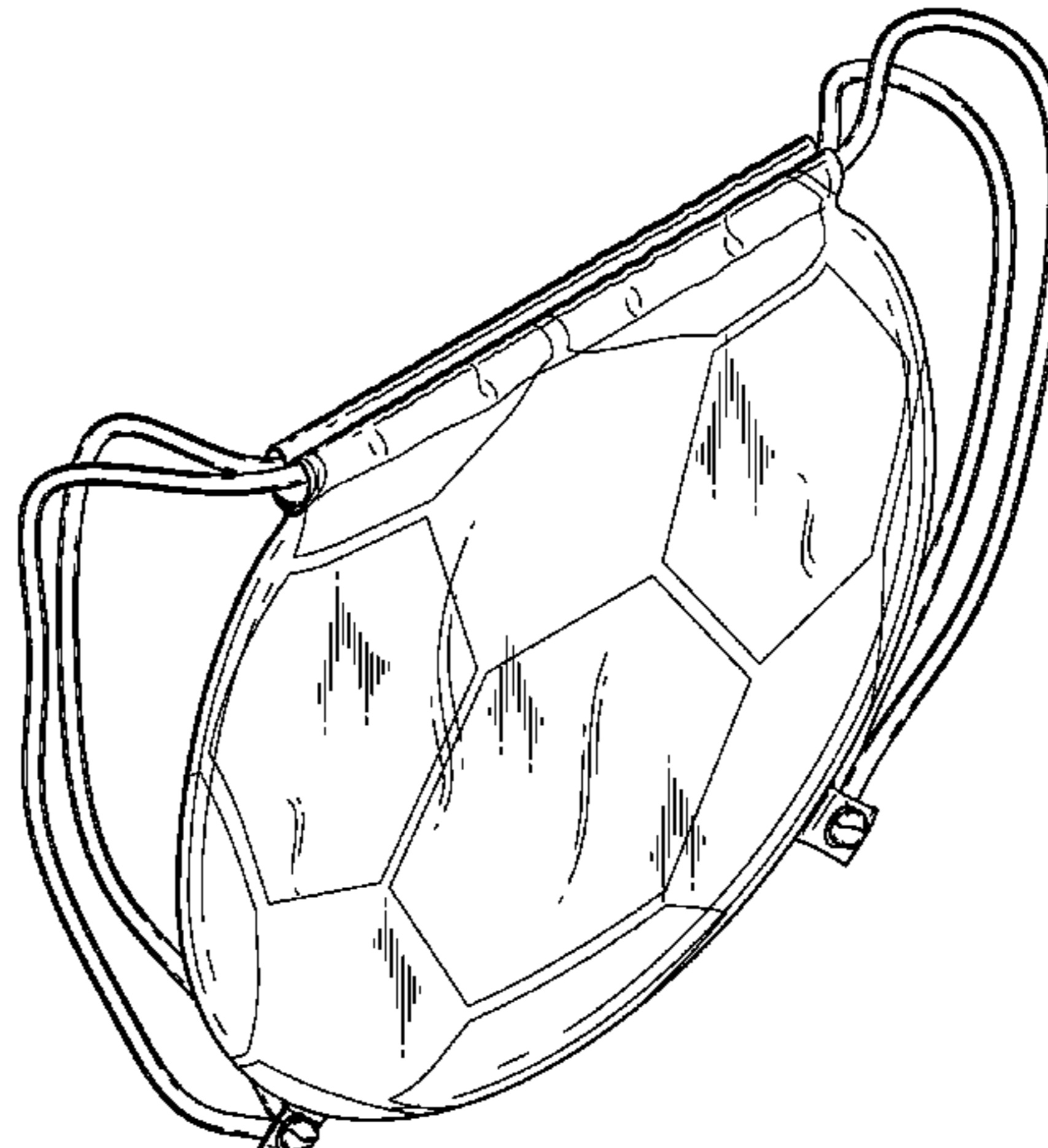
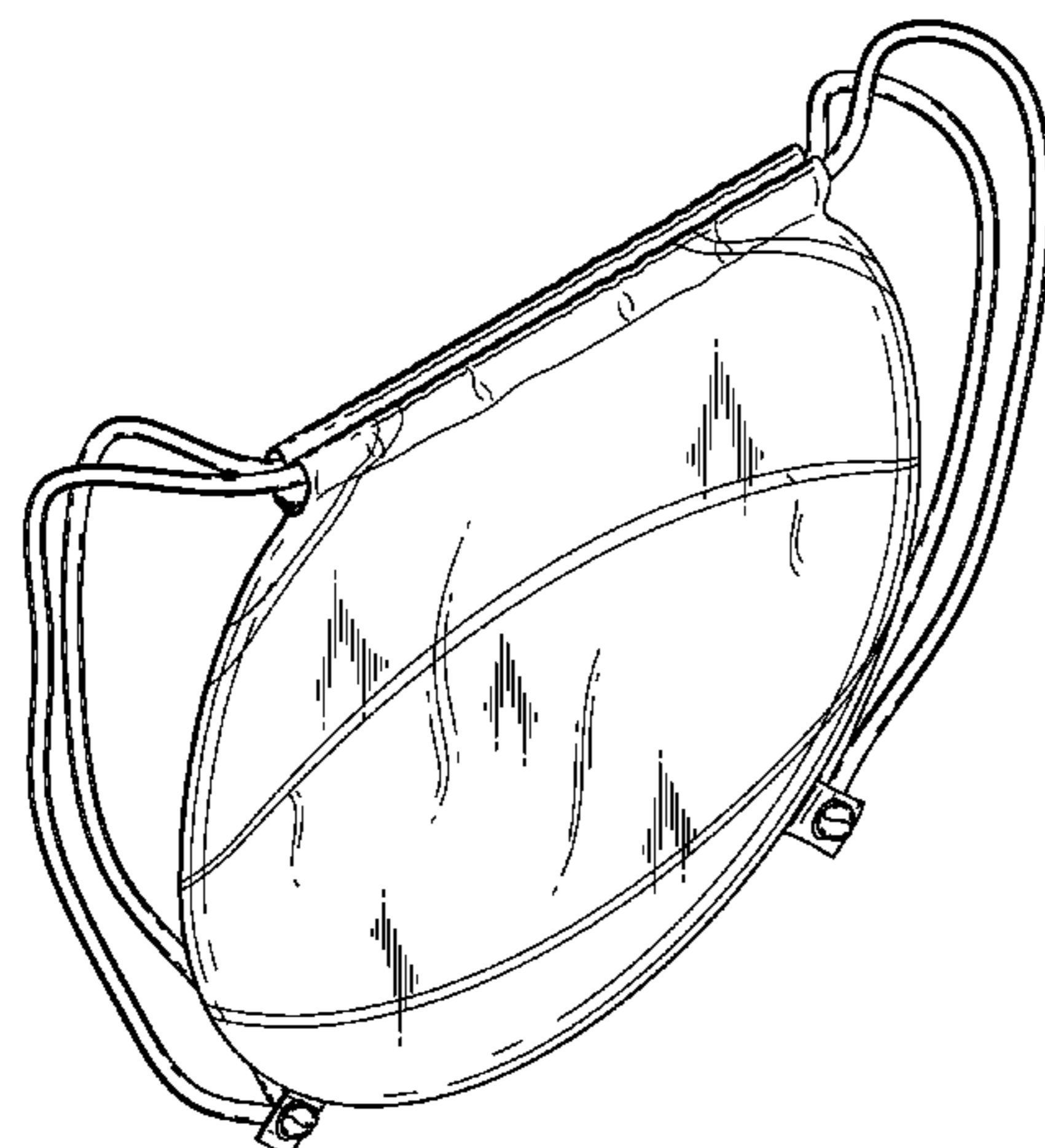


FIG. 26 is a front view of the fifth embodiment thereof;

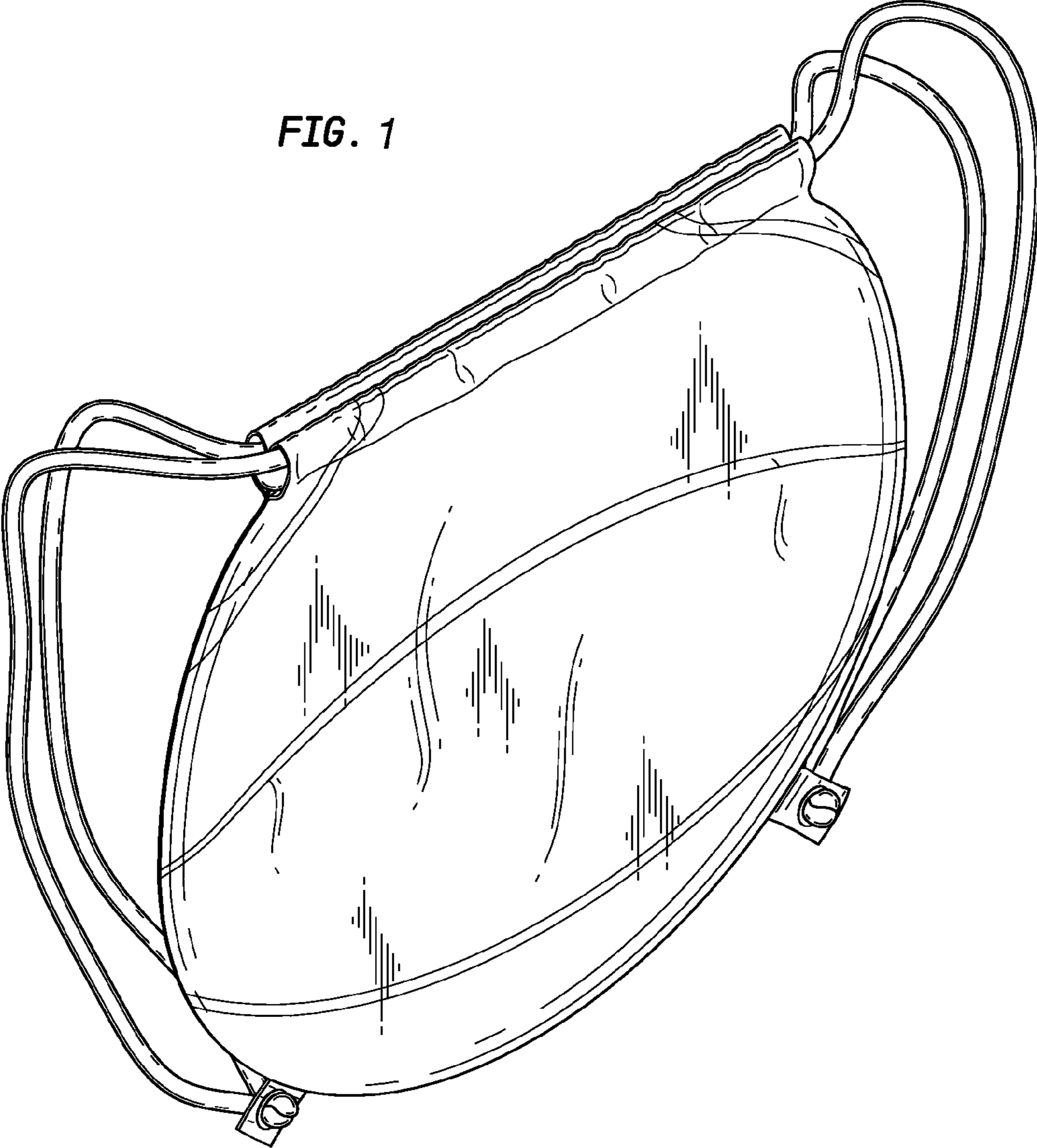

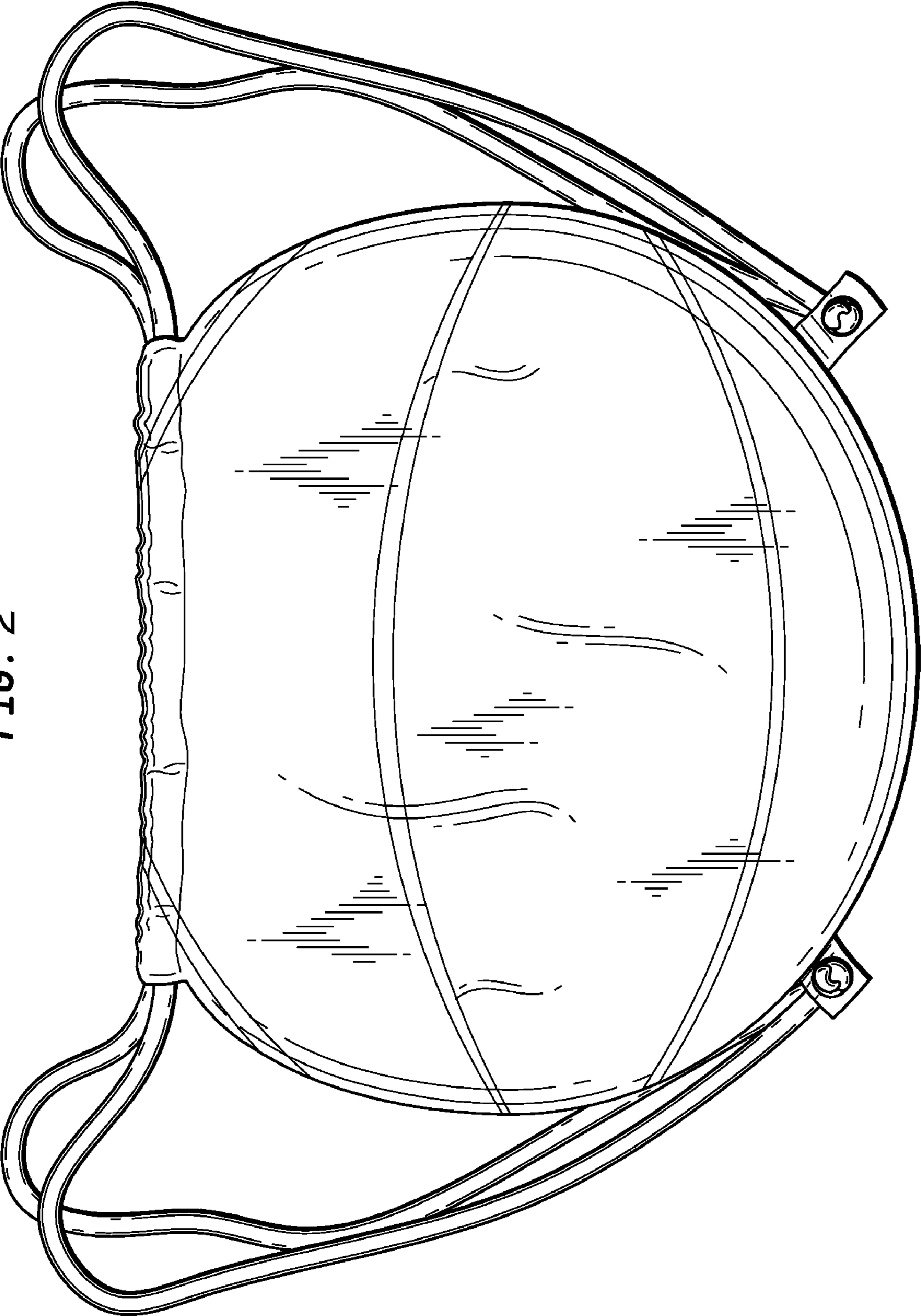

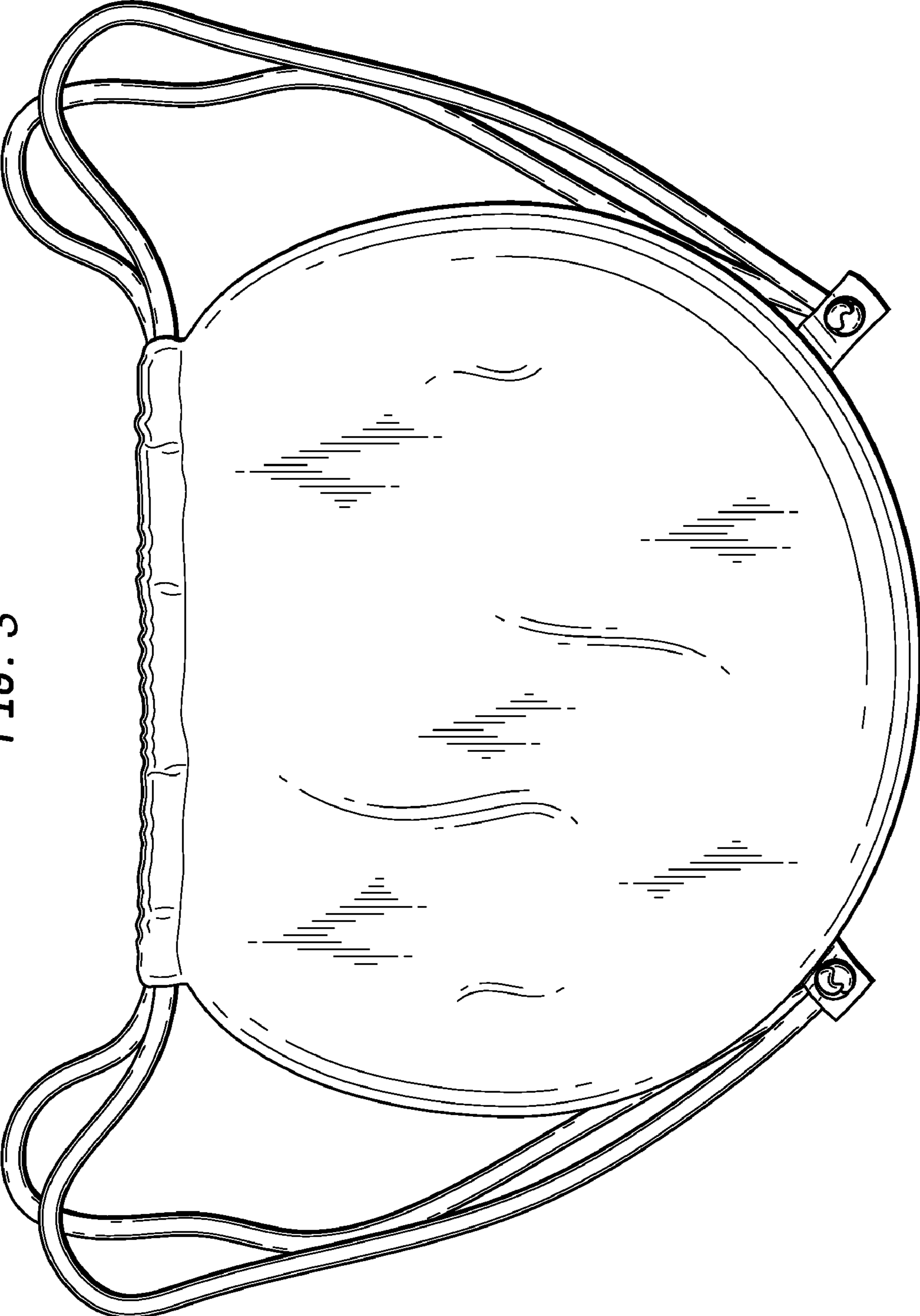

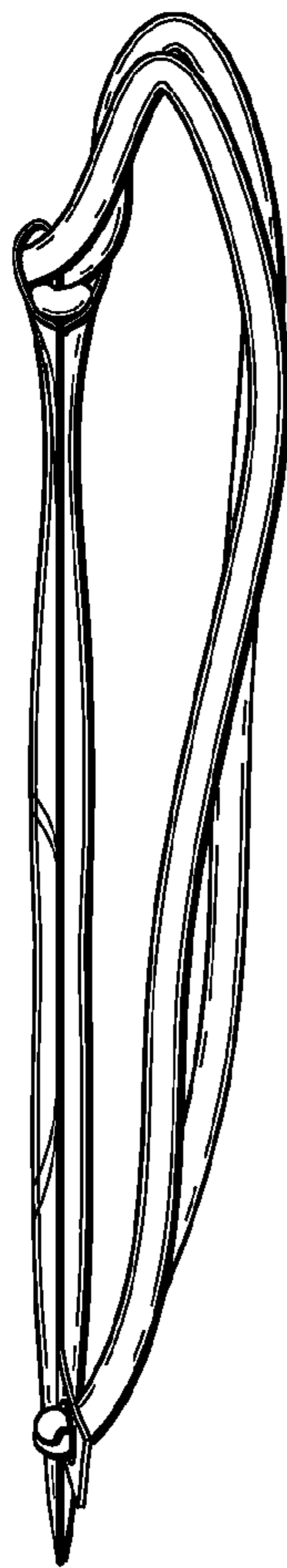

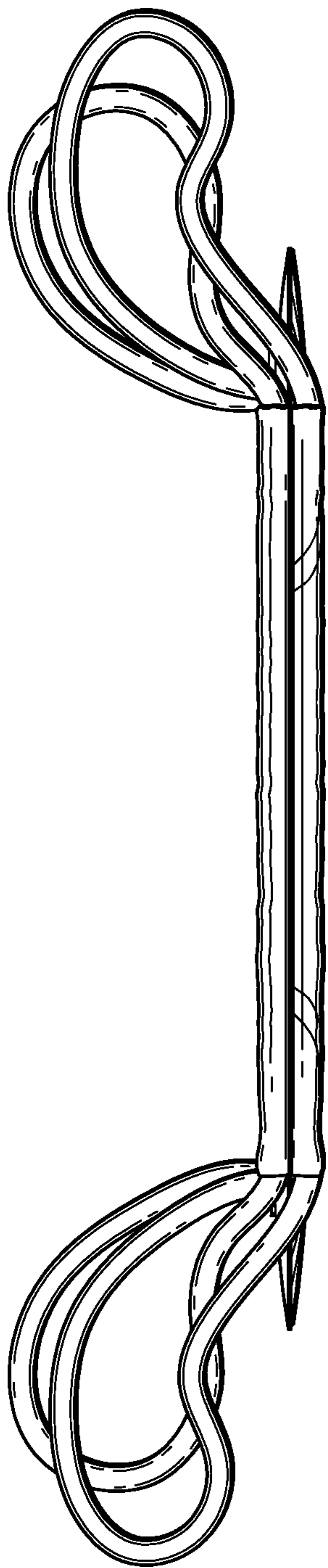

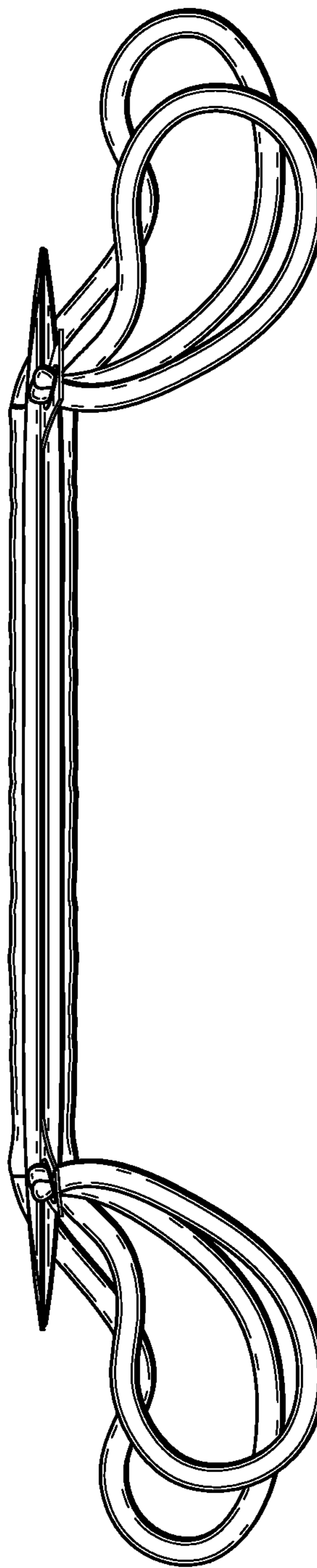

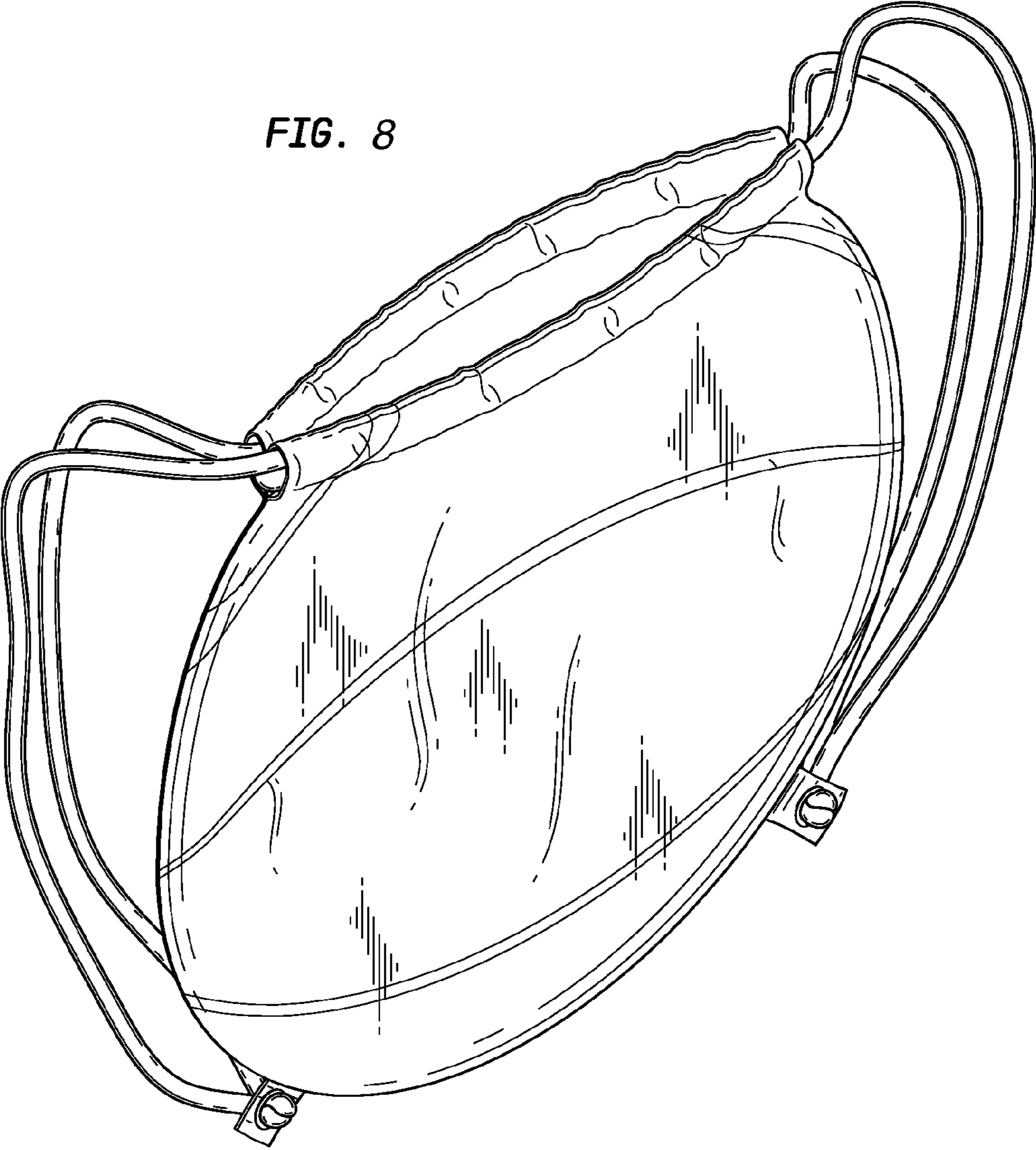

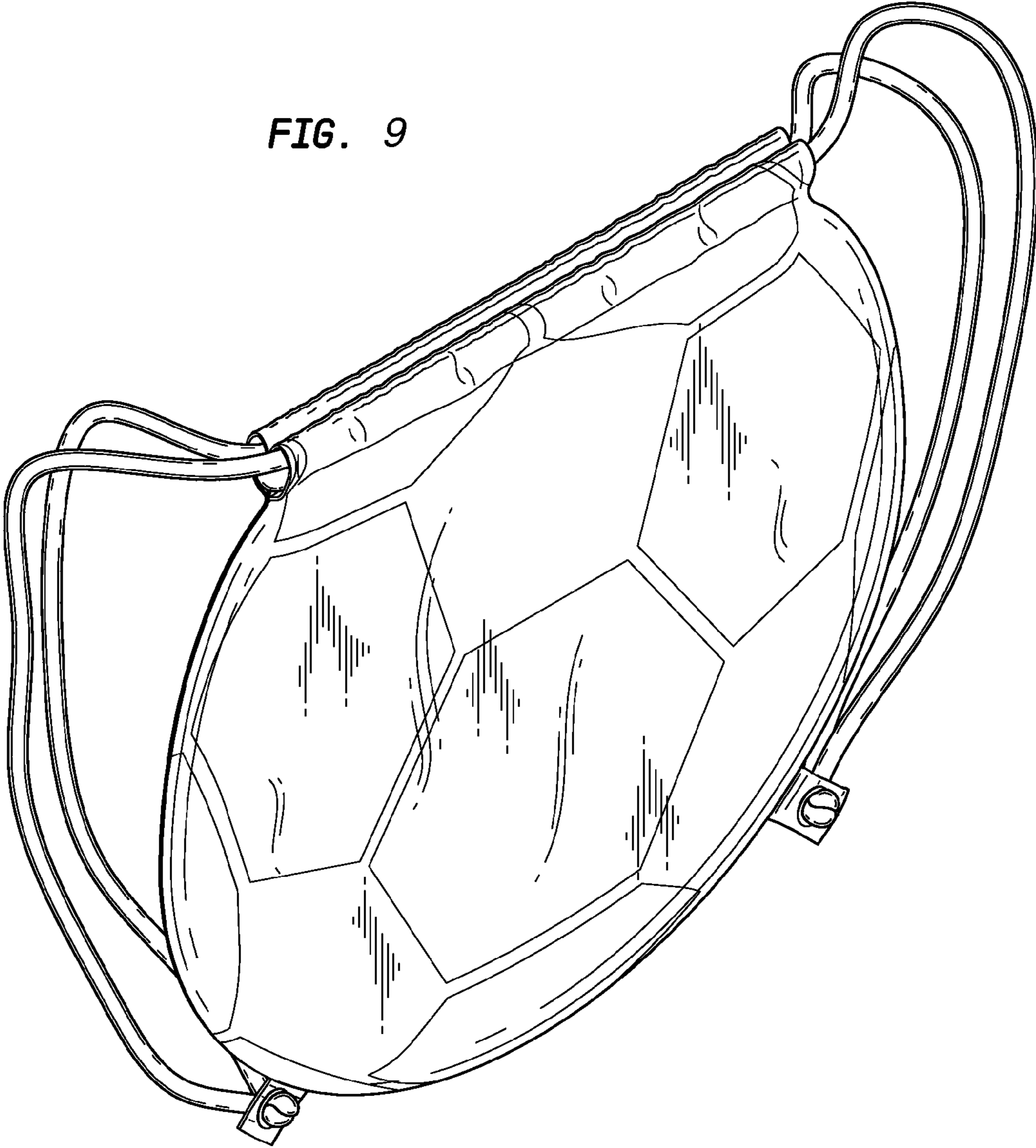

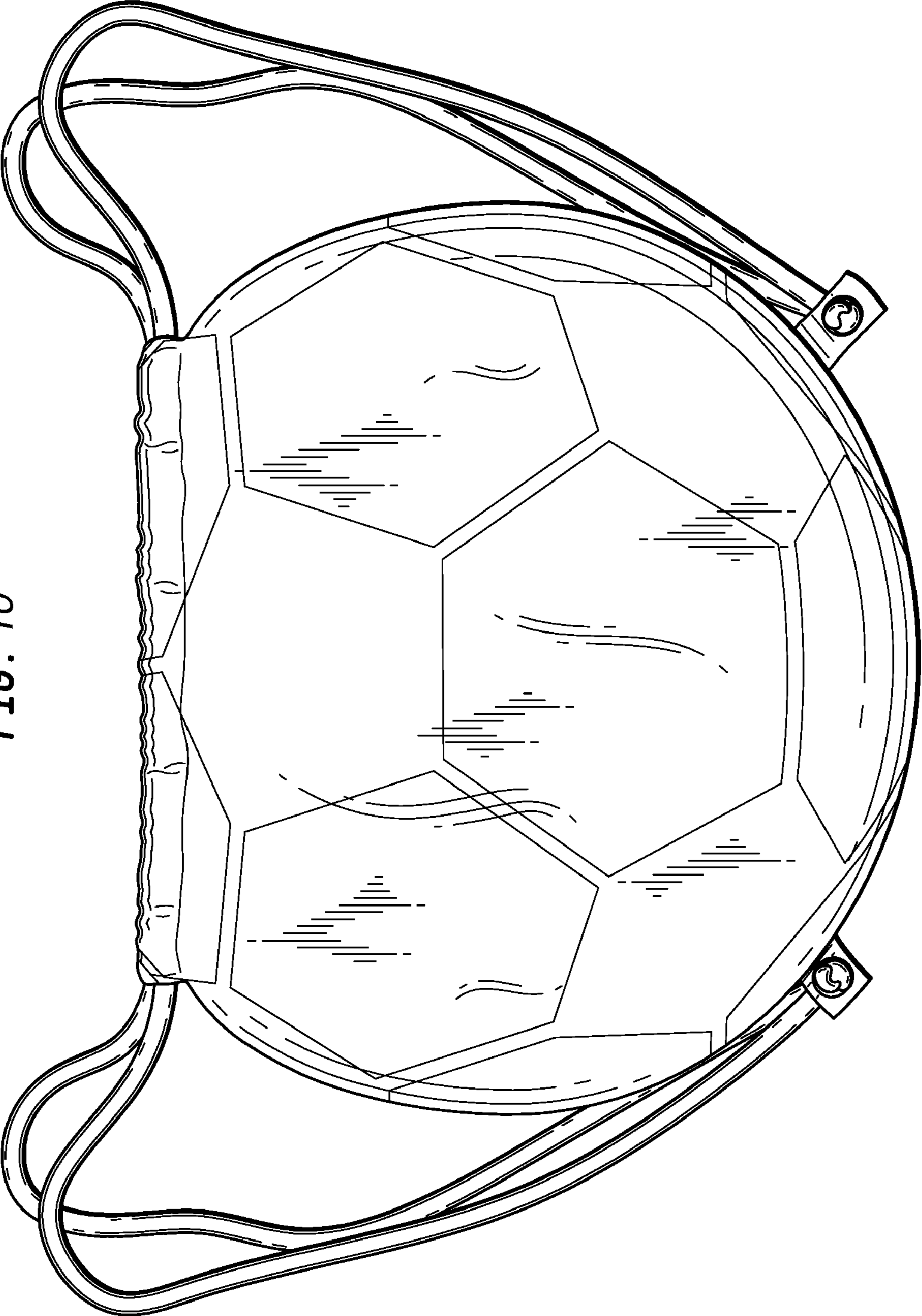

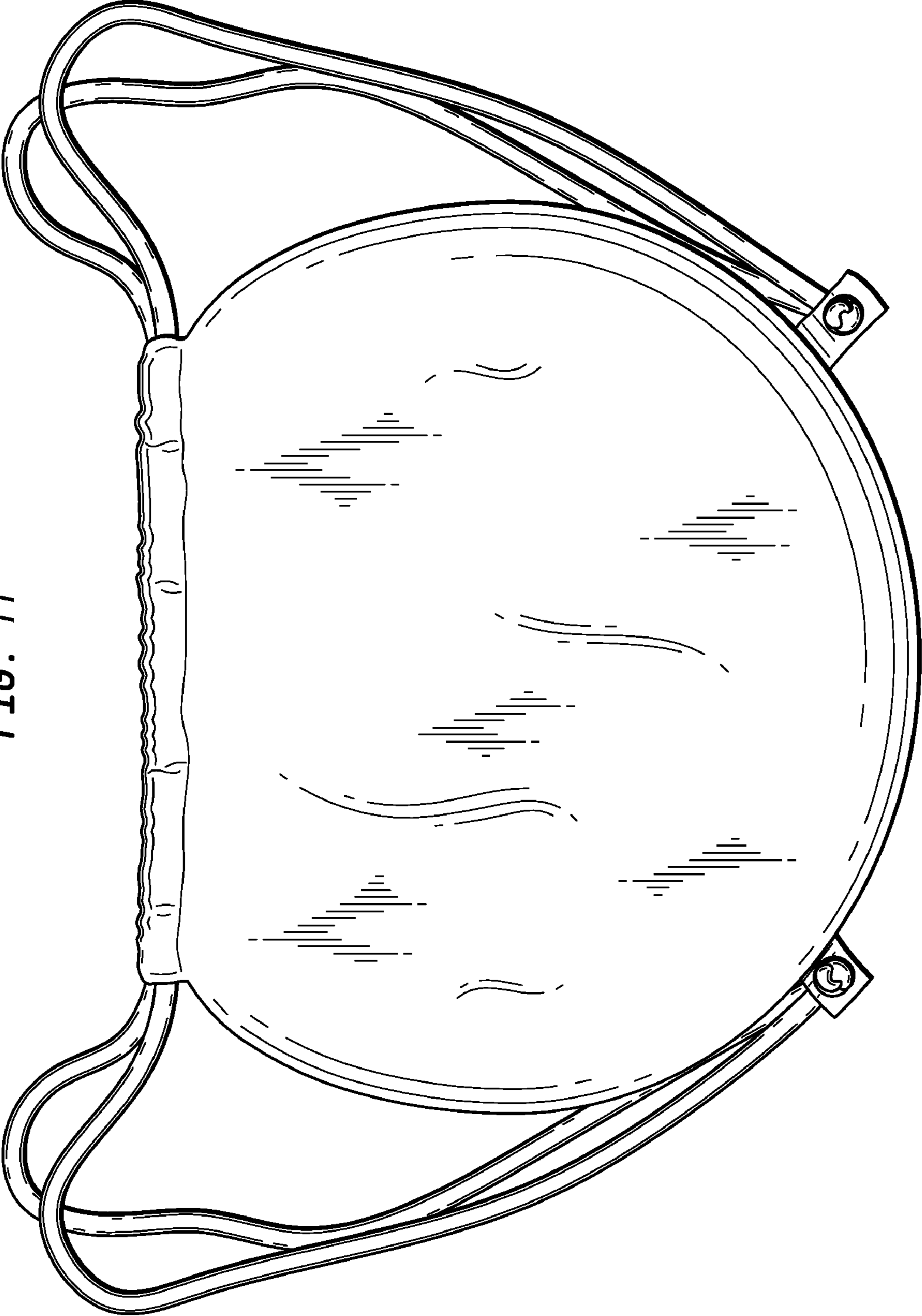

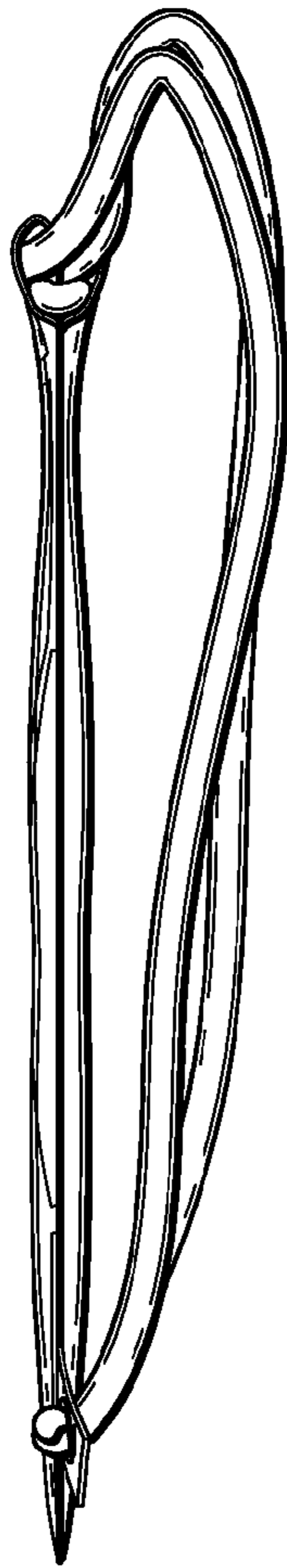

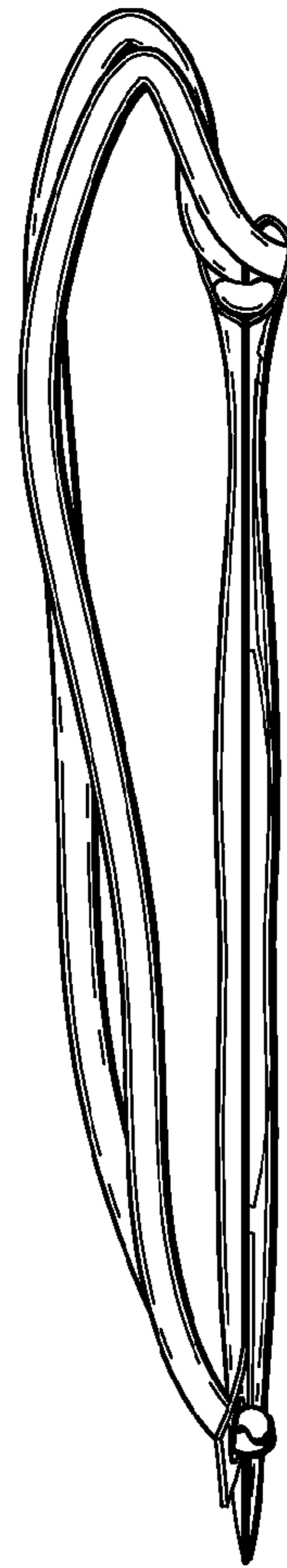

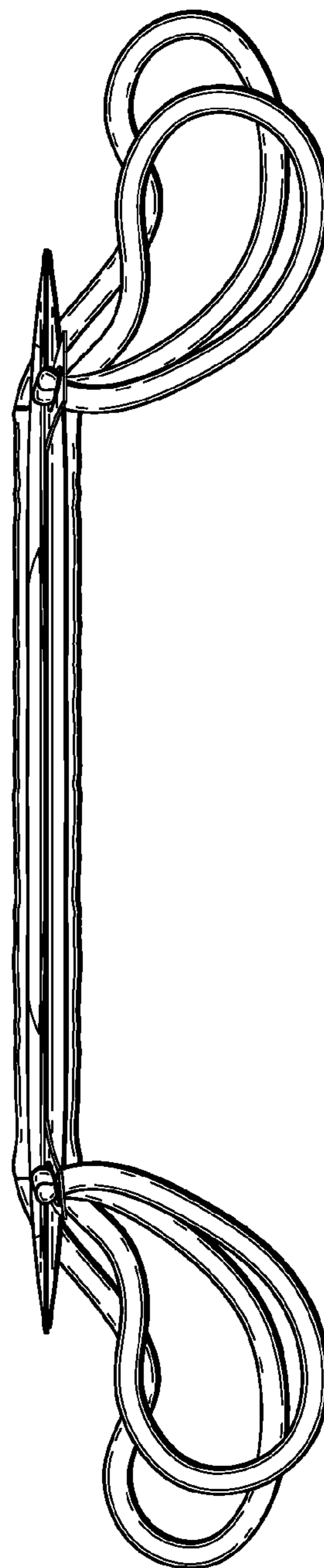

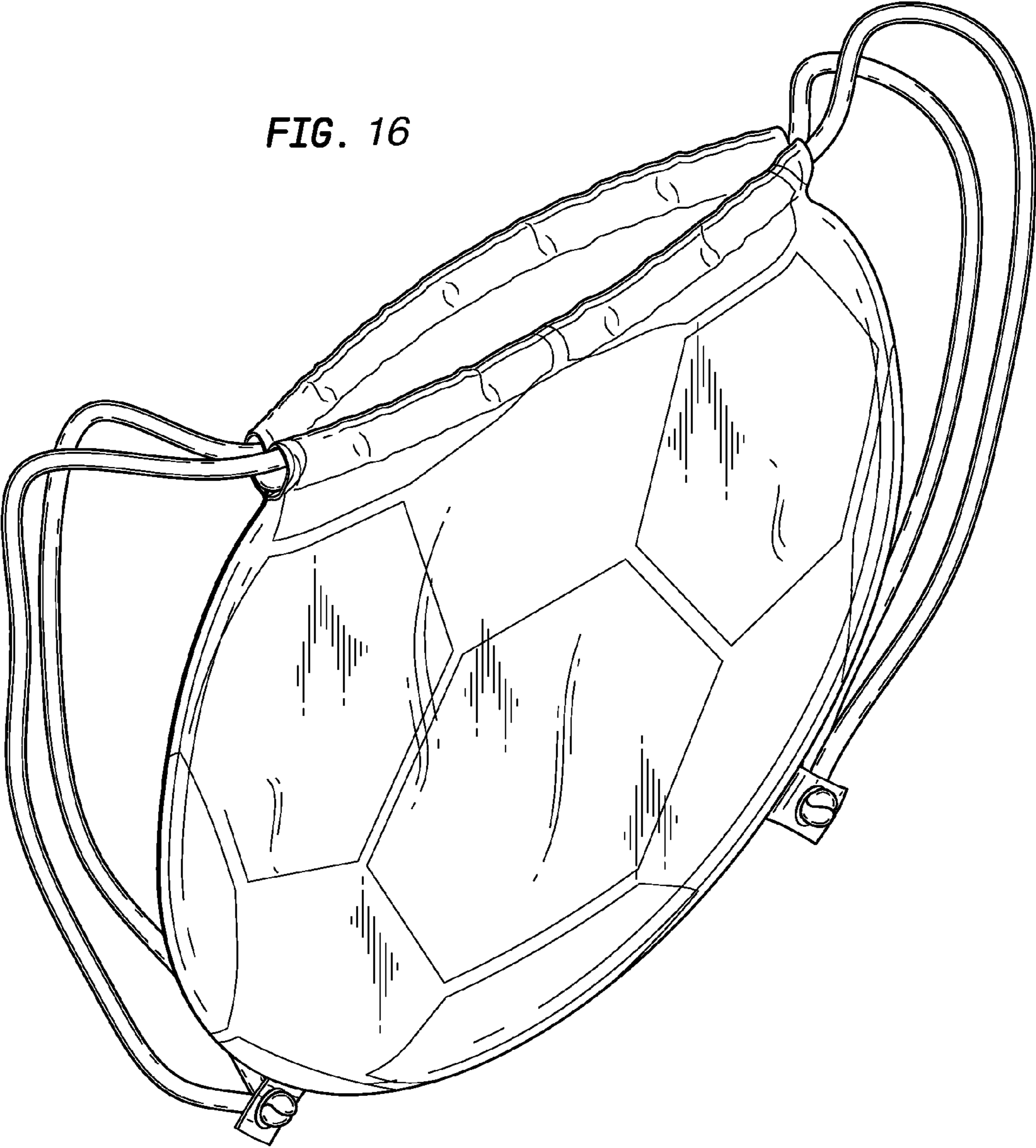

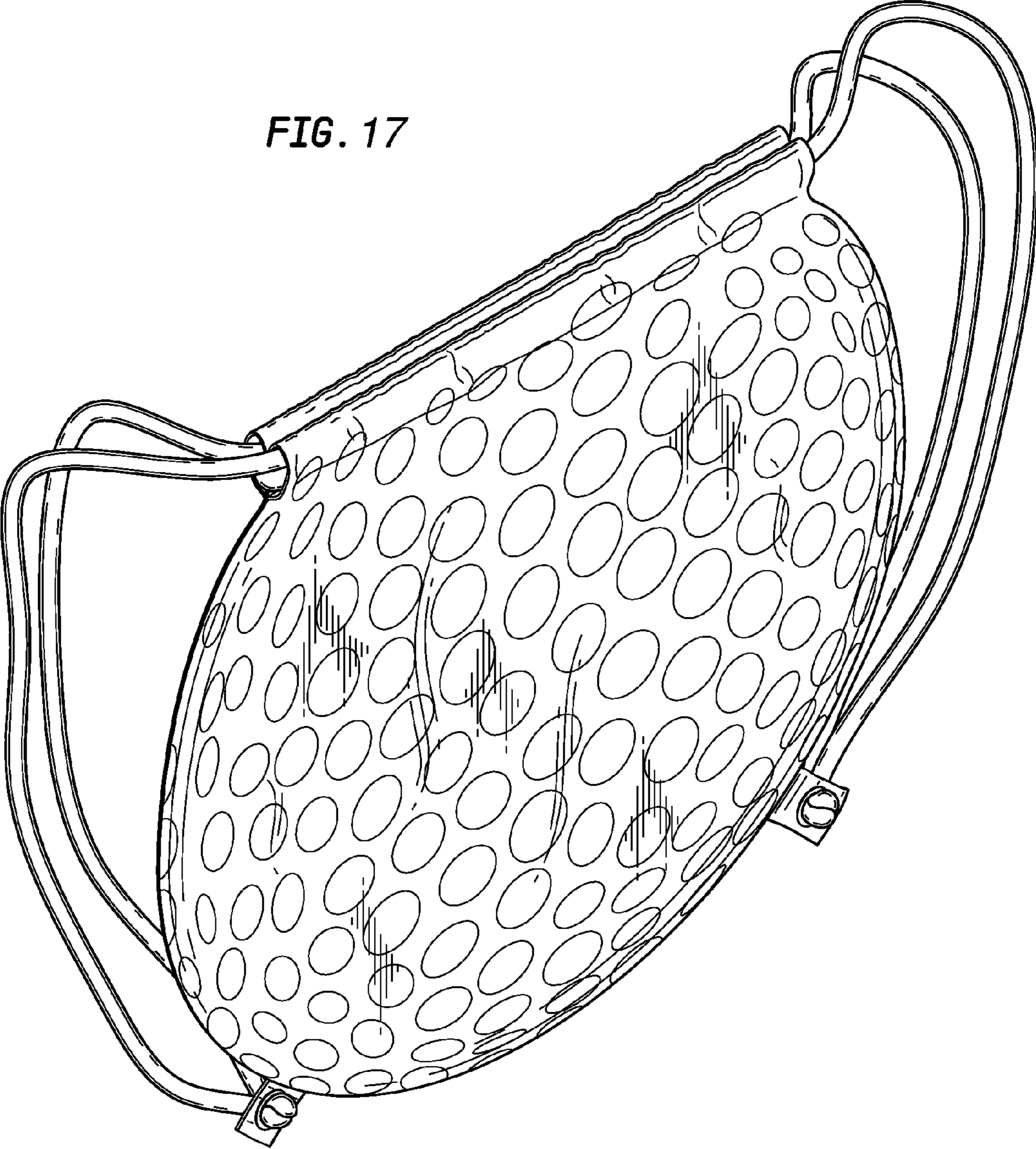

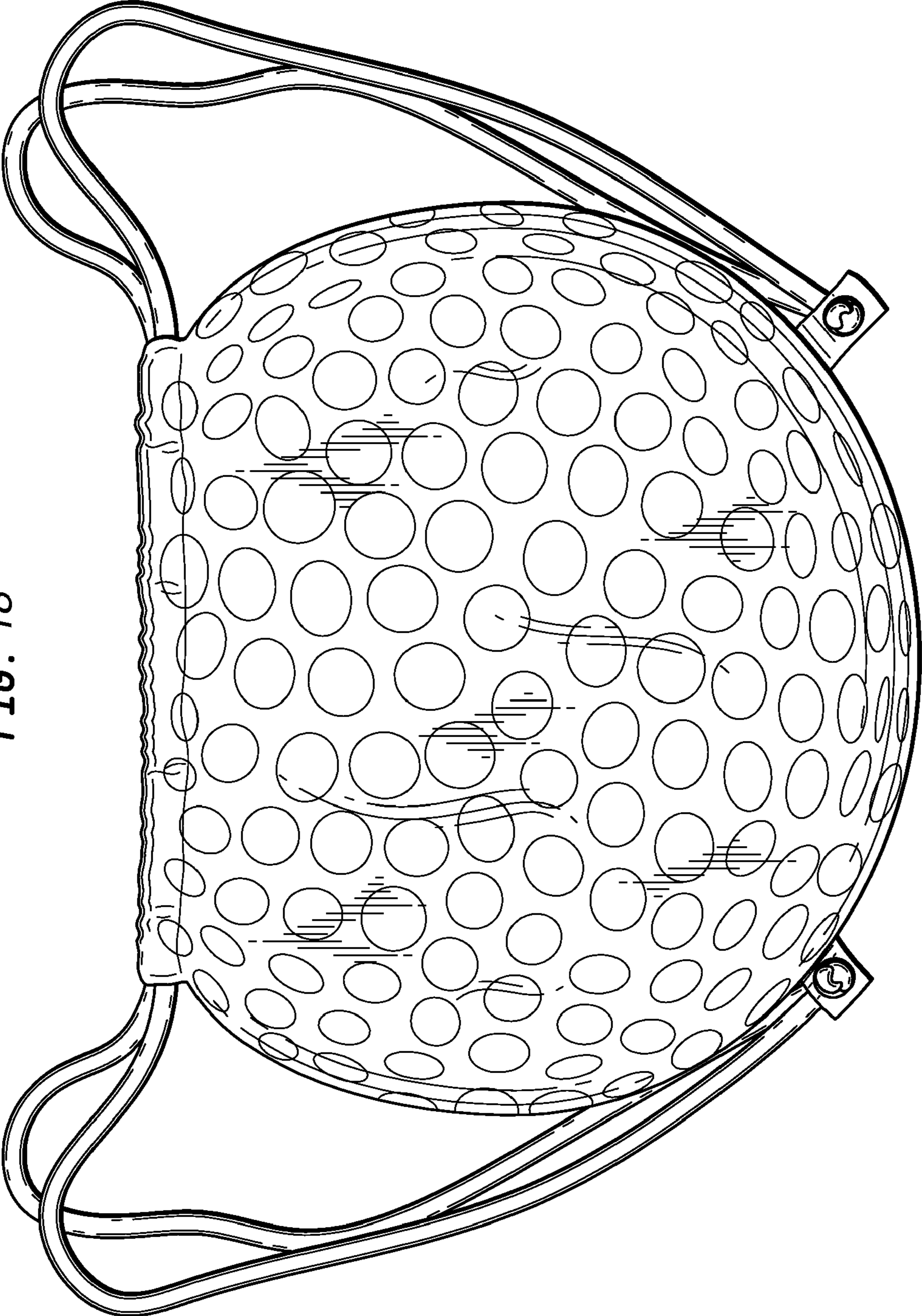

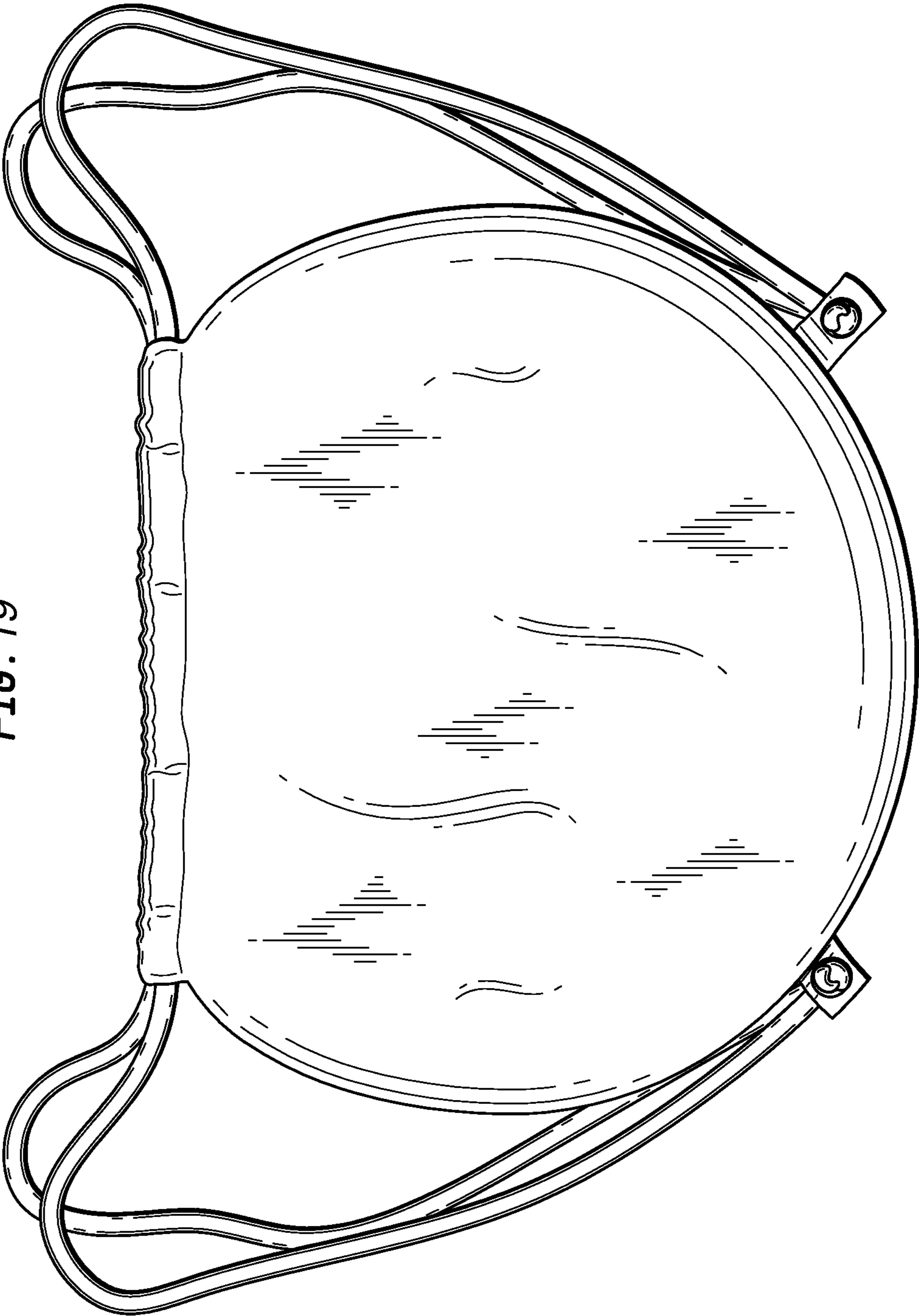

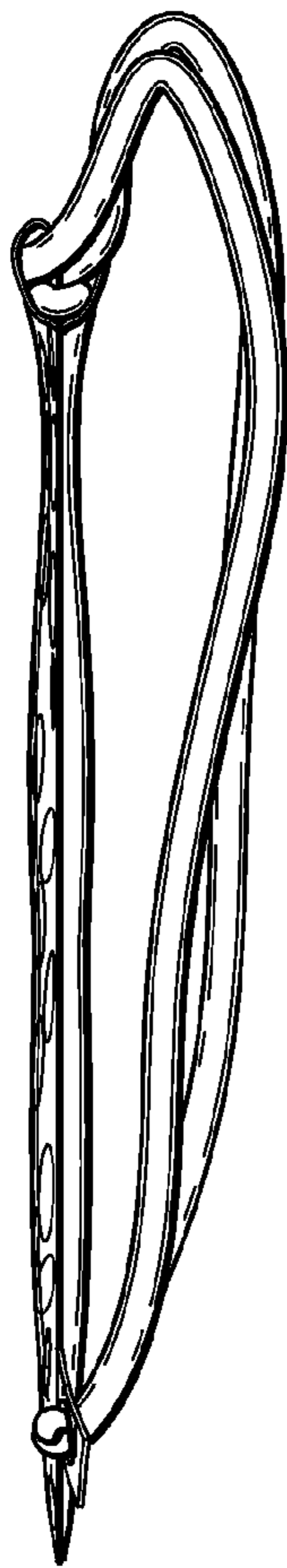

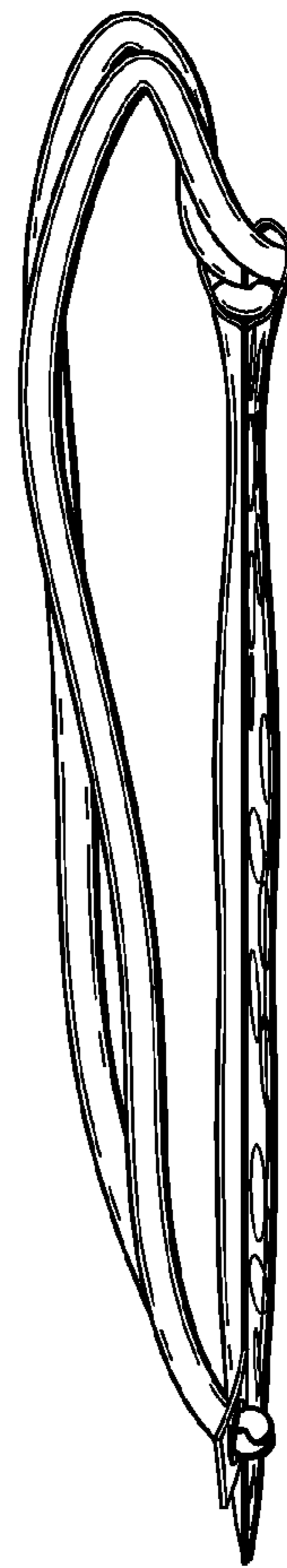

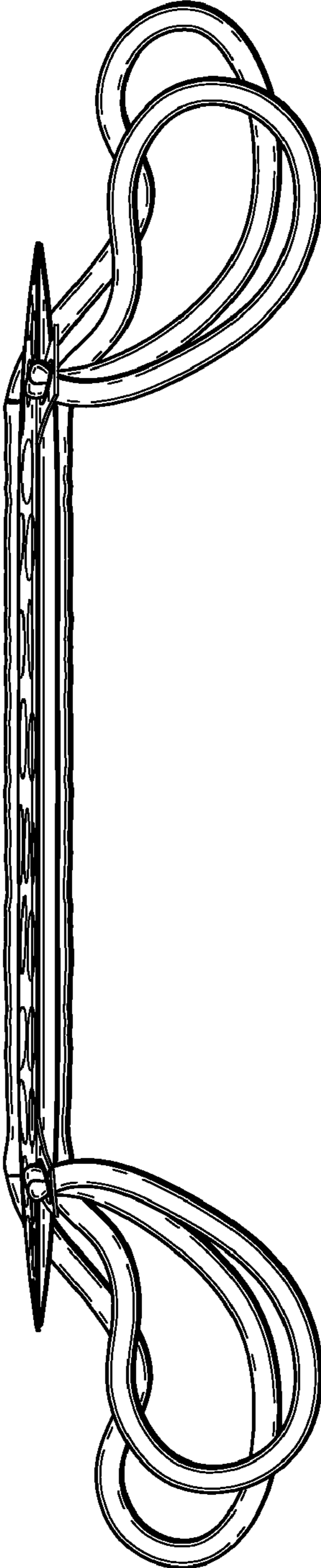

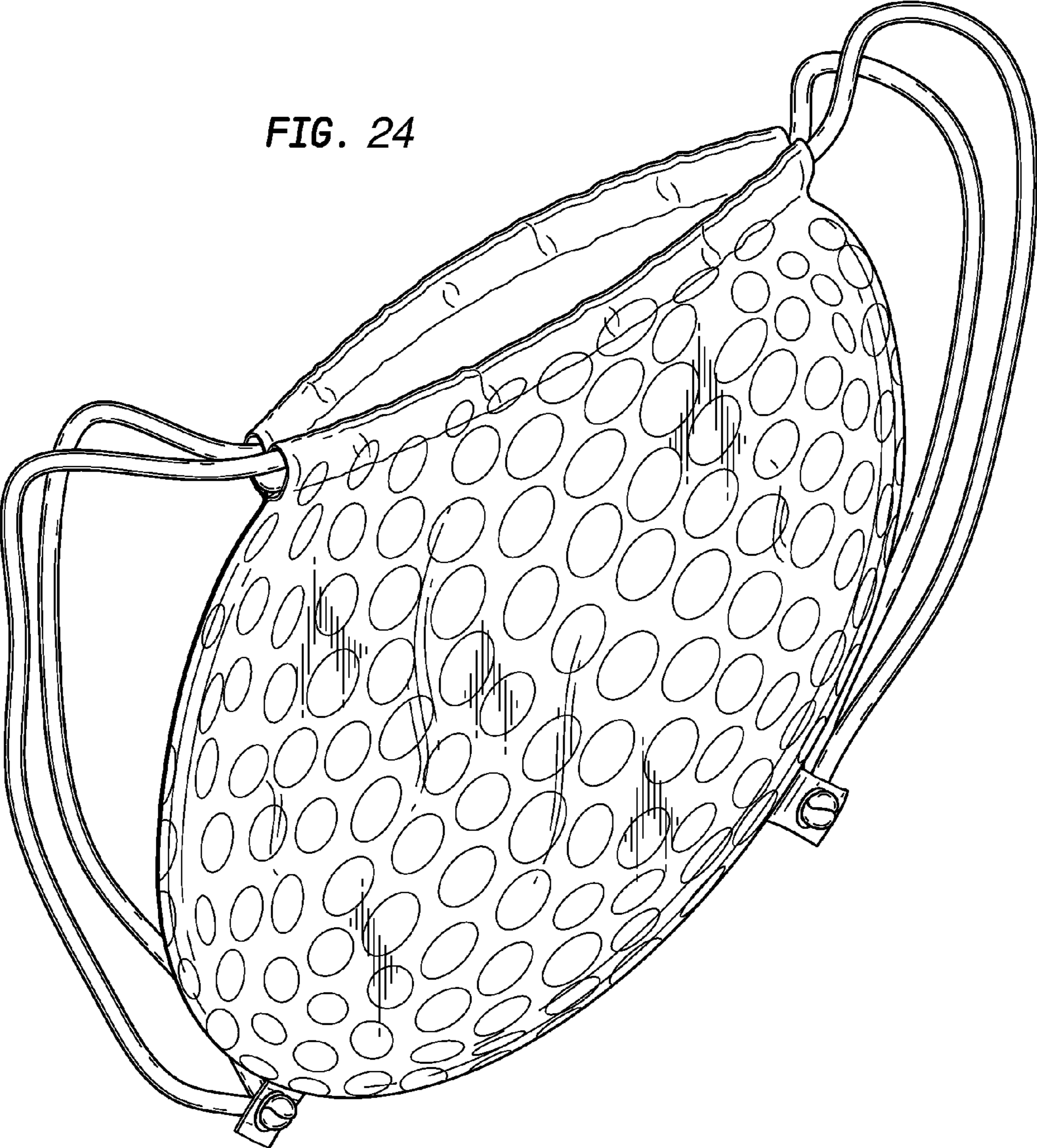

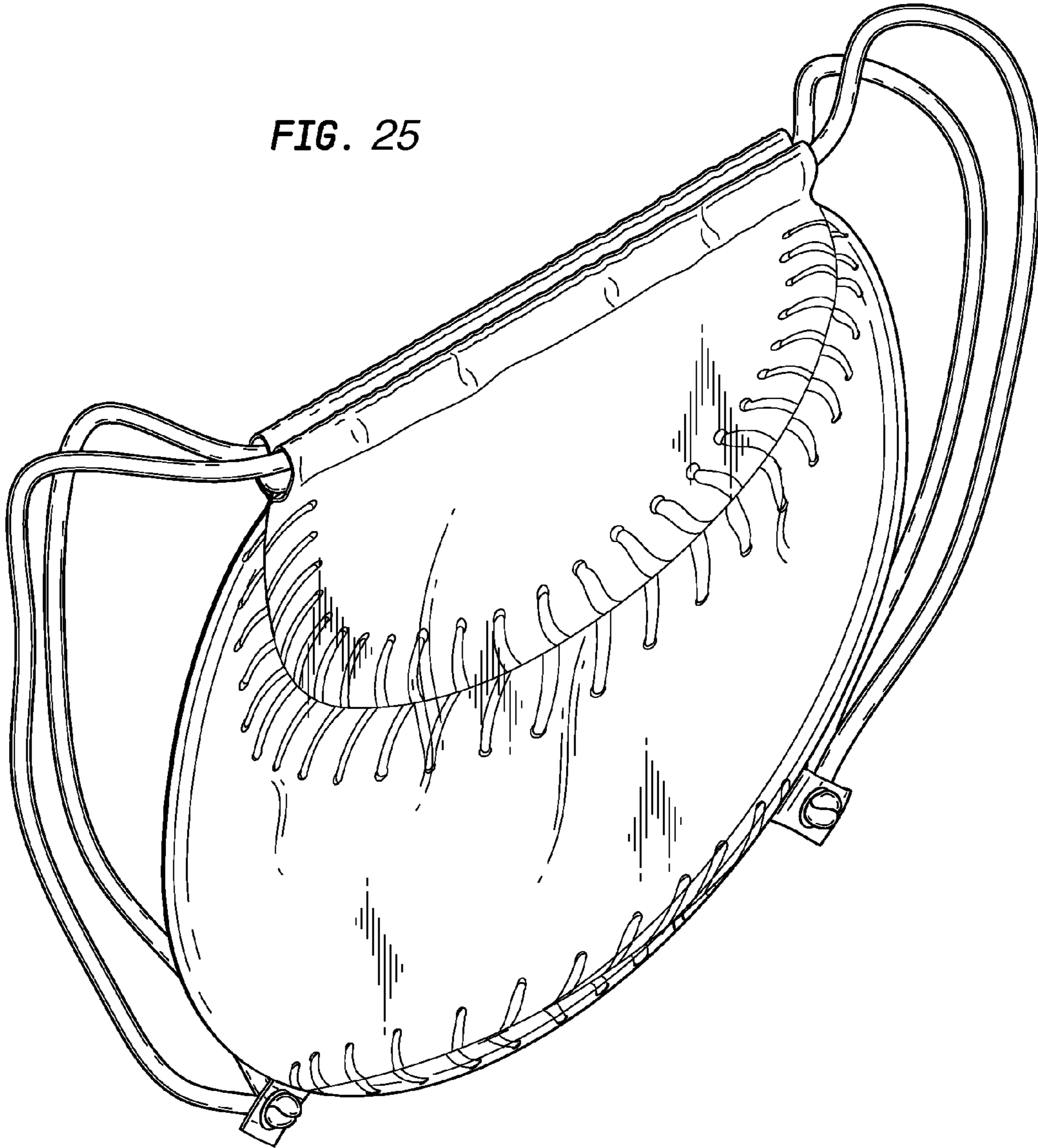

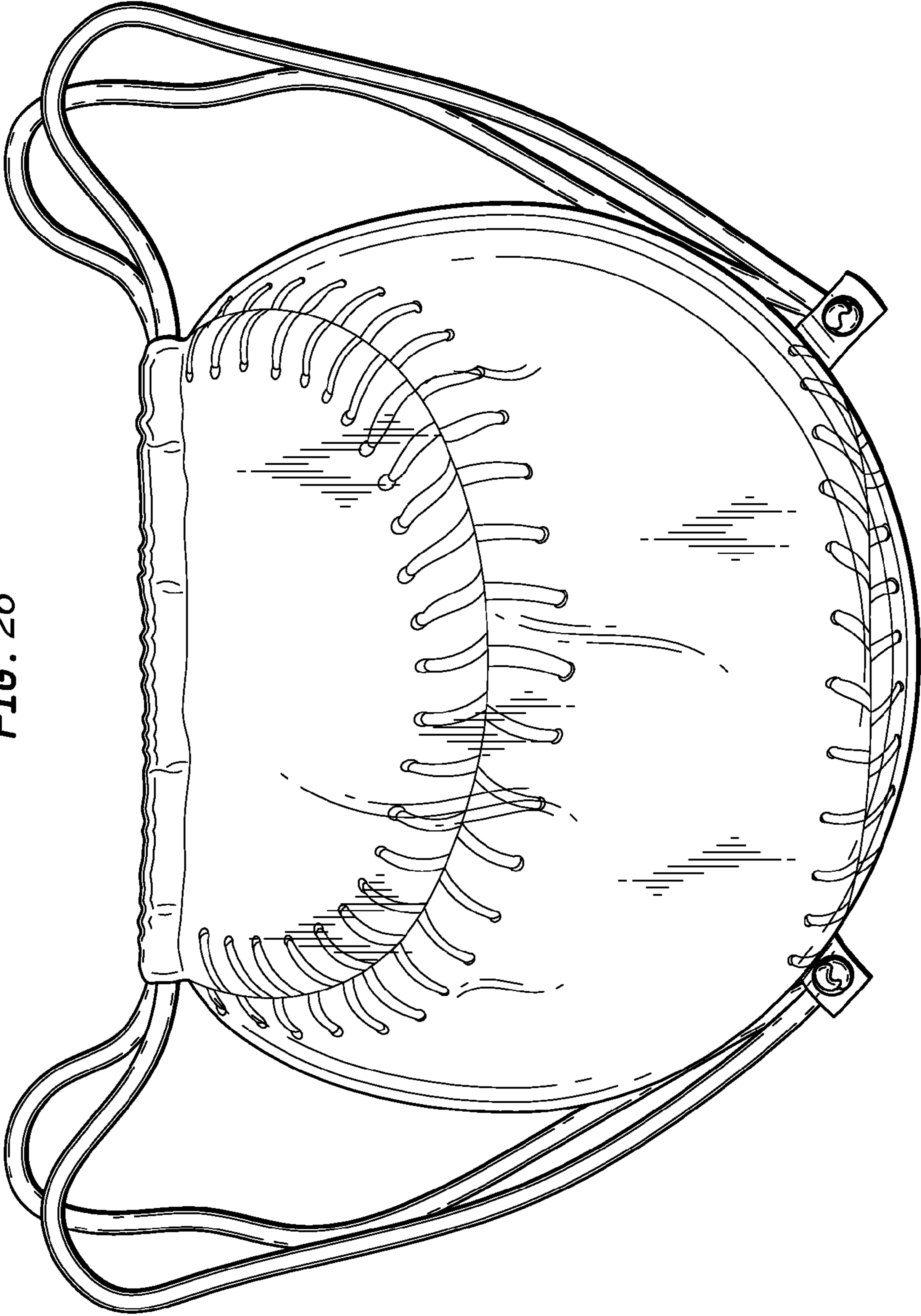

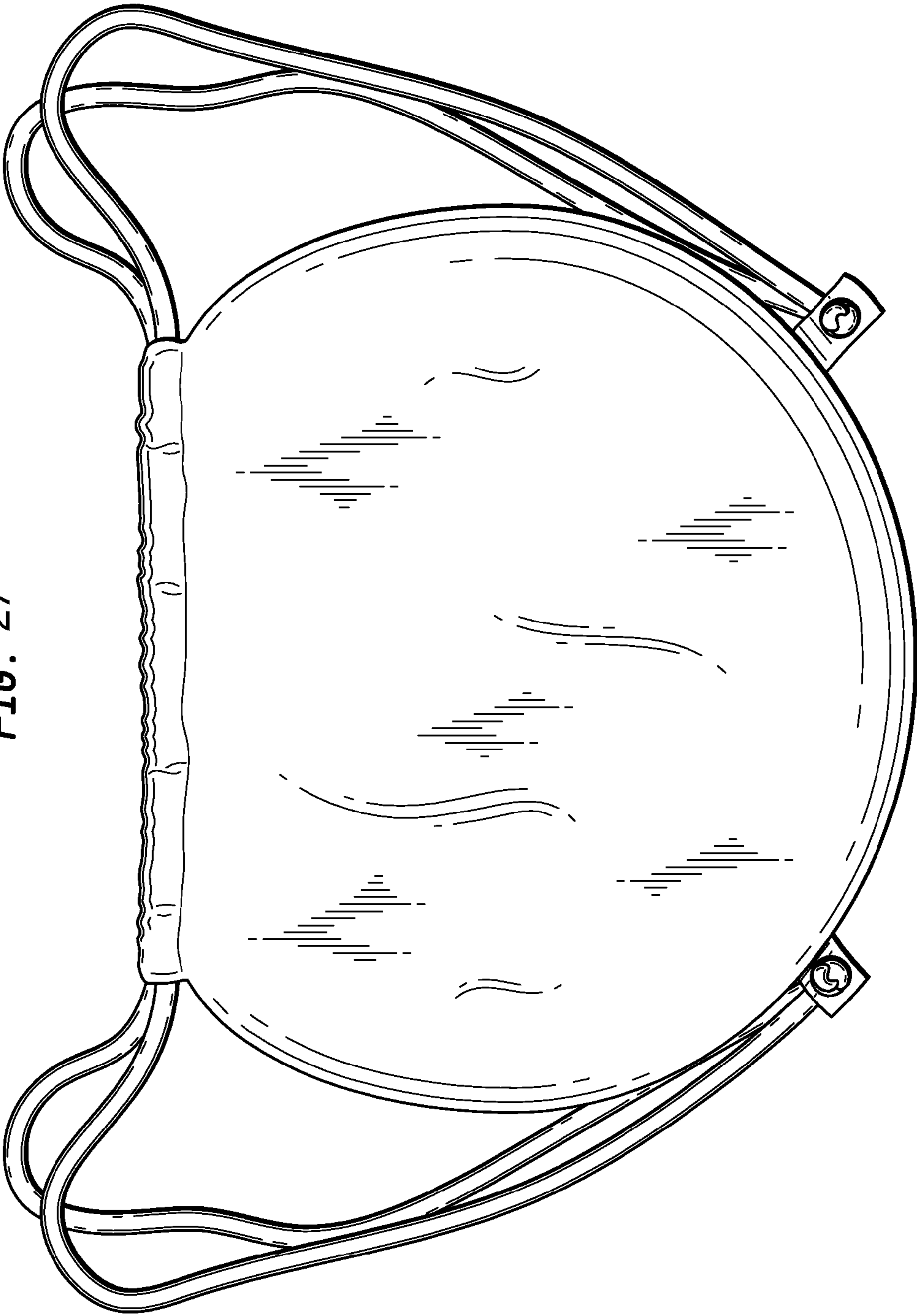

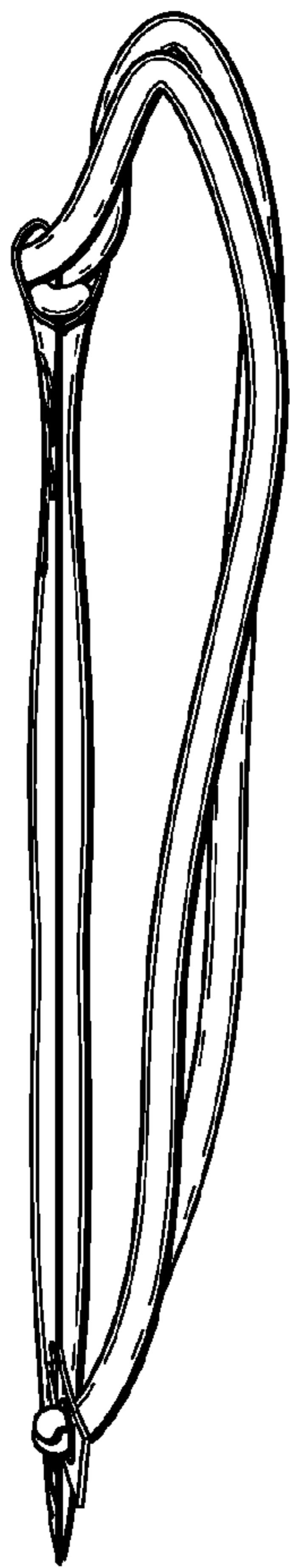

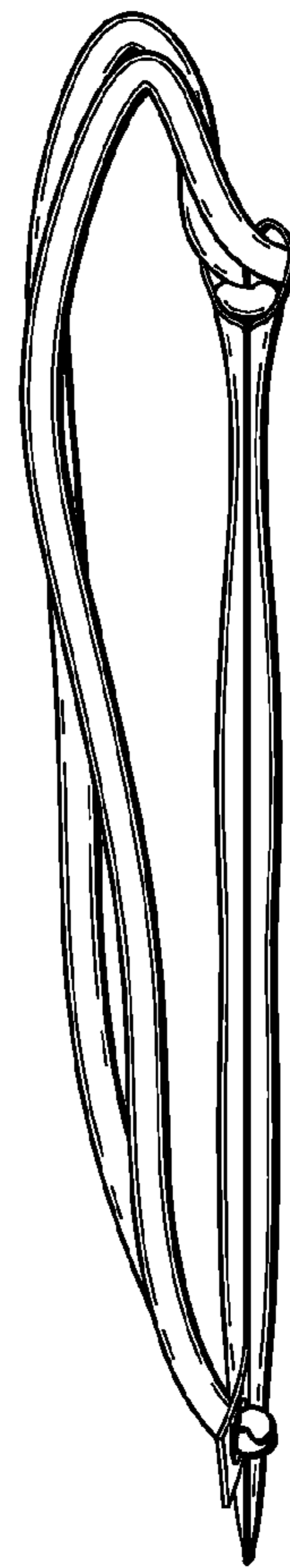

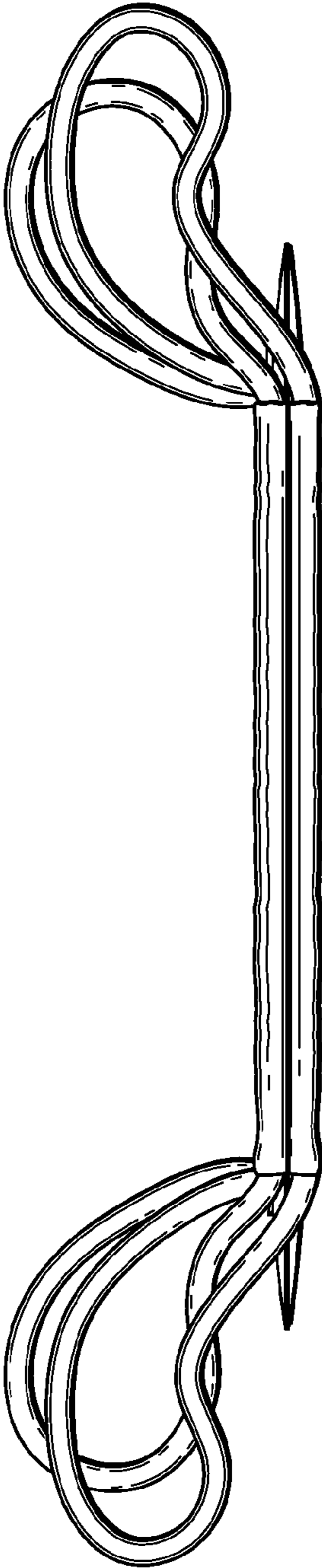

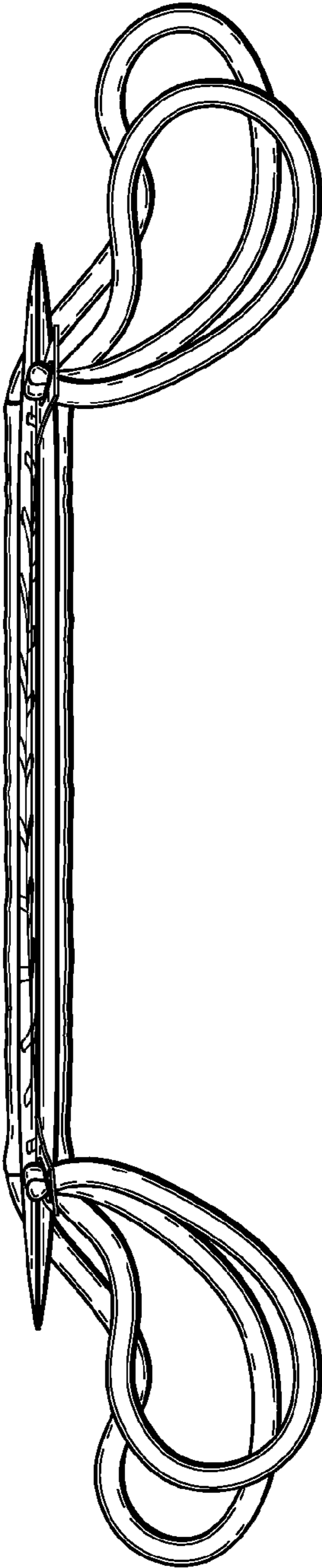

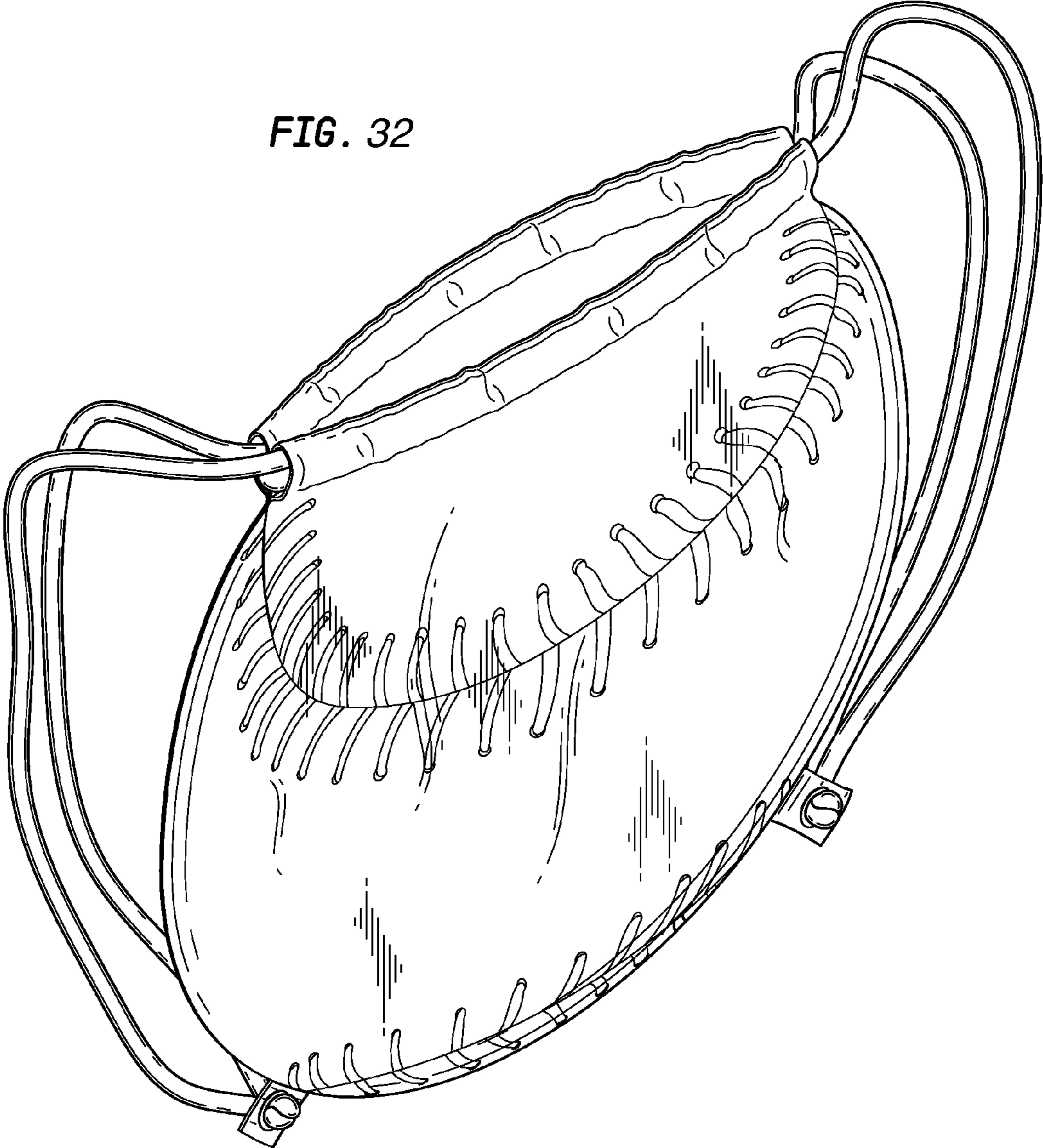

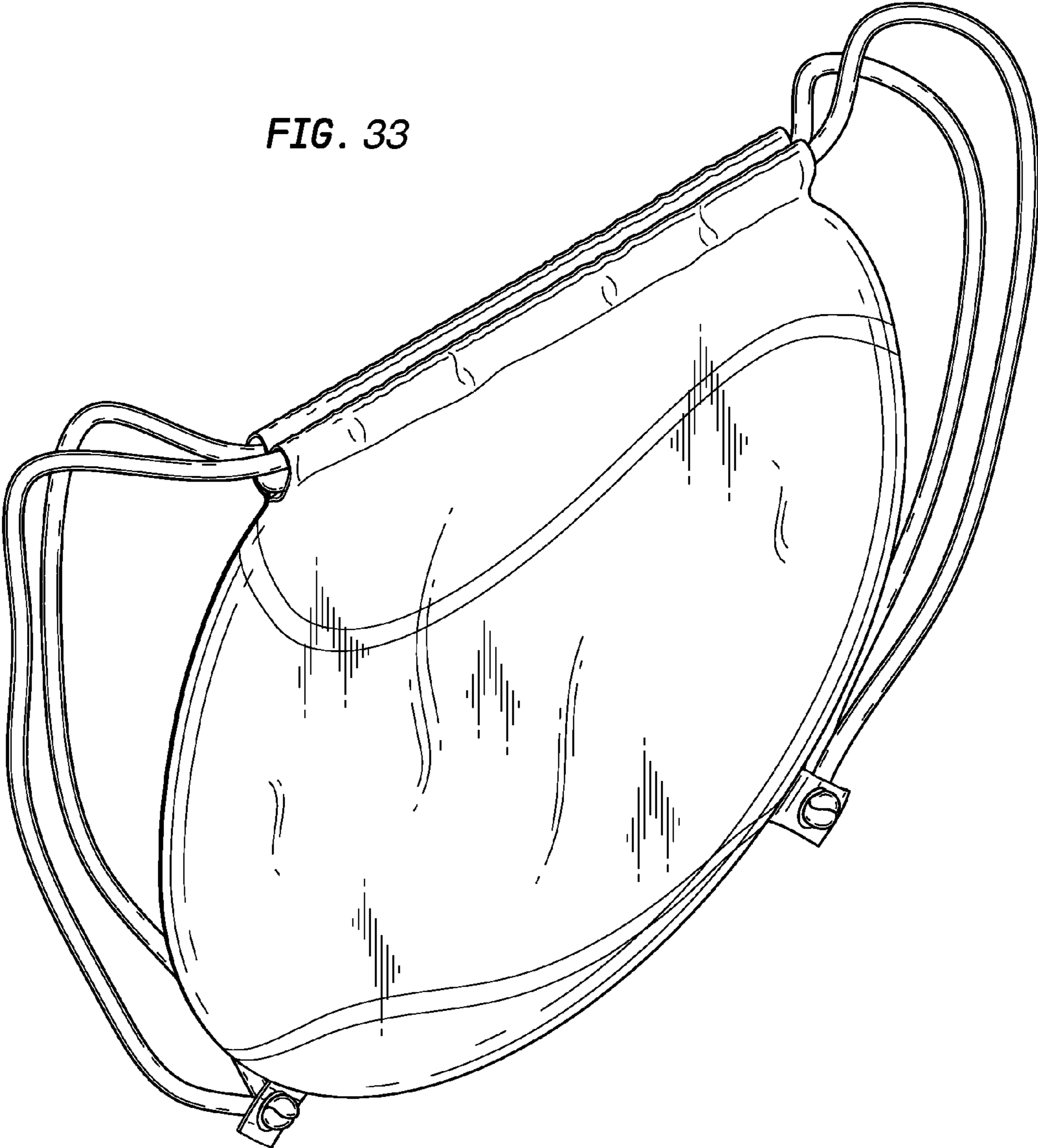

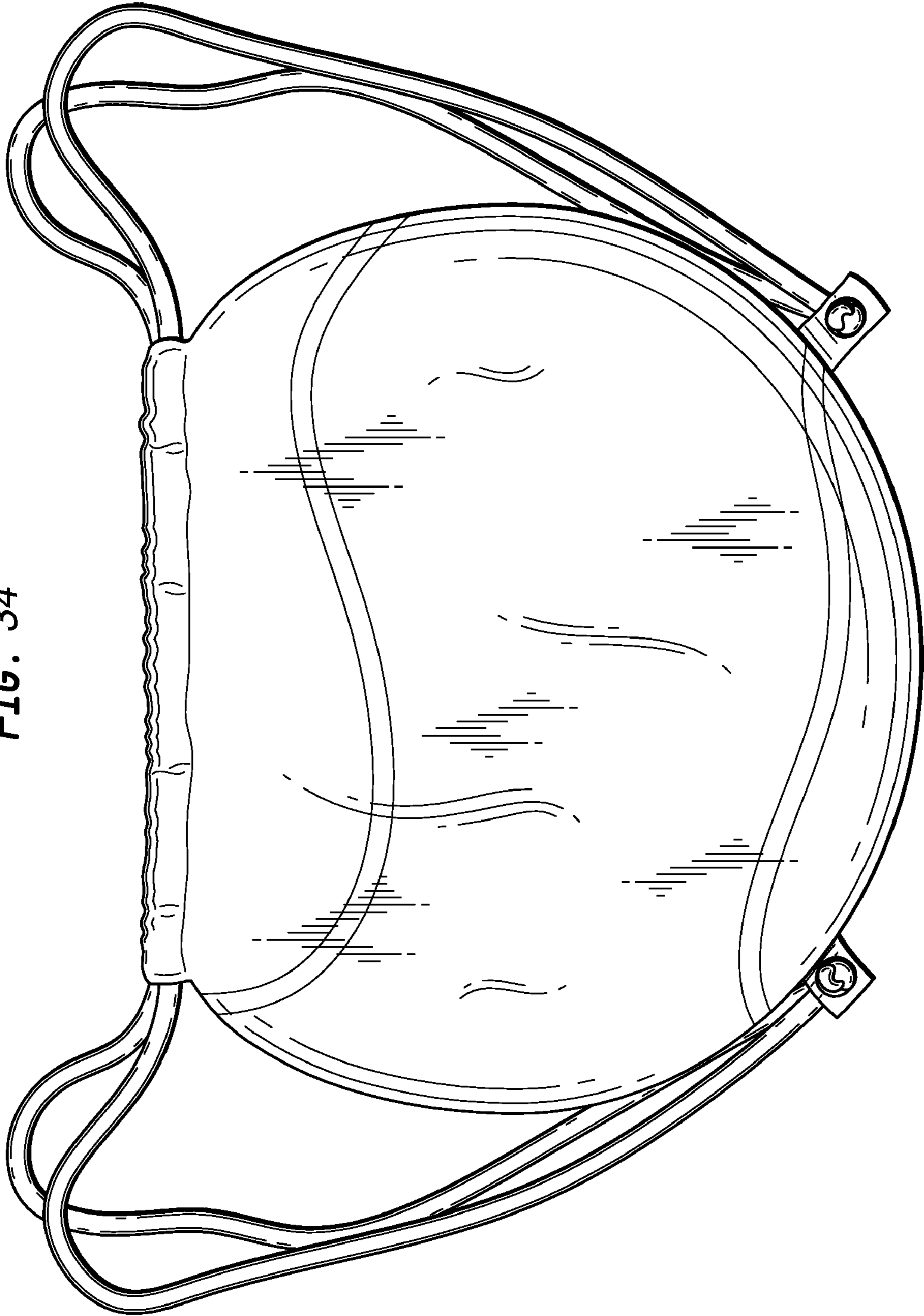

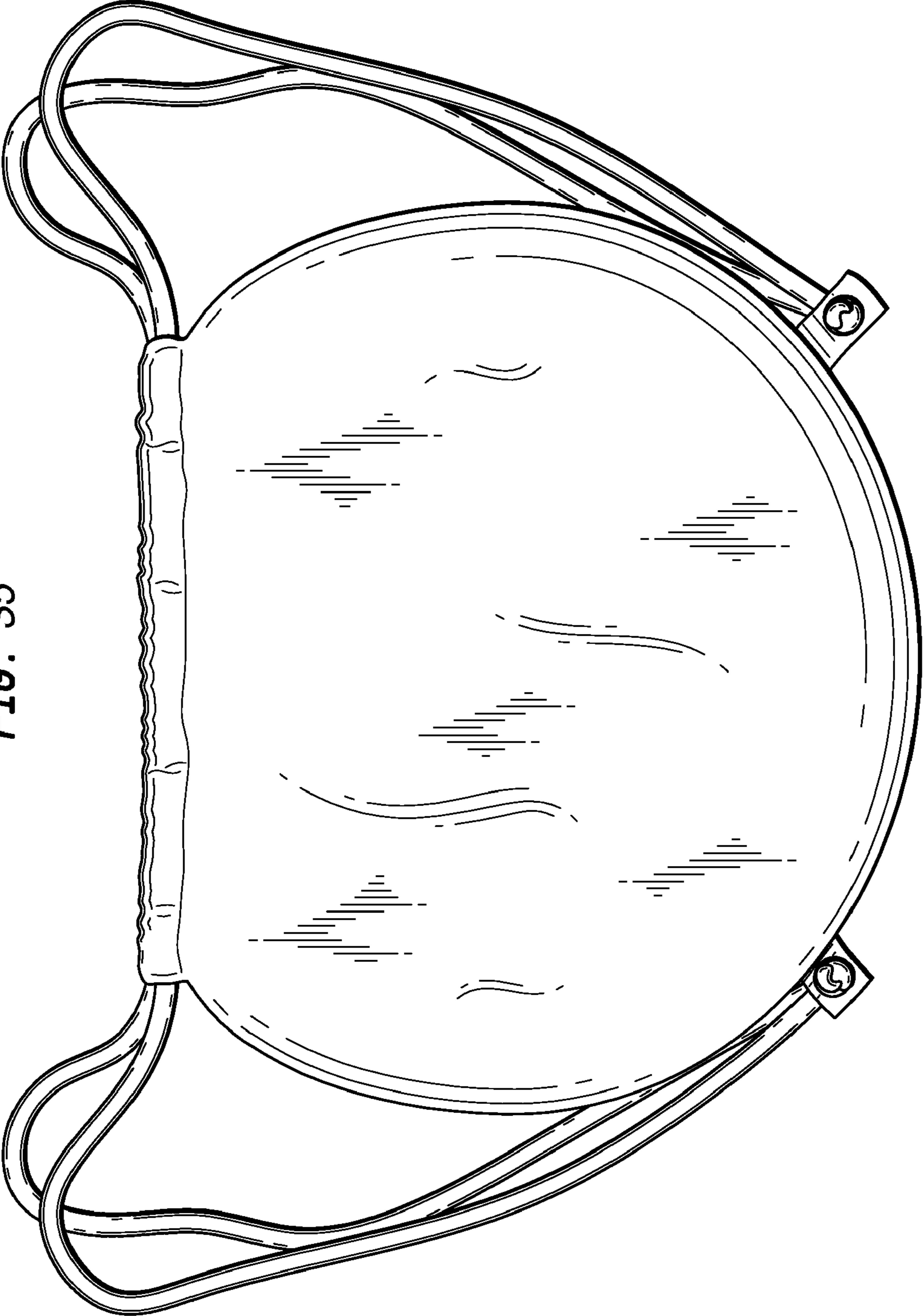

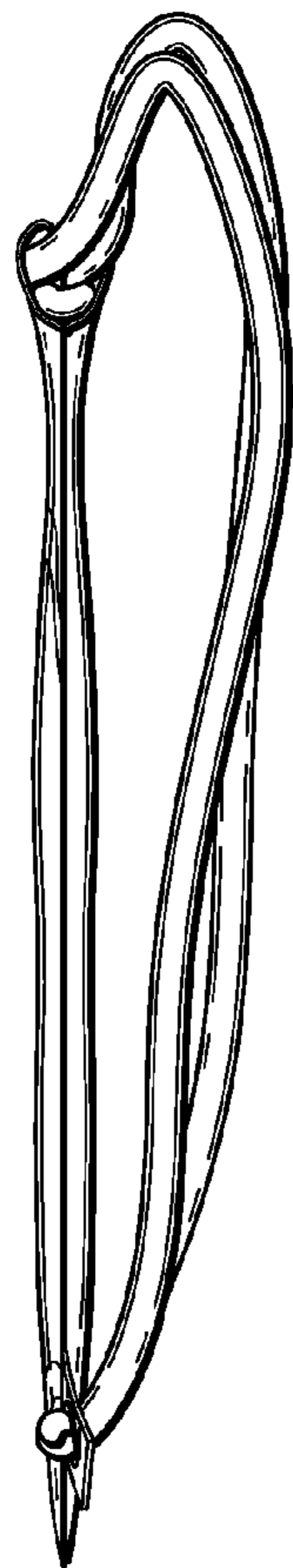

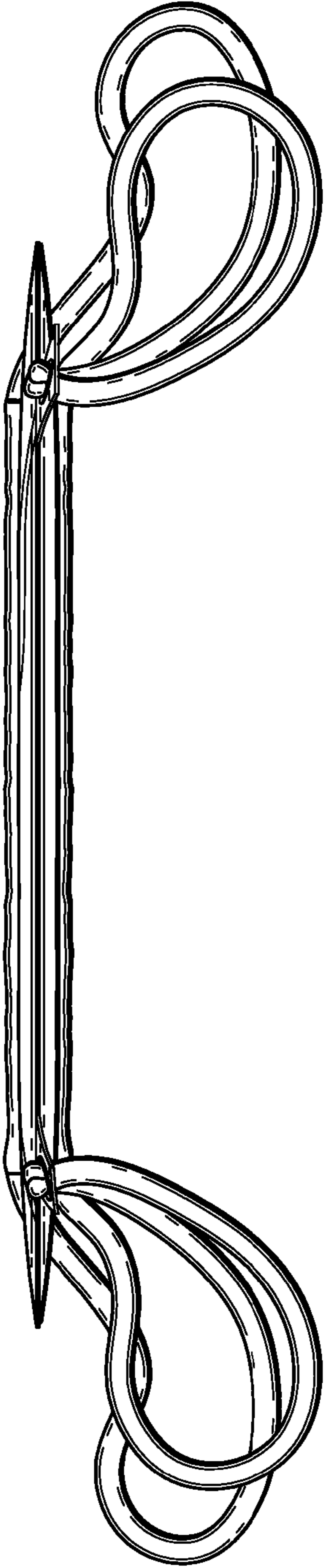

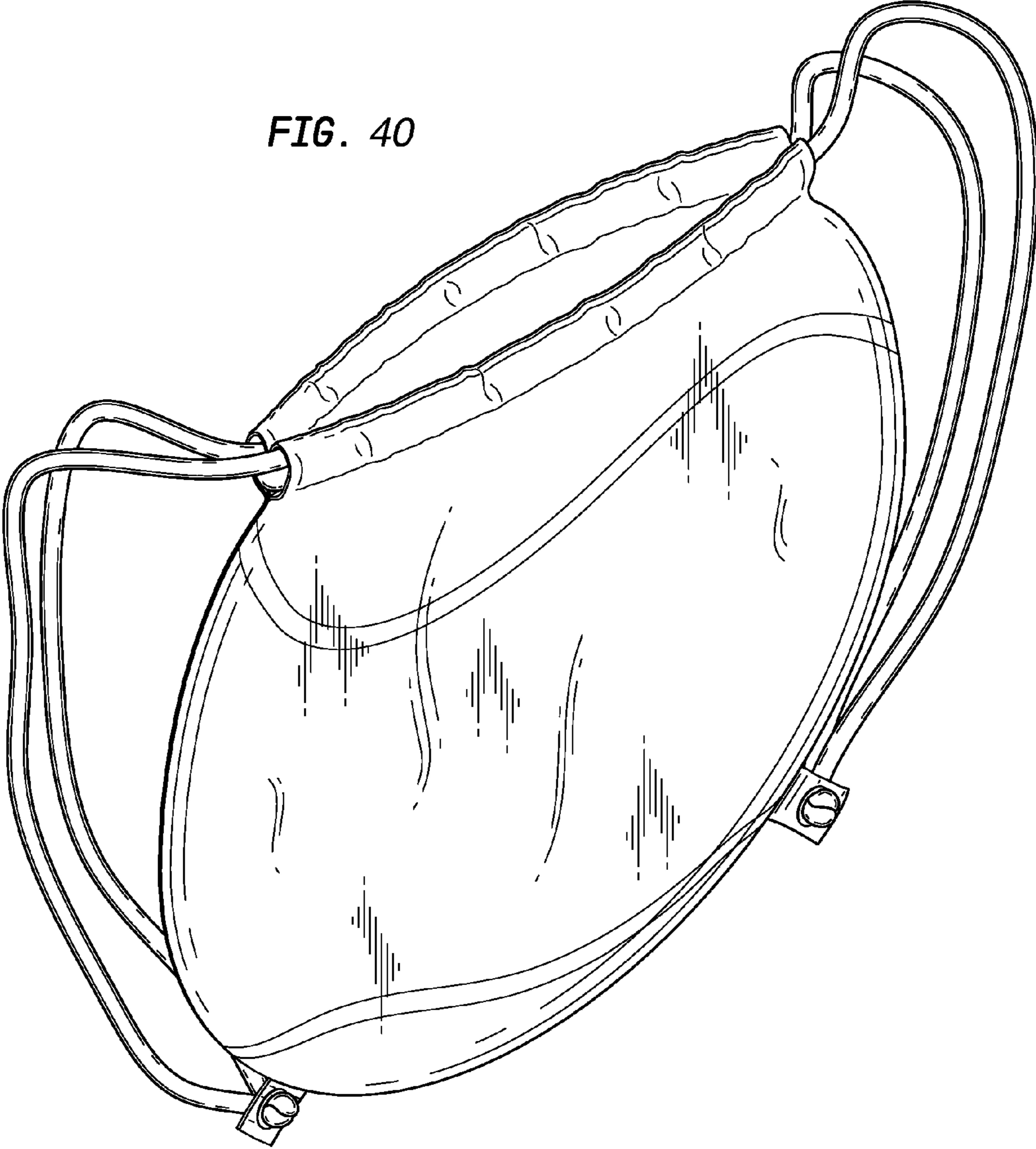

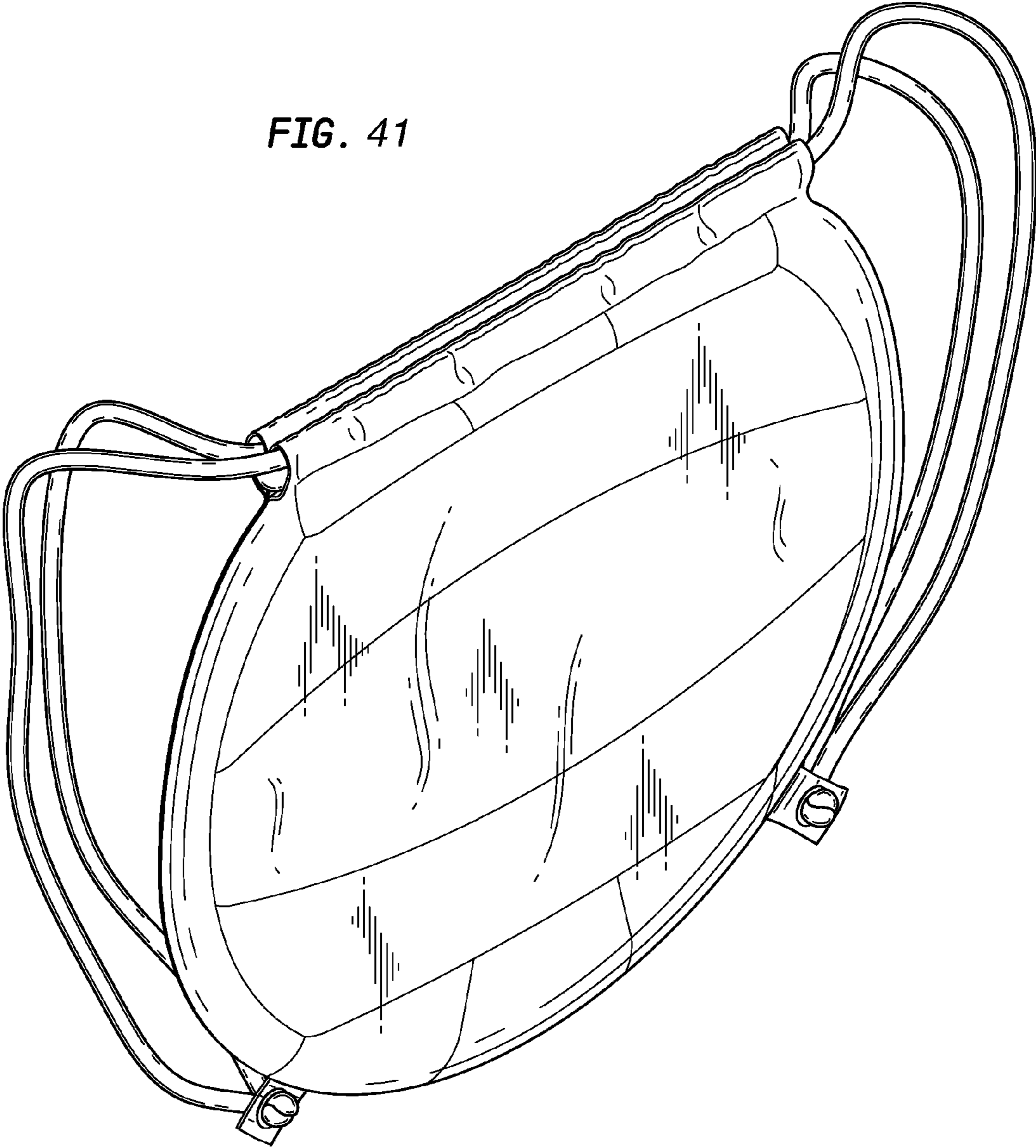

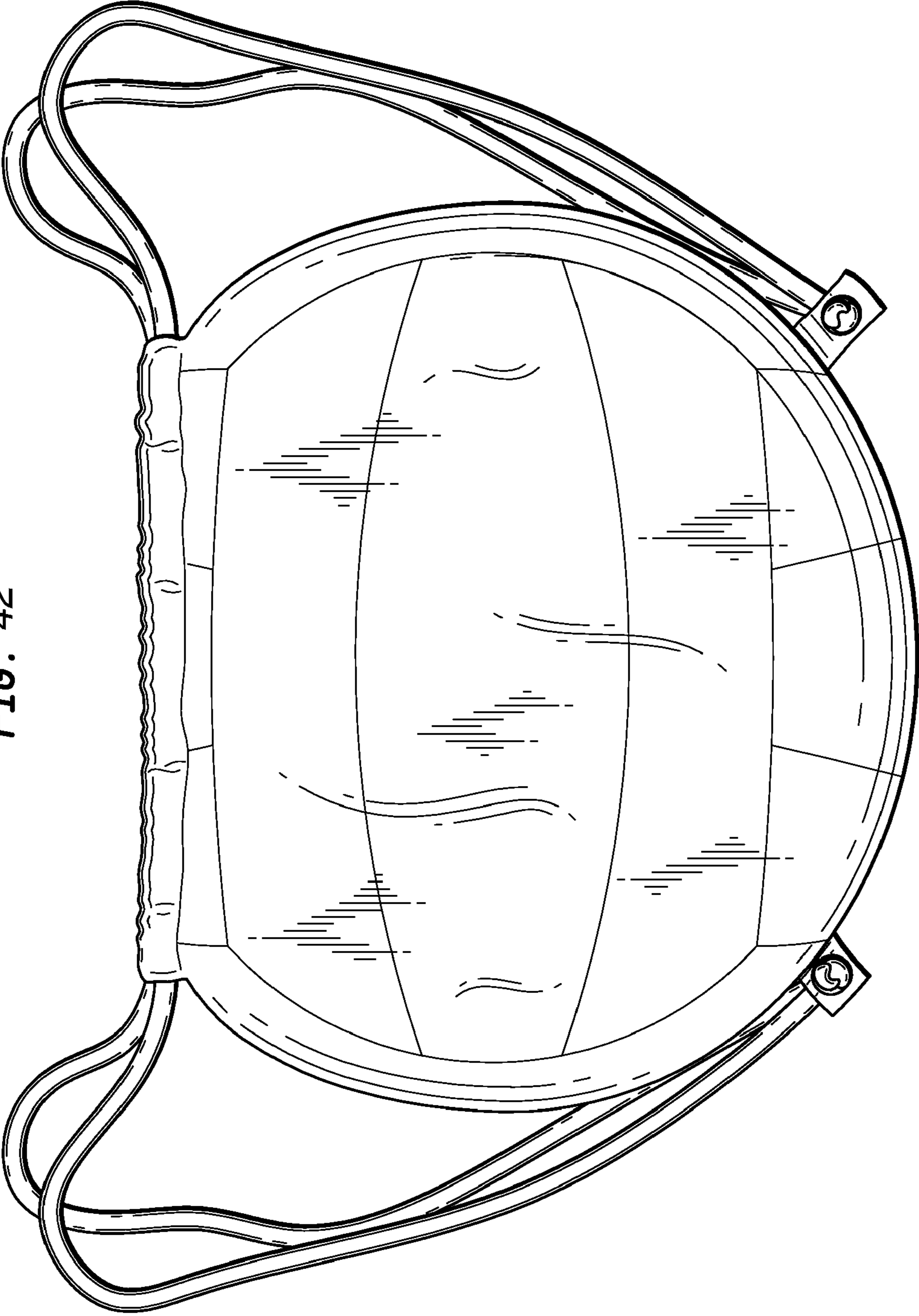

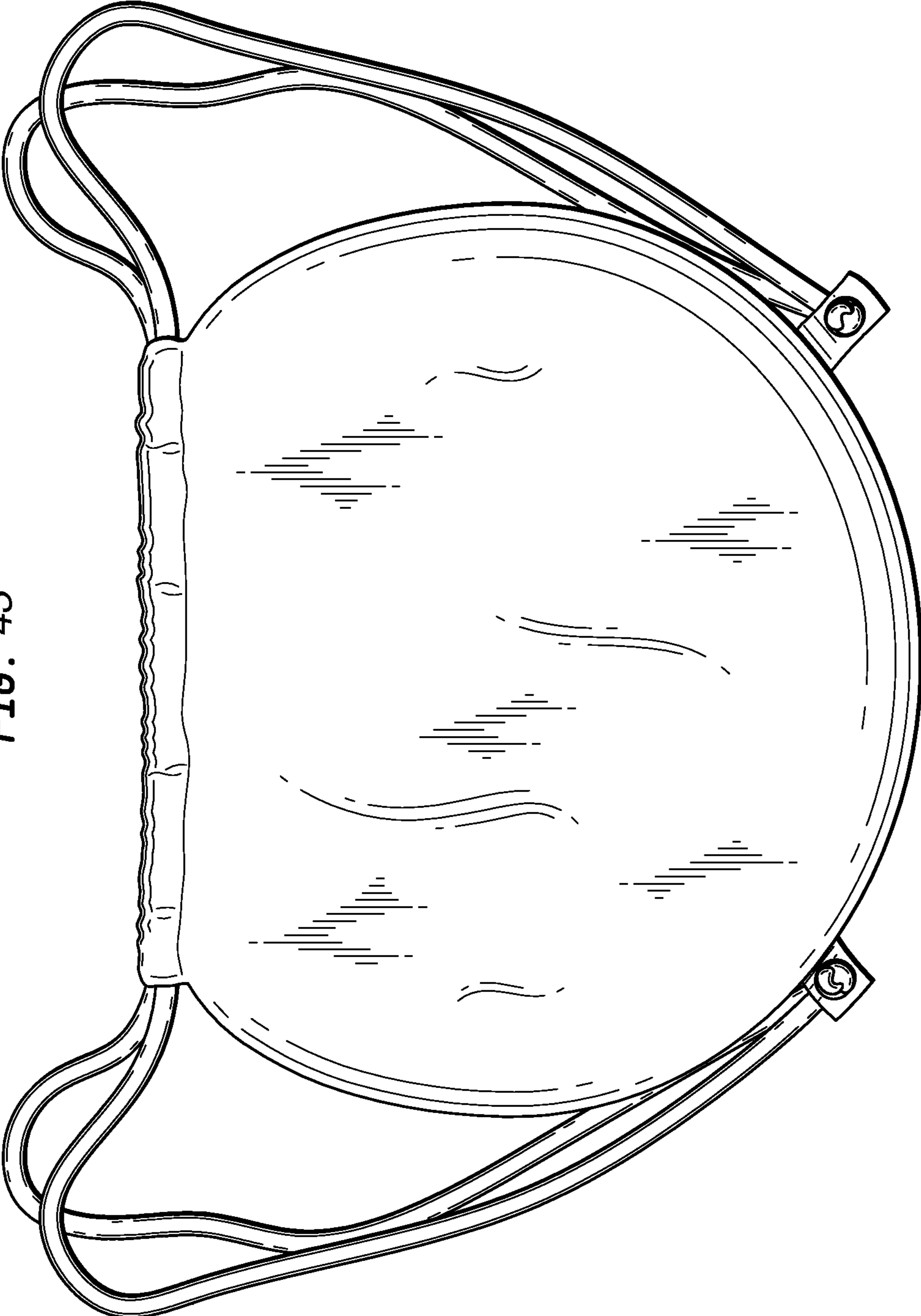

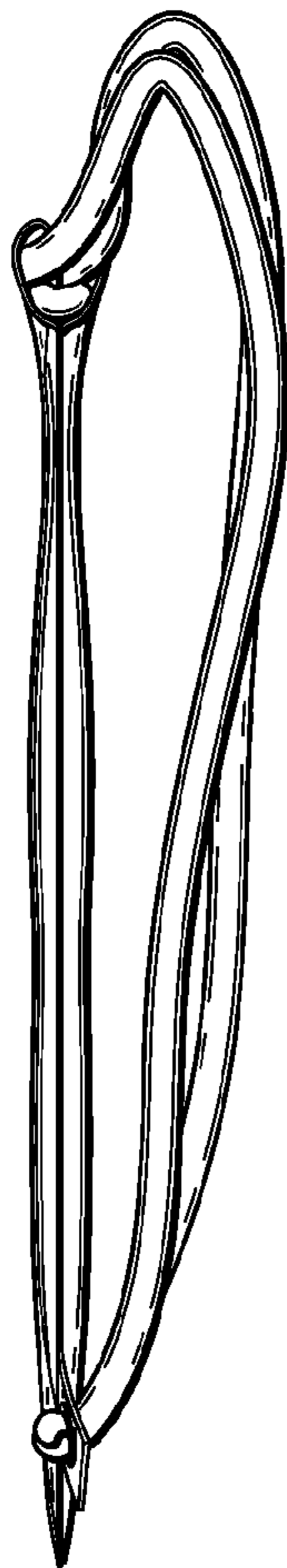

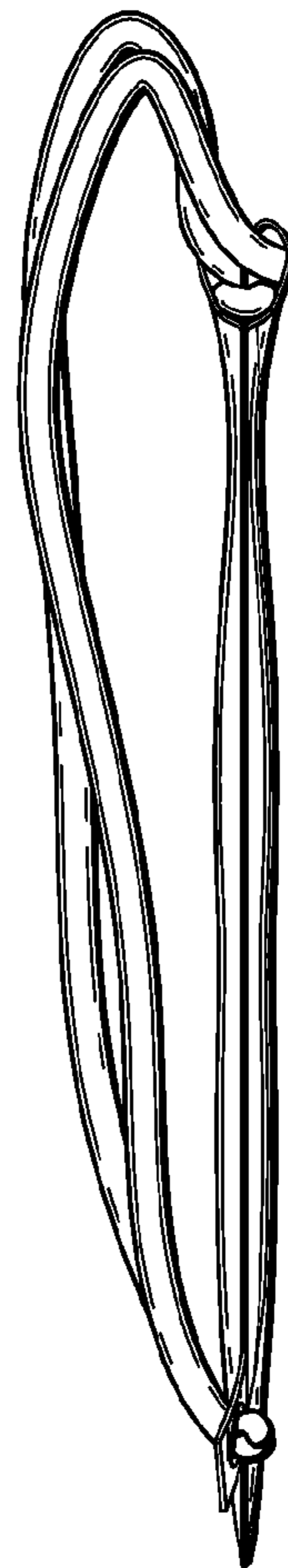

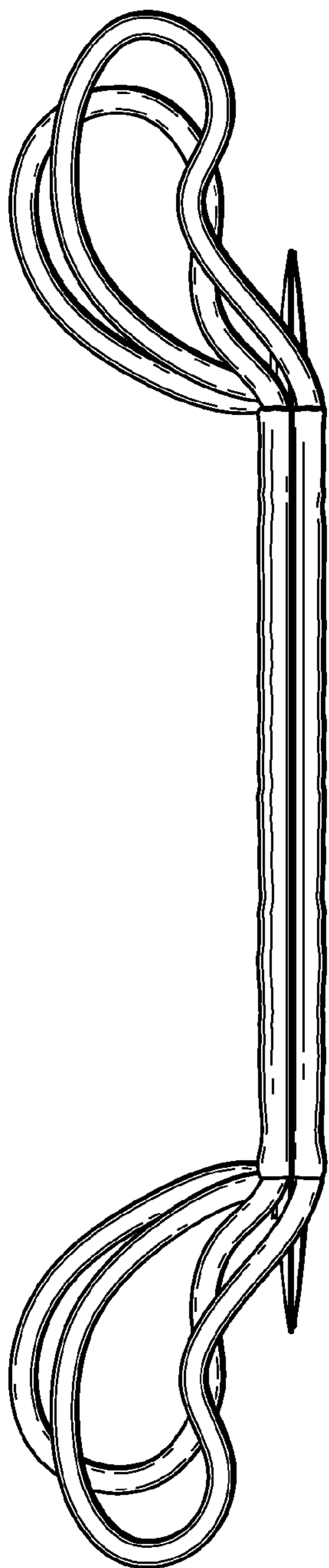

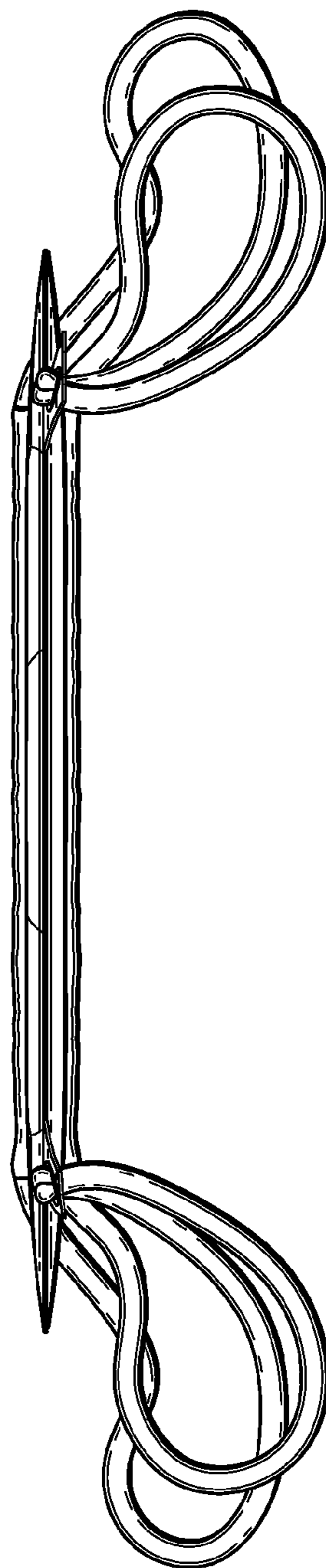
