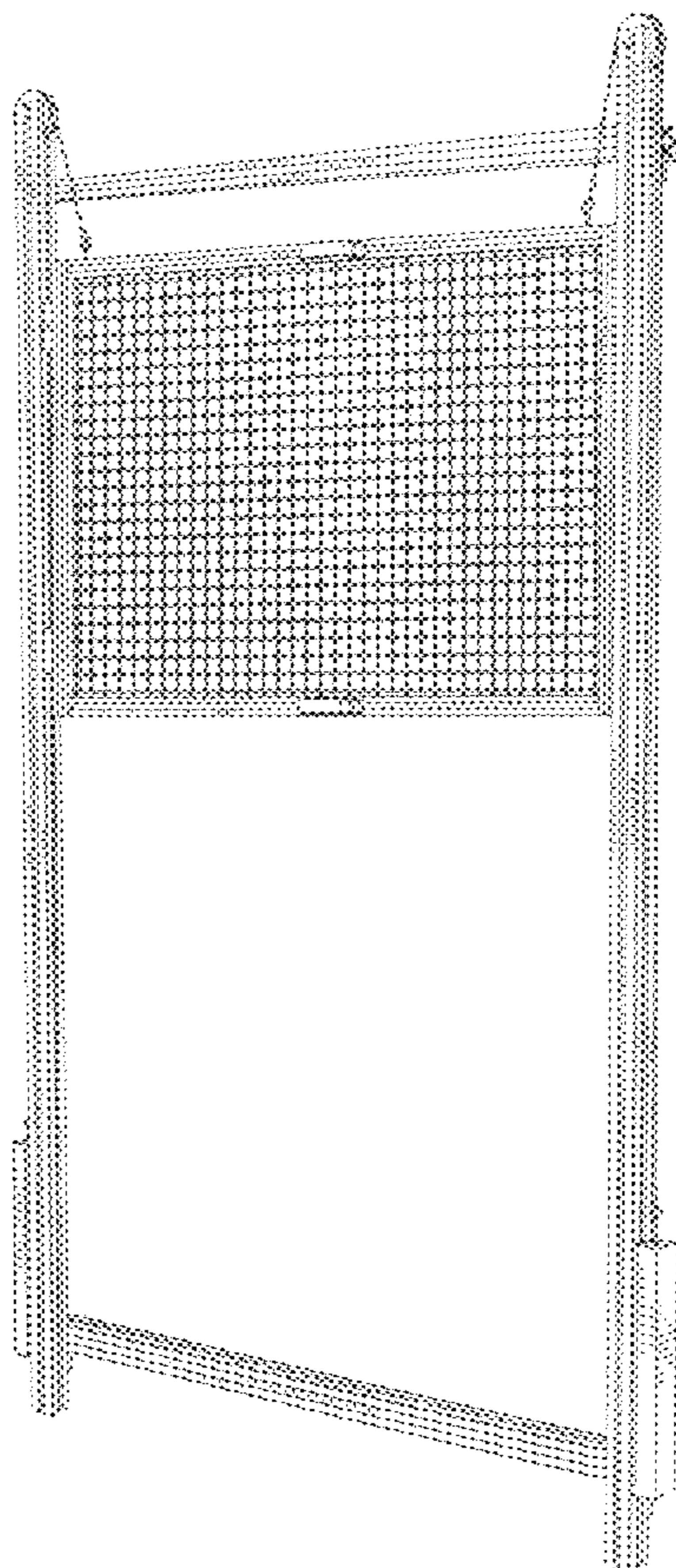
FIG. 1 is a front perspective view for a safety shield according to a first embodiment of the present design;

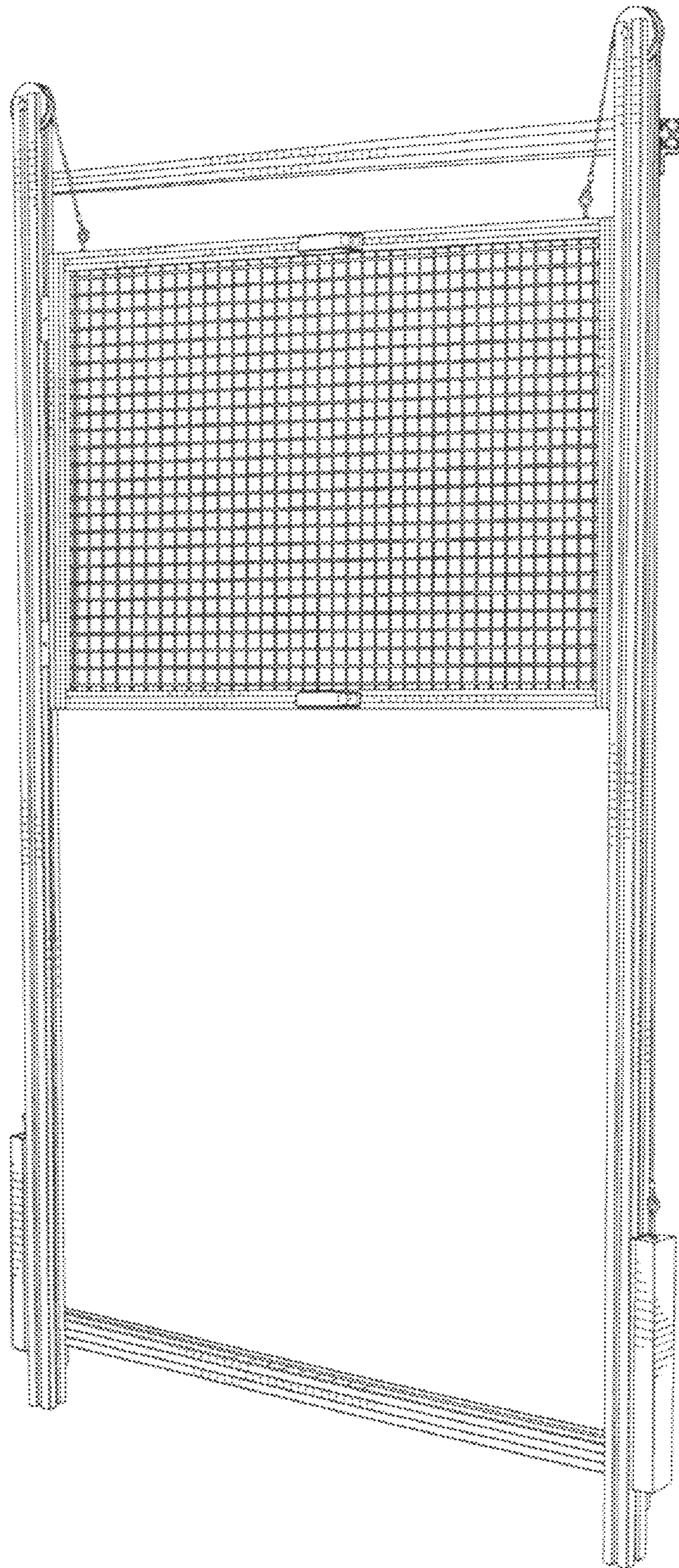

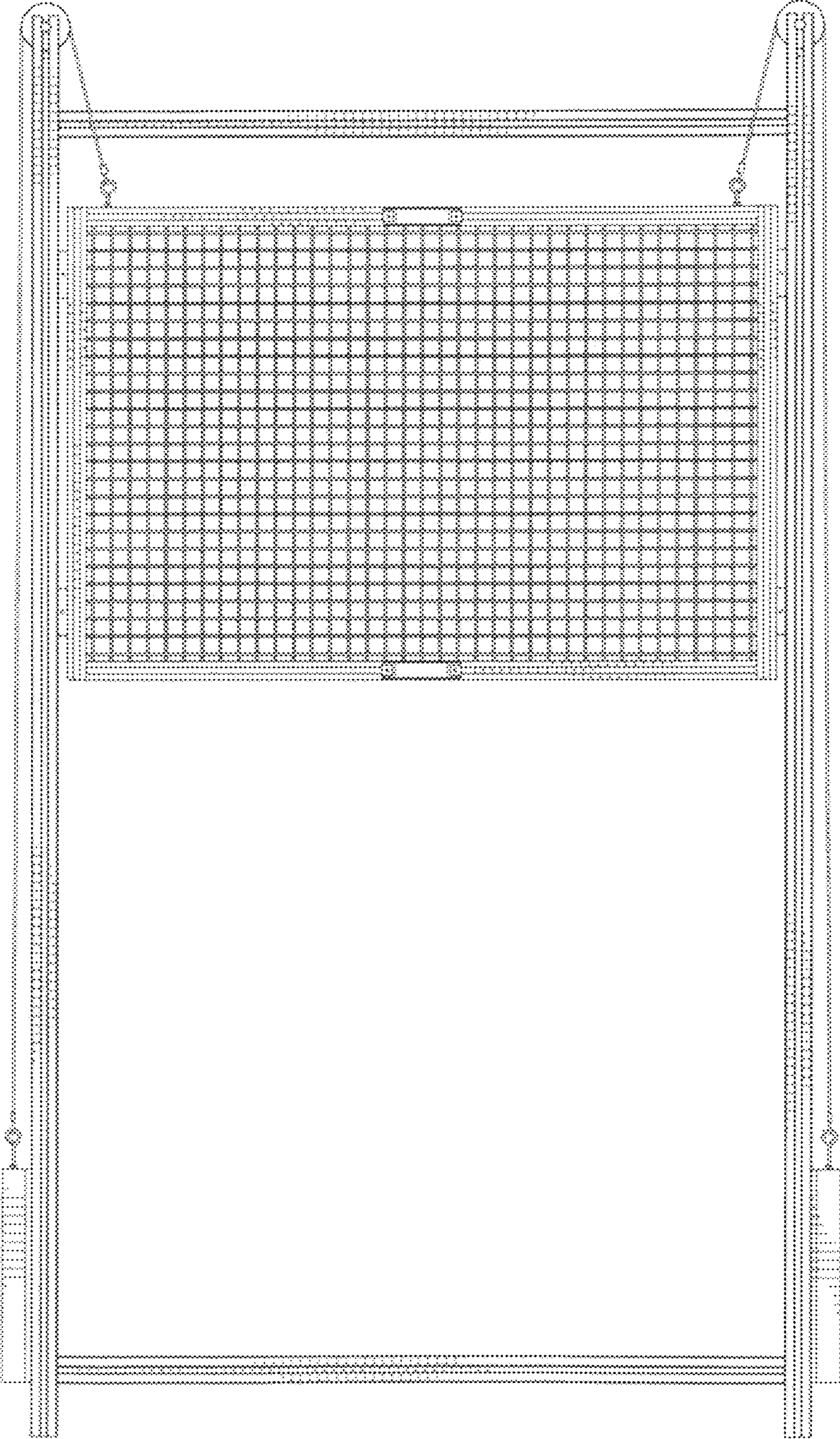

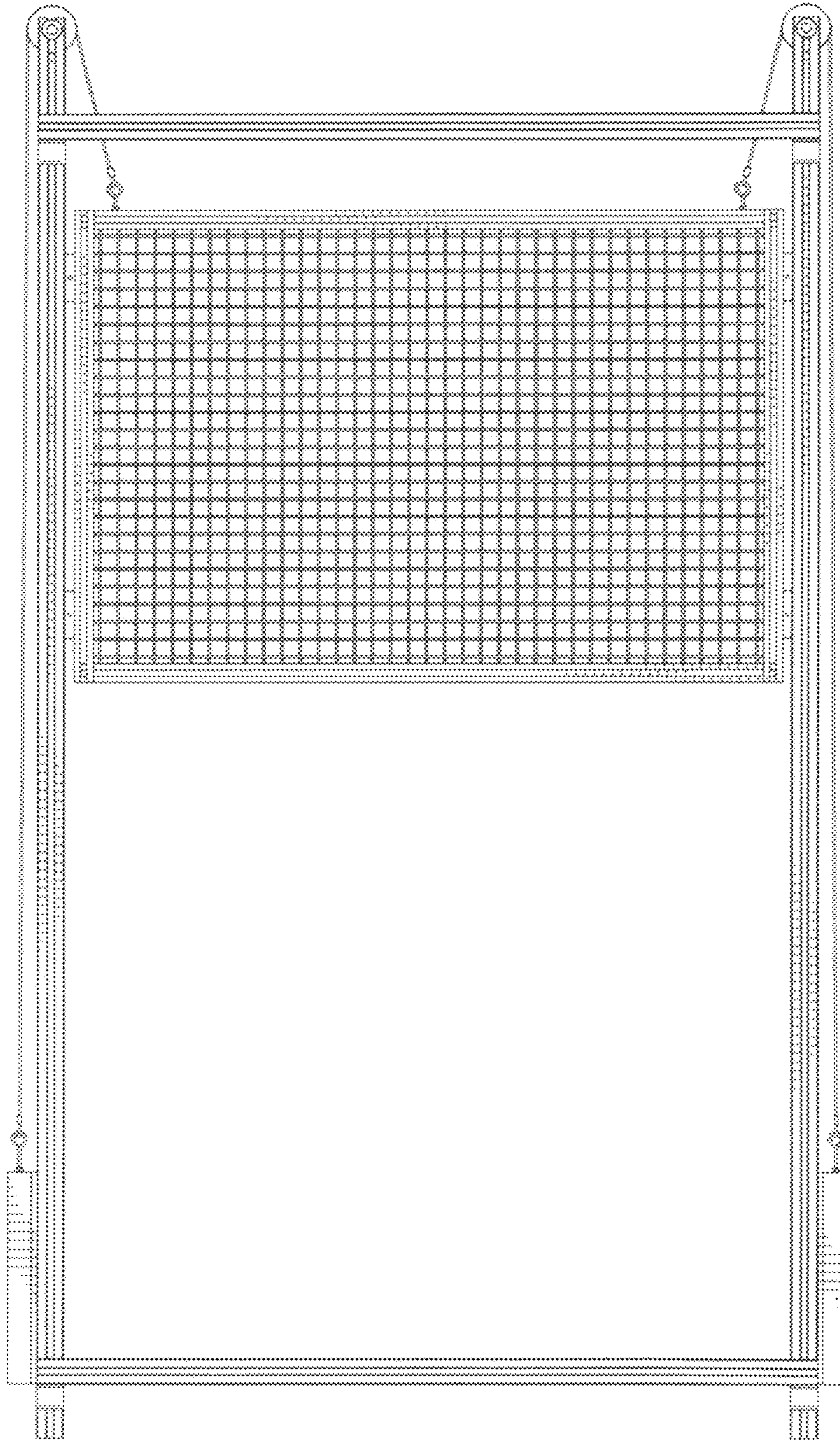

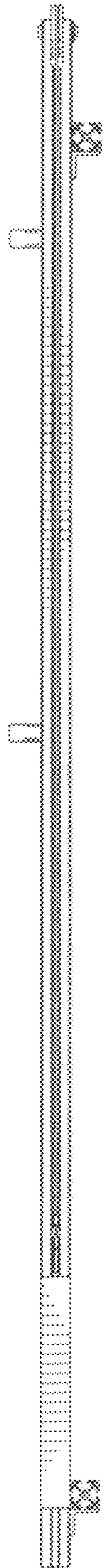

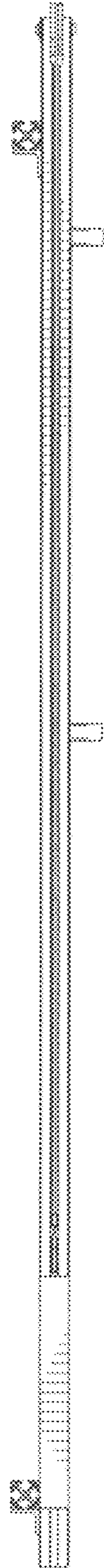

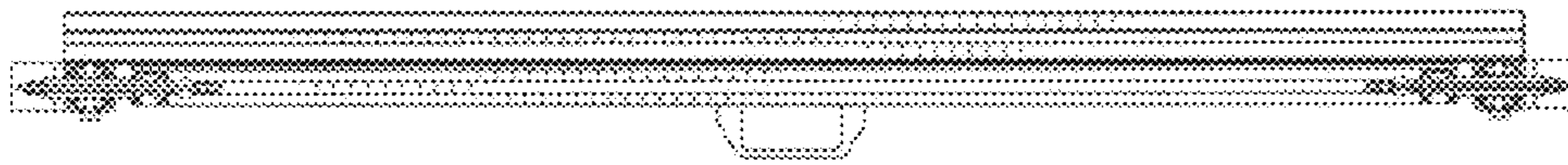
