The broken lines shown are for illustrative purpose only and form no part of the claimed design.

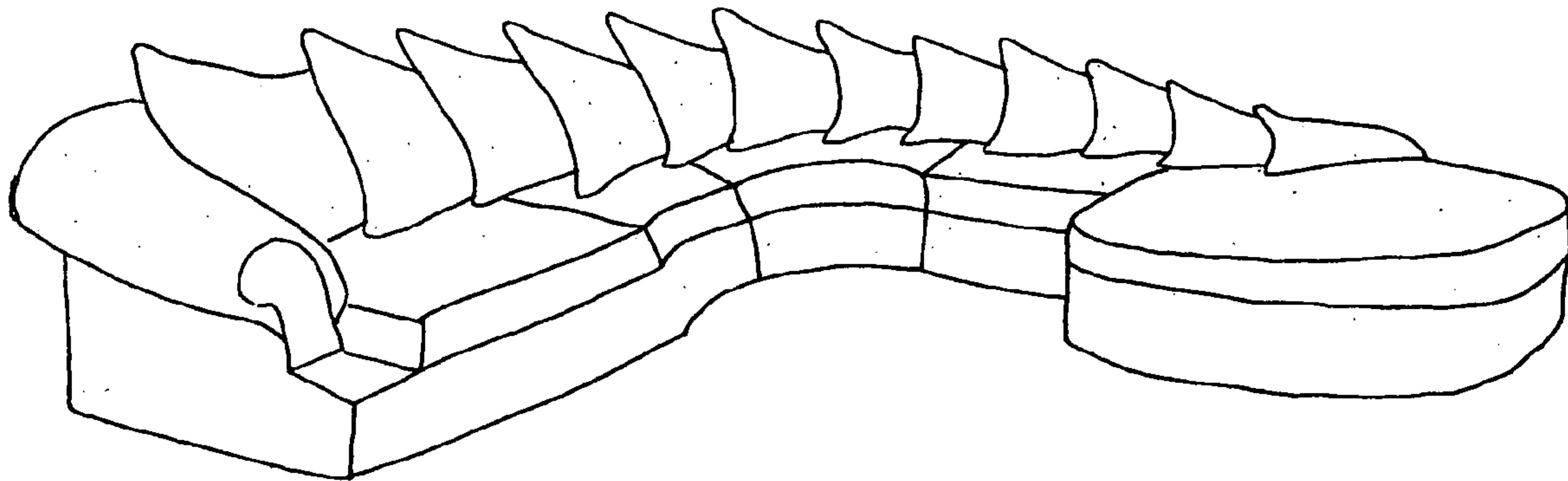

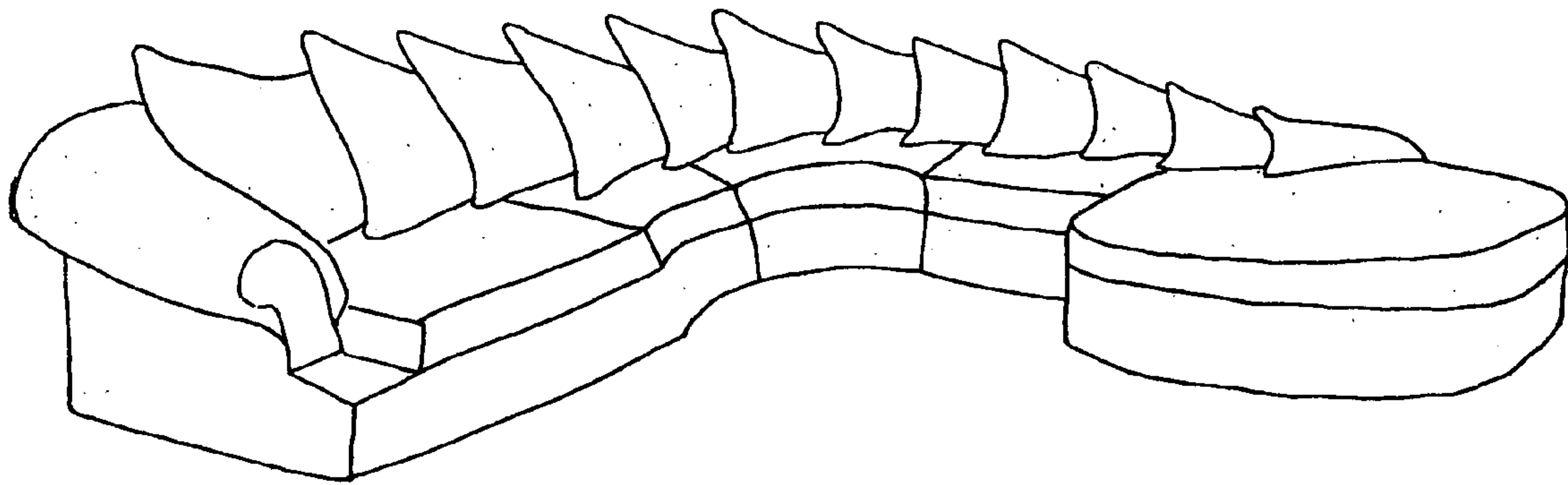

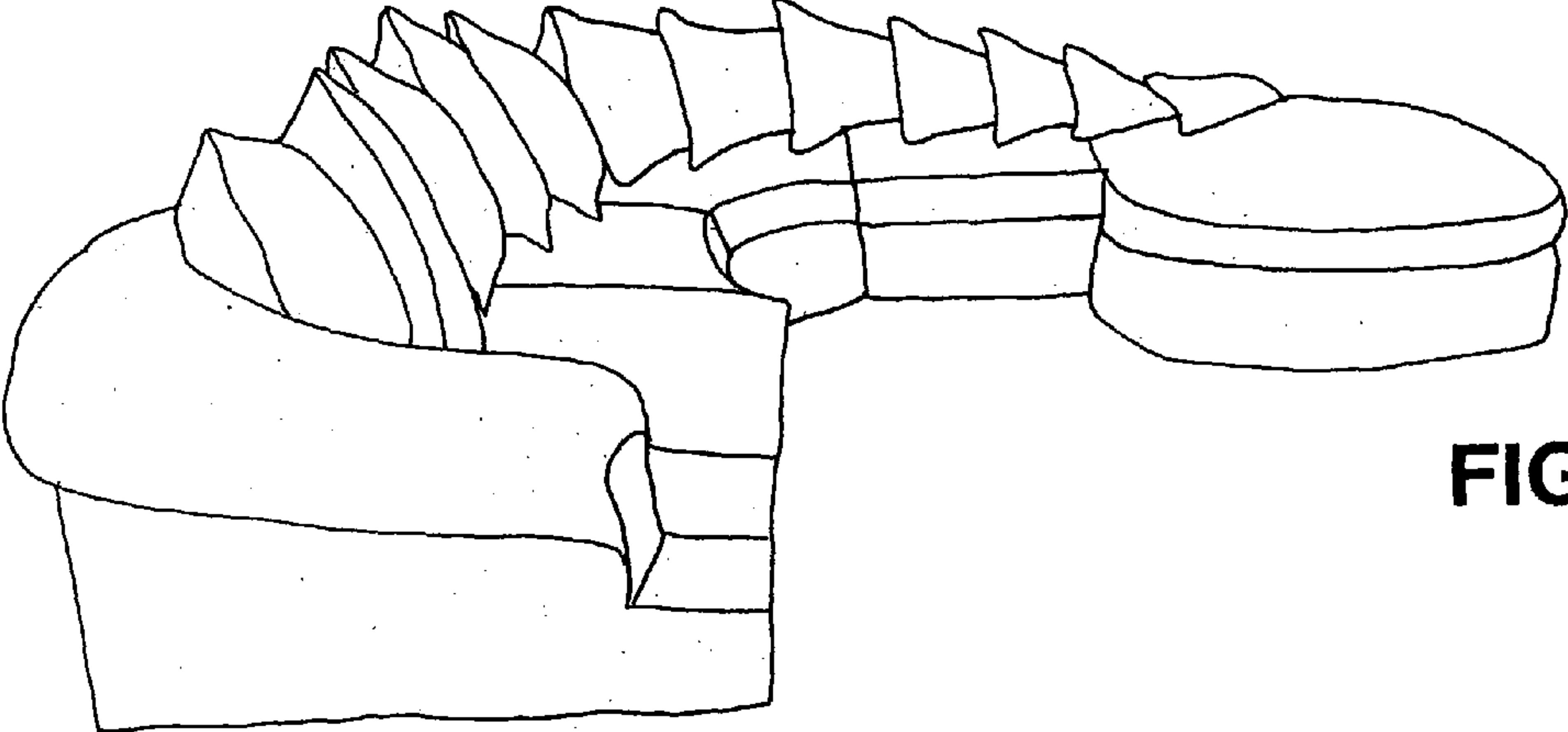
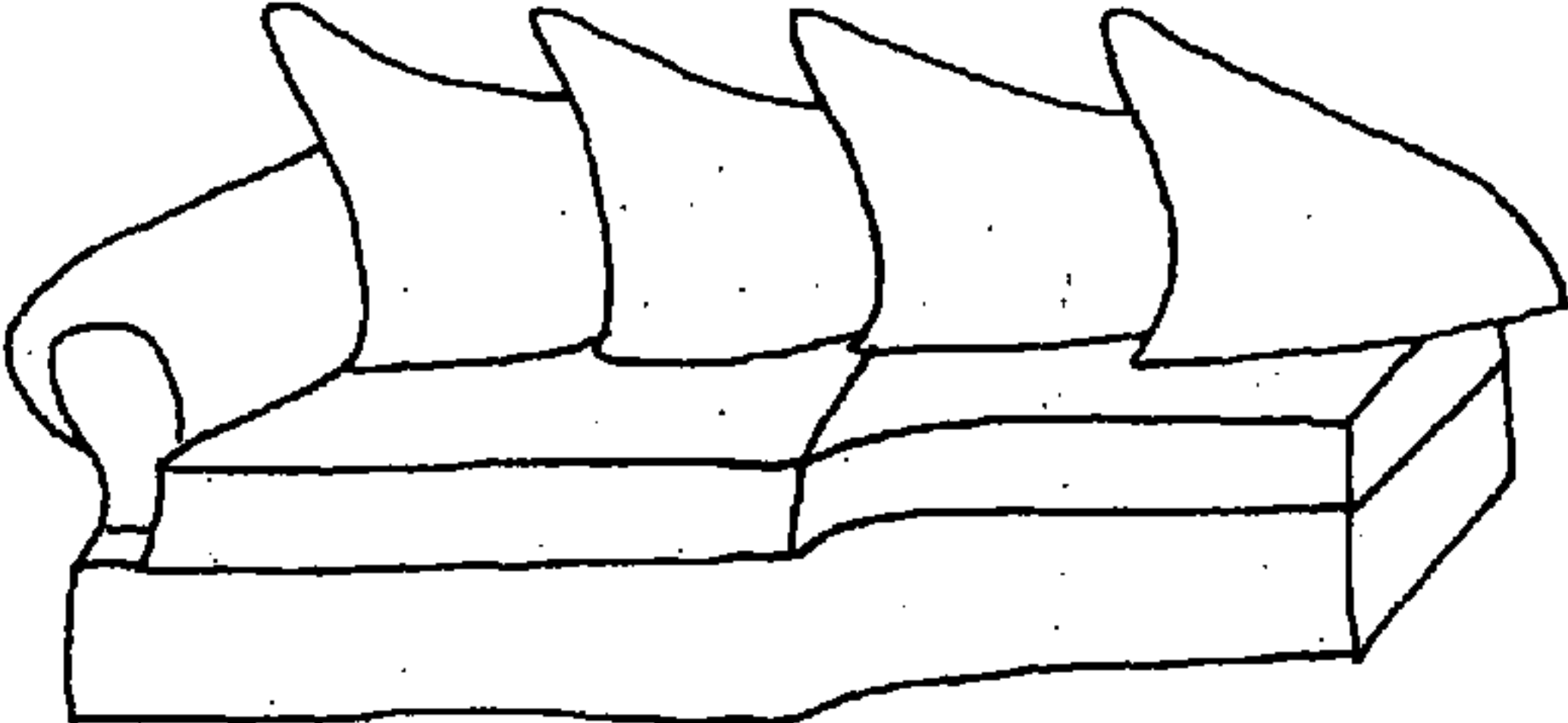
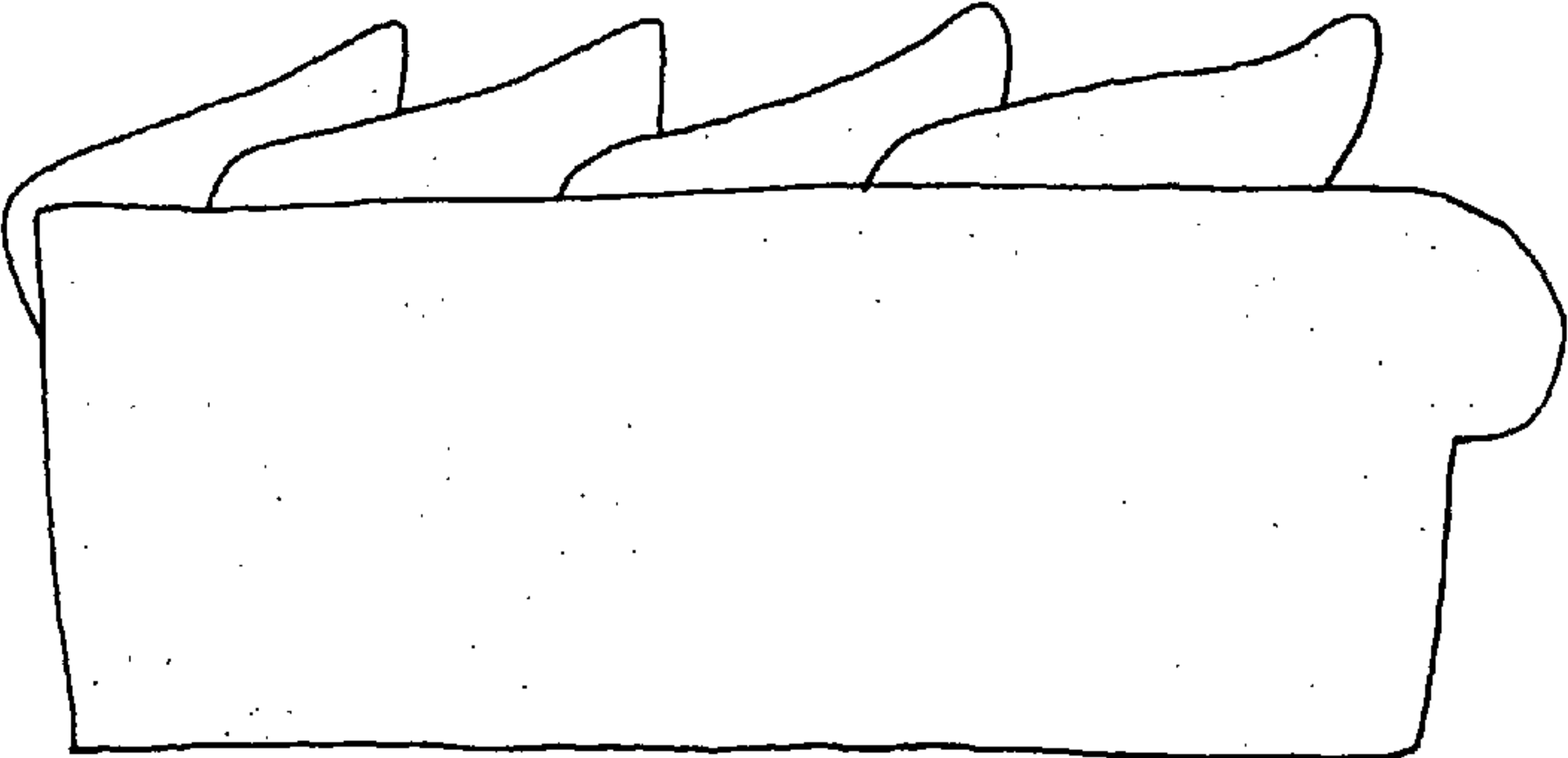

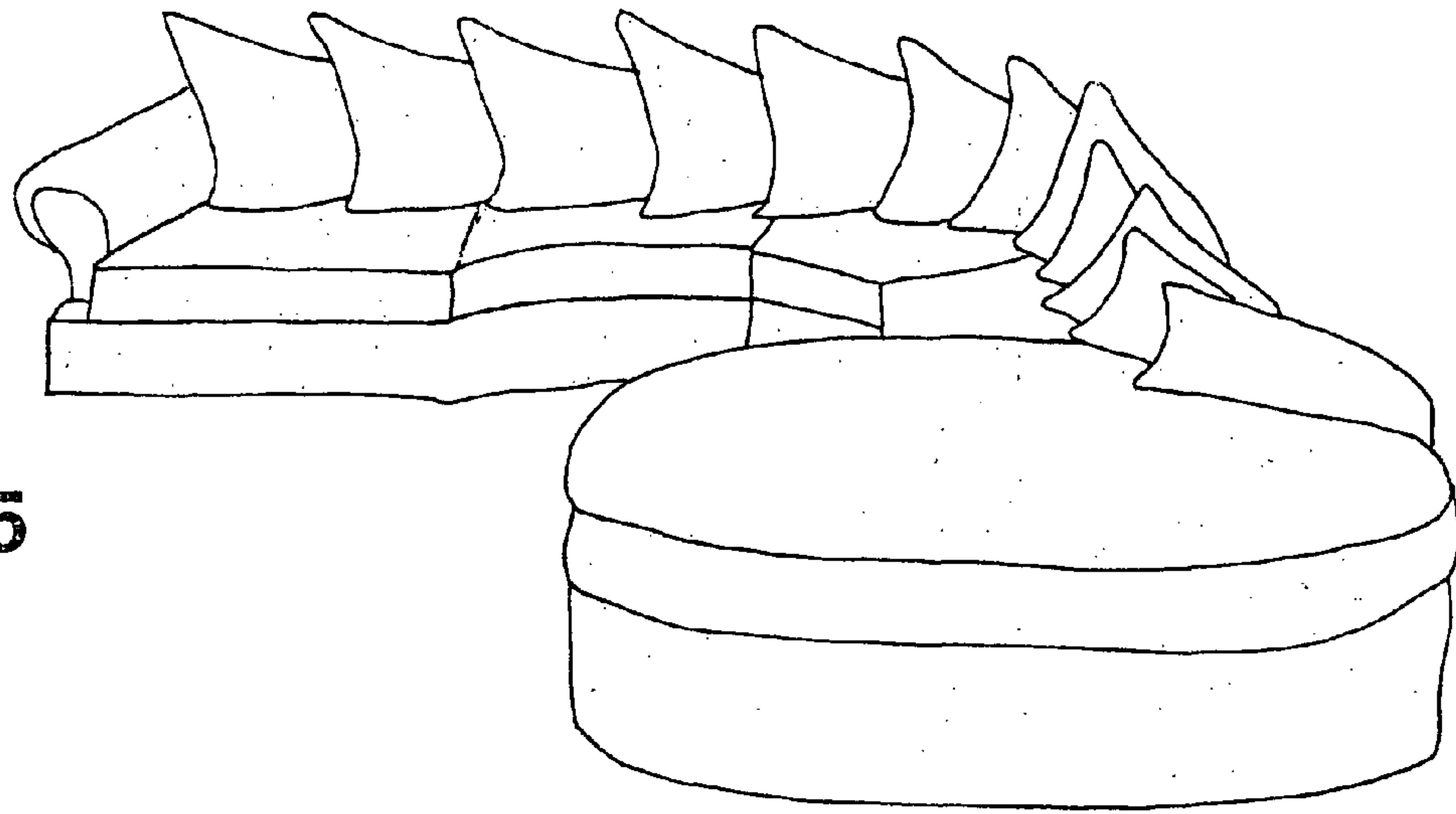

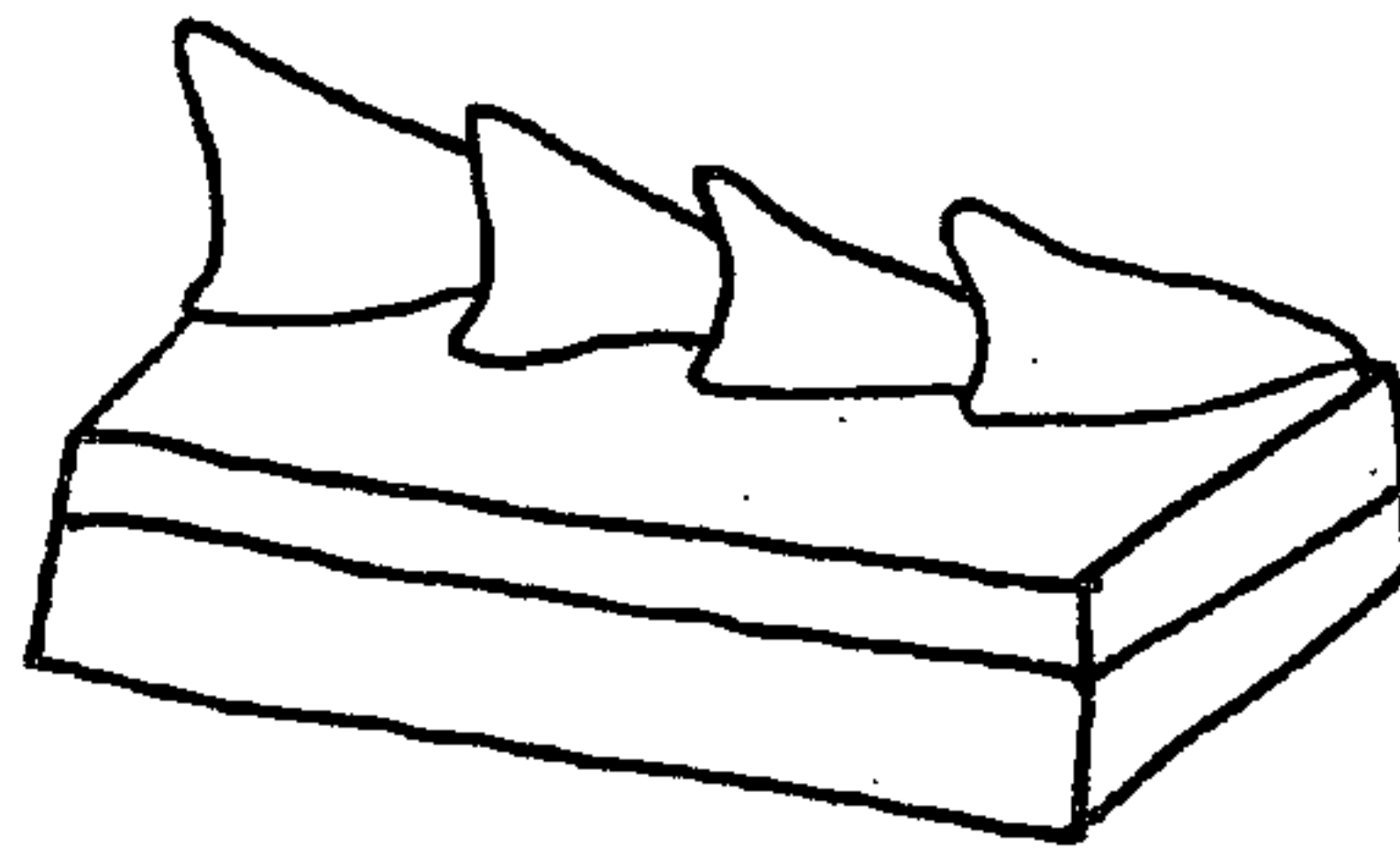

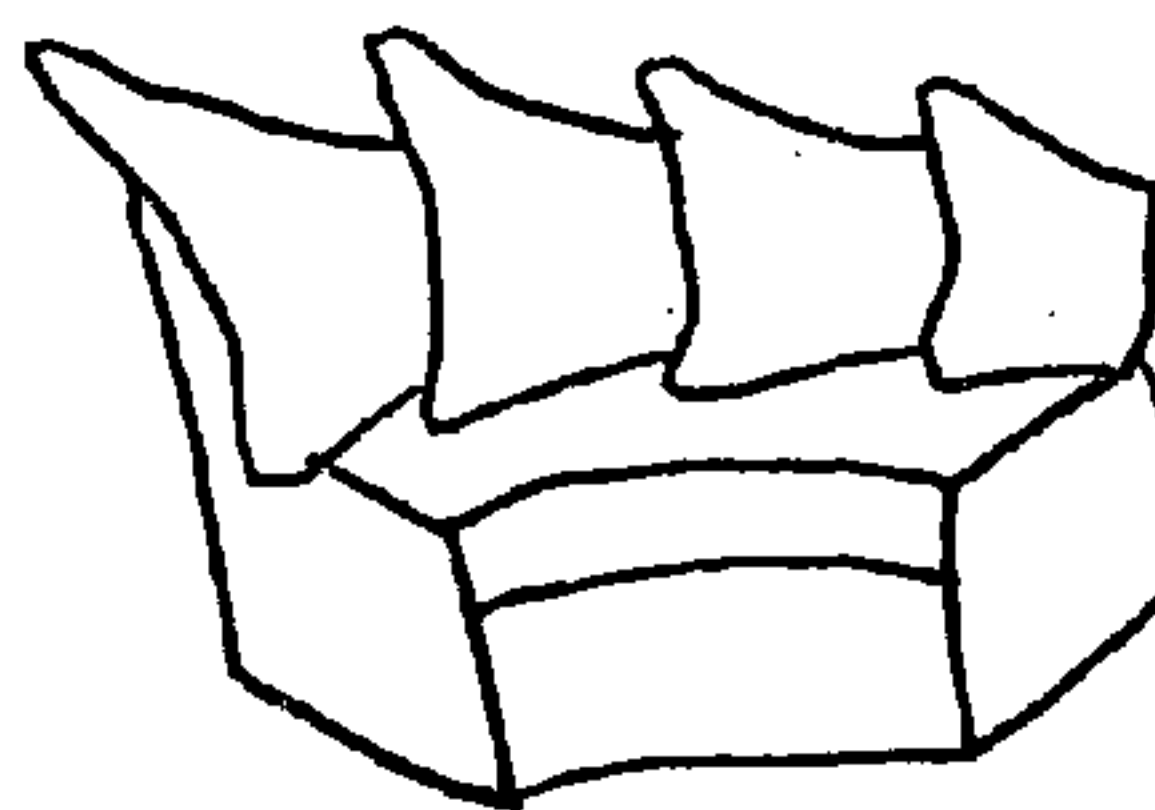

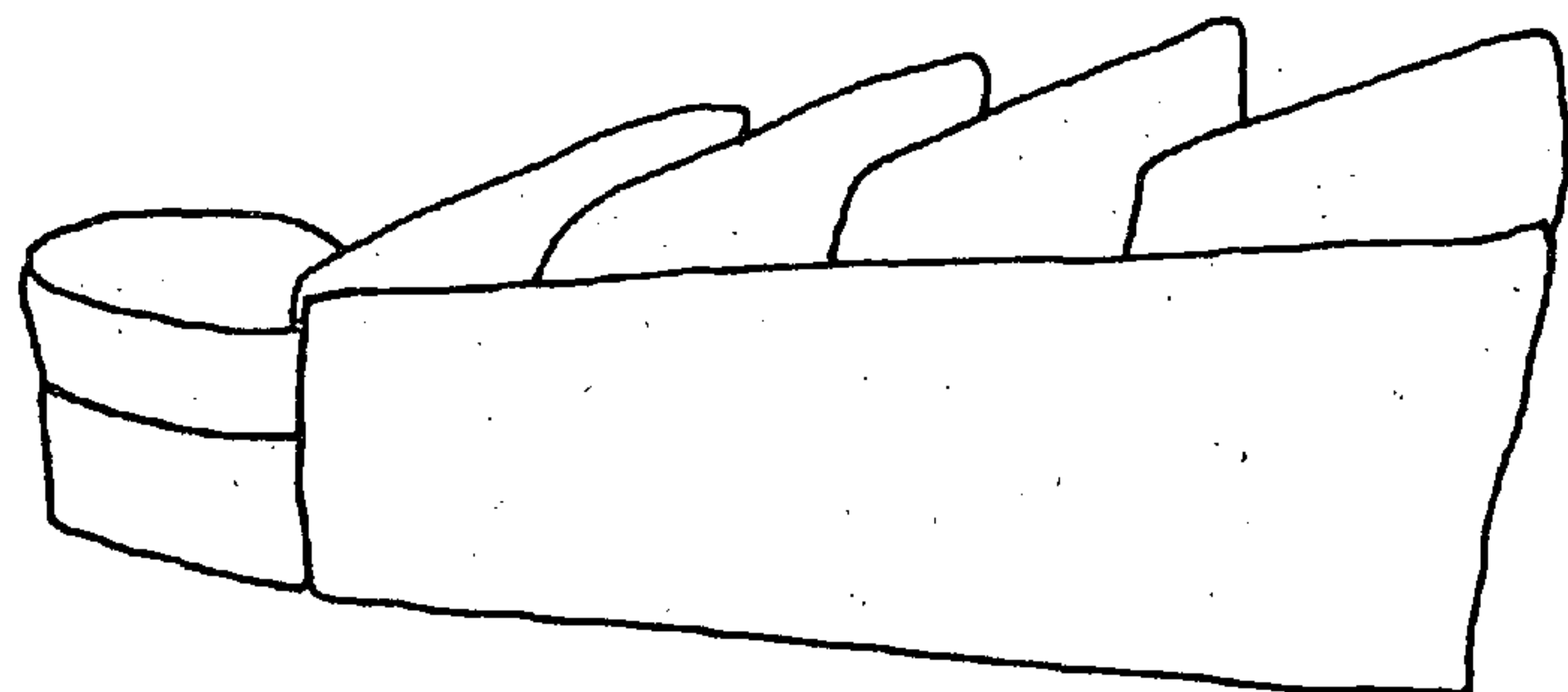

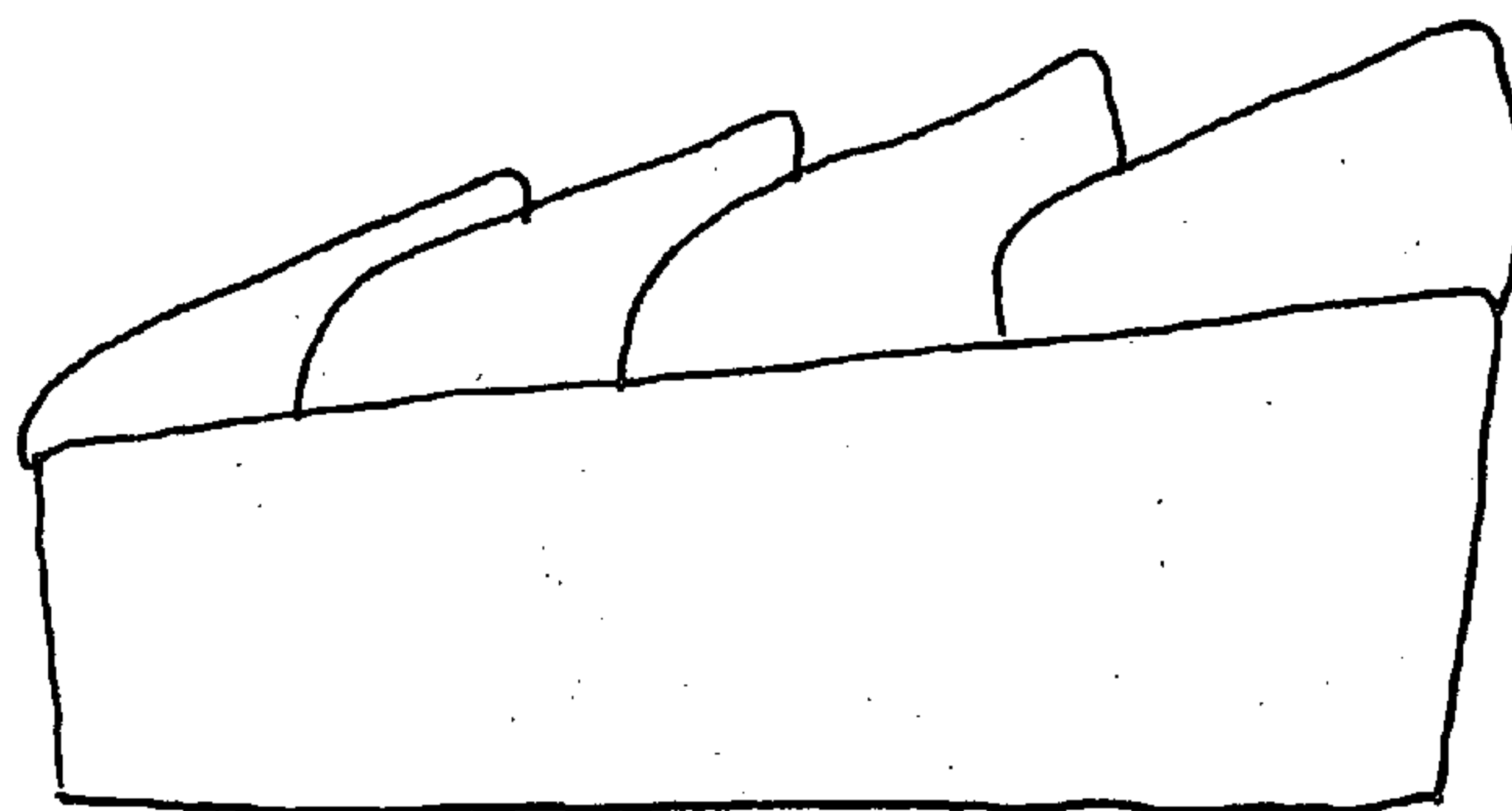

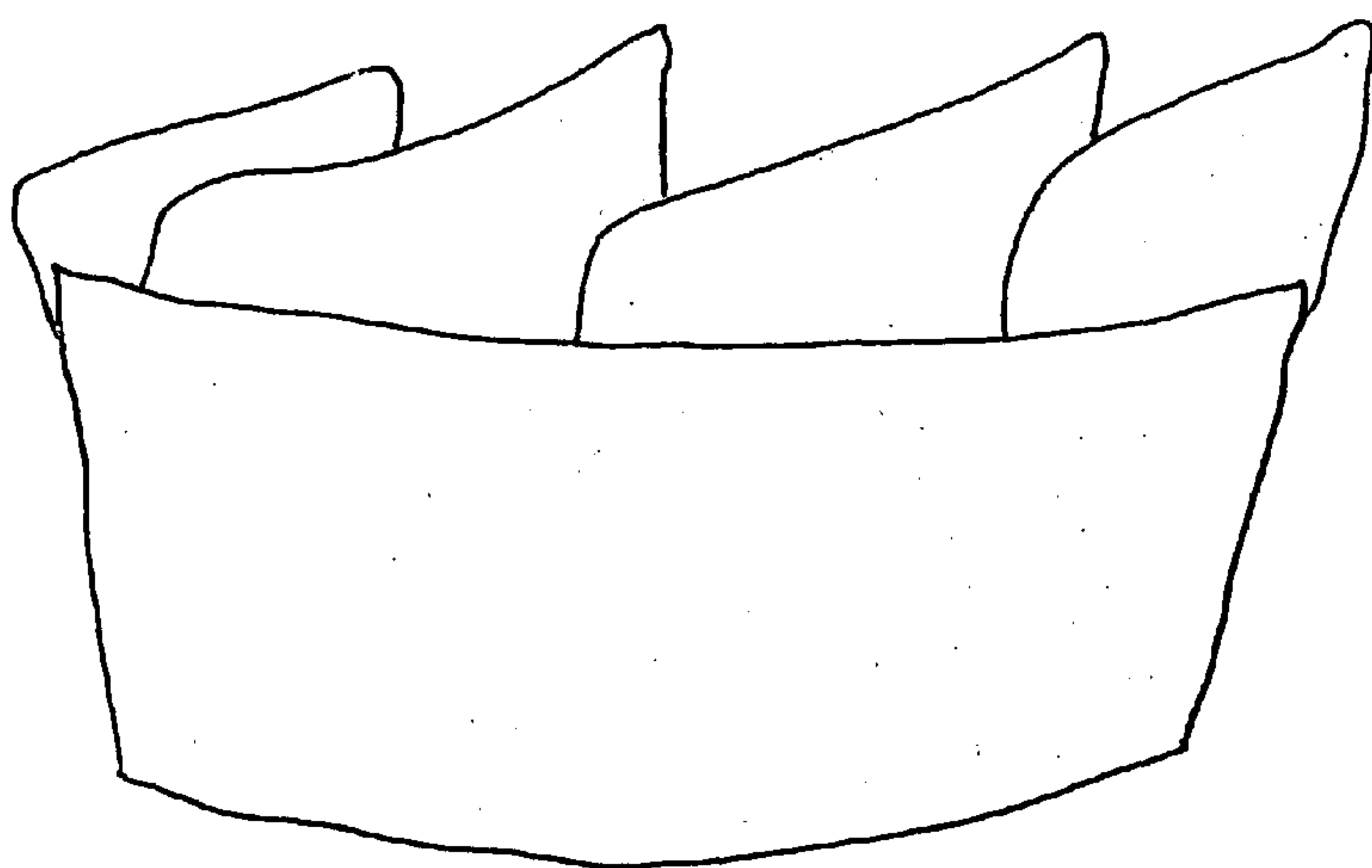

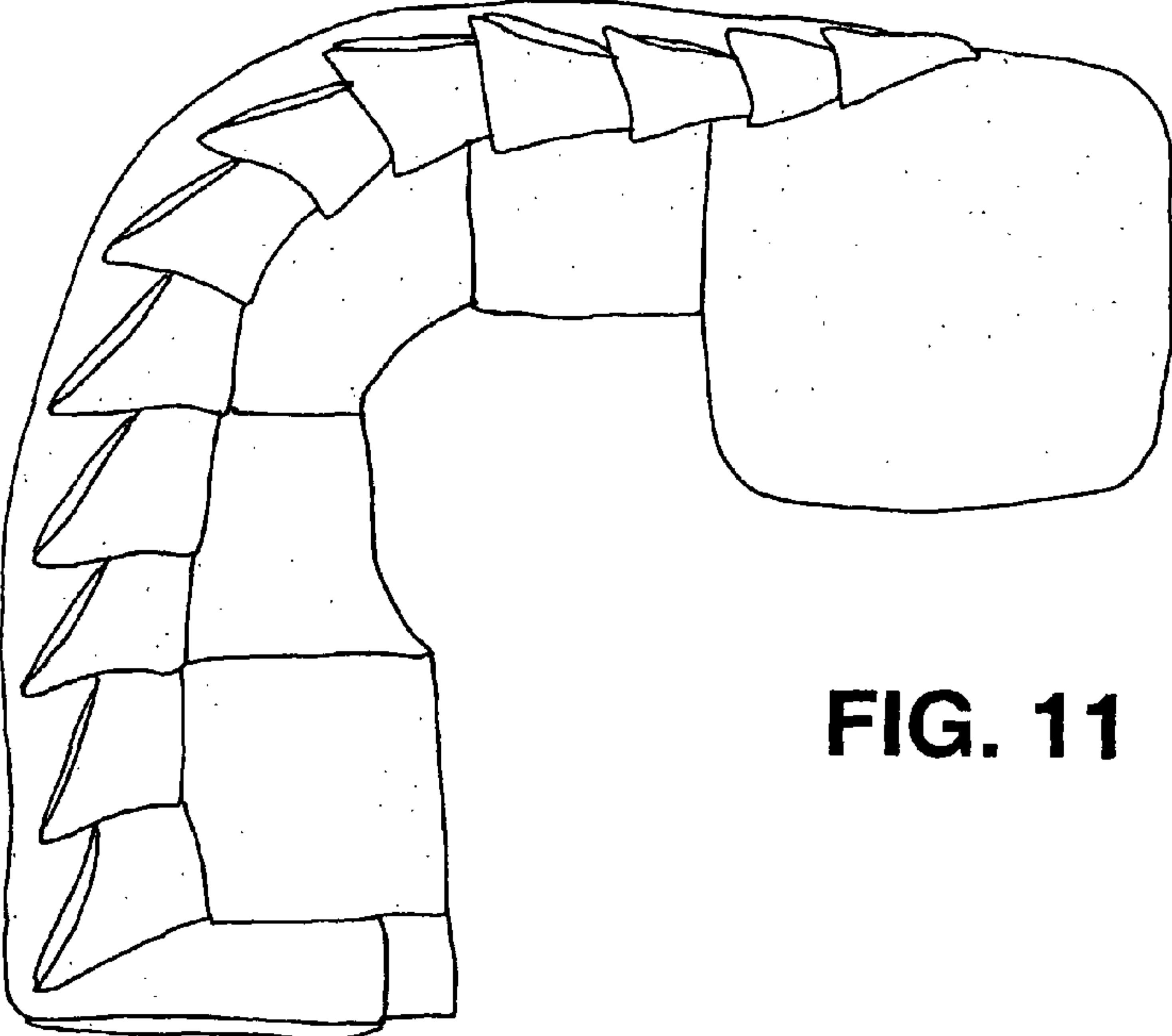

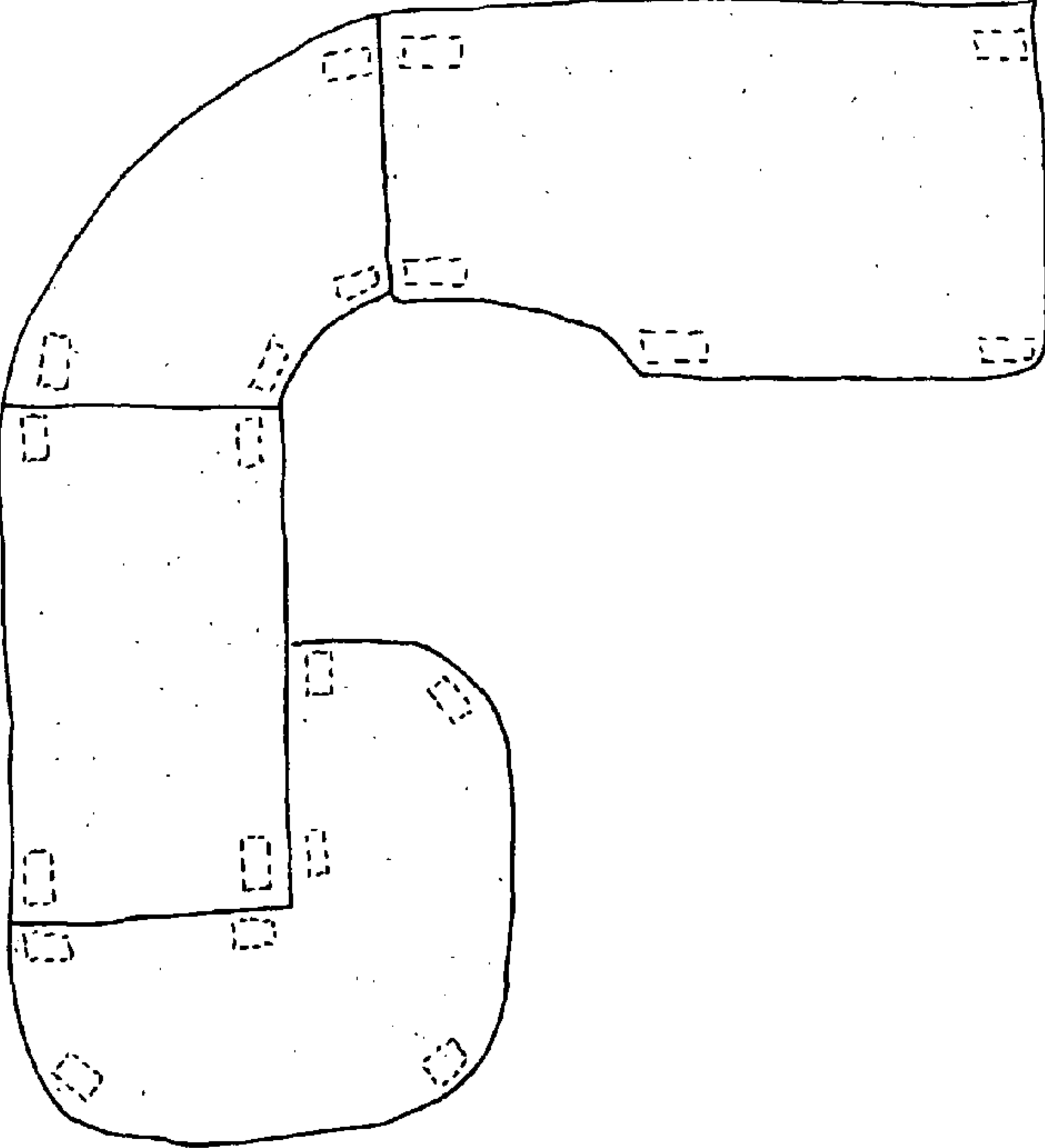
