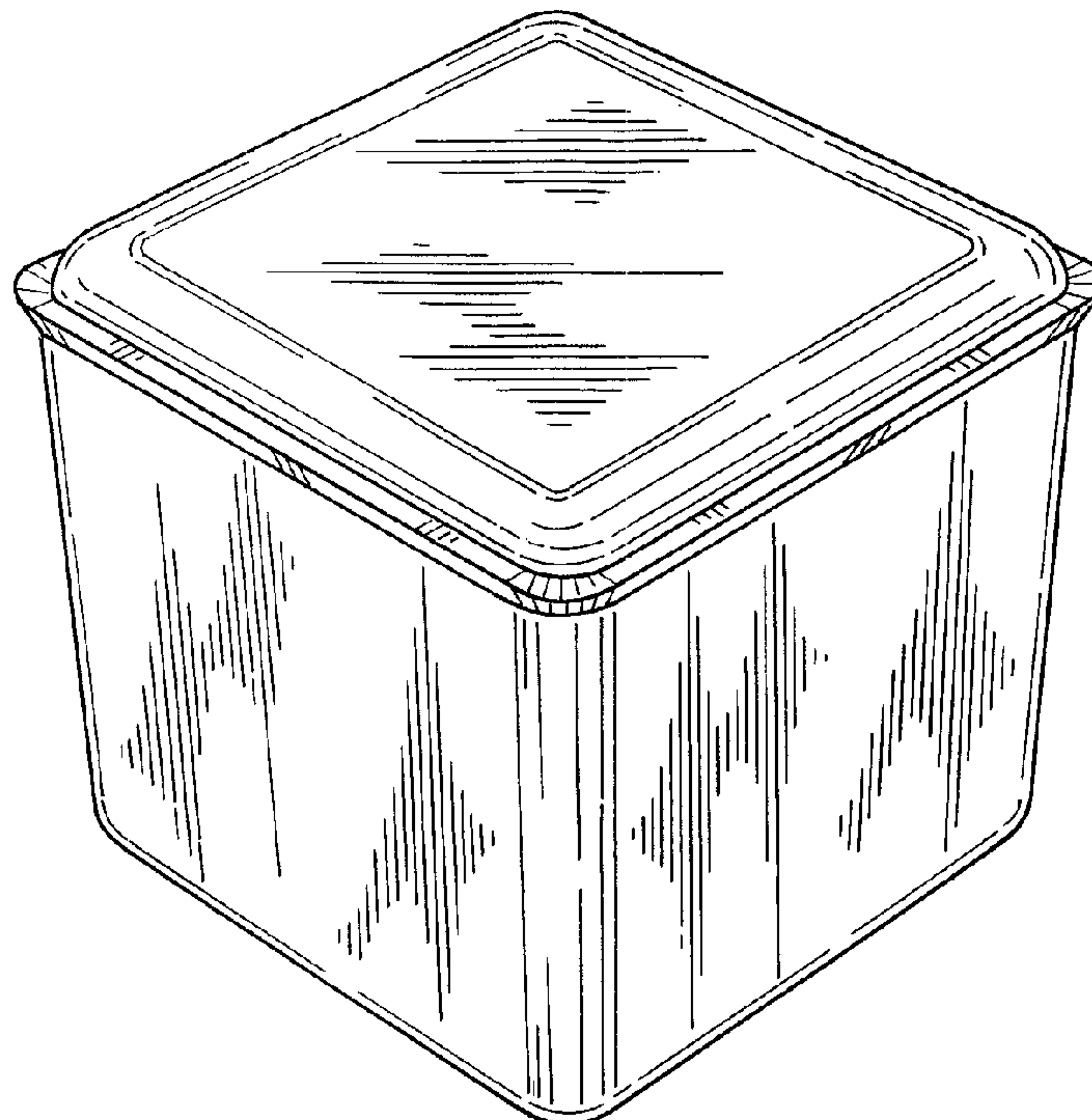
(57) **CLAIM**

We claim the ornamental design for a cartridge for coffee machine, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view, from above, of a cartridge for coffee machine embodying our design;

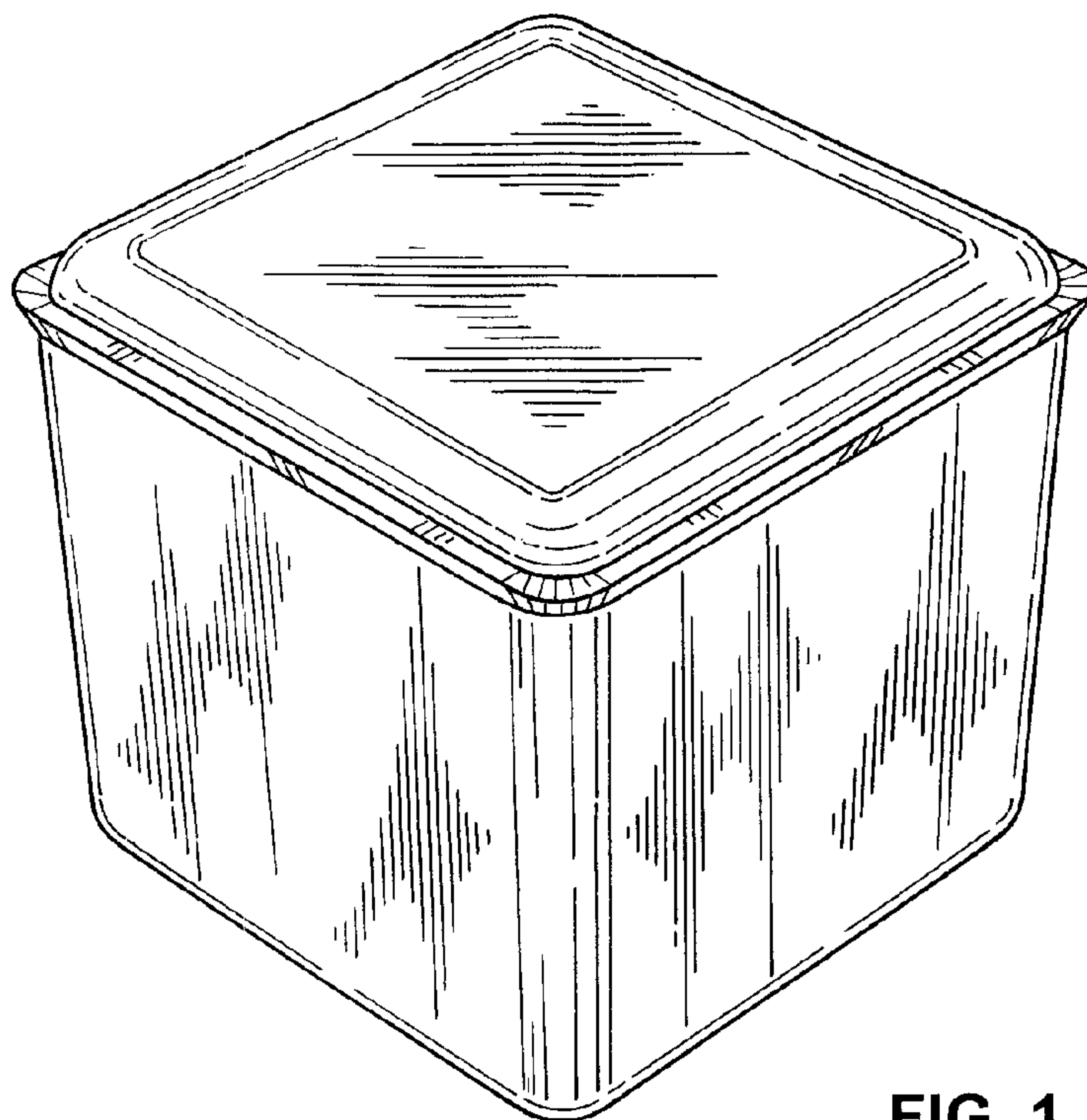

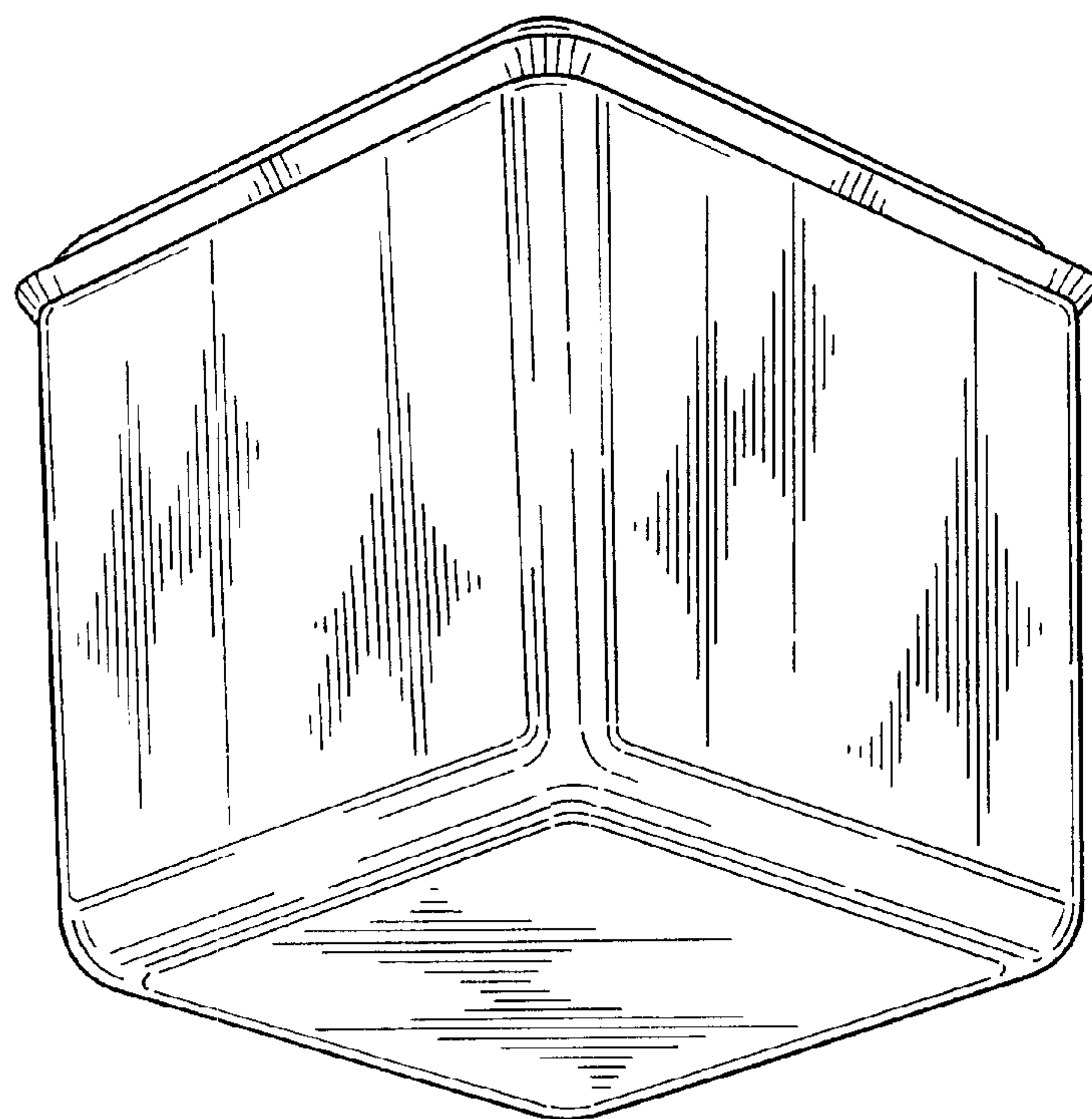

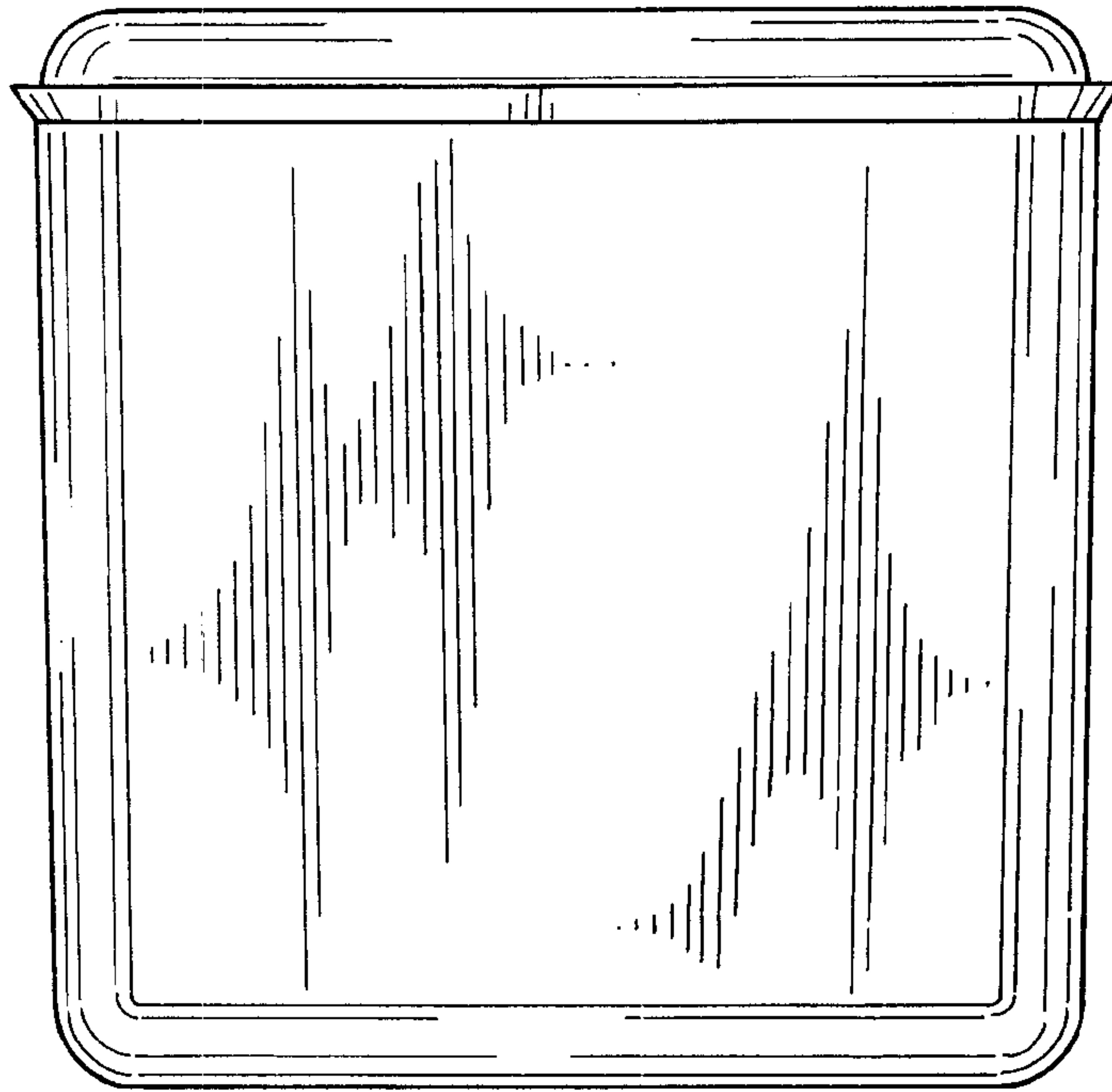

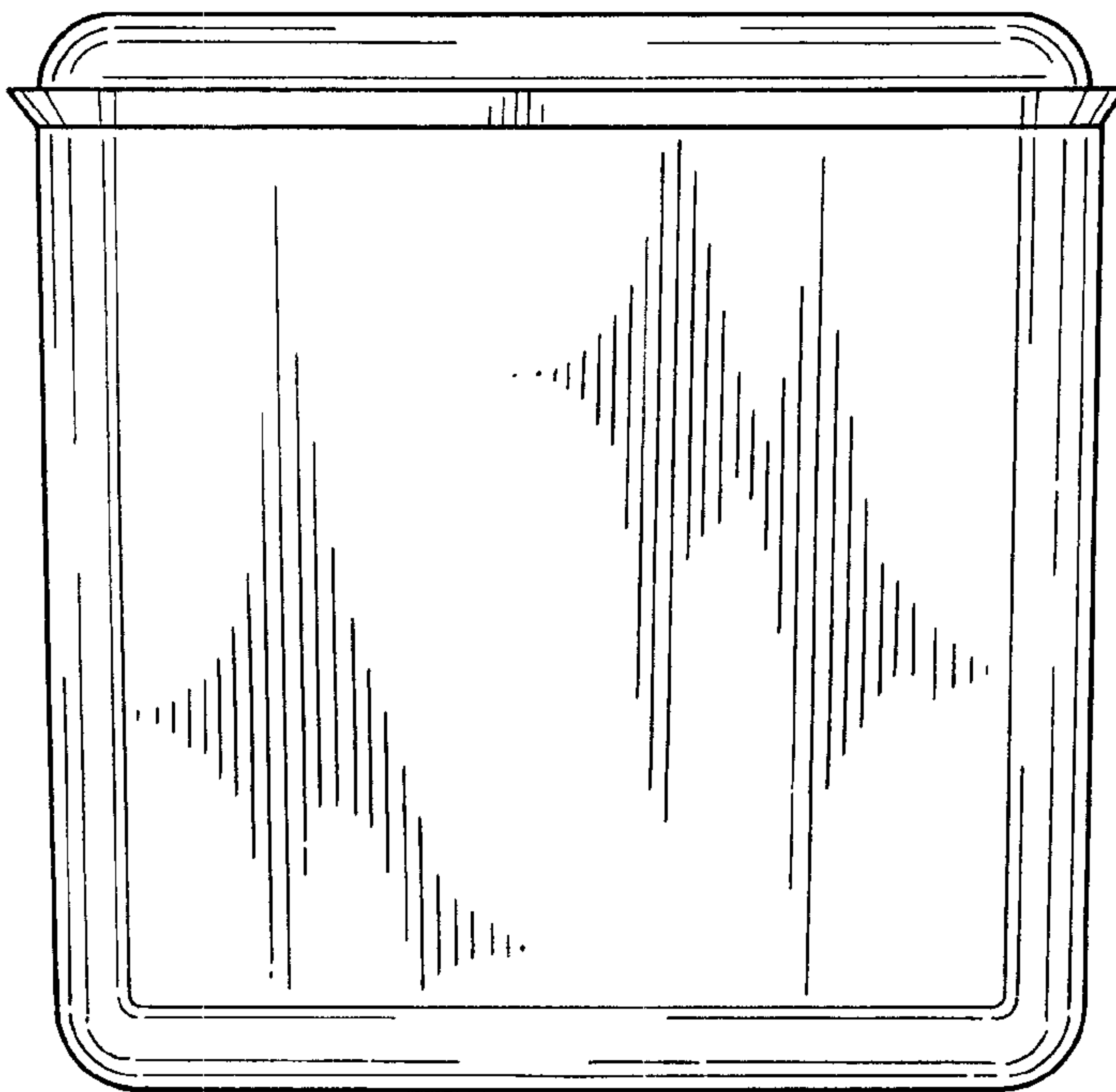

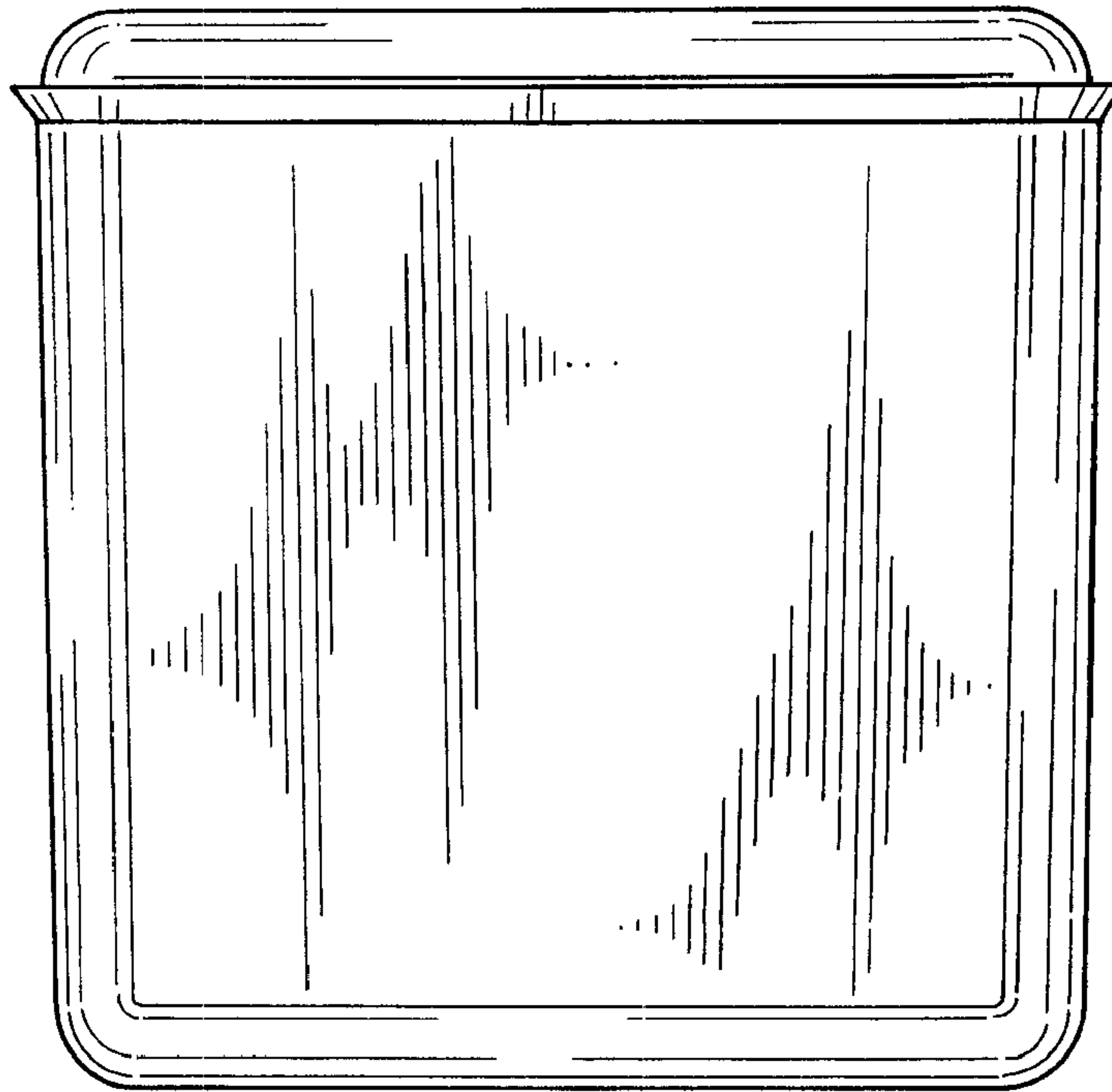

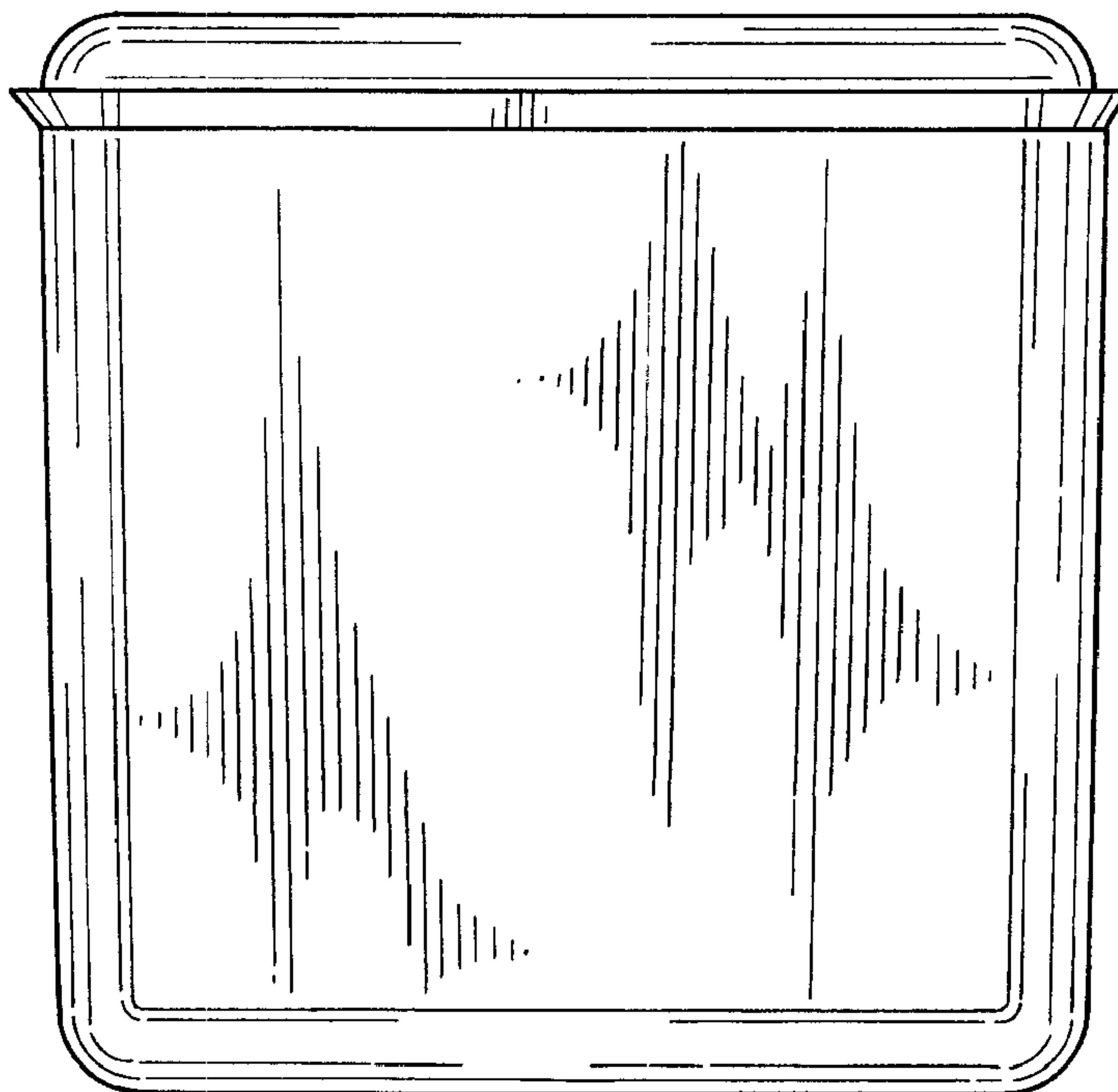

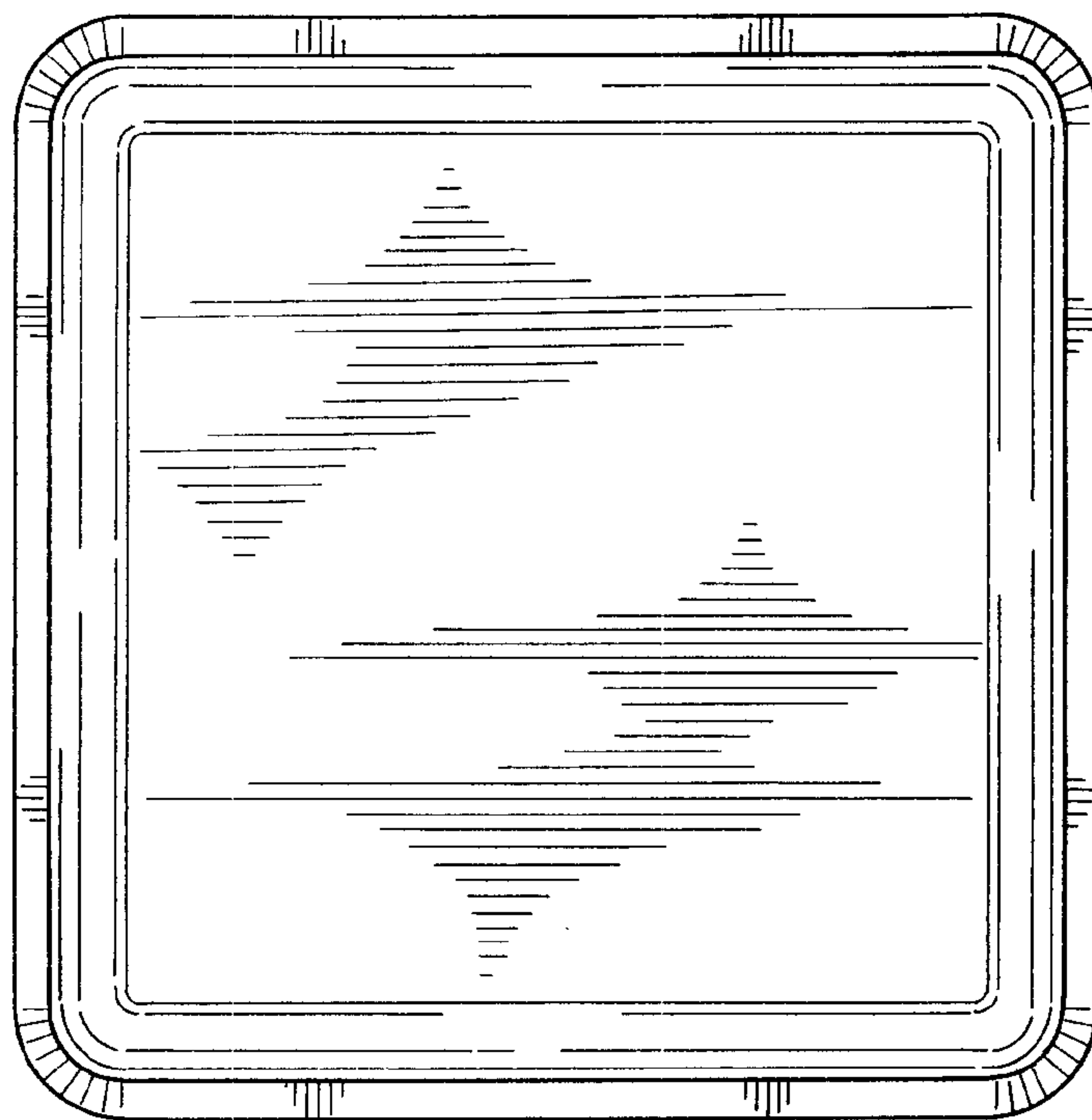
