(57) **CLAIM**

The ornamental design for a cup and saucer set, as shown and described herein.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a saucer.

FIG. 30 is a right side view of the cup shown in FIG. 27.

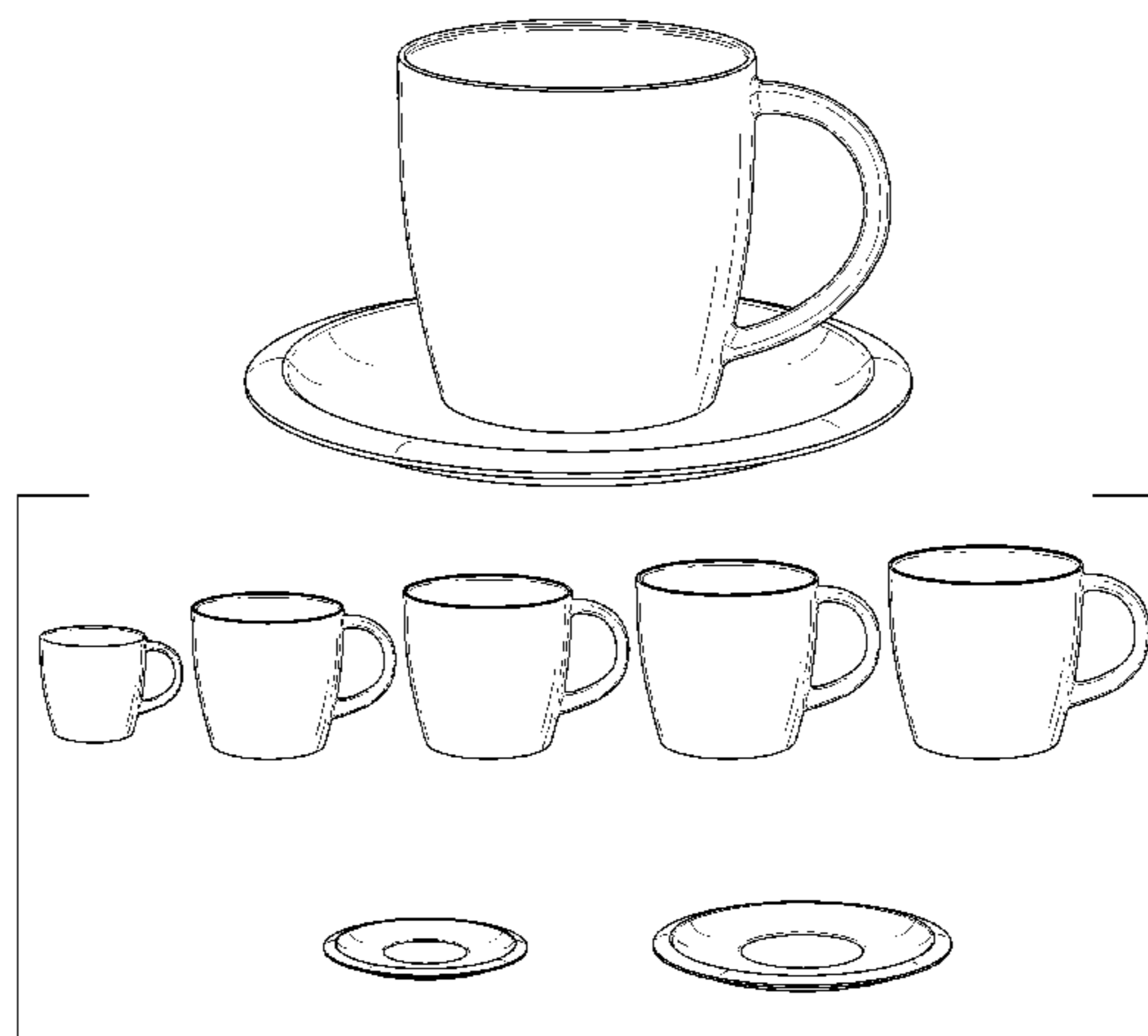


FIG. 31 is a bottom plan view of the cup shown in FIG. 27.

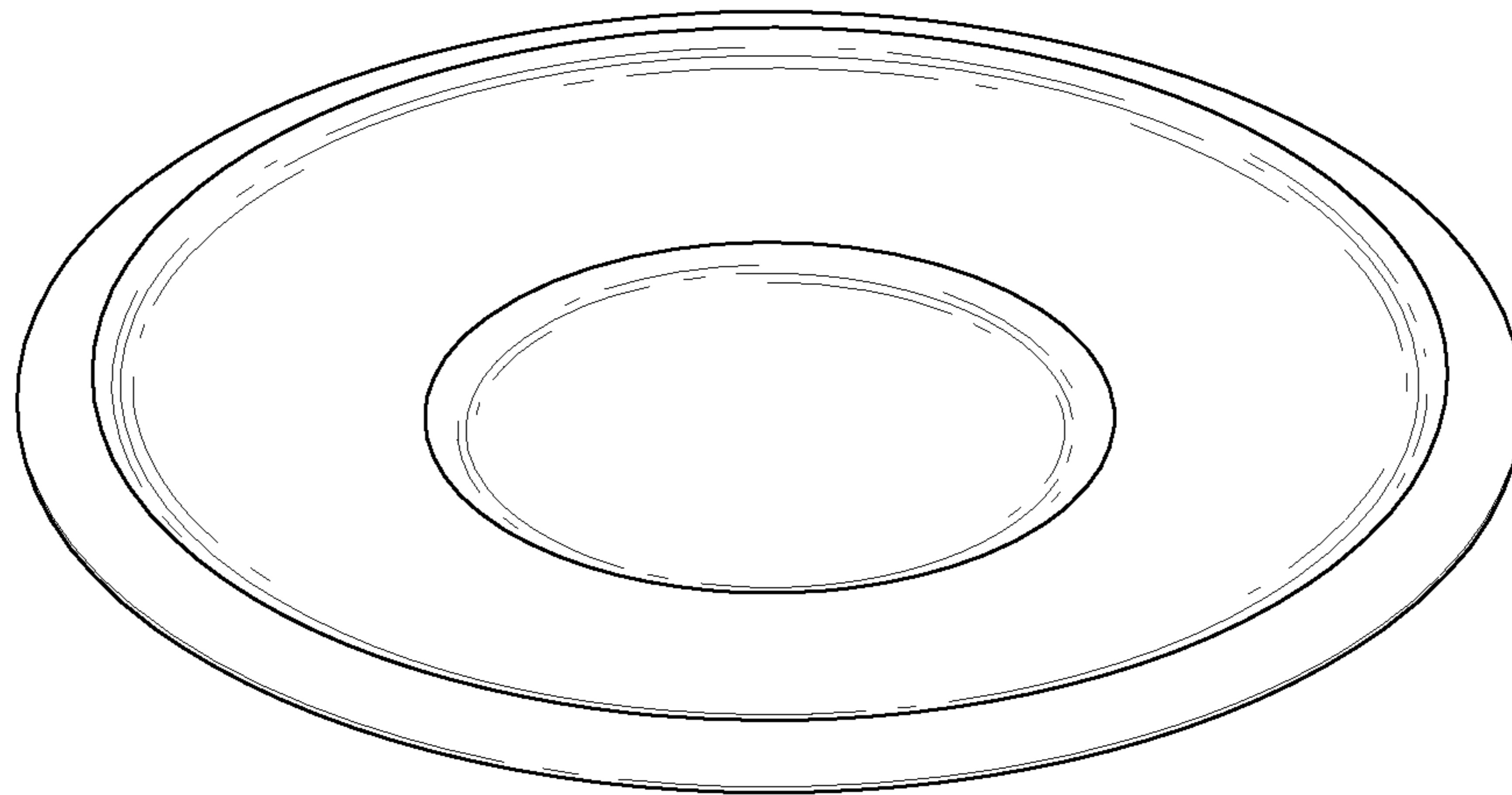

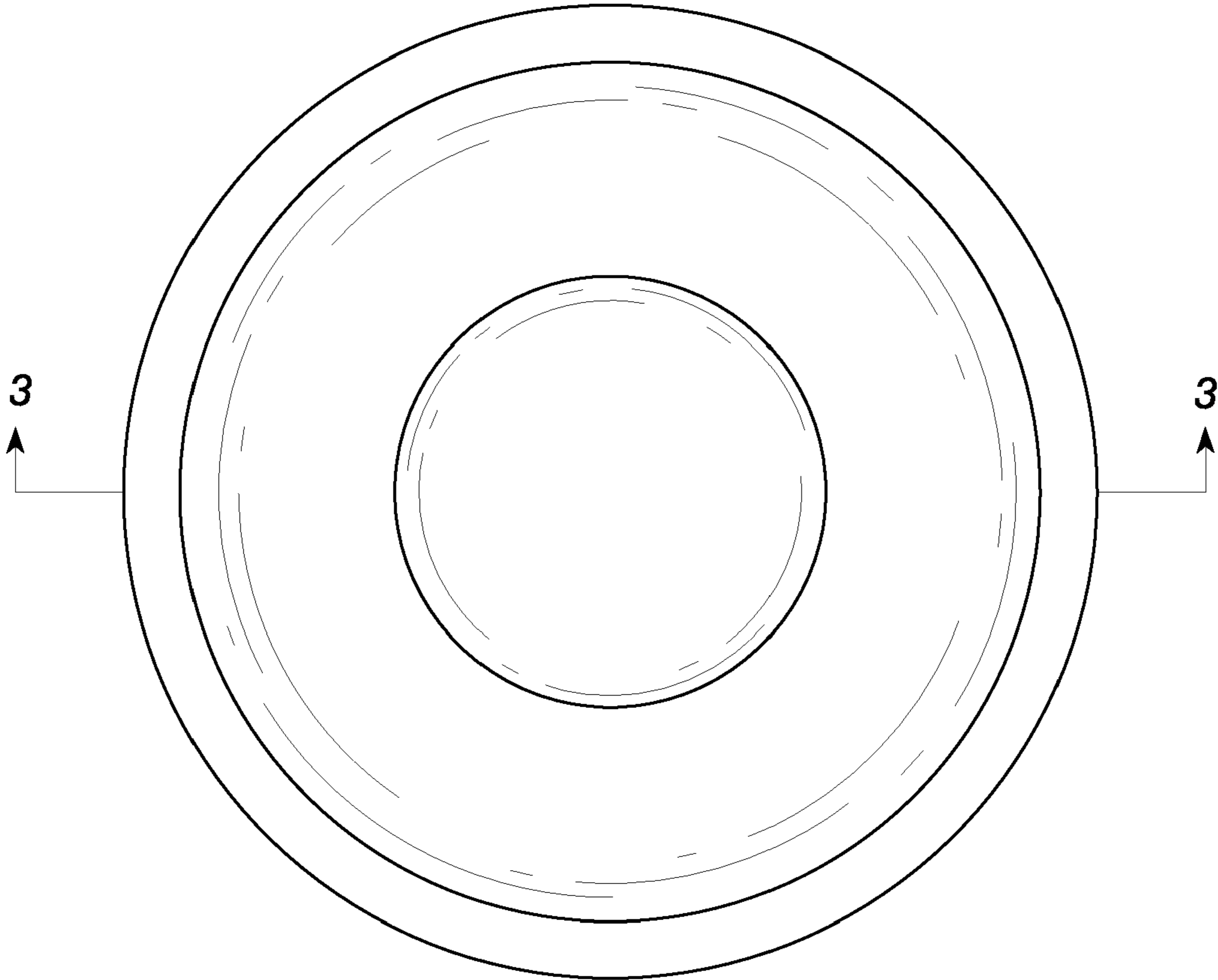

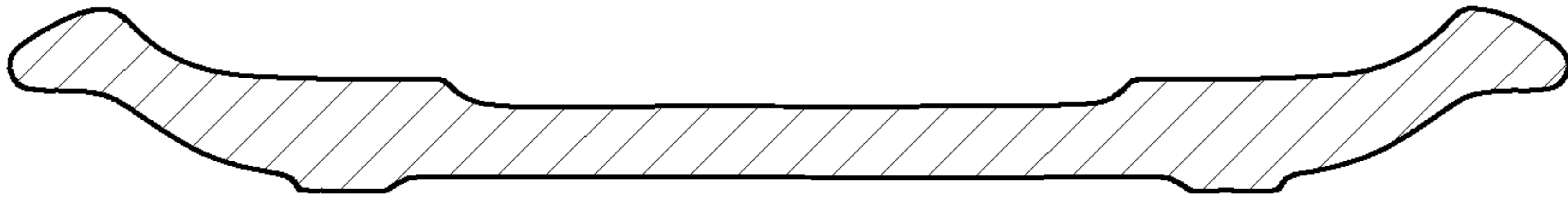

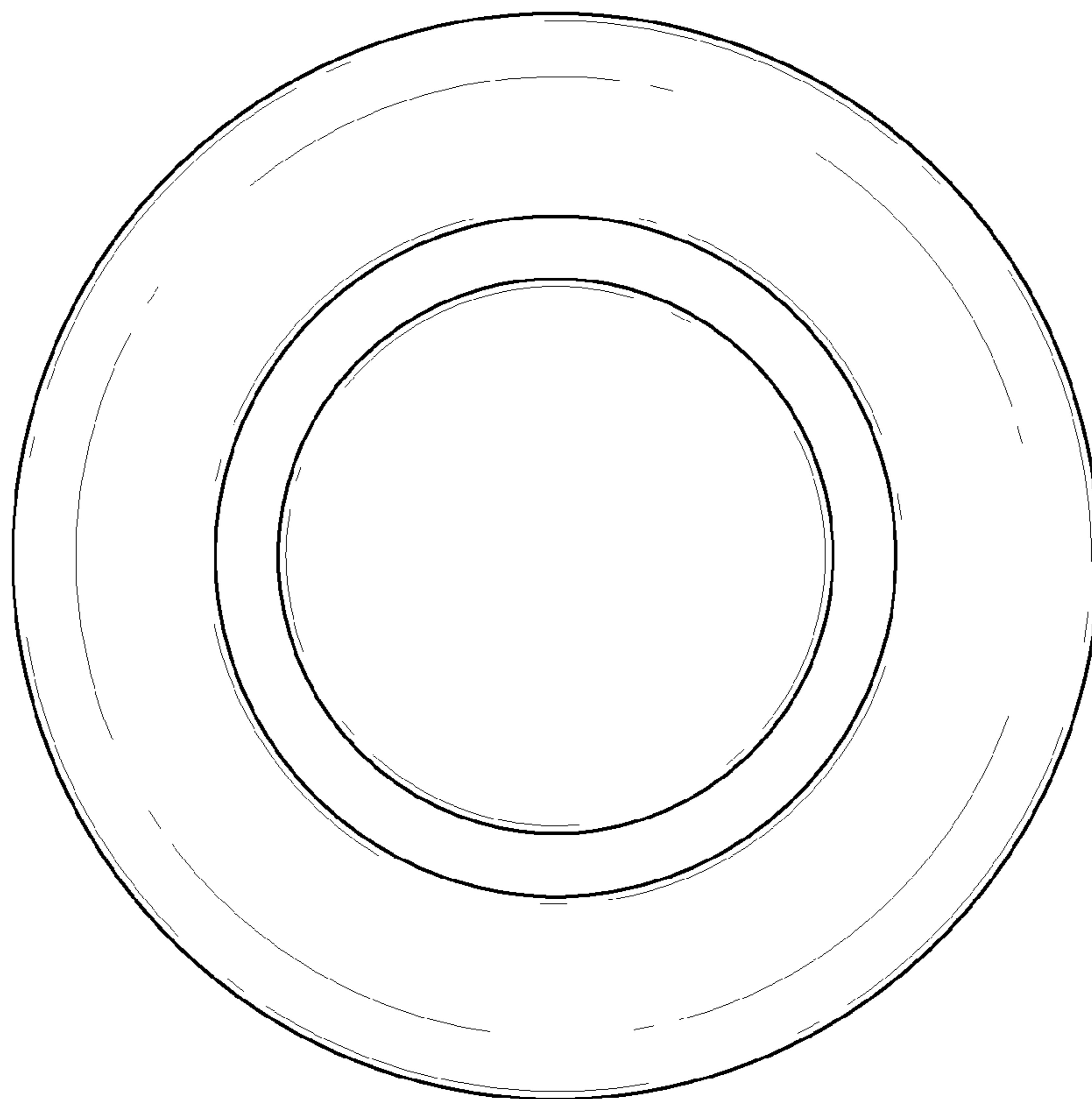

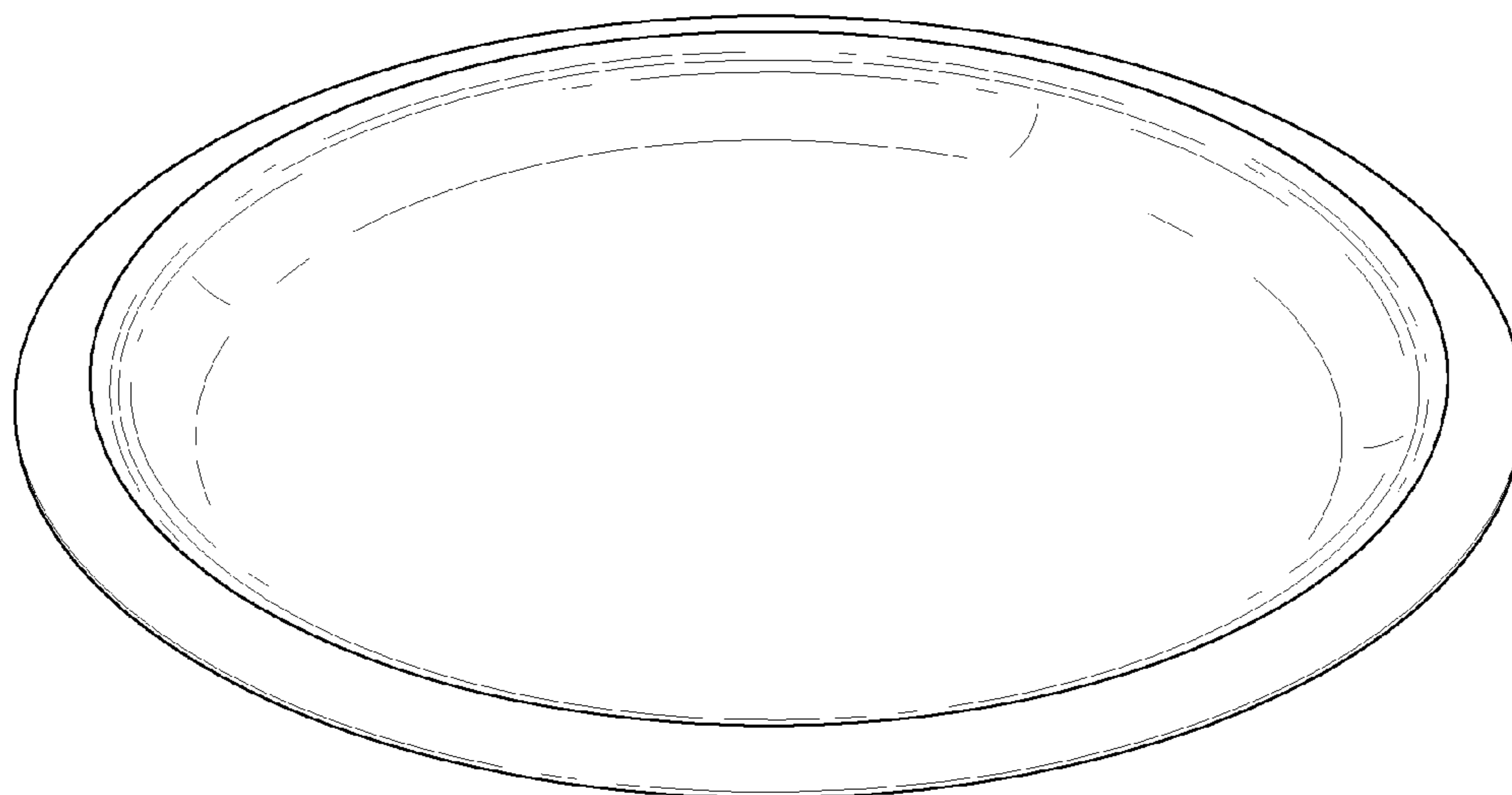

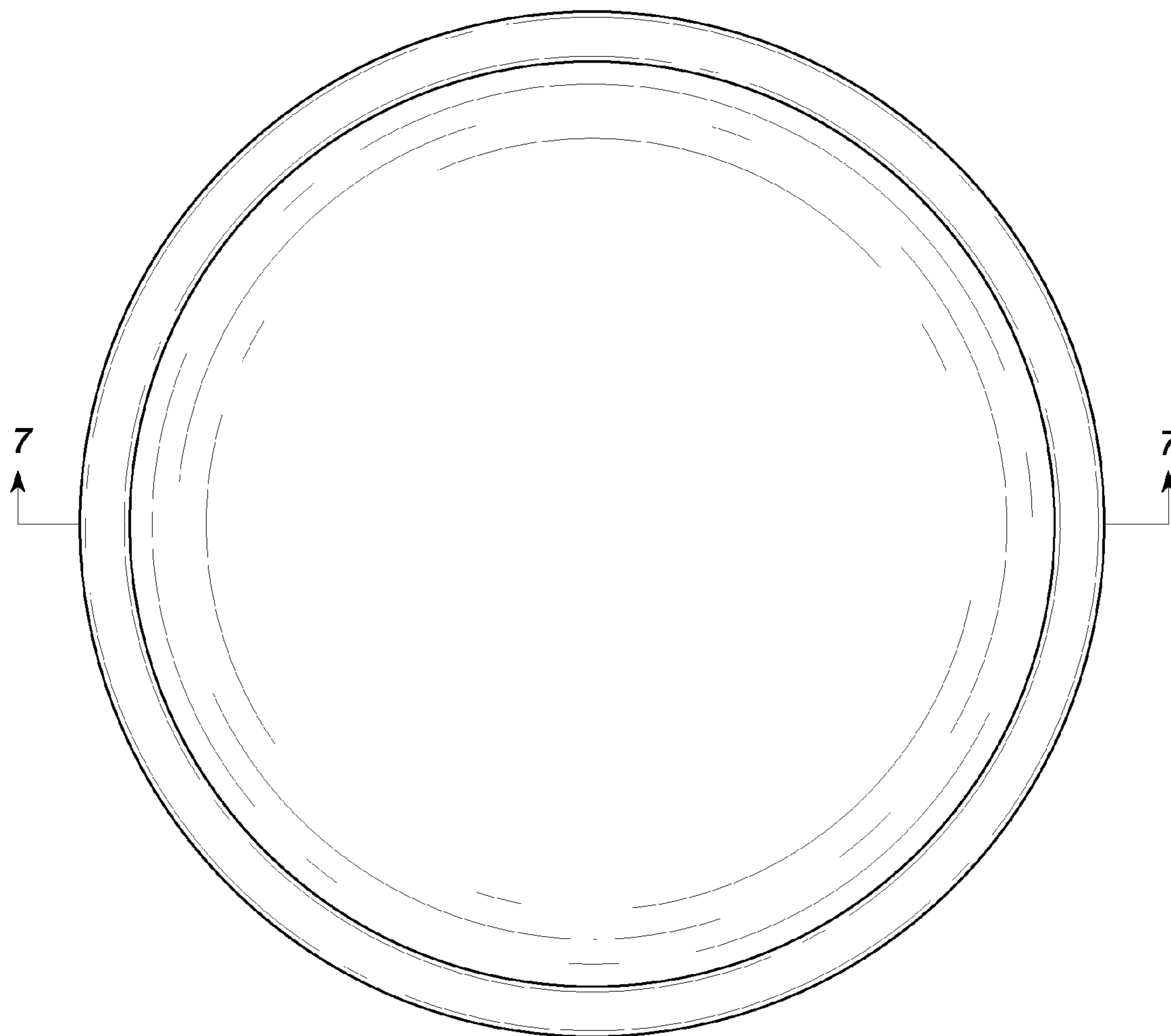

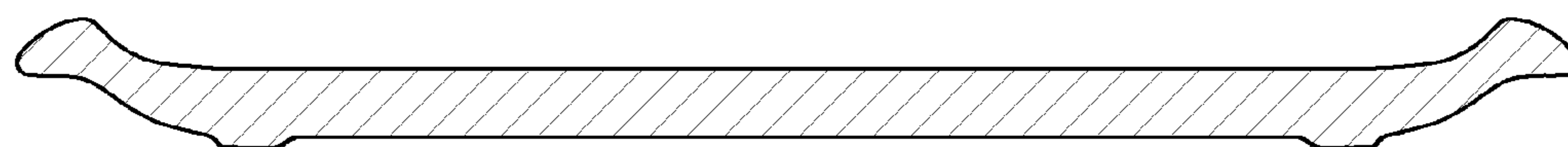

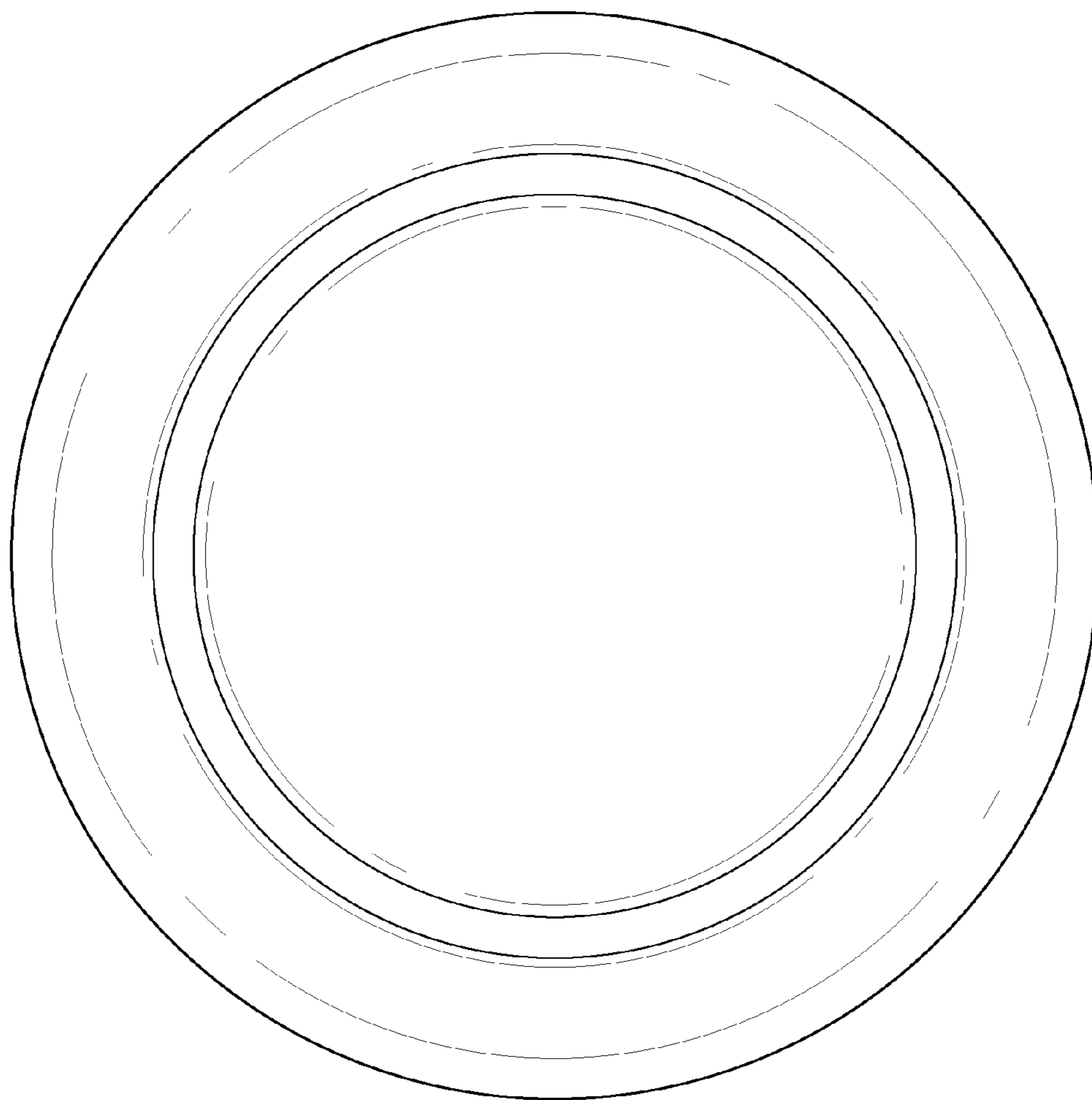

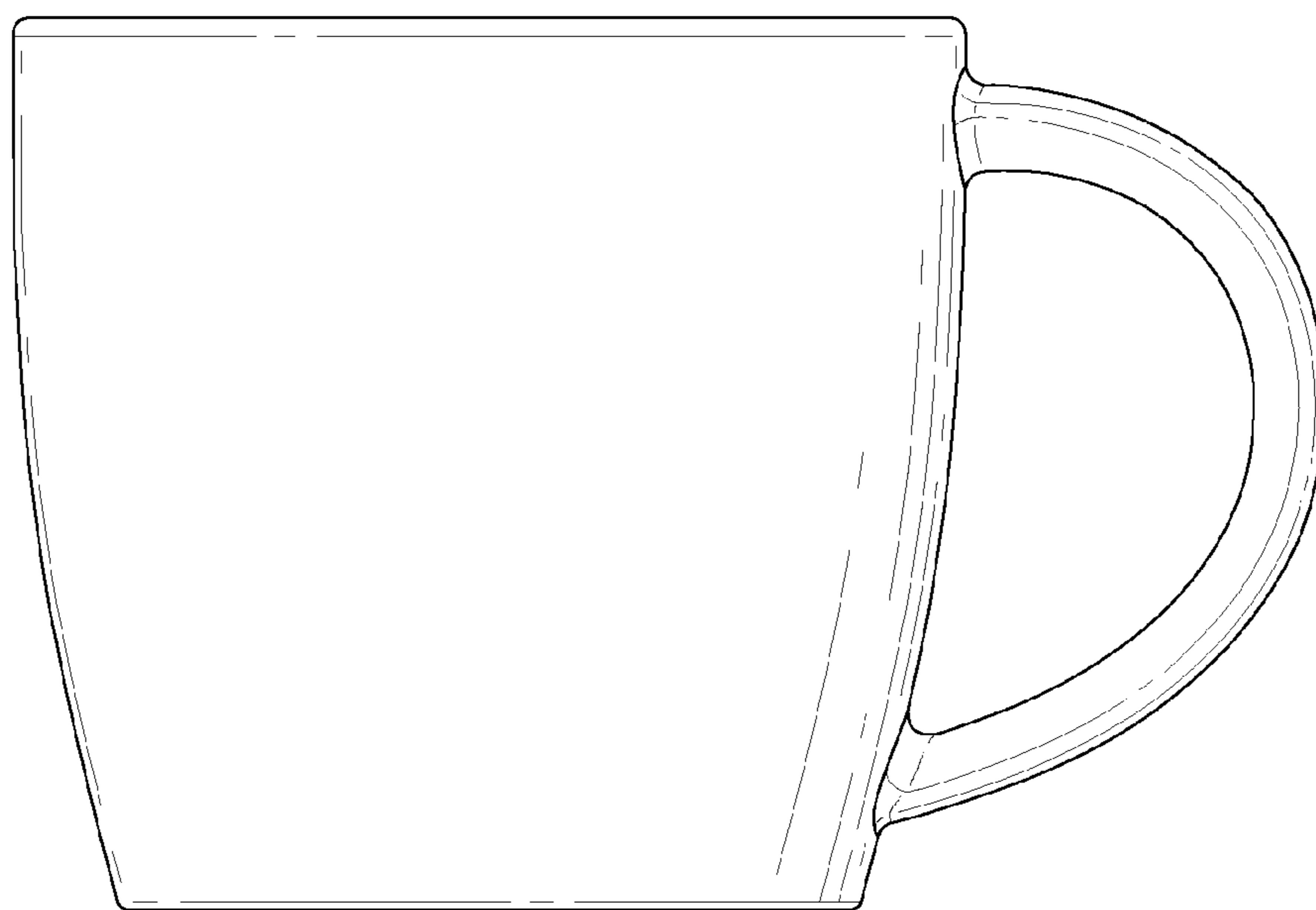

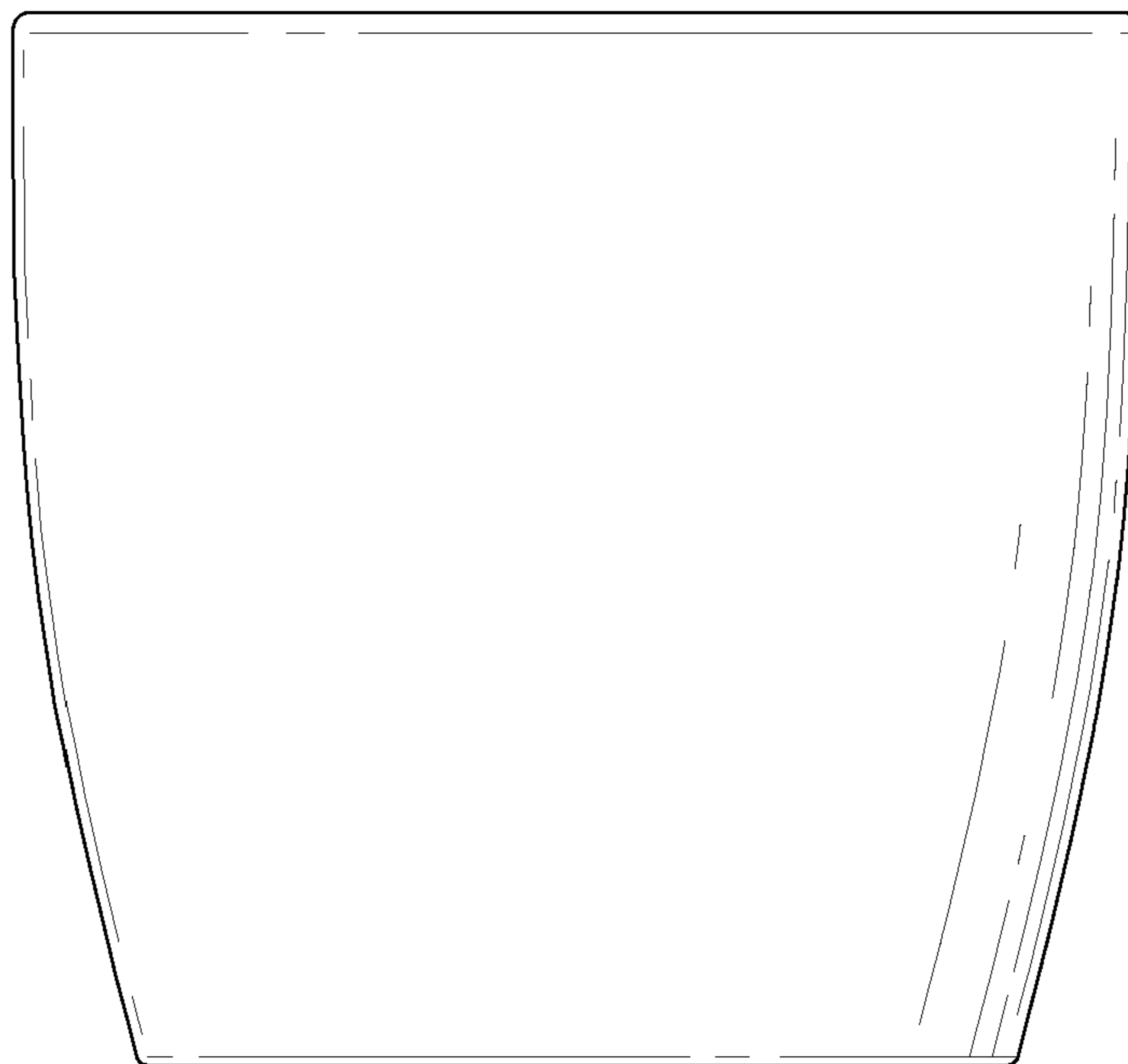

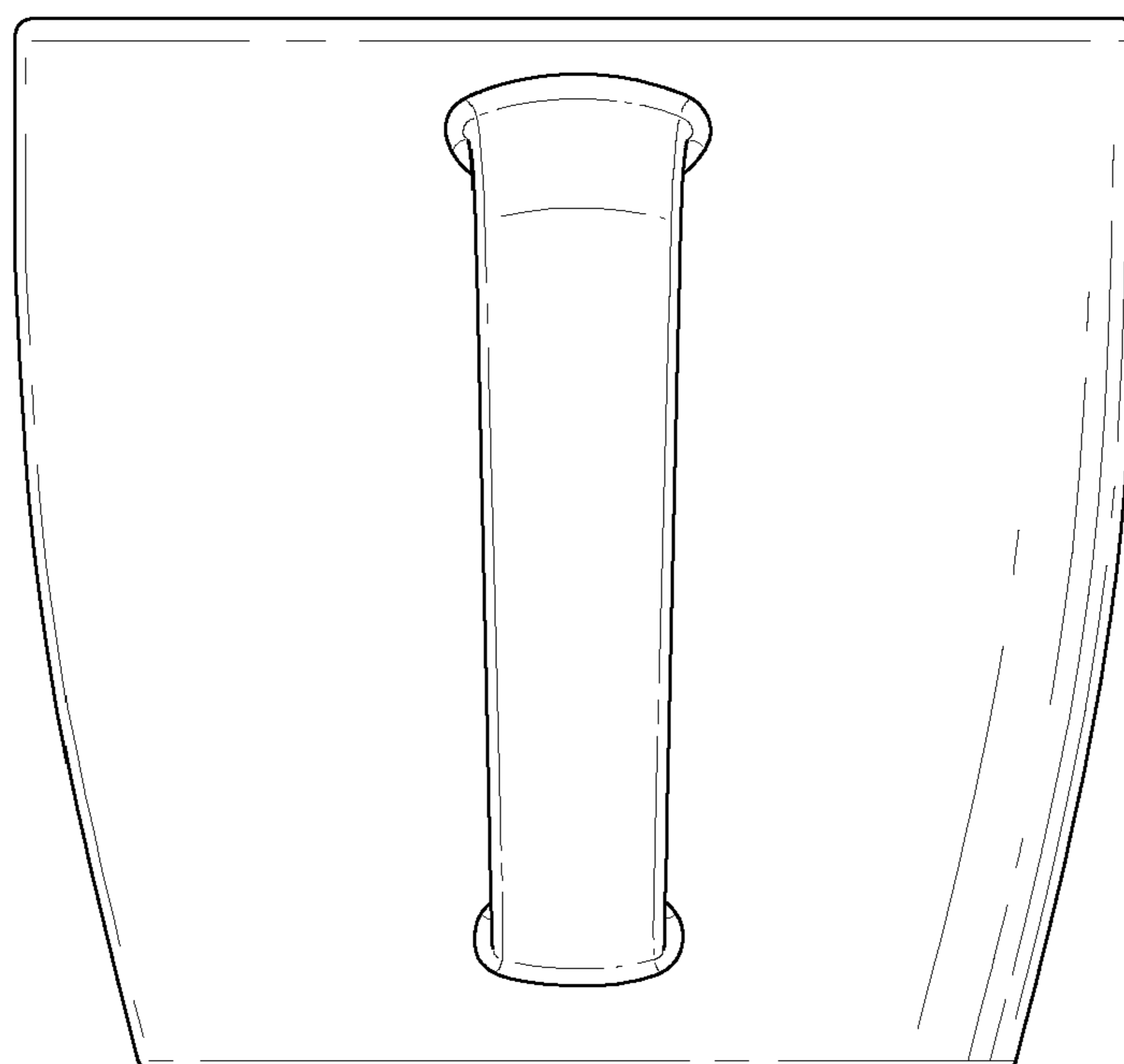

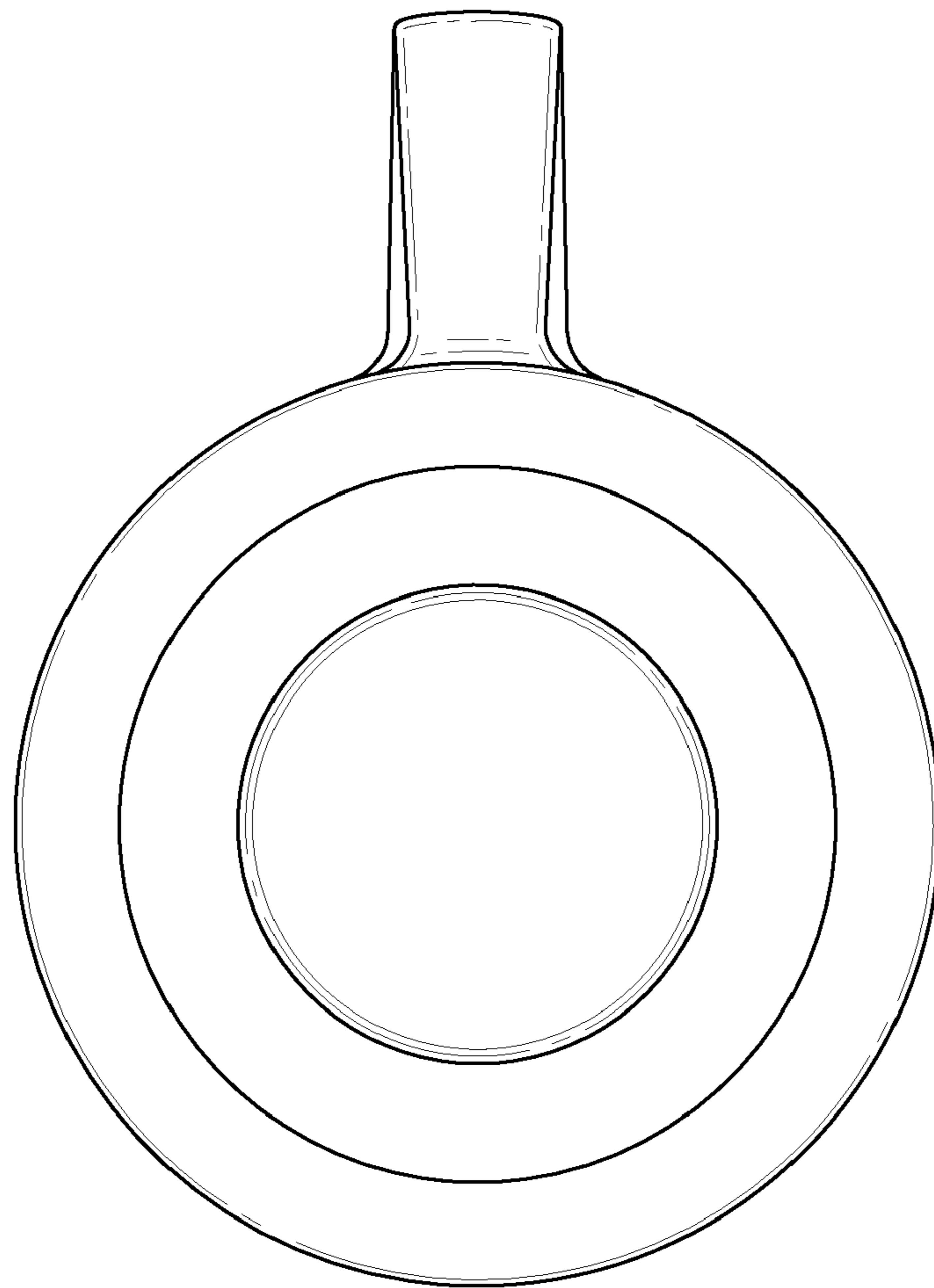

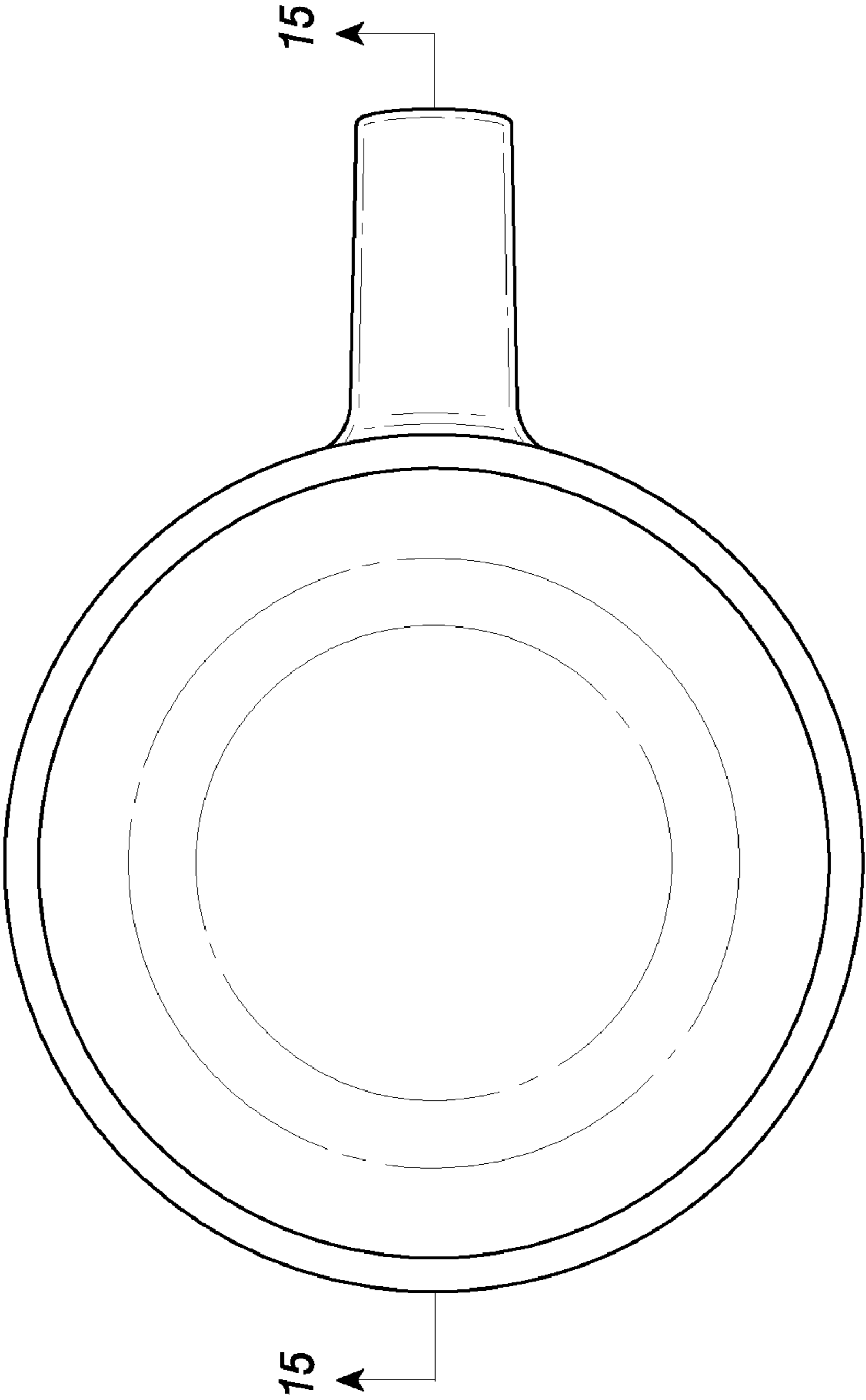

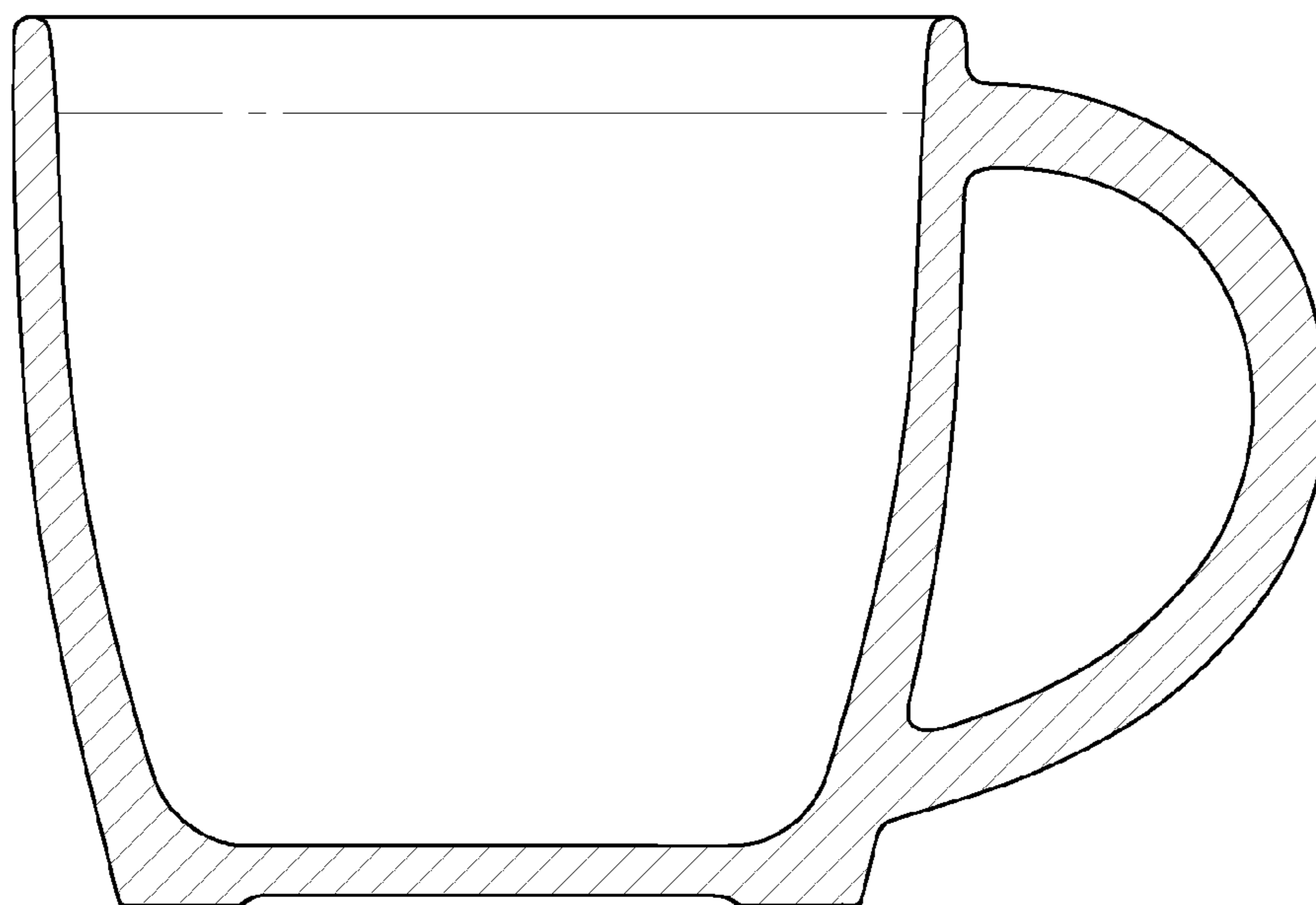

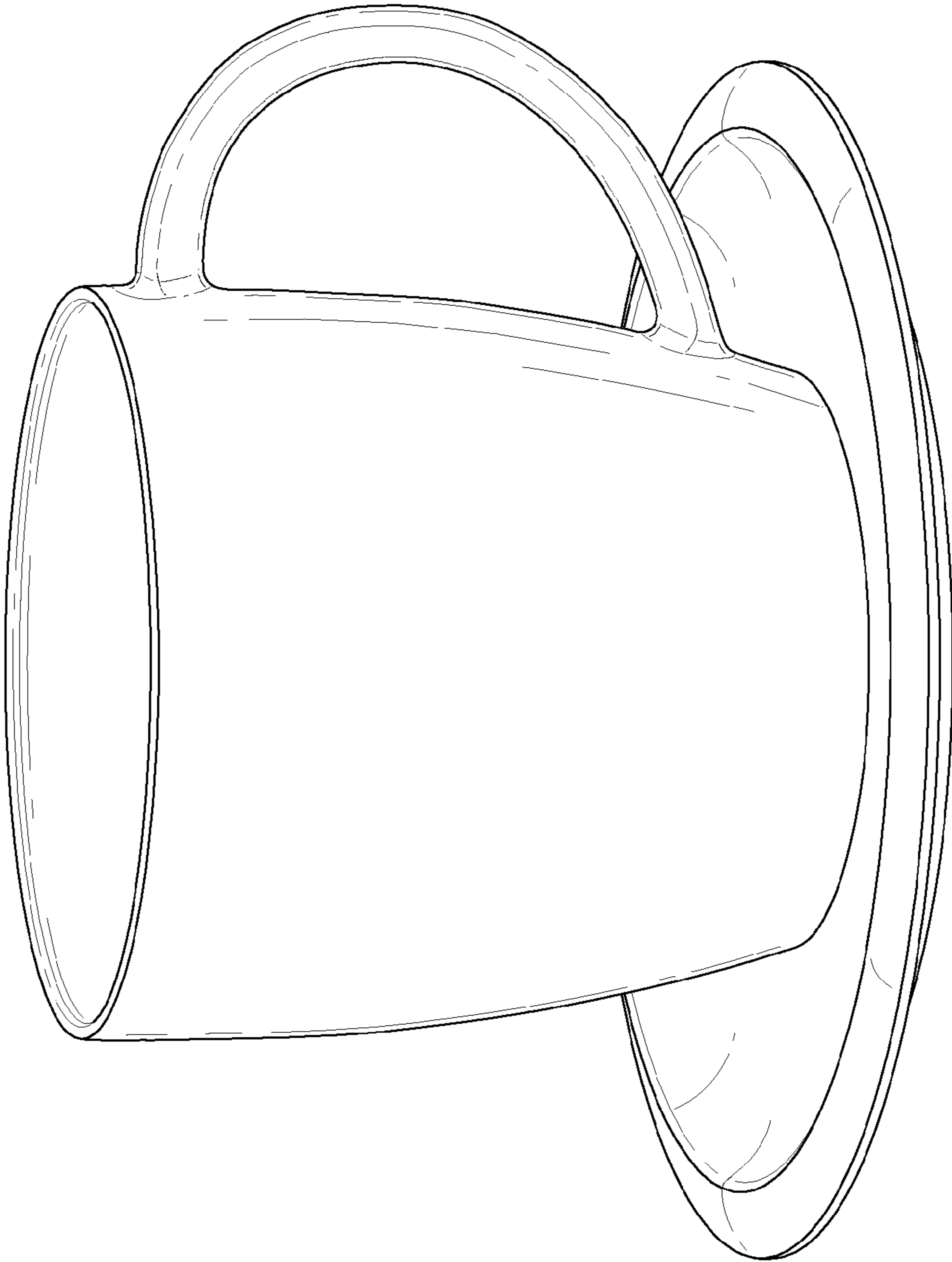

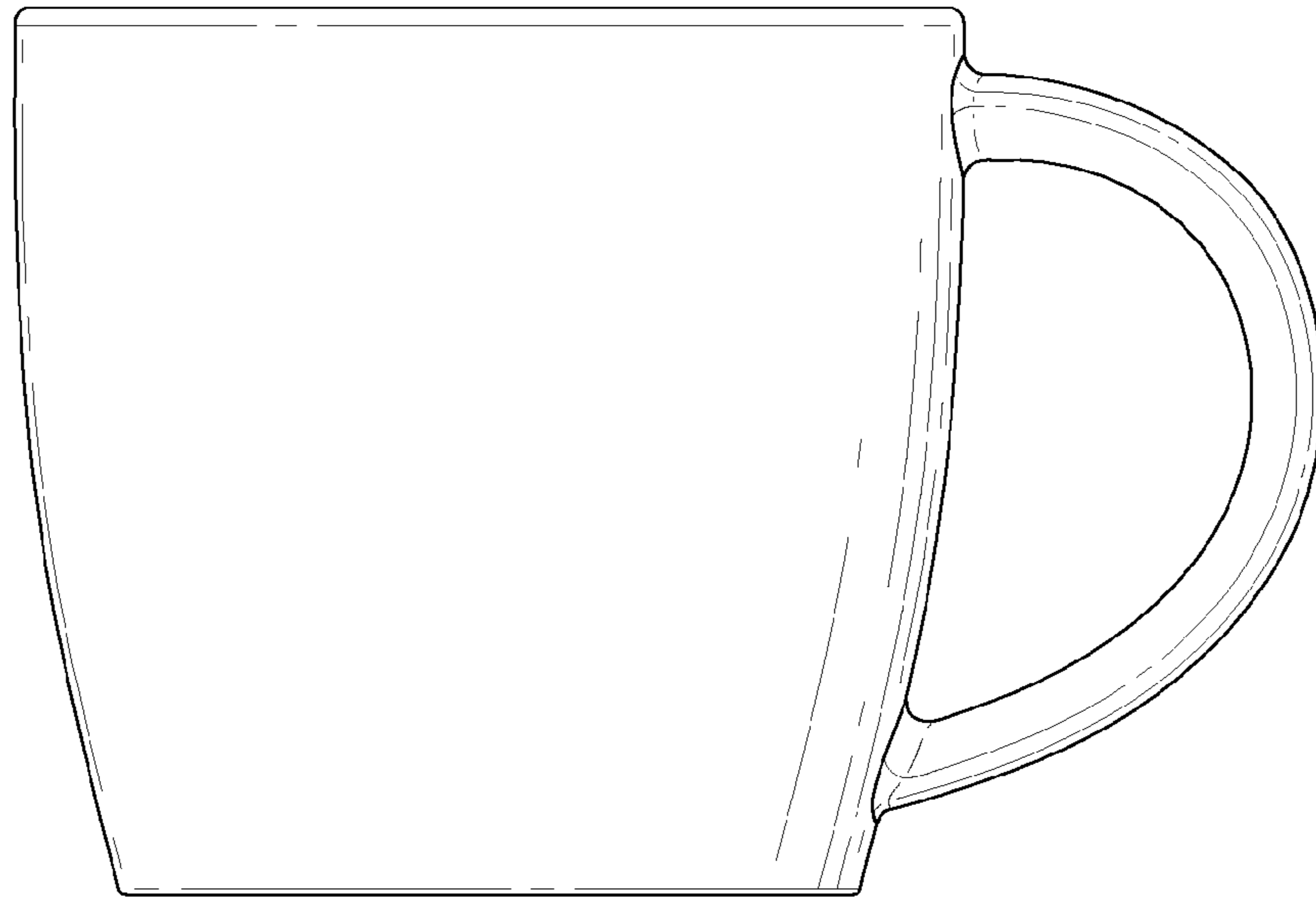

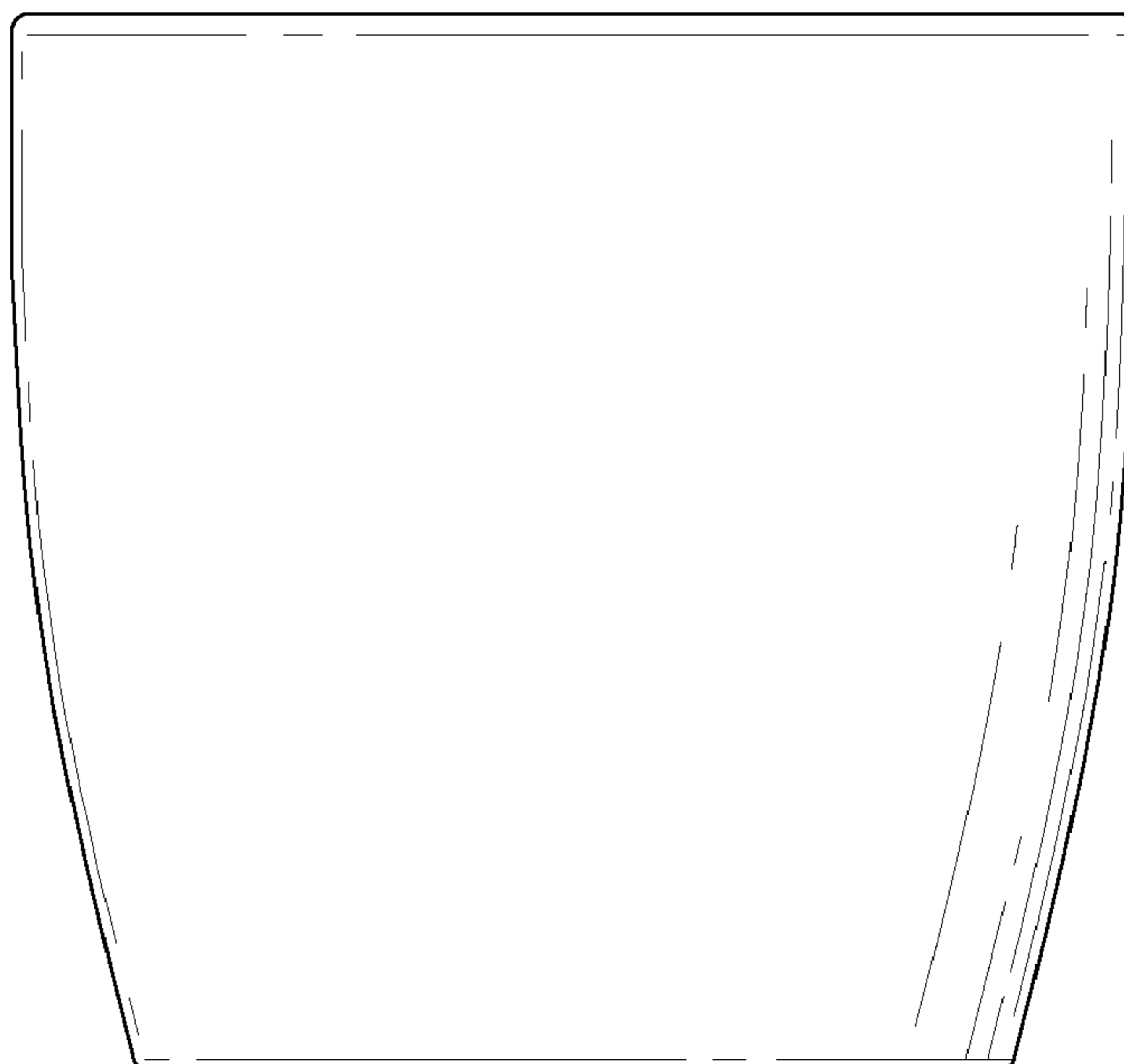

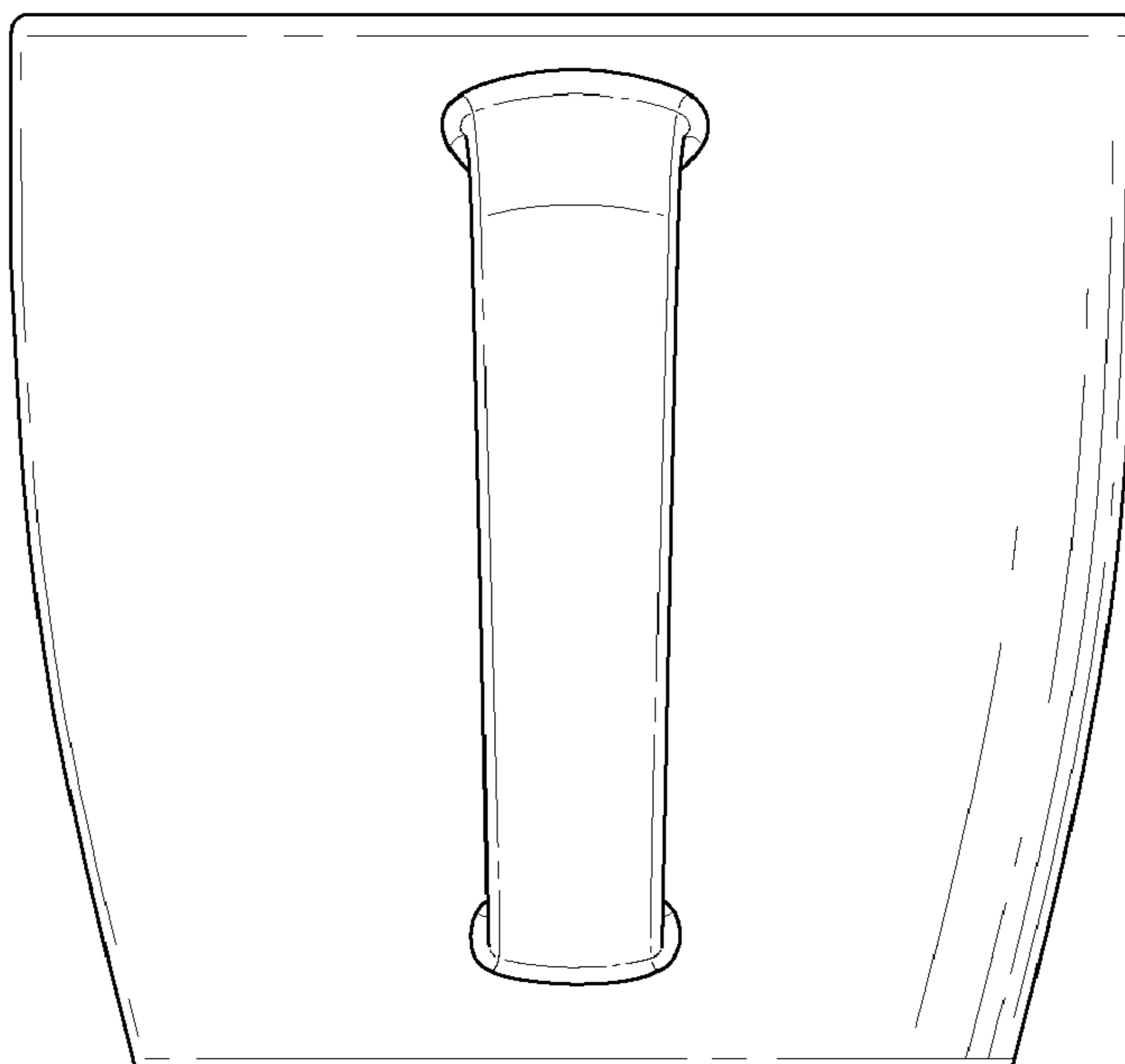

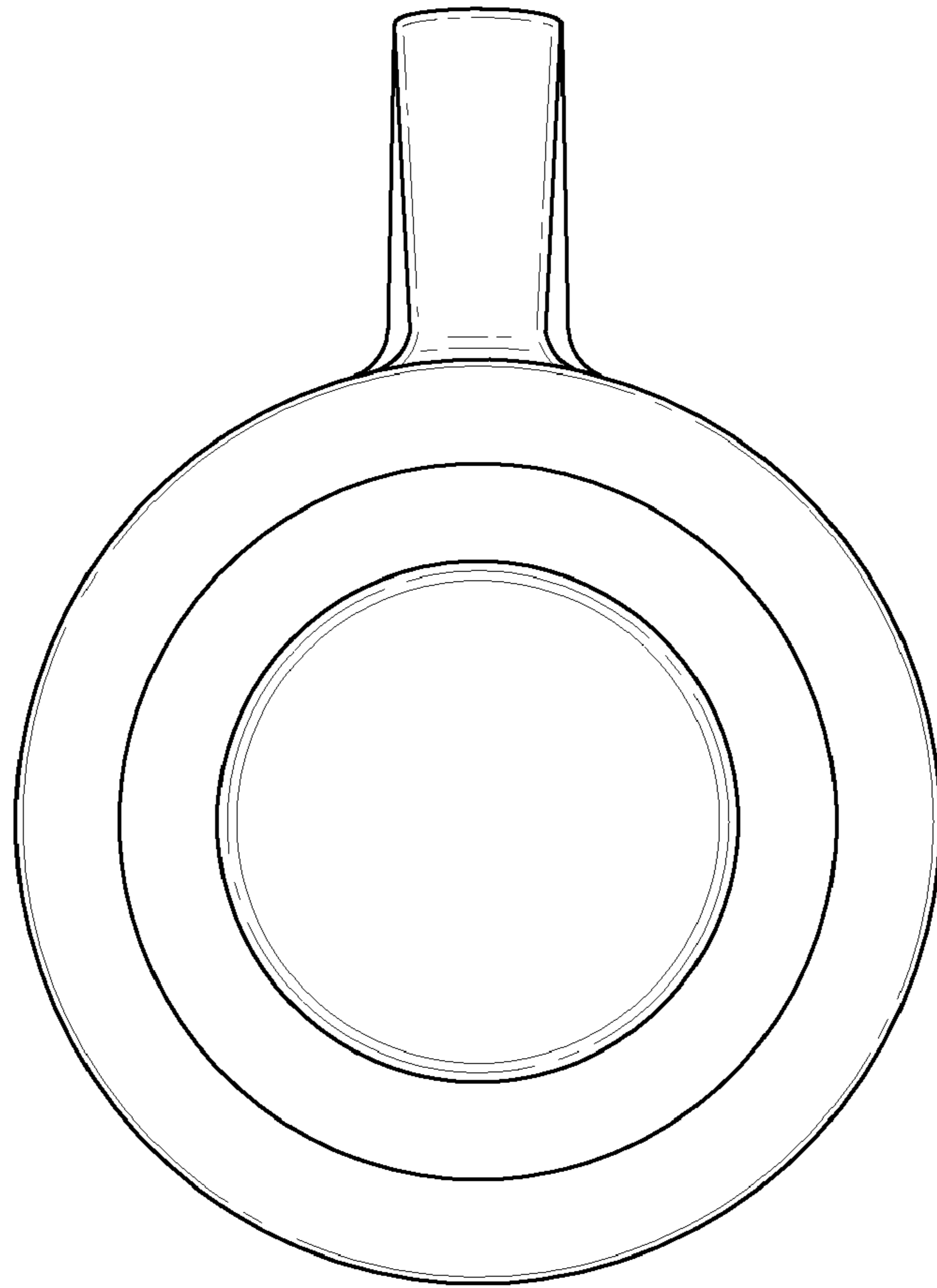

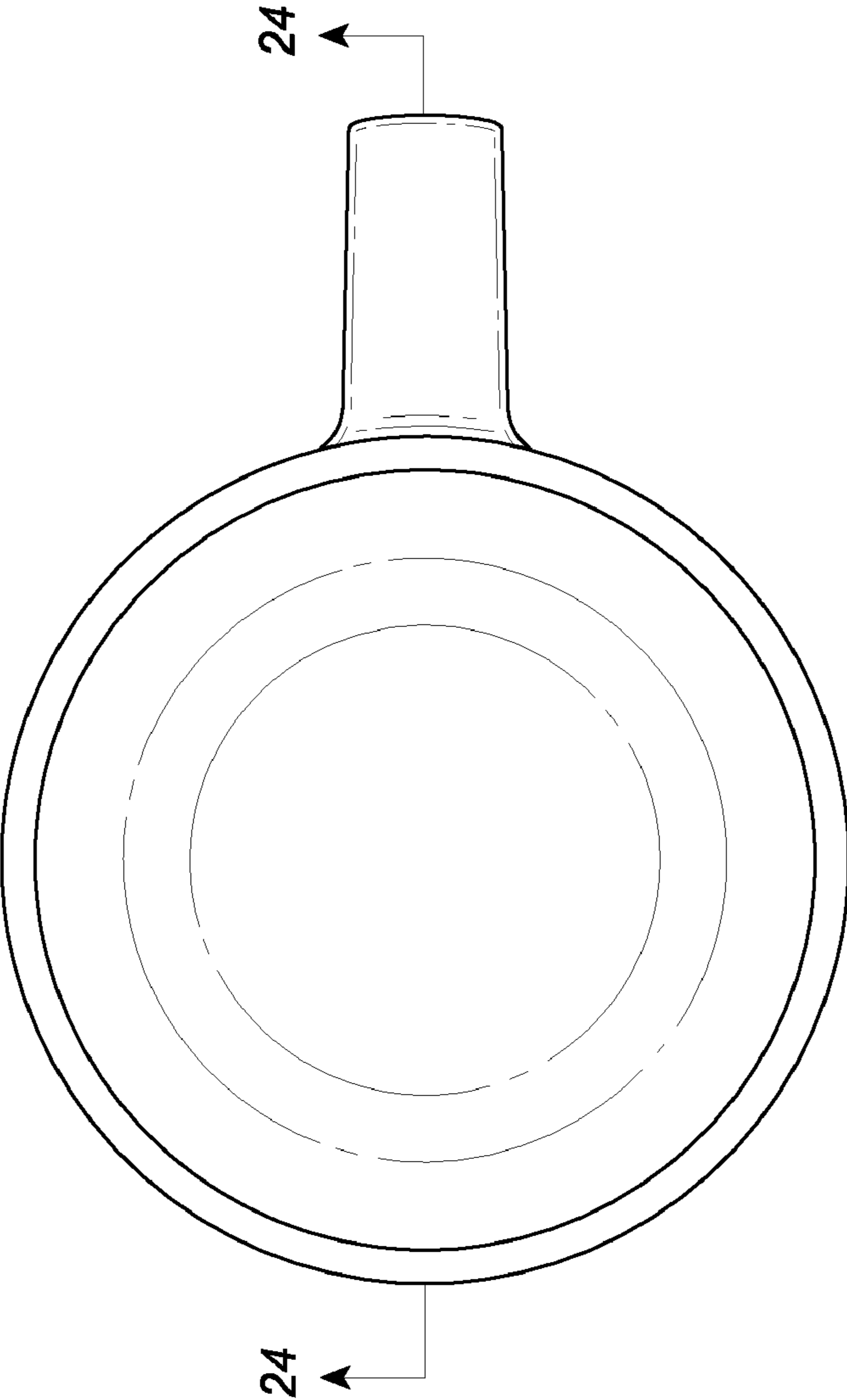

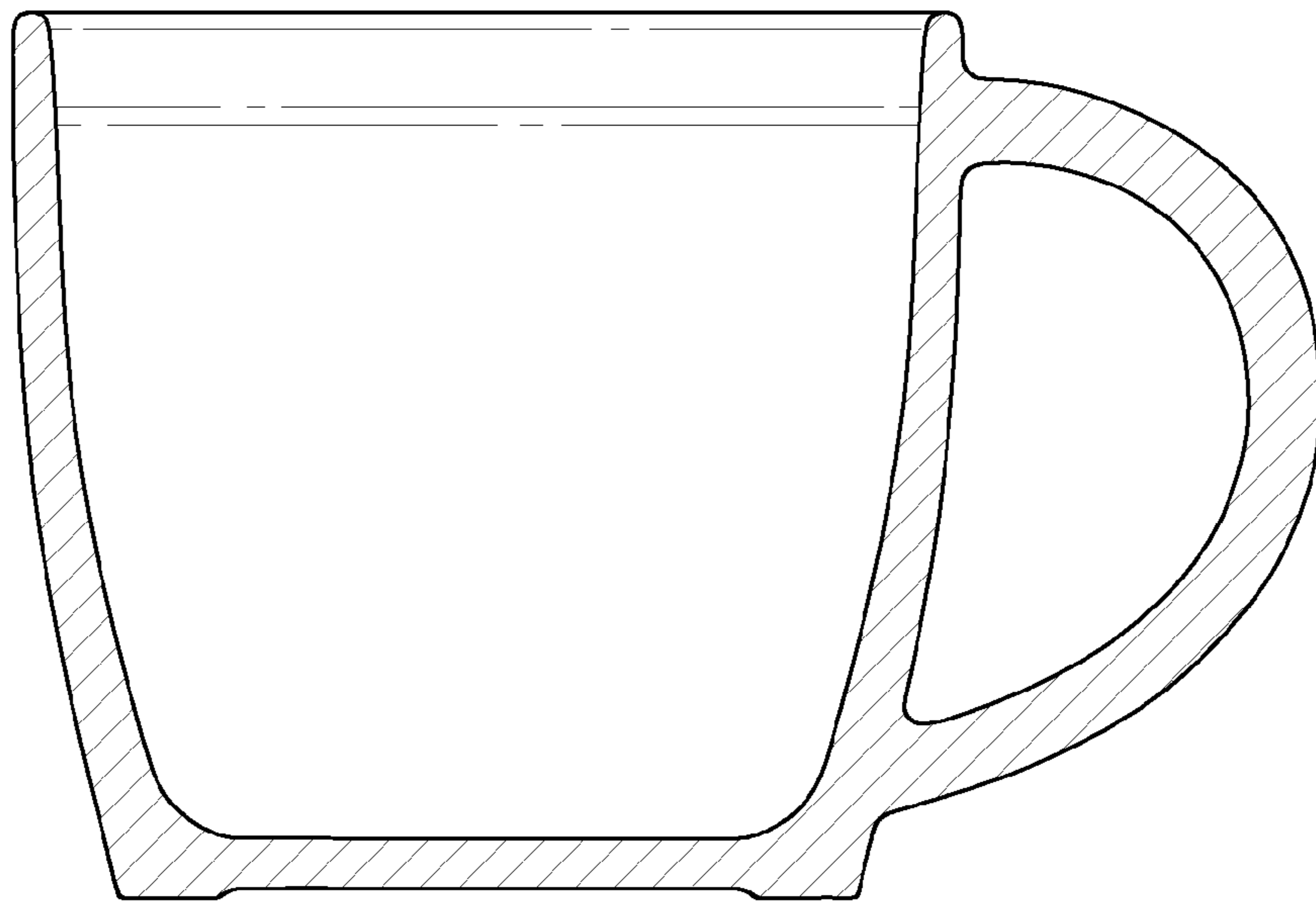

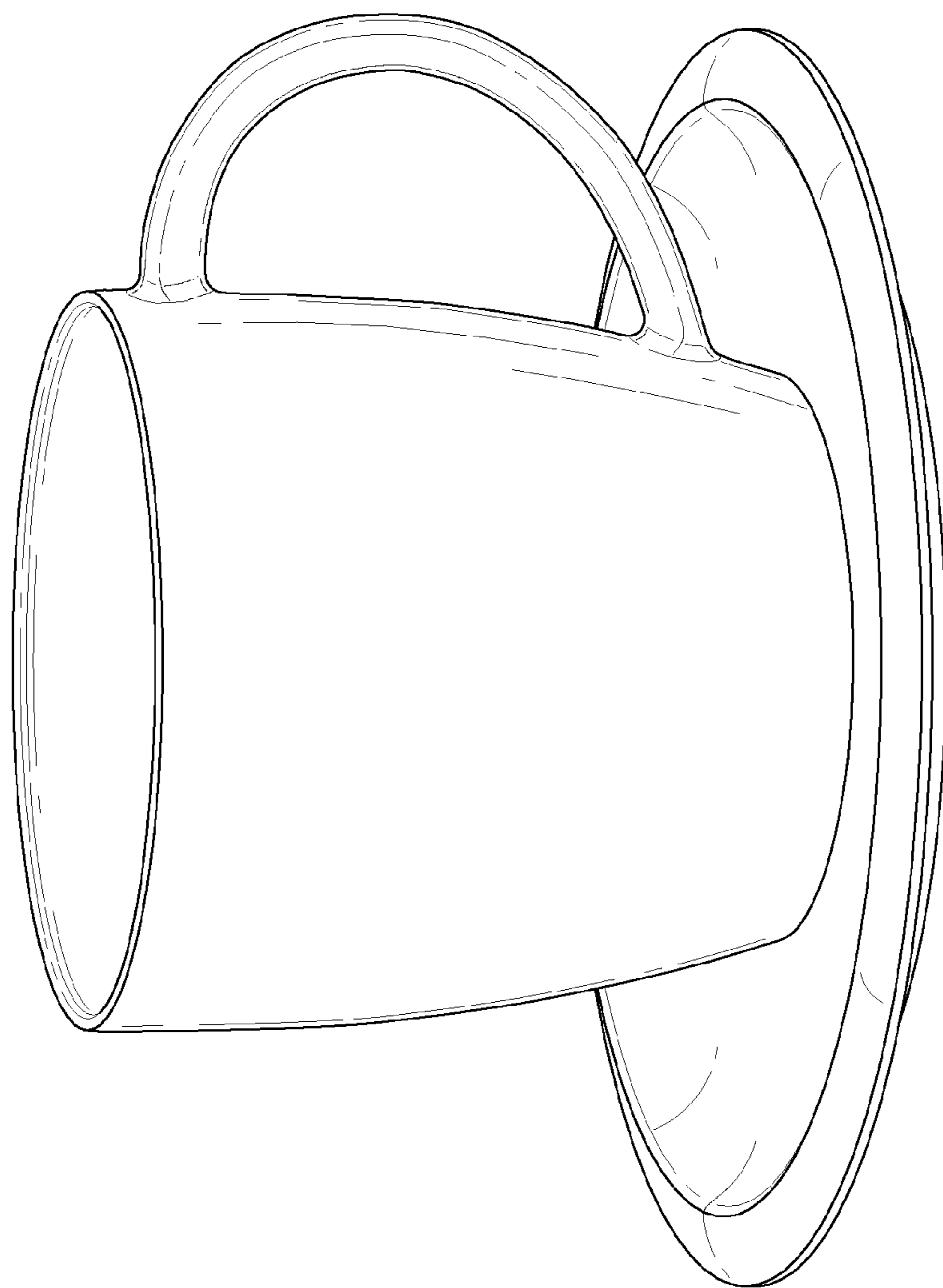

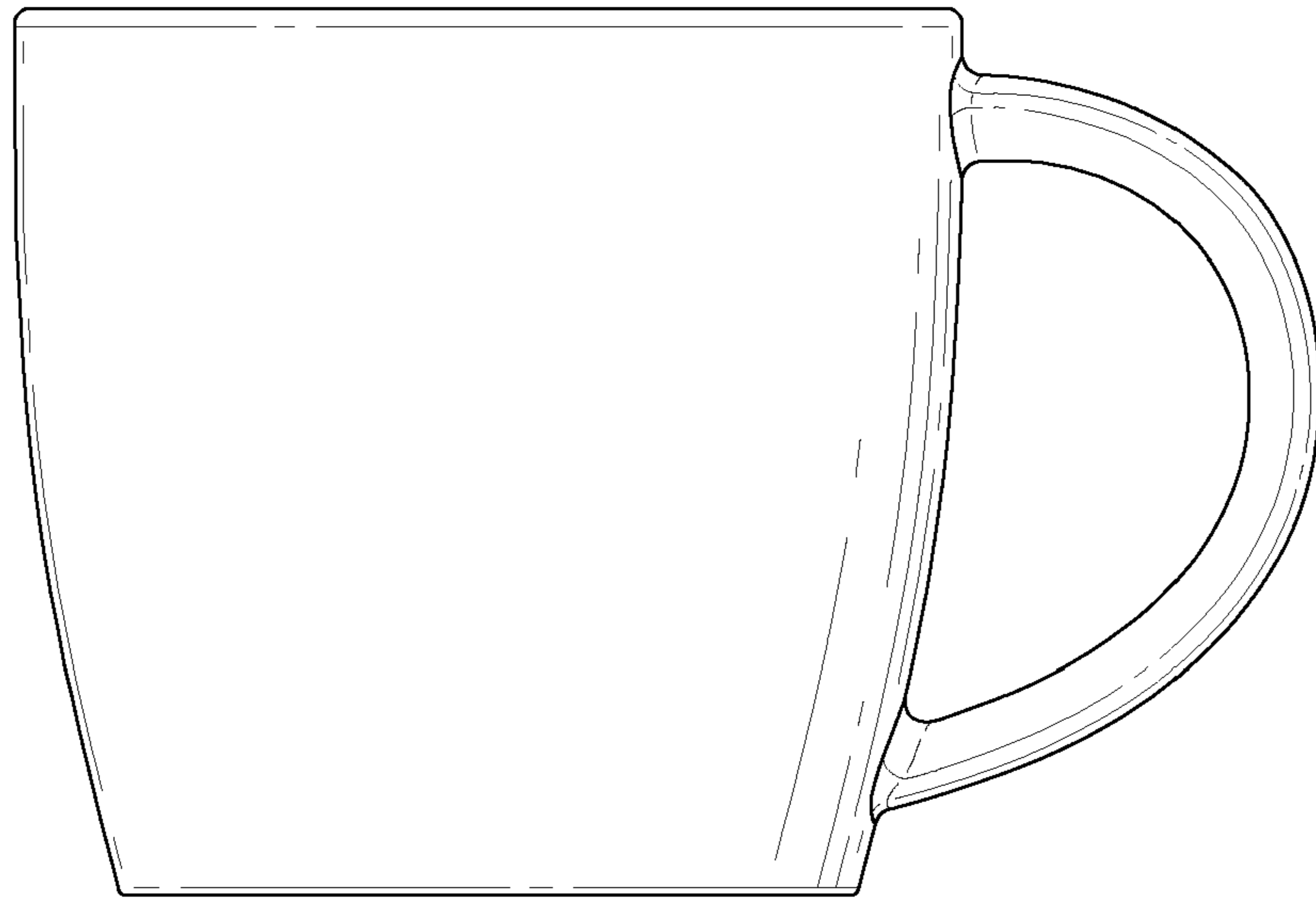

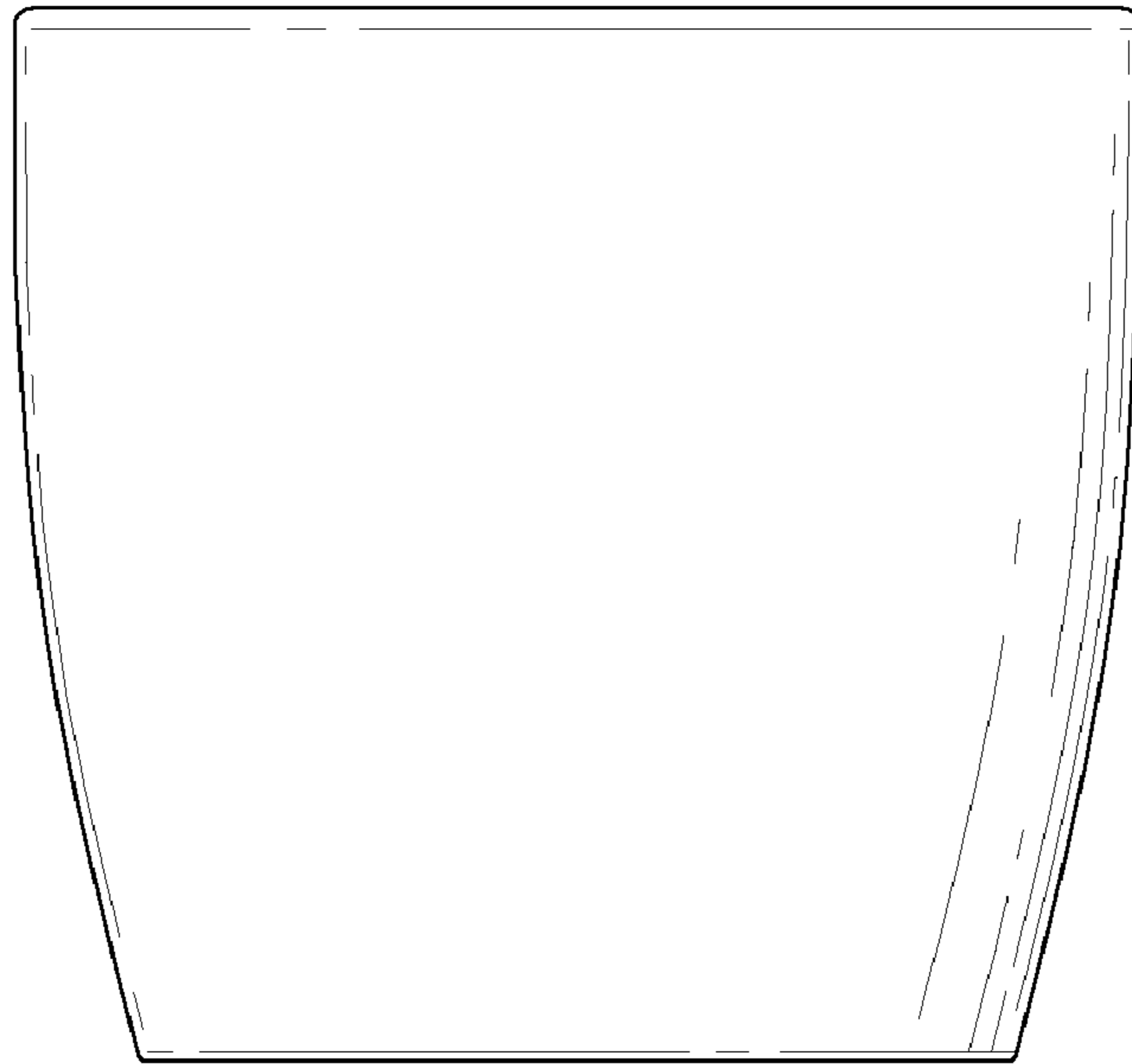

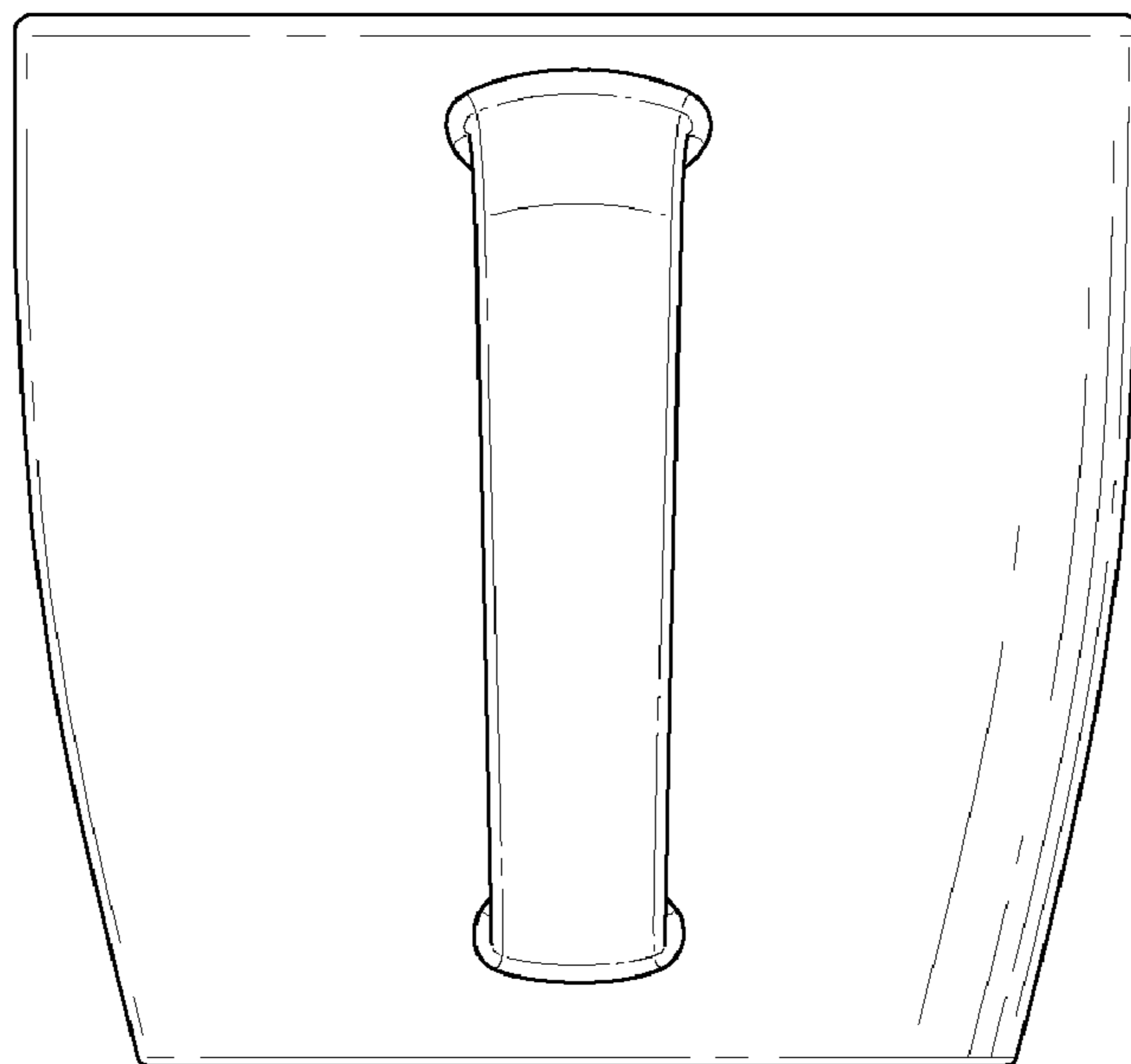

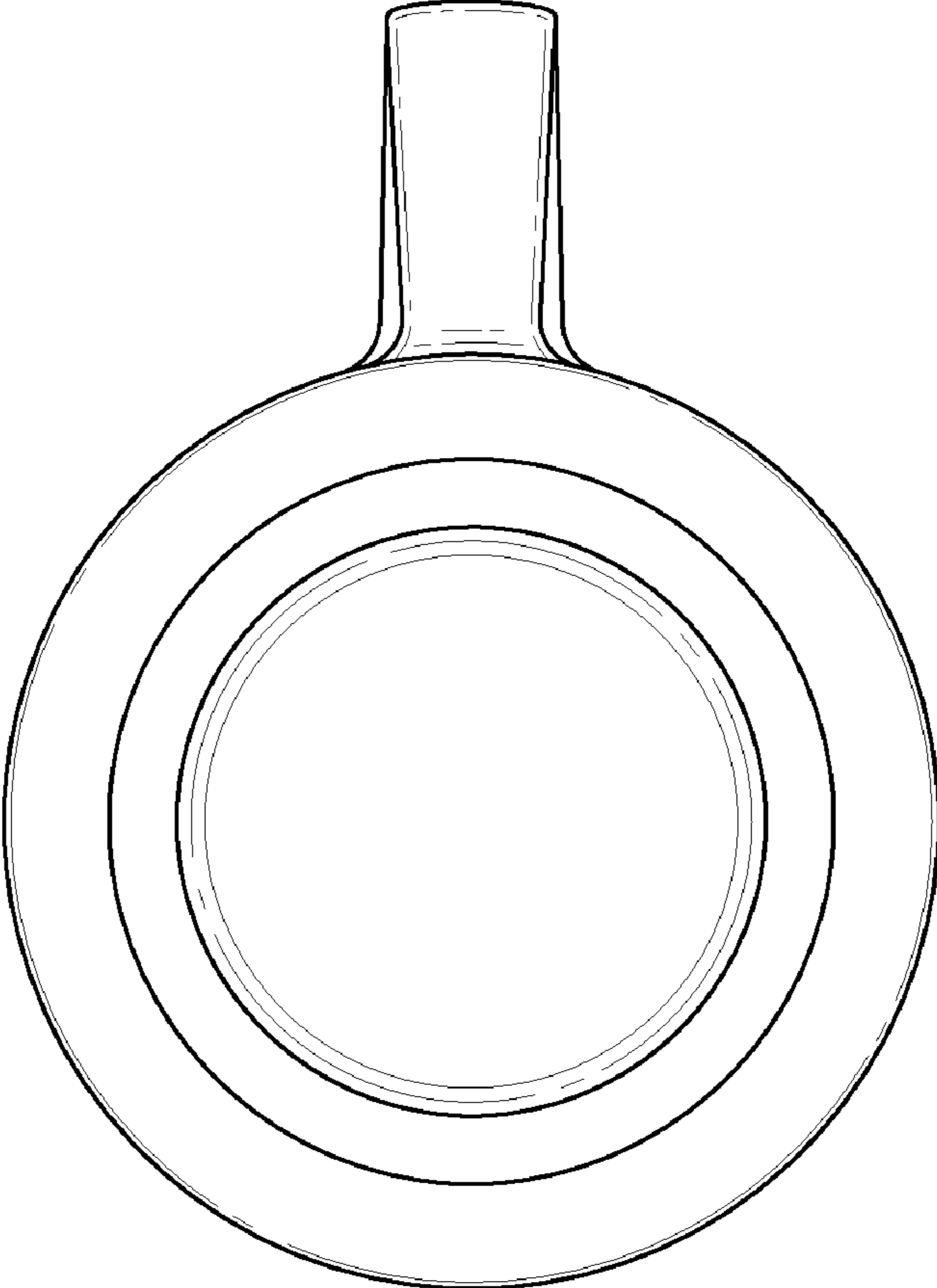

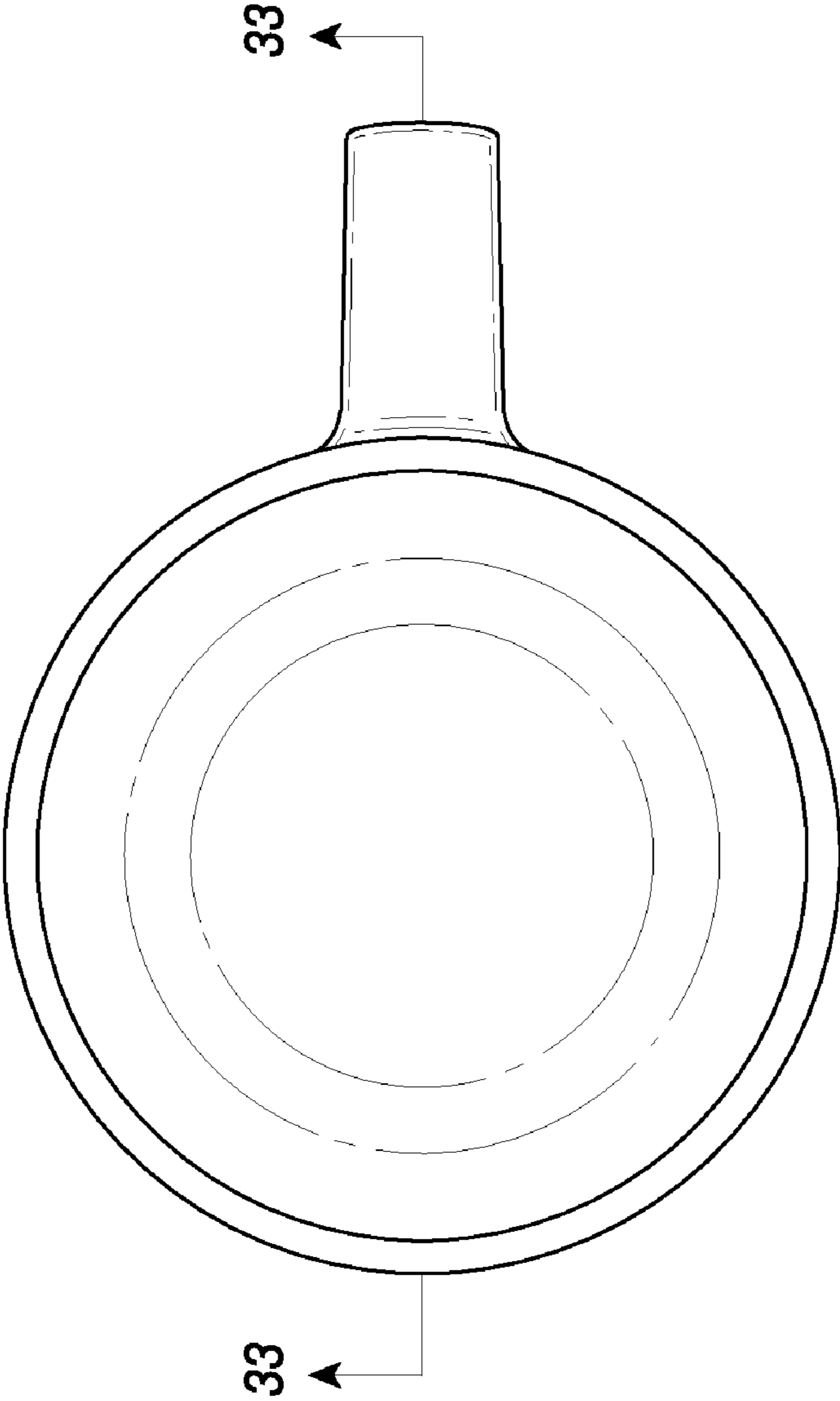

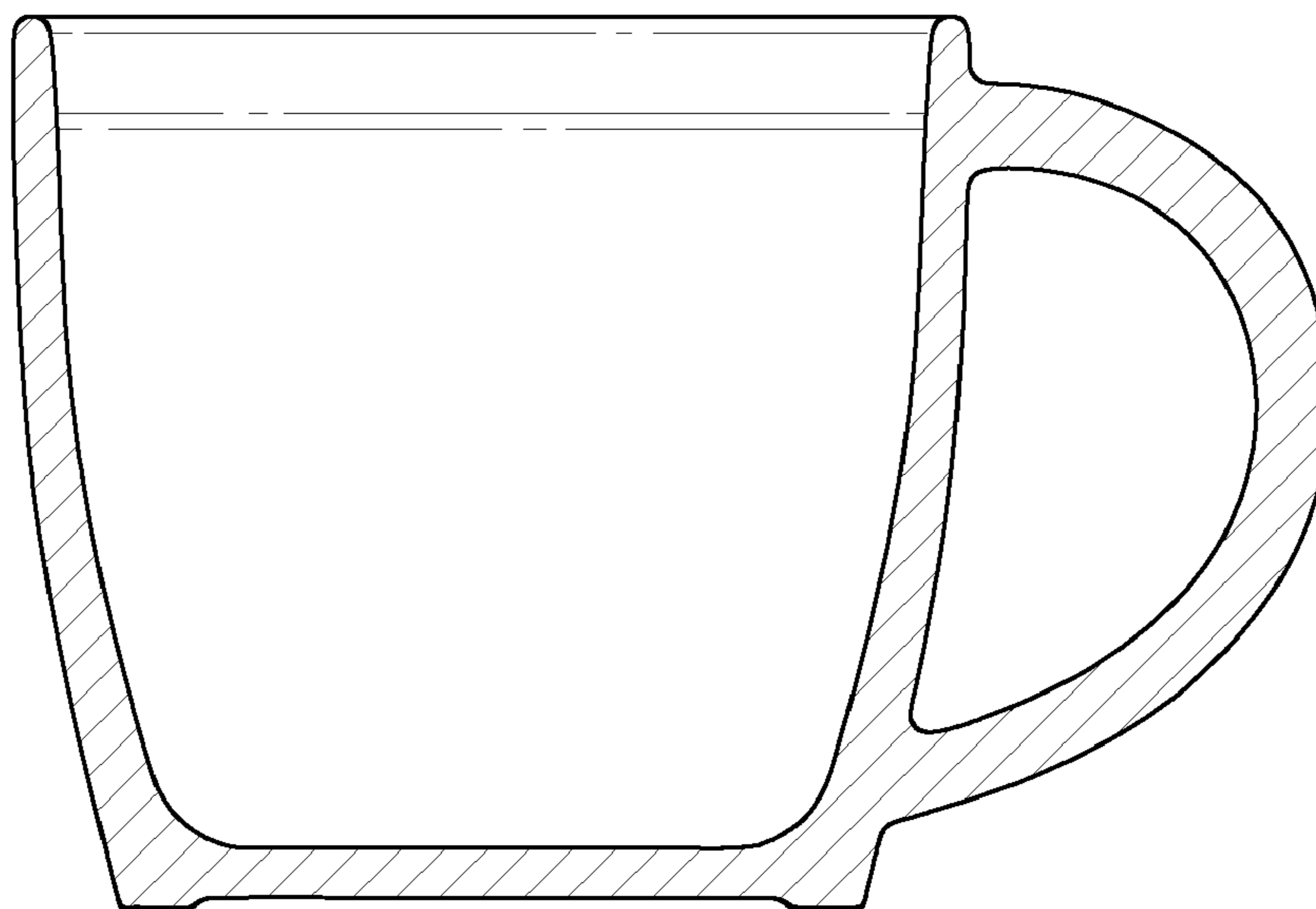

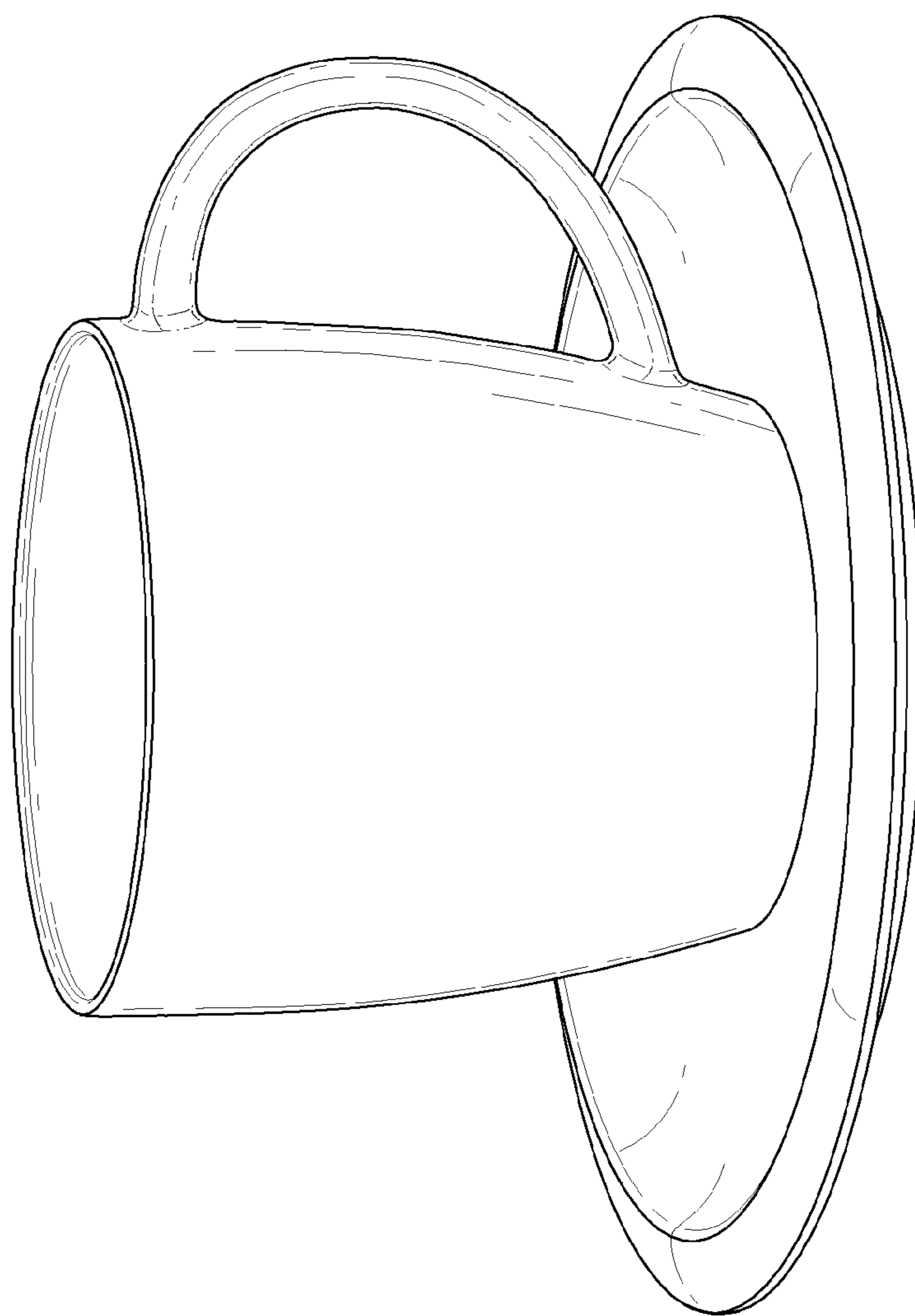

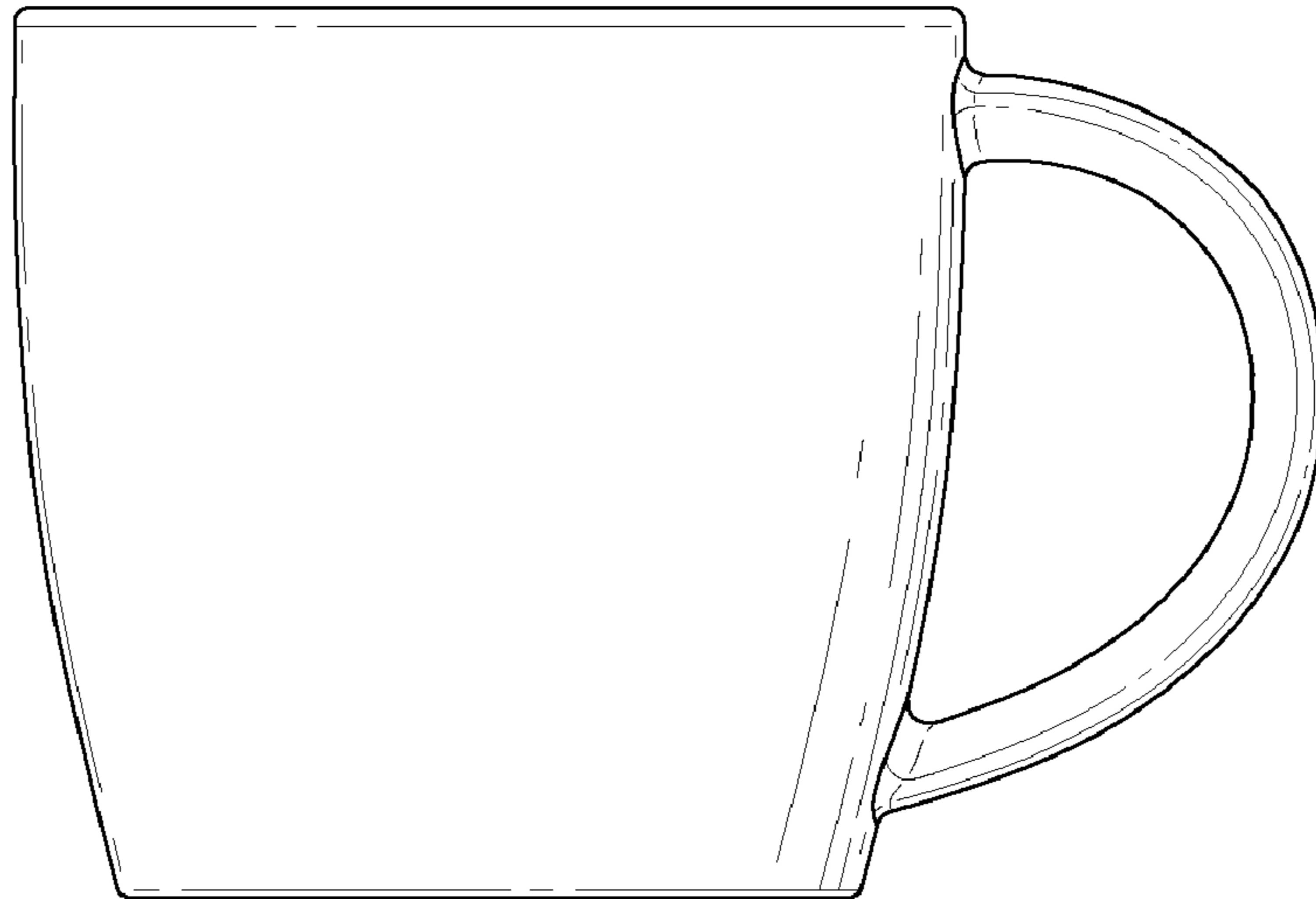

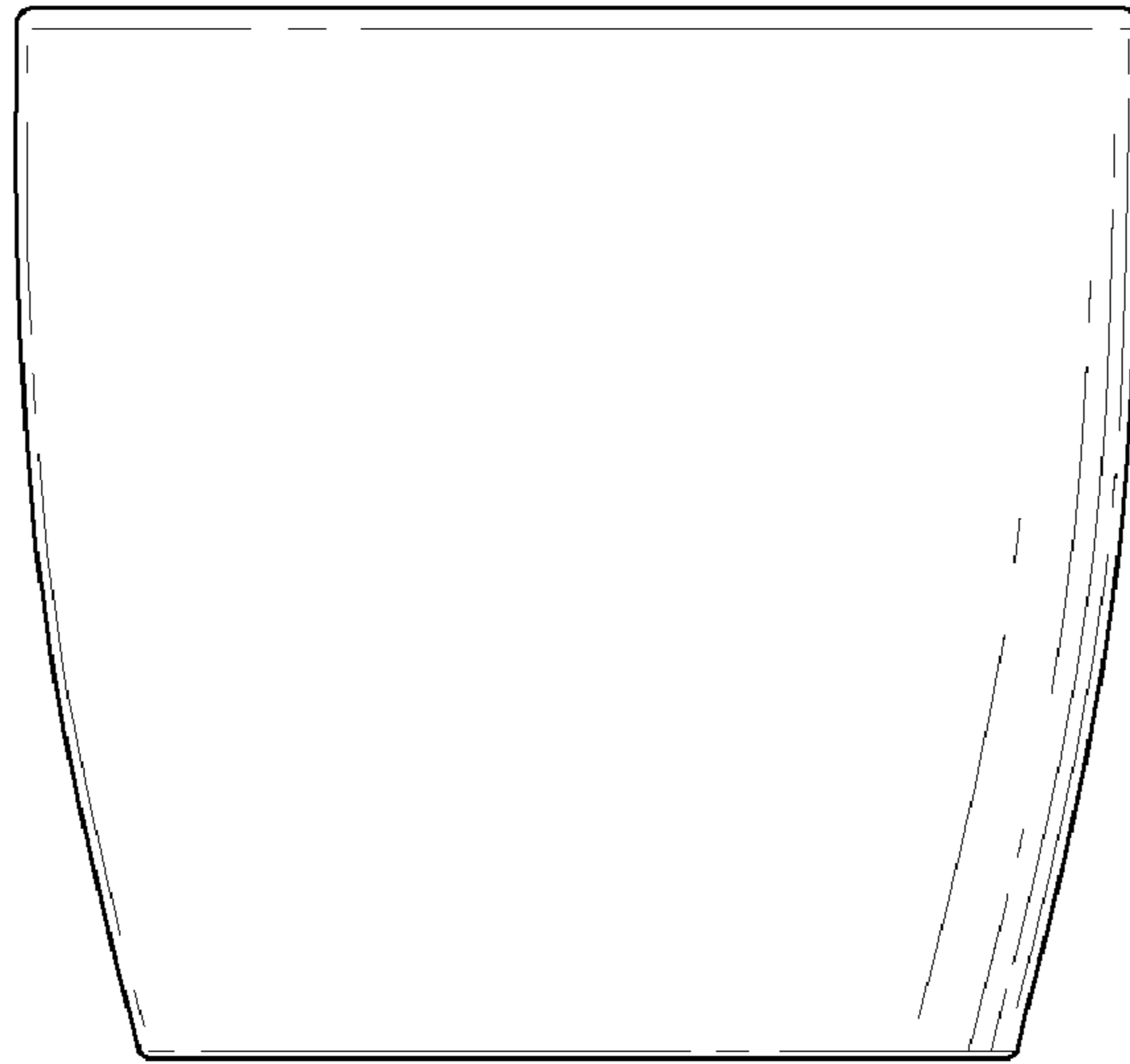

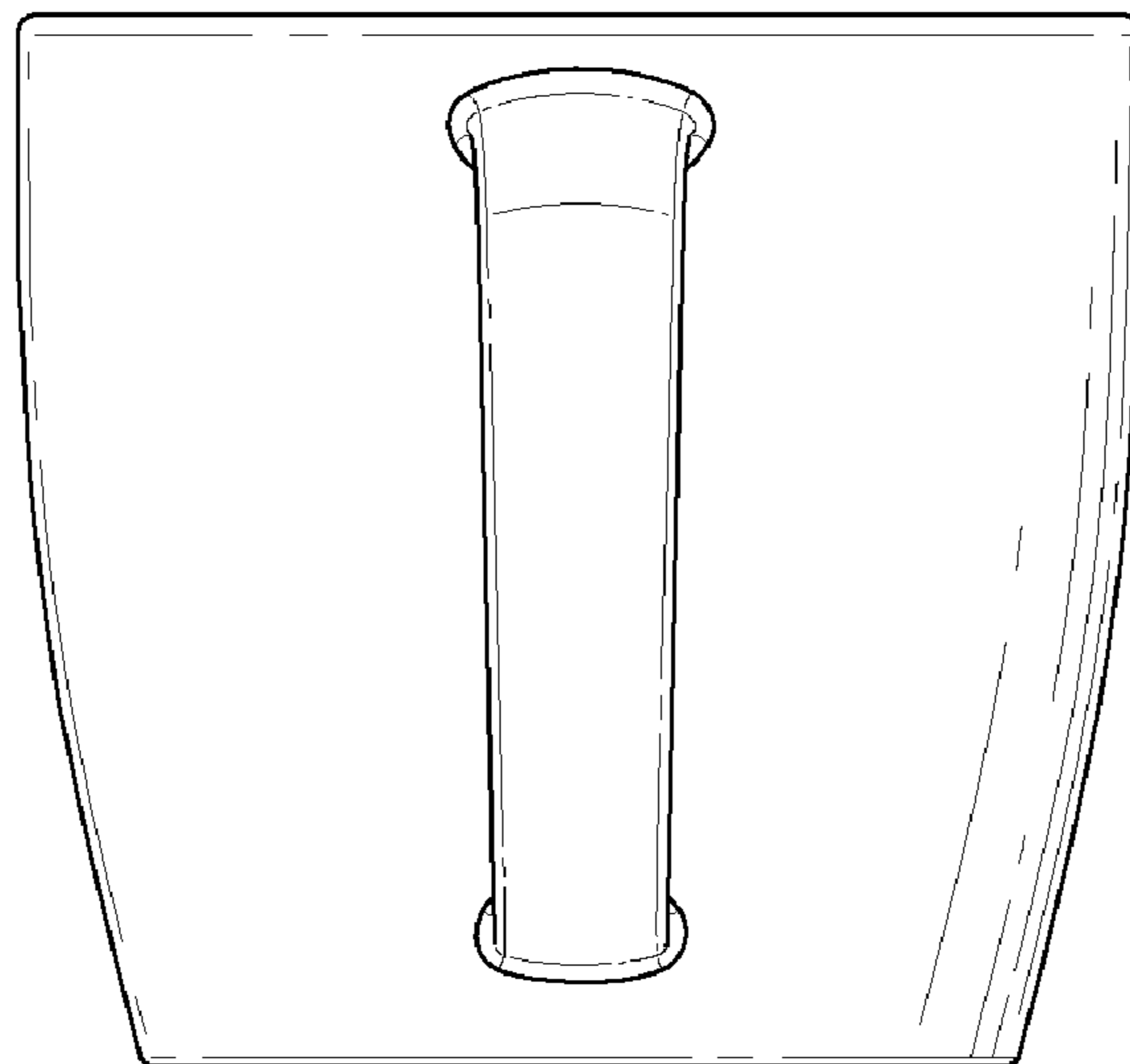

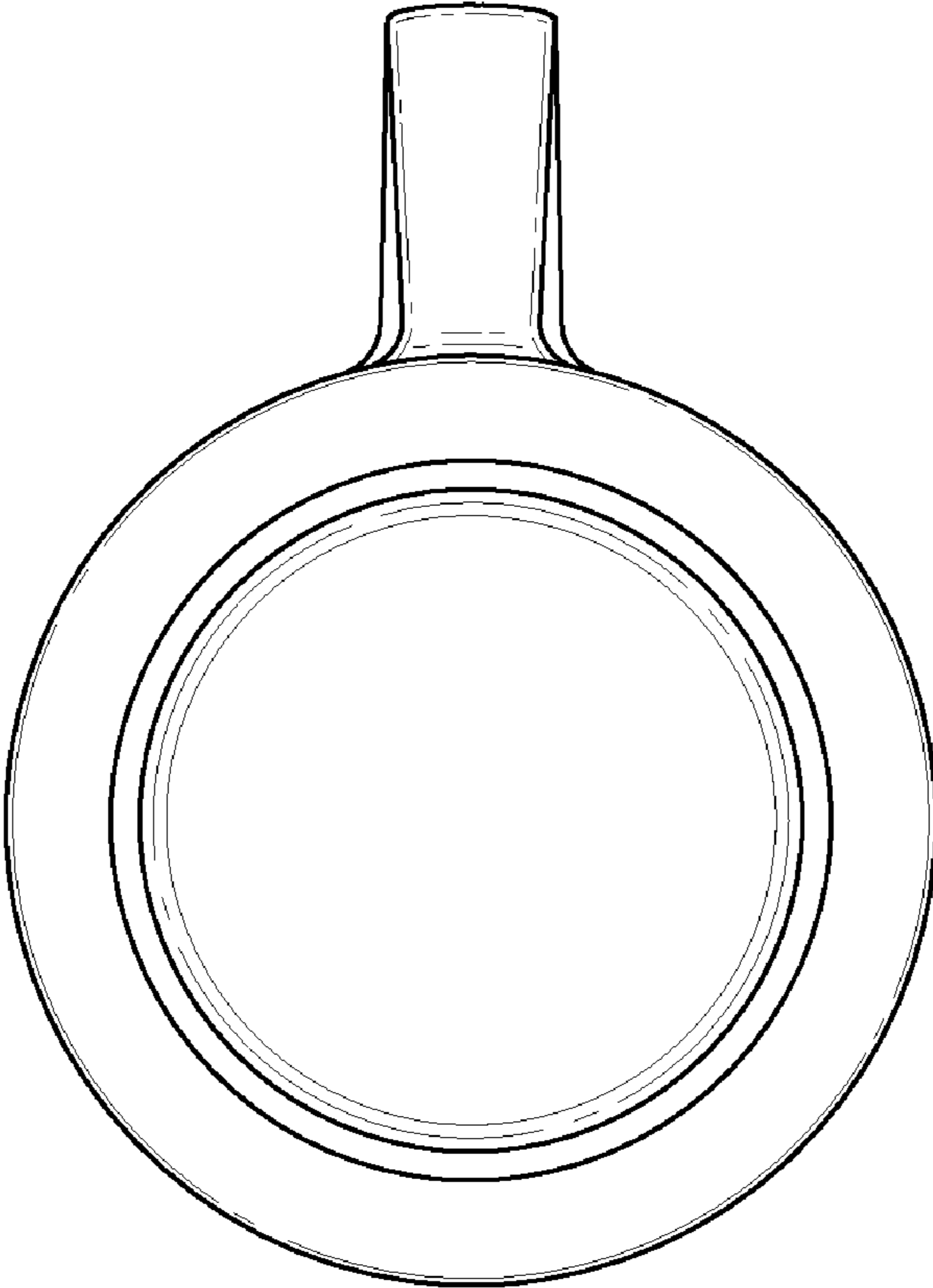

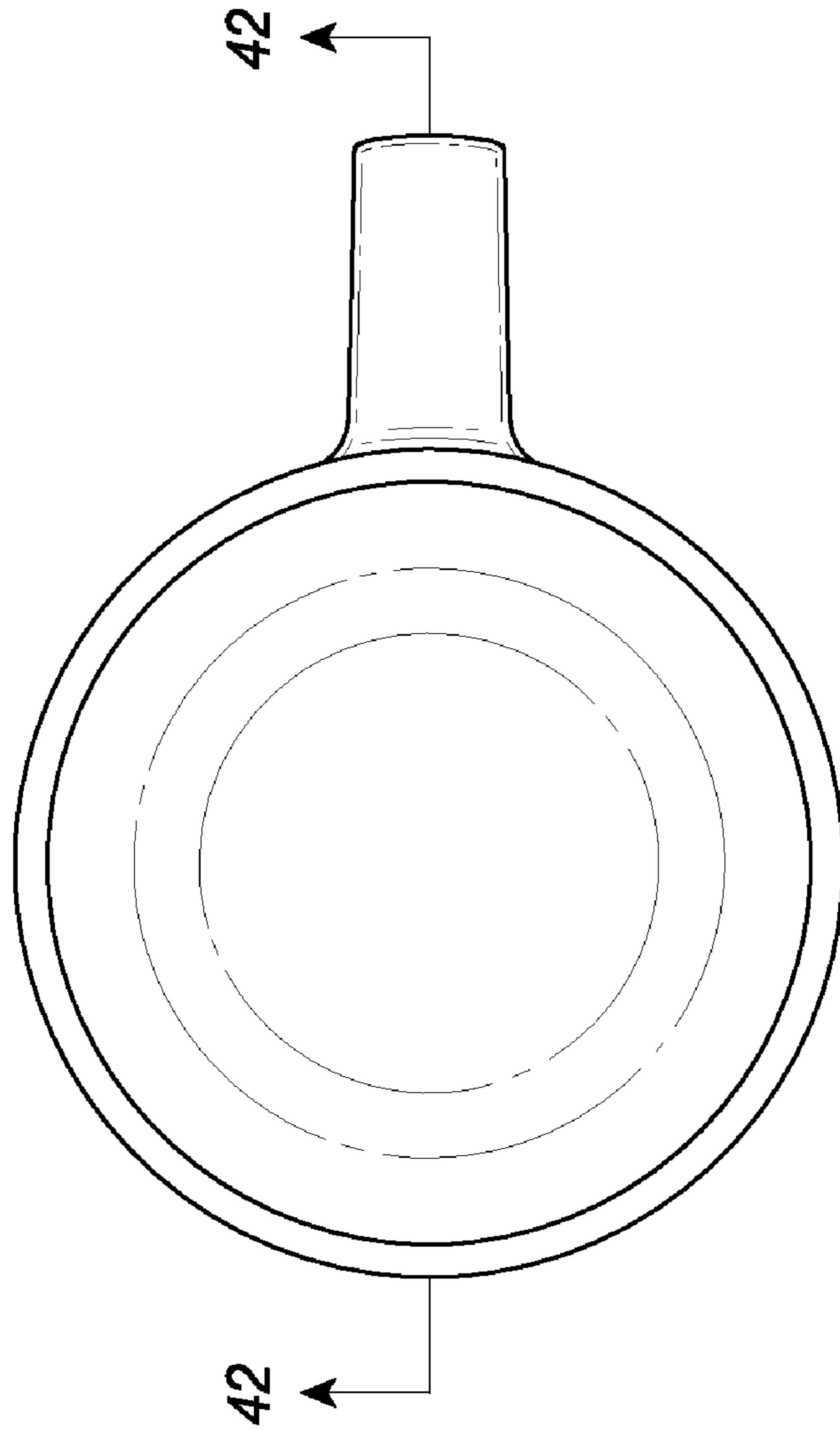

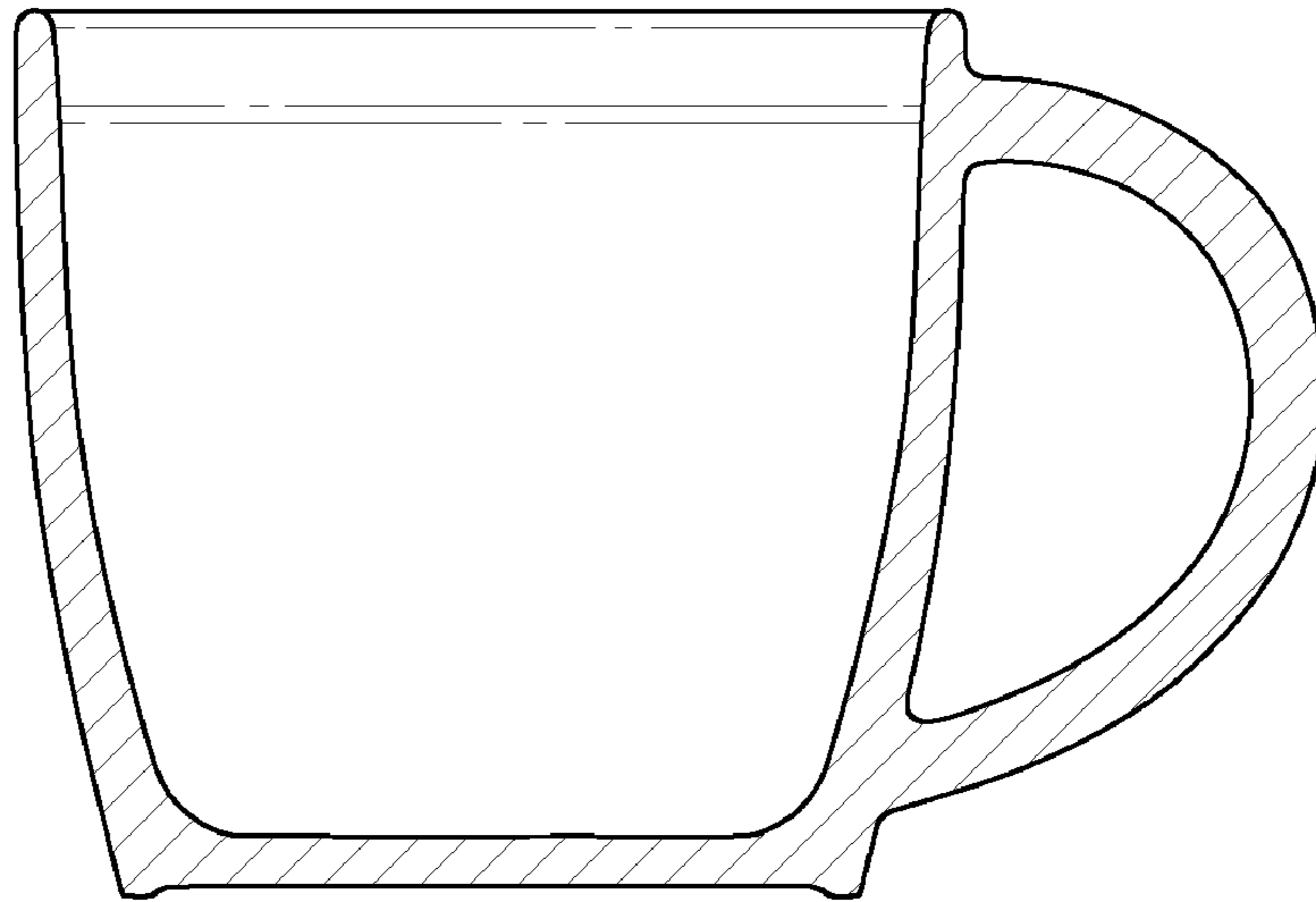

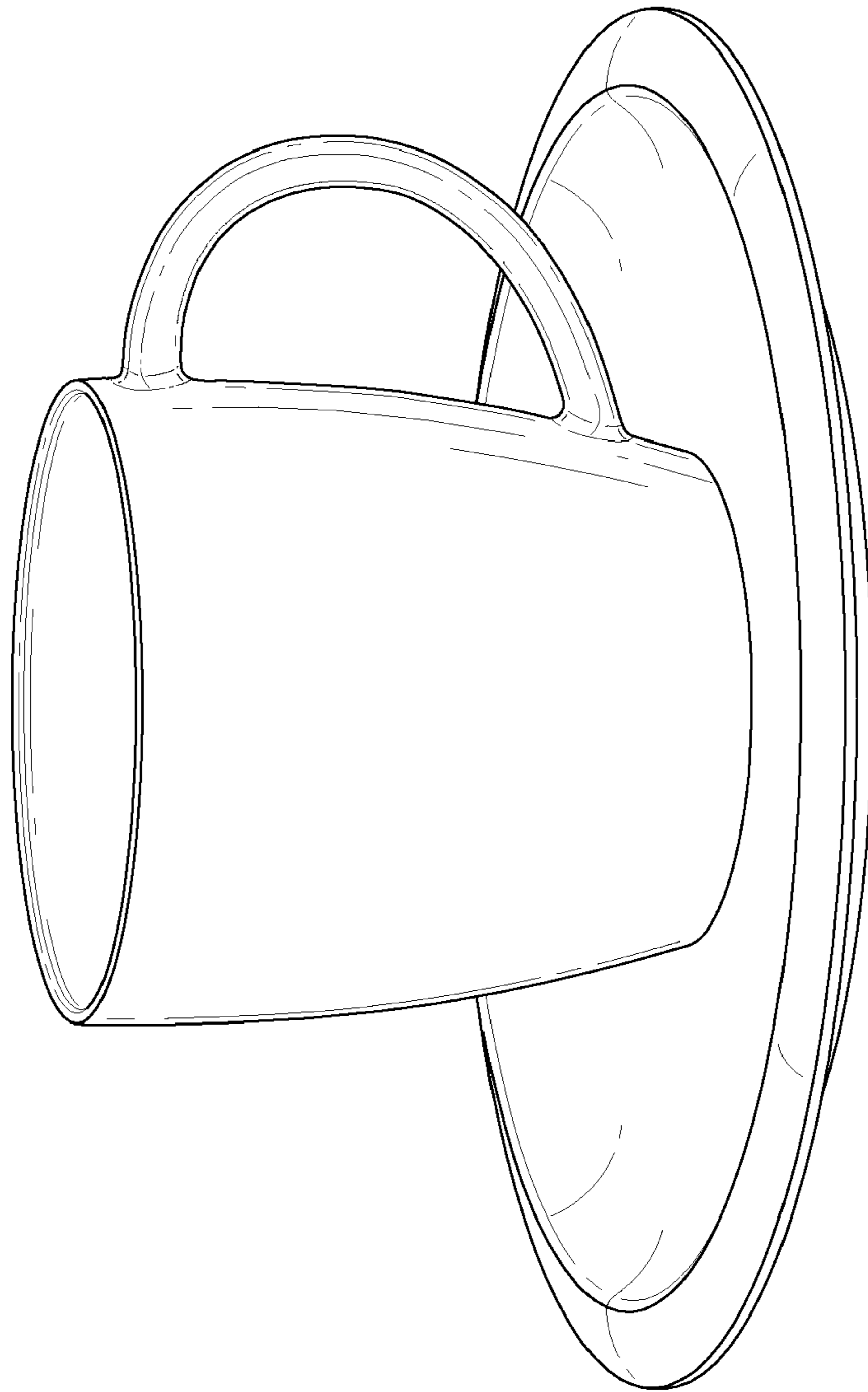

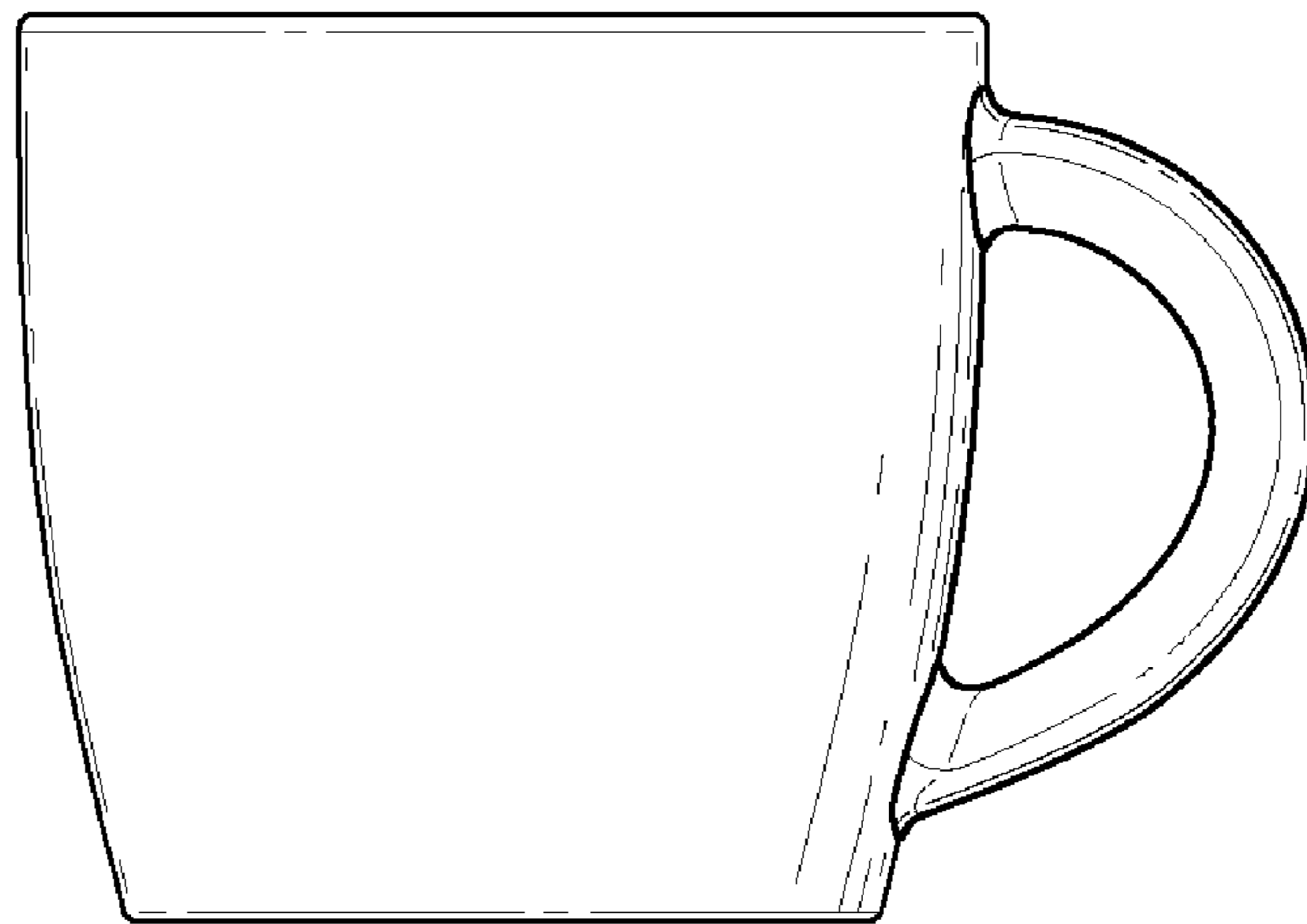

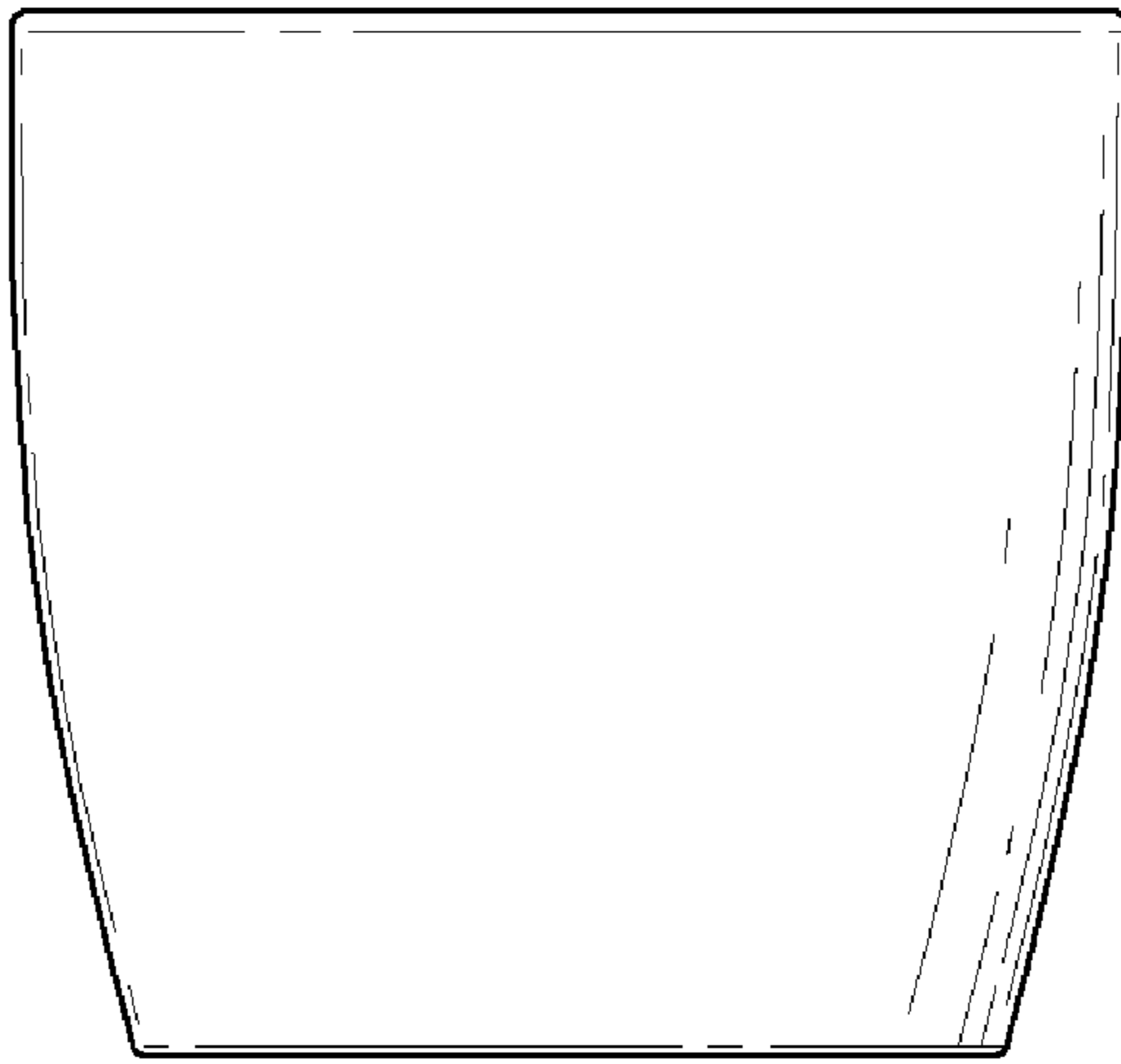

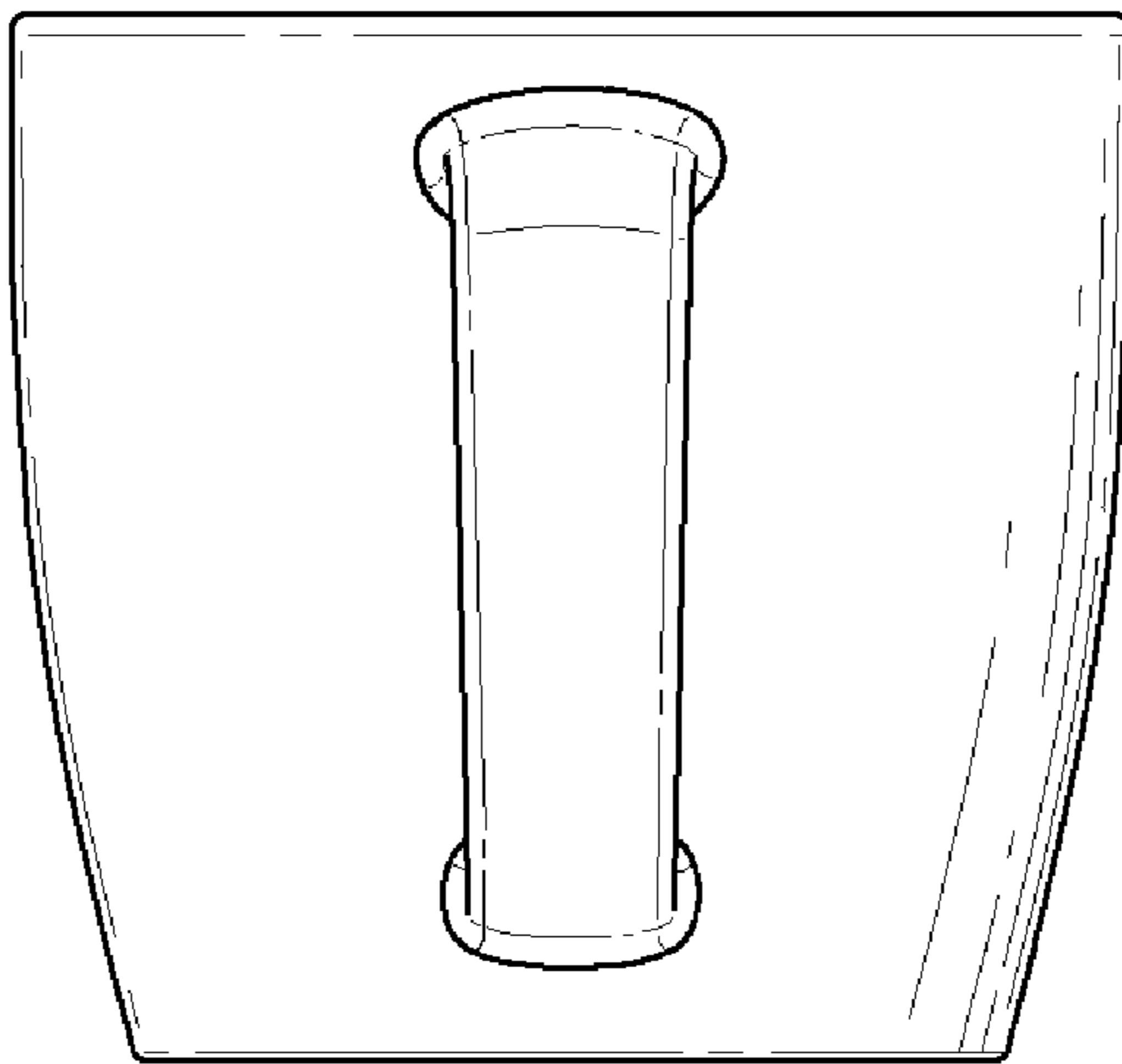

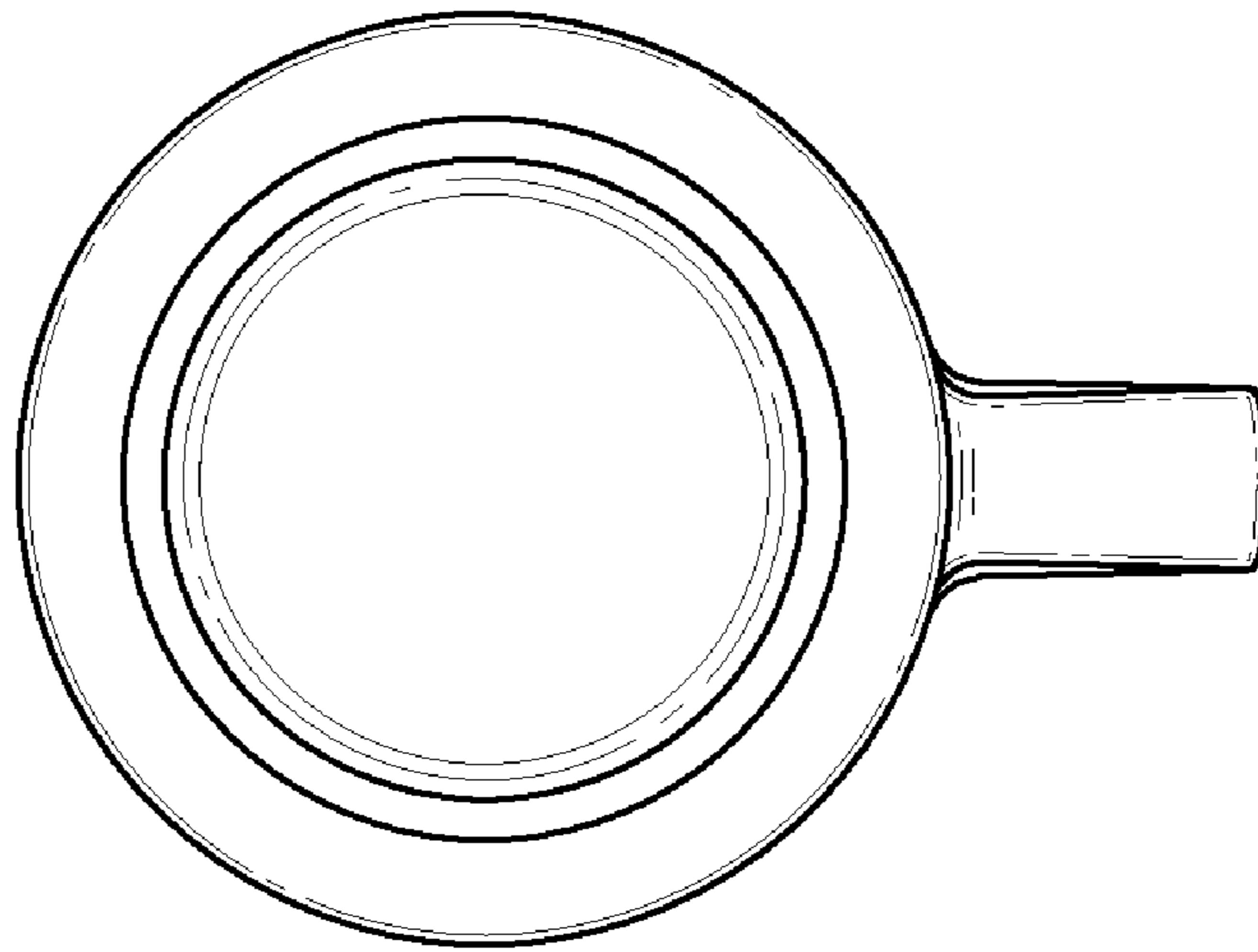

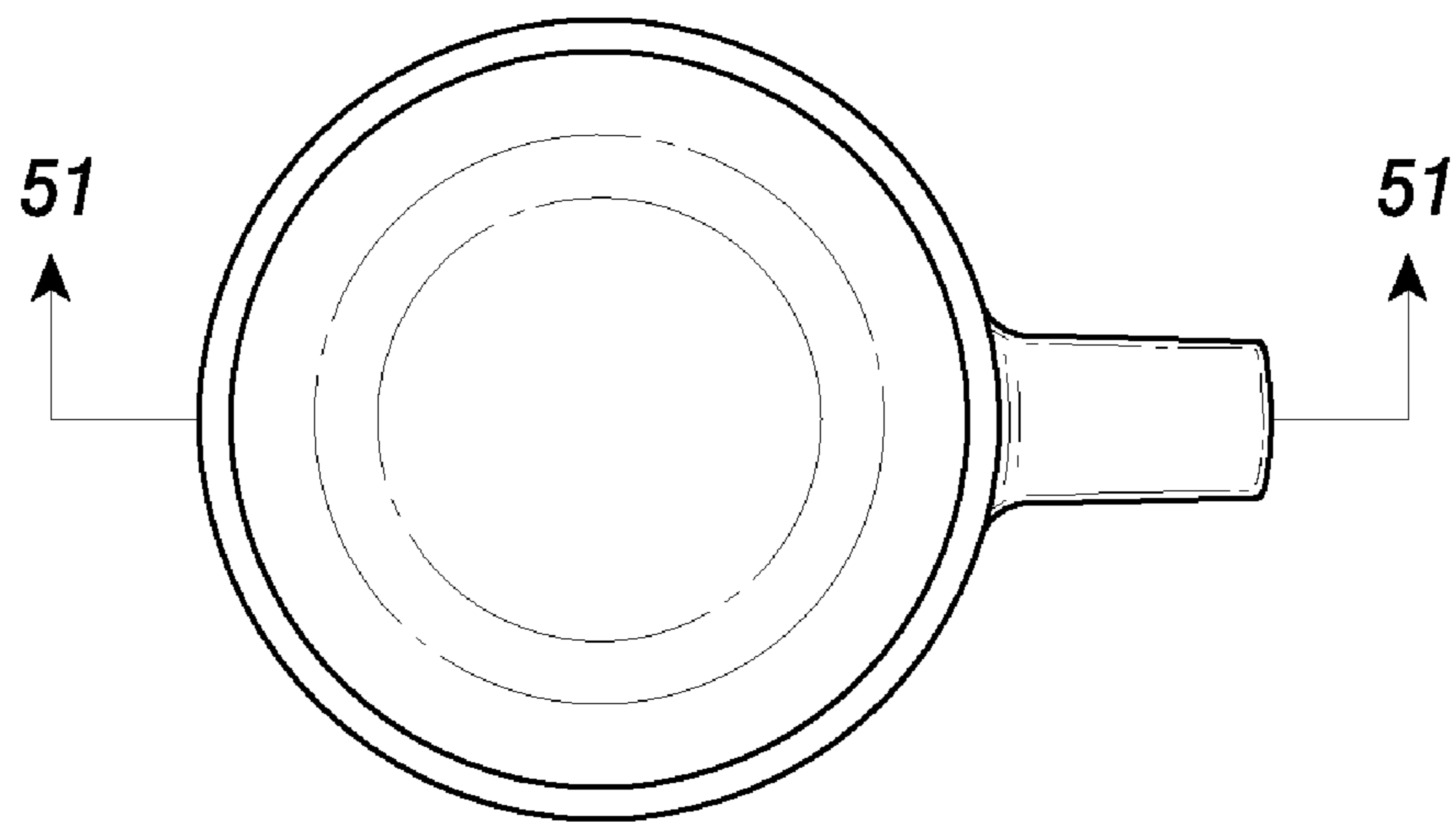

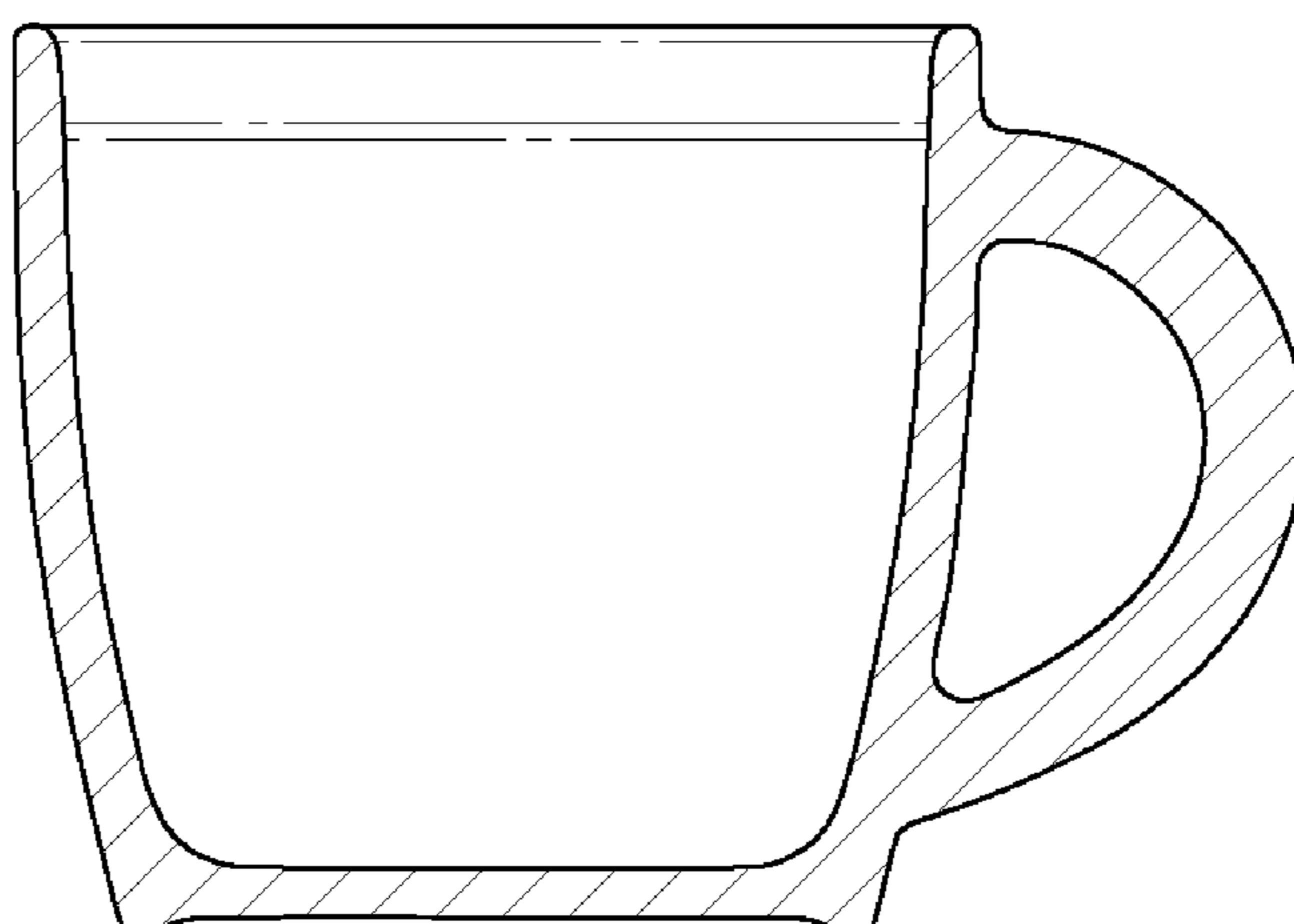

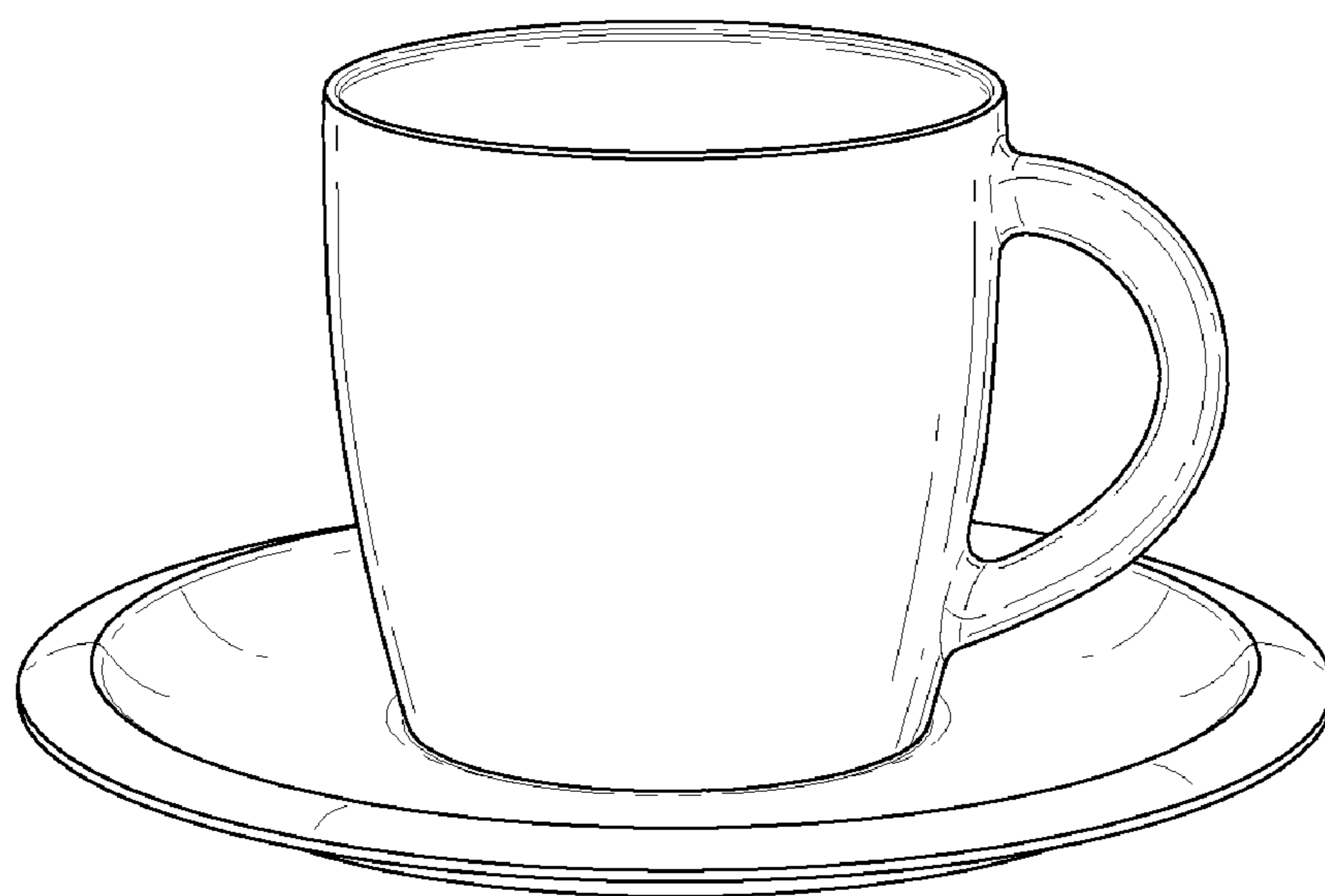

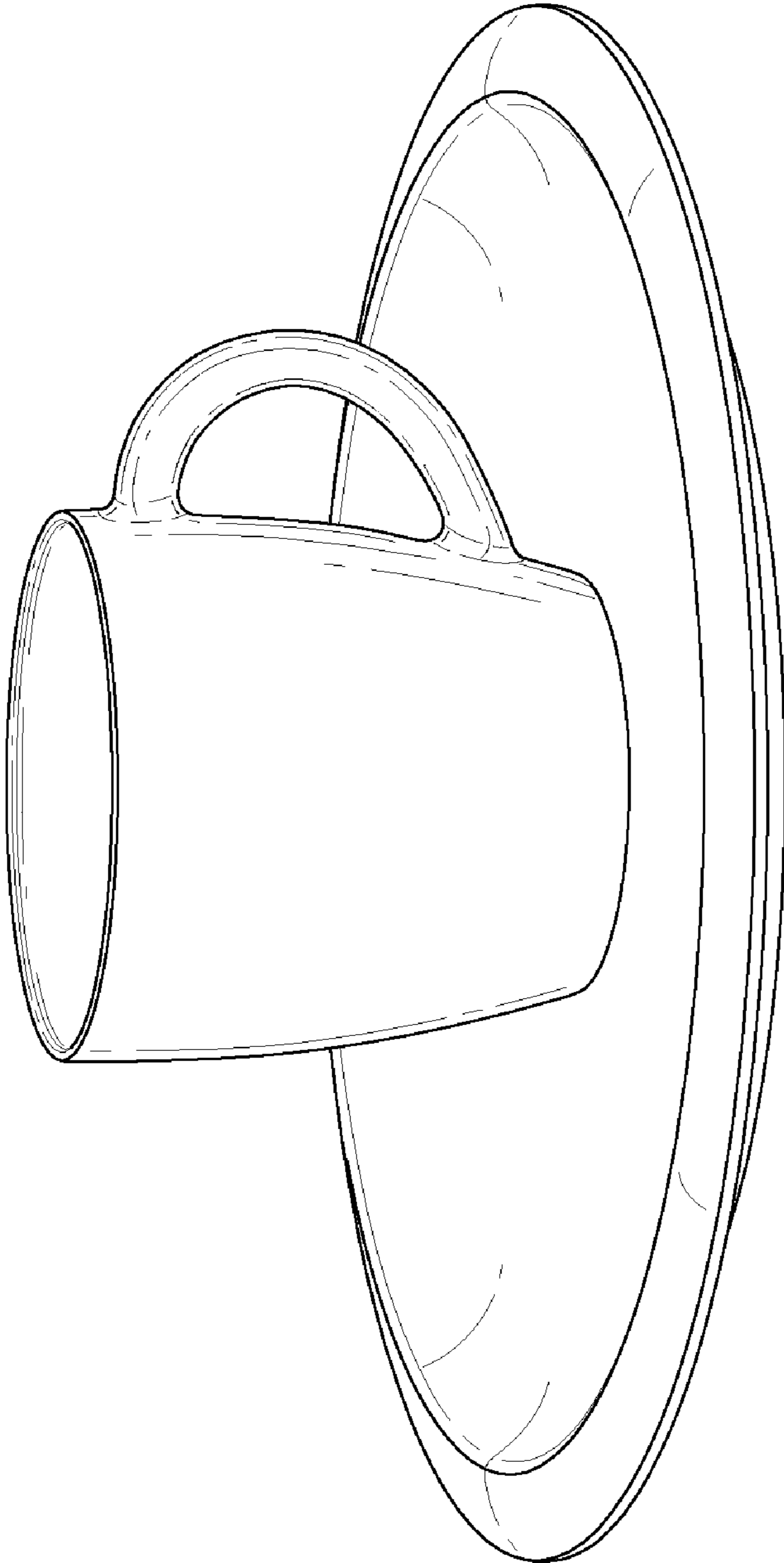

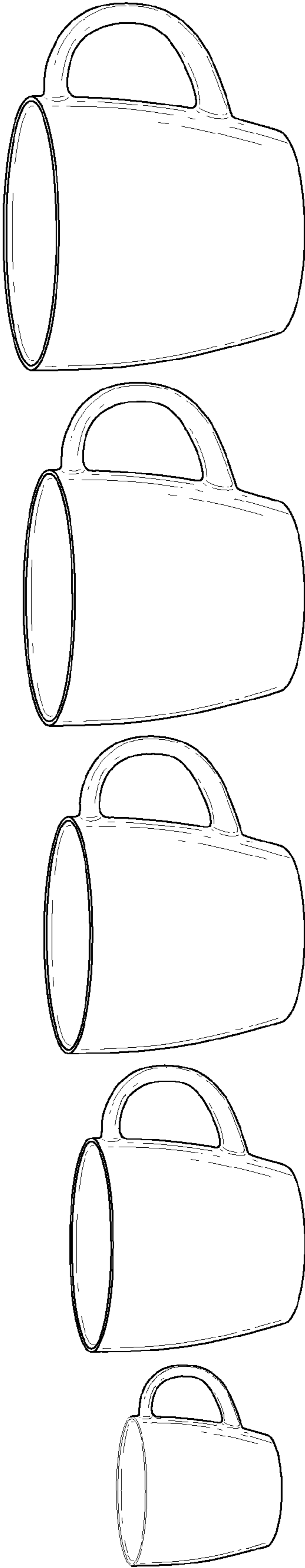

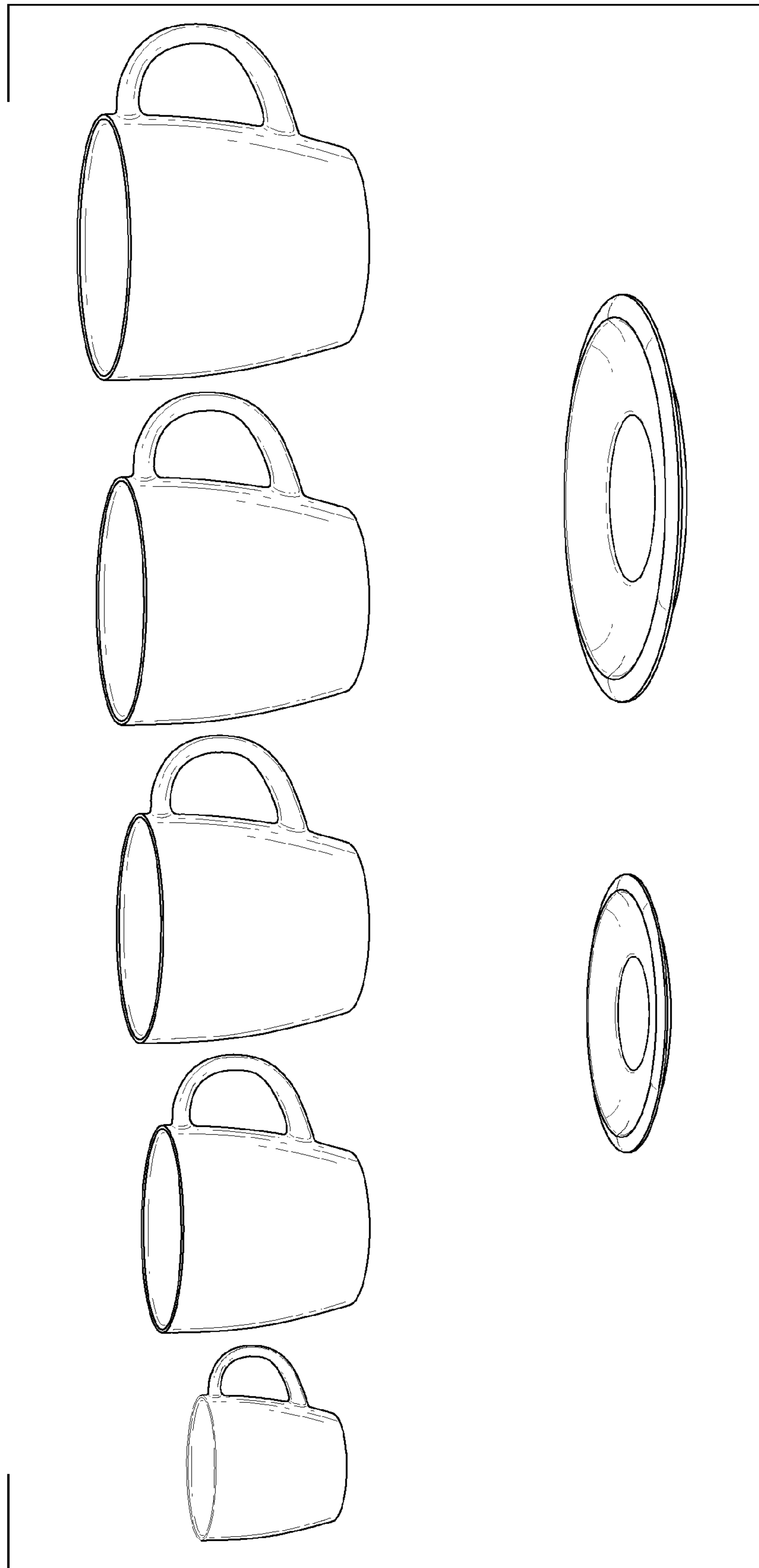
