(57) **CLAIM**

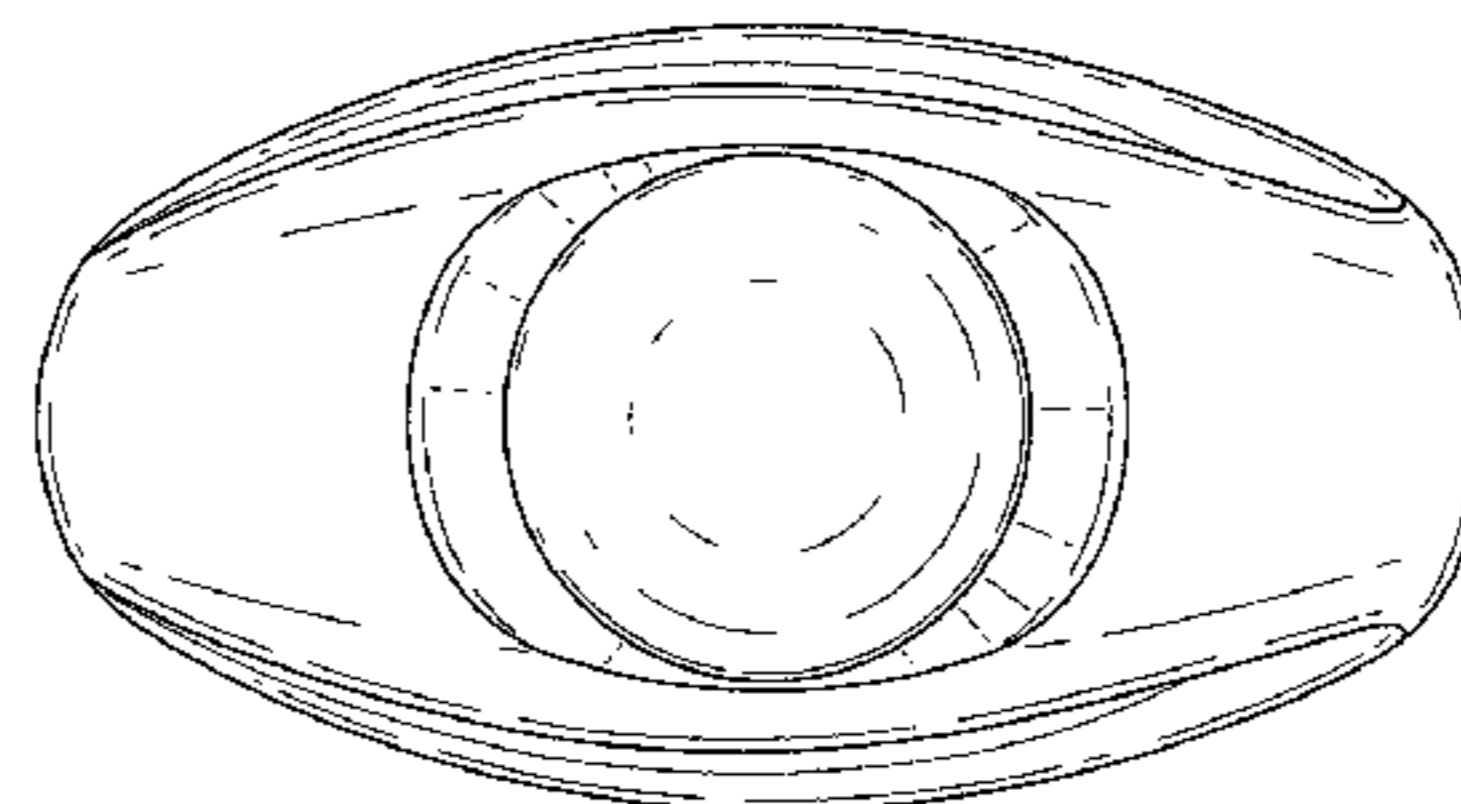
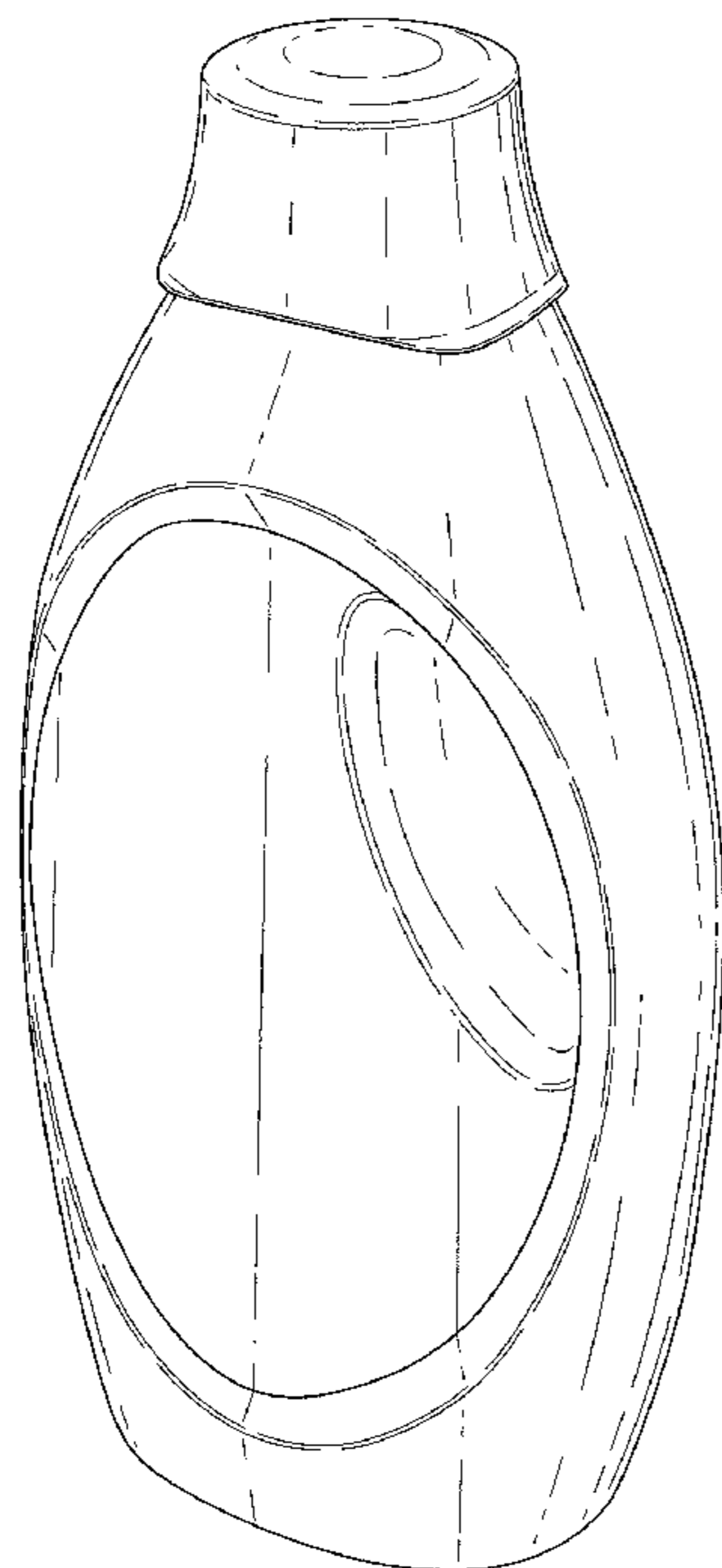
The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of the bottle of the claimed design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a back elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof; and
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

The broken lines showing a portion of the bottom surface are included for the purpose of illustrating environmental structure and form no part of the claimed design.

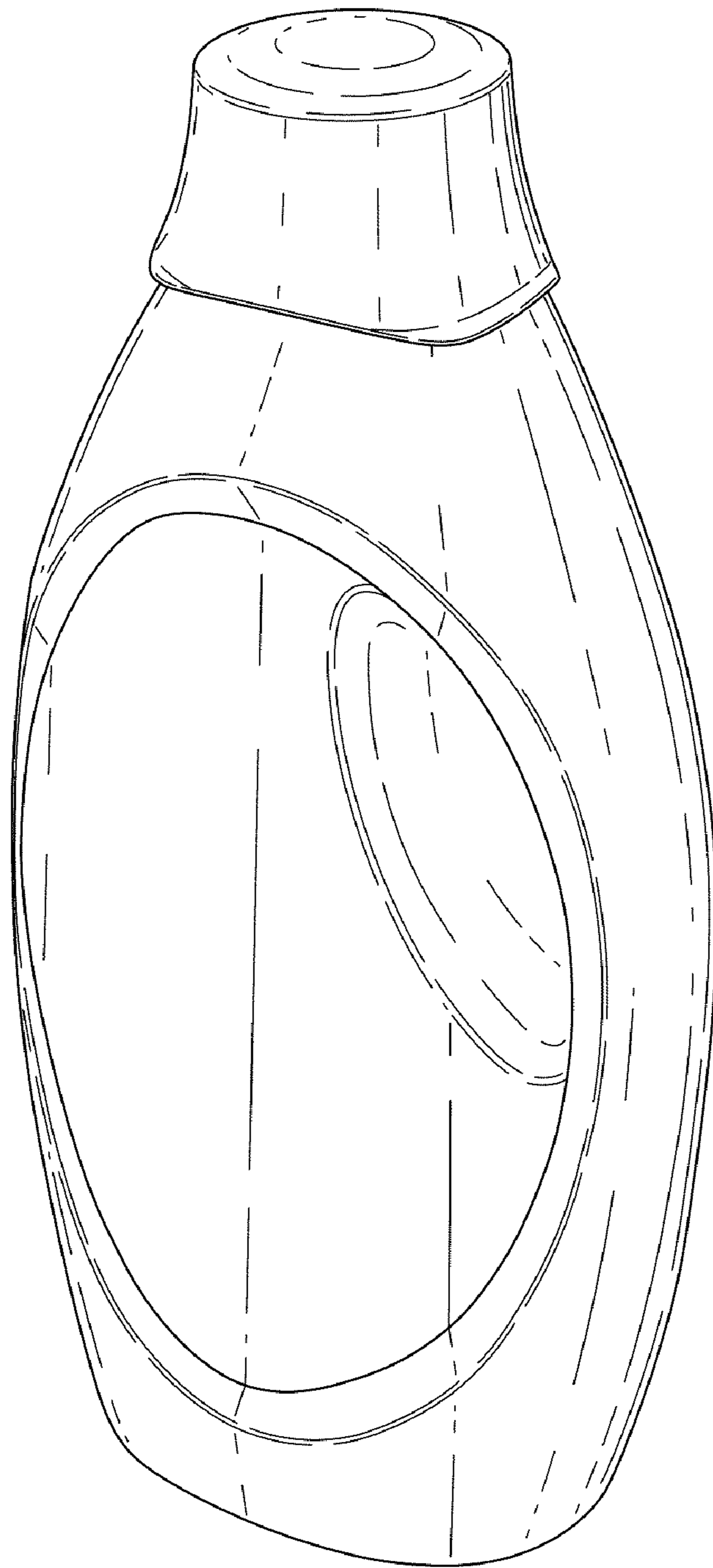

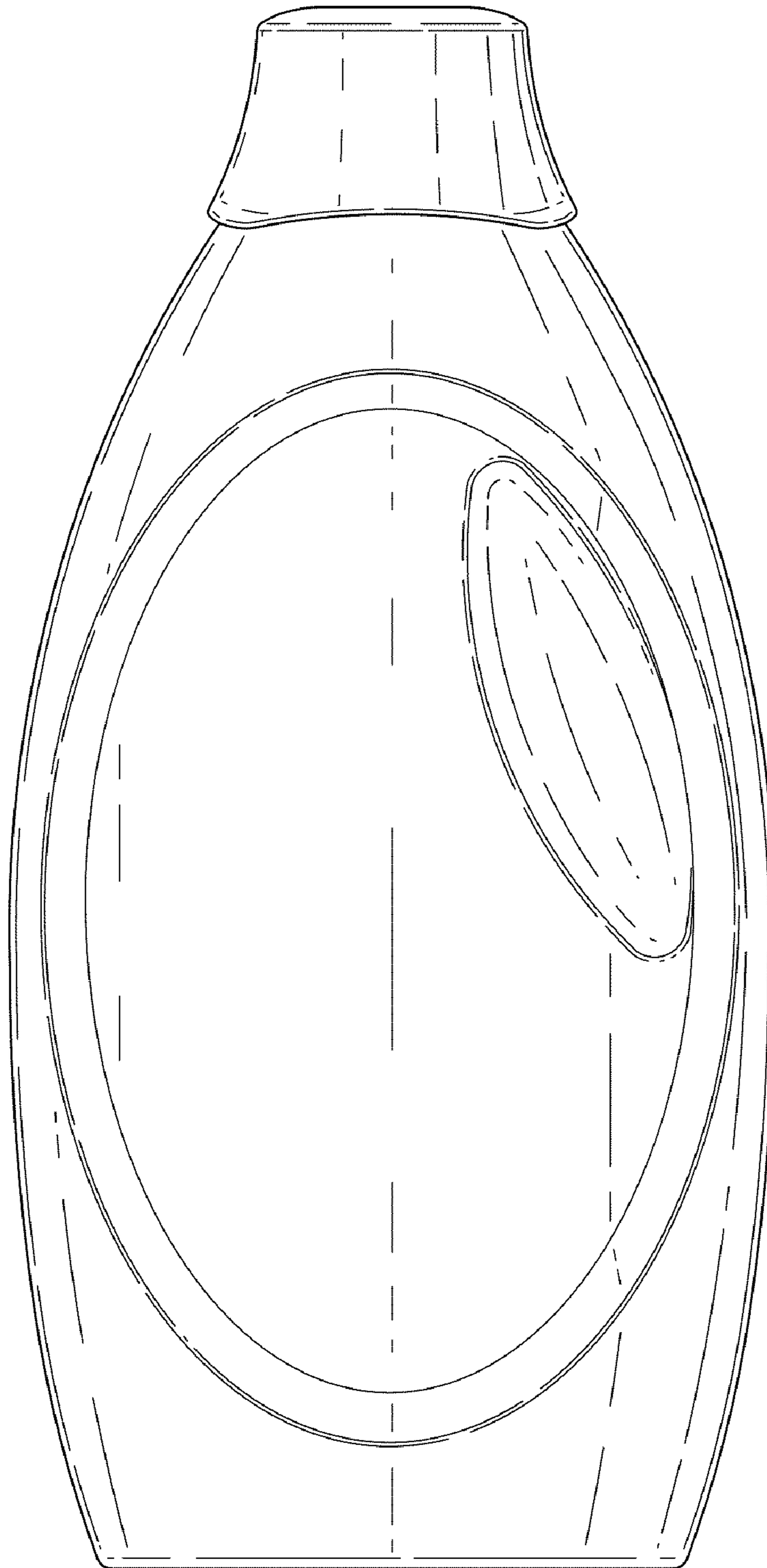

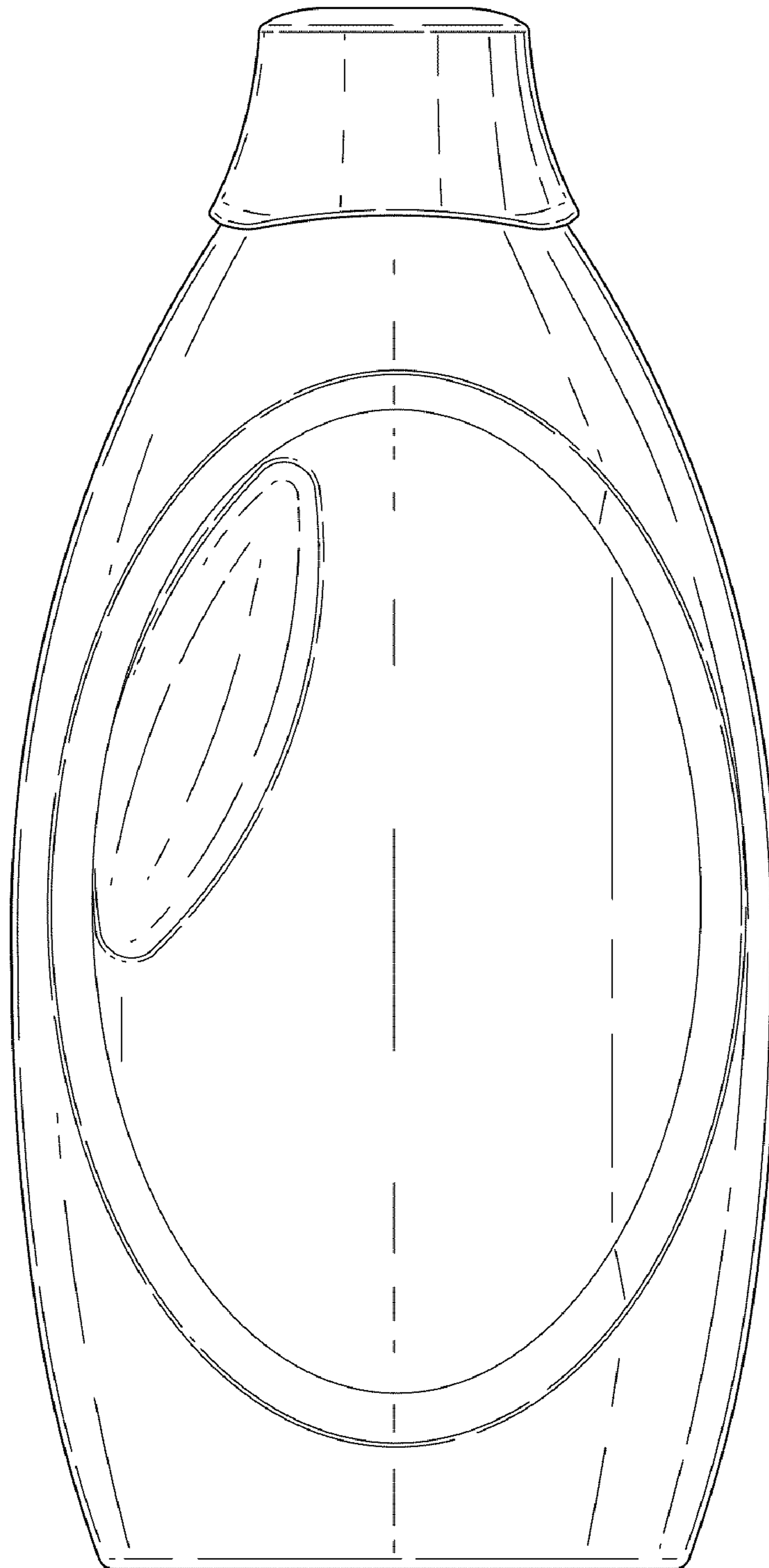

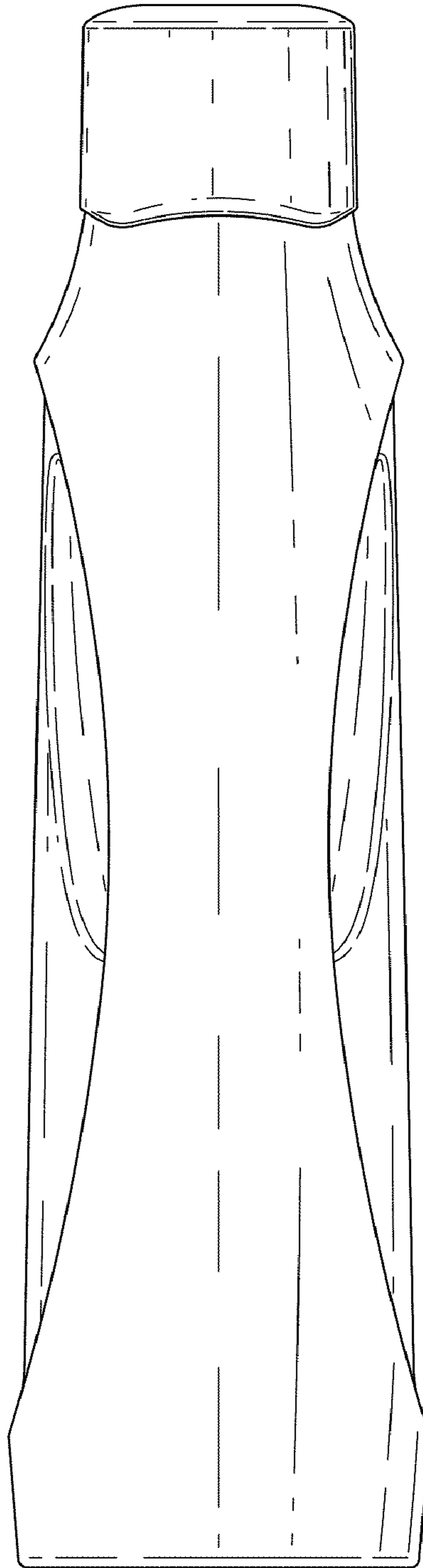

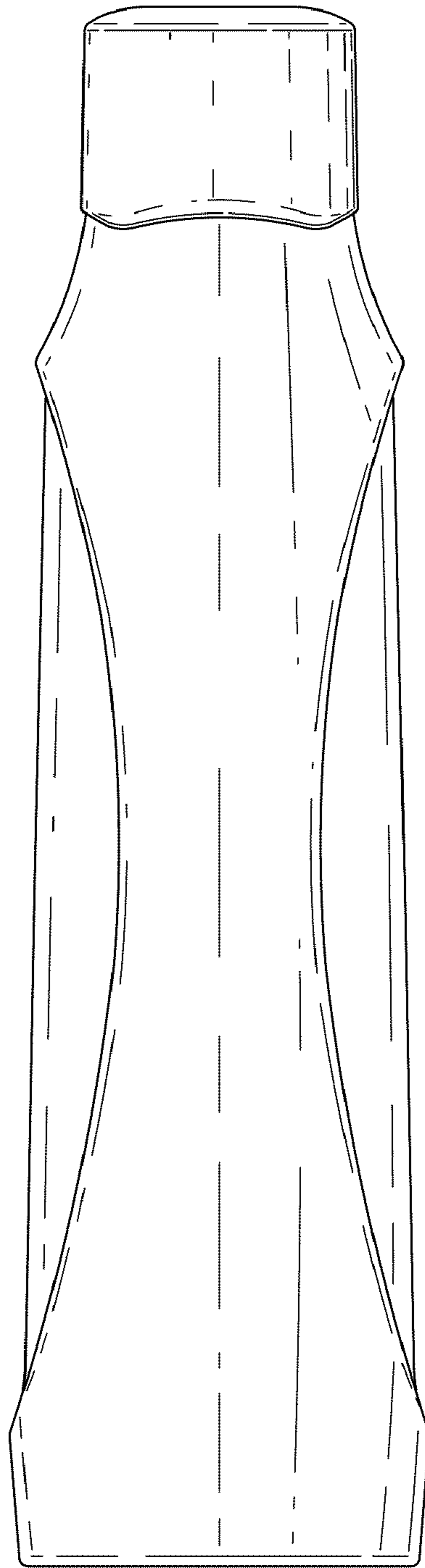

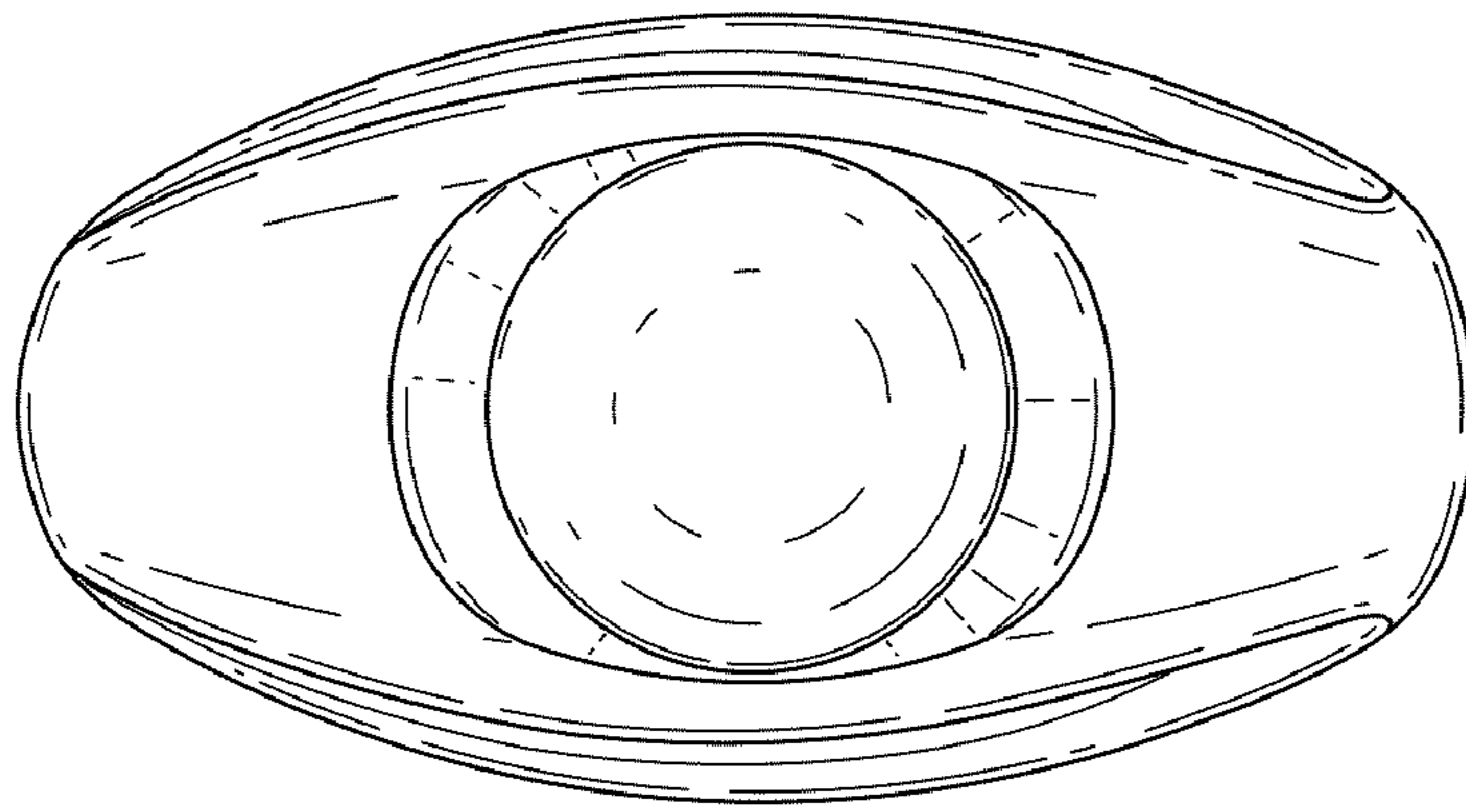

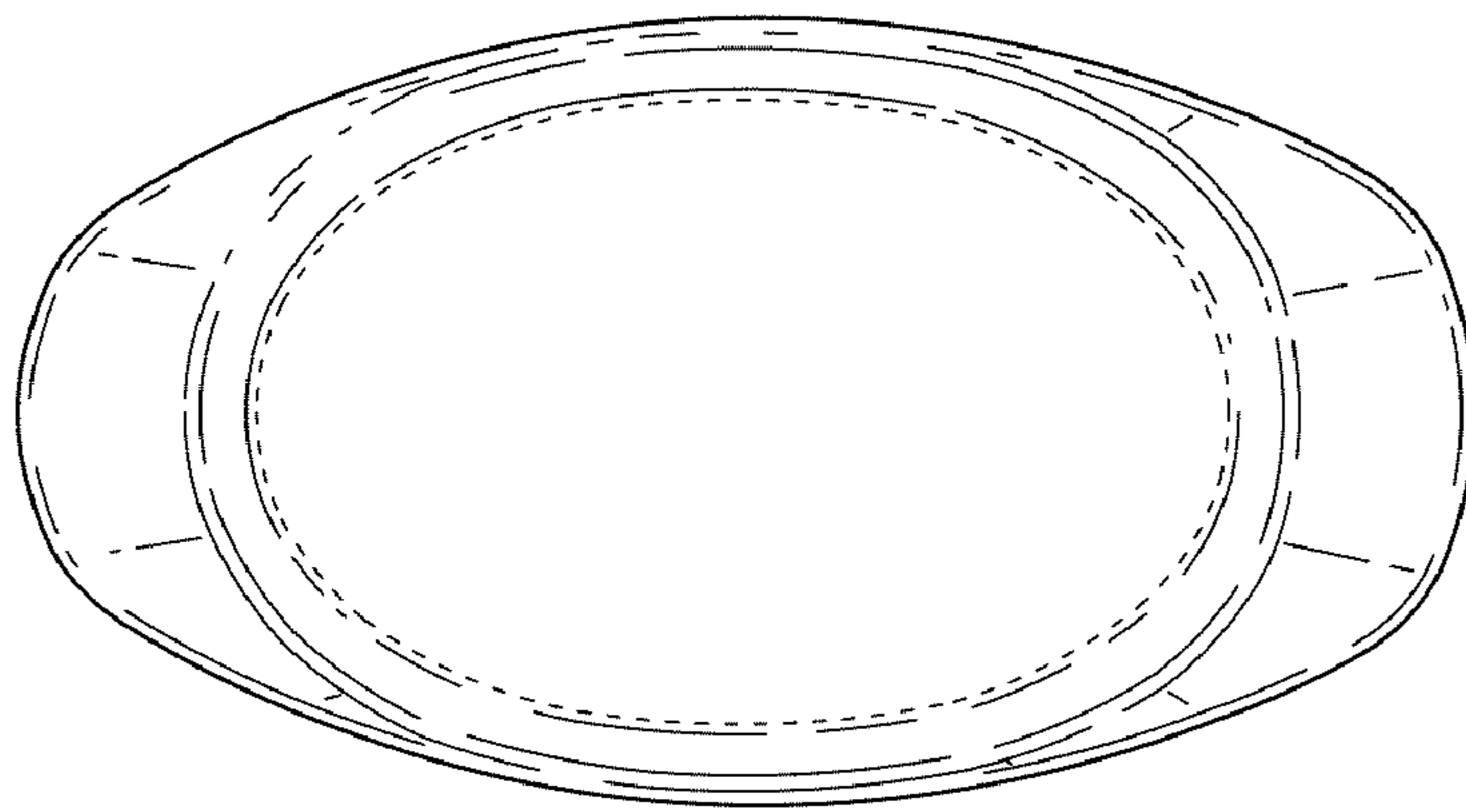
