(57) **CLAIM**

The ornamental design for a strip pattern substrate for a filtering device, as shown and described in the Figures.

**DESCRIPTION**

FIG. 1 is perspective view of the strip pattern substrate for a filtering device;  
FIG. 2 is a front end view of the strip pattern substrate for a filtering device;  
FIG. 3 is a rear end view of the strip pattern substrate for a filtering device;  
FIG. 4 is a lateral side view of the strip pattern substrate for a filtering device;  
FIG. 5 is a lateral side view of the strip pattern substrate for a filtering device that is opposite the lateral side view in FIG. 4;  
FIG. 6 is a top side plan view of the strip pattern substrate for a filtering device; and,  
FIG. 7 is a bottom side plan view of the strip pattern substrate for a filtering device.

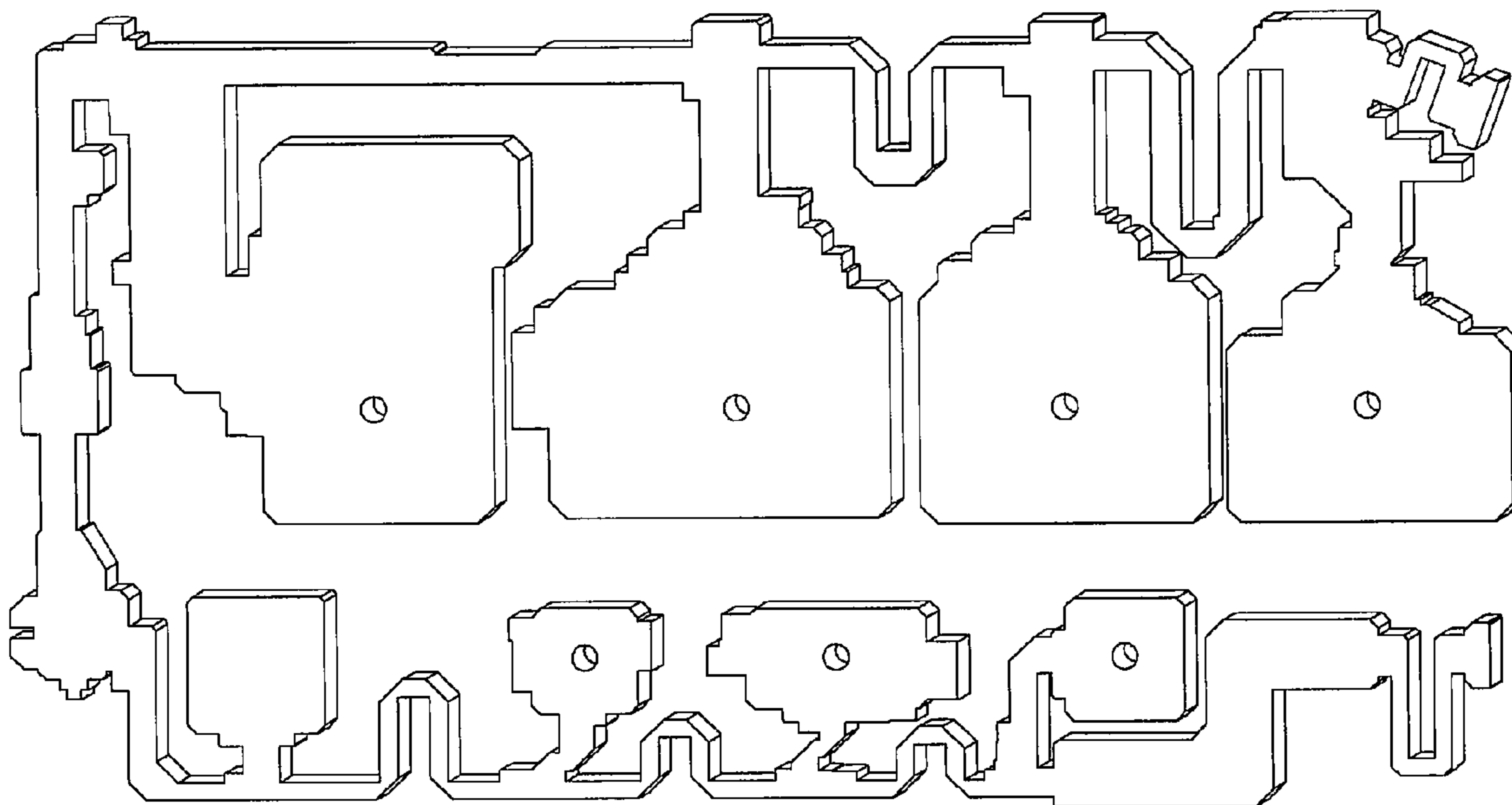

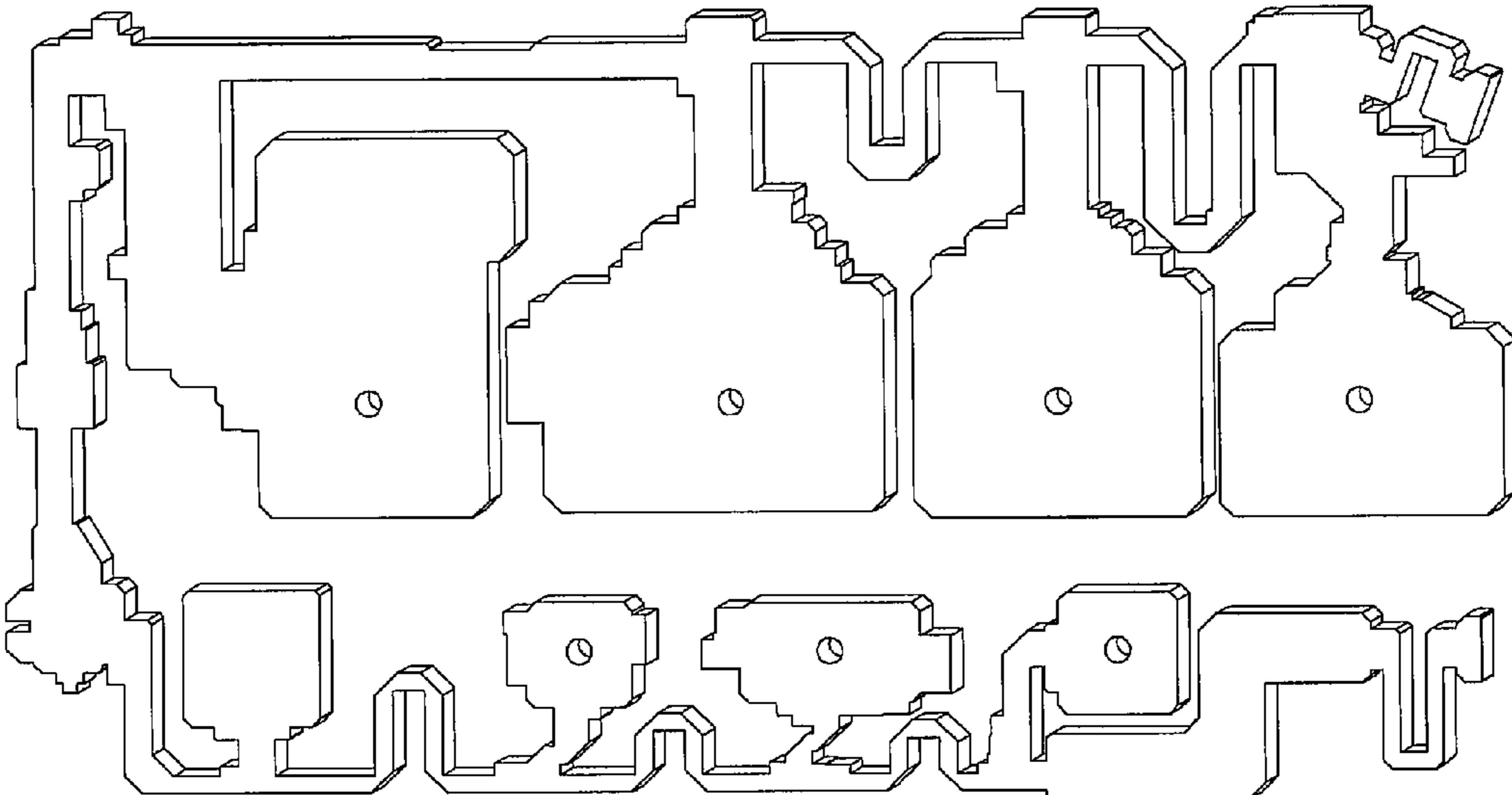

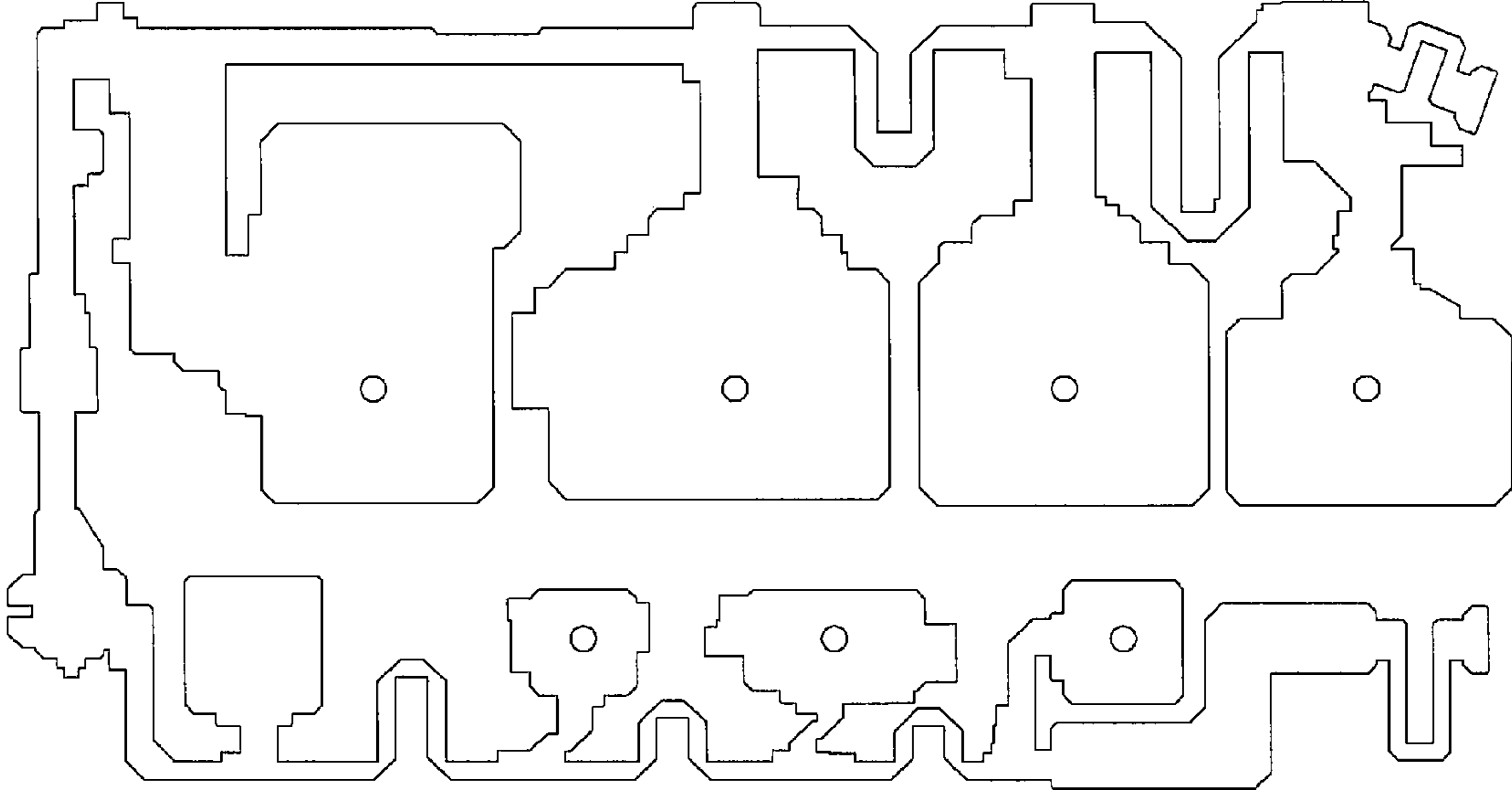

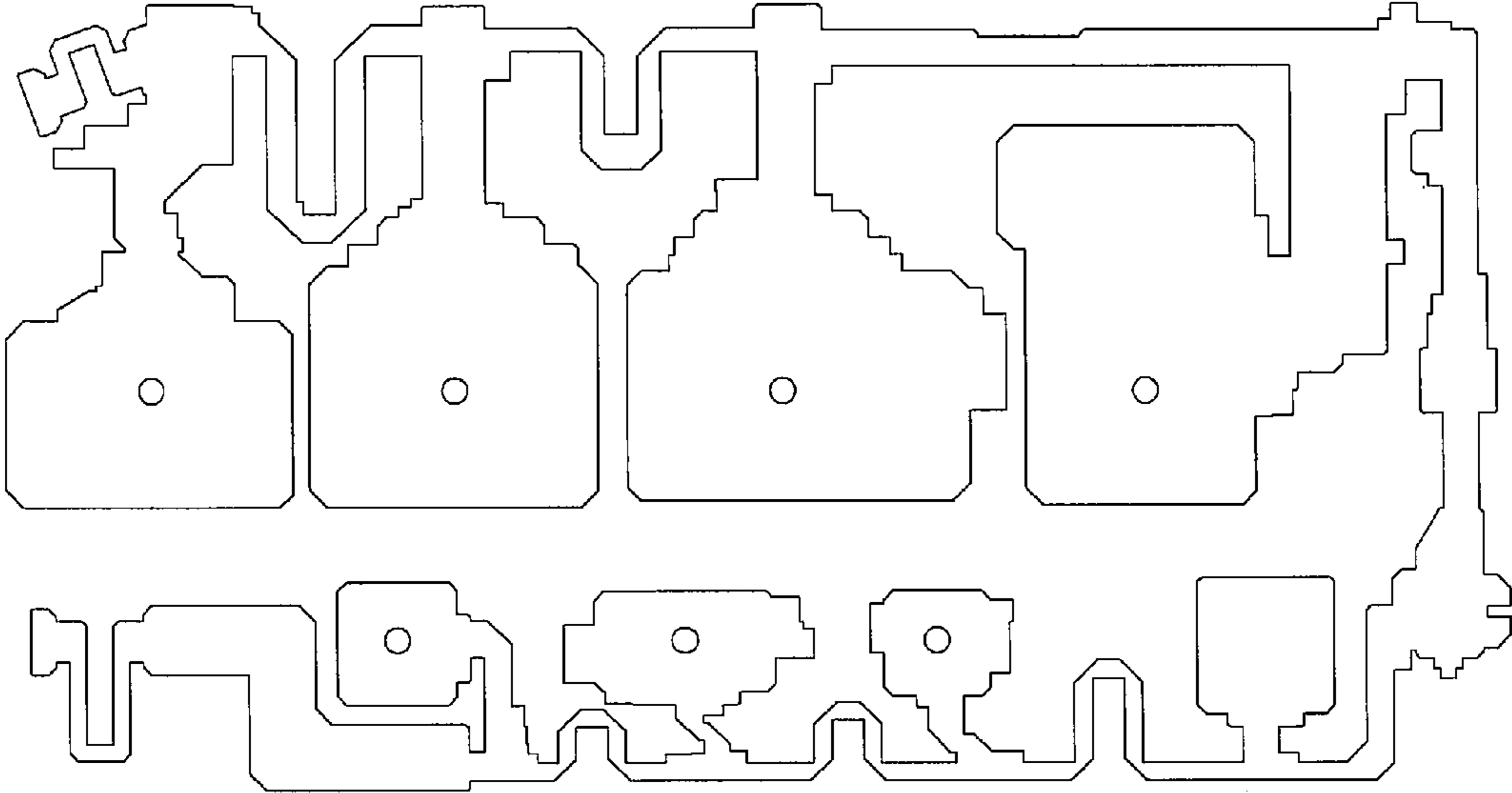

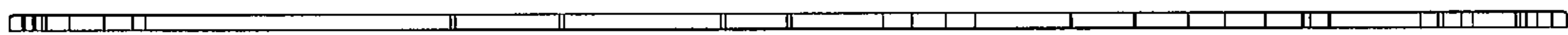
