**DESCRIPTION**

FIG. 1 is a perspective view of a mobile phone showing our new design:

FIG. 2 is a front elevation view thereof;

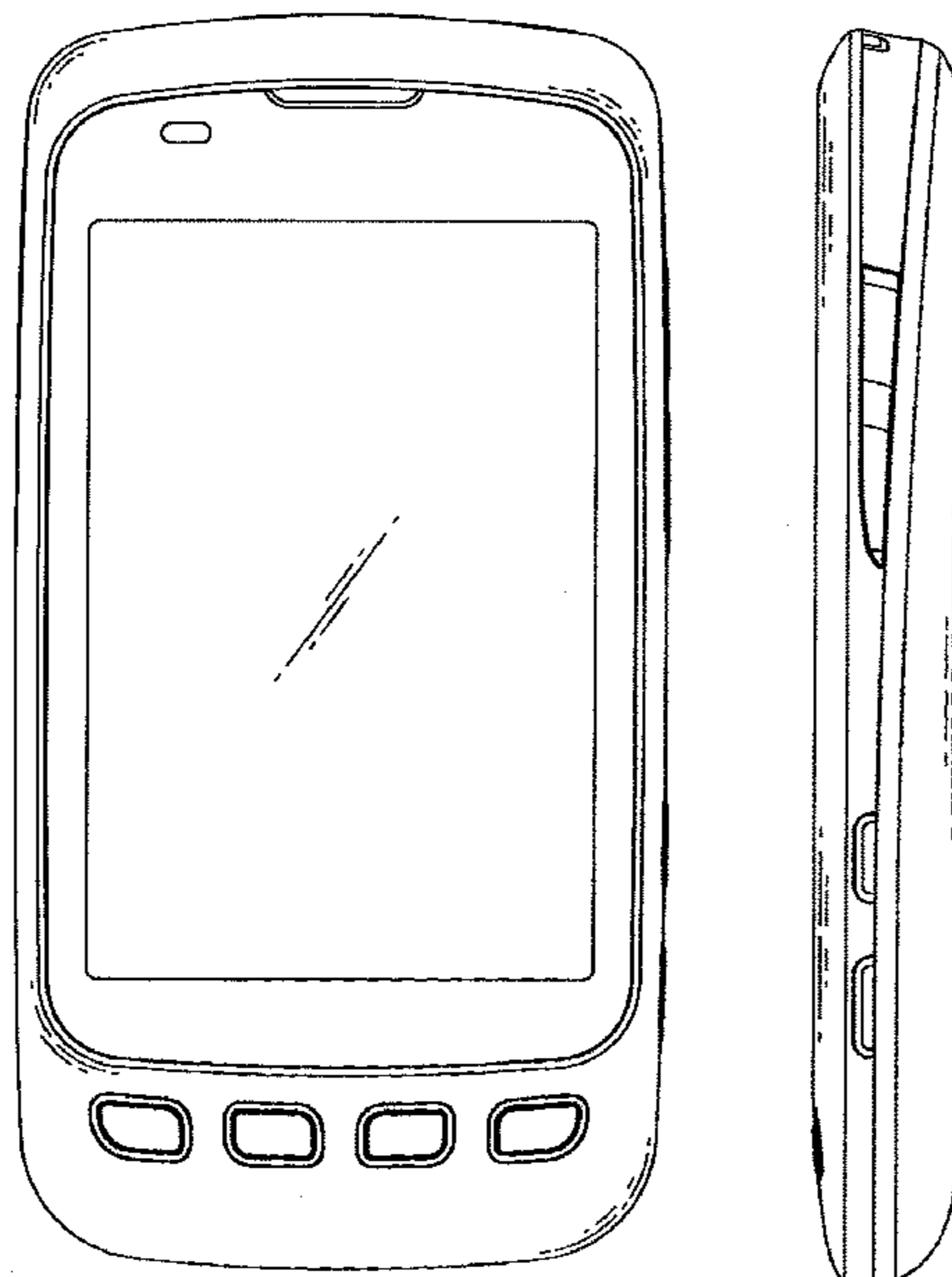

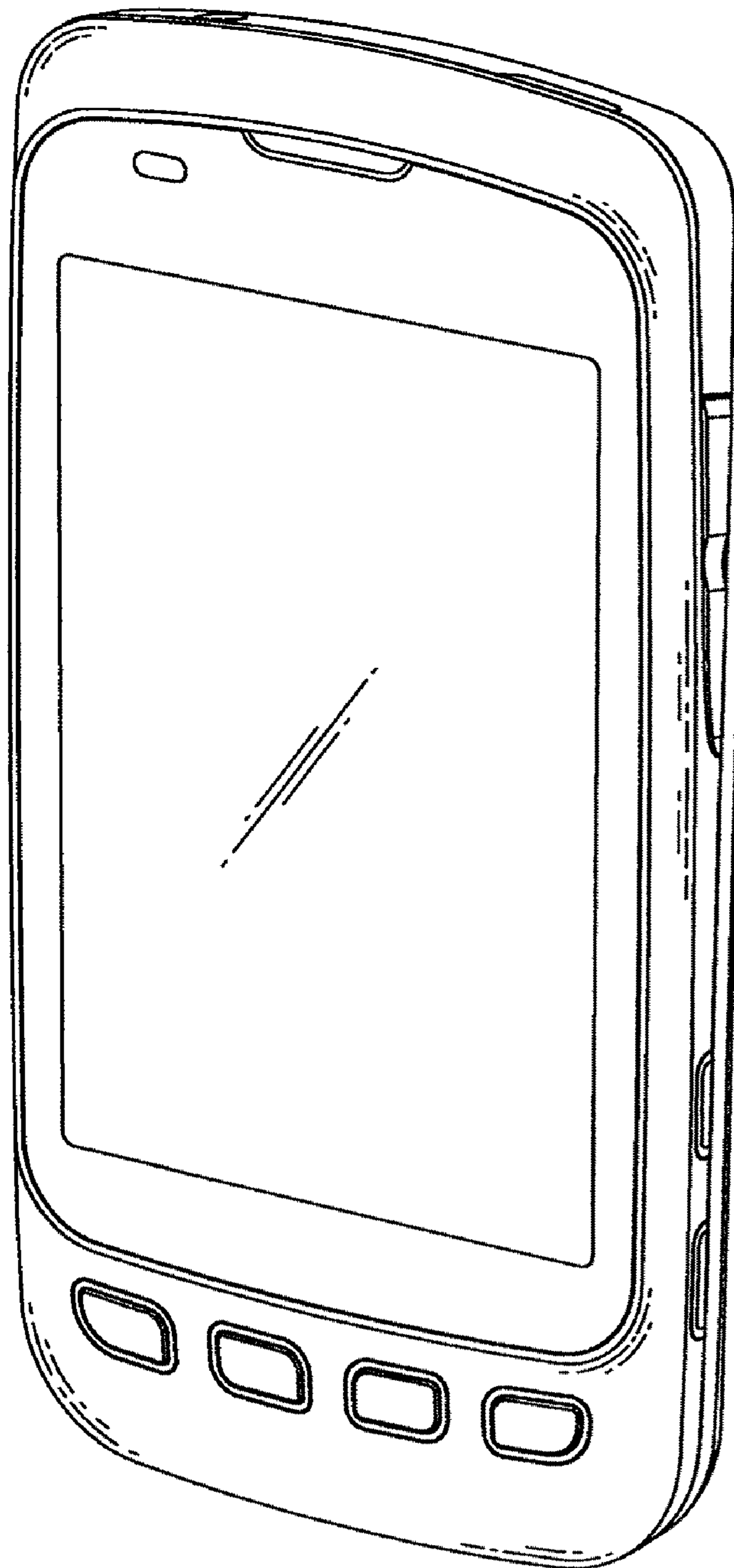

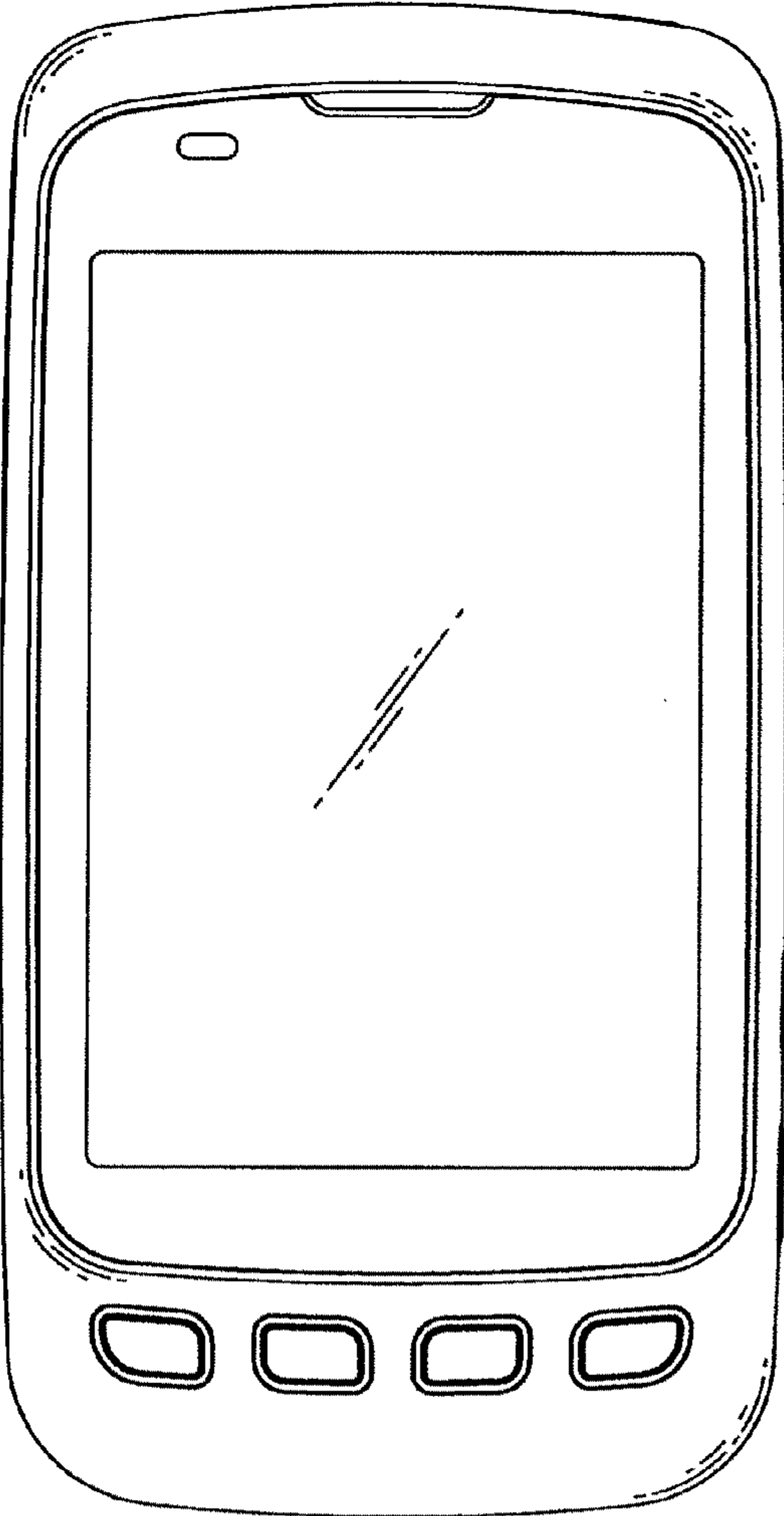

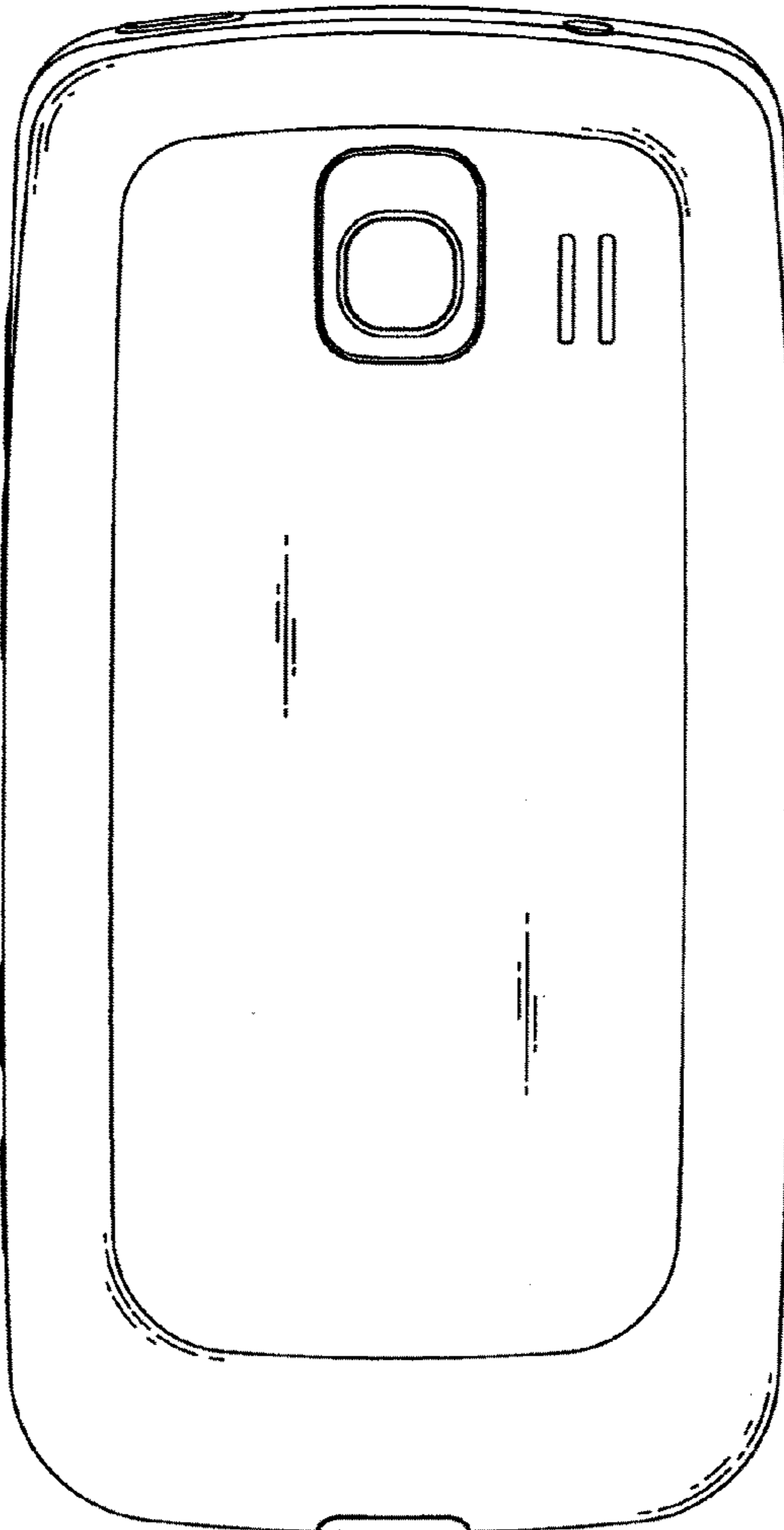

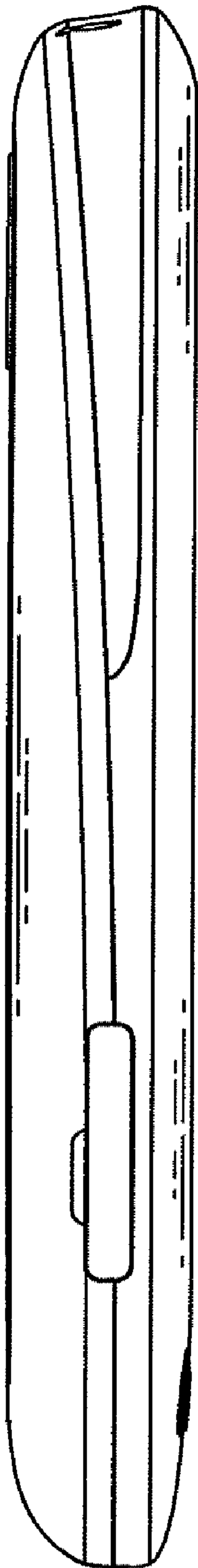

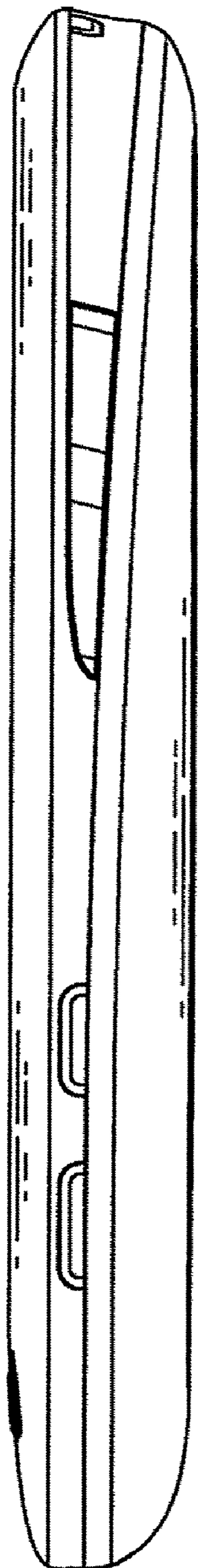

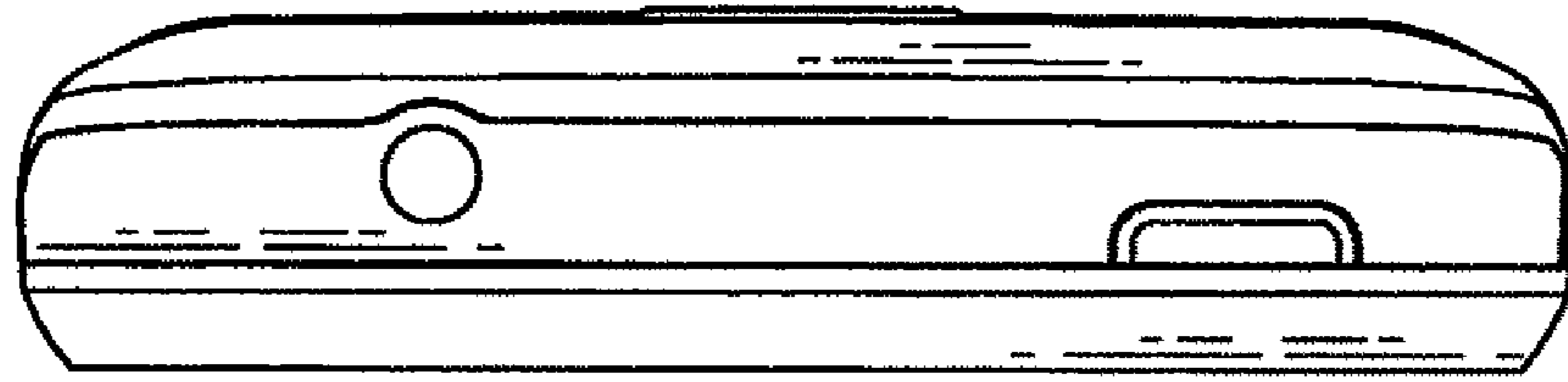
