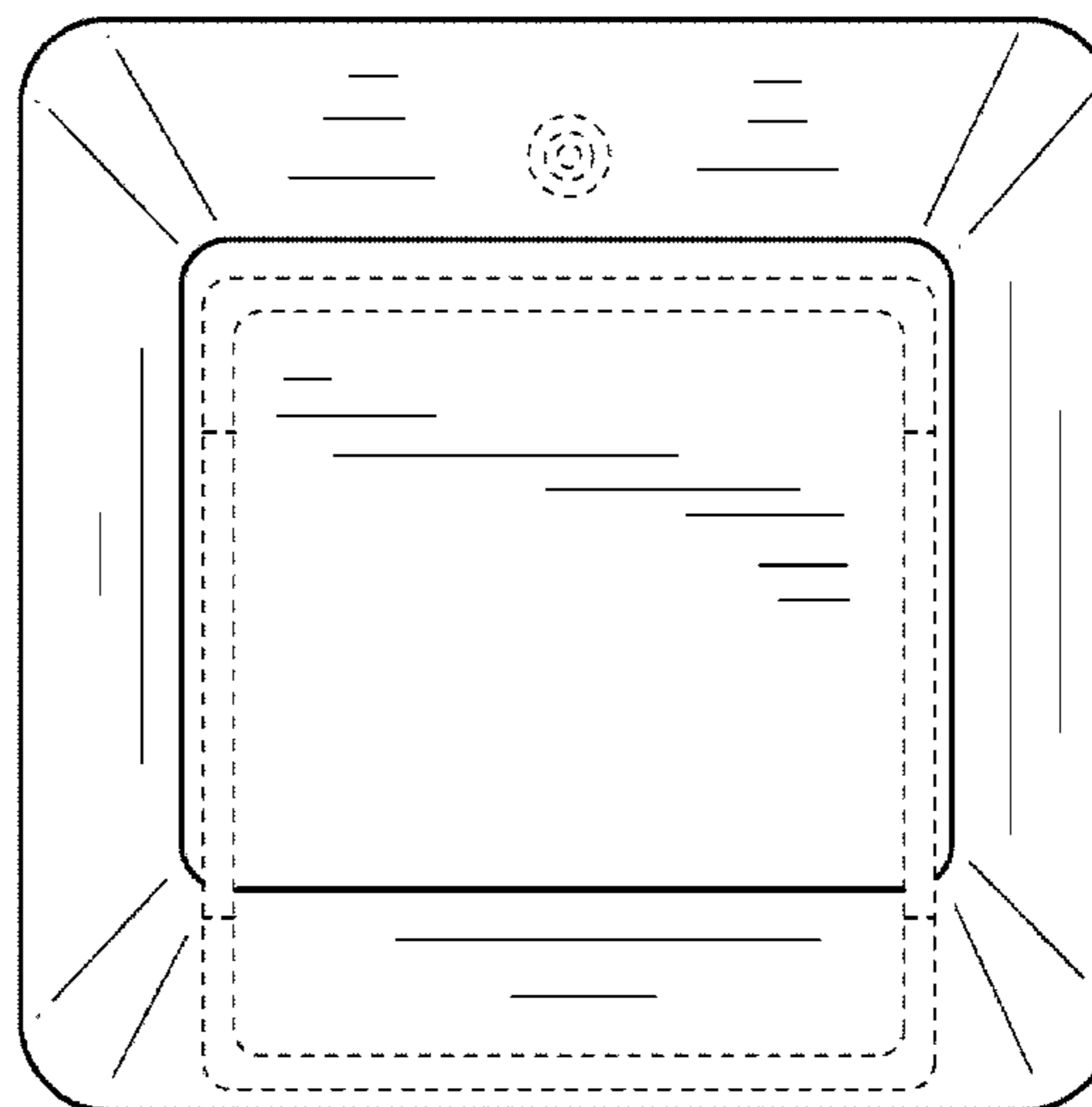
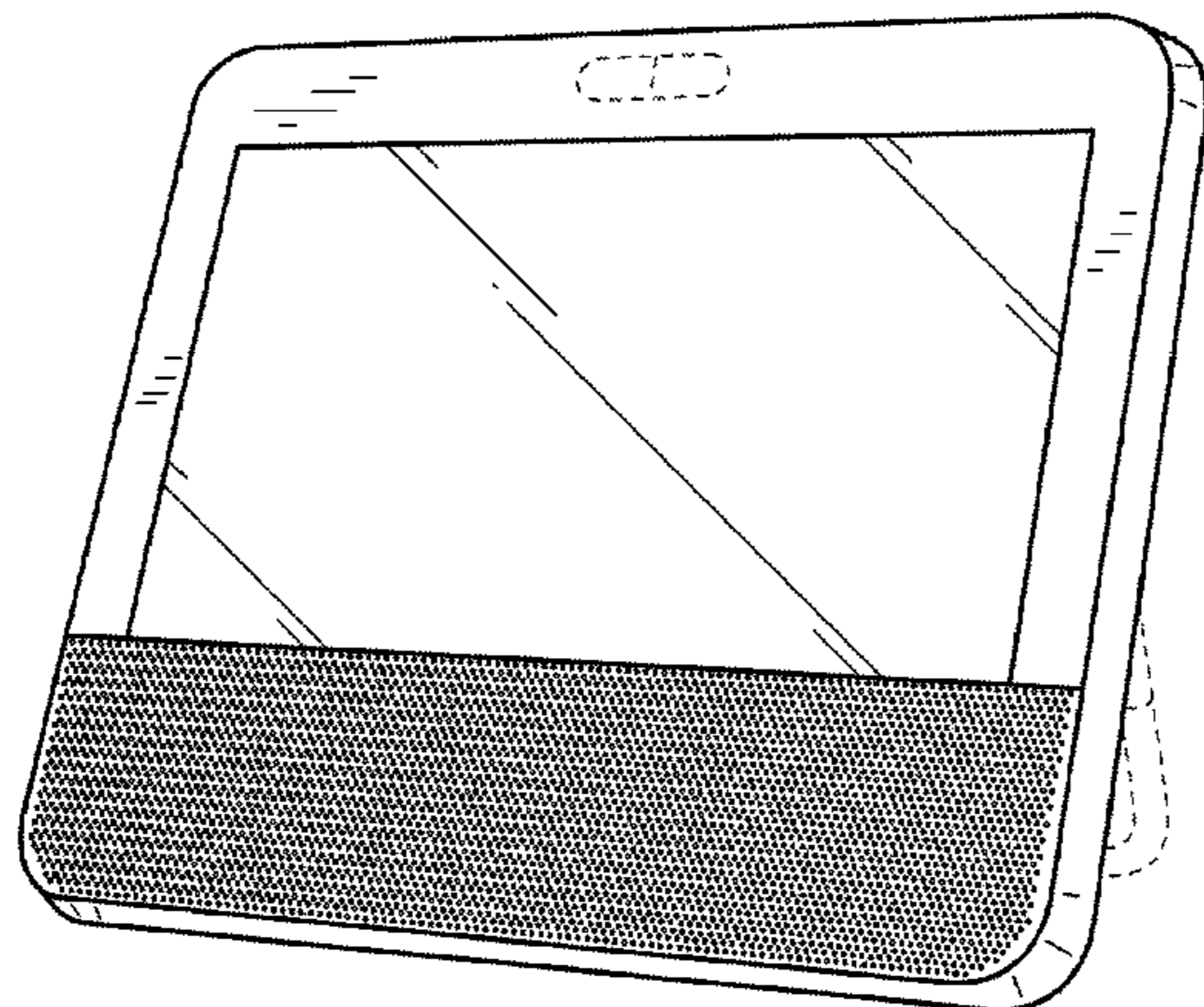
(57) **CLAIM**

The ornamental design for a communications tablet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a communications tablet showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a first side elevational view thereof;
FIG. 5 is a second side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is another first side elevation view in which the disclaimed stand is shown in an alternate orientation relative to the claimed portion of the communications tablet.
The broken lines shown represent unclaimed subject matter and form no part of the claimed design.

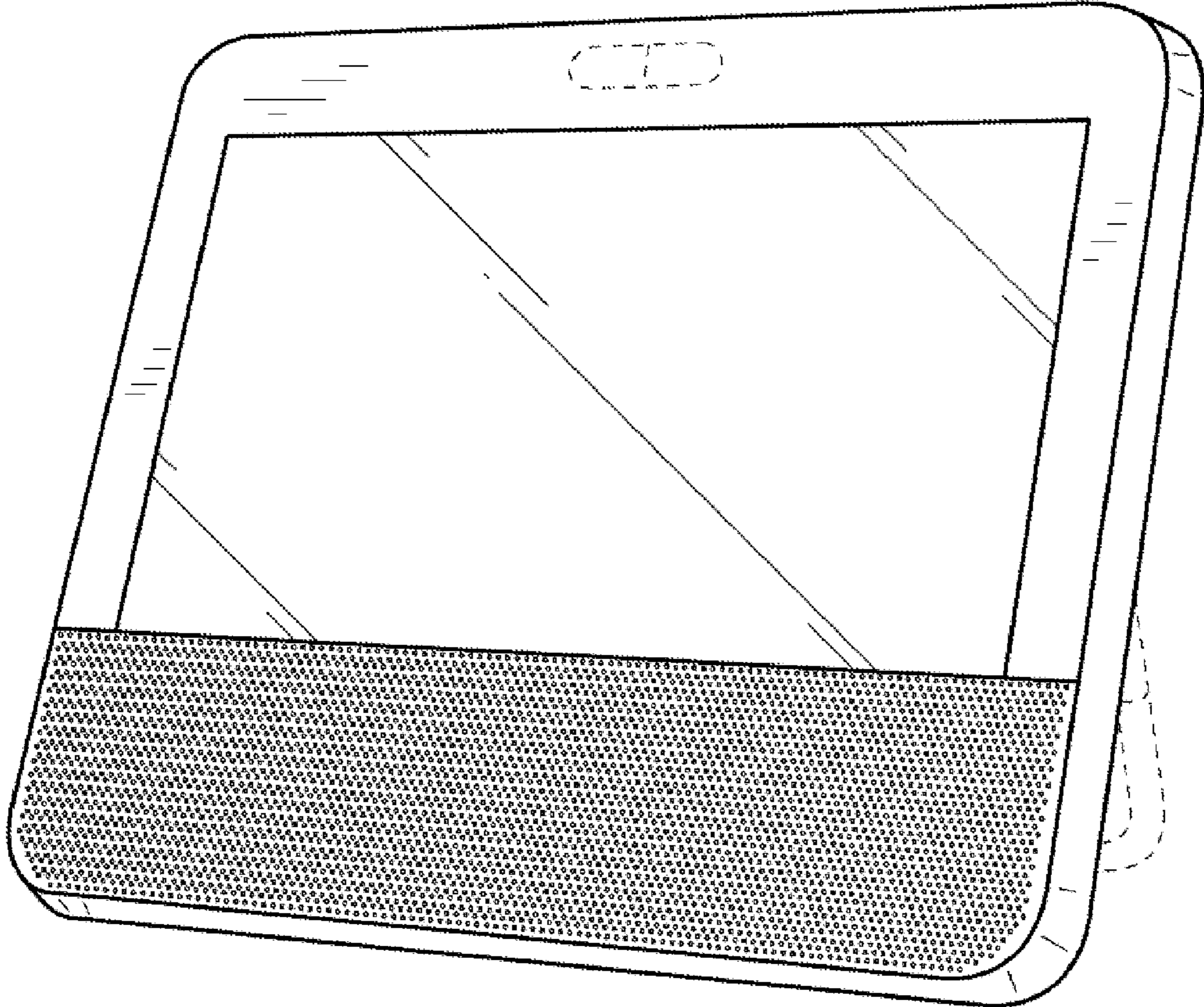

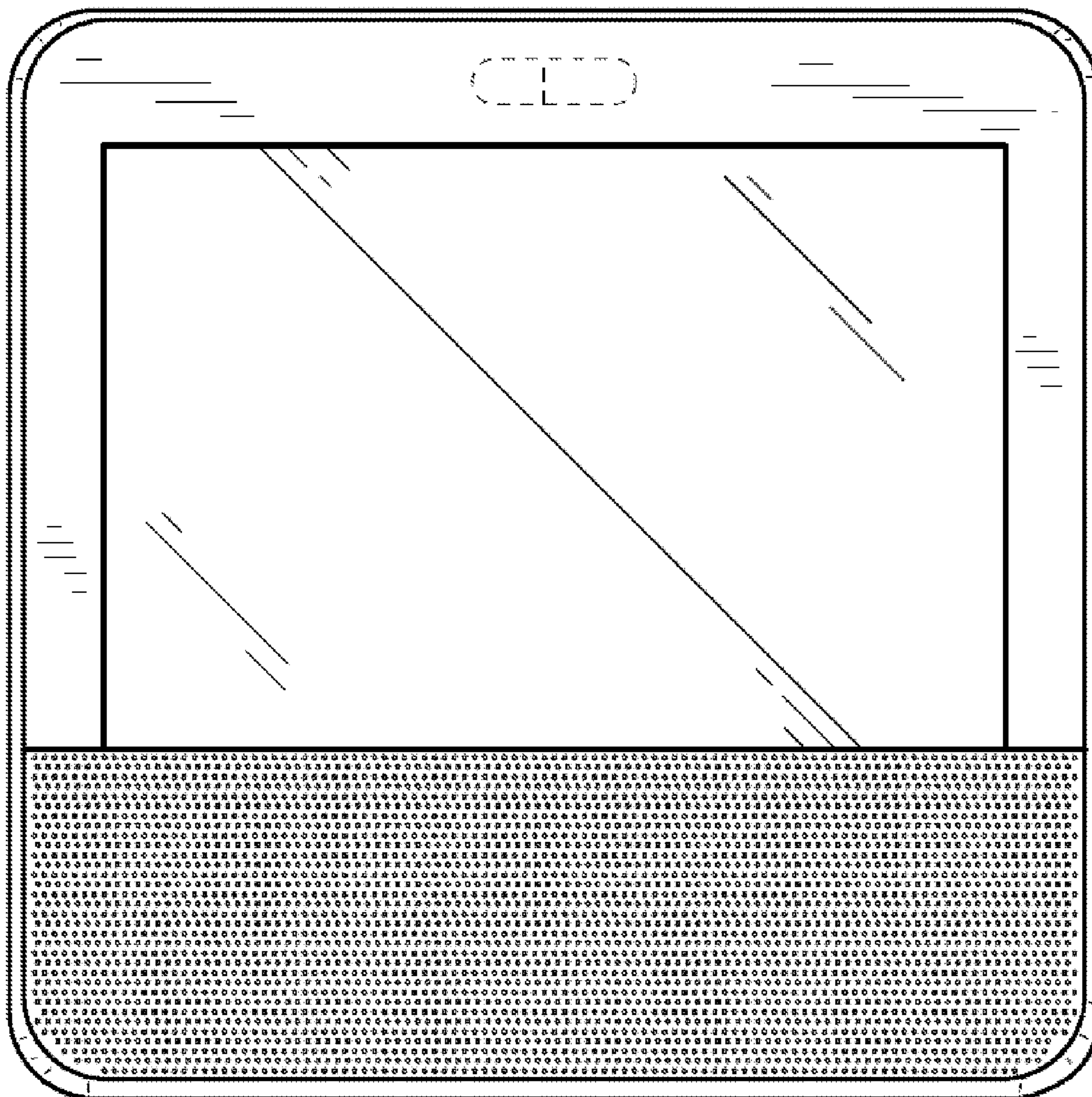

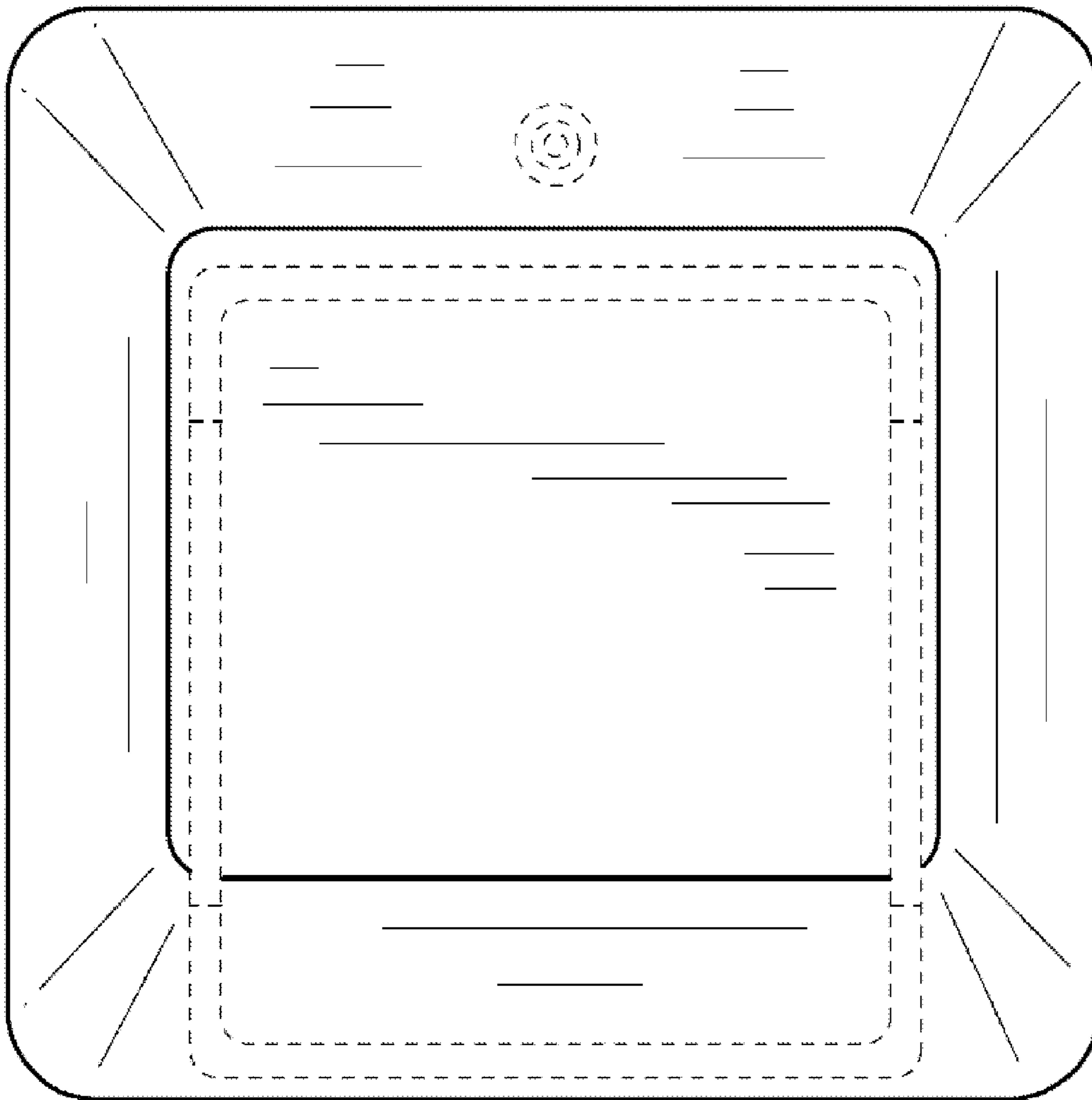

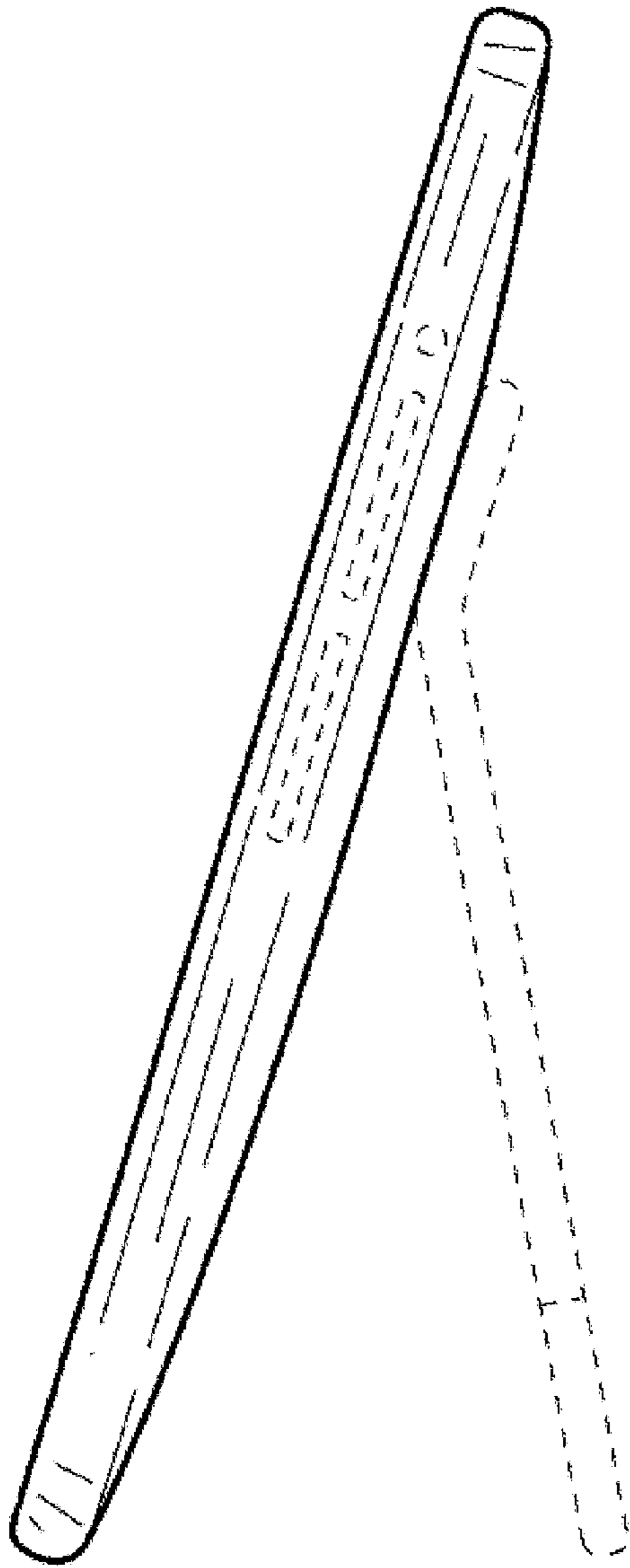

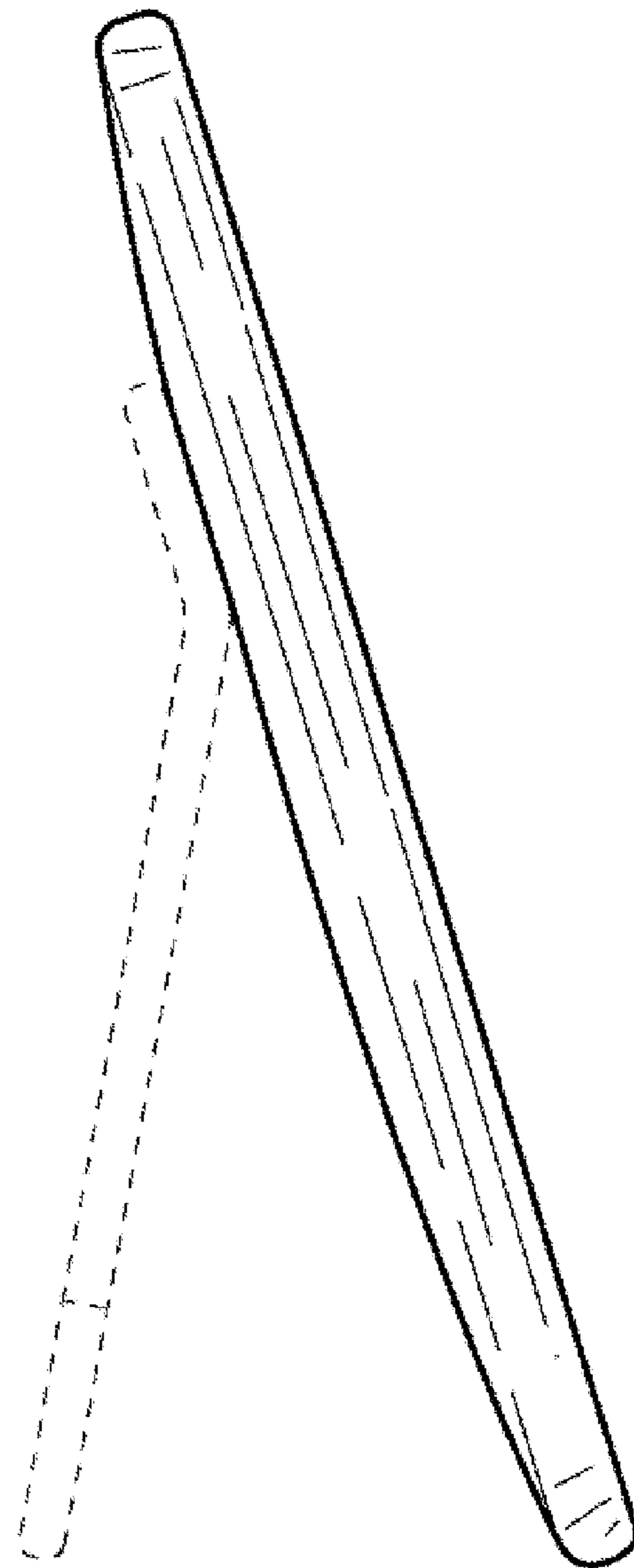

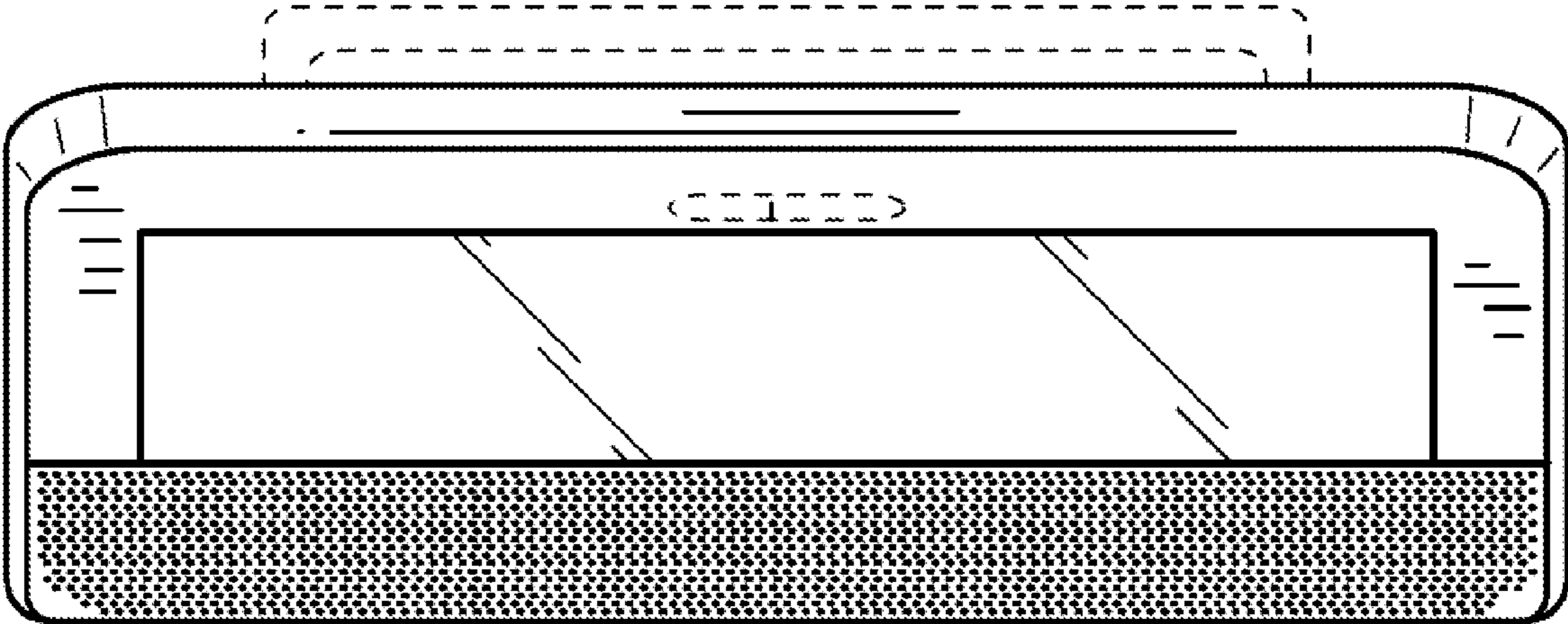

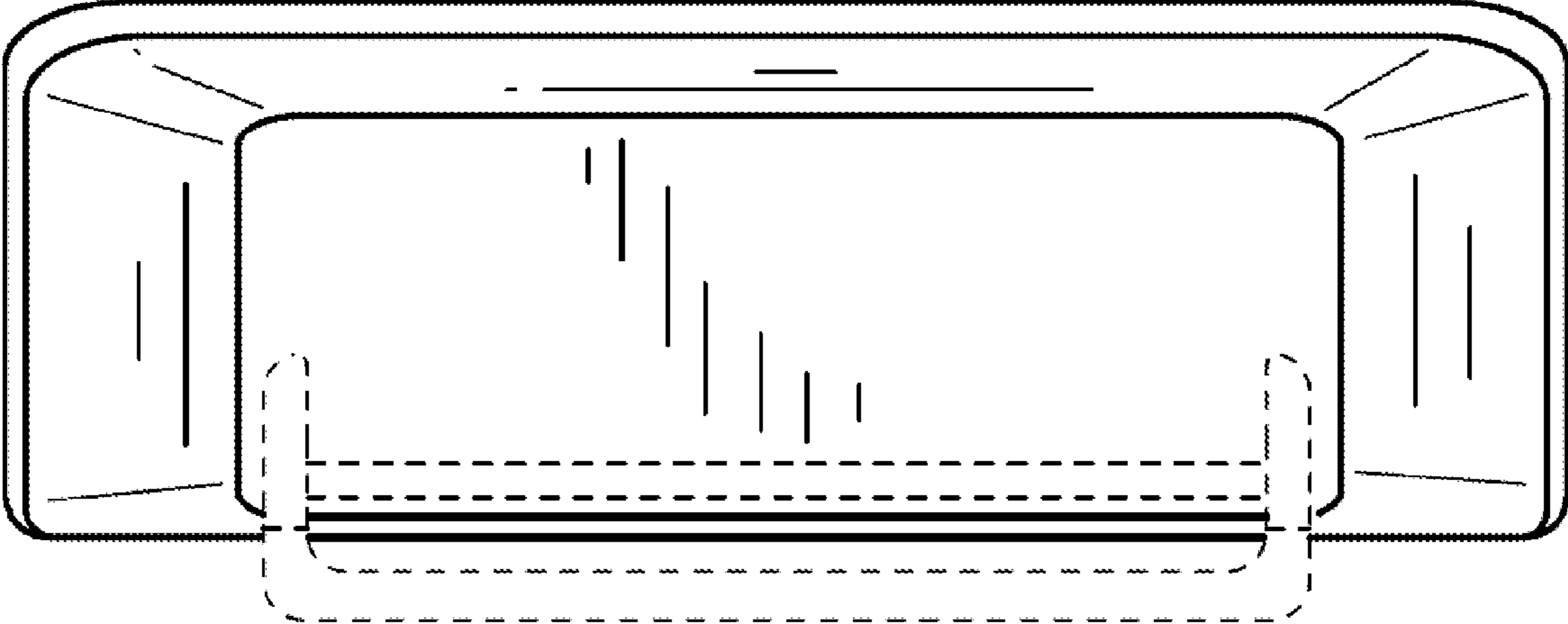

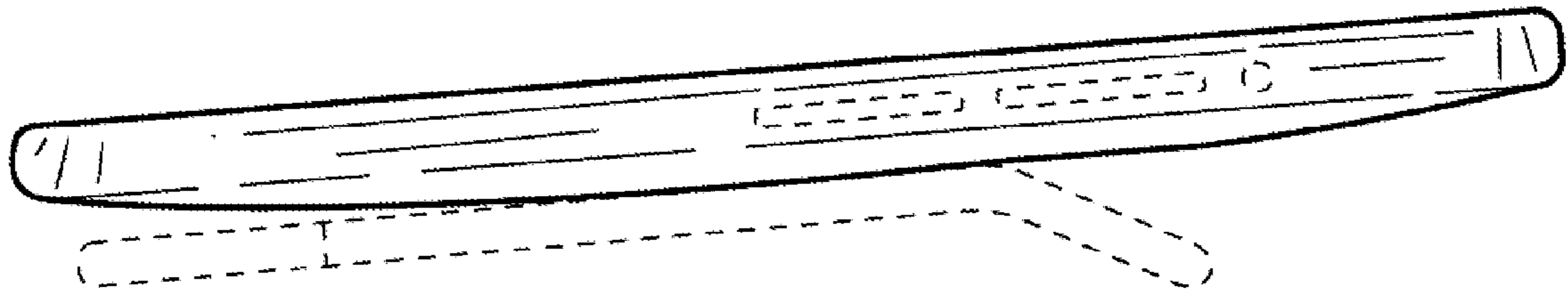
