FIG. 3 is another side view thereof;

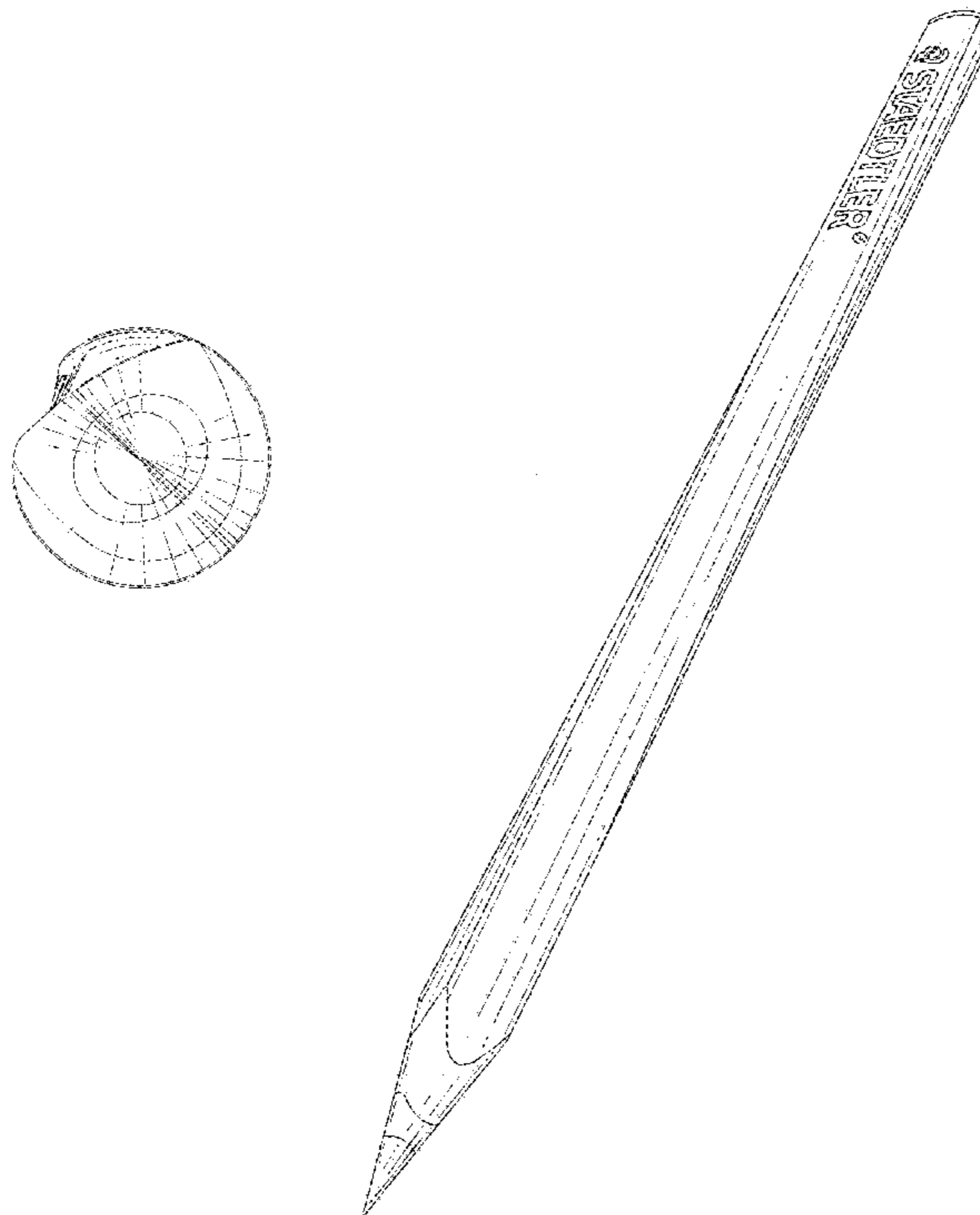
FIG. 4 is another side view thereof;

FIG. 5 is an enlarged front view thereof;

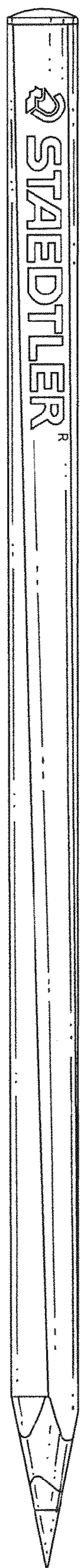
FIG. 6 is an enlarged rear view thereof; and,

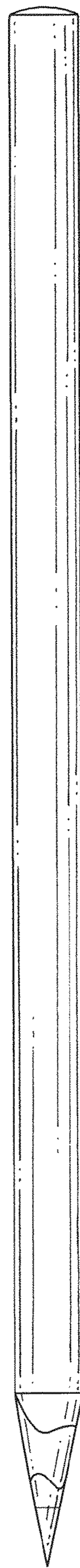

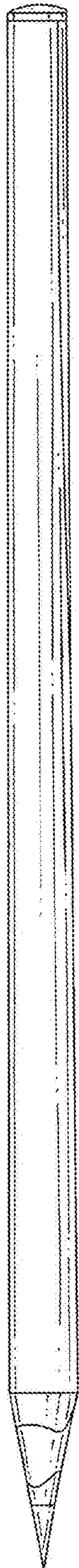
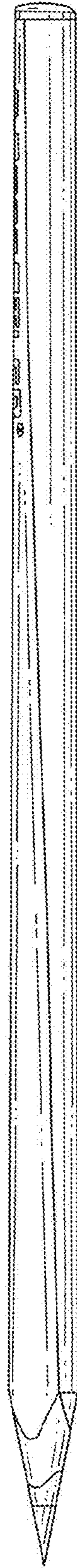
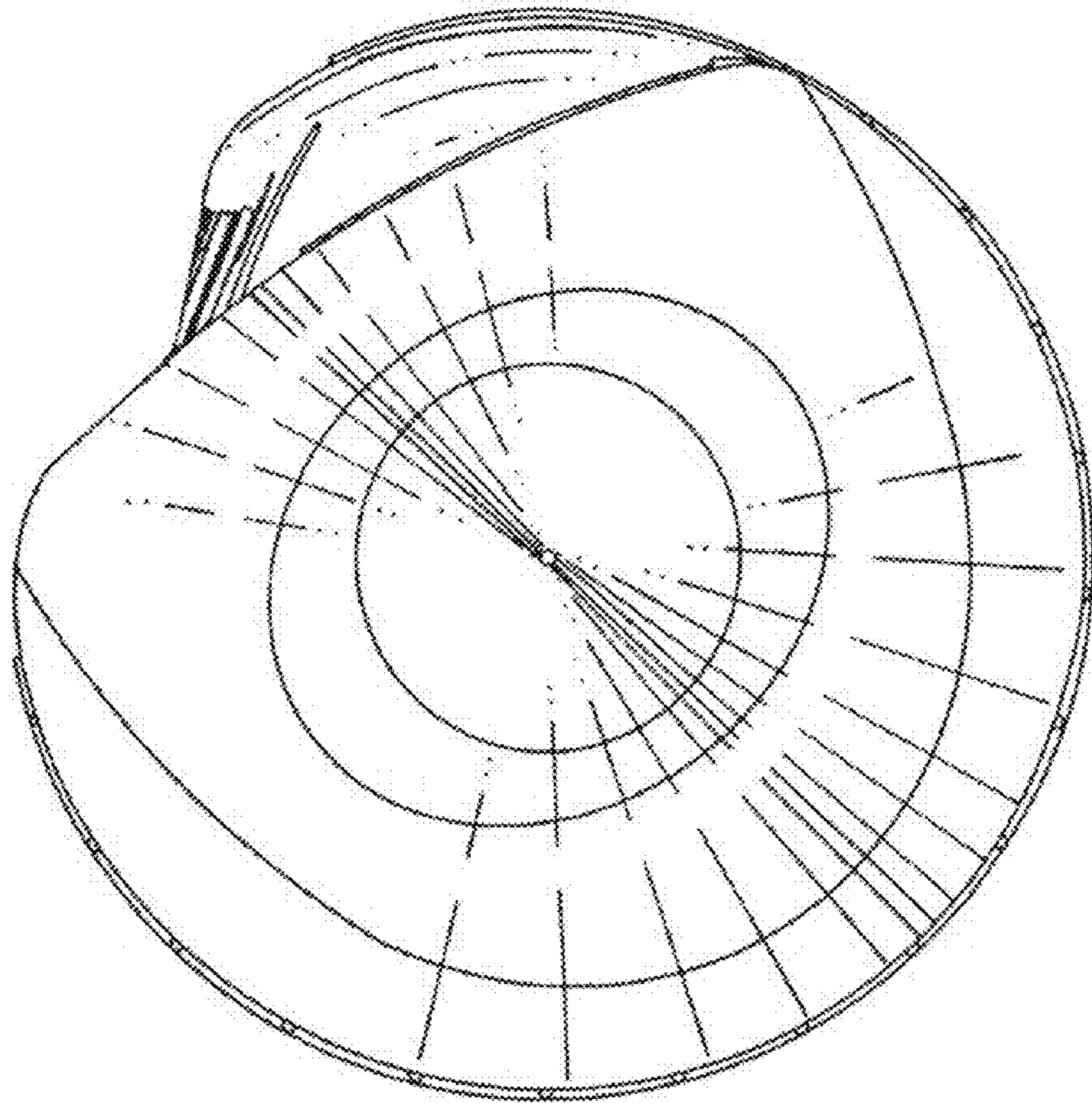
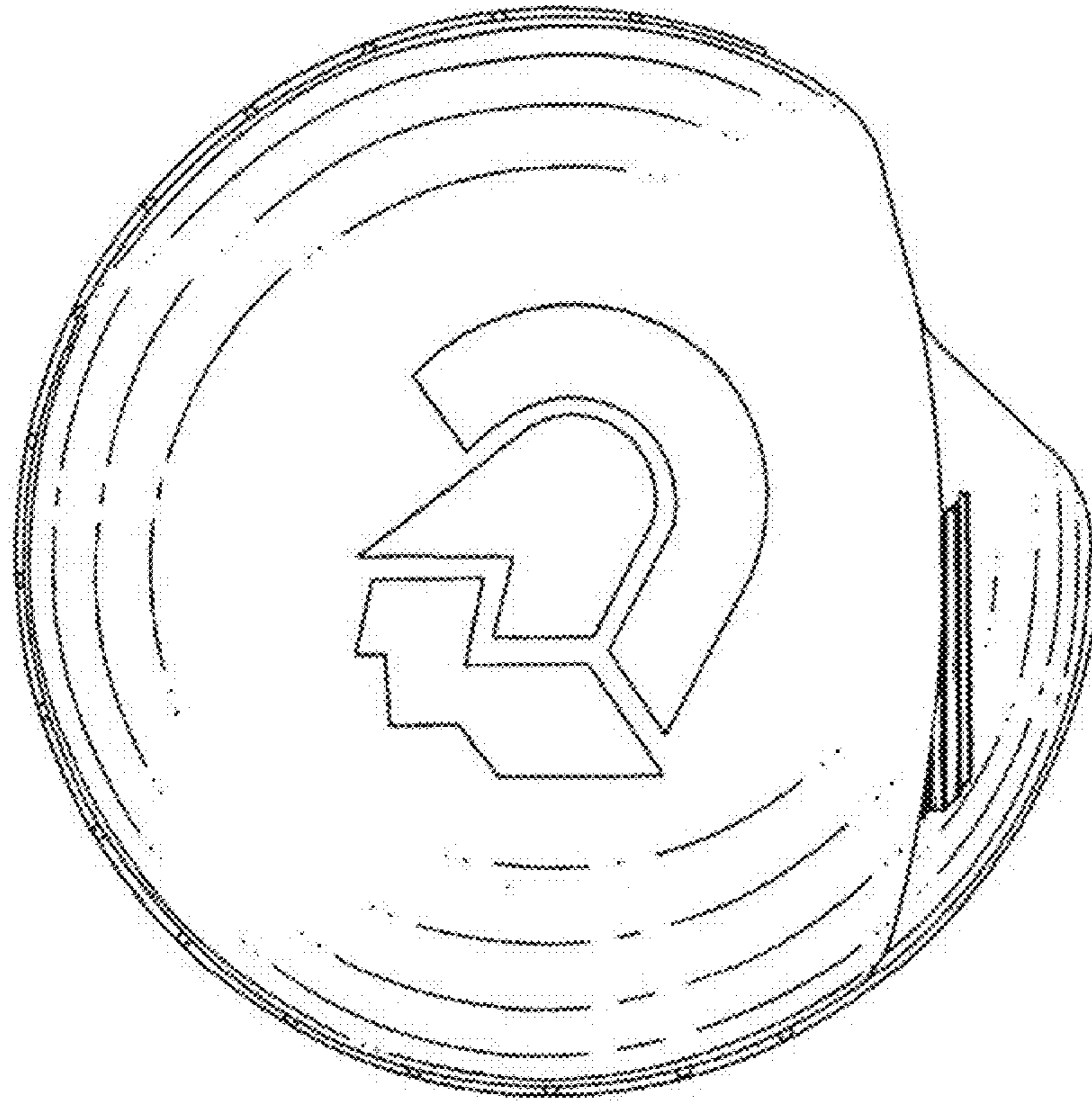

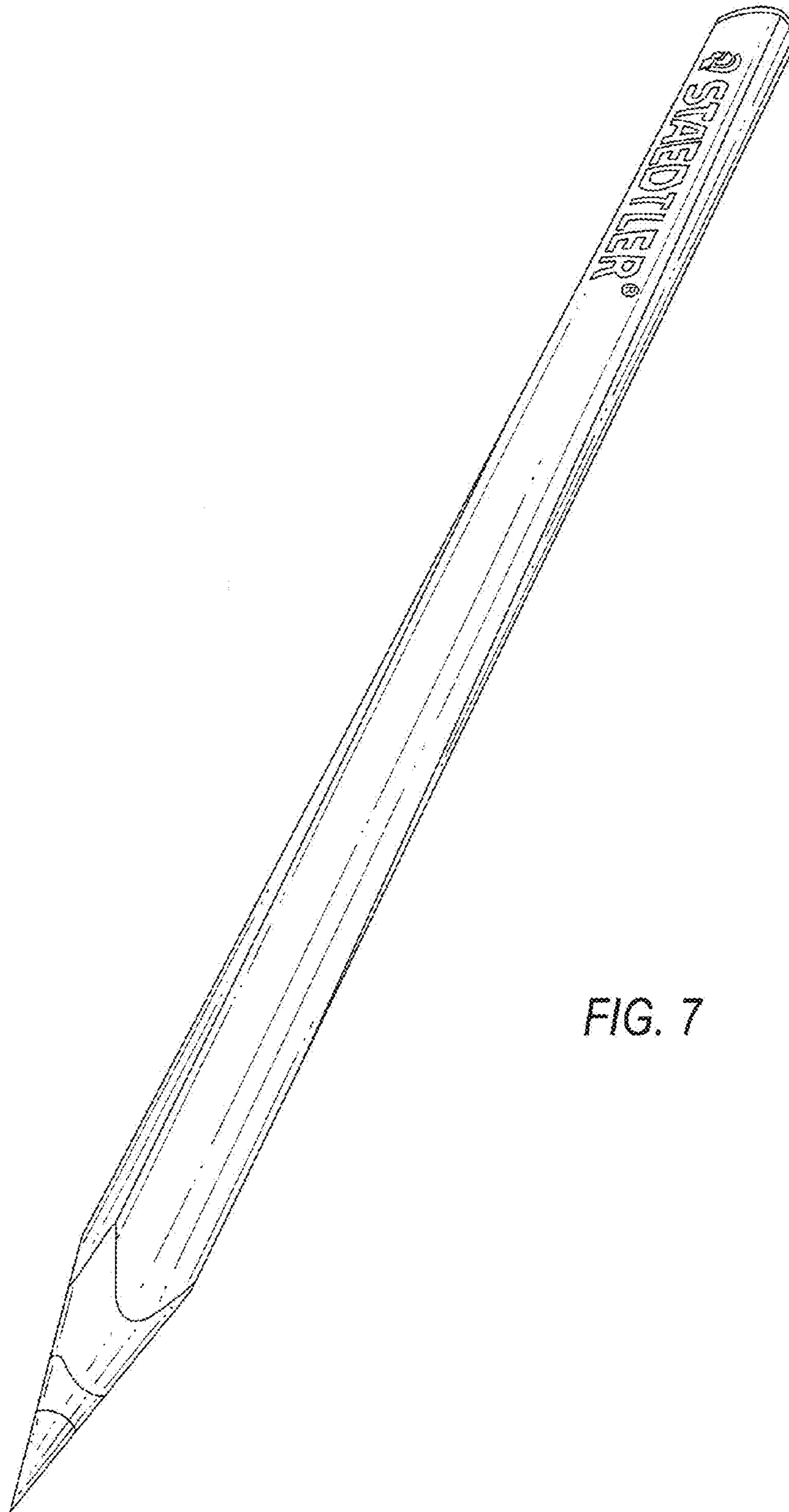
