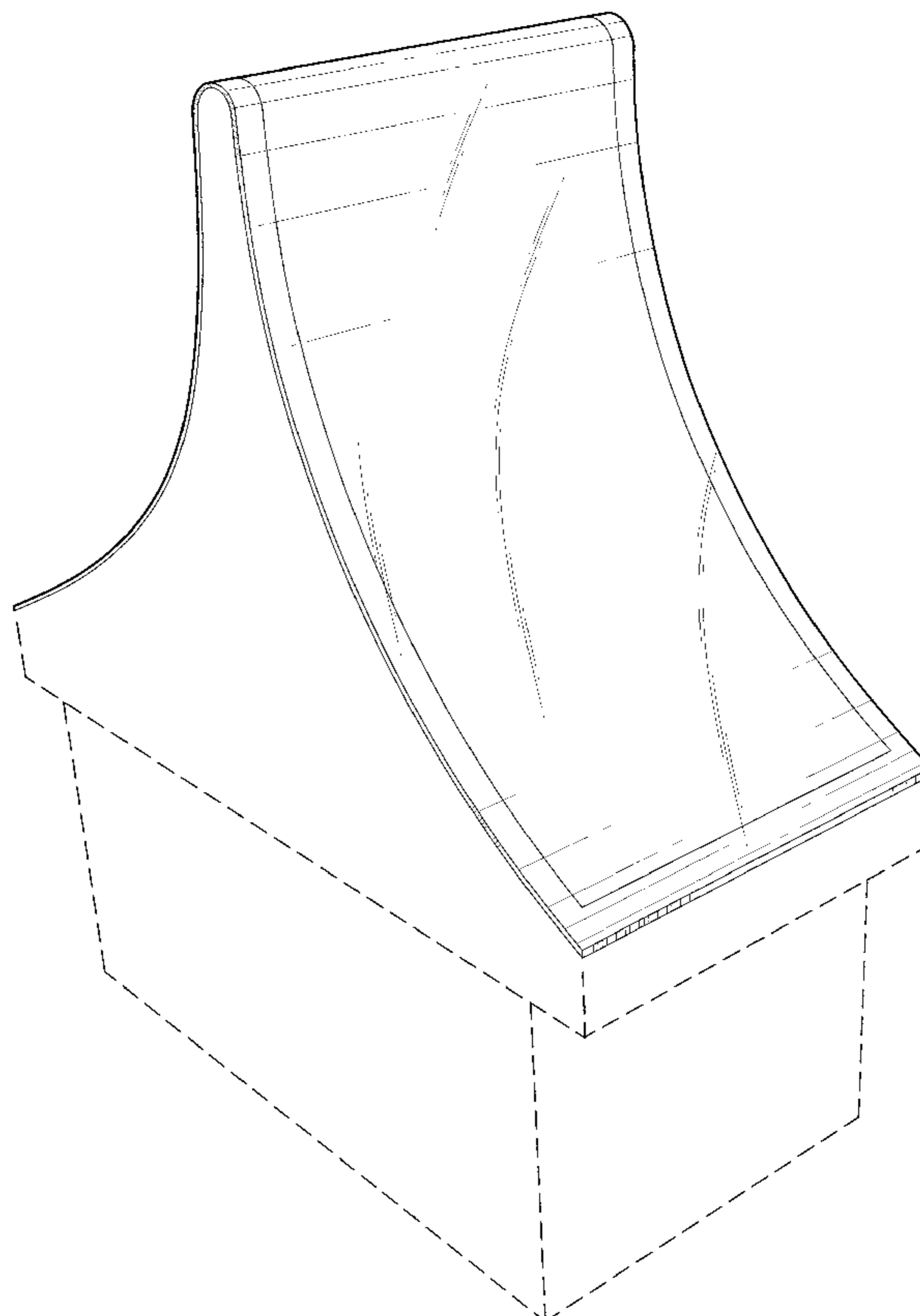
The broken lines showing portions of a terminal cabinet to support the display of the present invention in FIGS. 1-4 are for illustrative purposes only and form no part of the claimed design.

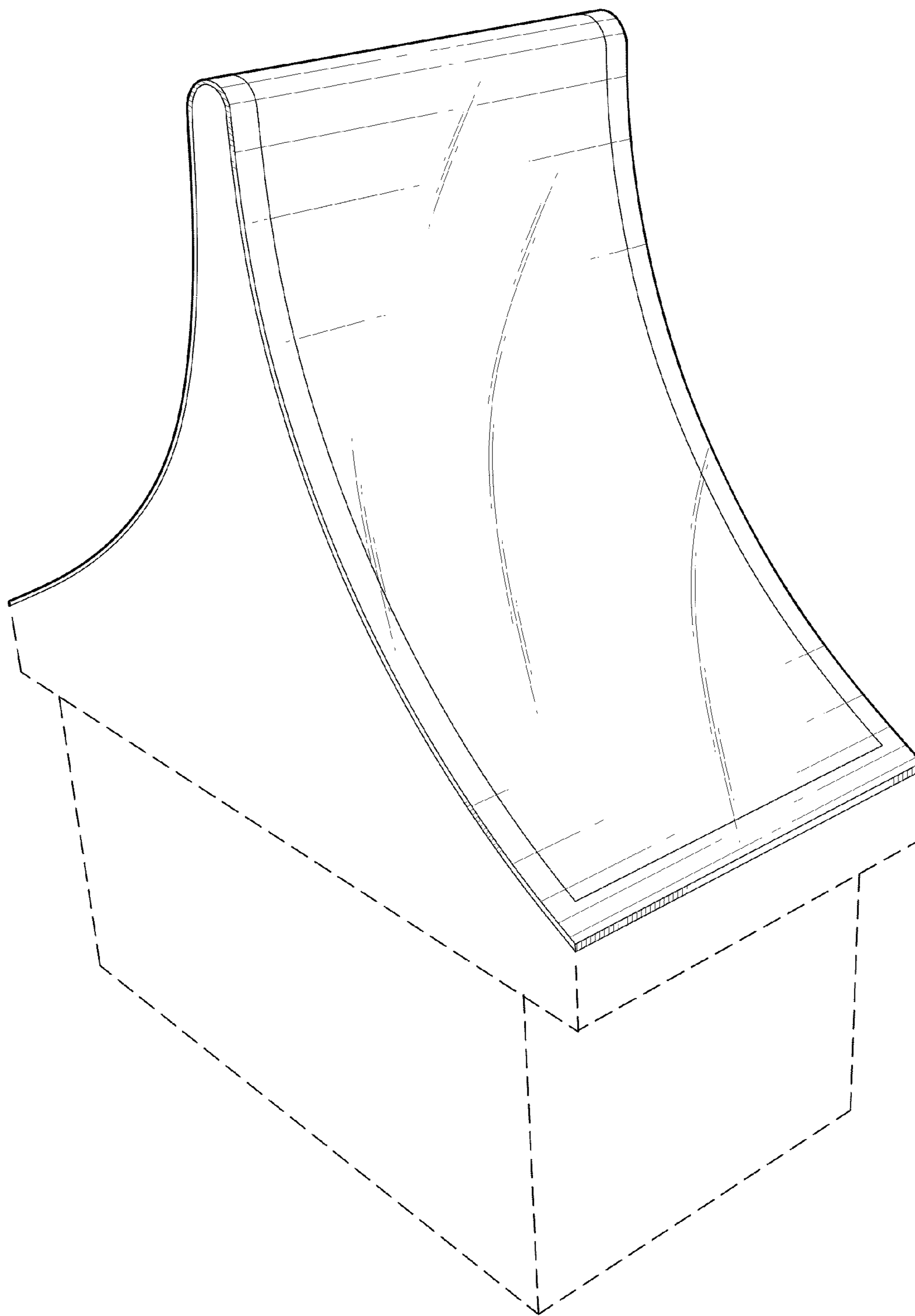

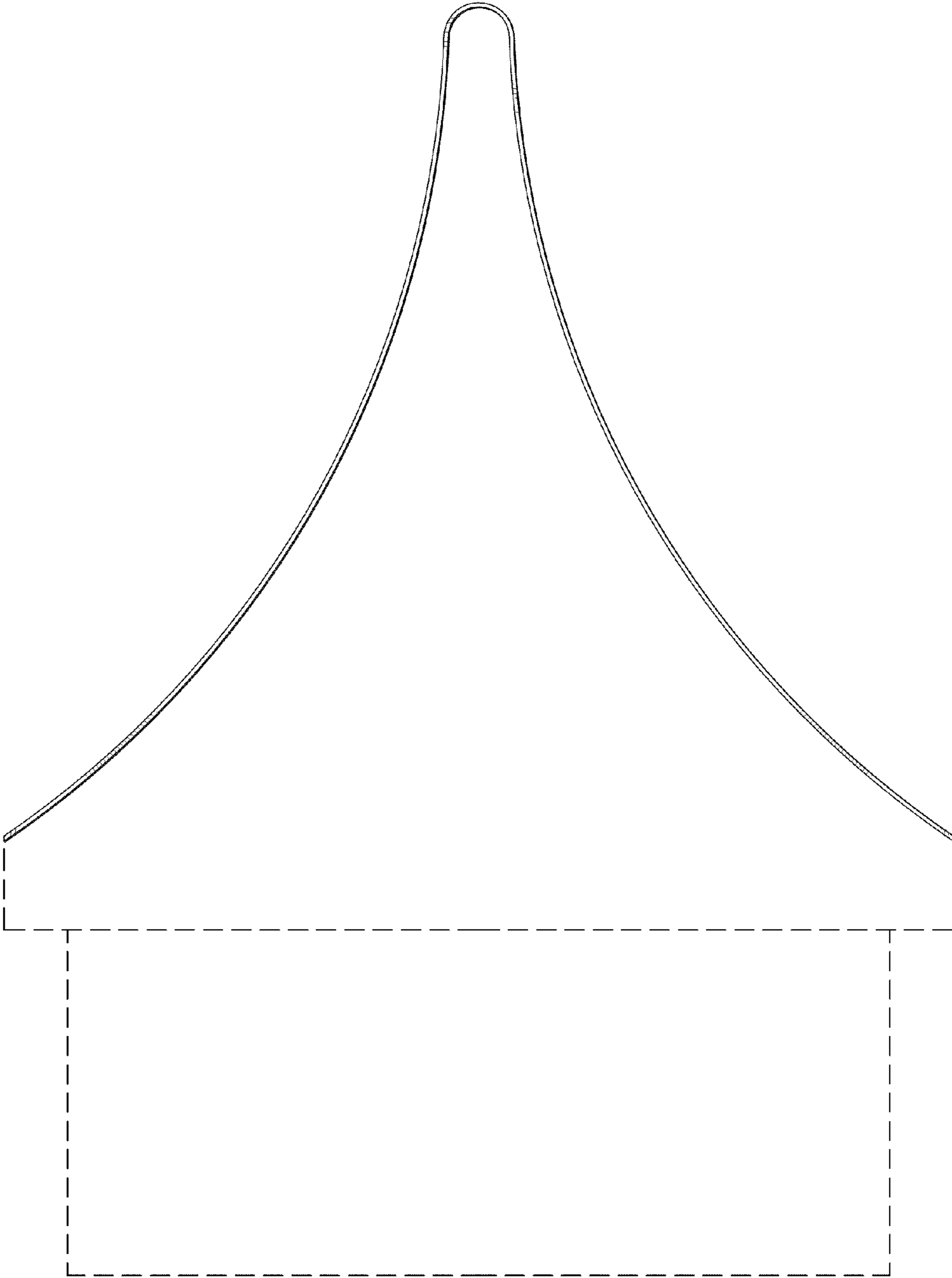

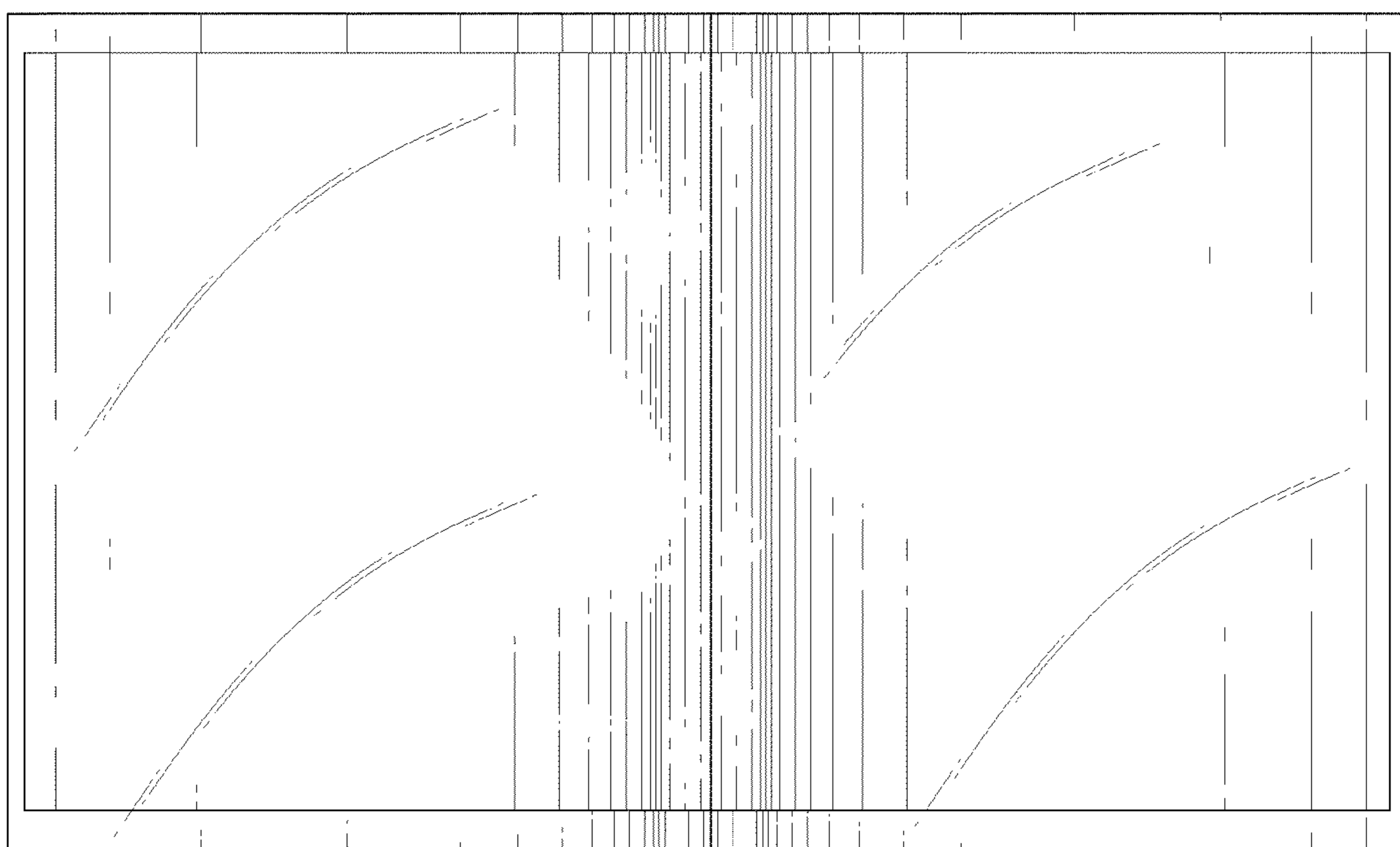

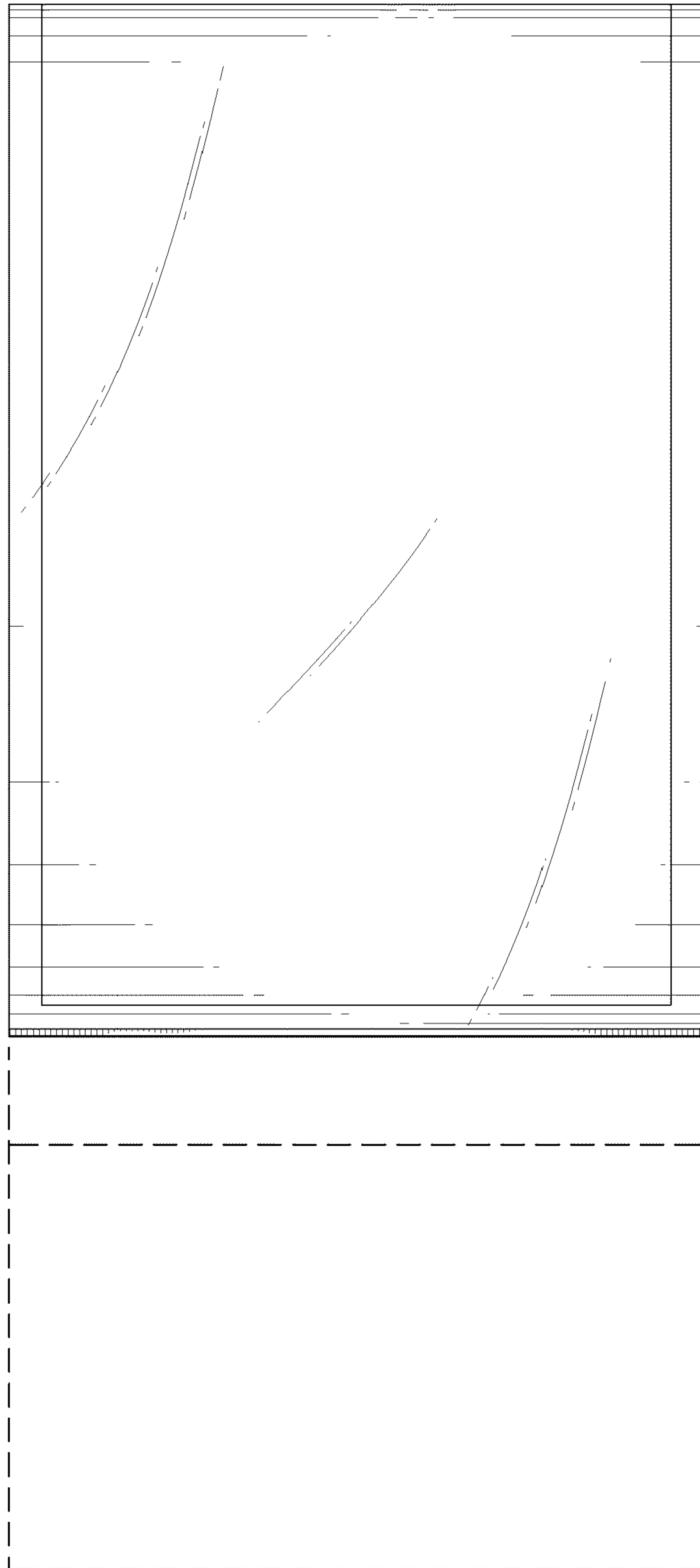
