FIG. 6 is a top view of the display of FIG. 1.

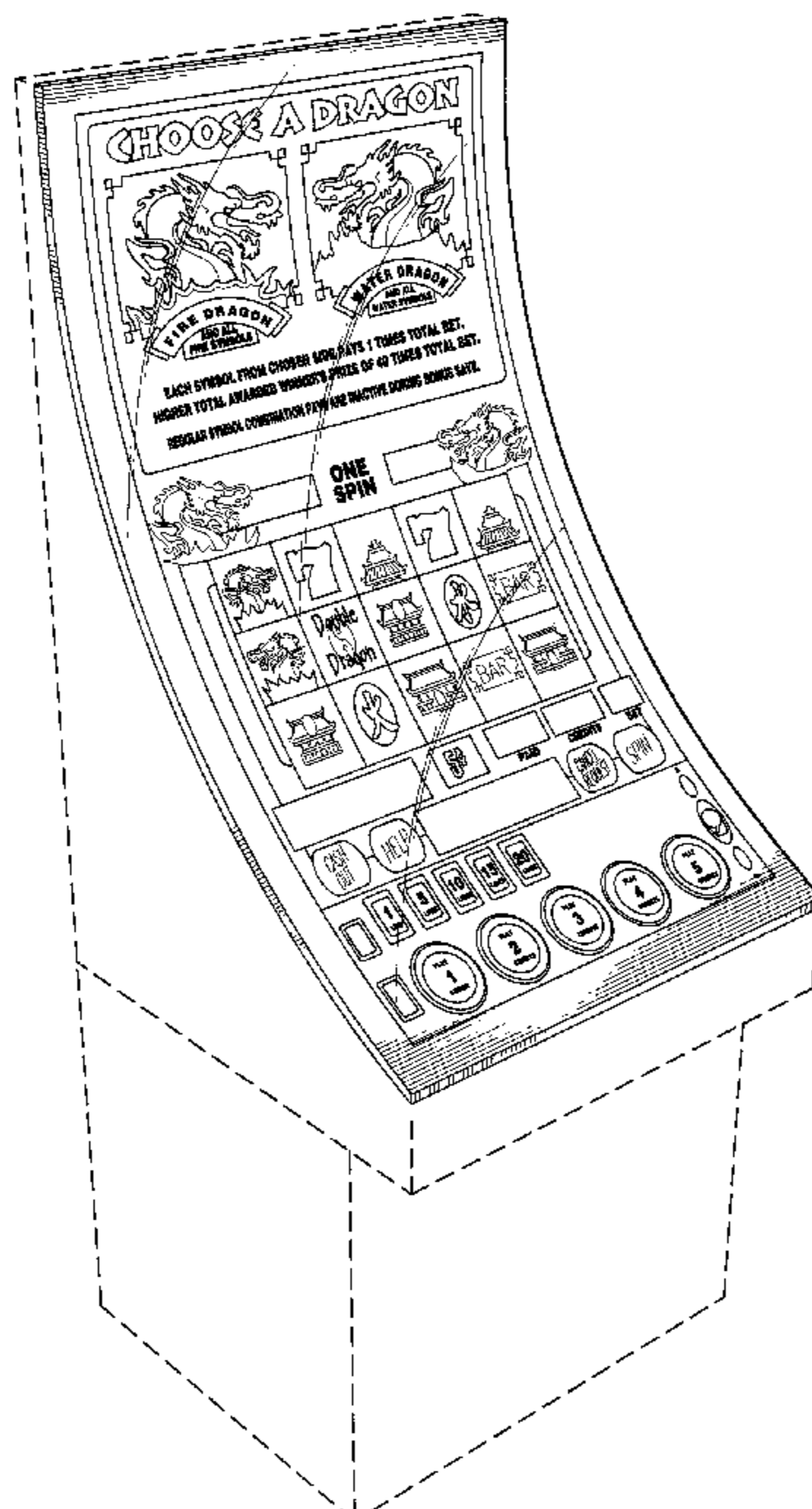
The broken lines showing portions of a terminal cabinet to support the display of the present invention in FIGS. 1-6 are for illustrative purposes only and form no part of the claimed design.

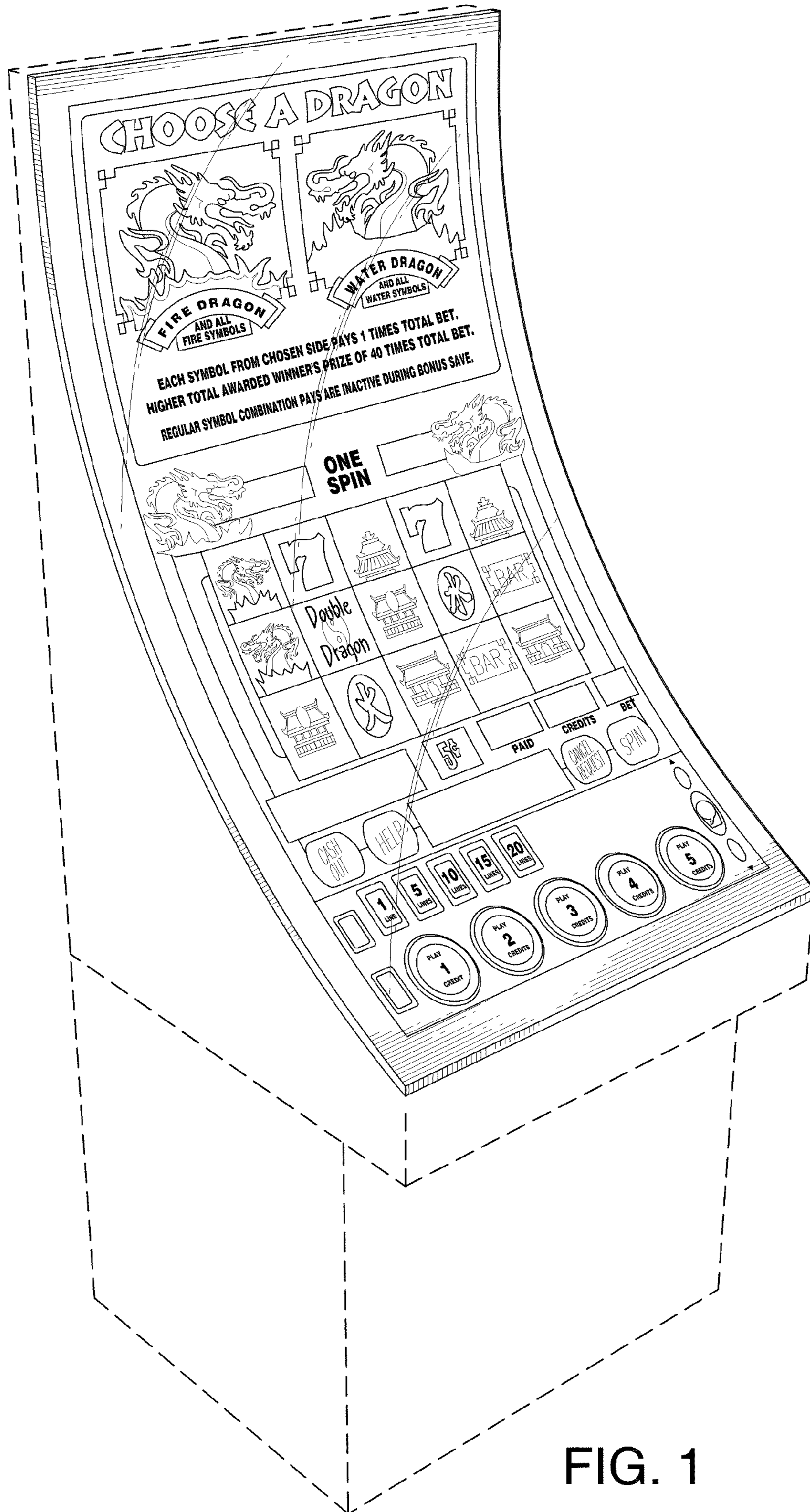

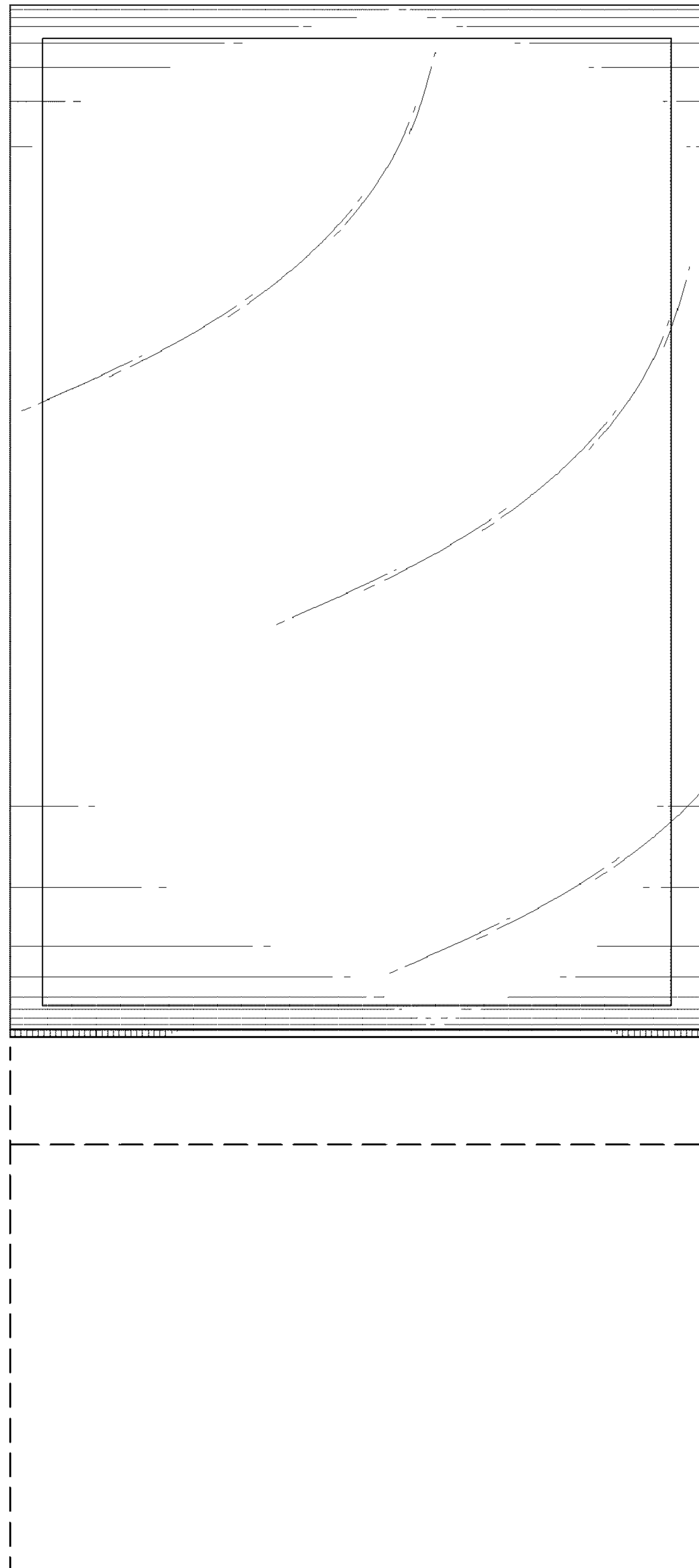

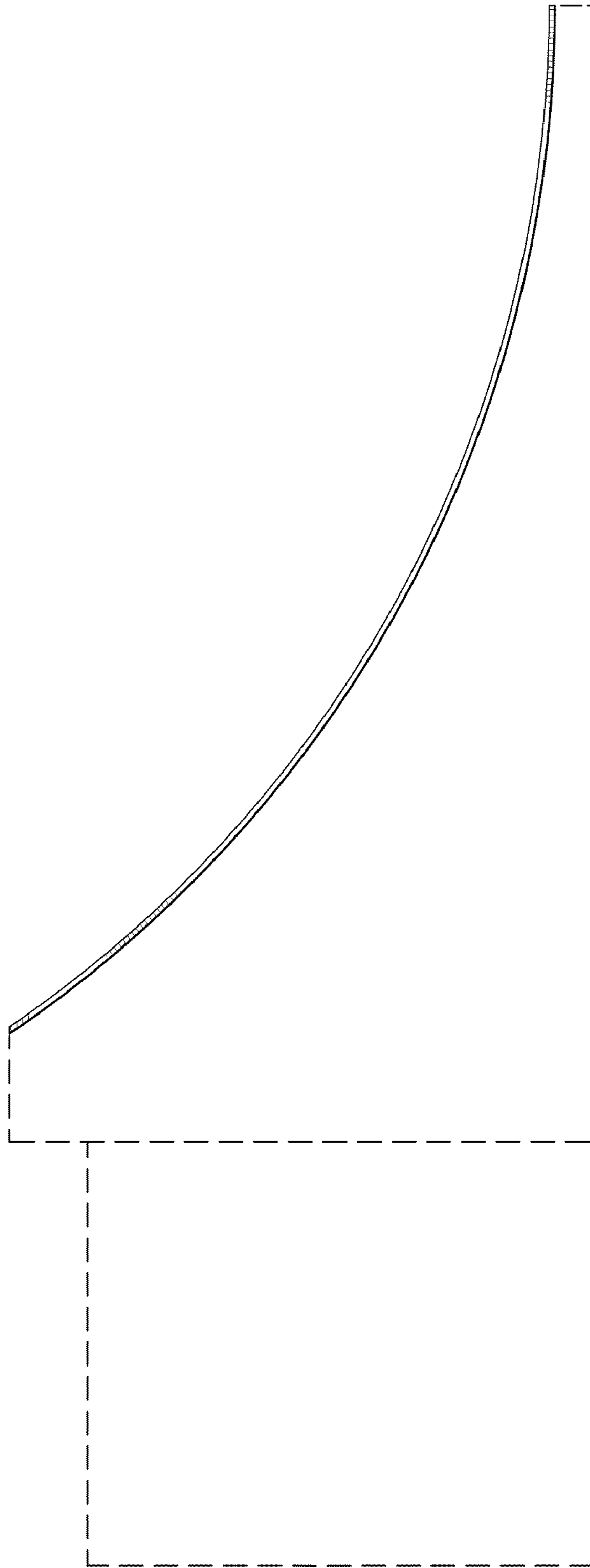

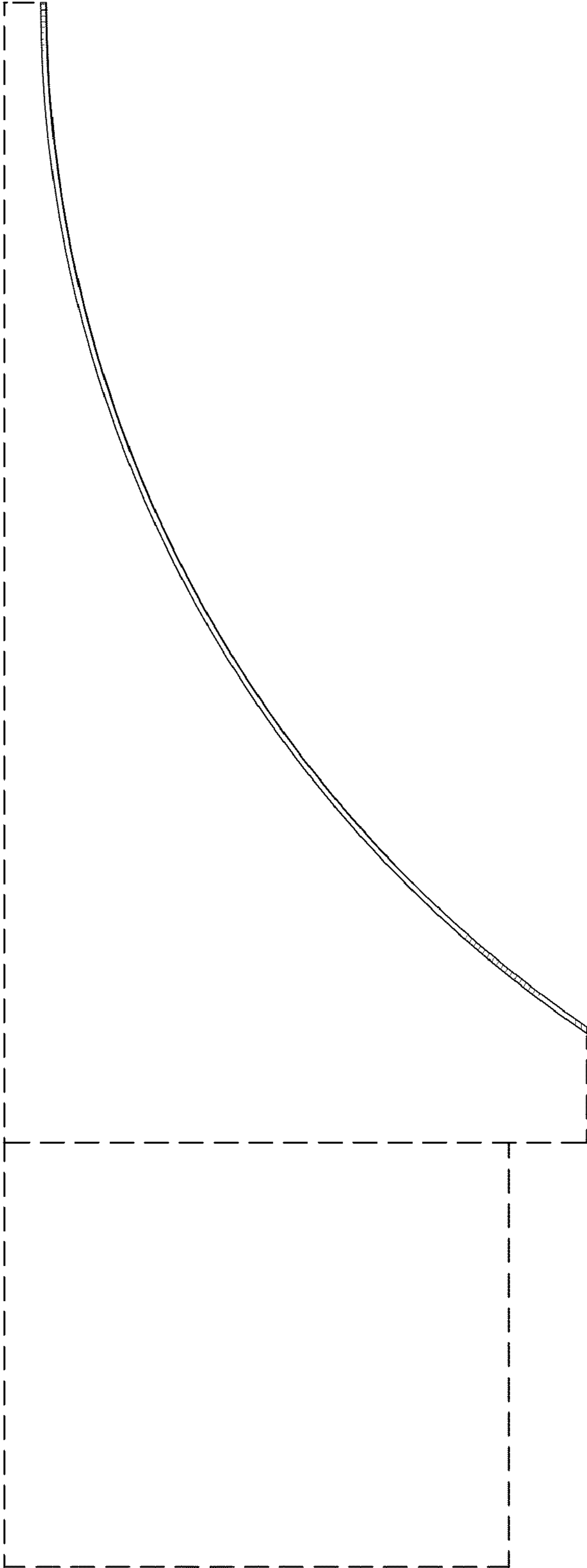

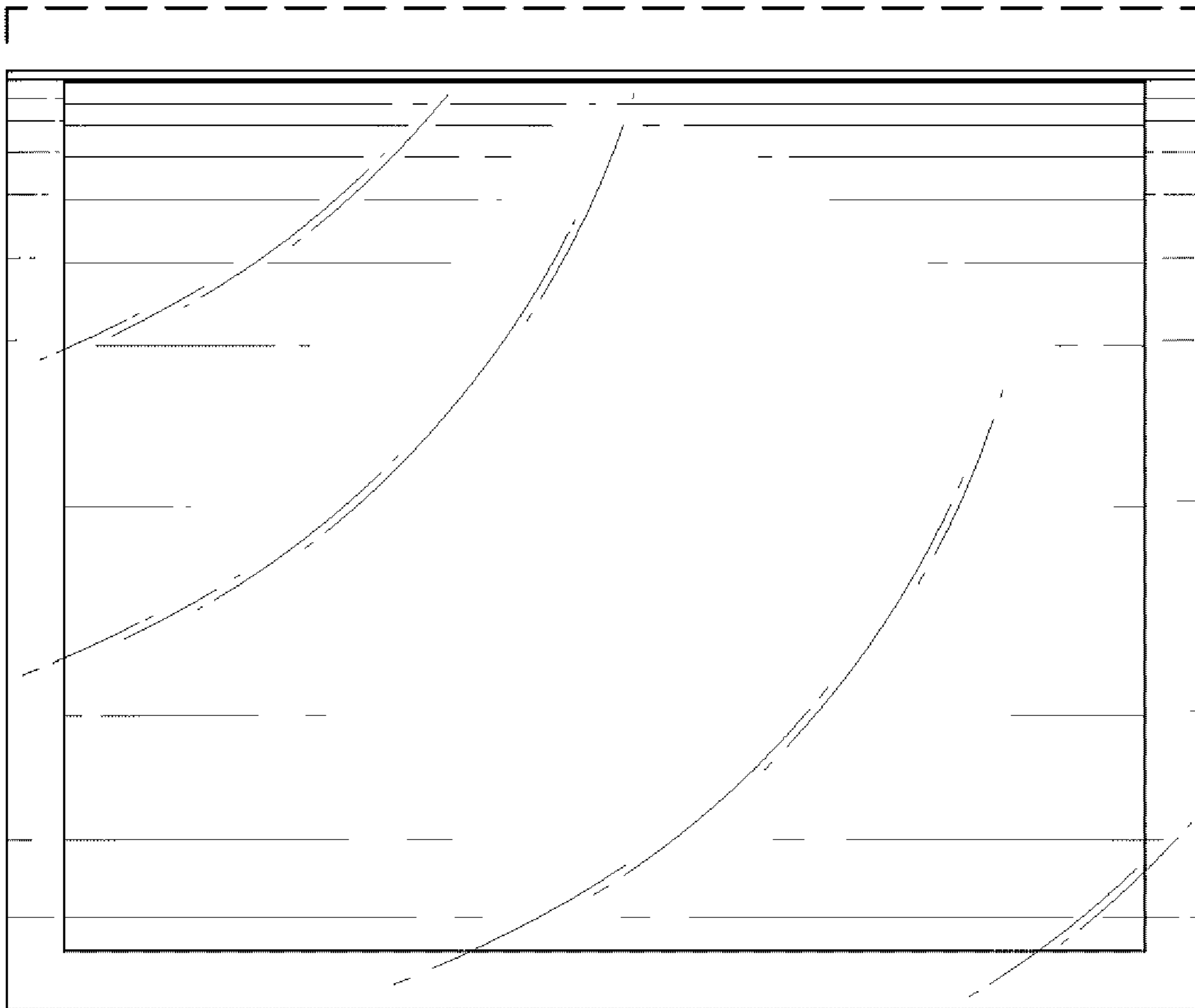
