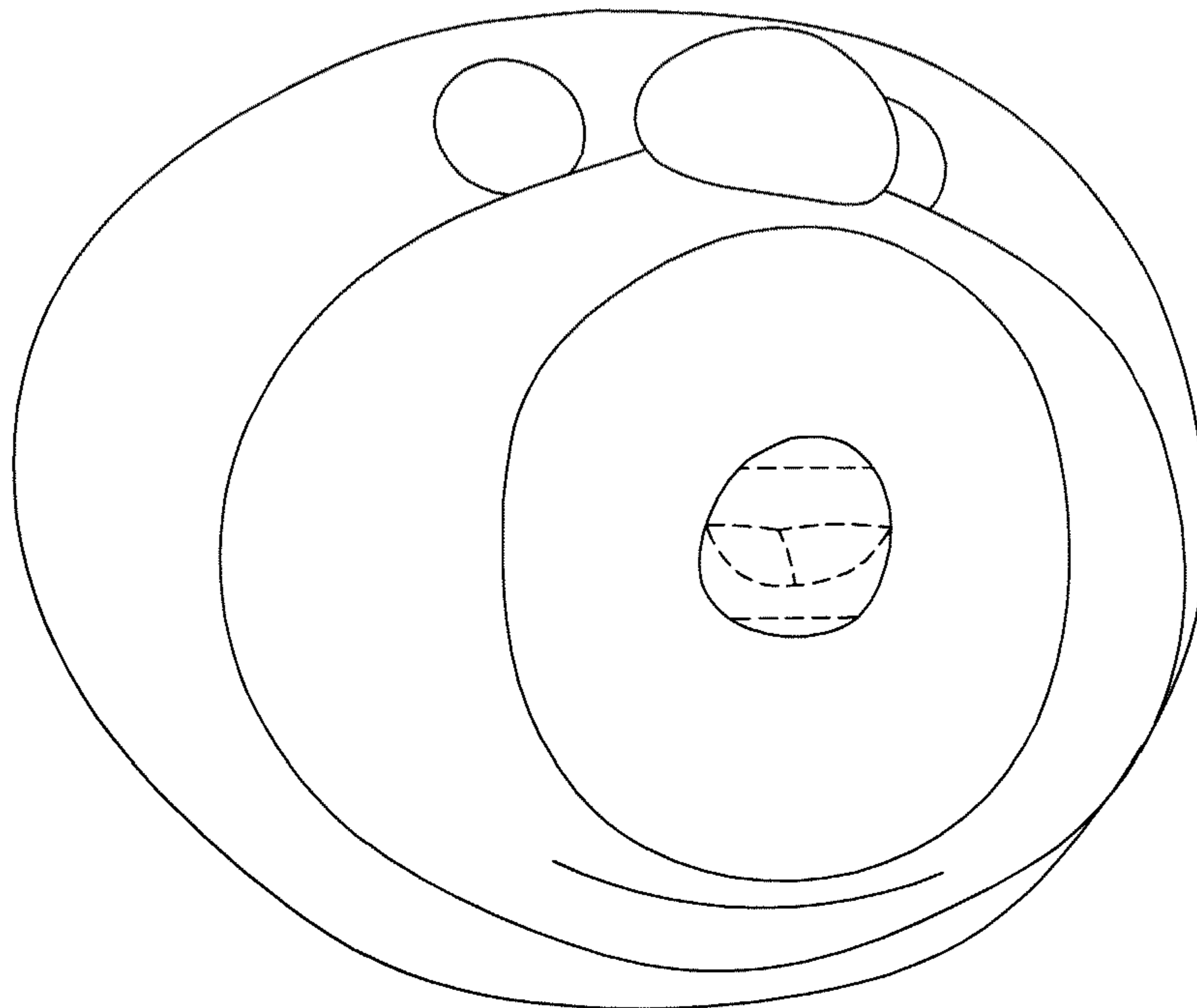
(57) **CLAIM**

The ornamental design for a head for a toy doll, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a head for a toy doll according to the present invention; FIG. 2 is front view of the head for a toy doll of FIG. 1; FIG. 3 is a rear view of the head for a toy doll of FIG. 1; FIG. 4 is a right side view of the head for a toy doll of FIG. 1; FIG. 5 is a left side view of the head for a toy doll of FIG. 1; FIG. 6 is a top view of the head for a toy doll of FIG. 1; FIG. 7 is a bottom view of the head for a toy doll of FIG. 1; FIG. 8 is a front perspective view of a head for a toy doll according to another embodiment of the present invention; FIG. 9 is front view of the head for a toy doll of FIG. 8; FIG. 10 is a rear view of the head for a toy doll of FIG. 8; FIG. 11 is a right side view of the head for a toy doll of FIG. 8; FIG. 12 is a left side view of the head for a toy doll of FIG. 8; FIG. 13 is a top view of the head for a toy doll of FIG. 8; and, FIG. 14 is a bottom view of the head for a toy doll of FIG. 8. 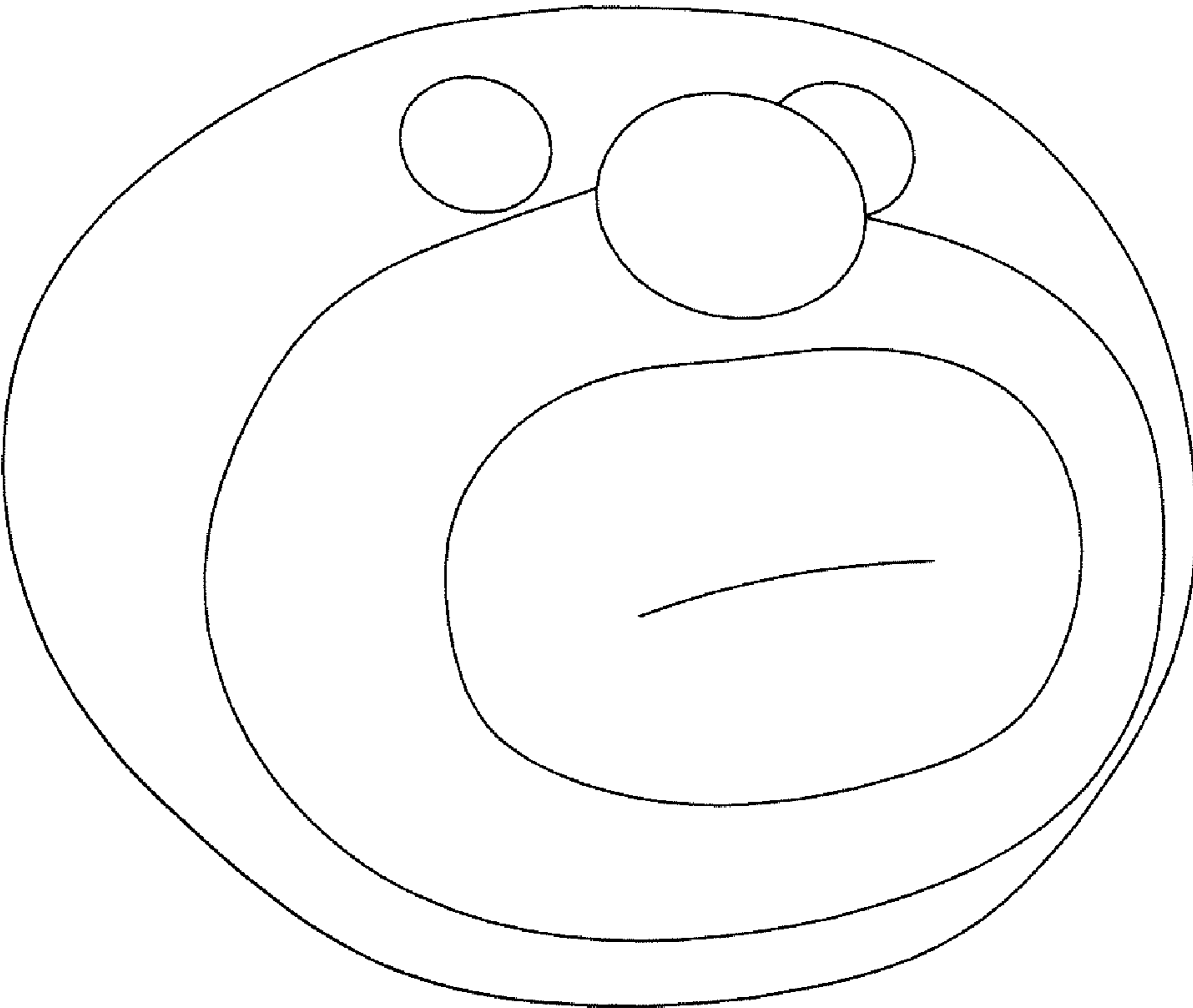

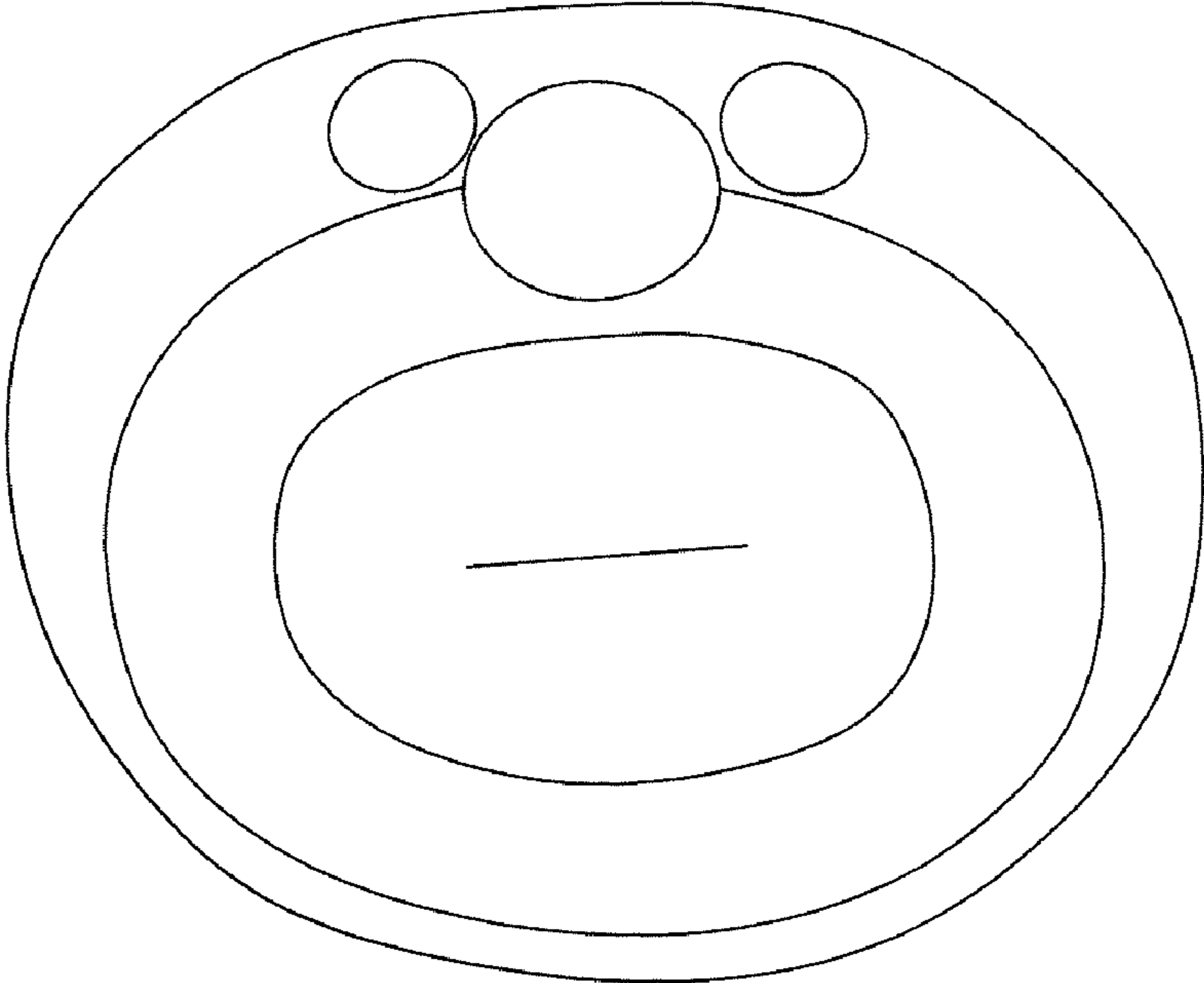

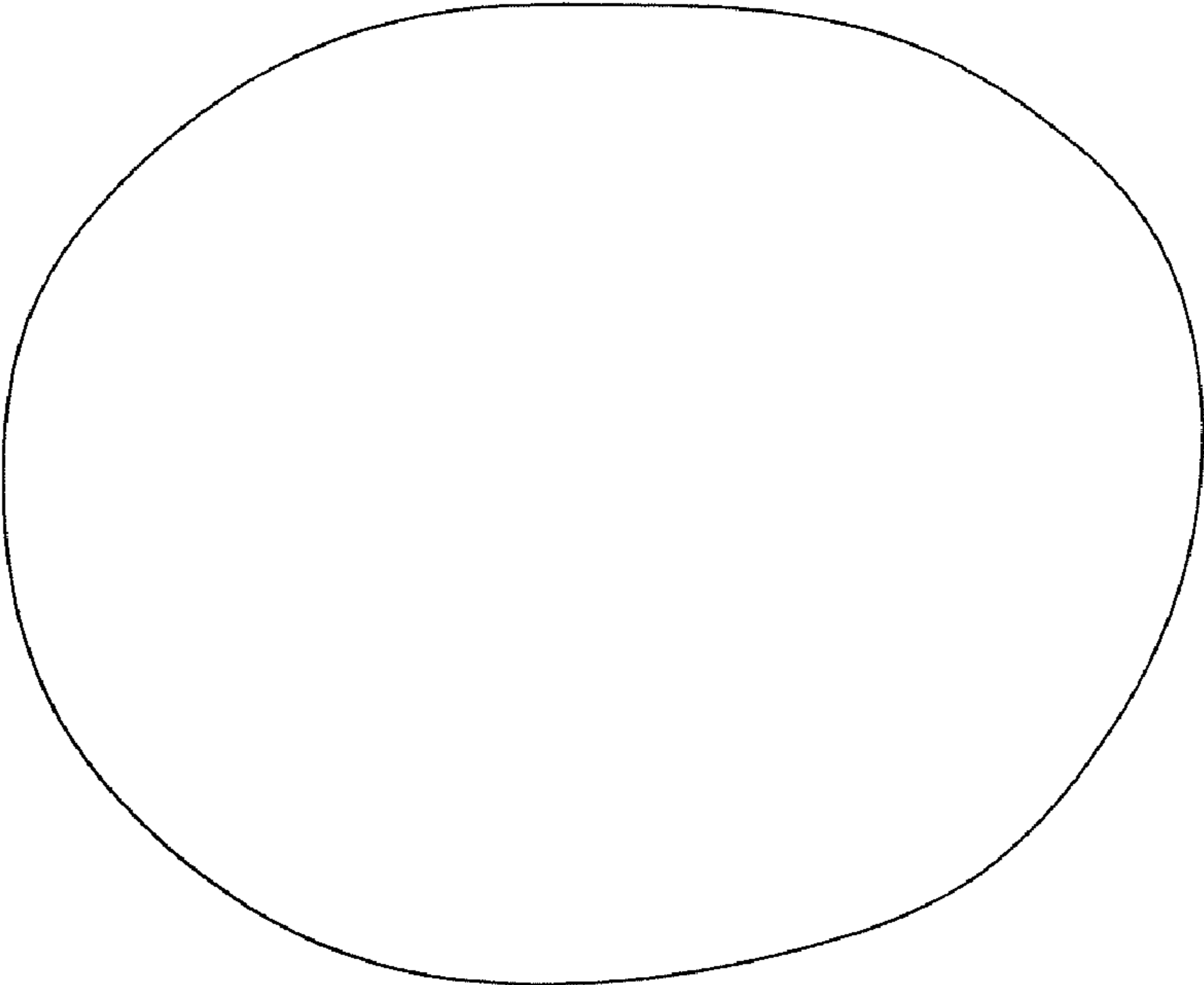

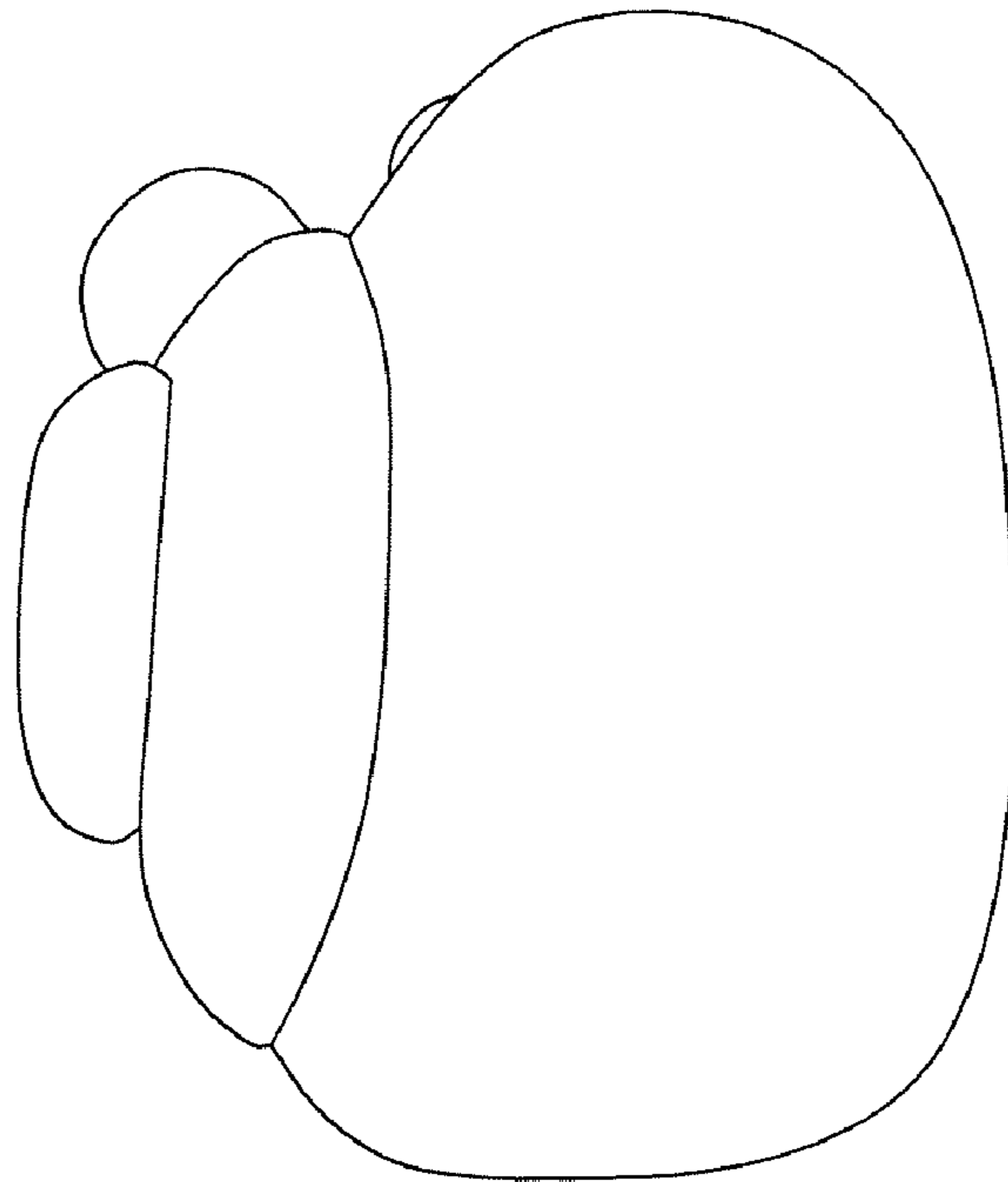

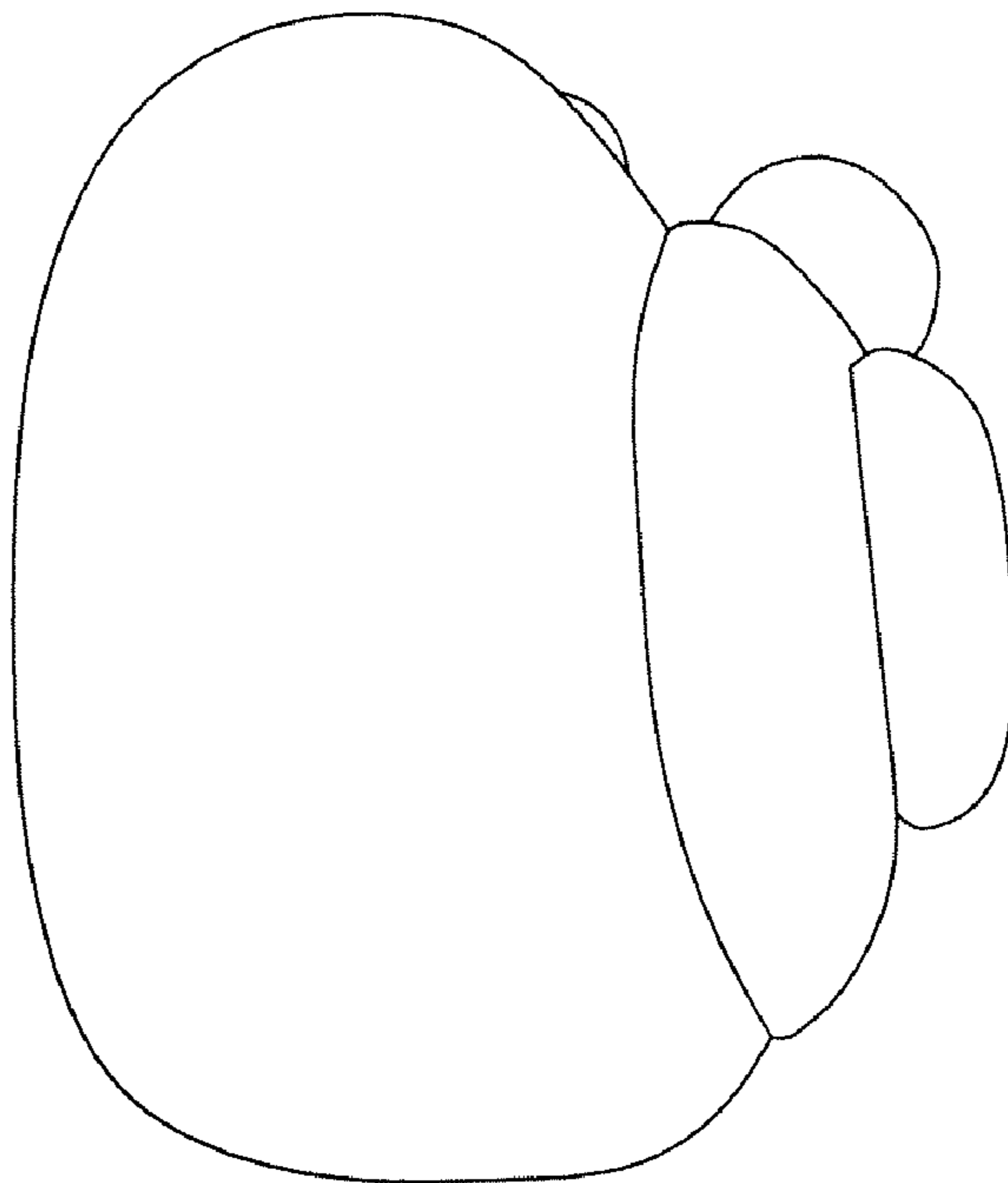

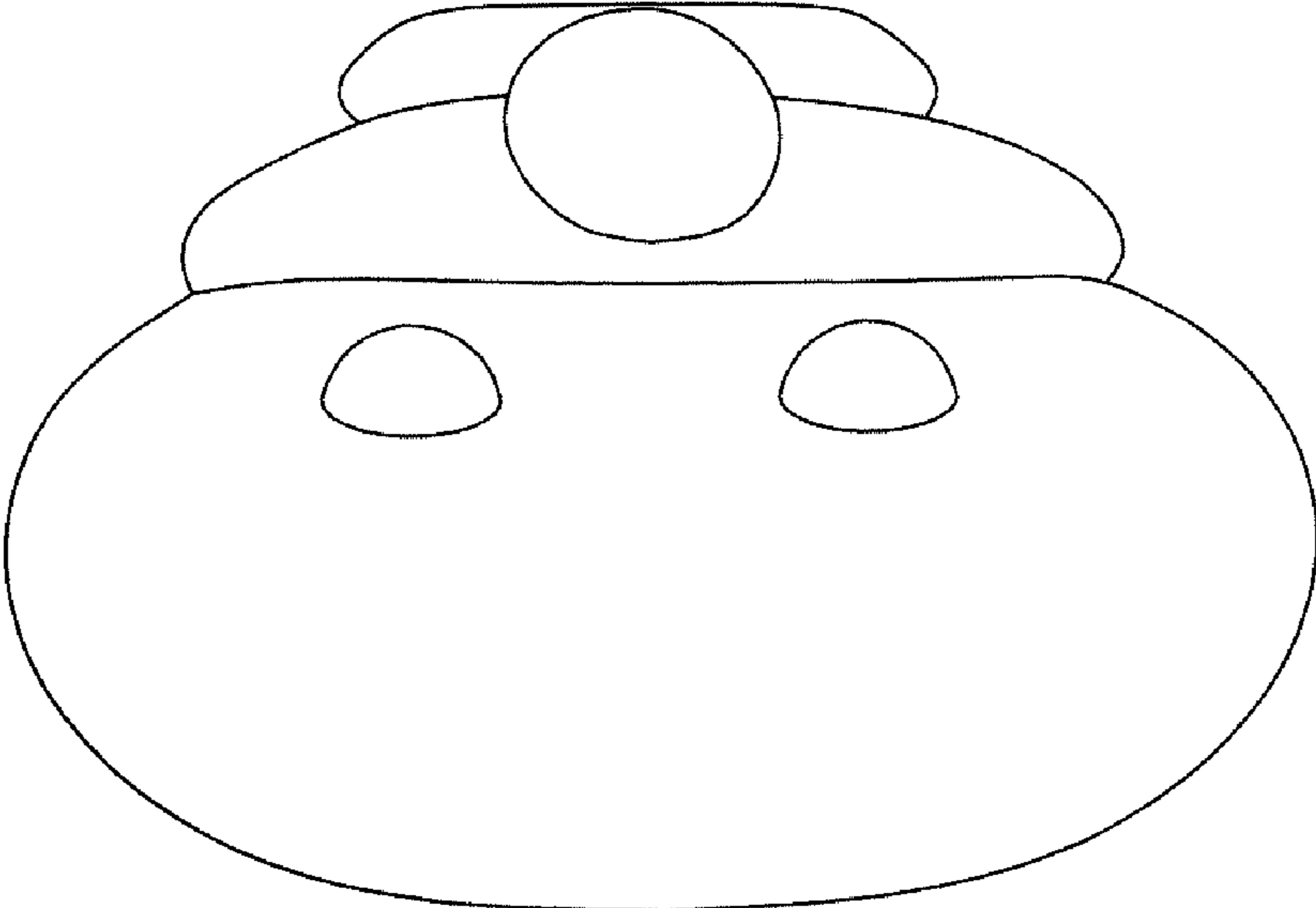

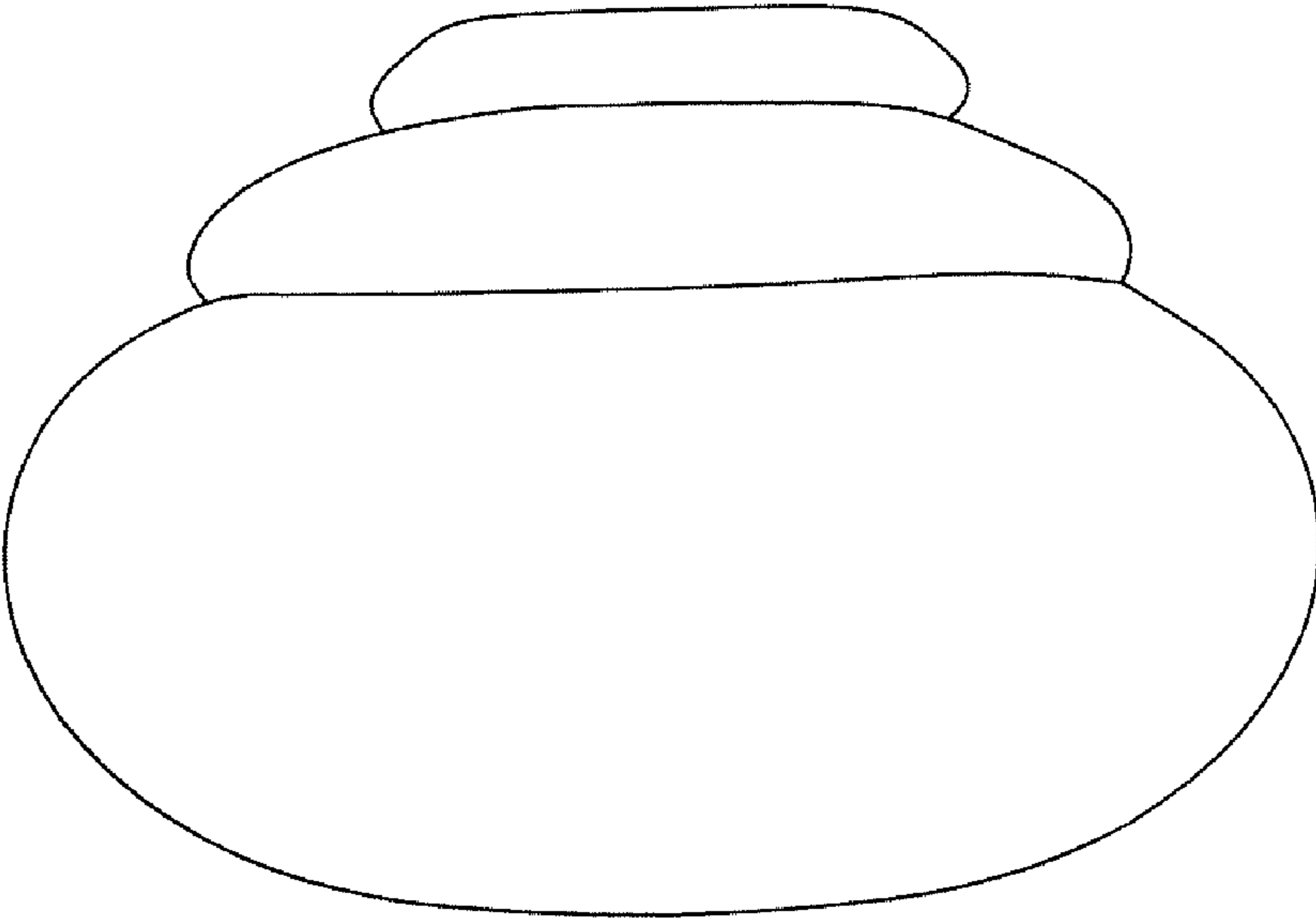

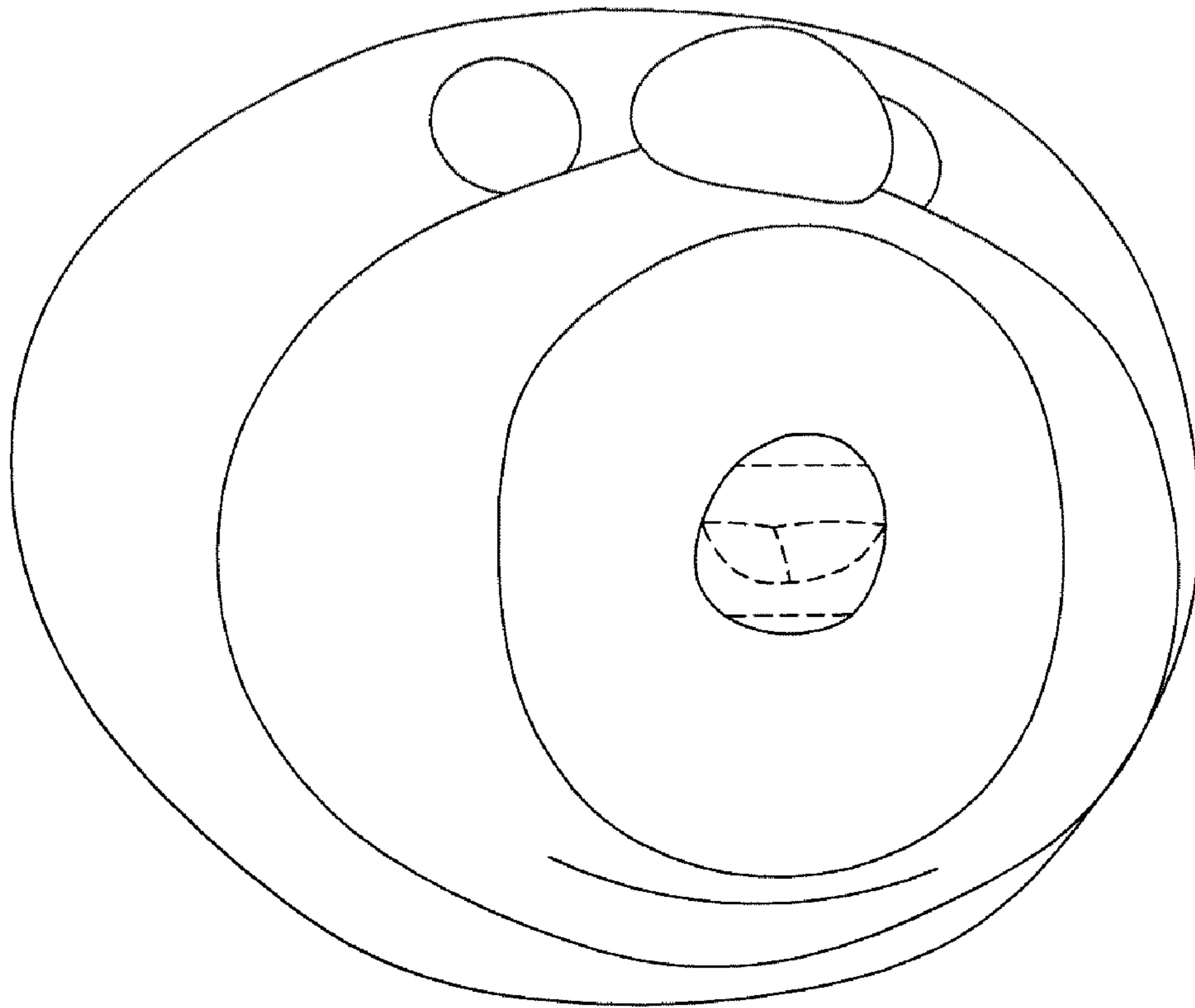

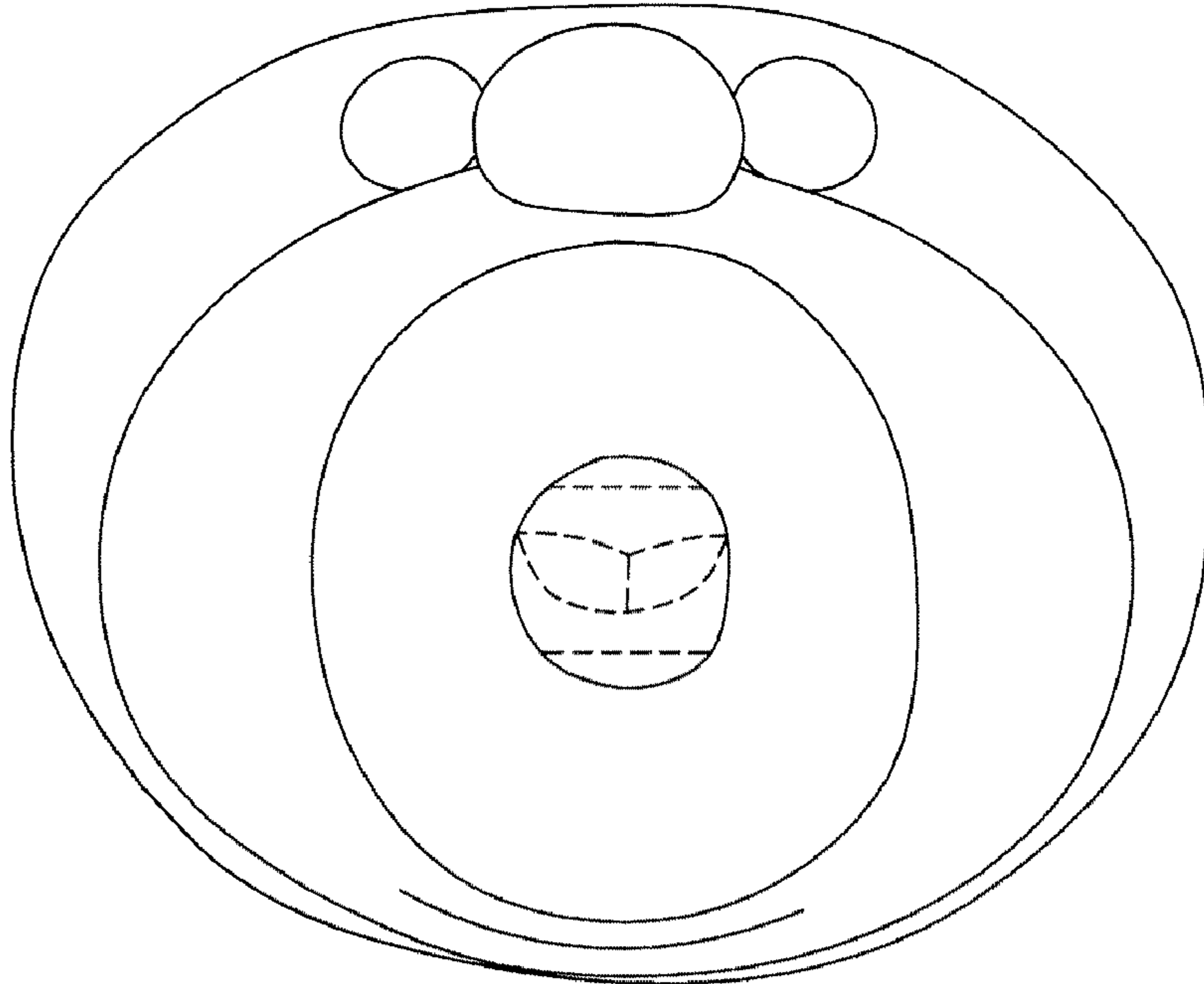

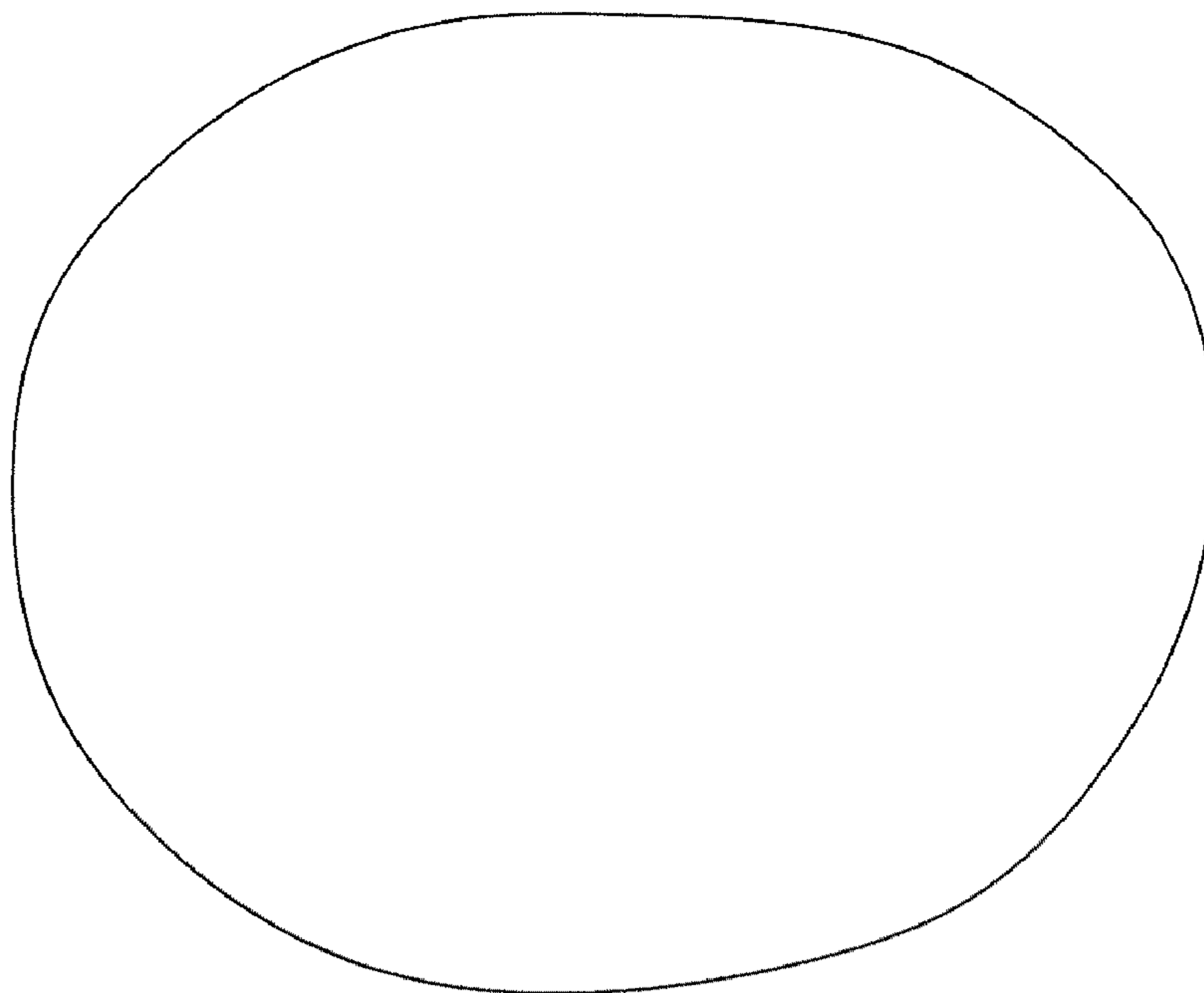

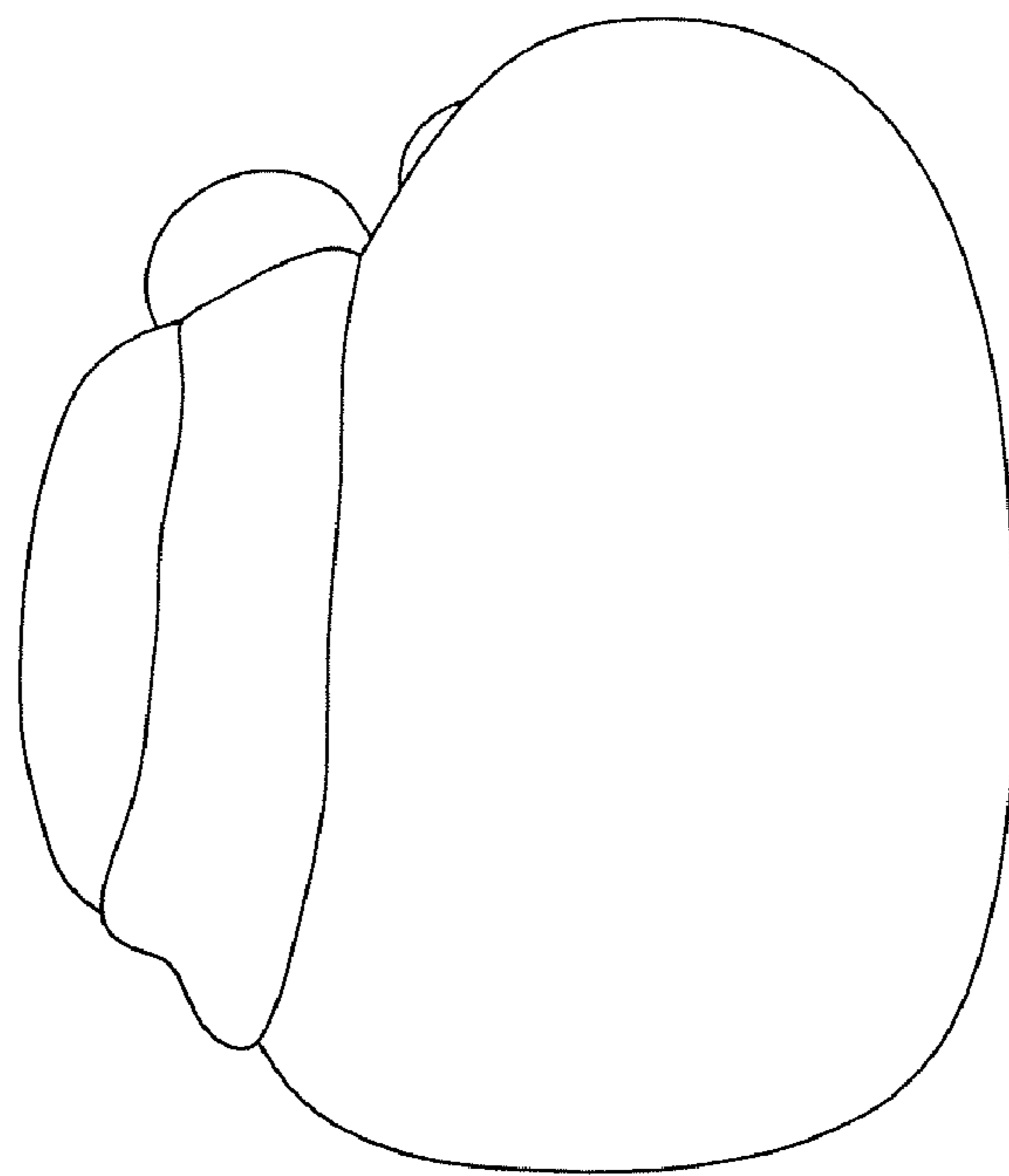

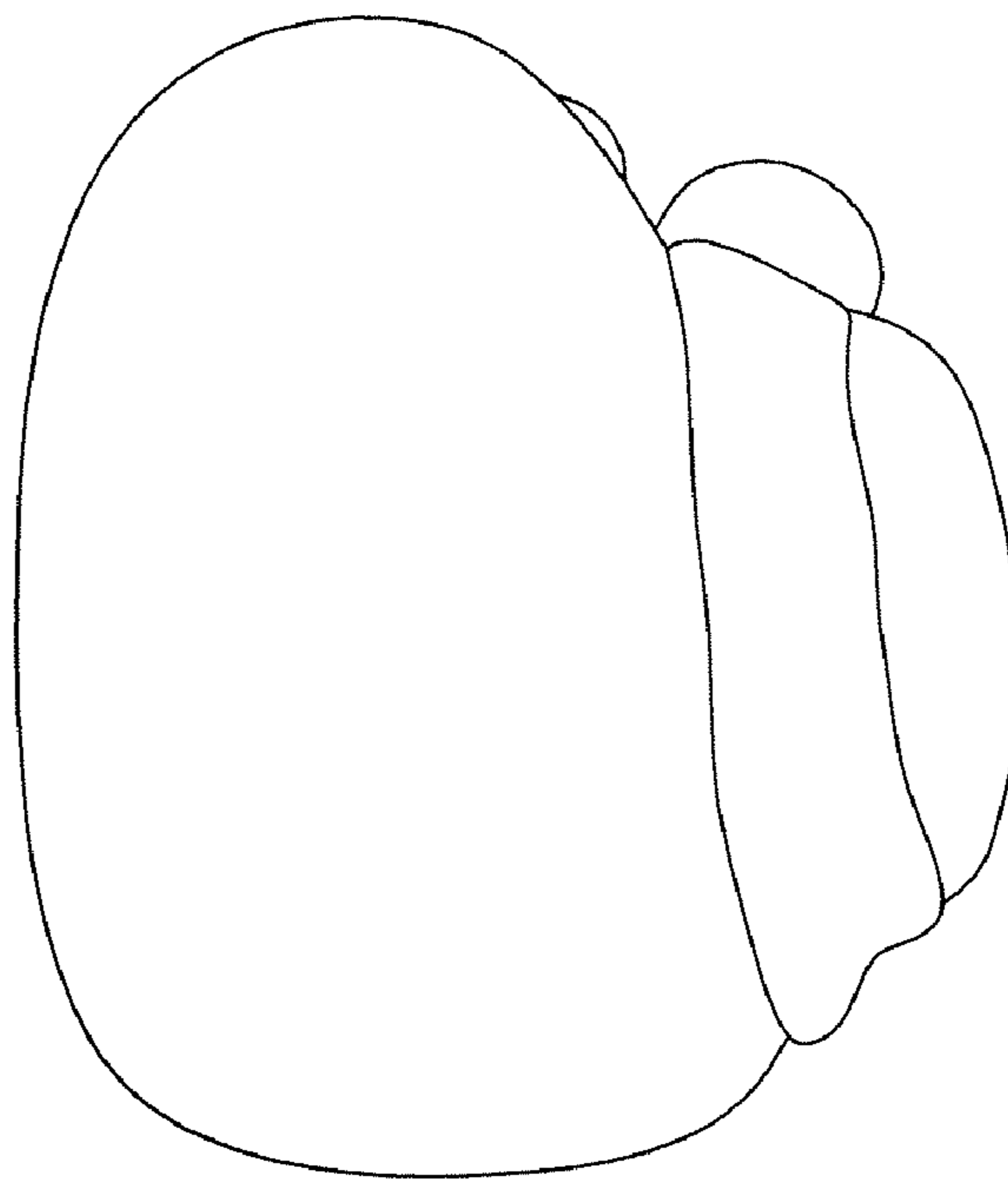

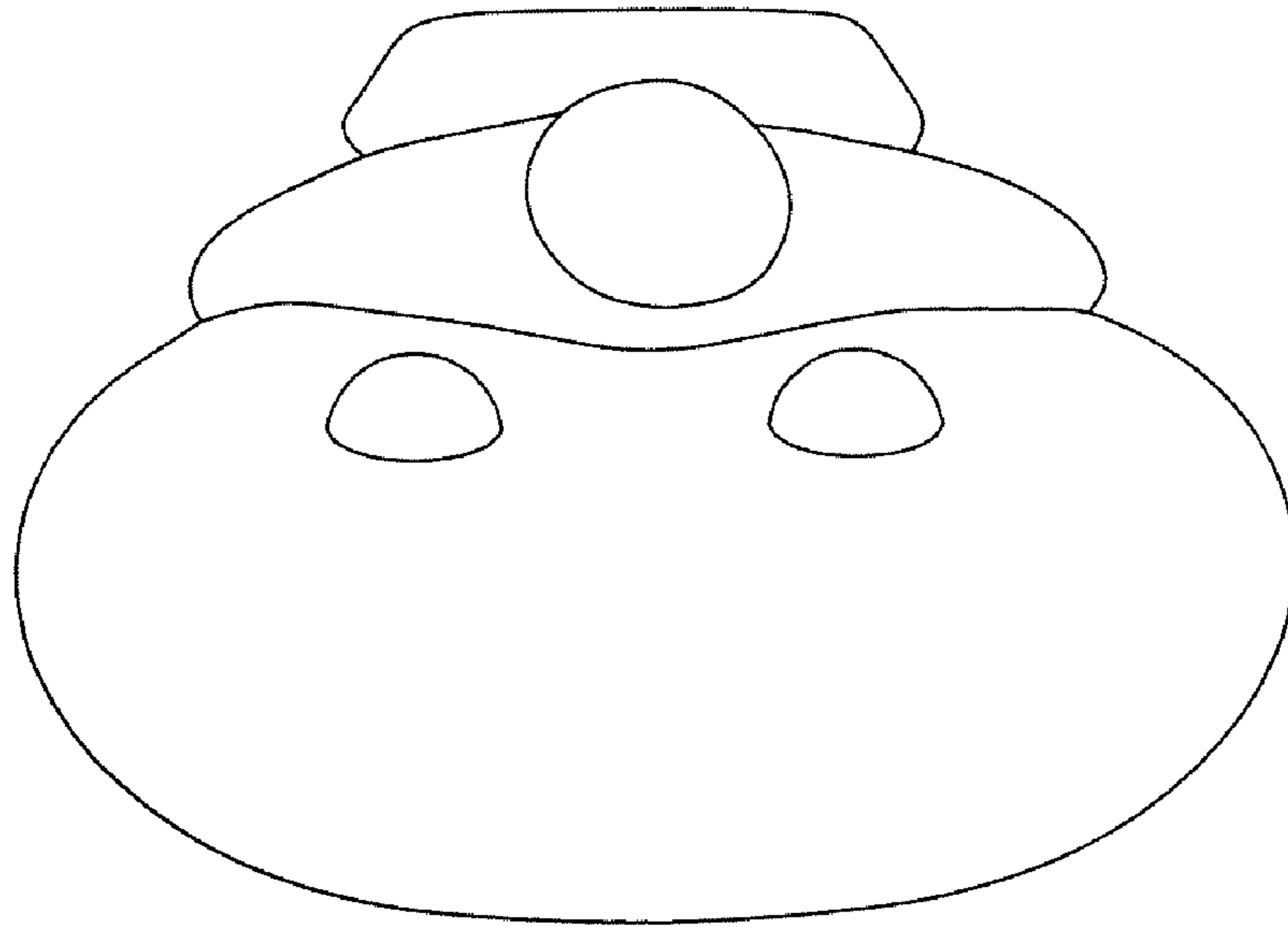

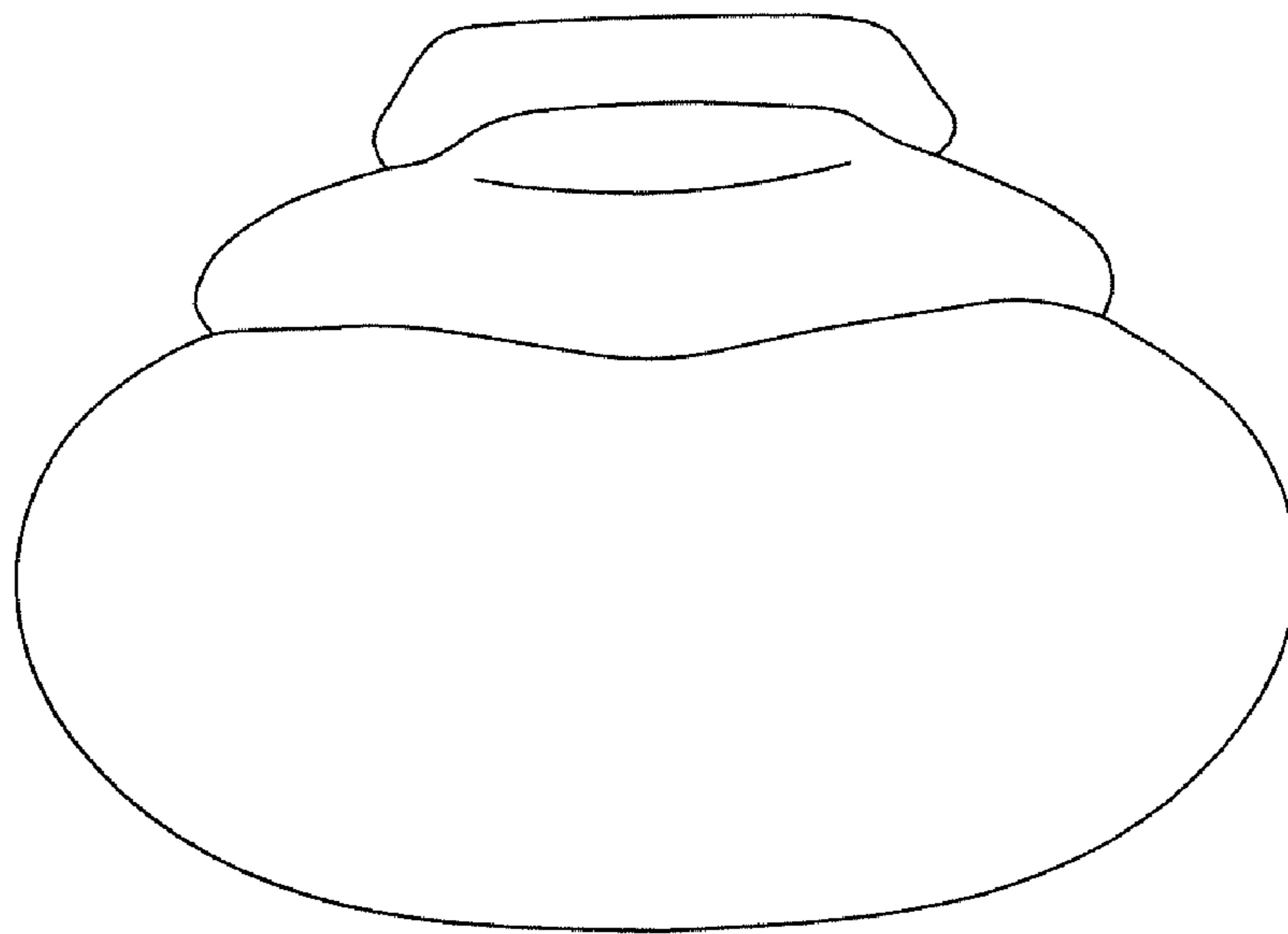
