FIG. 2 is an enlarged front elevation view thereof;

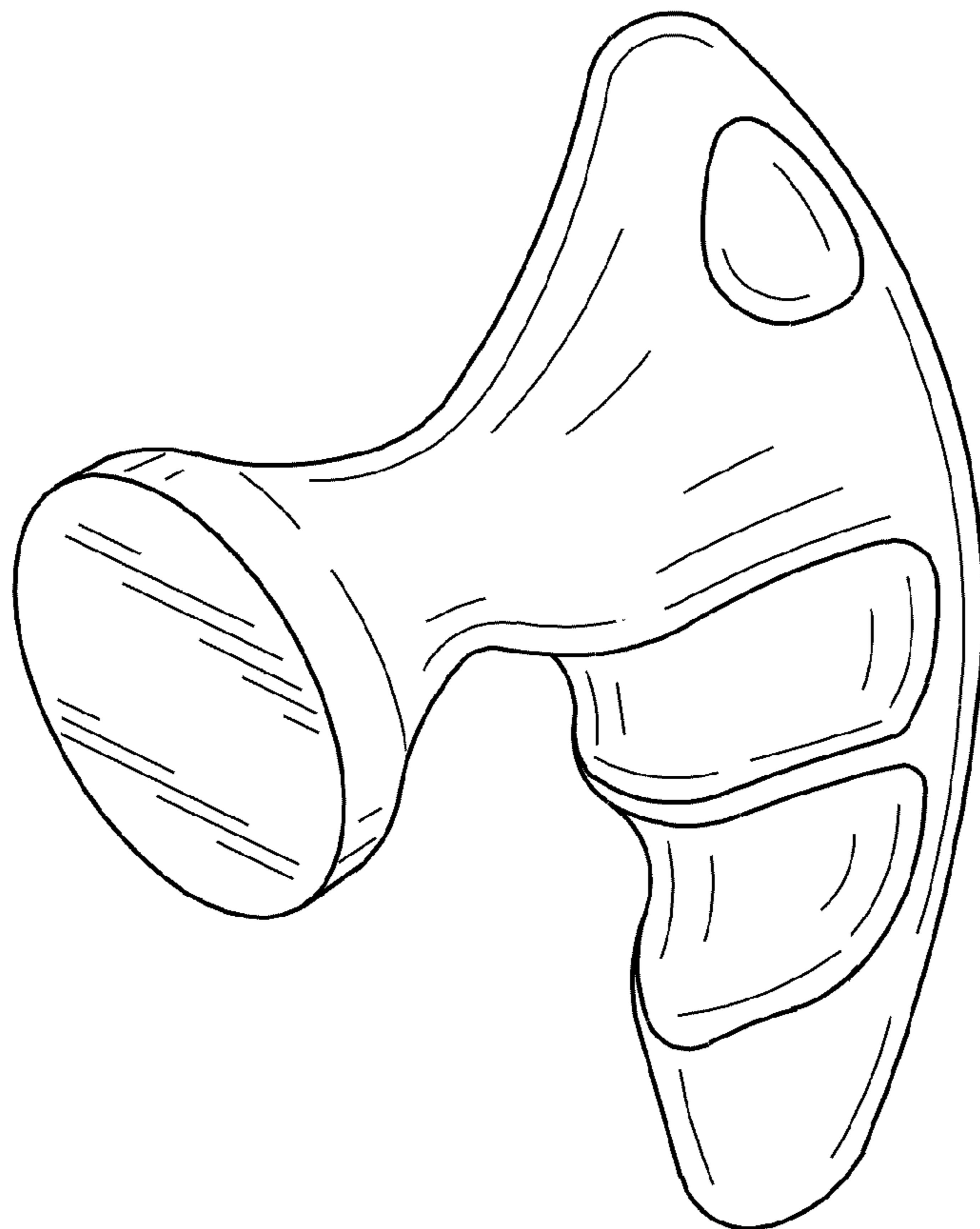
FIG. 3 is an enlarged rear elevation view thereof;

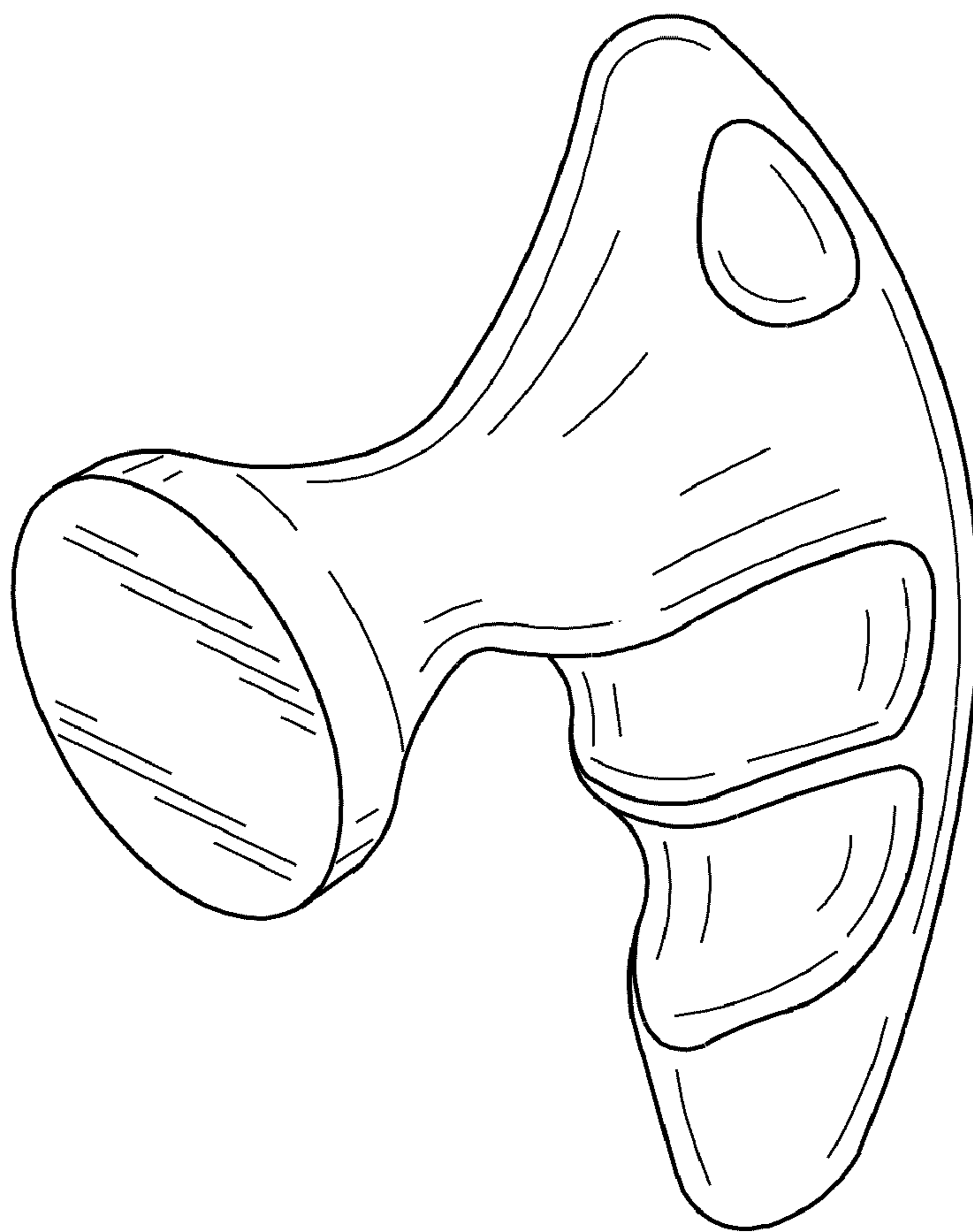

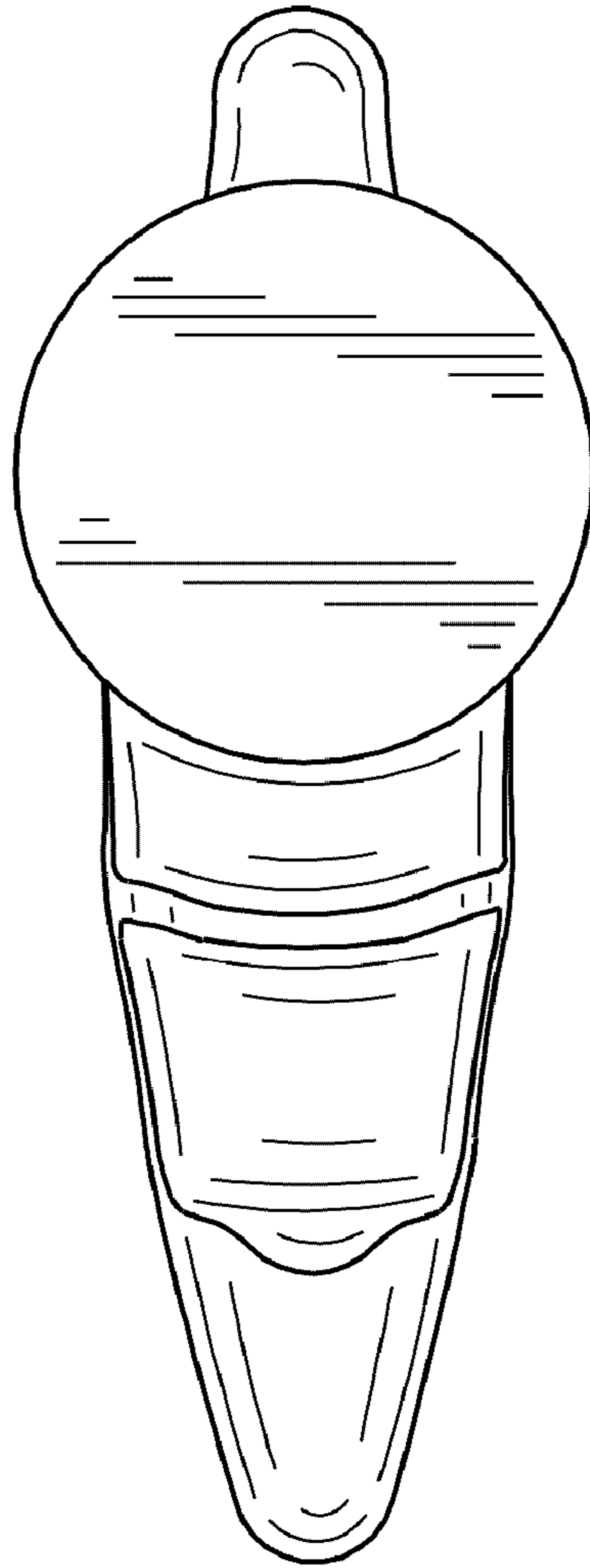

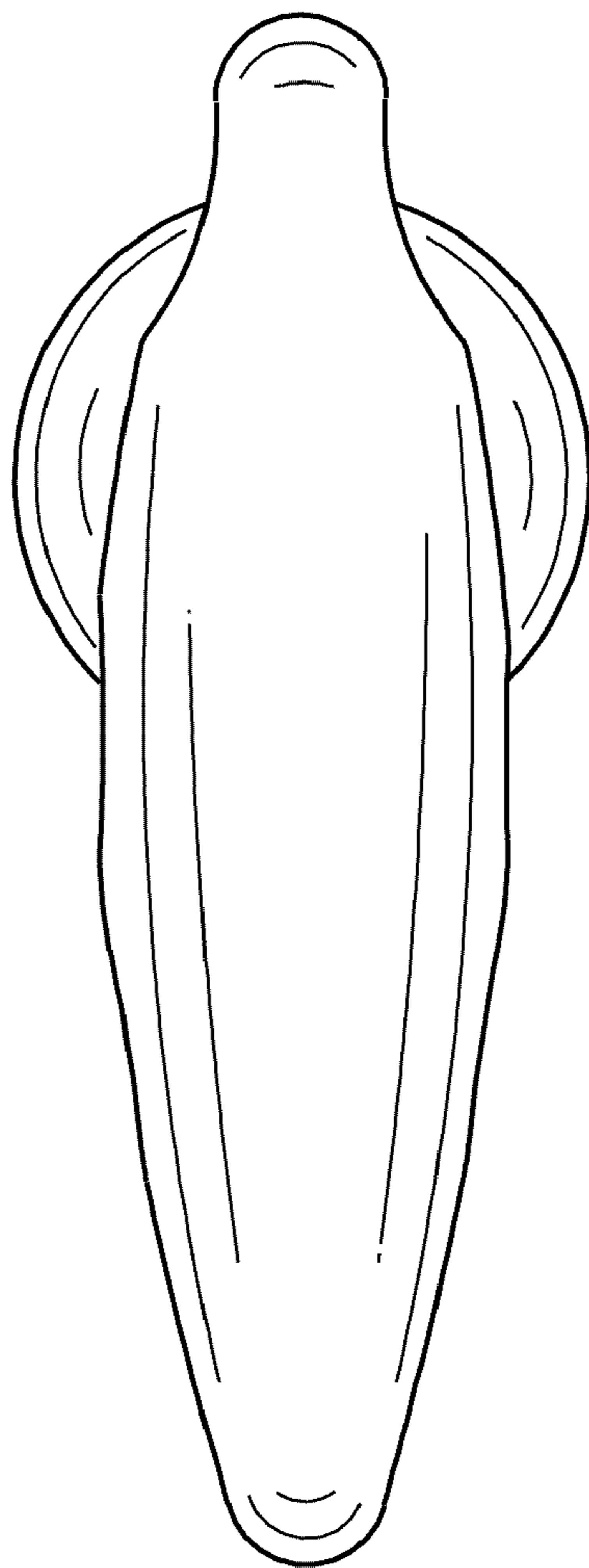

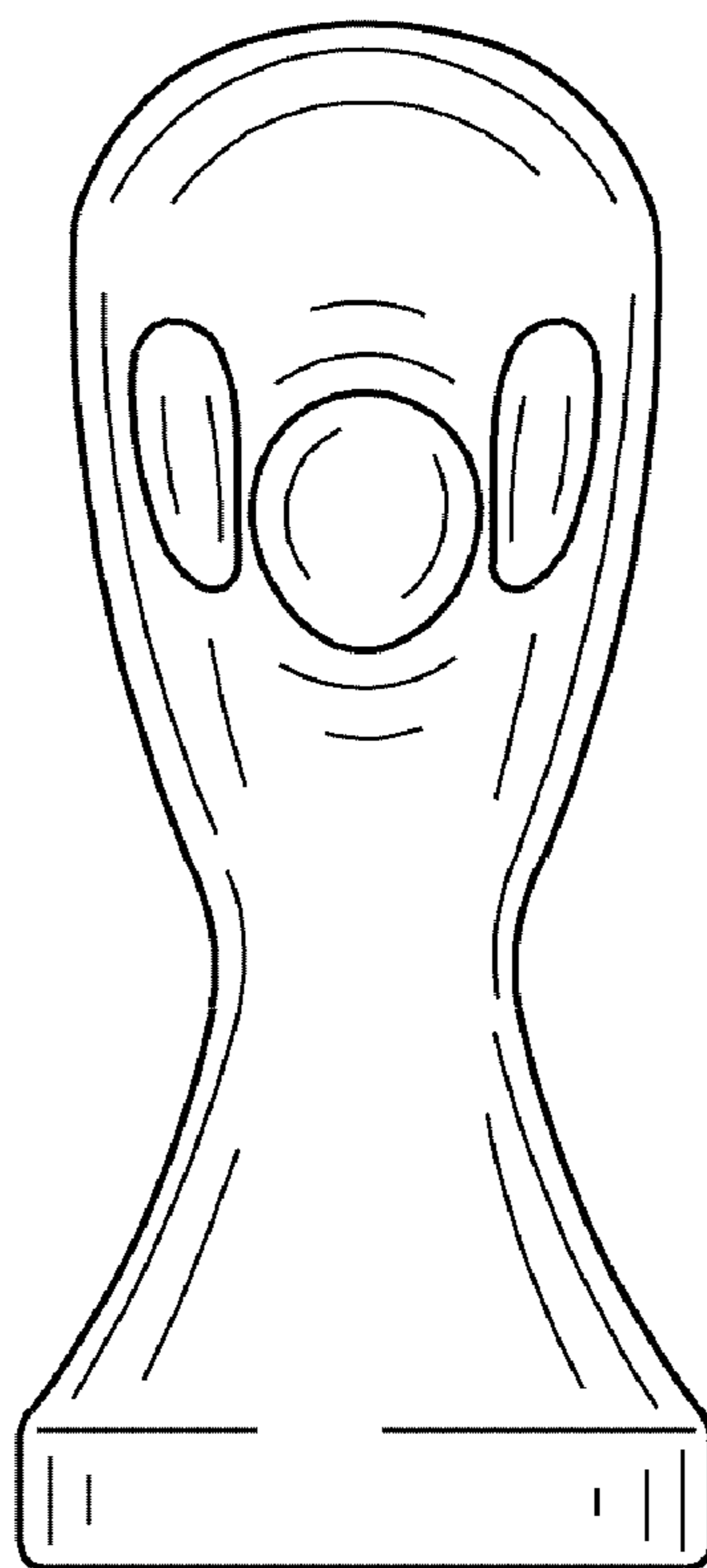

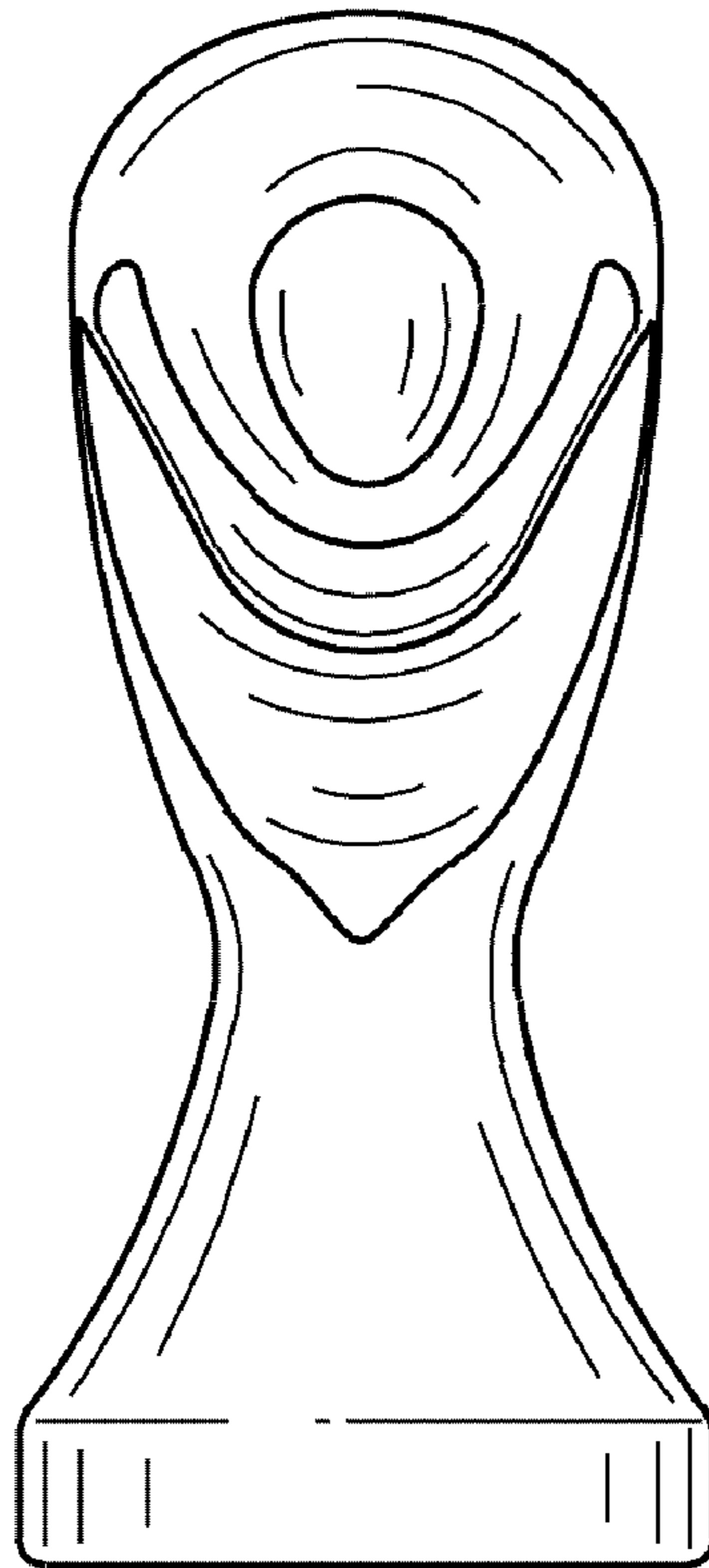

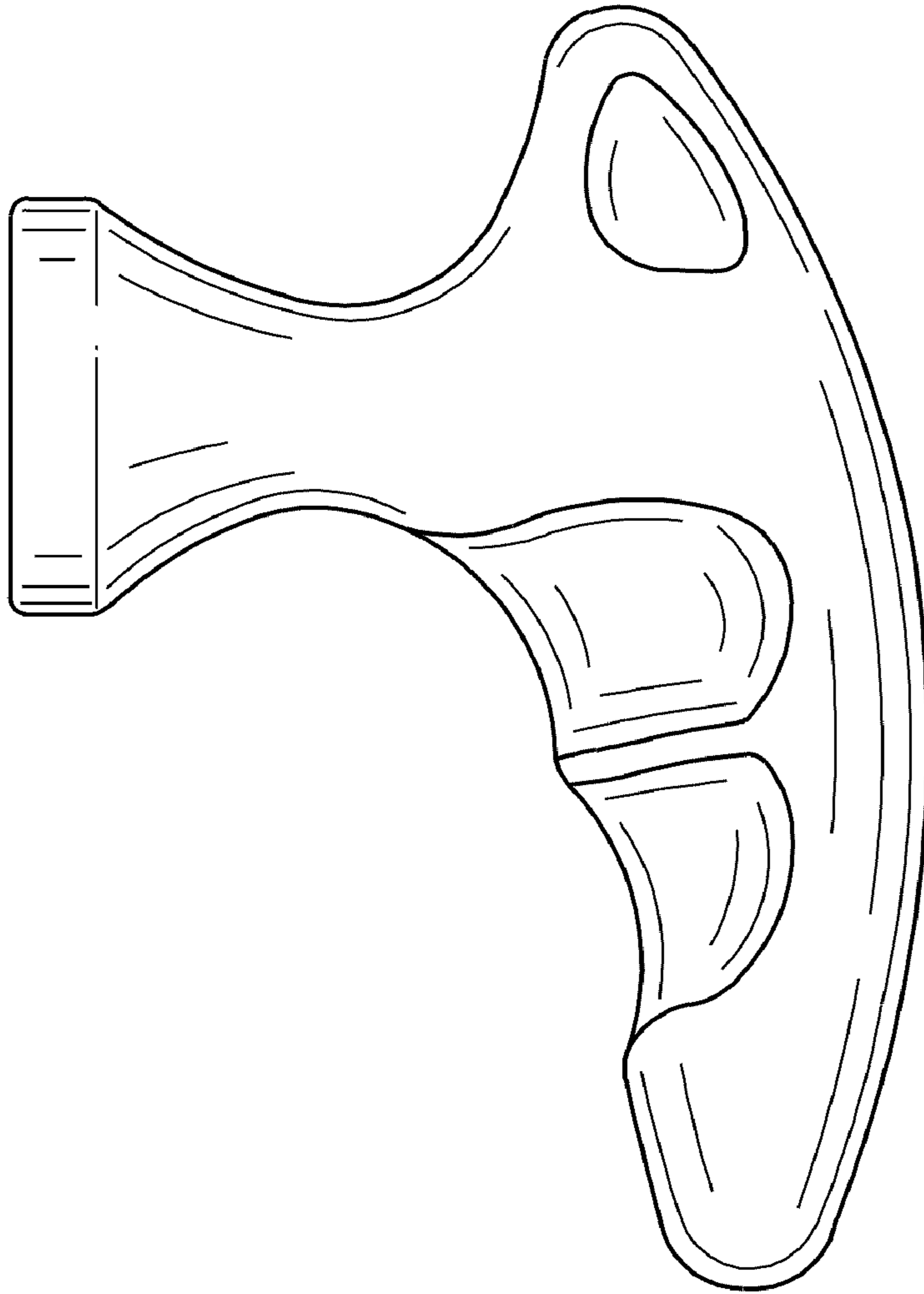
