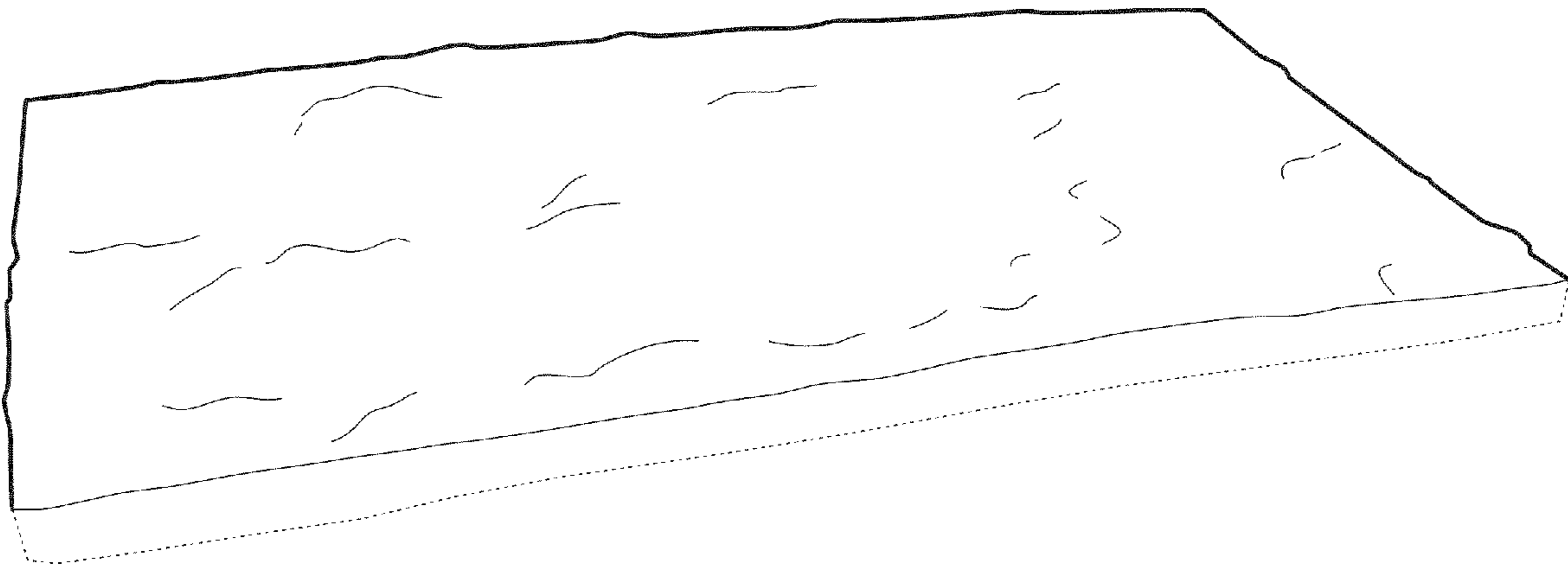
The ornamental design for a recycled rubber flagstone, as shown and described.

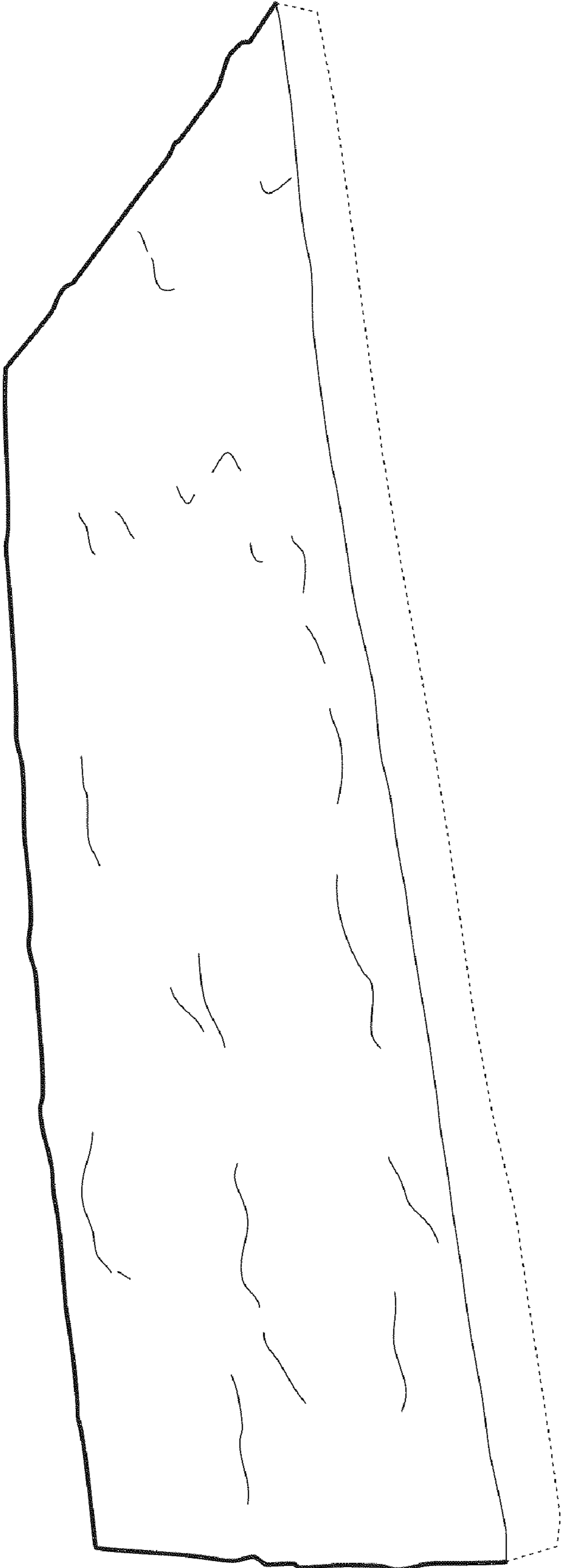
**DESCRIPTION**

FIG. 6 is a top view thereof.

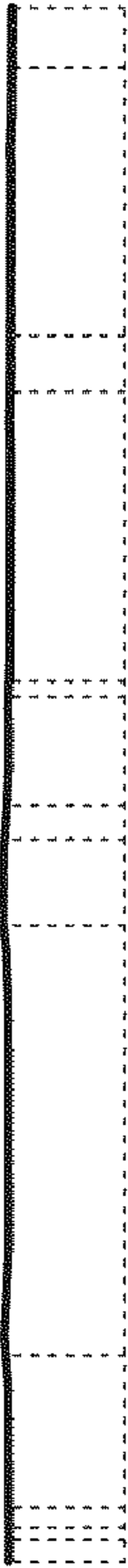
The broken lines in the drawing views are included for the purpose of illustrating a portion of the recycled rubber flagstone that forms no part of the claimed design.

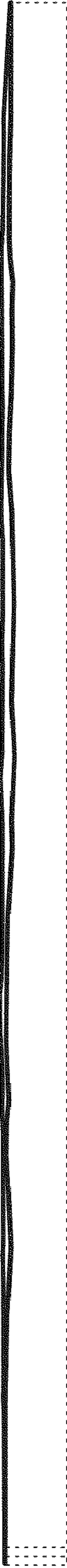

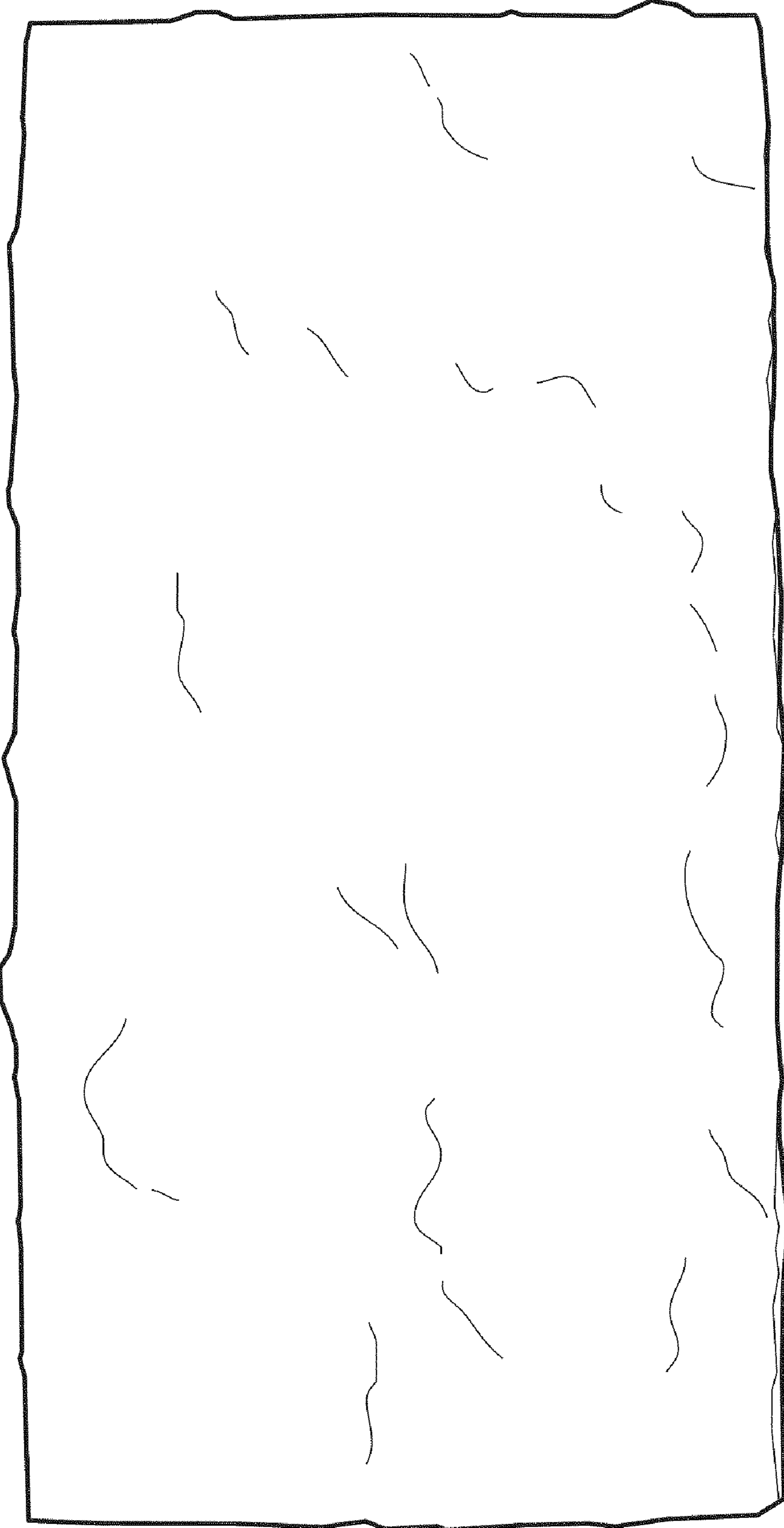
