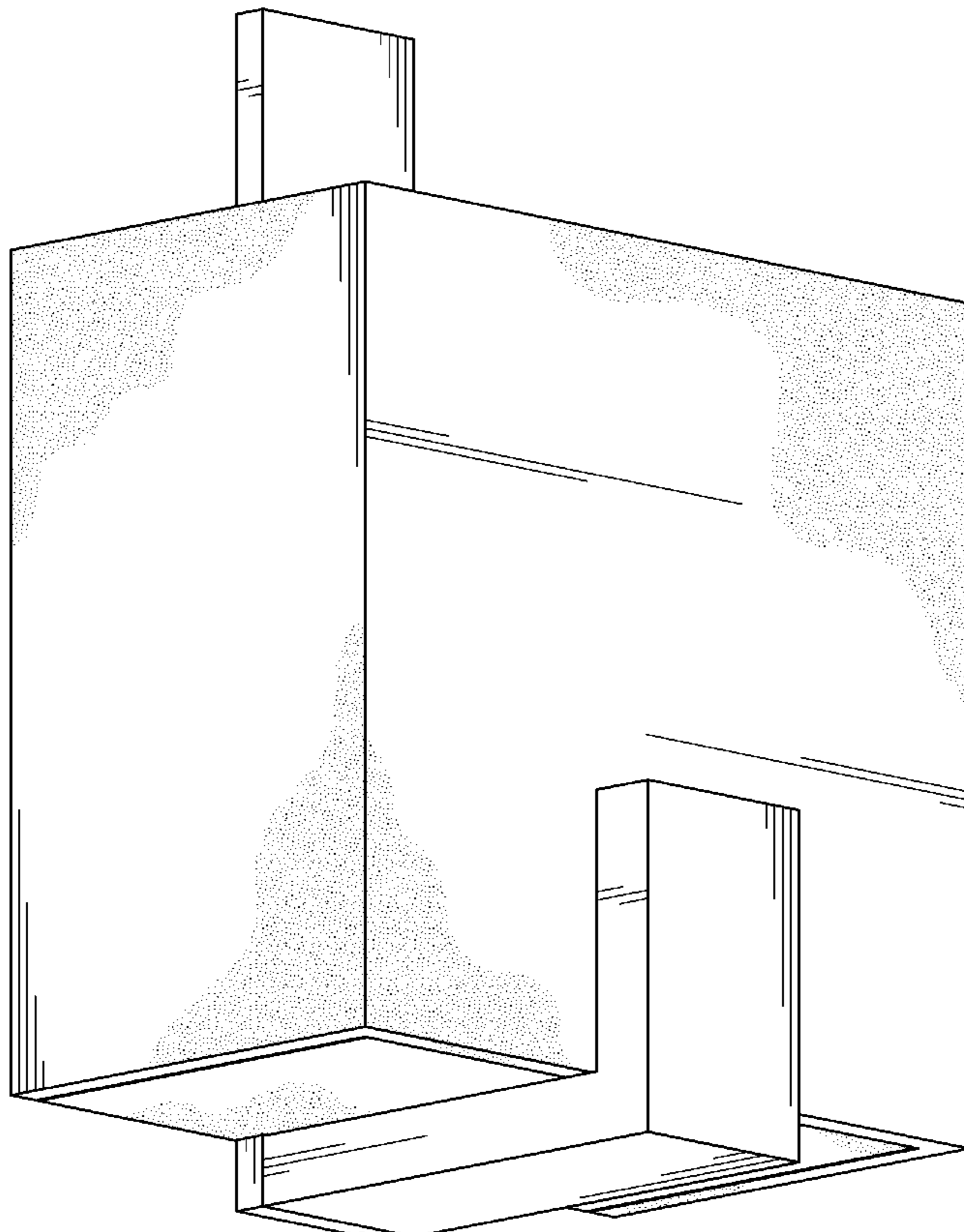
(57) **CLAIM**

The ornamental design for a wall sconce, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of one embodiment of a wall sconce in accordance with one aspect of the new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a right elevational view thereof; FIG. 4 is a left elevational view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a perspective view of another embodiment of a wall sconce having translucent portions in accordance with another aspect of the new design; FIG. 7 is a front elevational view thereof; FIG. 8 is a right elevational view thereof; FIG. 9 is a left elevational view thereof; and, FIG. 10 is a bottom view thereof. The rear surface of the wall sconce is devoid of surface ornamentation and forms no part of the claimed design.

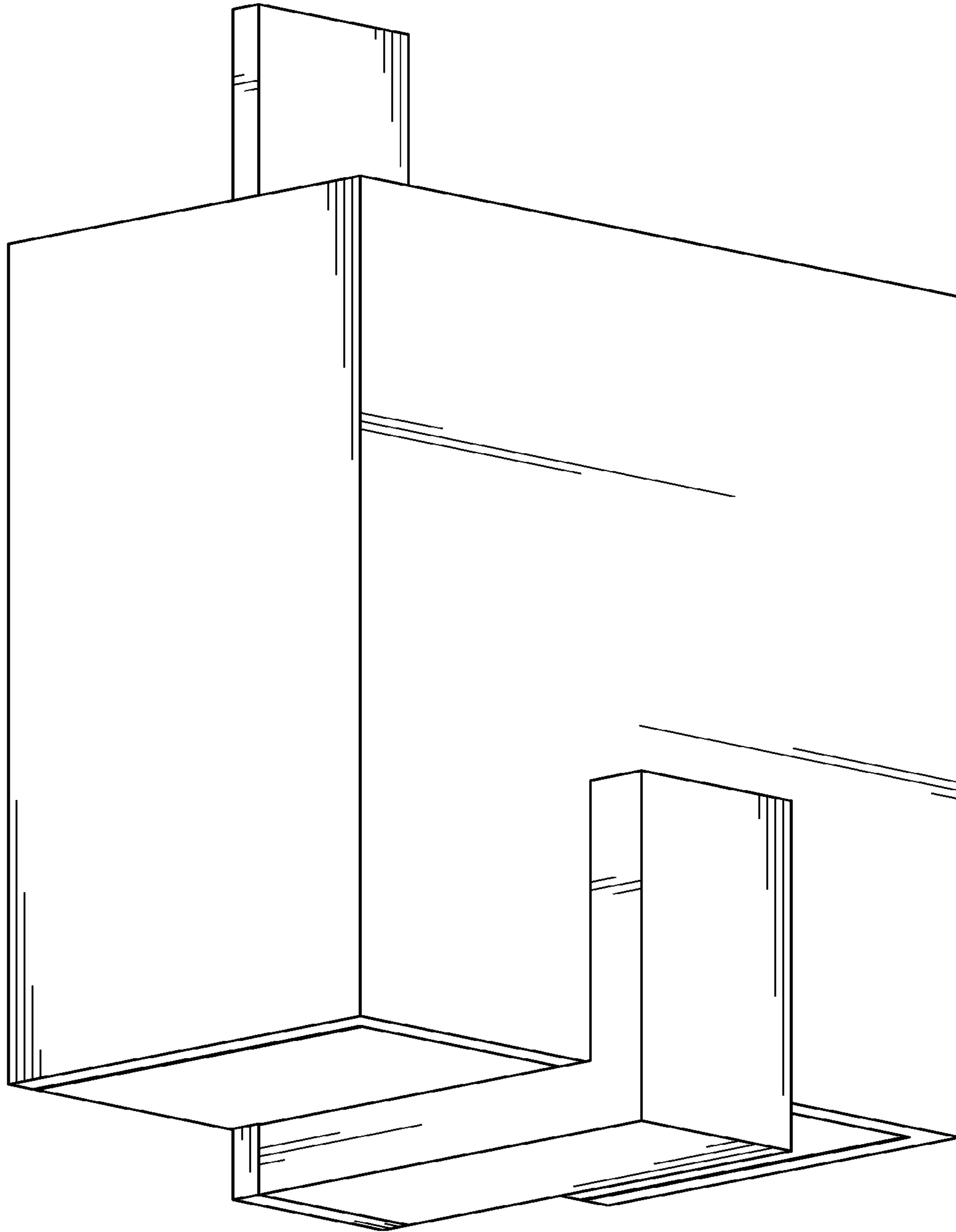

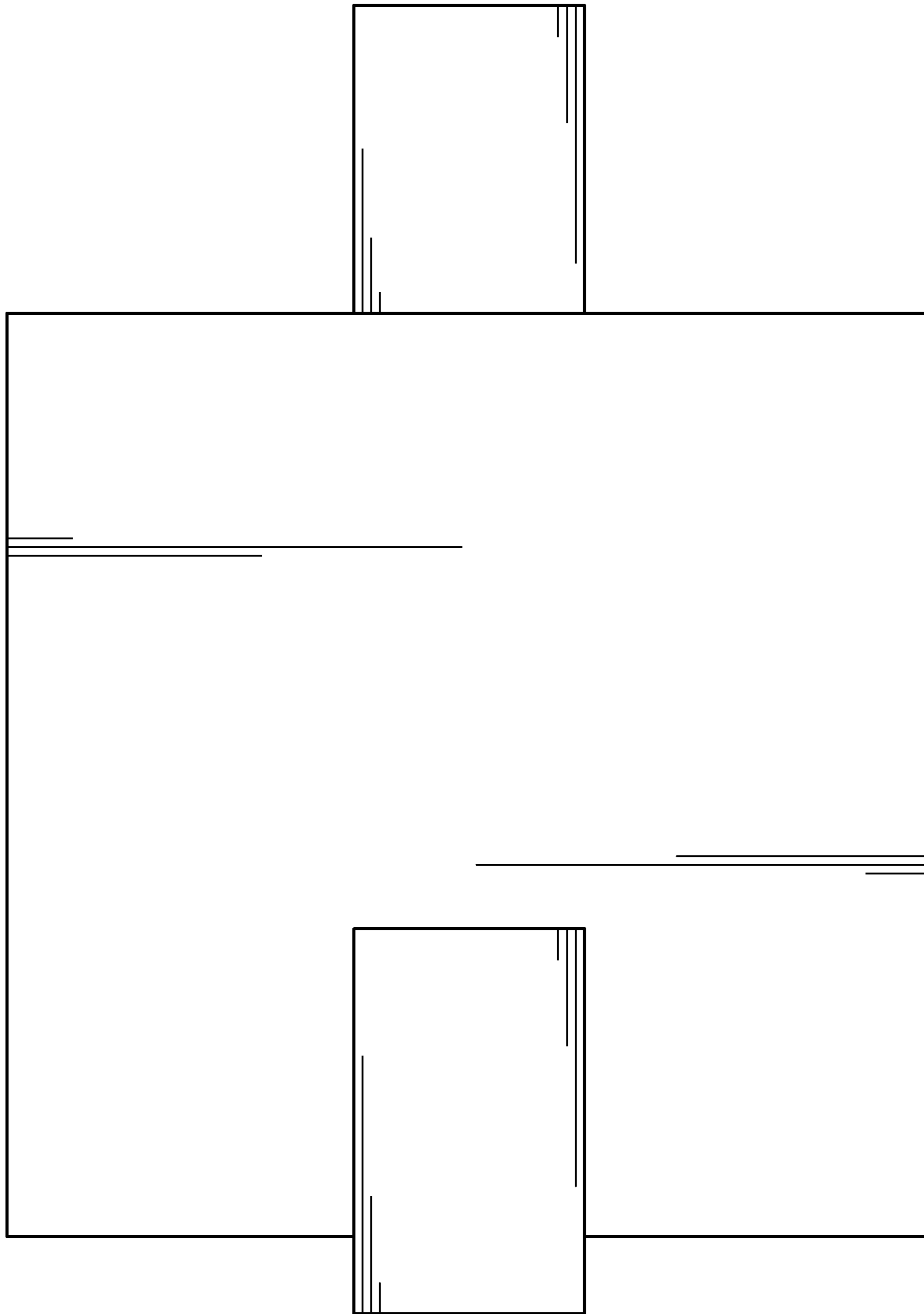

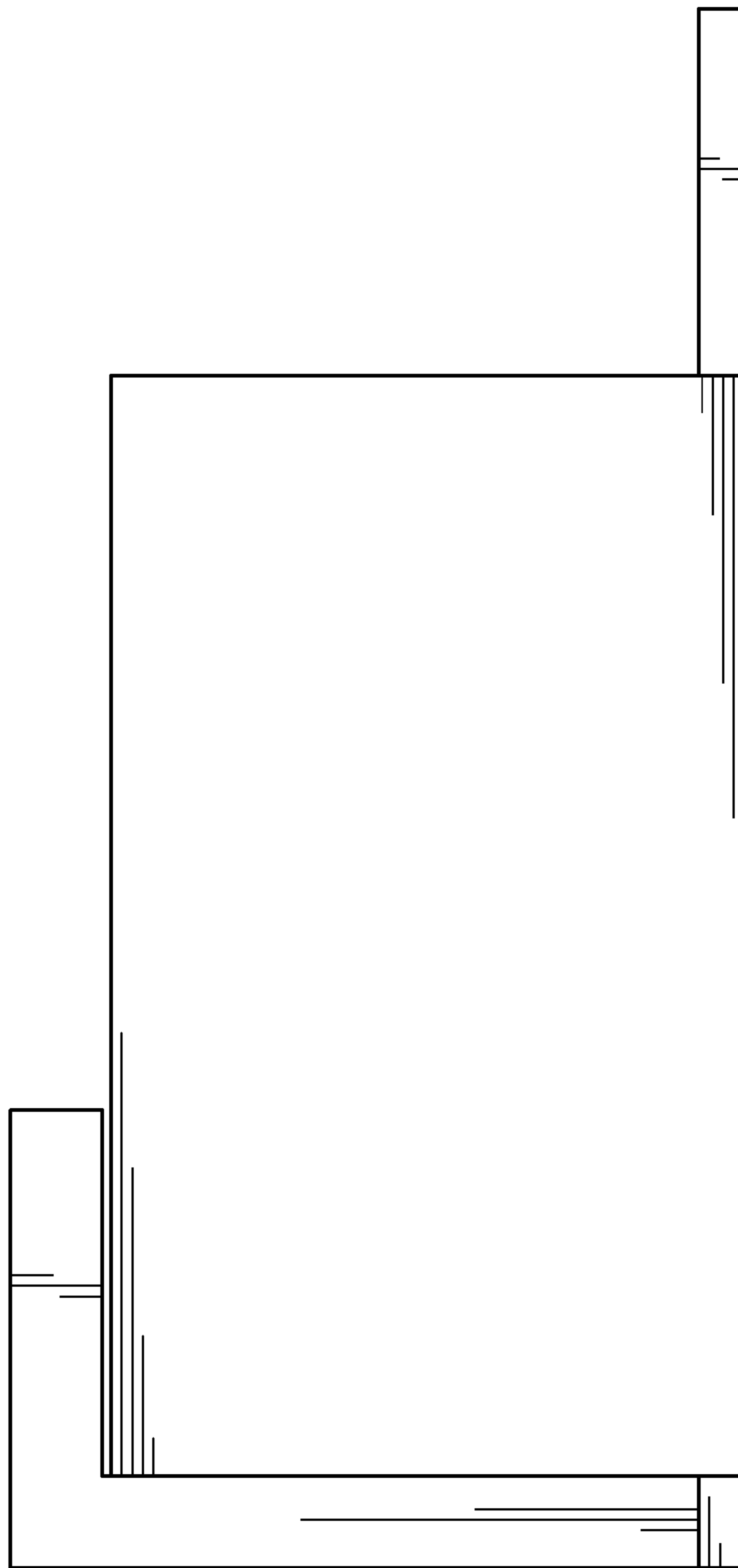

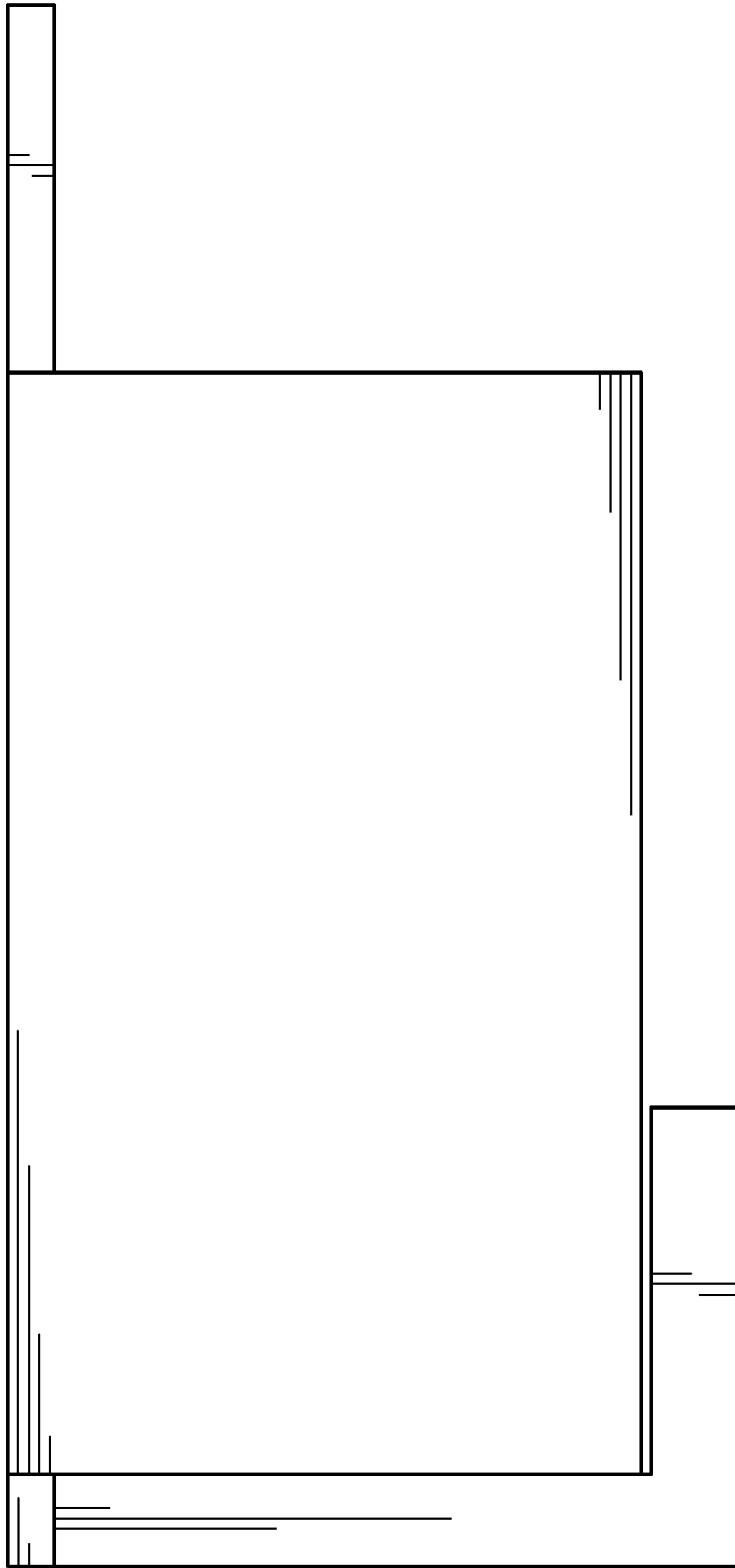

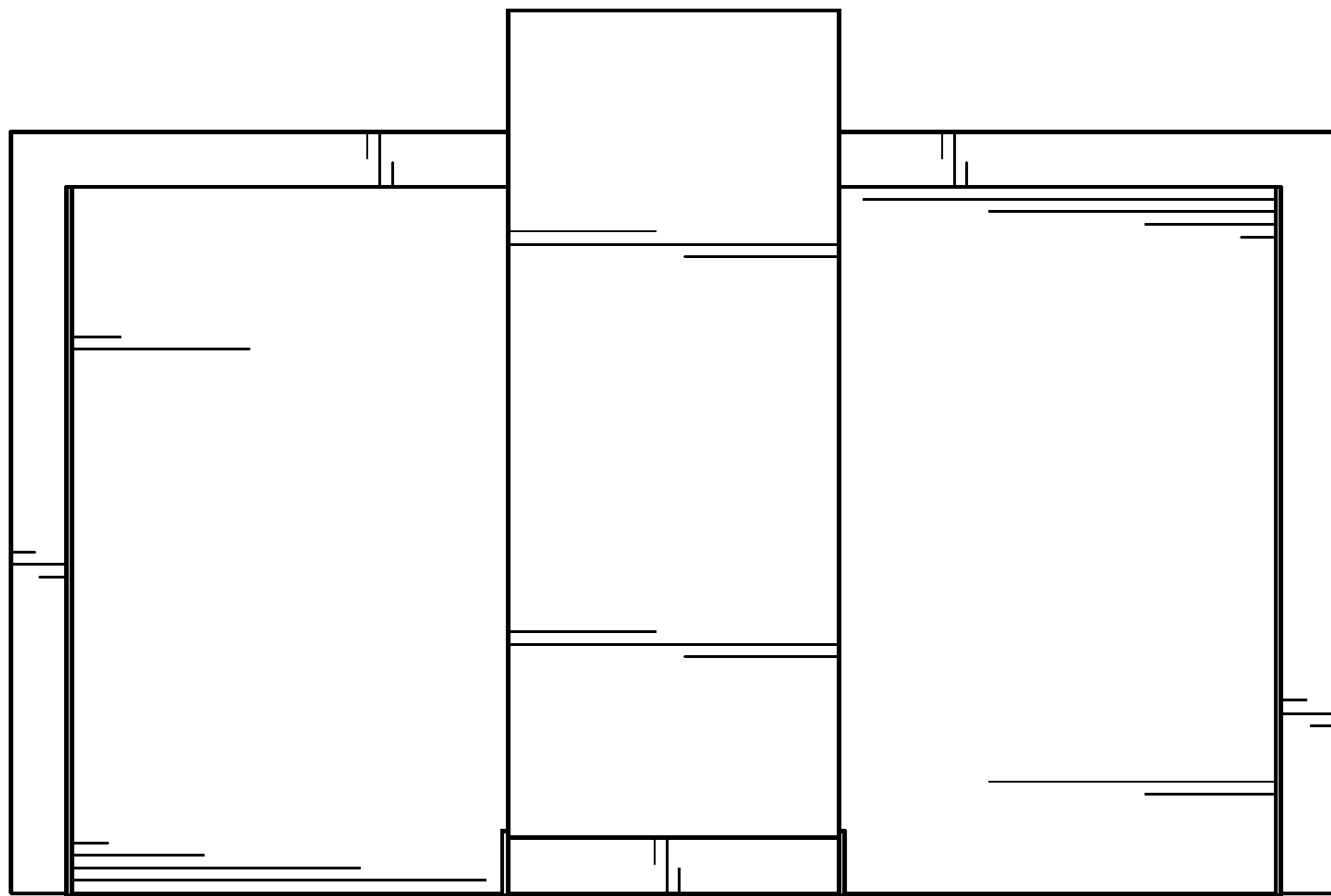

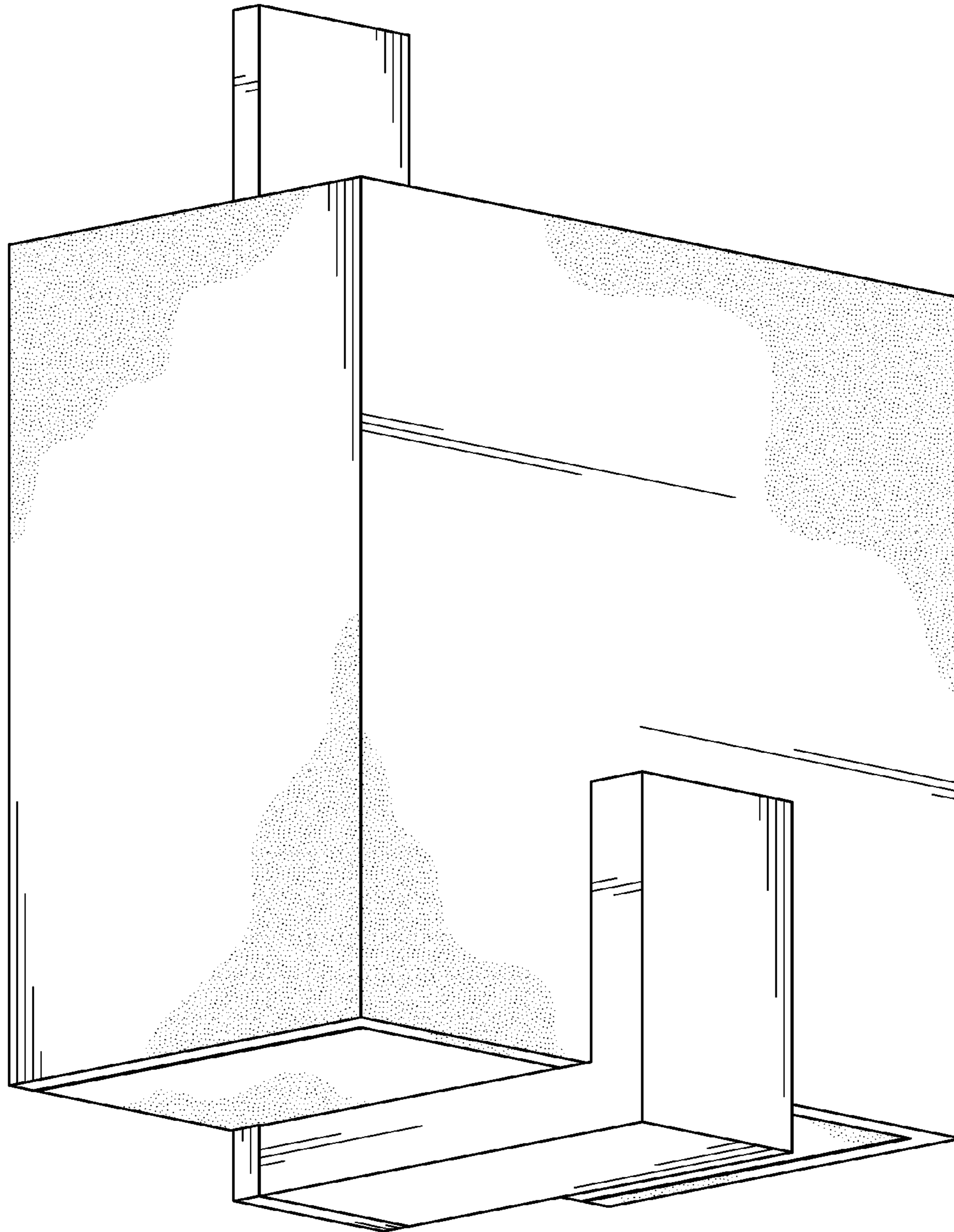

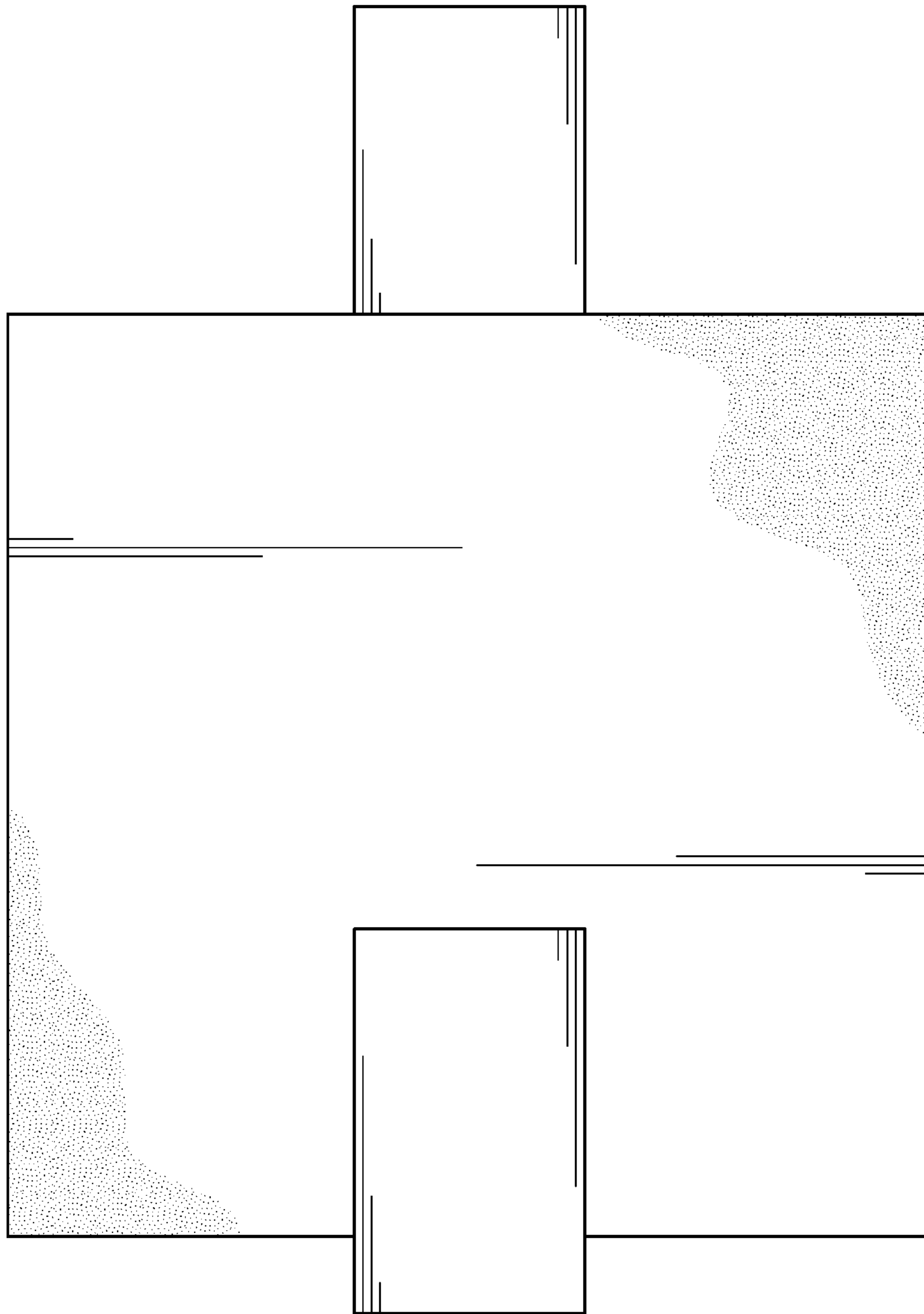

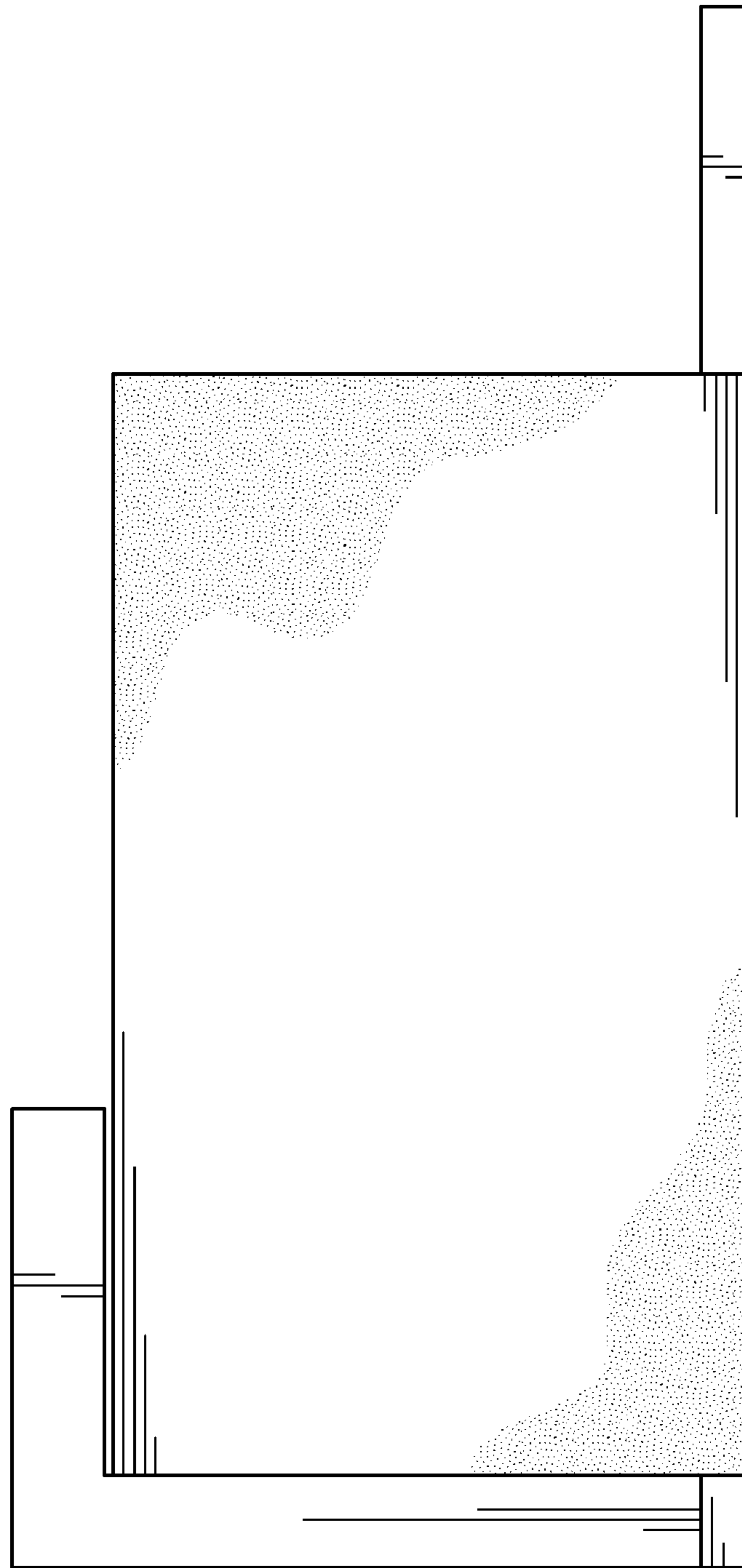

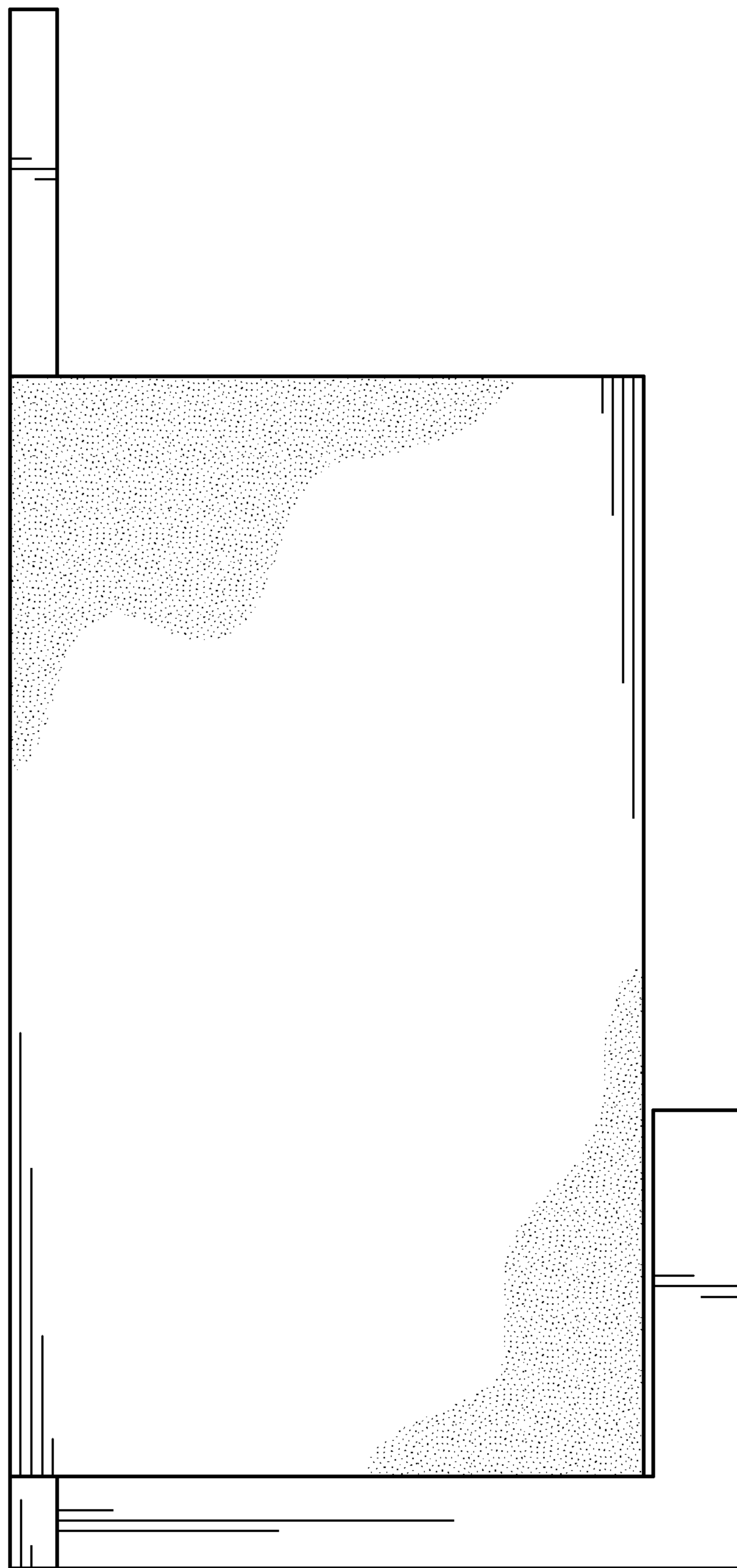

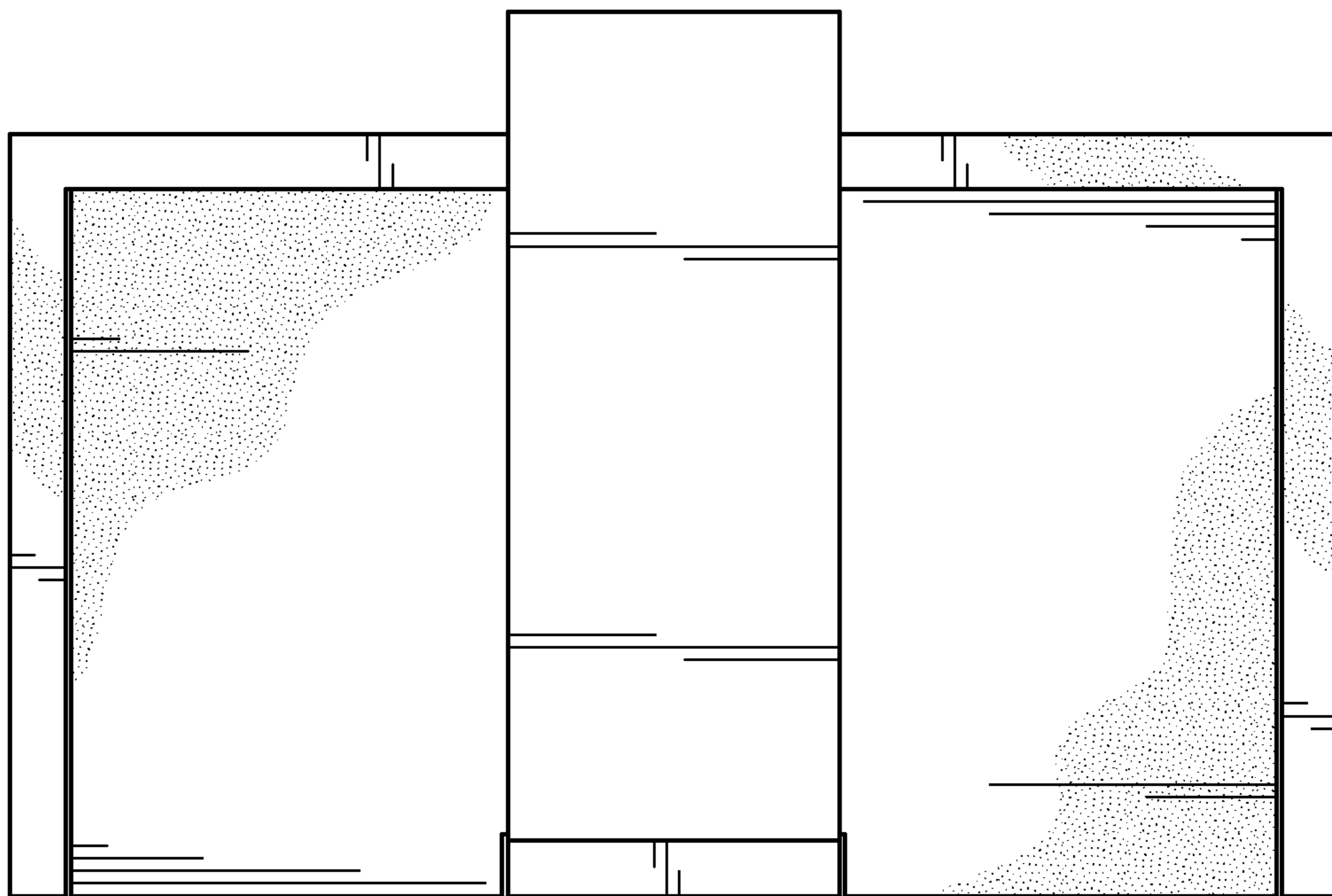
