The ornamental design for a washing ball, as shown and described.

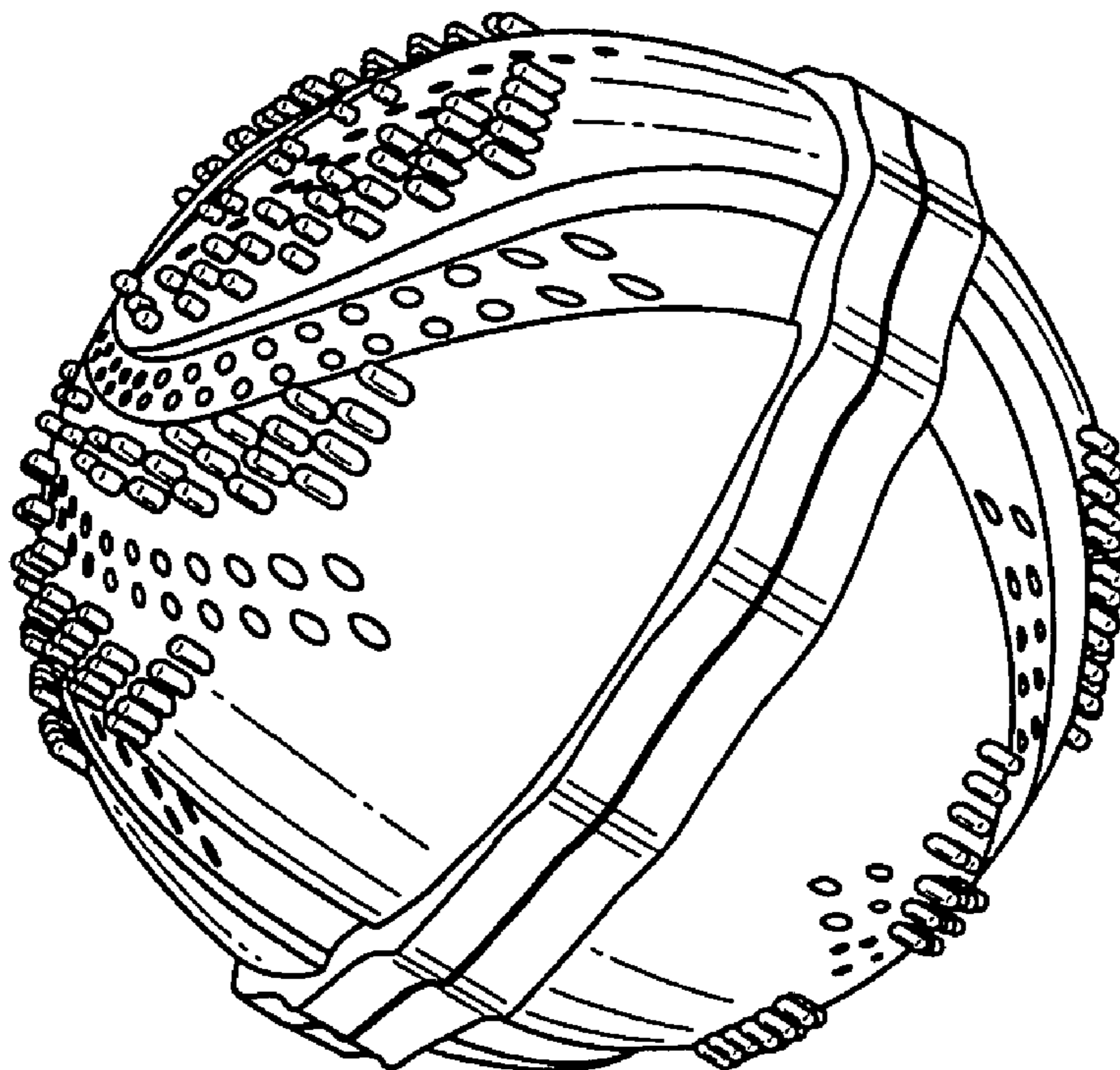
**DESCRIPTION**

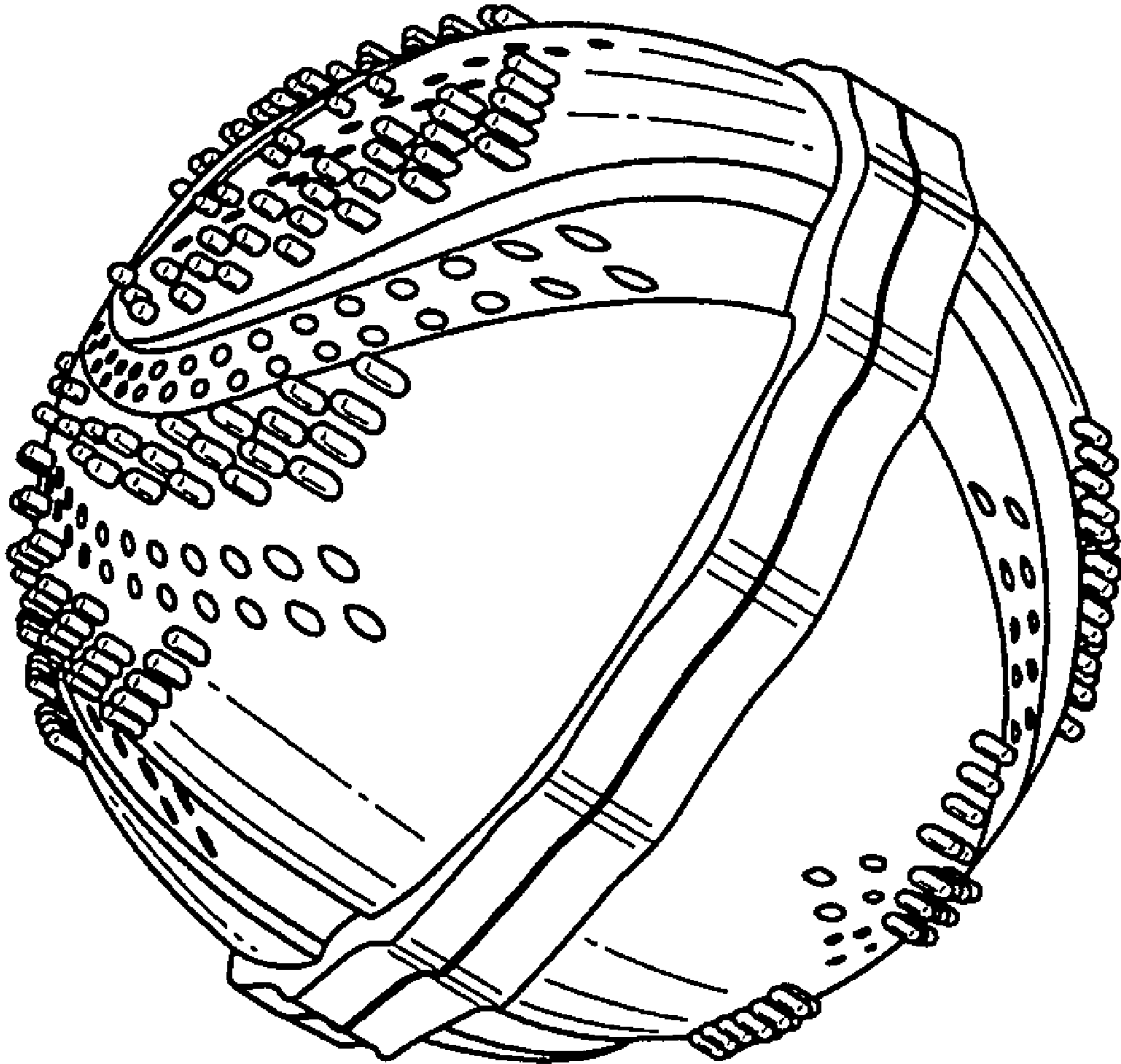
FIG. 1 is a perspective view of a washing ball illustrating my new design;

FIG. 2 is a top view thereof; and,

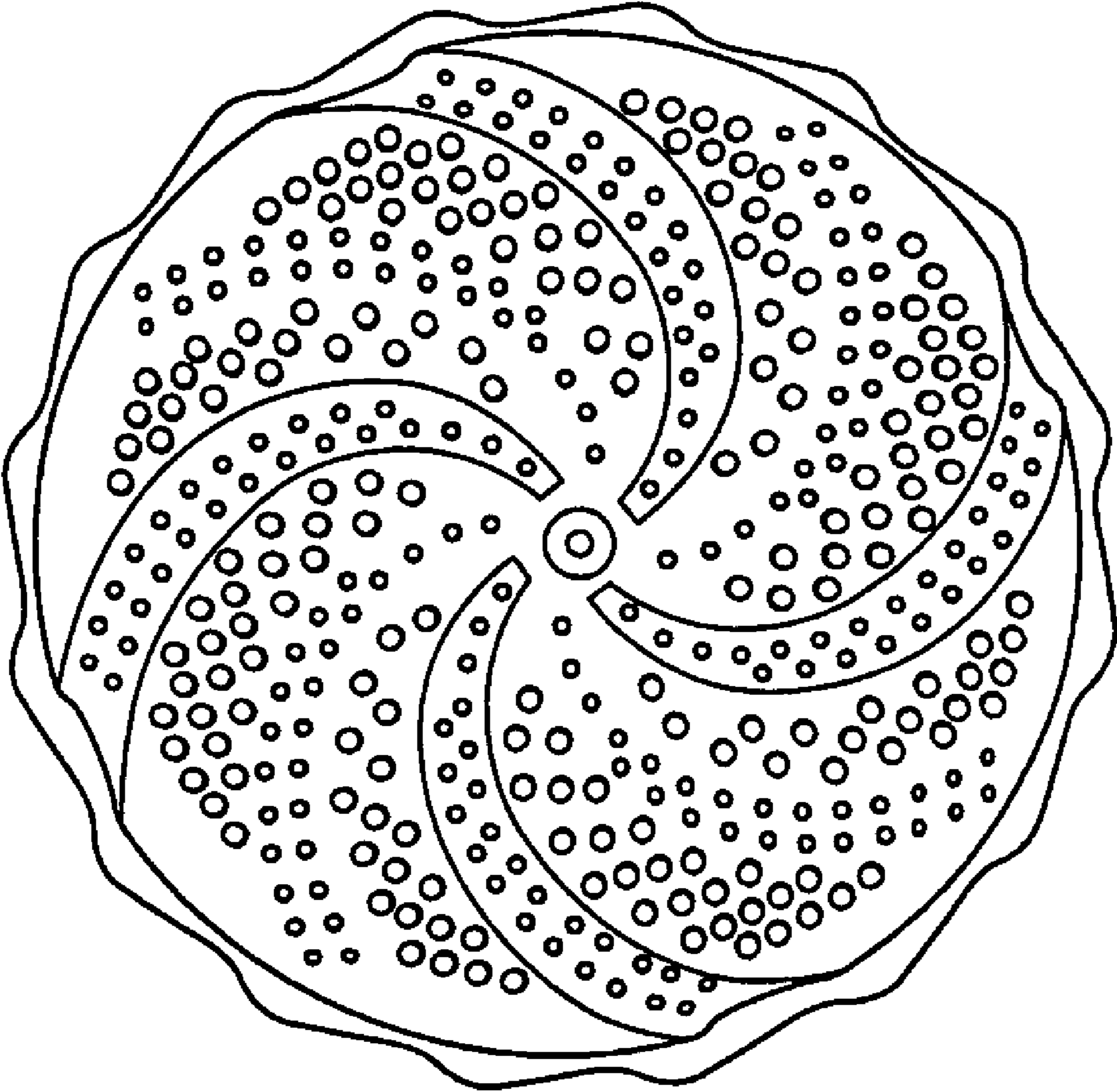
FIG. 3 is a side view thereof.

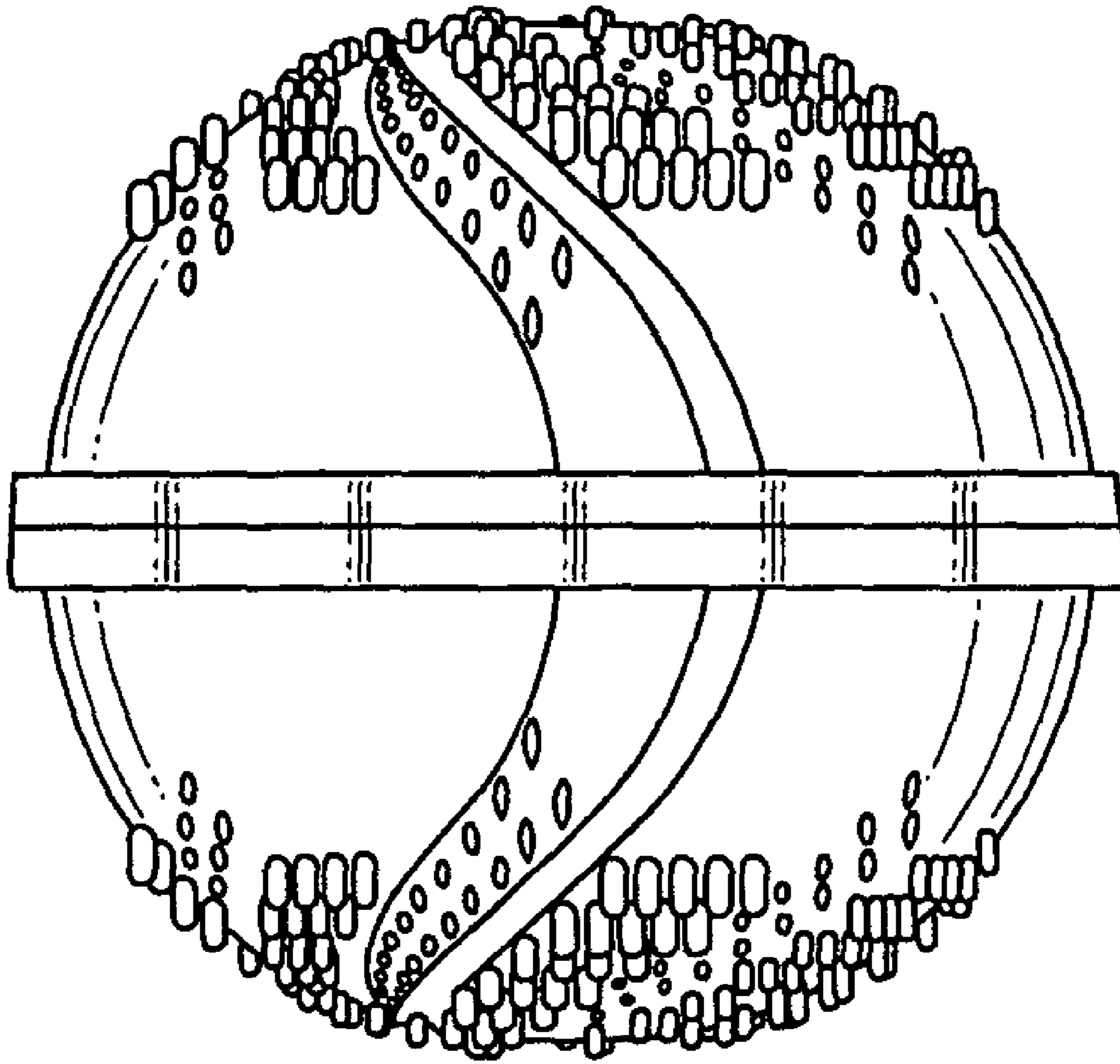
