(57) **CLAIM**

The ornamental design for a baby garment, as shown and described.

DESCRIPTION

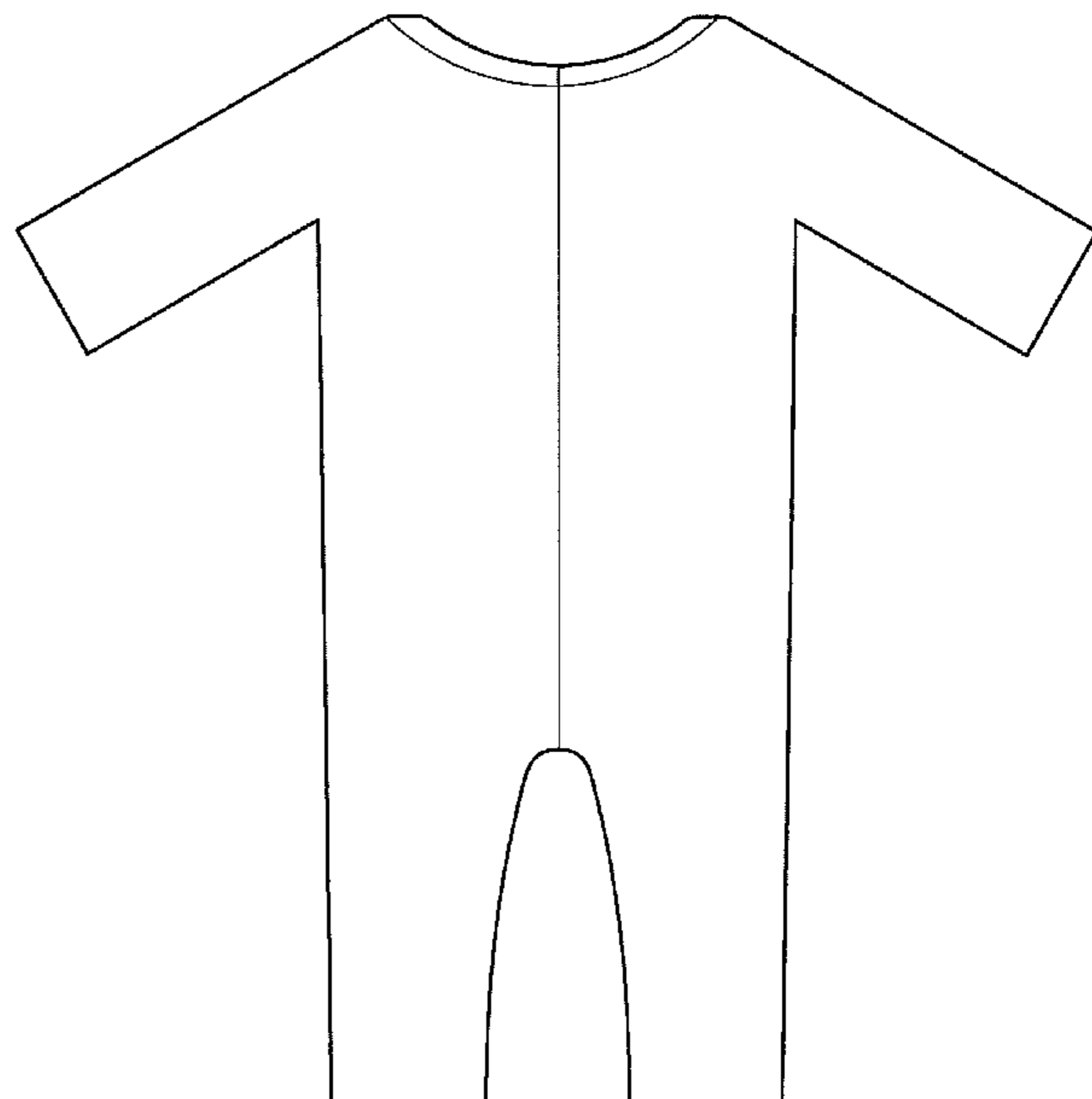
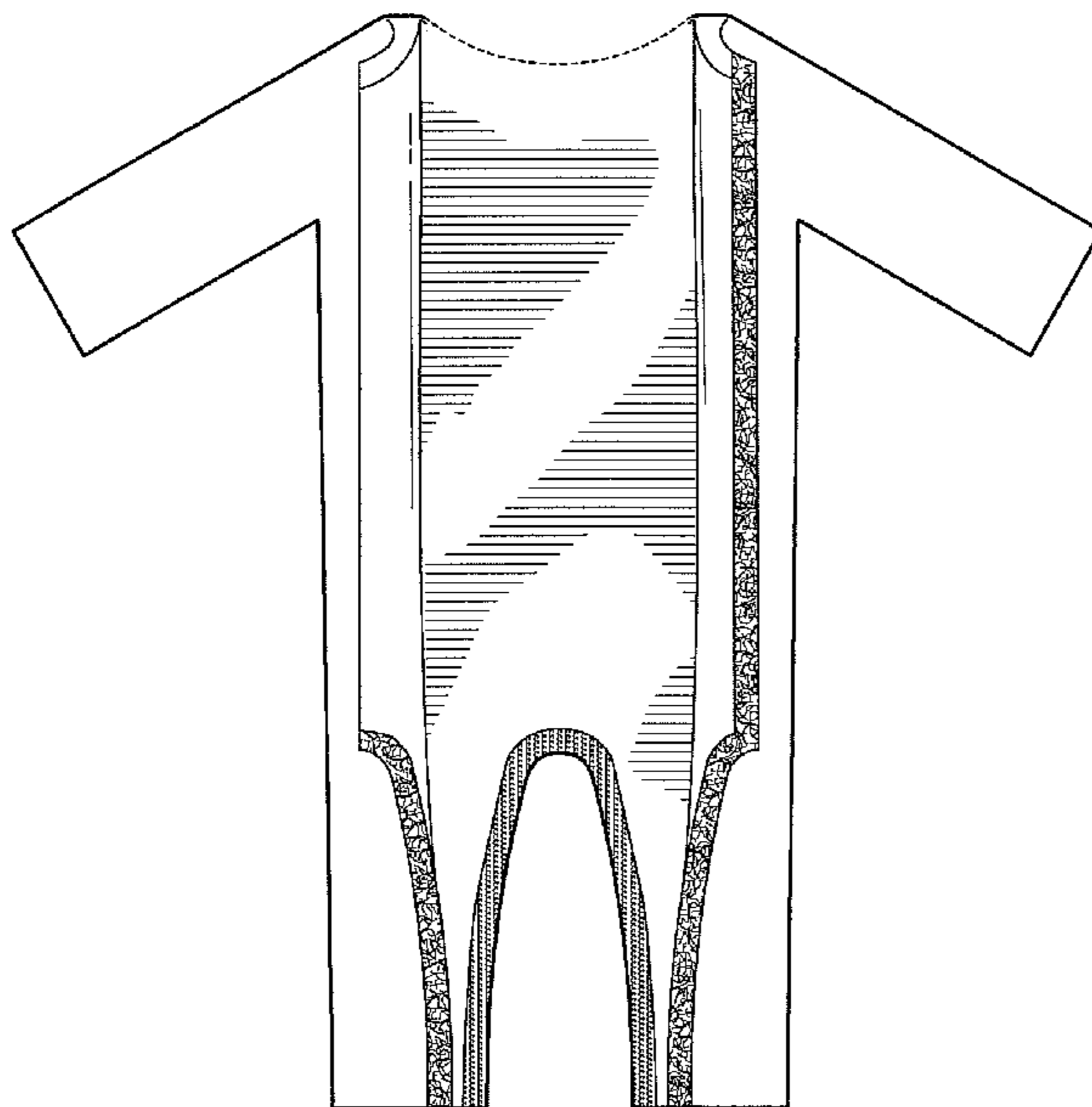
FIG. 1 is a front elevational view of a baby garment incorporating the design, with the front panels partially separated to show details of the design;

FIG. 2 is a front elevational view of the baby garment of FIG. 1, shown with a left panel closed while the right panel remains open; and,

FIG. 3 is a front elevational view of the baby garment shown in FIGS. 1 and 2, with both panels closed; the undisclosed rear view of the garment is unornamented and forms no part of the claimed design.

The portion of the design shown in broken lines forms no part of the claim.

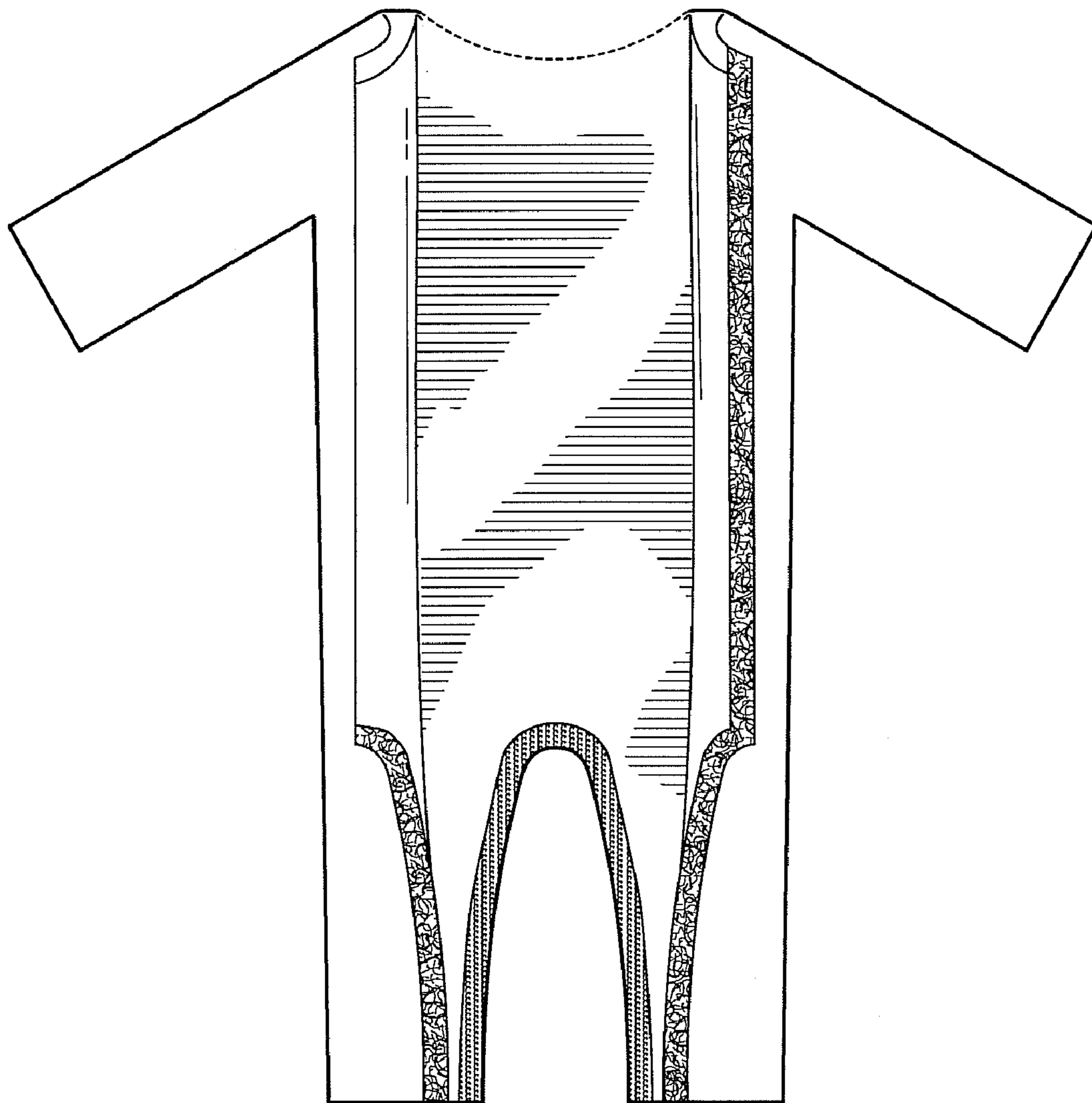

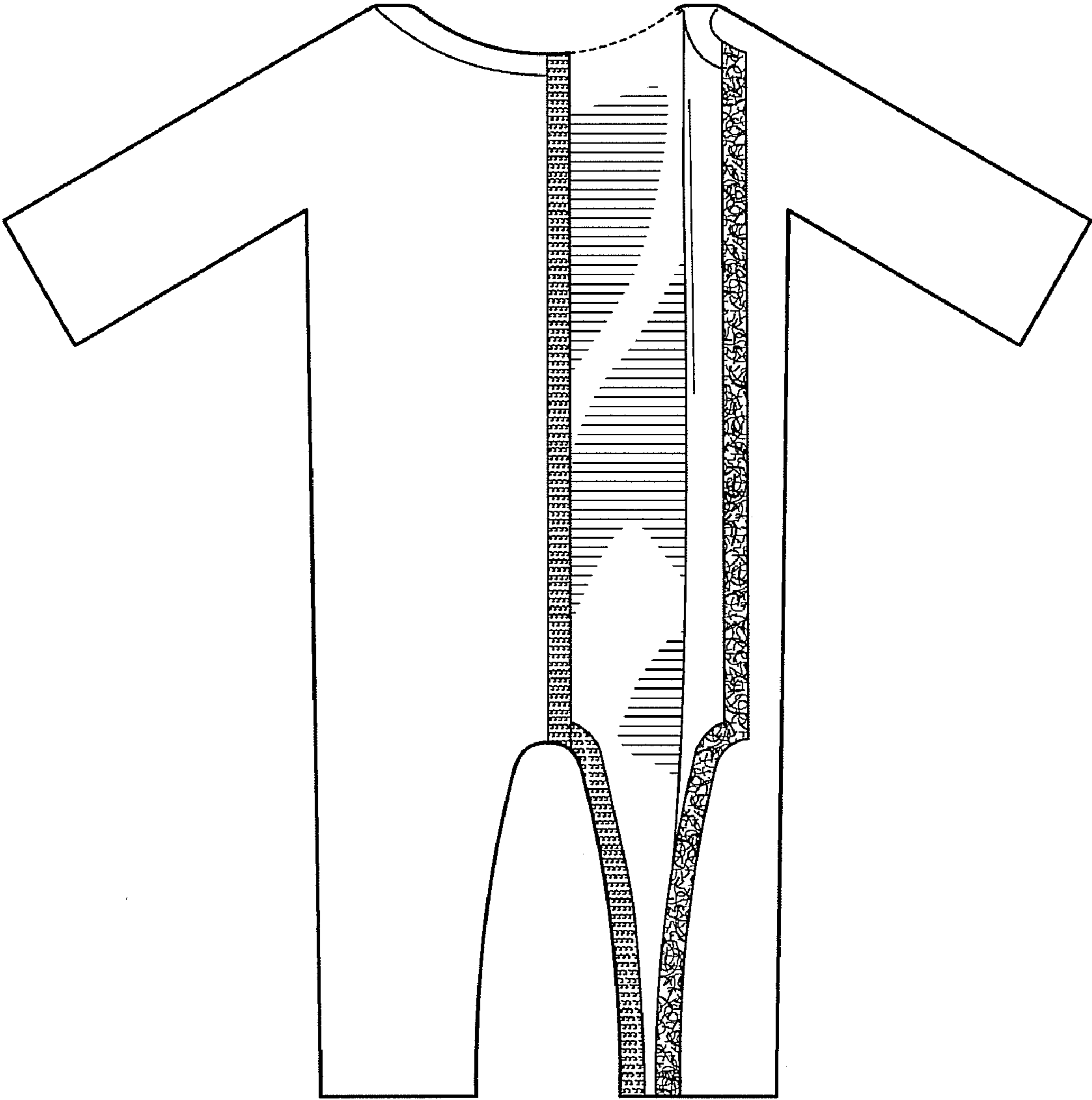

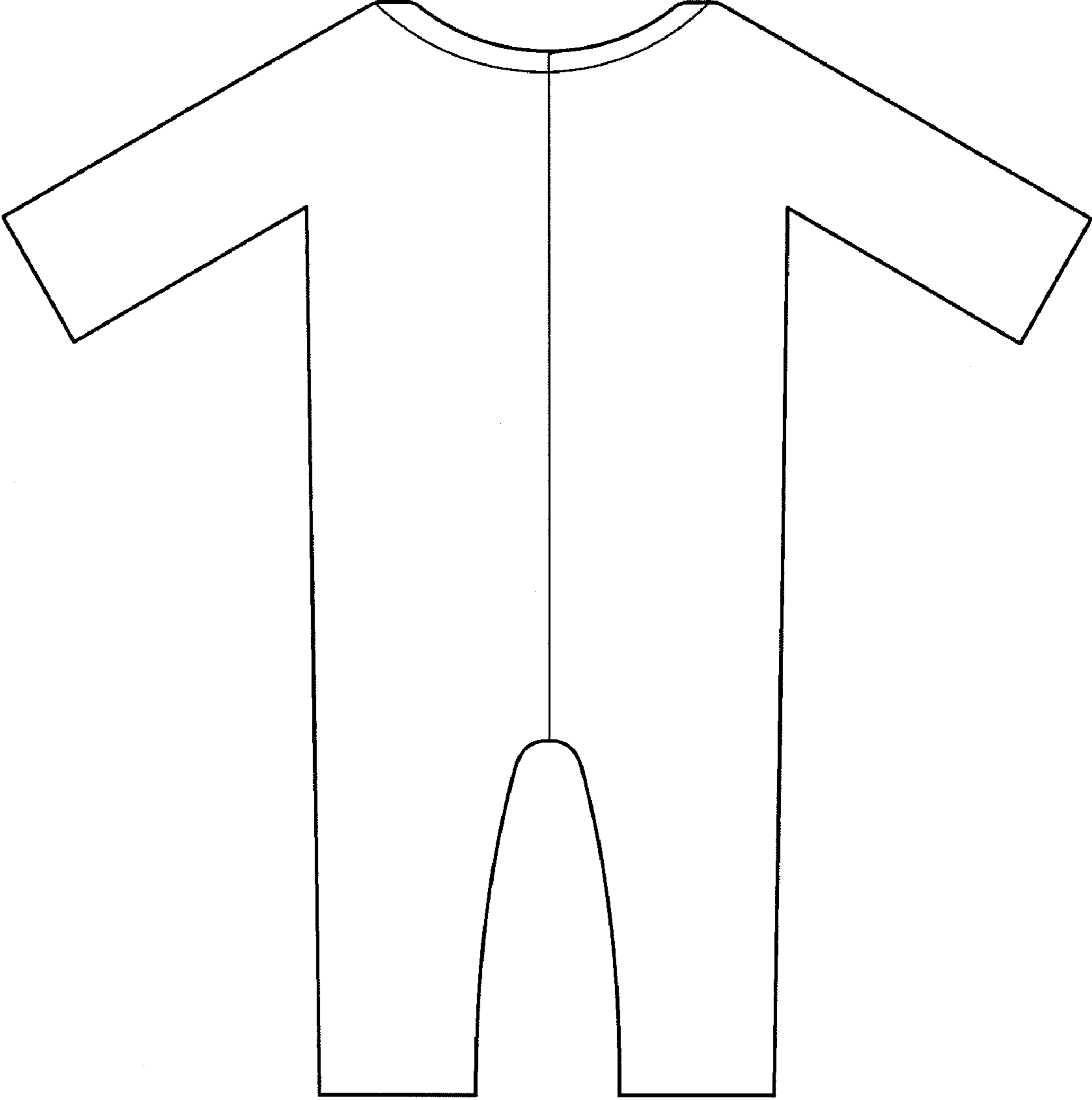
