(57) **CLAIM**

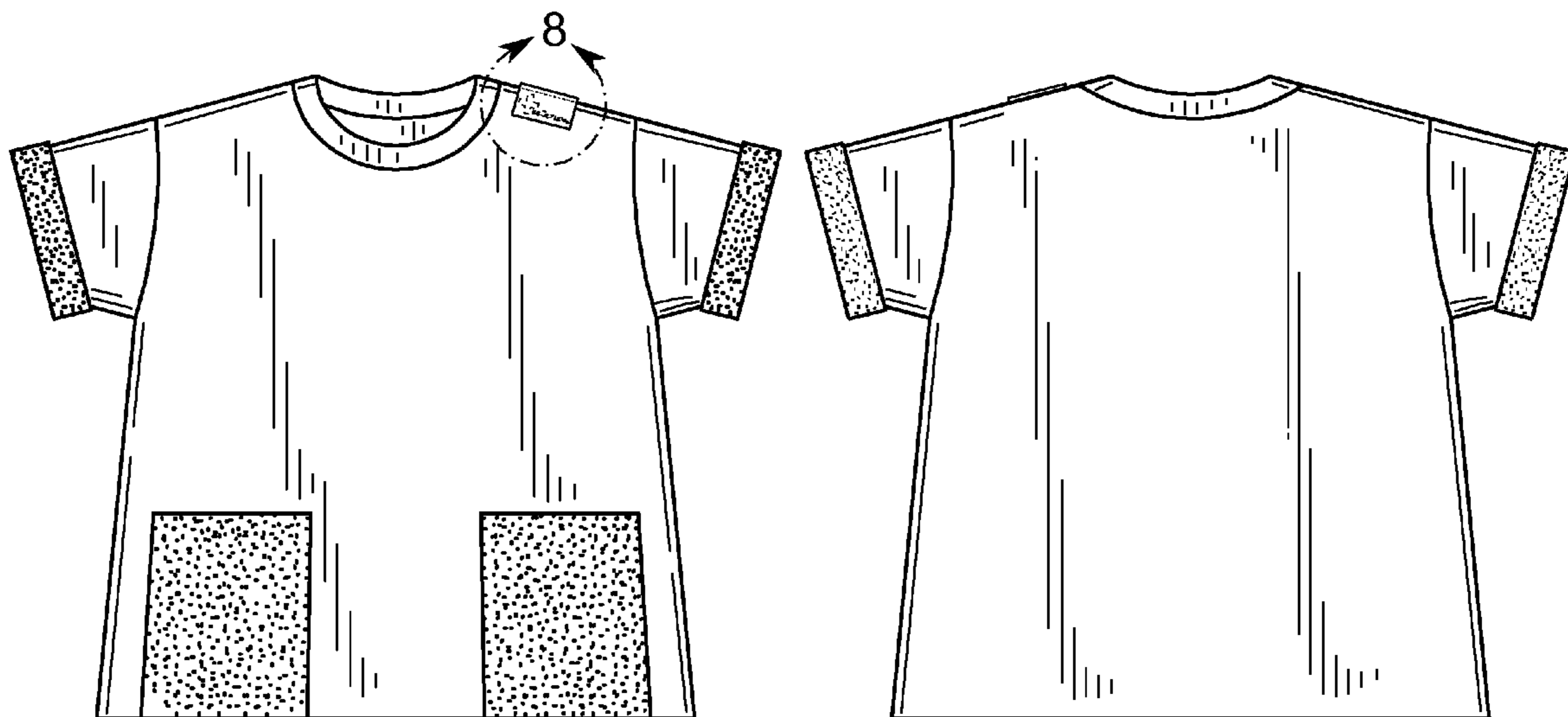
I claim the ornamental design for hospital scrubs with a clip attachment, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of hospital scrubs with a clip attachment, showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a left-side elevational view thereof; FIG. 4 is a right-side elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a top plan view thereof; and FIG. 7 is a bottom plan view thereof; and FIG. 8 is an enlarged partial elevational view, taken generally along lines 8-8 of FIG. 2.

The broken lines showing a person in FIG. 1 depict environmental matter and form no part of the claimed design. The remaining lines represent stitching and form part of the claimed design.

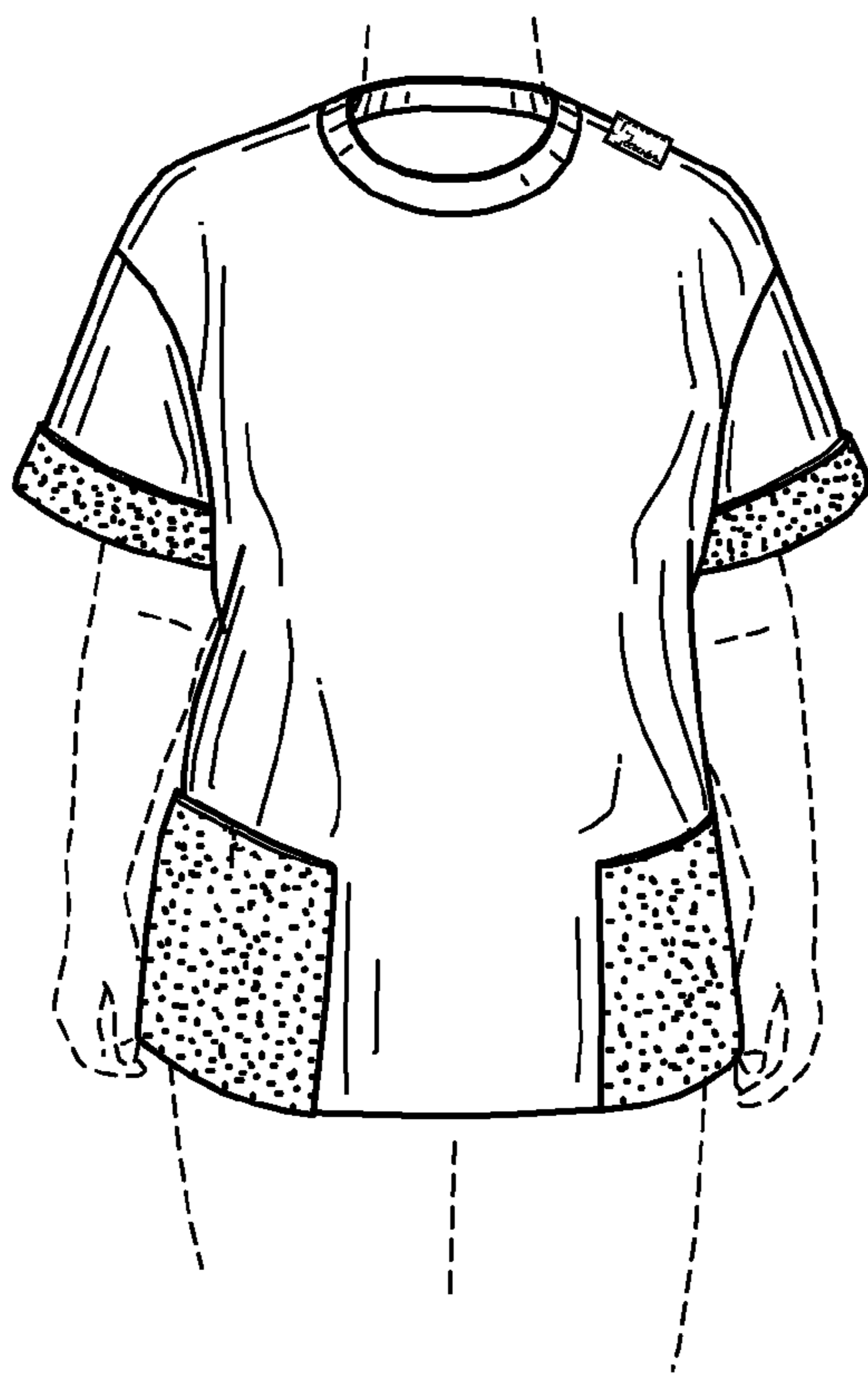

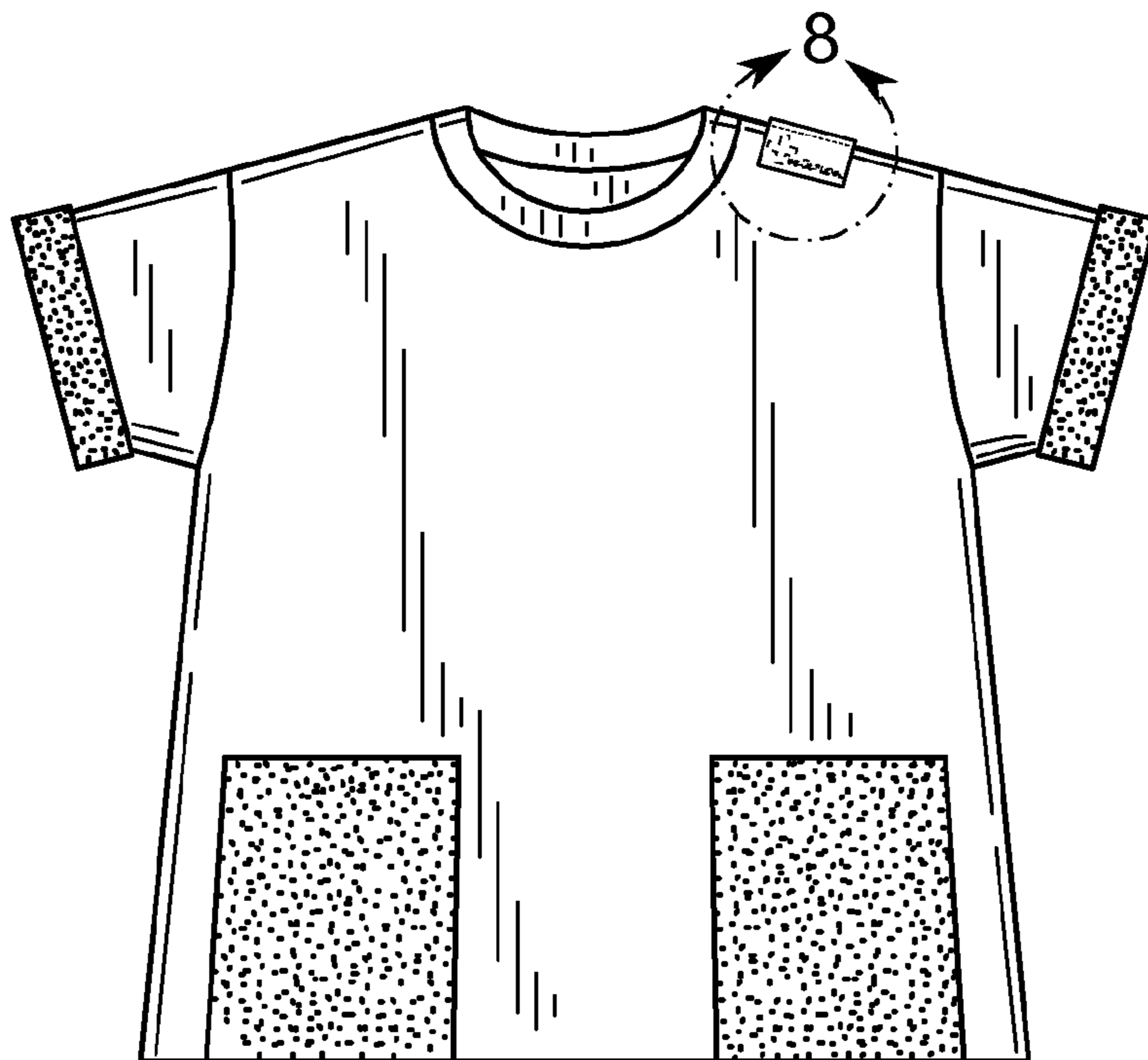

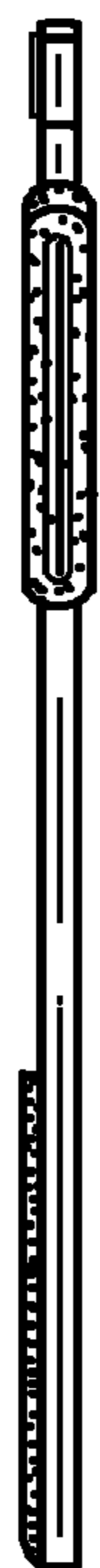

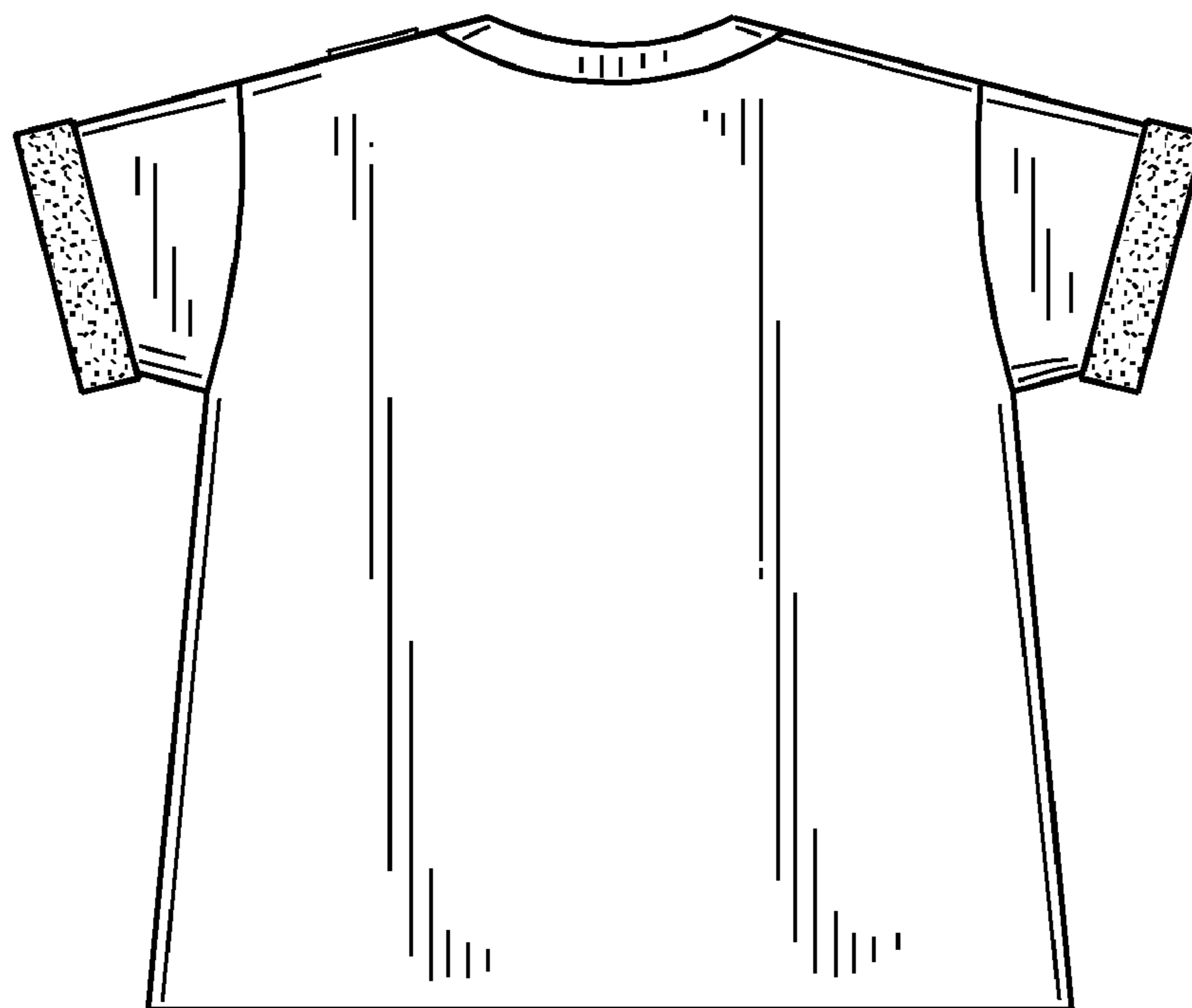

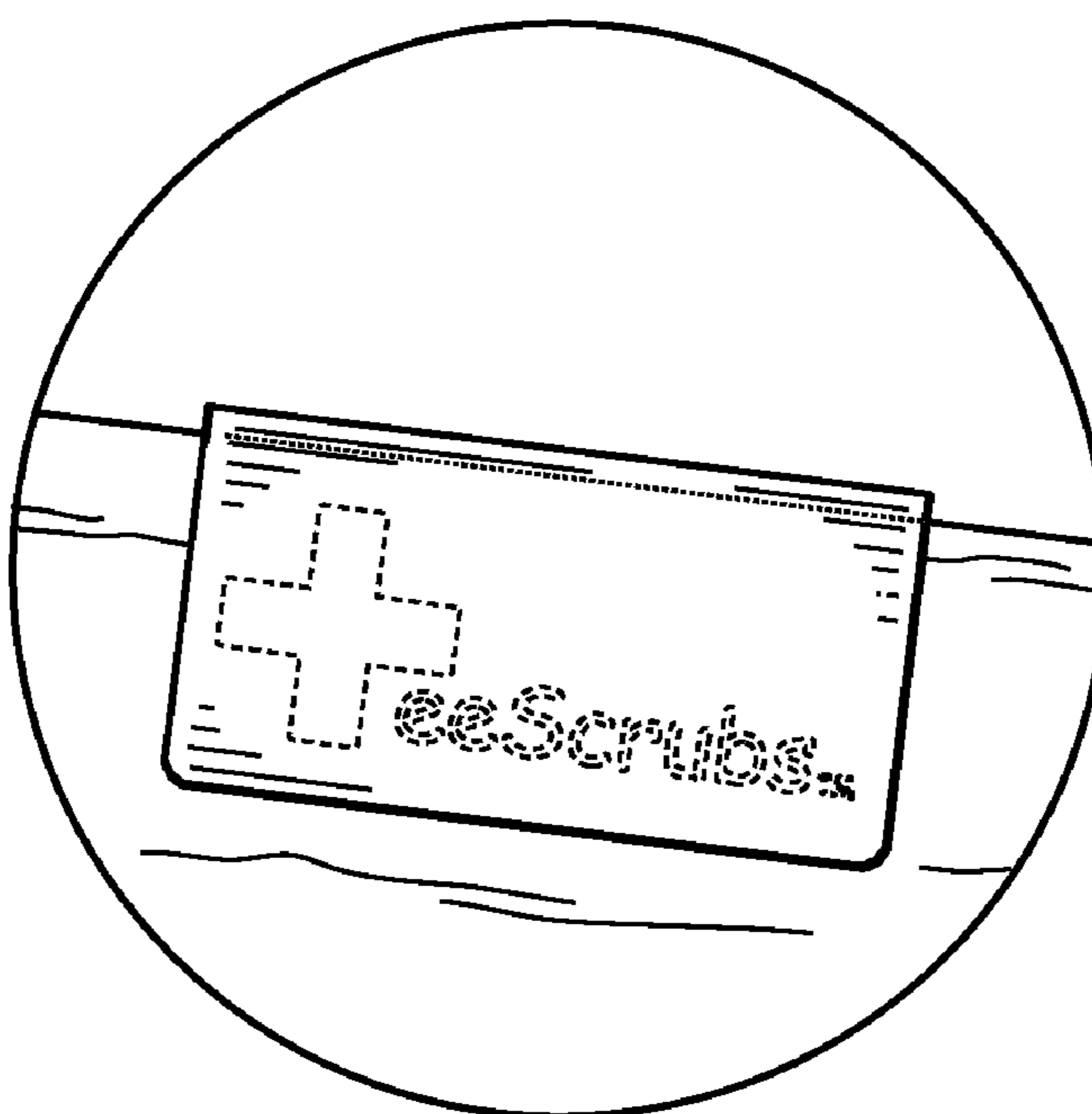
