FIG. 2 is a rear elevational view of a hat showing my new design;

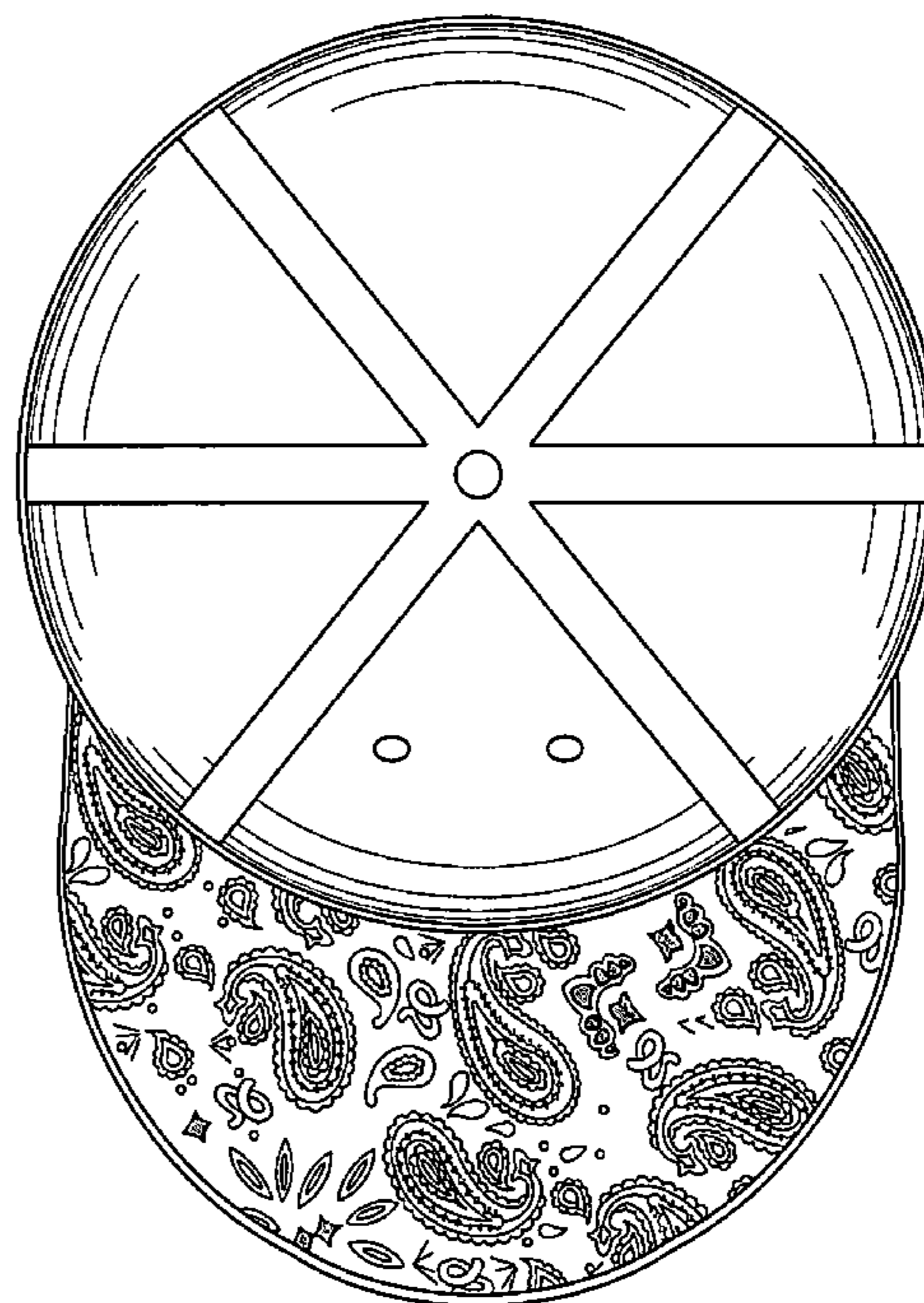
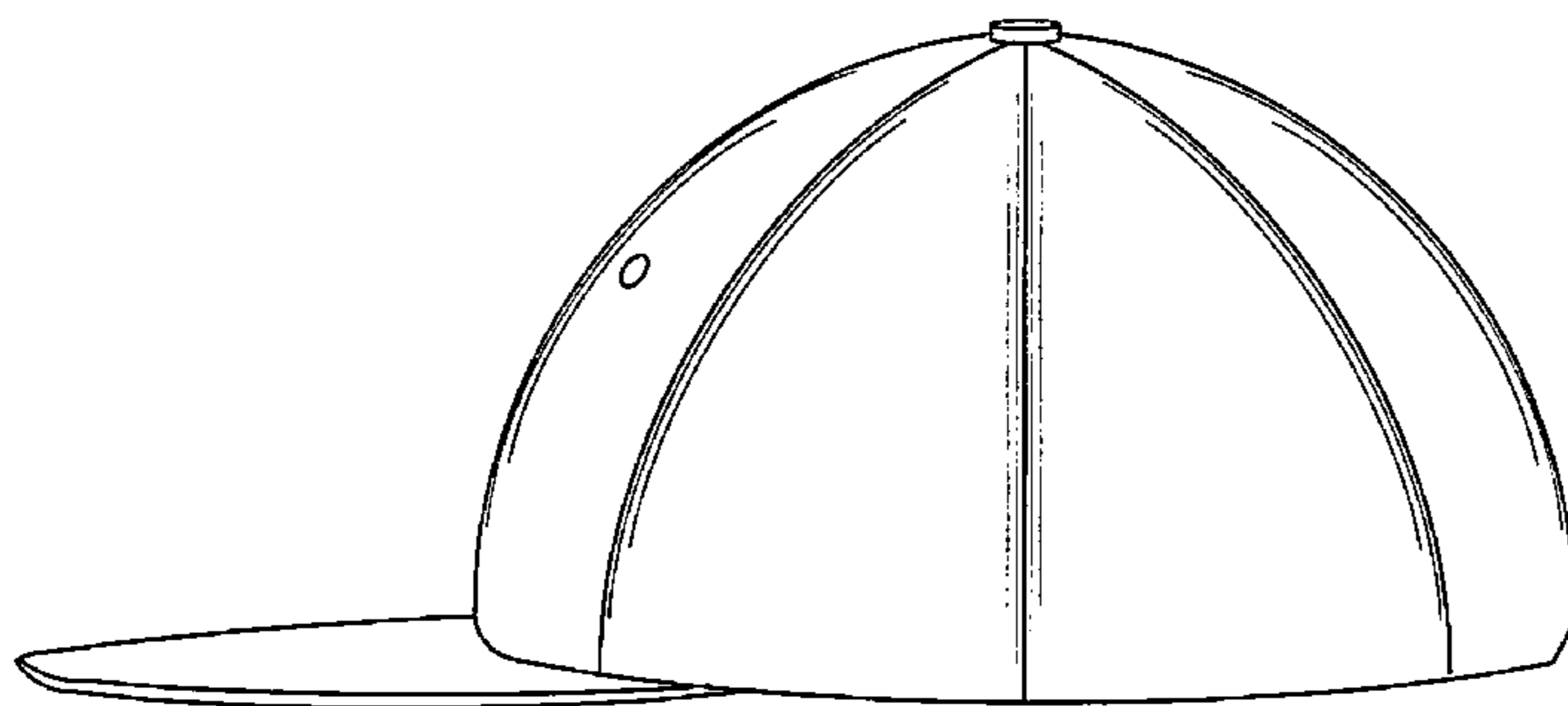
FIG. 3 is a left side elevational view of a hat showing my new design;

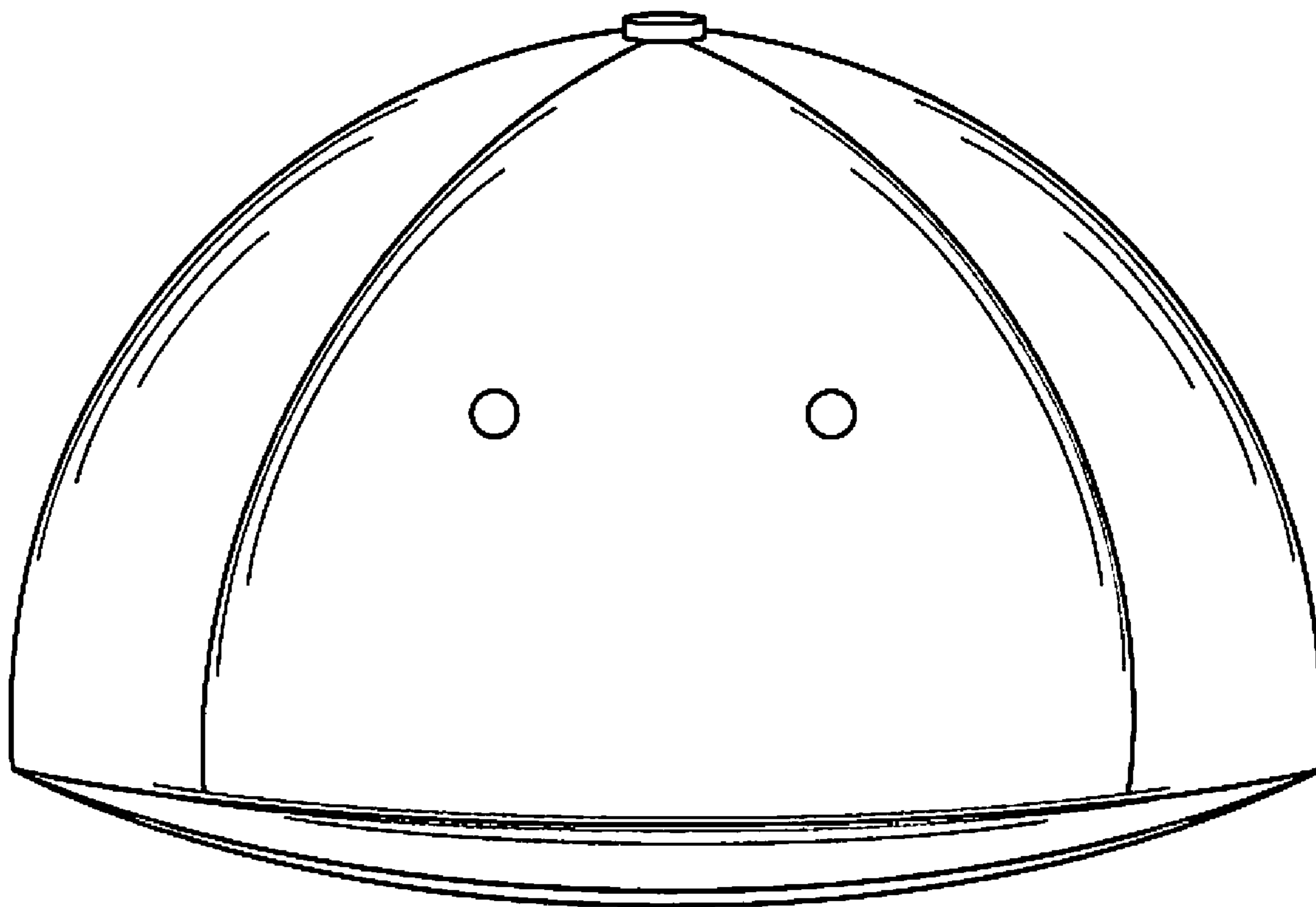

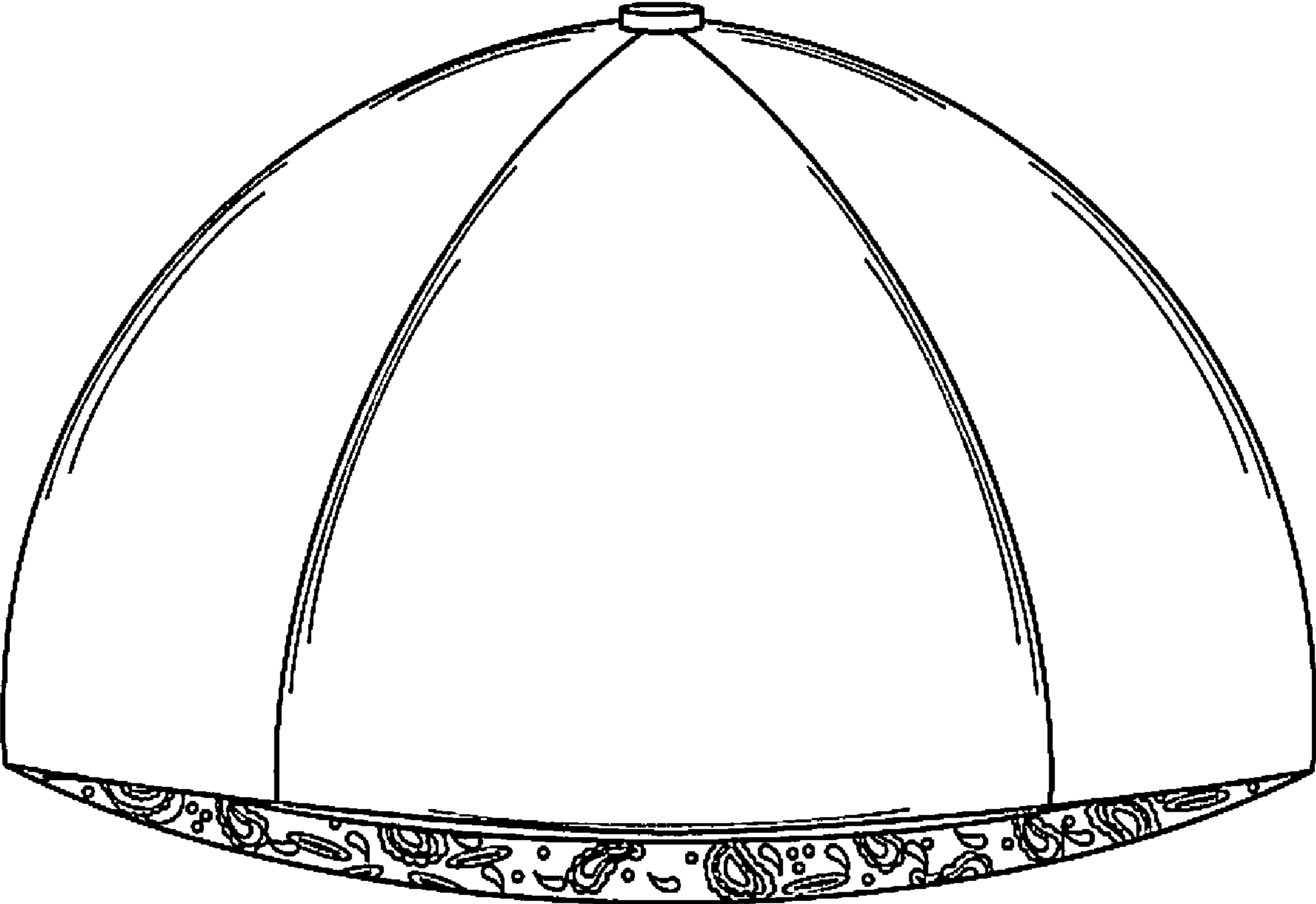

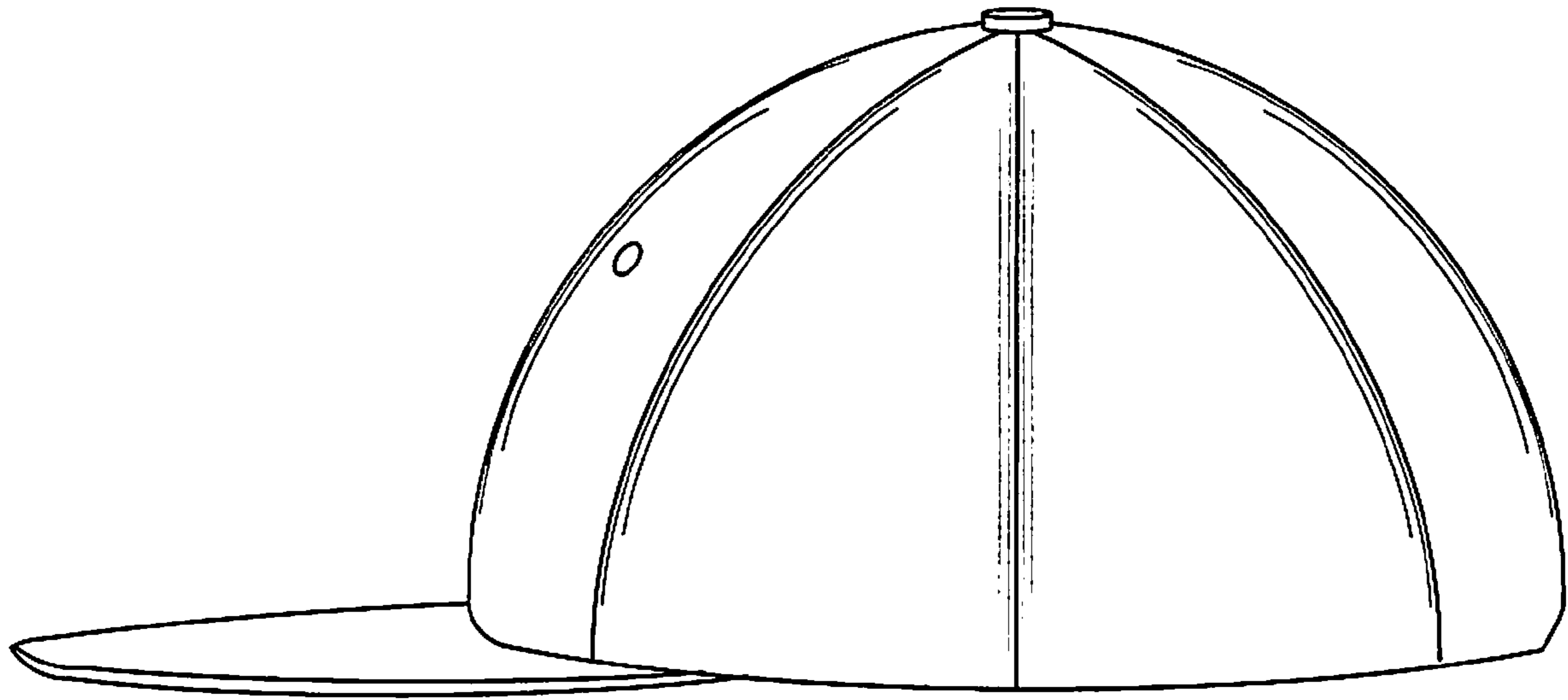

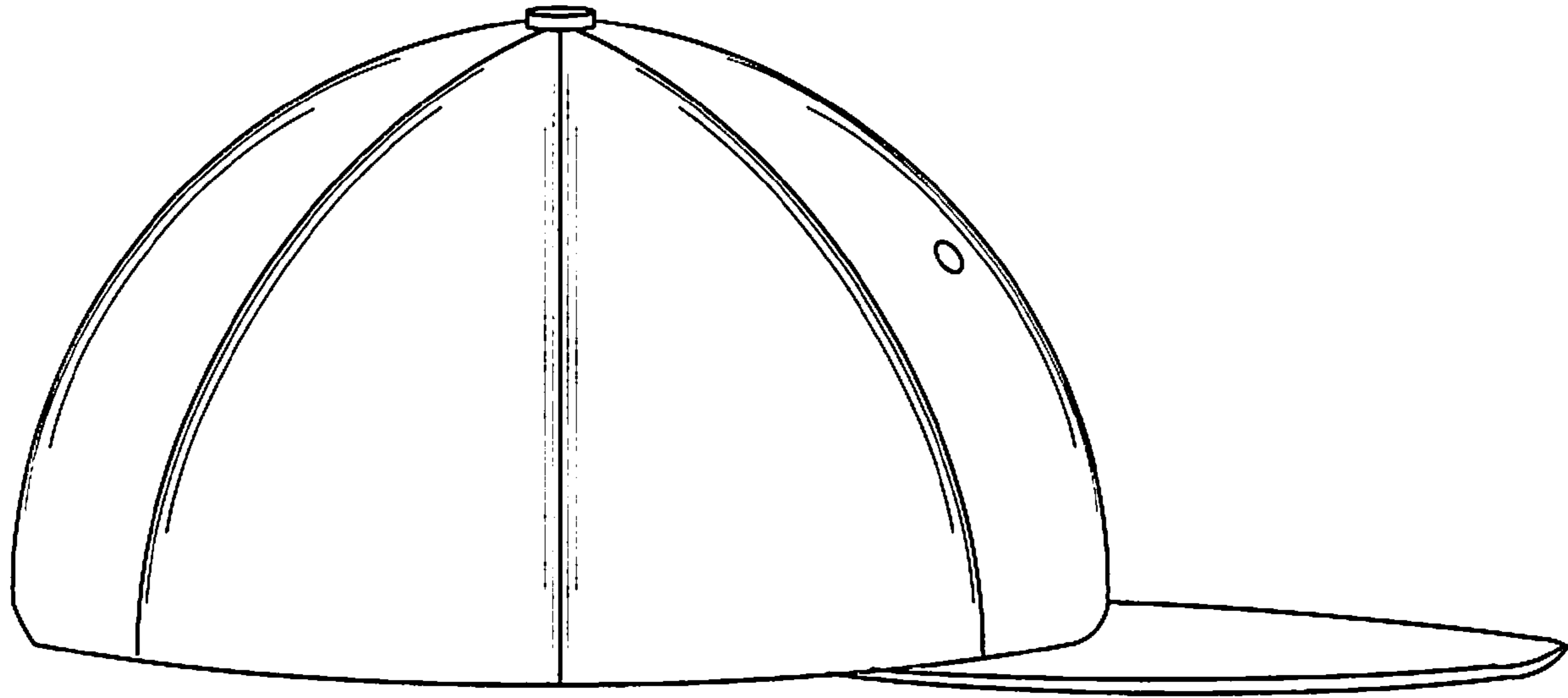

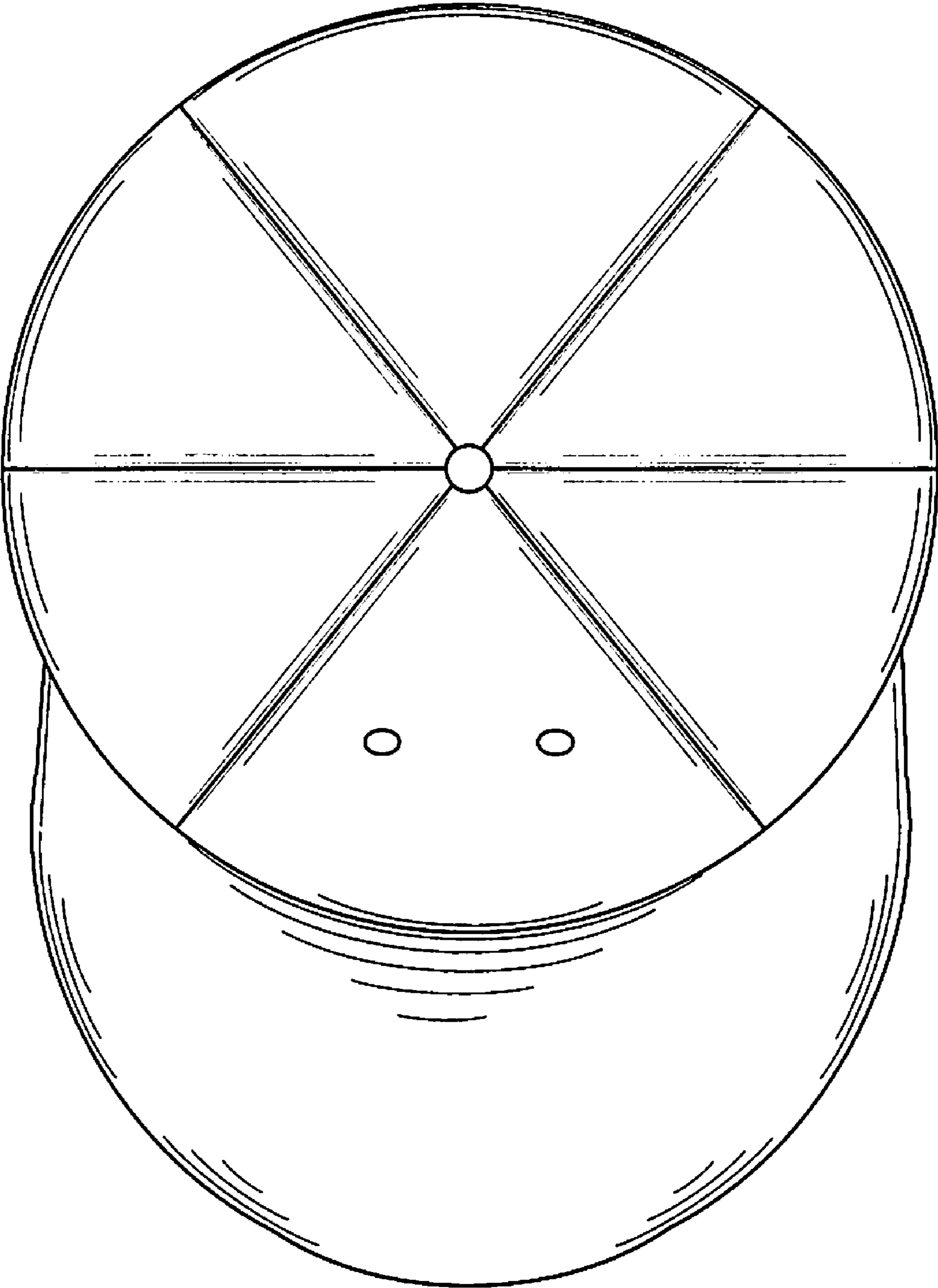

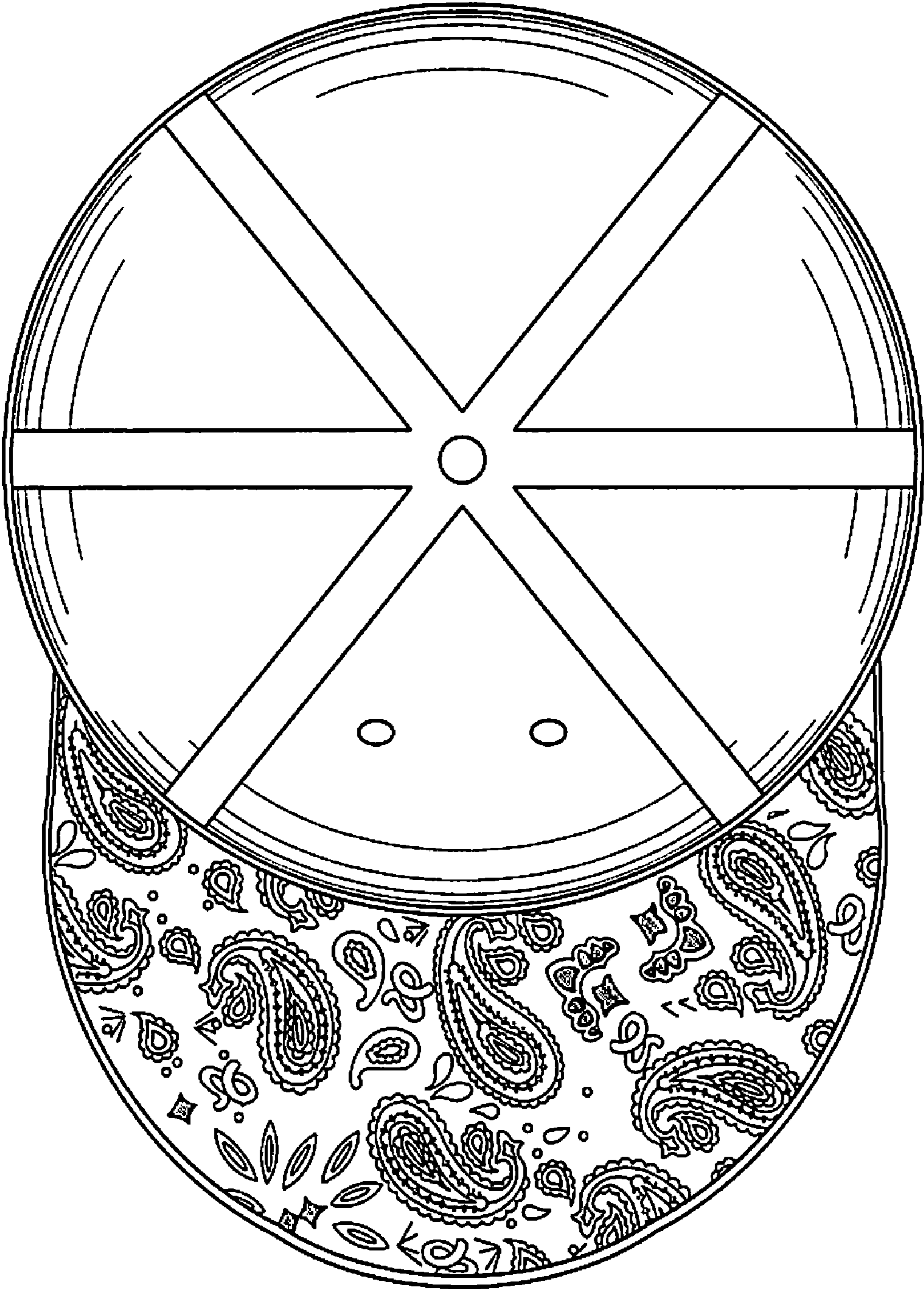
