**DESCRIPTION**

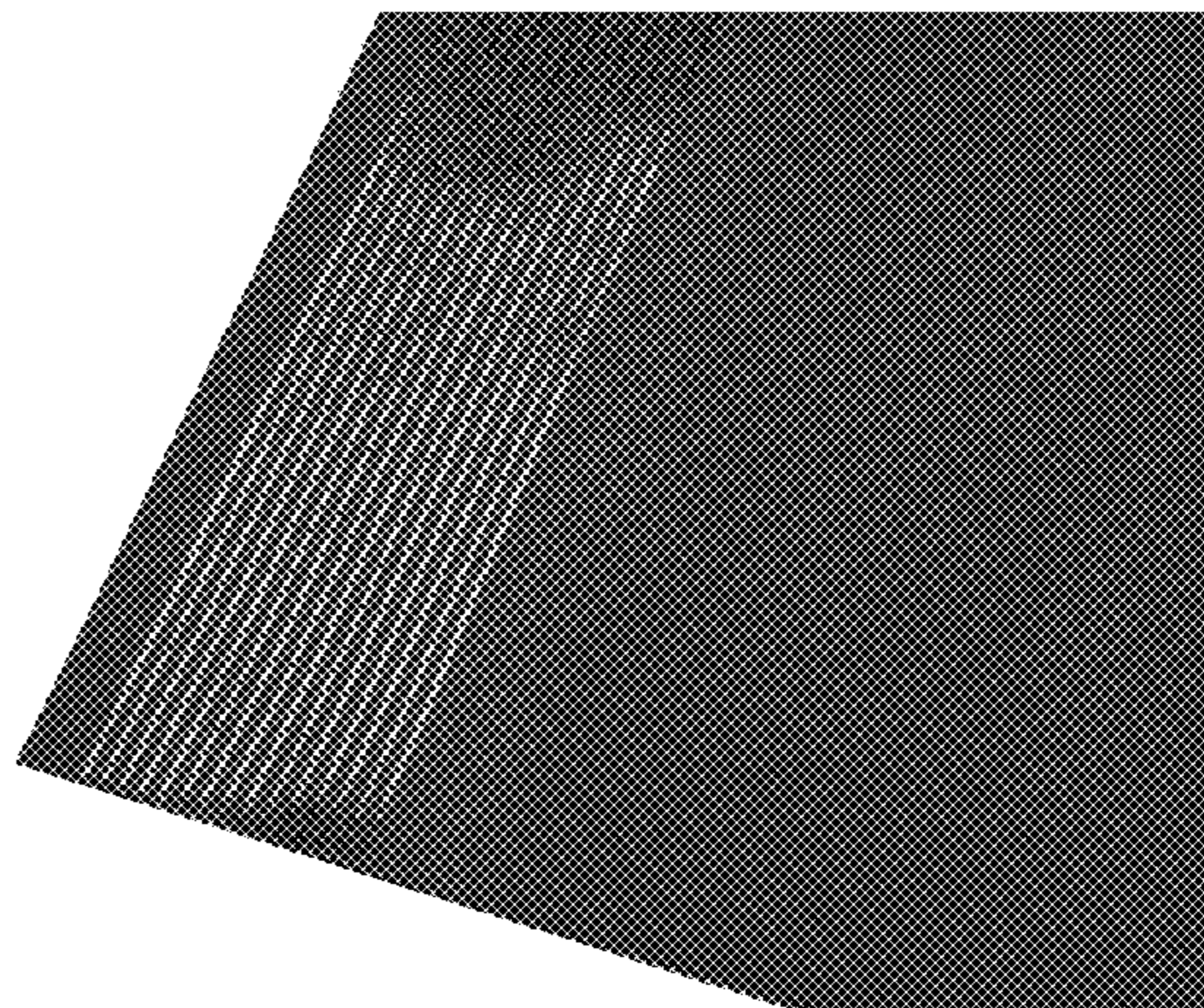
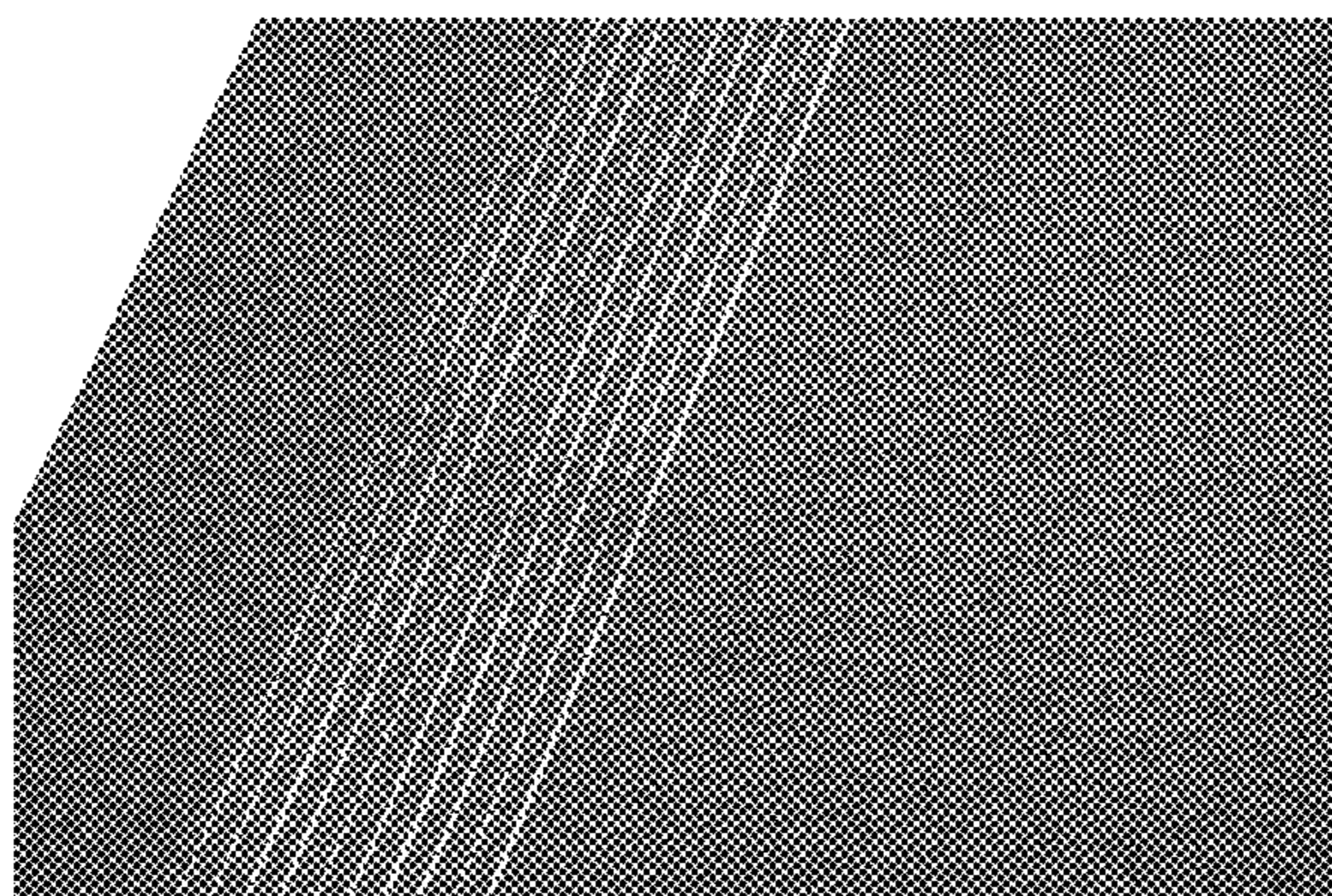
FIG. 2 is a perspective view of the design of FIG. 1 shown as part of a roll;

FIG. 1 is a perspective view of a first embodiment of a flexible sheet material in accordance with the present invention. The figure is an enlarged detail of FIG. 2;

FIG. 3 is a perspective view of a second embodiment of a flexible sheet material in accordance with the present invention. The figure is an enlarged detail of FIG. 4; and,

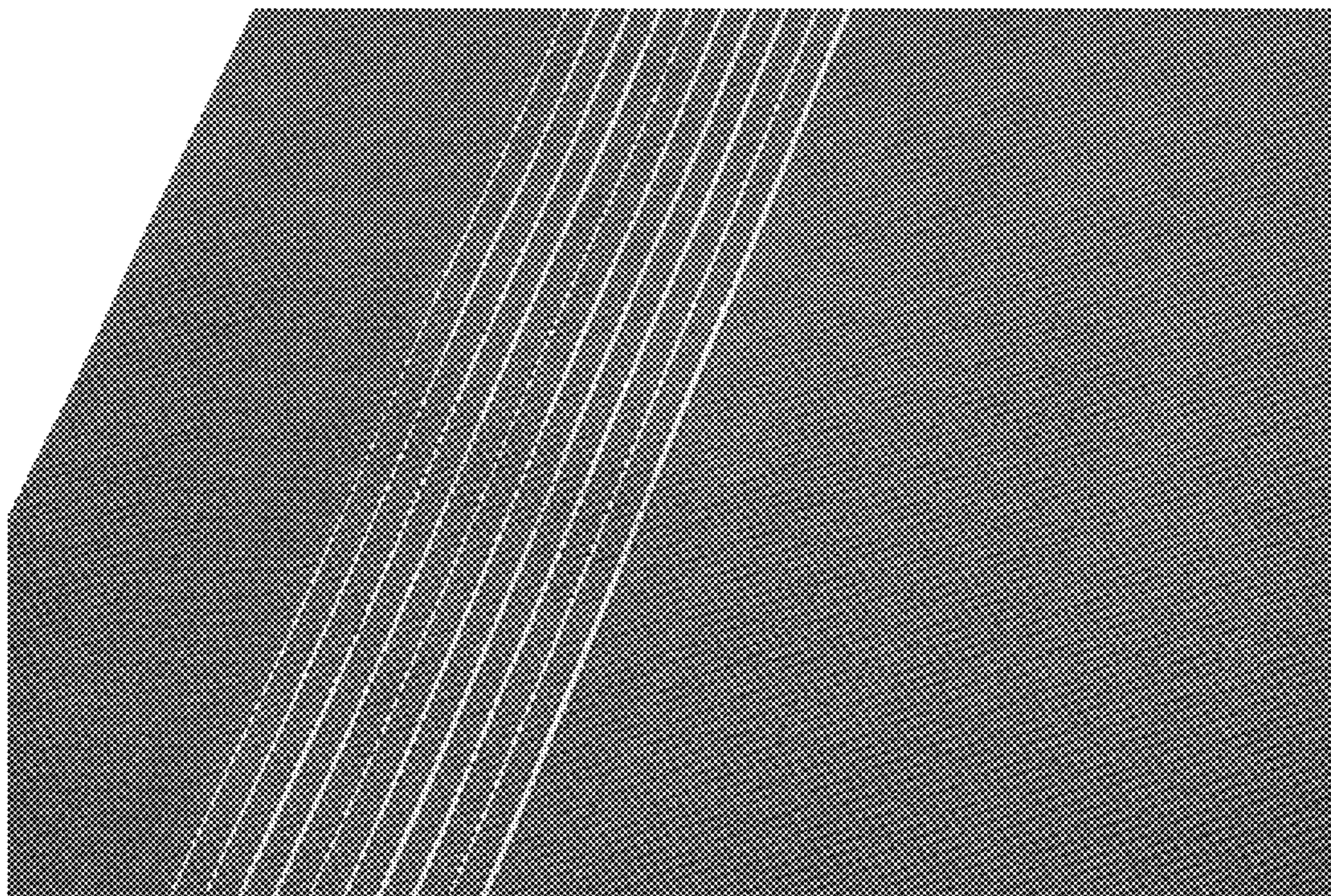

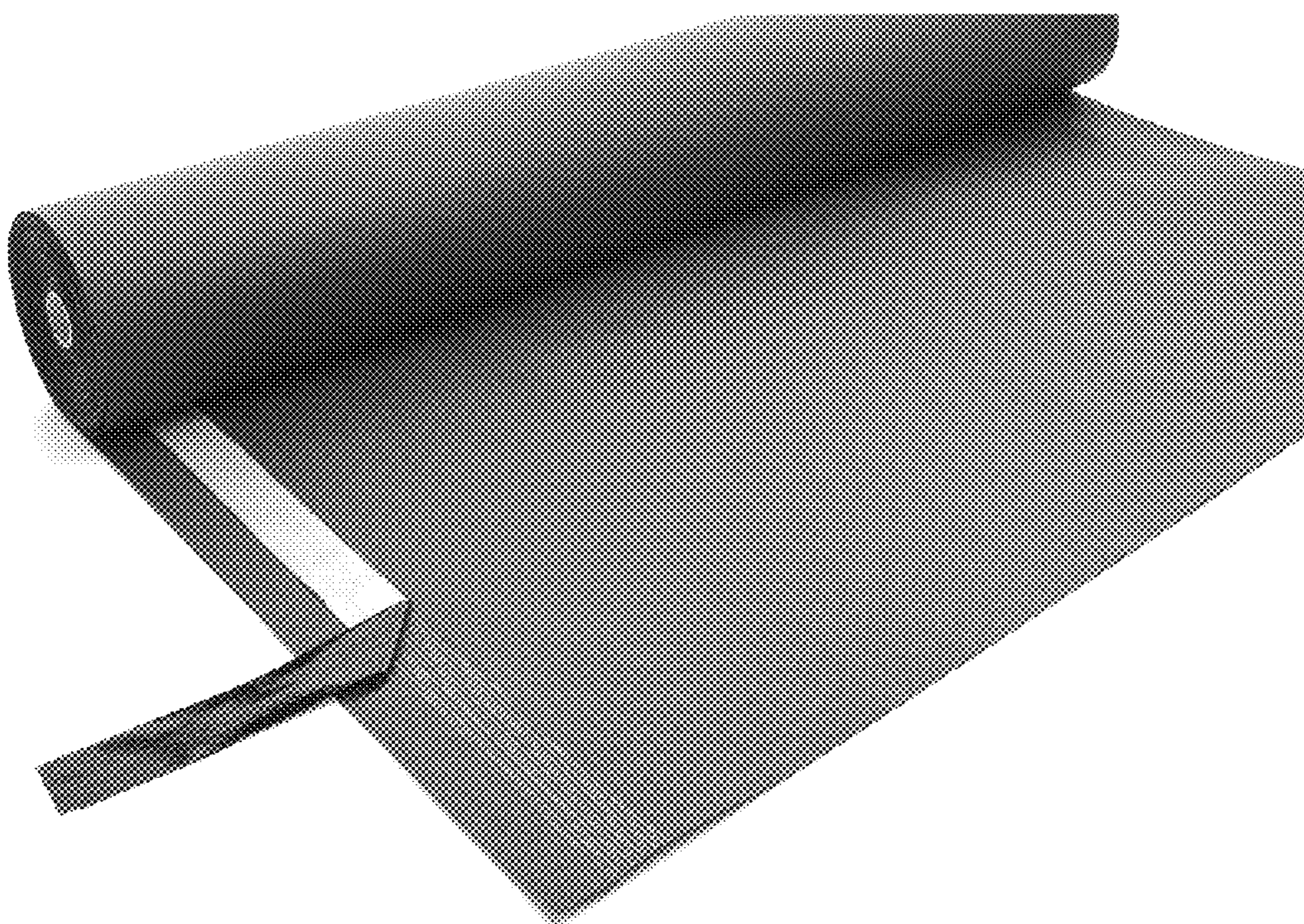

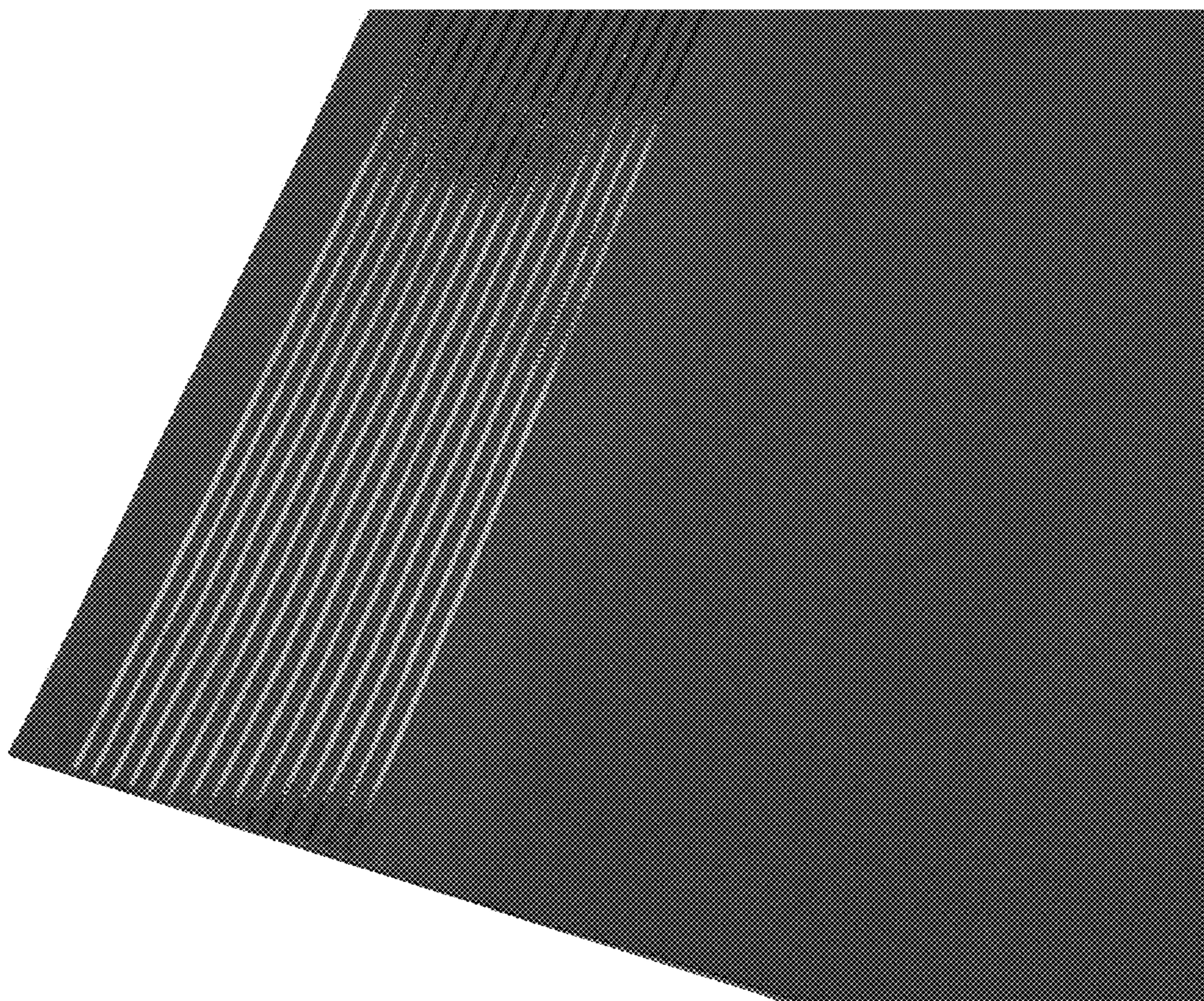

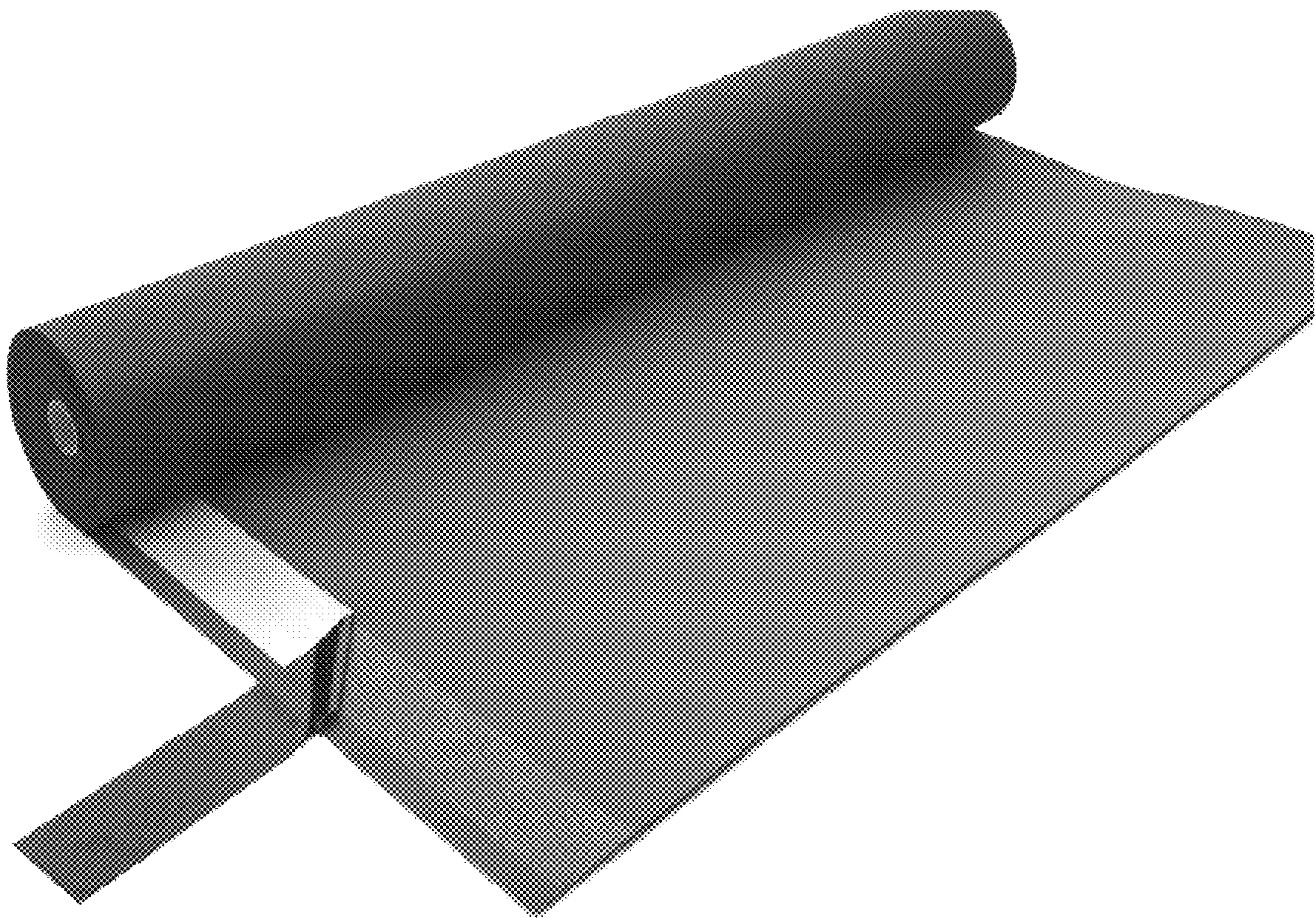
