(57) **CLAIM**

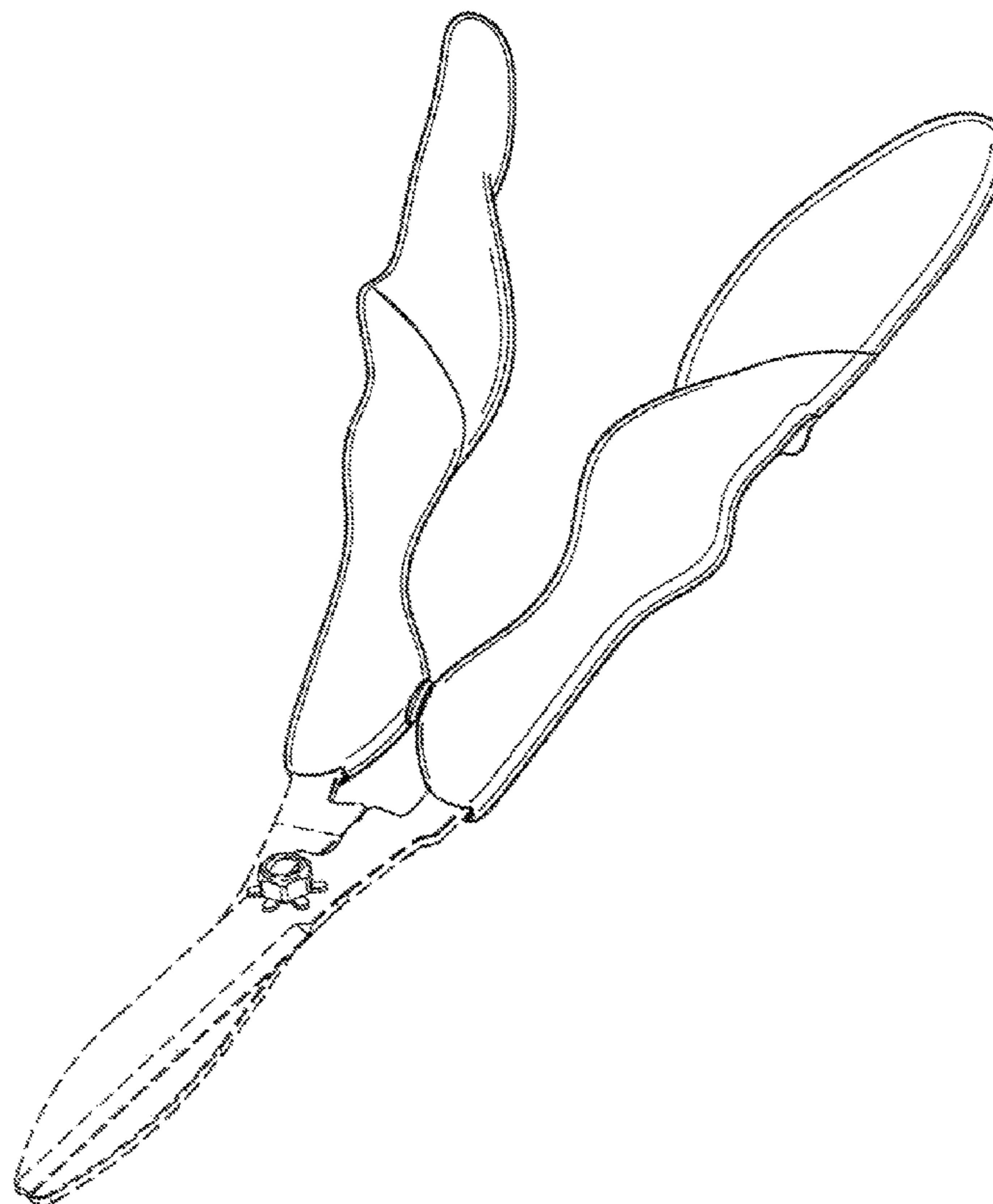
The ornamental design for handles for a tool with scissor action, as shown and described.

**DESCRIPTION**

FIG. 1 is a three-dimensional view of the handles for a tool with scissor action incorporating the design of our invention; FIG. 2 is a left side view of the handles of FIG. 1; FIG. 3 is a right side view of the handles of FIG. 1; FIG. 4 is a top view of the handles of FIG. 1; FIG. 5 is a bottom view of the handles of FIG. 1; FIG. 6 is a front end view of the handles of FIG. 1; and, FIG. 7 is a rear end view of the handles of FIG. 1.

The broken lines are included for the purpose of illustrating portions of the article and form no part of the claimed design.

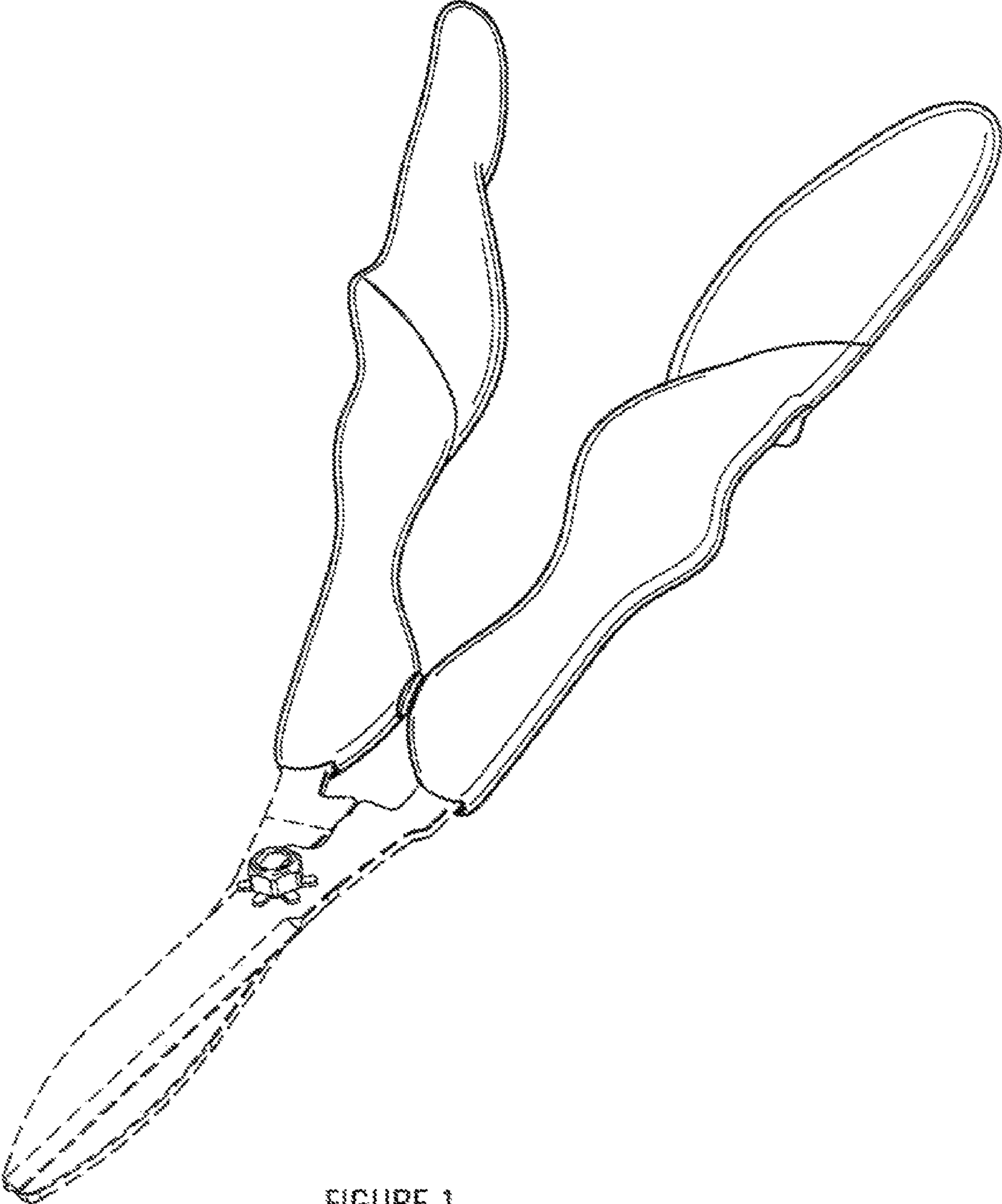

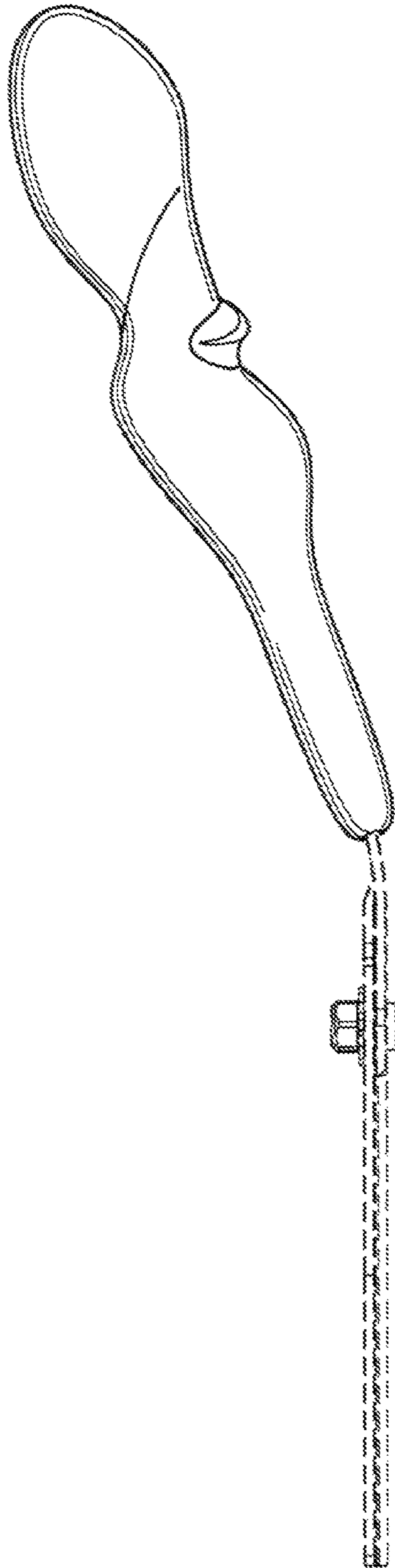

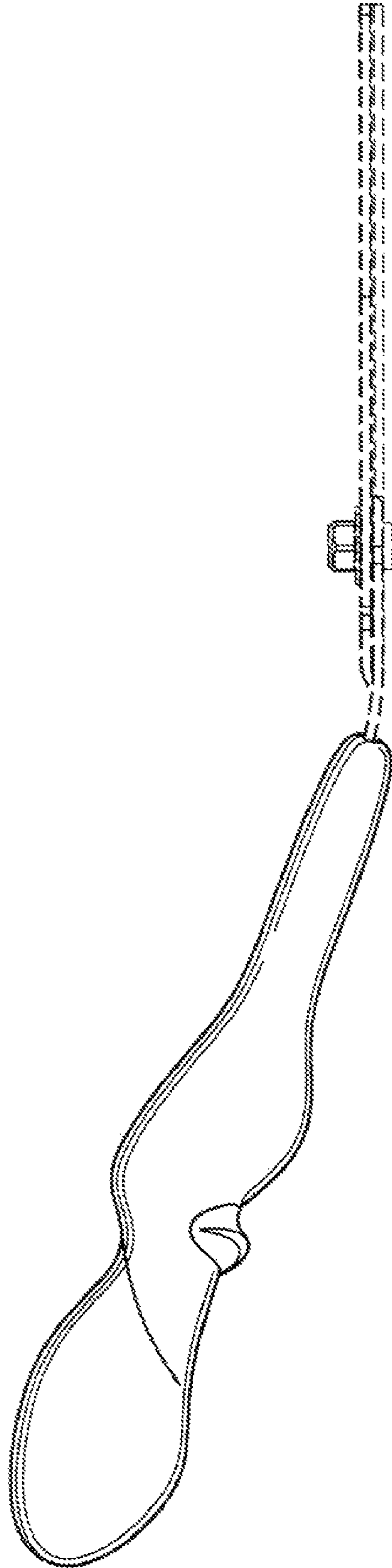

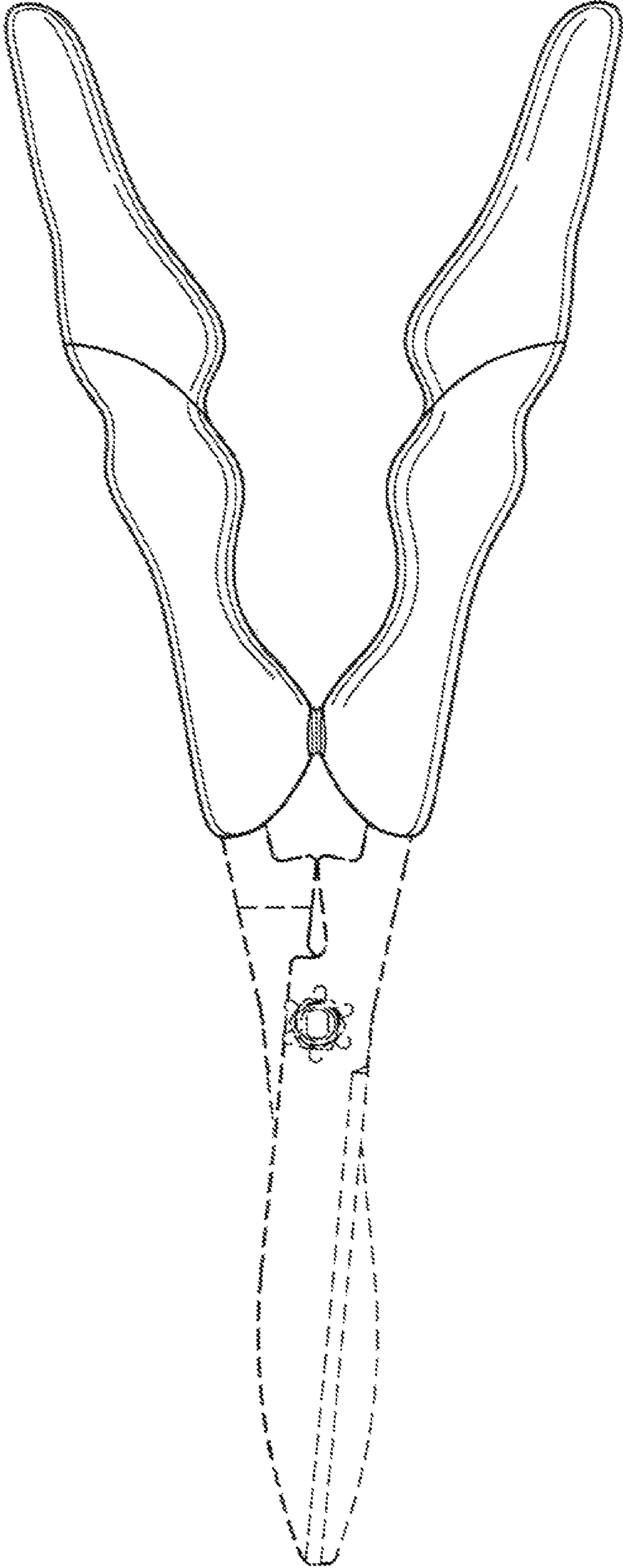

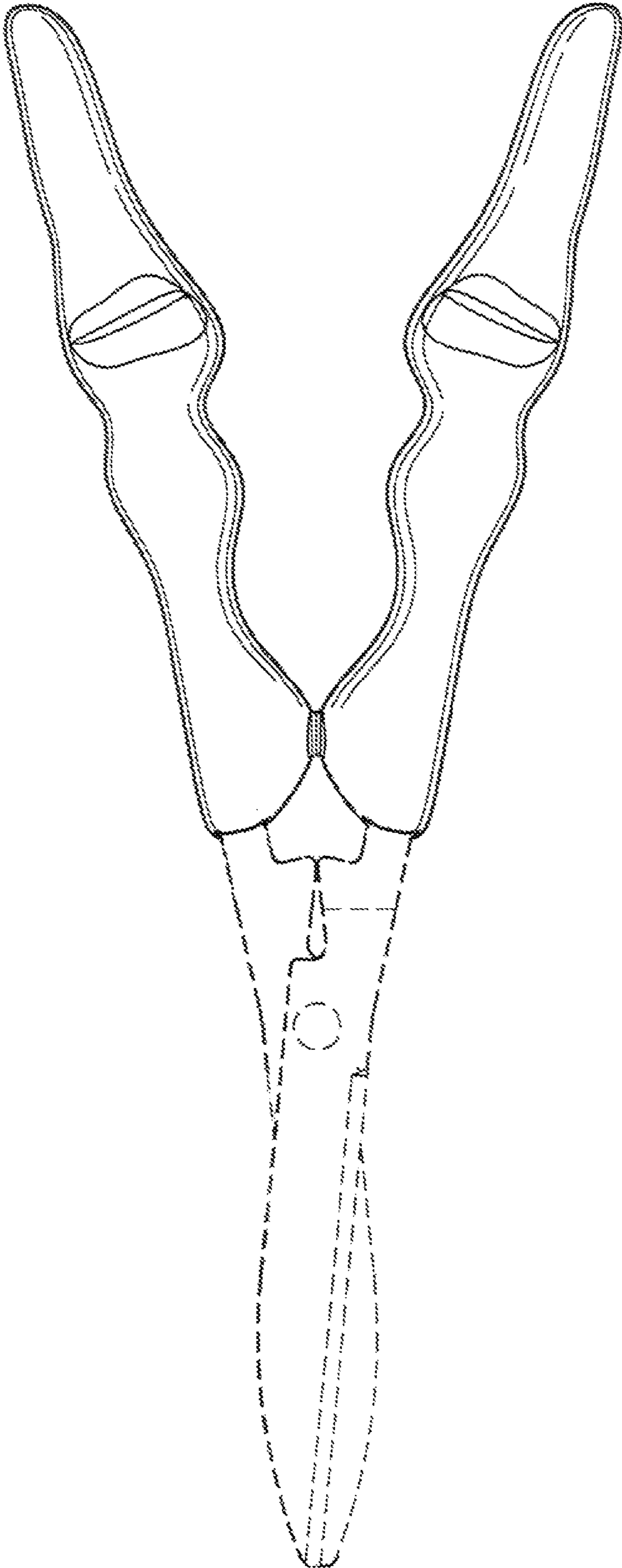

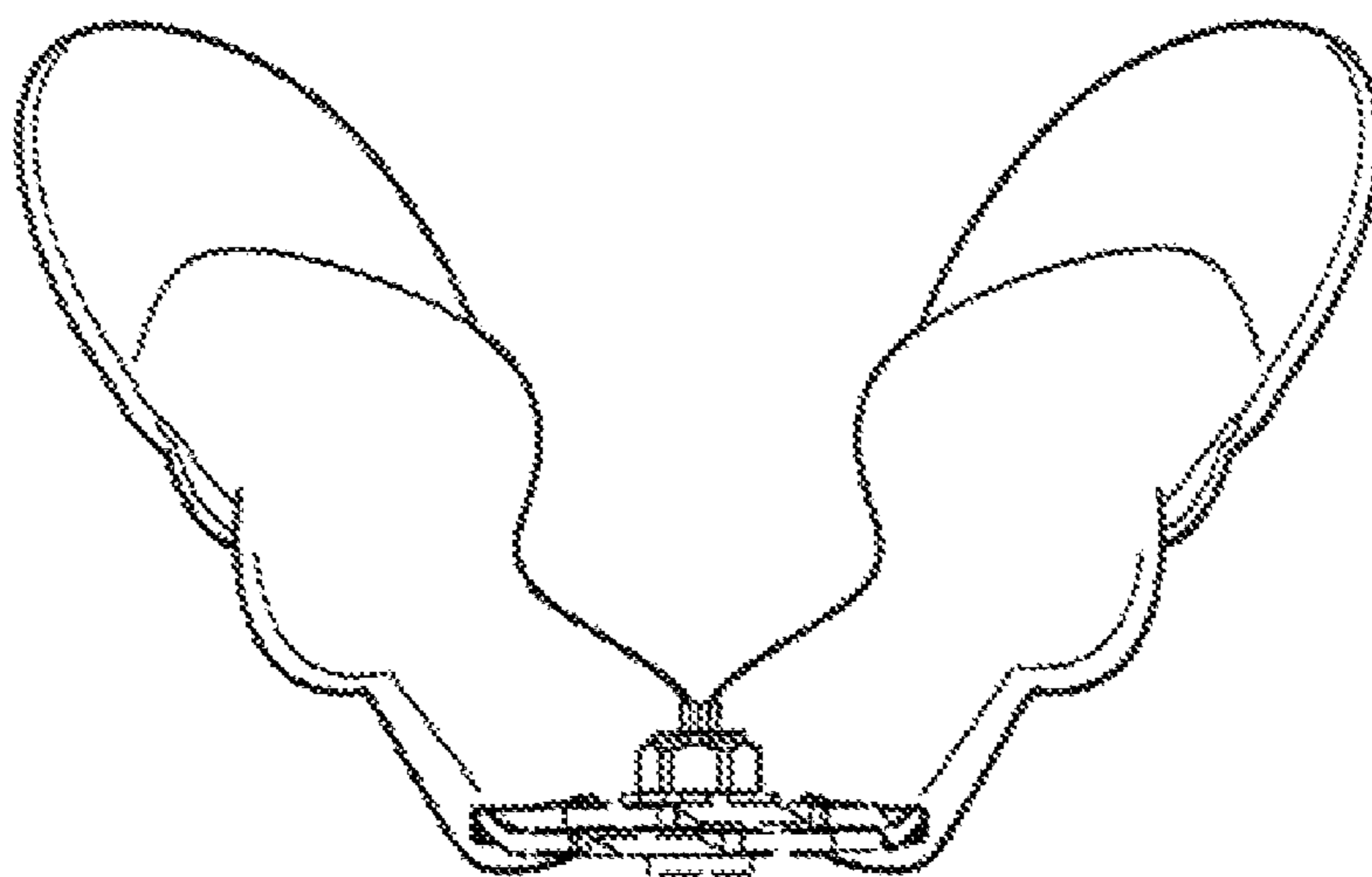

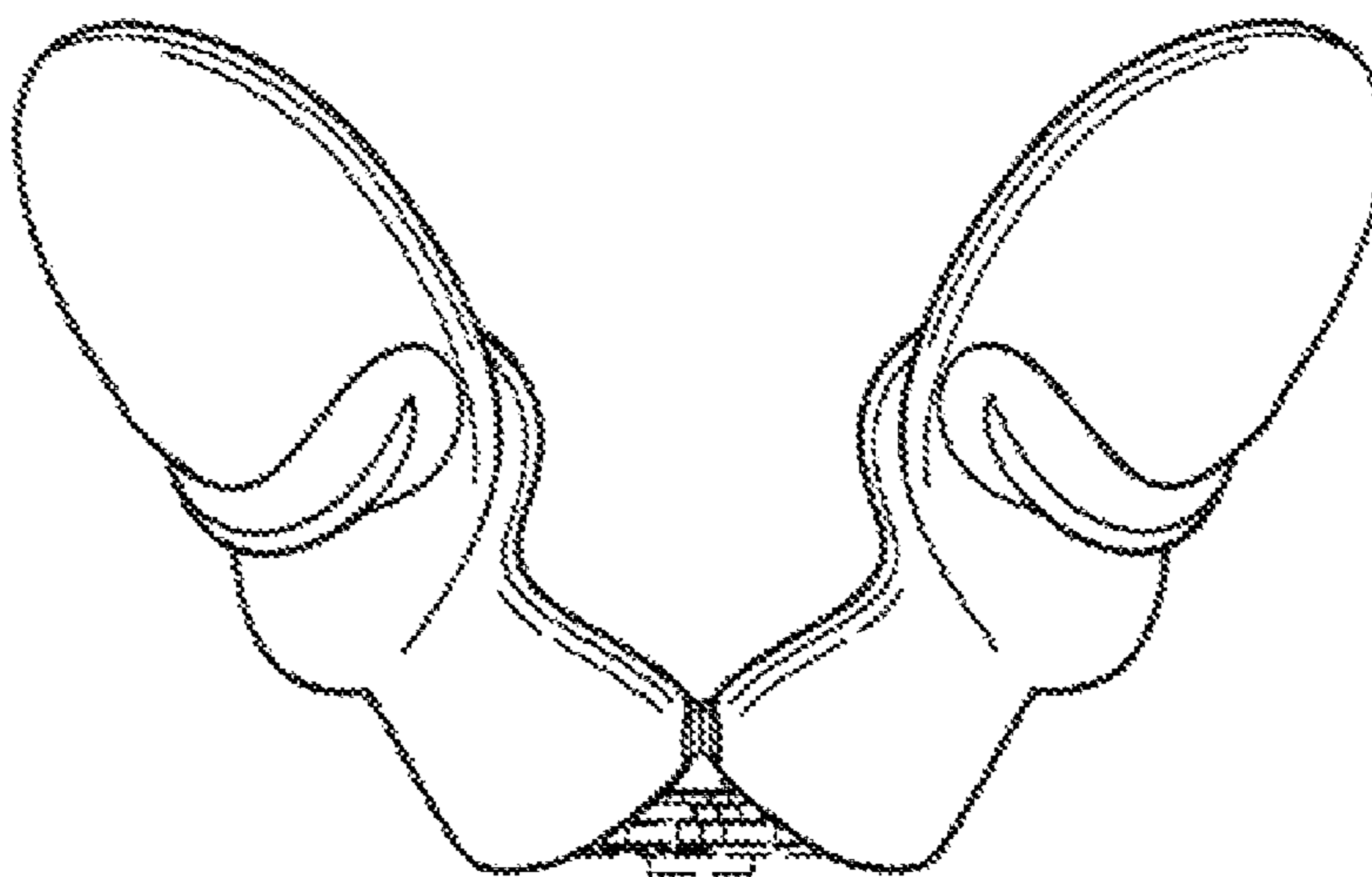
