The ornamental design for a “paddle trim assembly,” as shown and described.

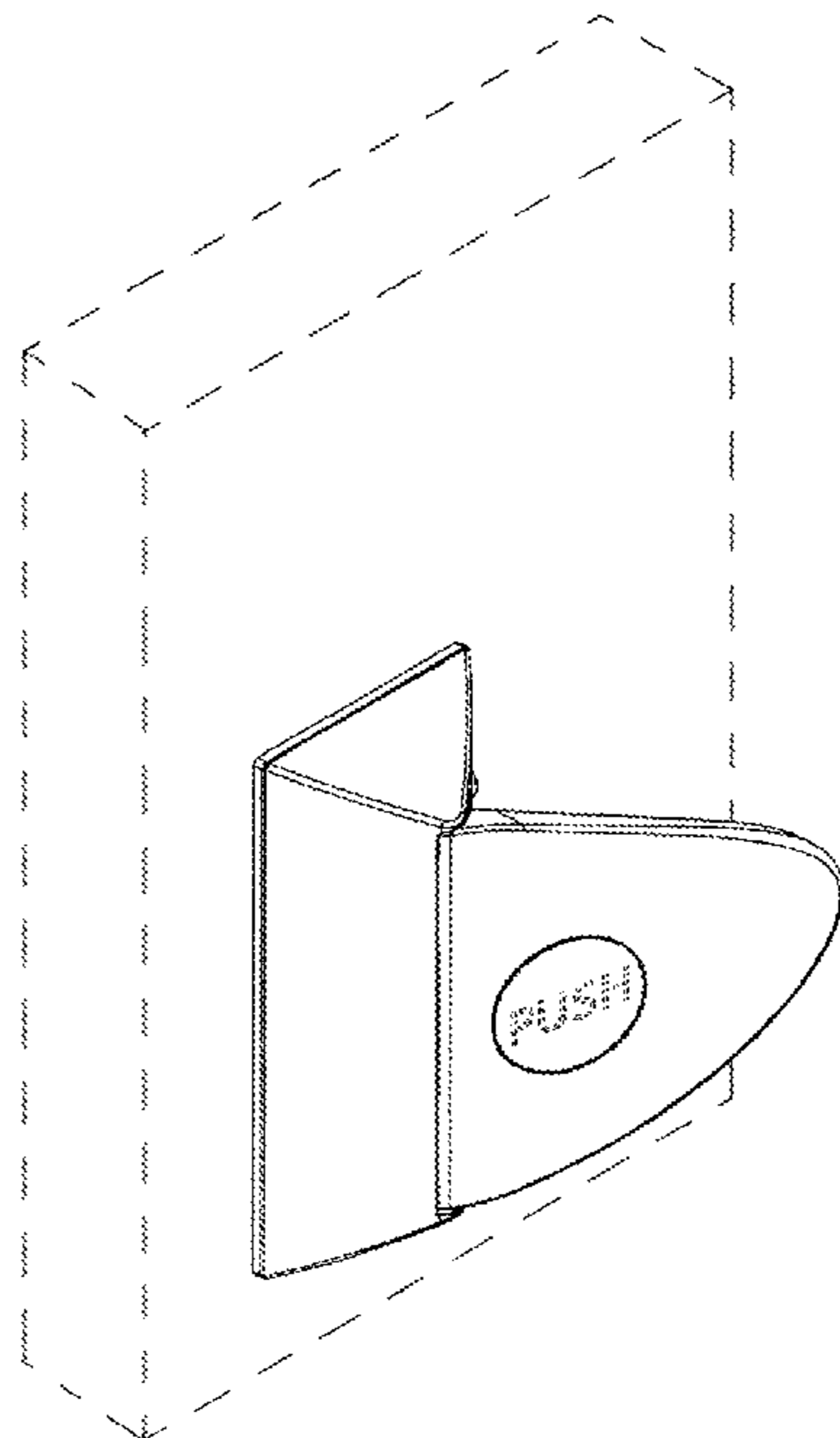
**DESCRIPTION**

FIG. 1 is a left side perspective view of a paddle trim assembly showing our new design in environmental use;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a left side elevational view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a right side perspective view thereof; and,  
FIG. 7 is a front elevational view thereof, rotated 90 degrees of that shown in FIG. 2.

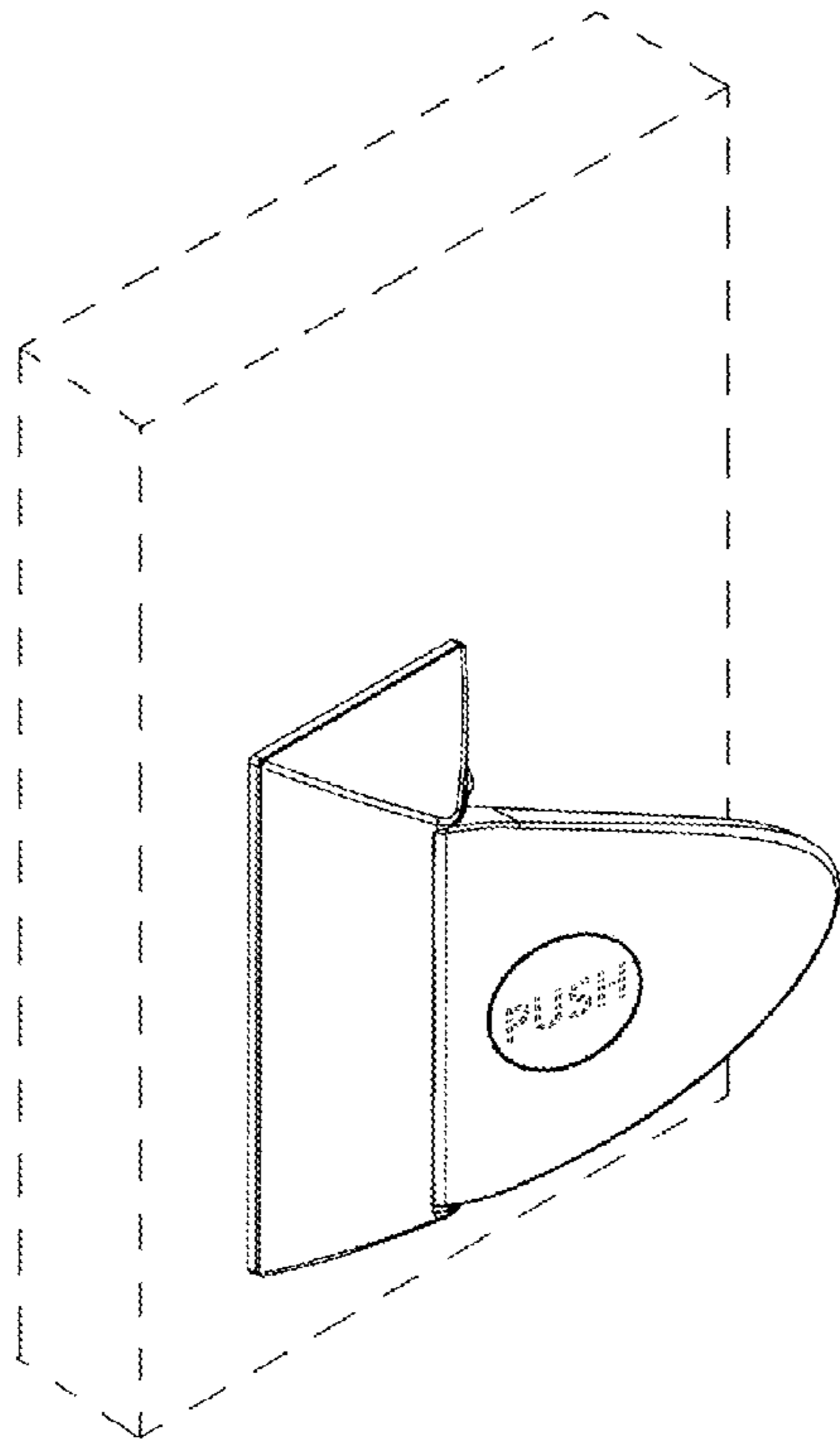

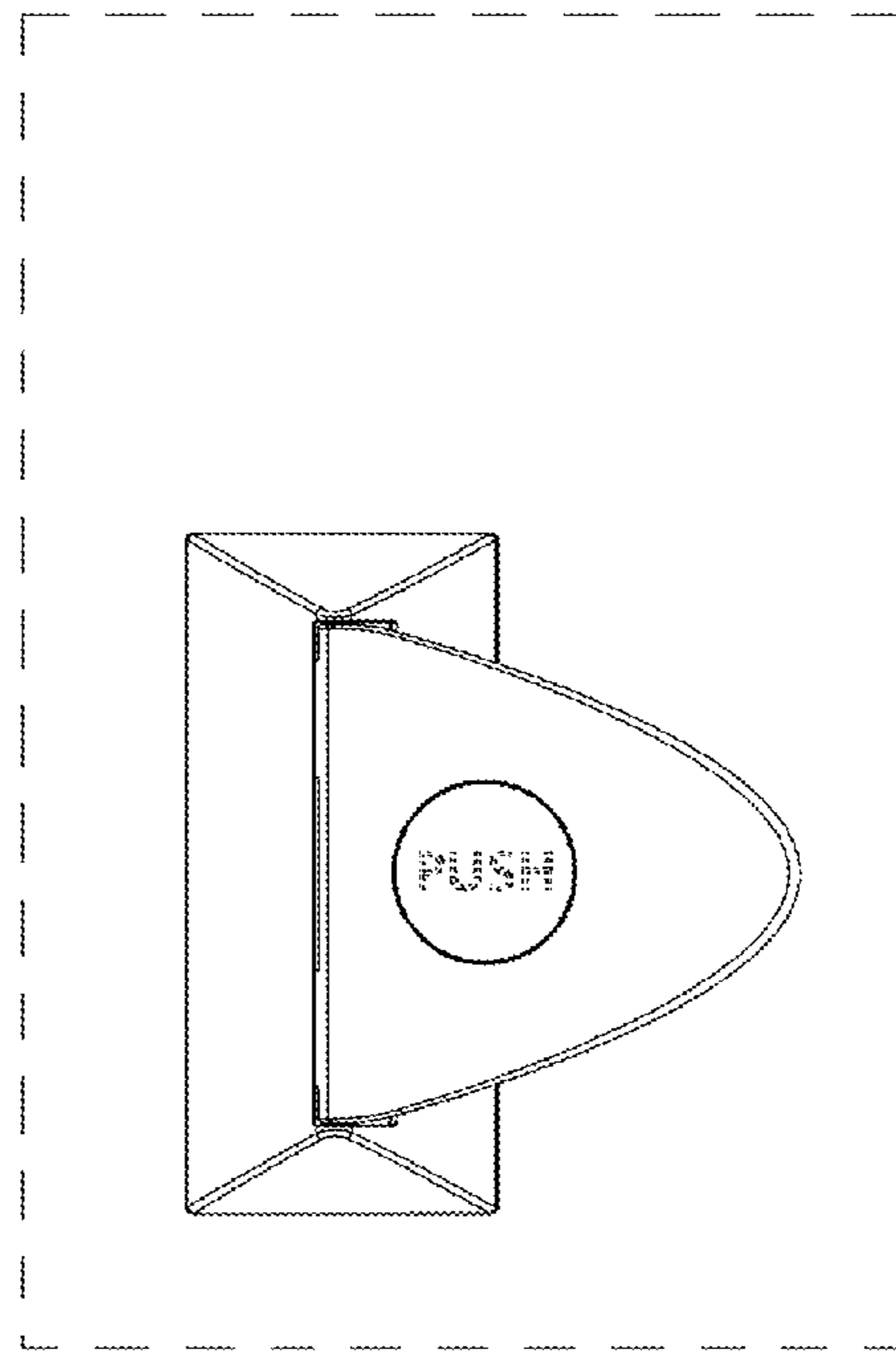

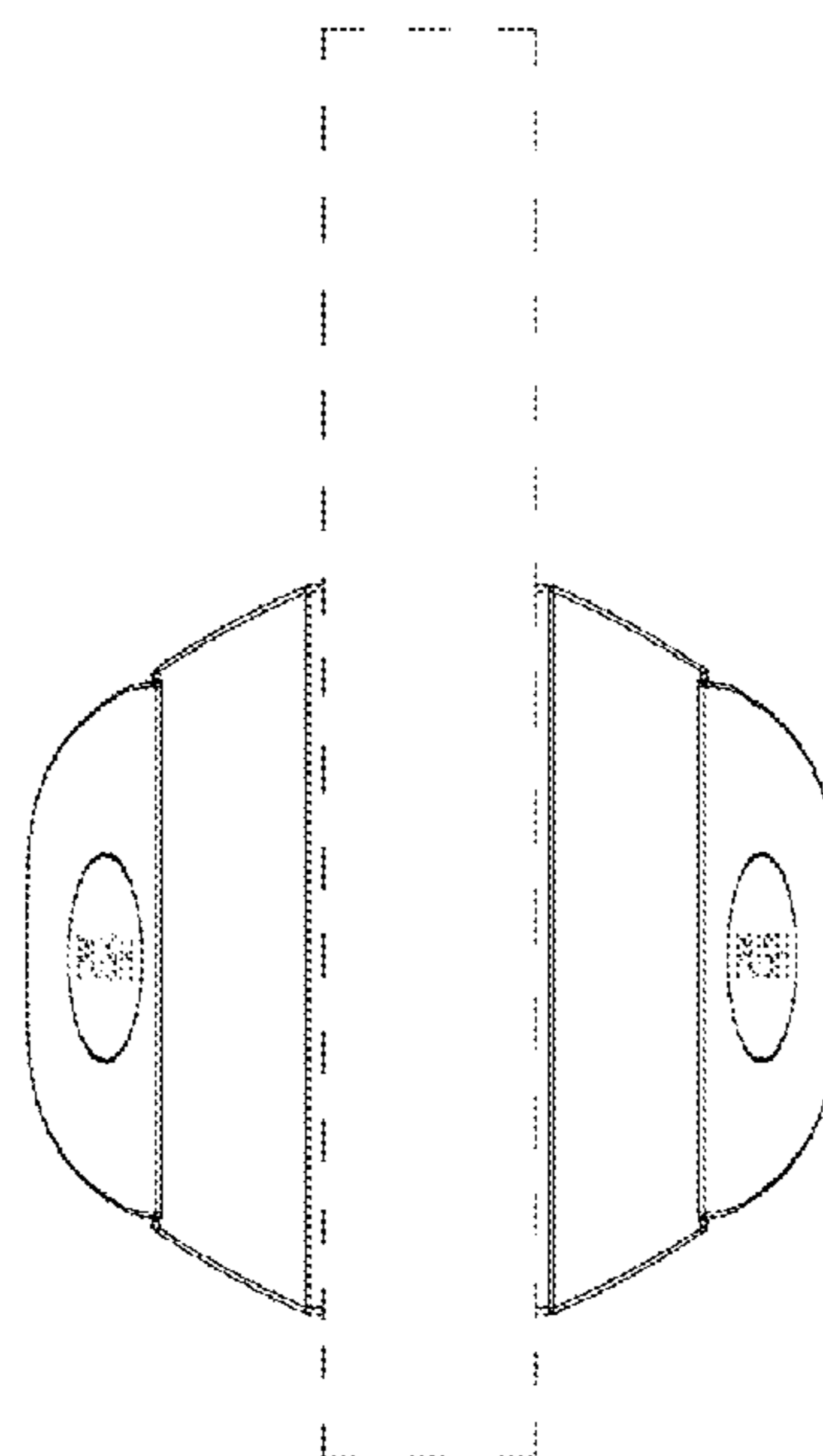

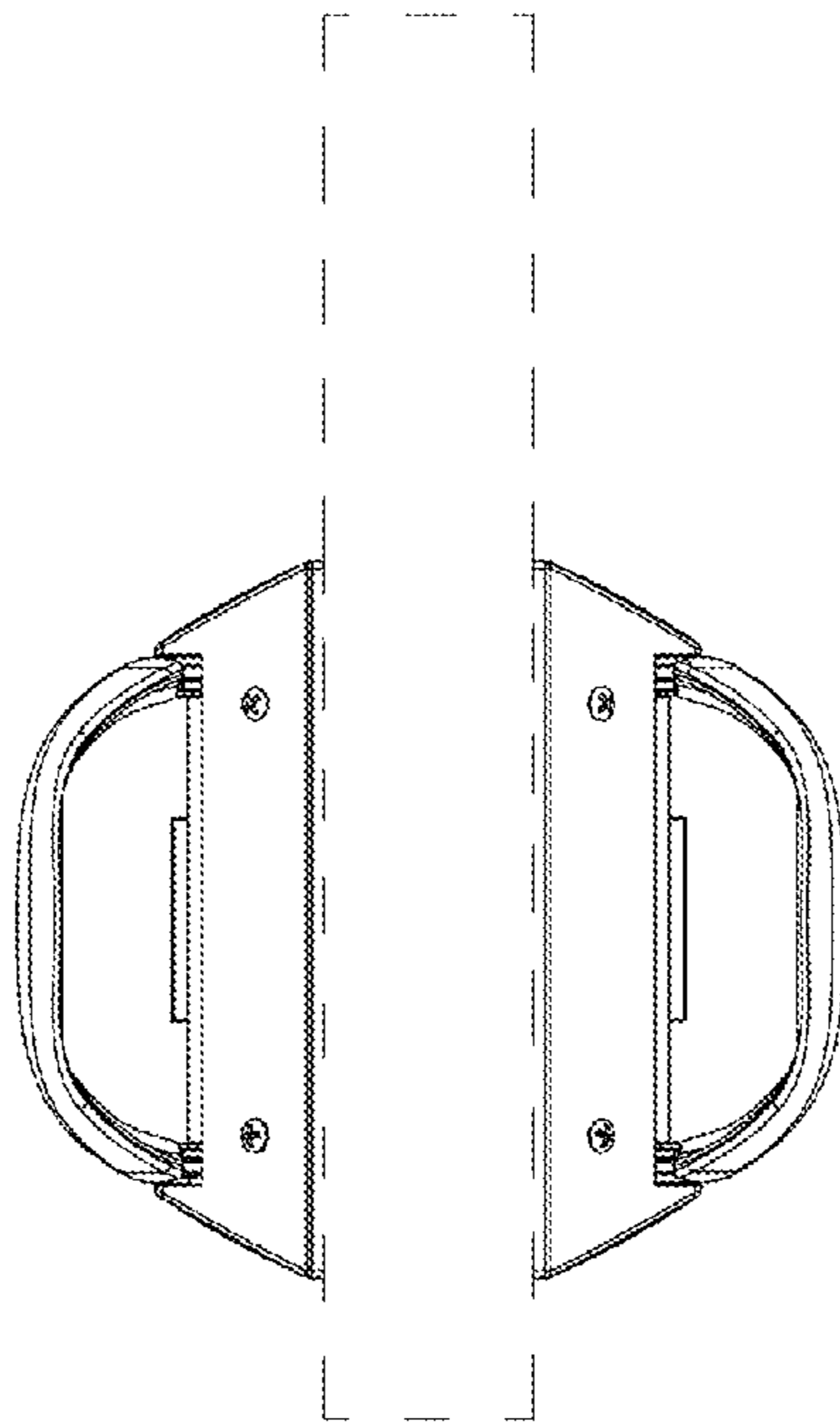
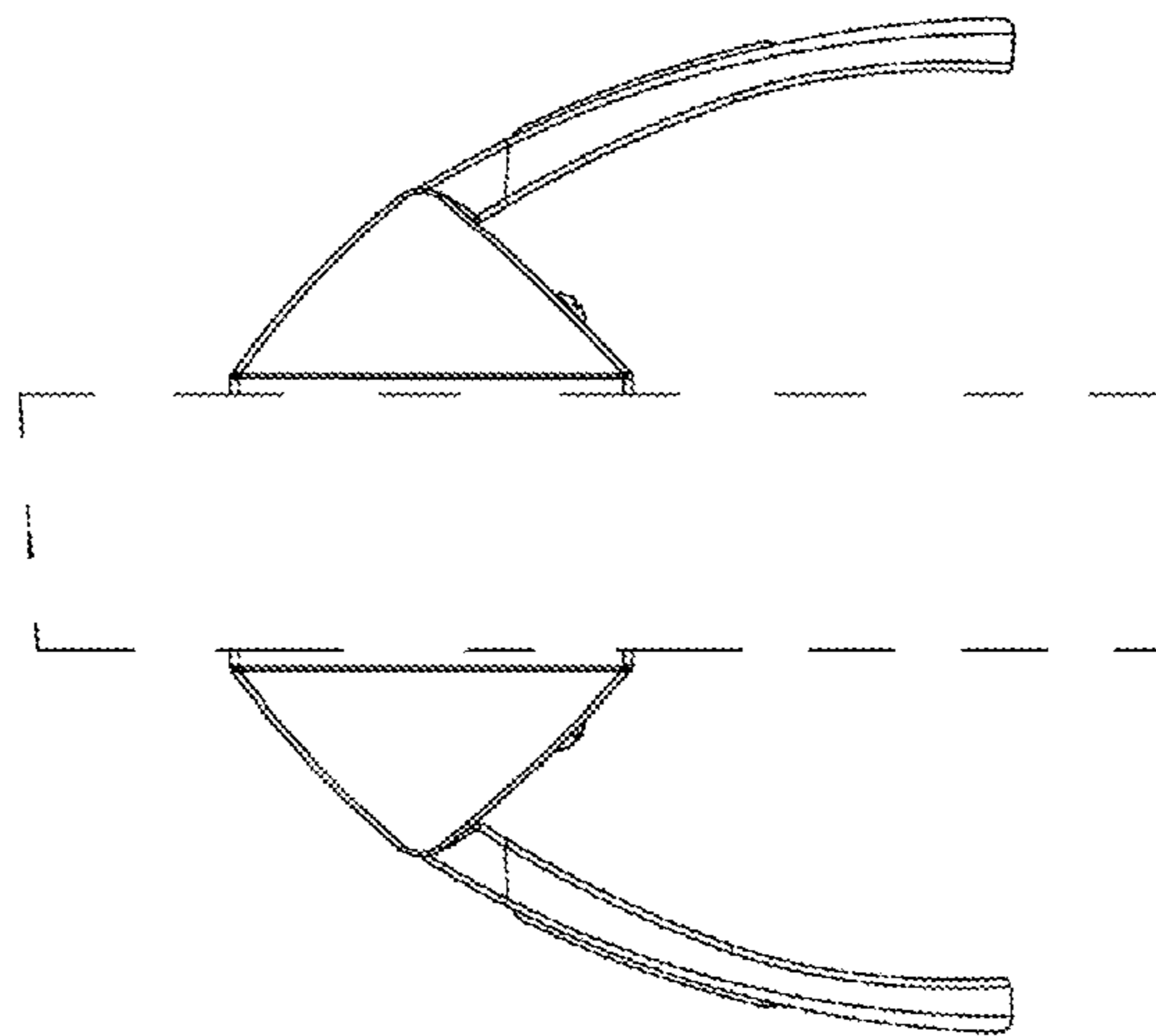

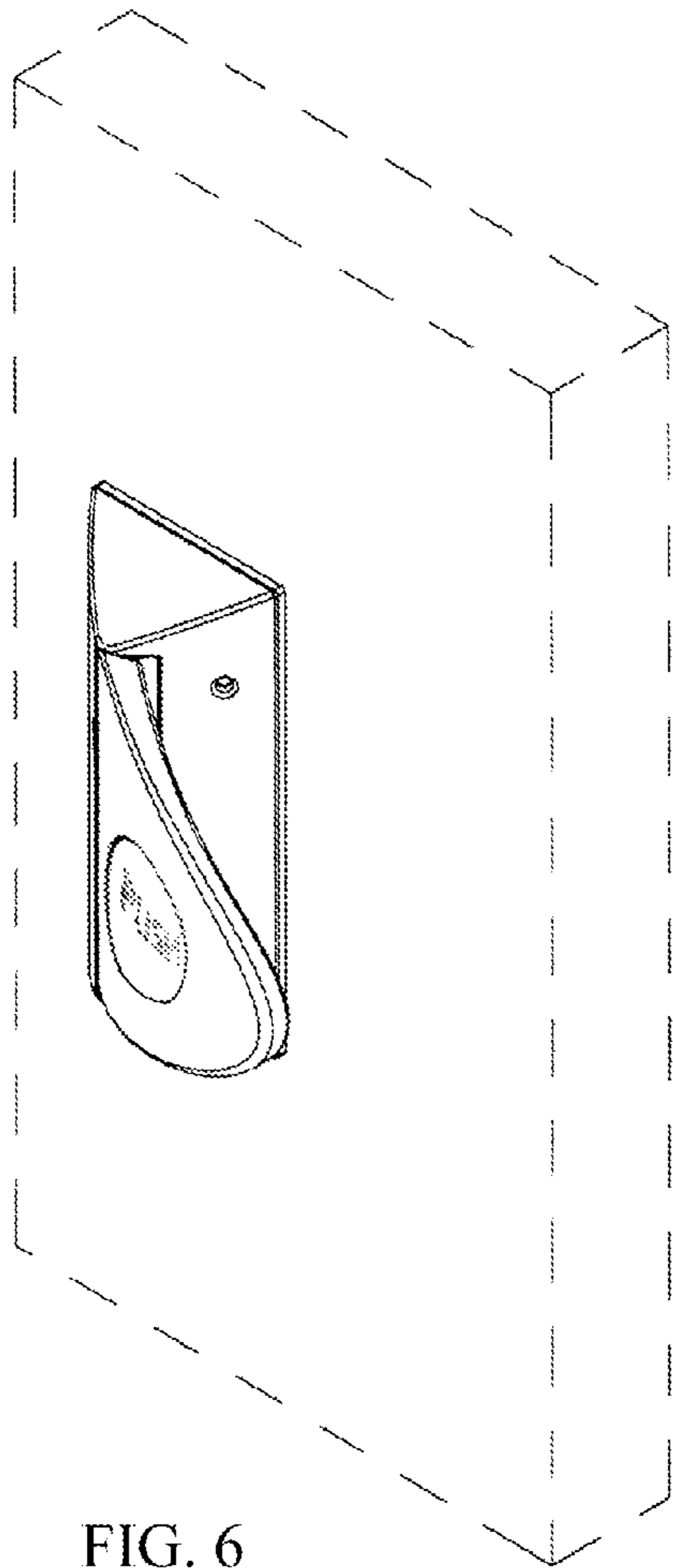

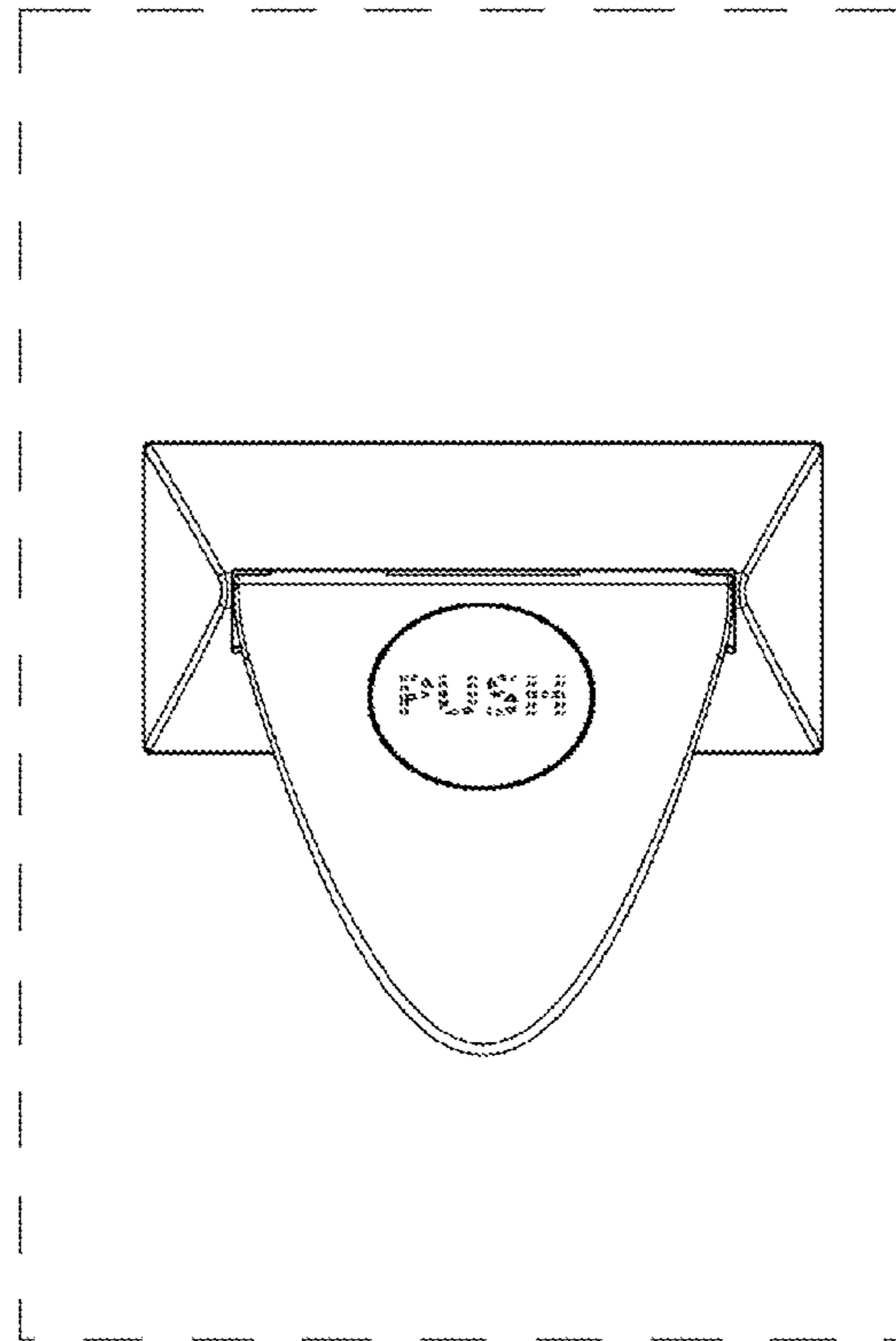
