(57) **CLAIM**

I claim the ornamental design for a combination container and storage compartment, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of the combination container and storage compartment showing my new design; FIG. 2 is a rear elevation view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a perspective view thereof showing the storage compartment being used to store eating utensils or other items the user may desire to store with the container; the broken lines depict eating utensils for illustrative purposes only and form no part of the claimed design; and, FIG. 8 is a perspective view thereof showing the storage compartment being used to store eating utensils or other items the user may desire to store with the container; The broken lines depicting an optional, removable cover for the storage compartment in FIG. 8 are for illustrative purposes only and form no part of the claimed design.

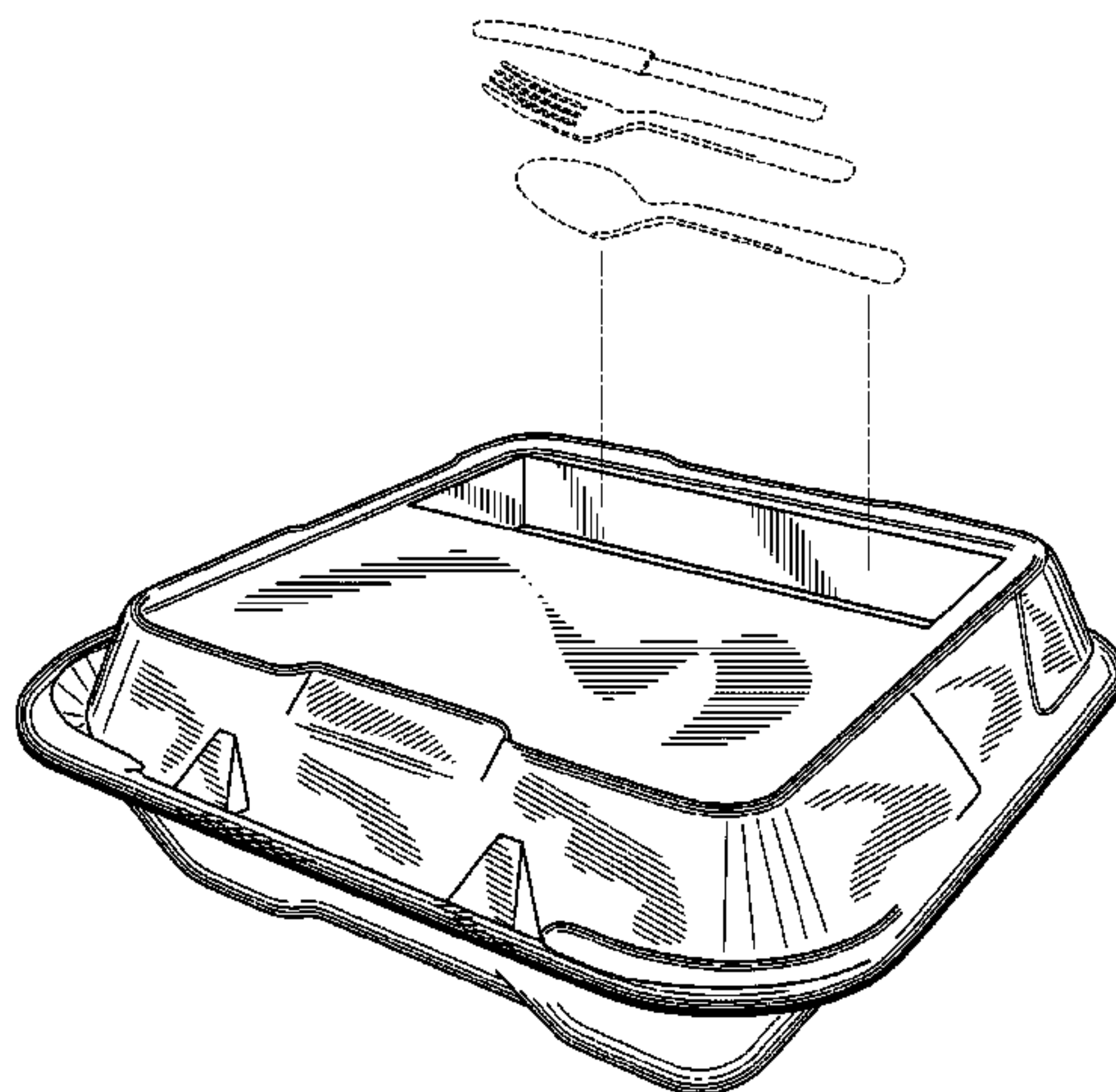

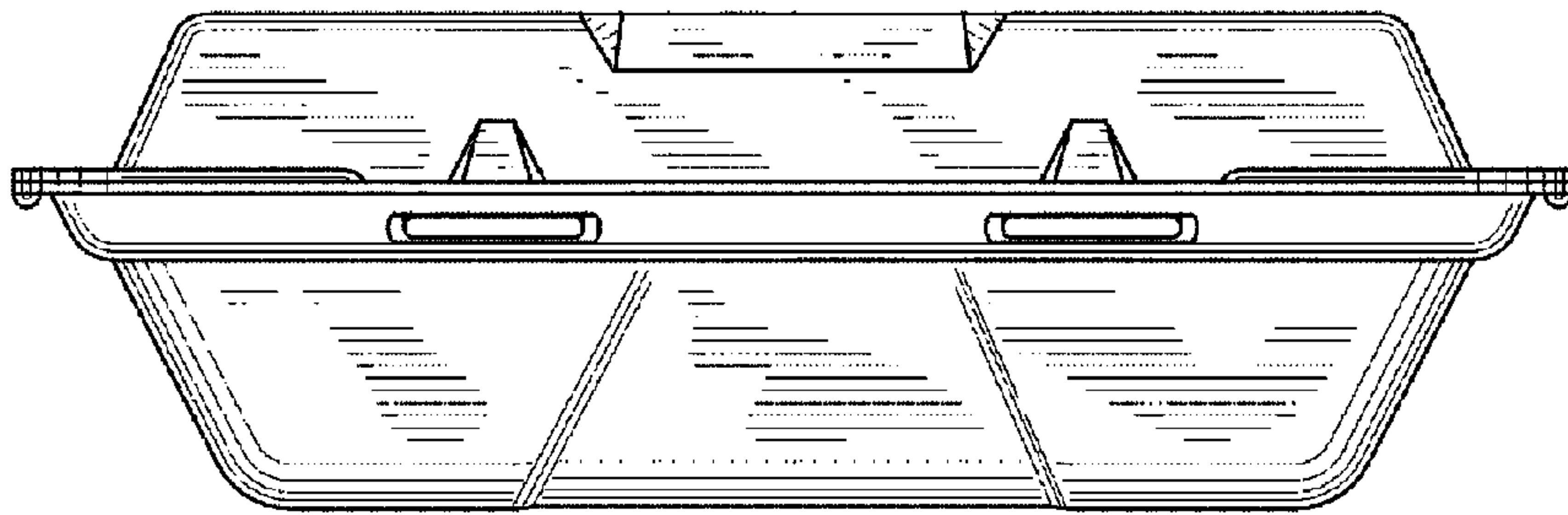

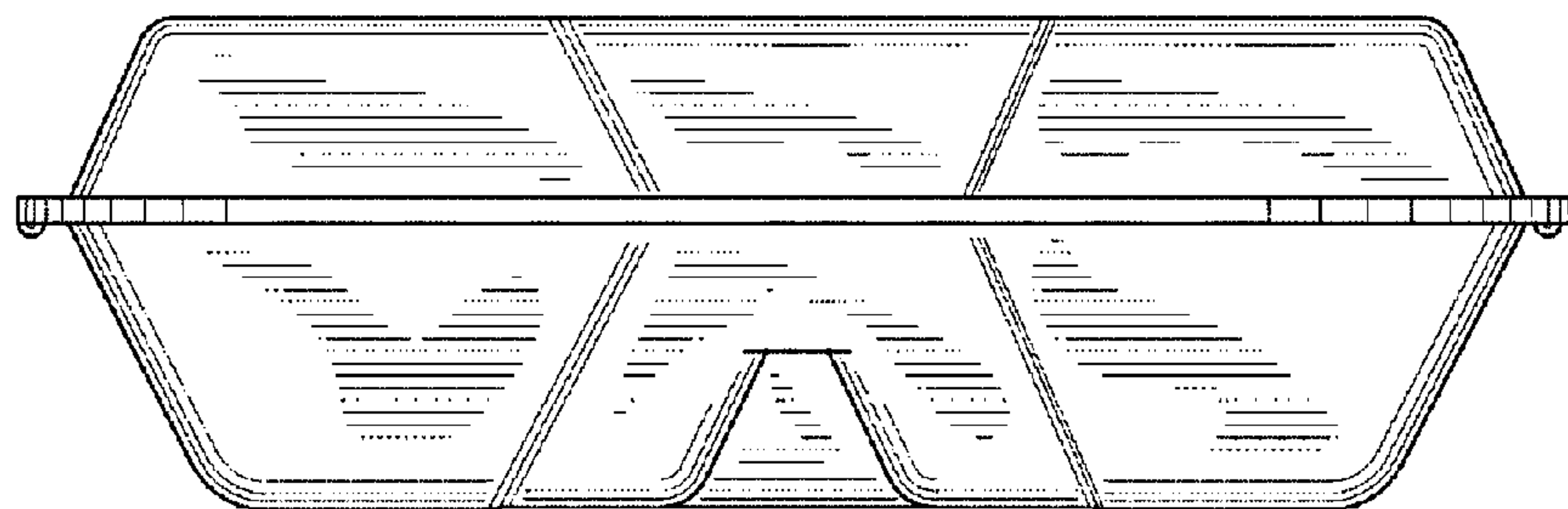

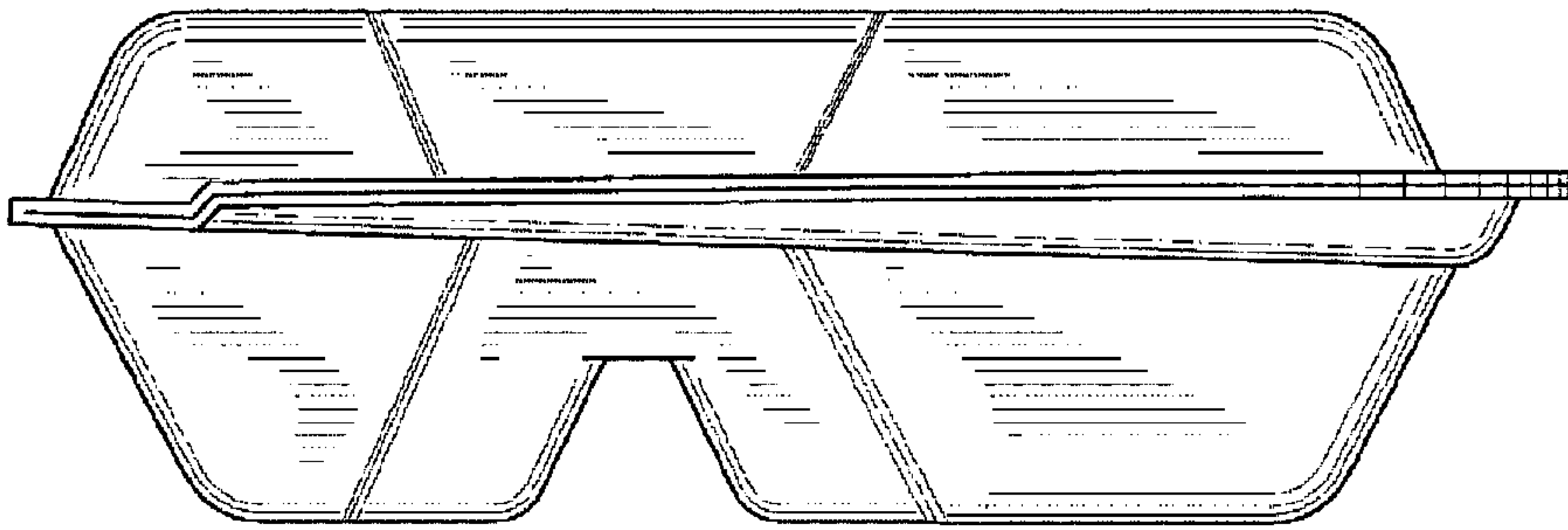
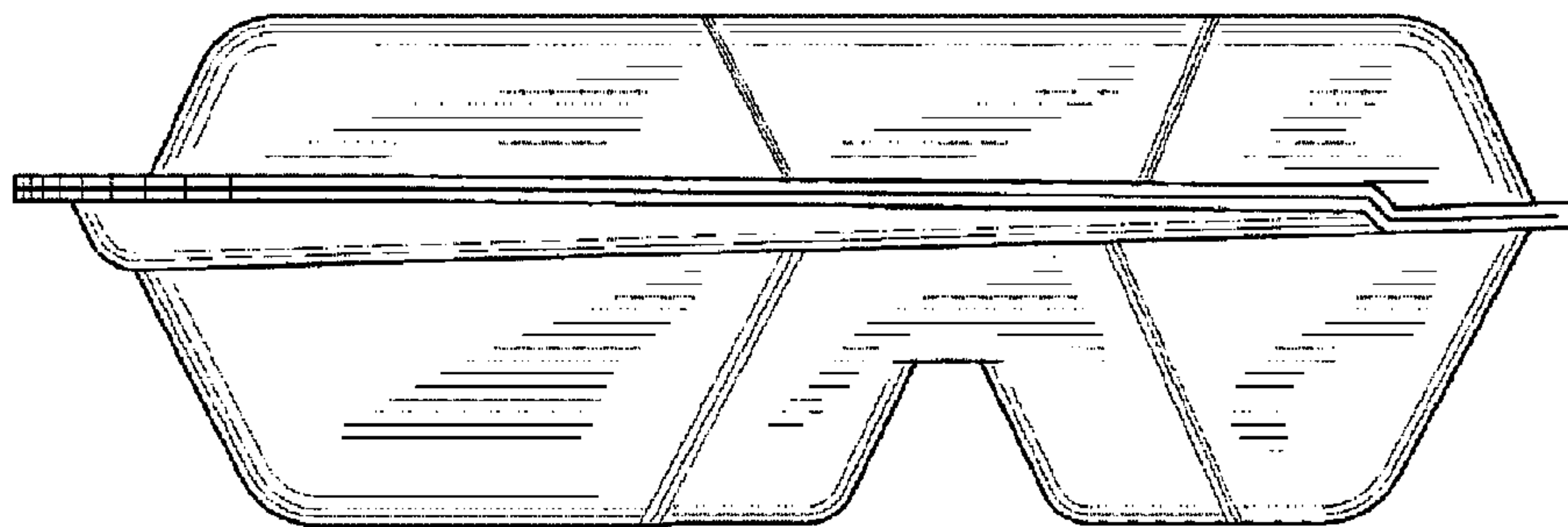

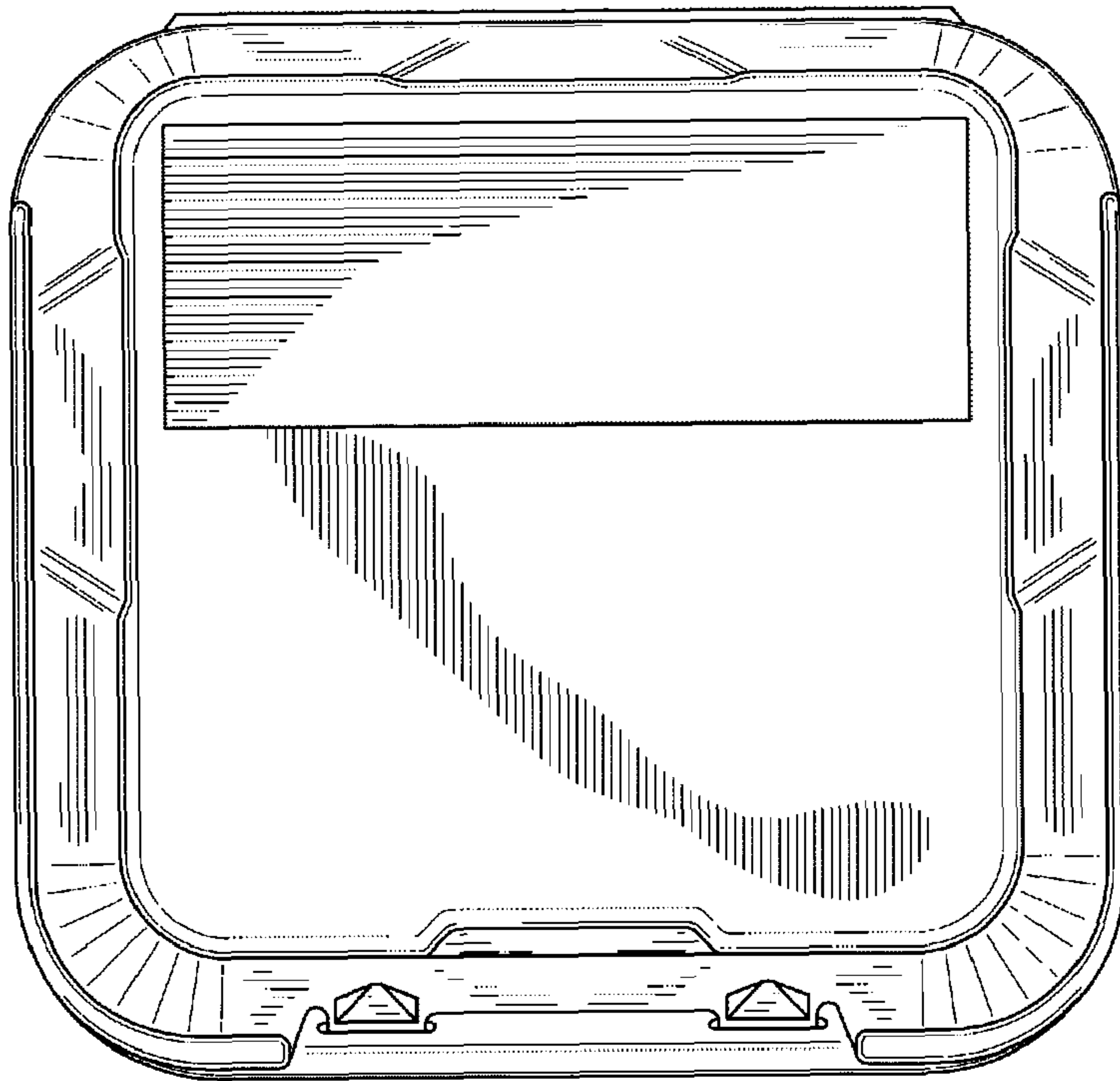

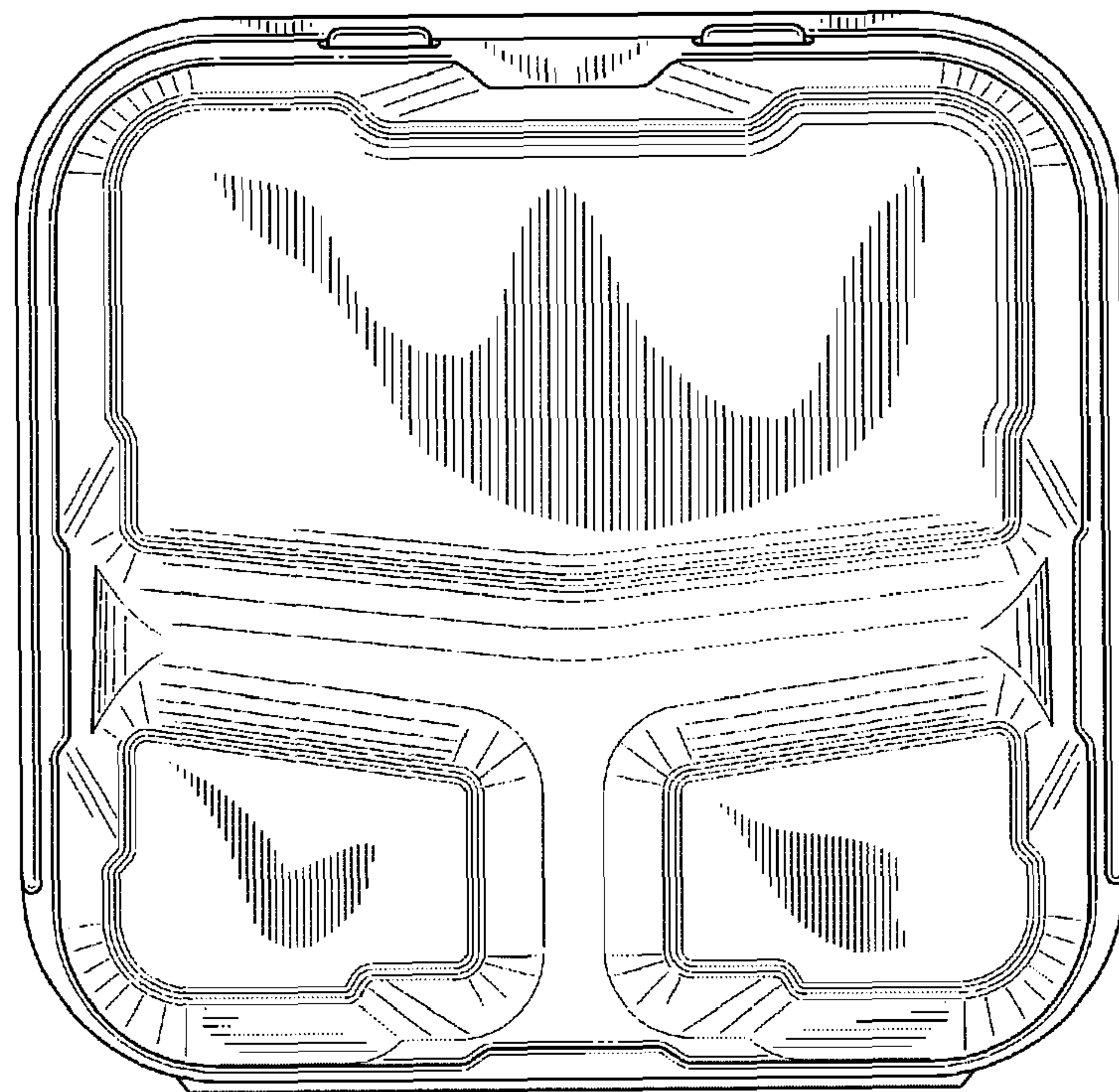
