(57) **CLAIM**

The ornamental design for a railway vehicle and/or toy replica thereof, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a railway vehicle and/or toy replica thereof showing our new design;
FIG. 2 is a left side elevational view thereof, the right side view being a mirror image of that shown;
FIG. 3 is a top plan view thereof;
FIG. 4 is a front right perspective view thereof; and,
FIG. 5 is a front right perspective view thereof with a portion of a skirt, which laterally covers a front wheel unit, removed.
The broken lines in FIGS. 2 to 5, showing portions of the railway vehicle and/or toy replica thereof, form no part of the claimed design.

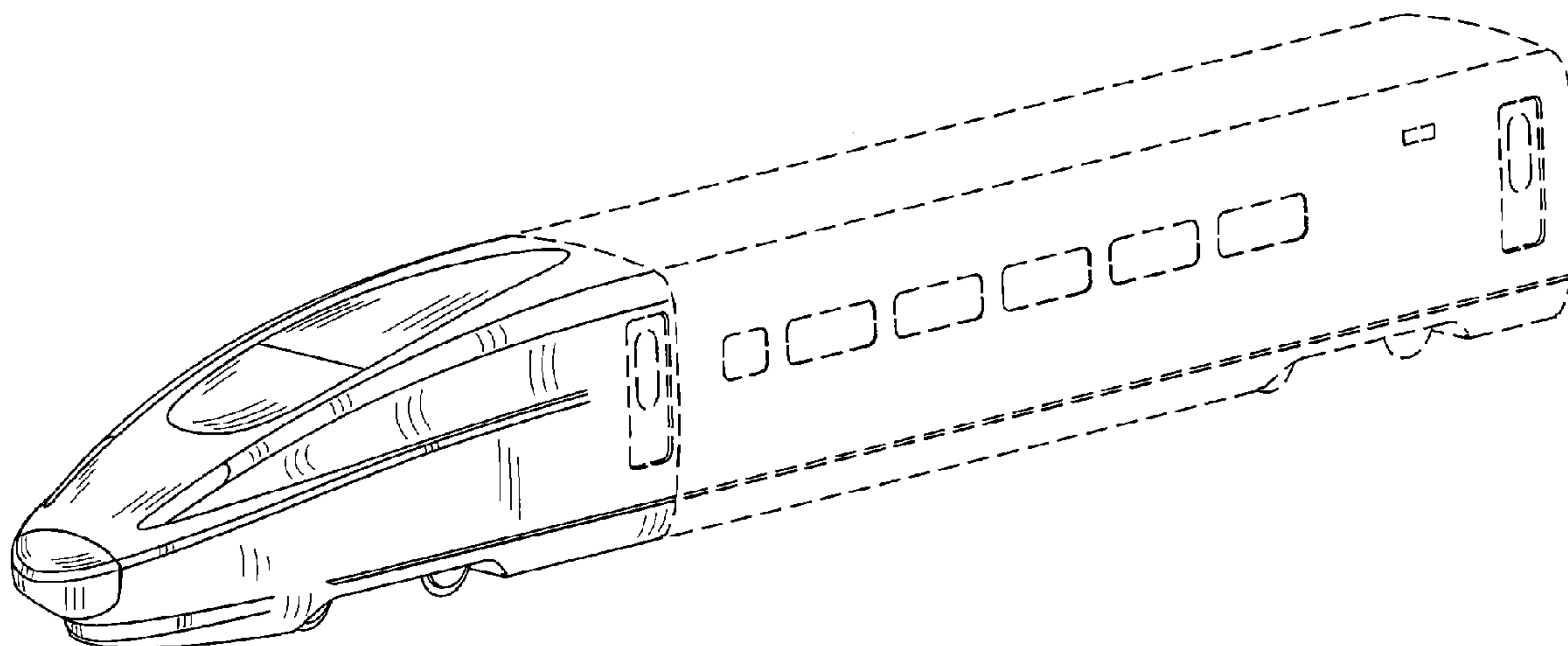

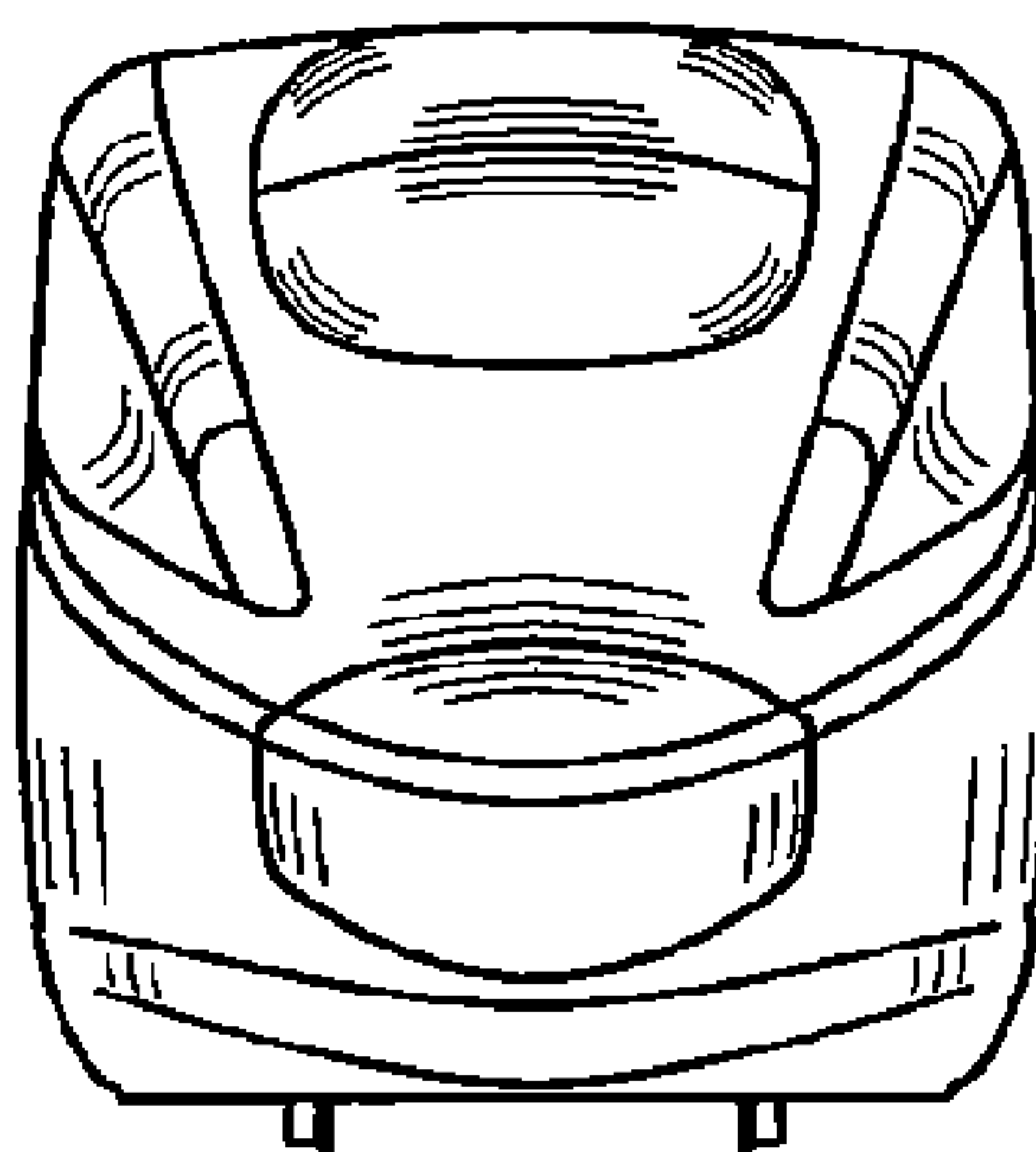

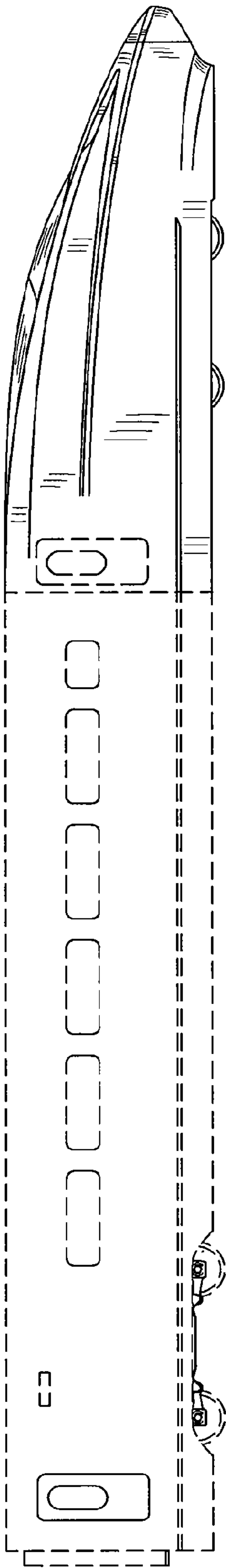

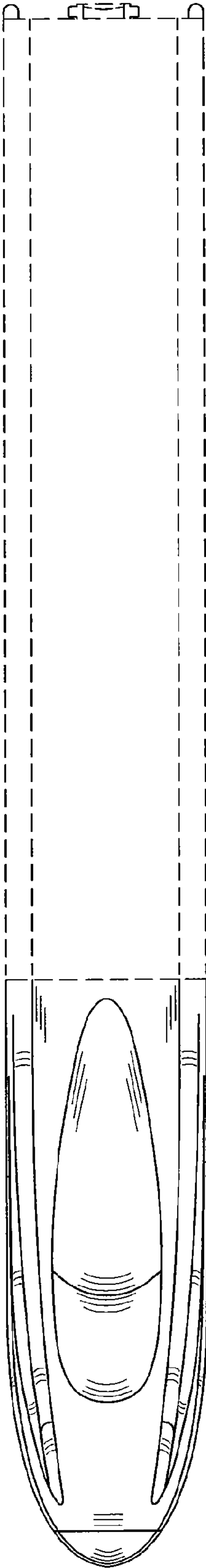

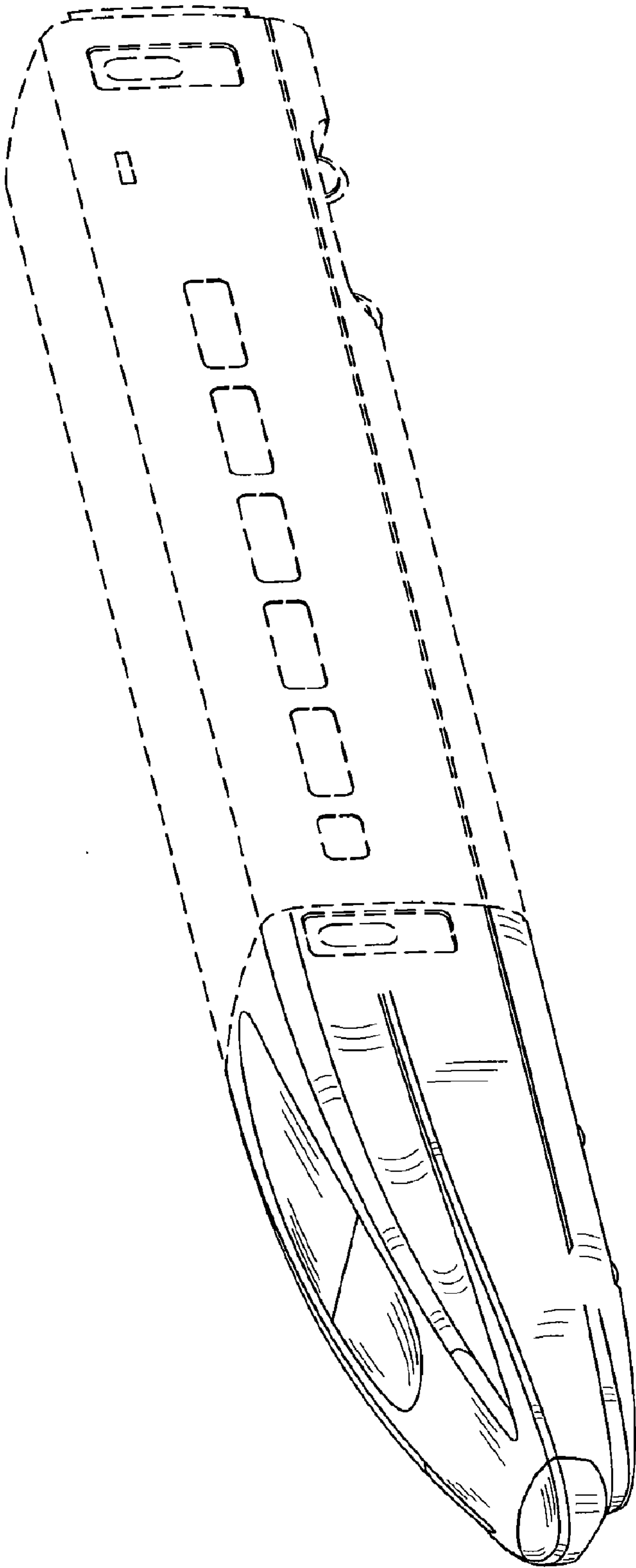
