DESCRIPTION

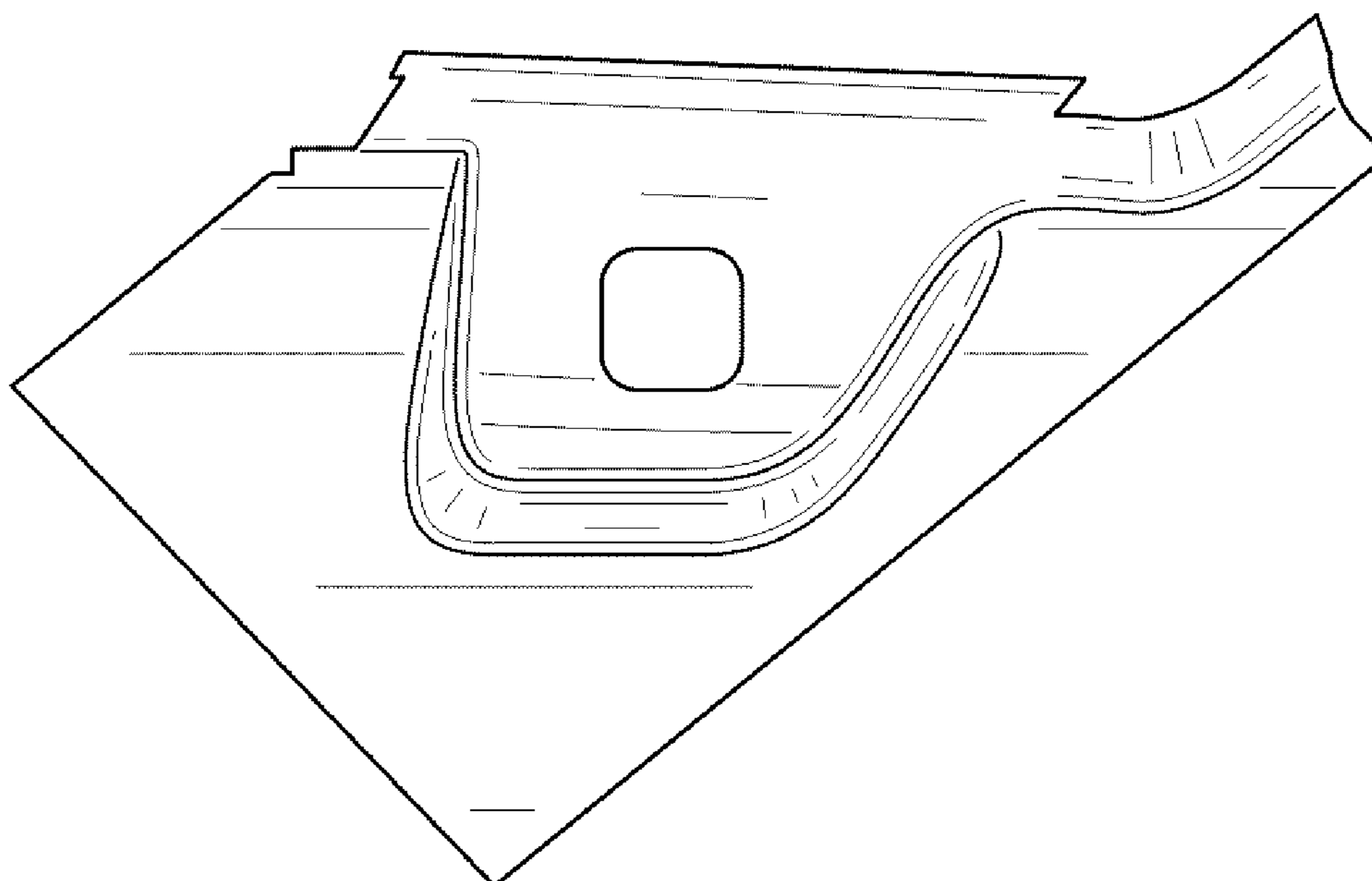
FIG. 1 is a perspective view of a vehicle interior garnish showing my new design;

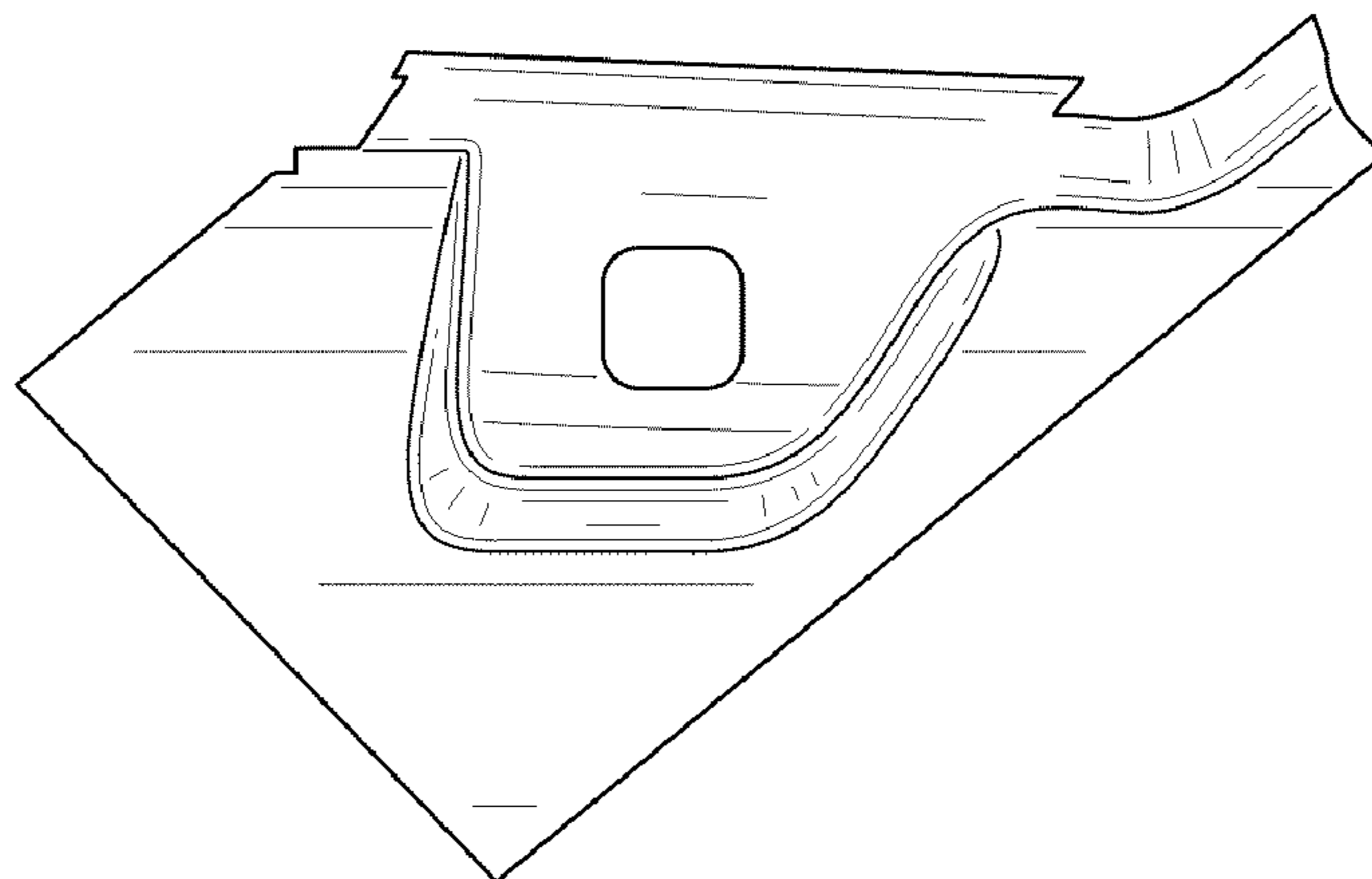

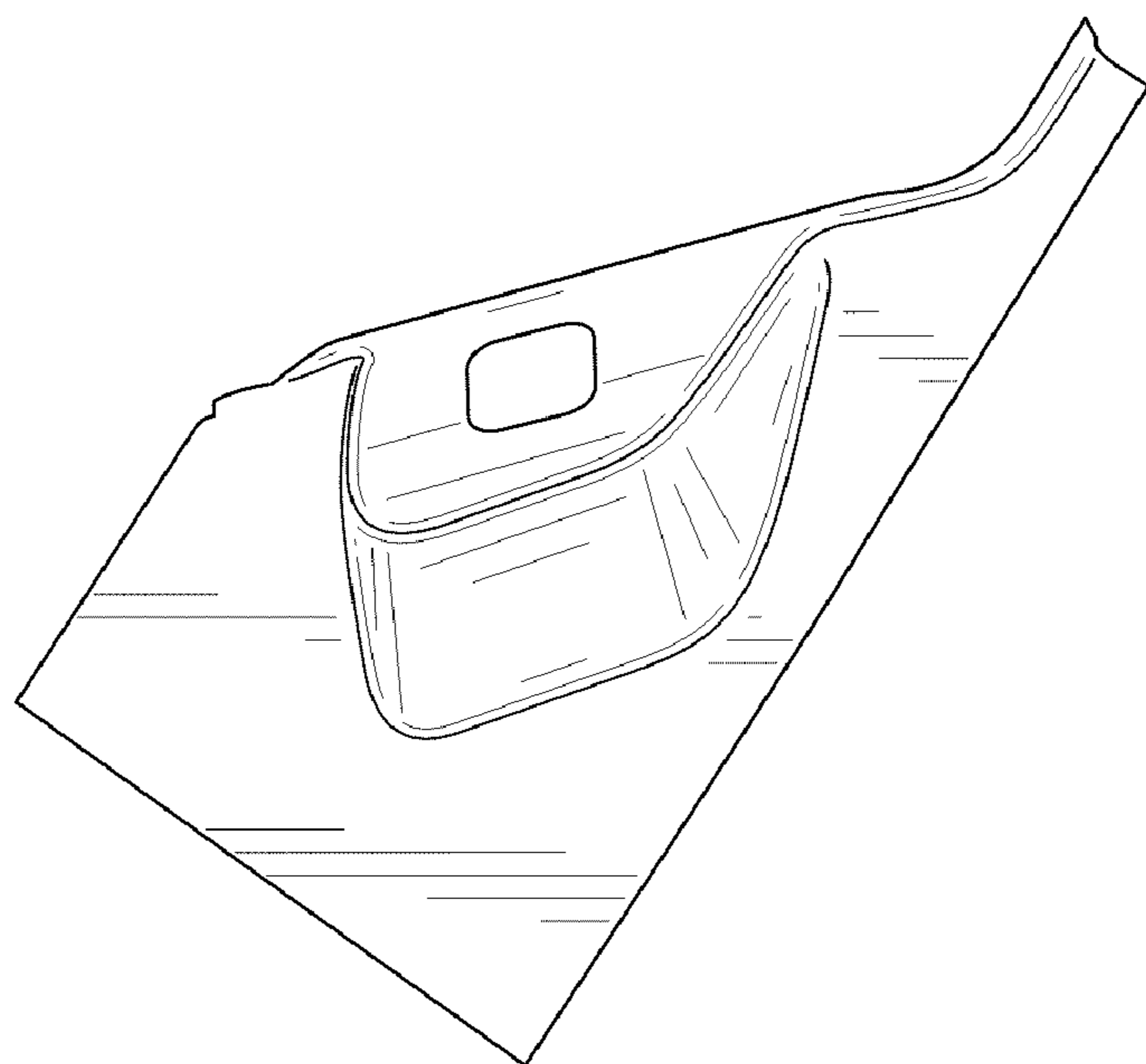

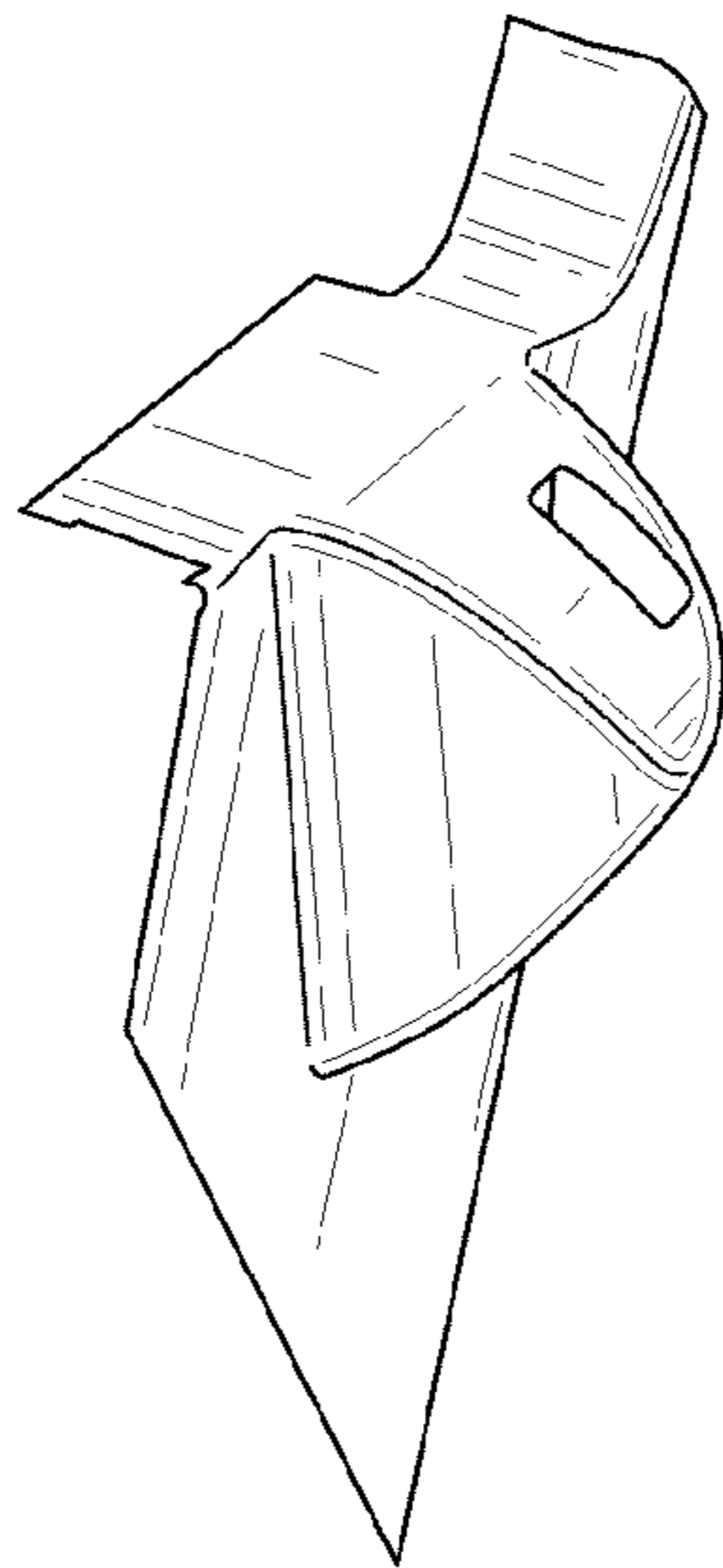

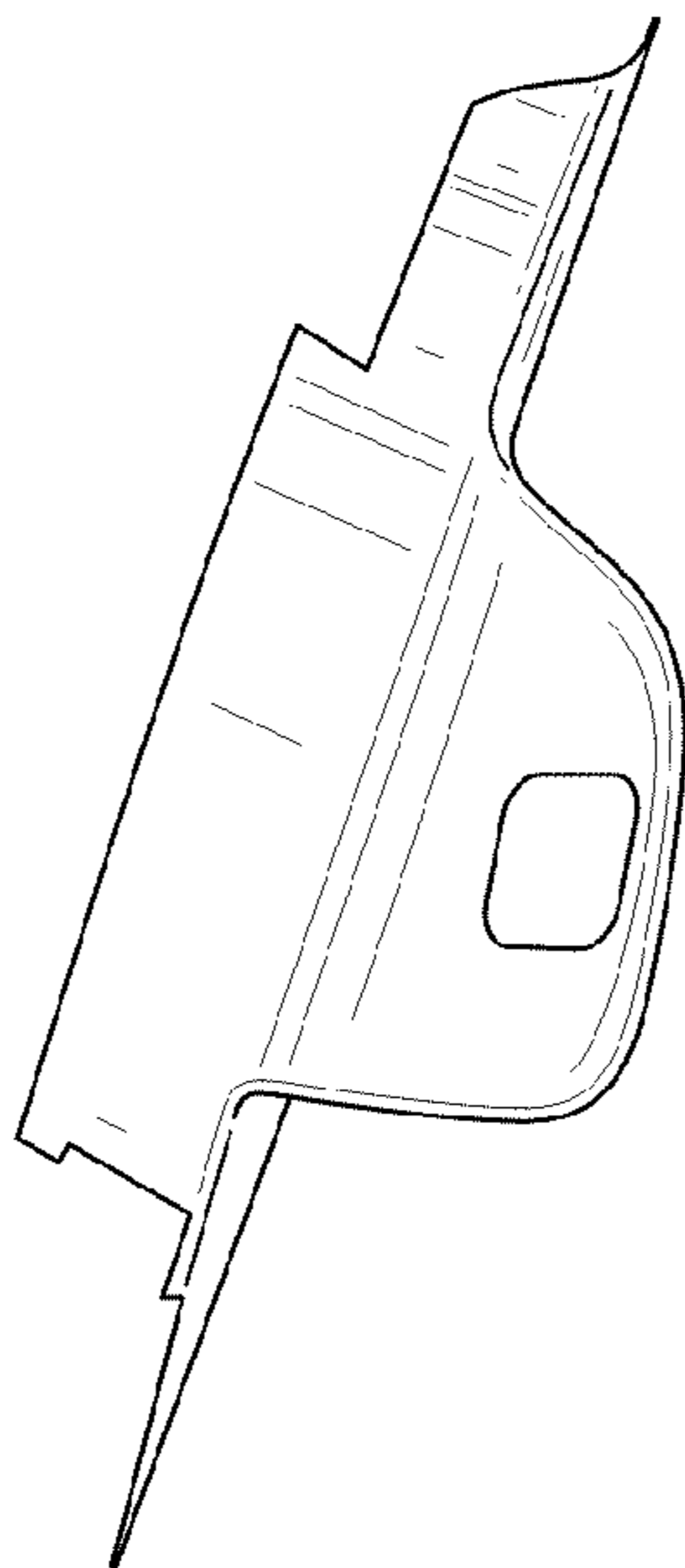
