(57) **CLAIM**

The ornamental design for the spectacles with removable eye seals, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the spectacles with removable eye seals showing my design.

FIG. 2 is rear perspective view of the spectacles of FIG. 1.

FIG. 3 is a front elevation view of the spectacles of FIG. 1.

FIG. 4 is a right side elevation view of the spectacles of FIG. 1.

FIG. 5 is a rear elevation view of the spectacles of FIG. 1.

FIG. 6 is a top plan view of the spectacles of FIG. 1.

FIG. 7 is a bottom plan view of the spectacles of FIG. 1.

FIG. 8 is cross-sectional right side elevation view of the spectacles of FIG. 6 taken along view line 8—8.

FIG. 9 is front perspective view of the spectacles showing my design with their strap and with the removable eye seals separated showing my design.

FIG. 10 is rear perspective view of the spectacles of FIG. 9.

FIG. 11 is a front perspective view of the spectacles with the removable eye seals removed showing my design.

FIG. 22 is a right side elevation view of the spectacles of FIG. 19.

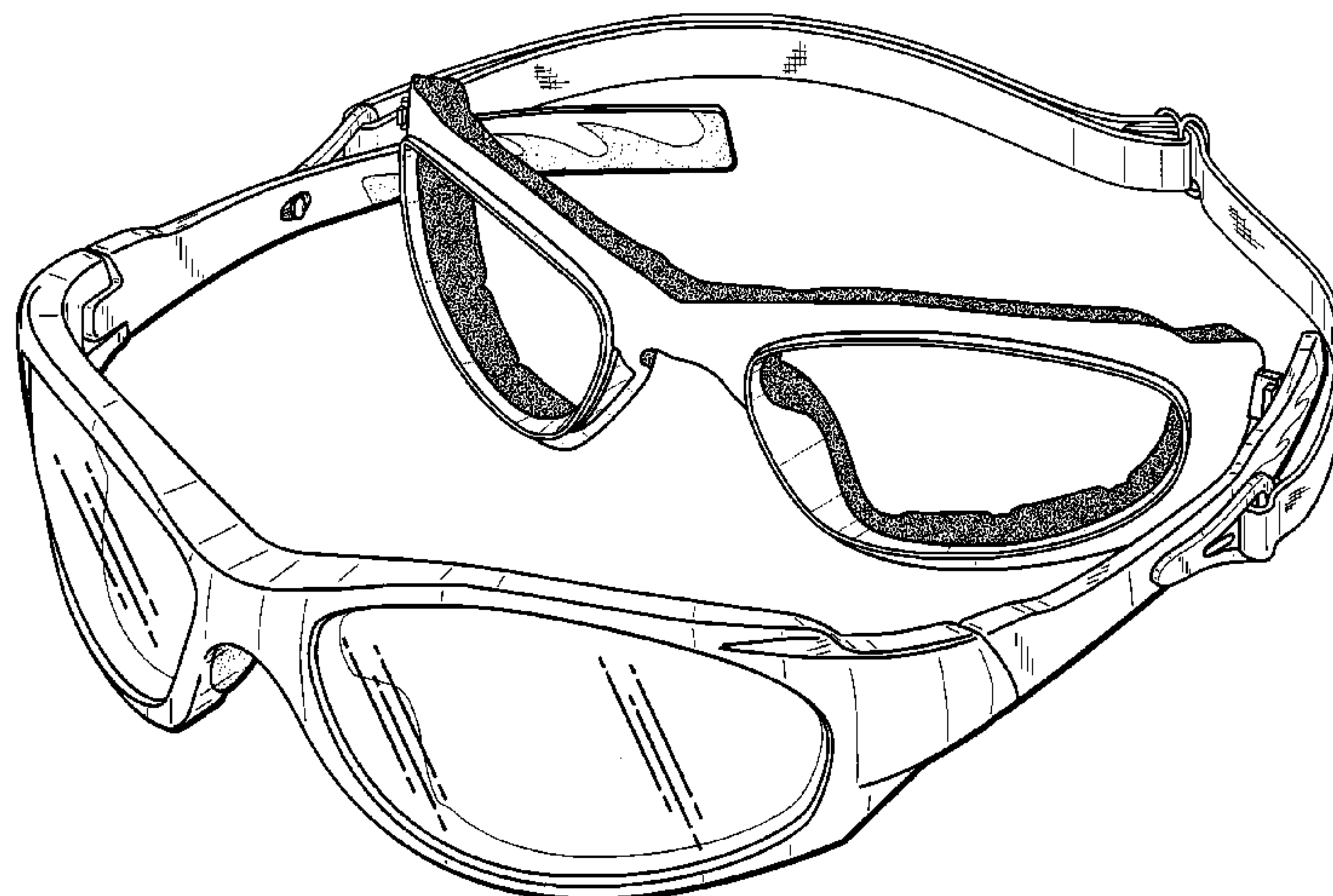
FIG. 23 is a bottom plan view of the spectacles of FIG. 19.

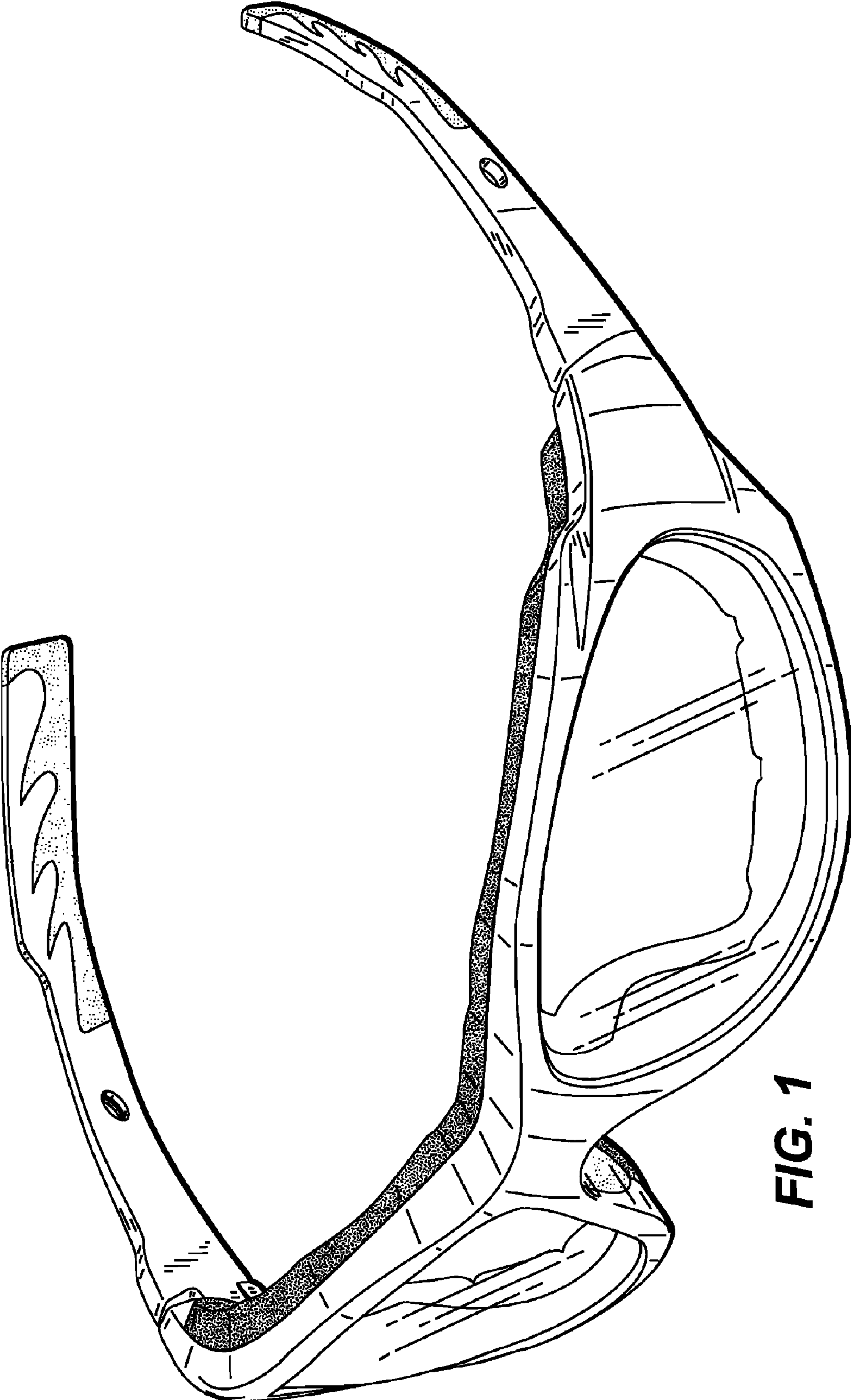

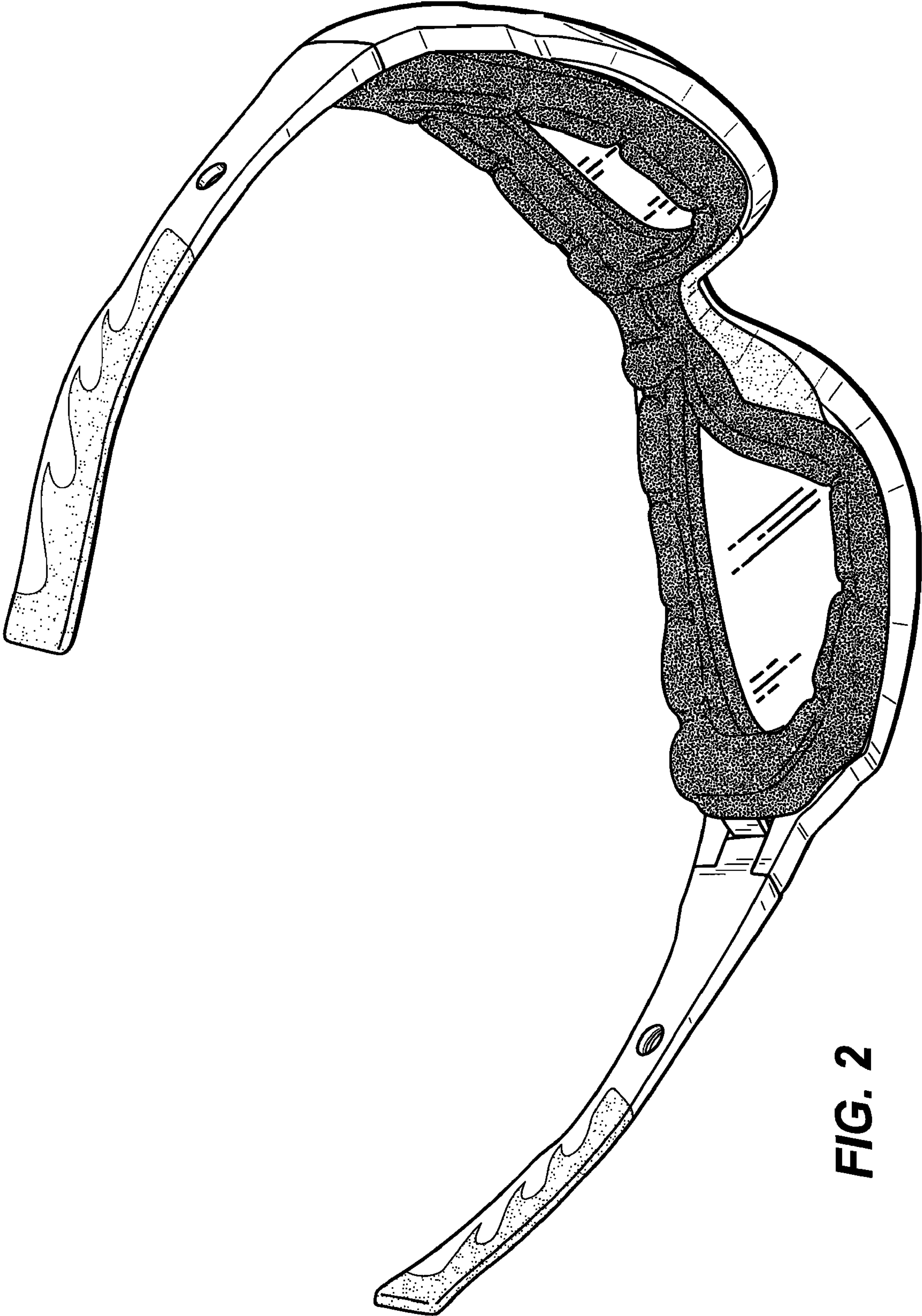
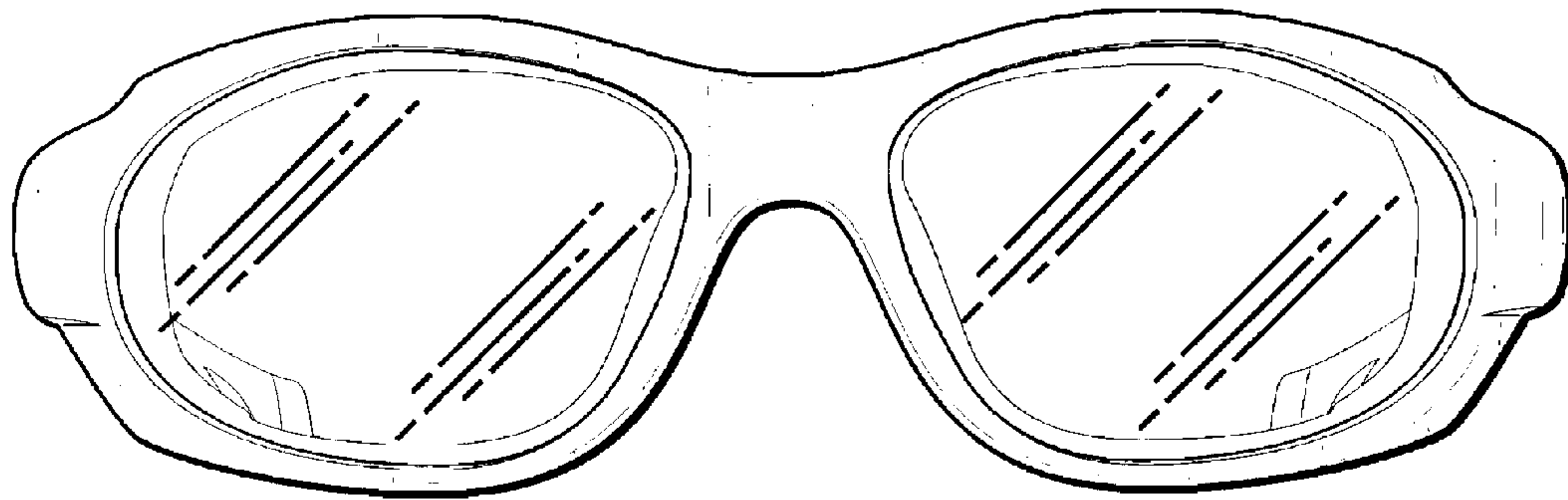
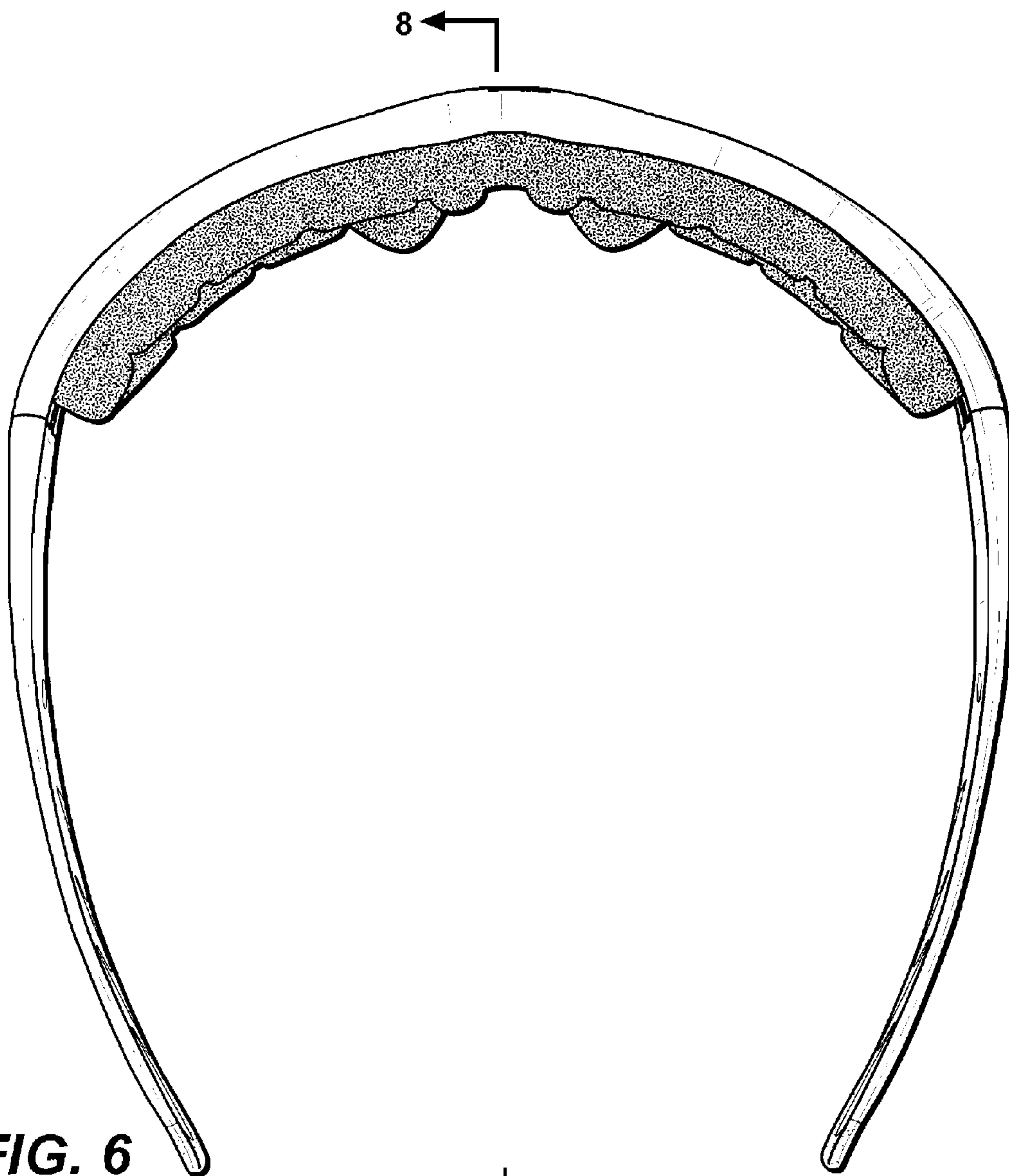

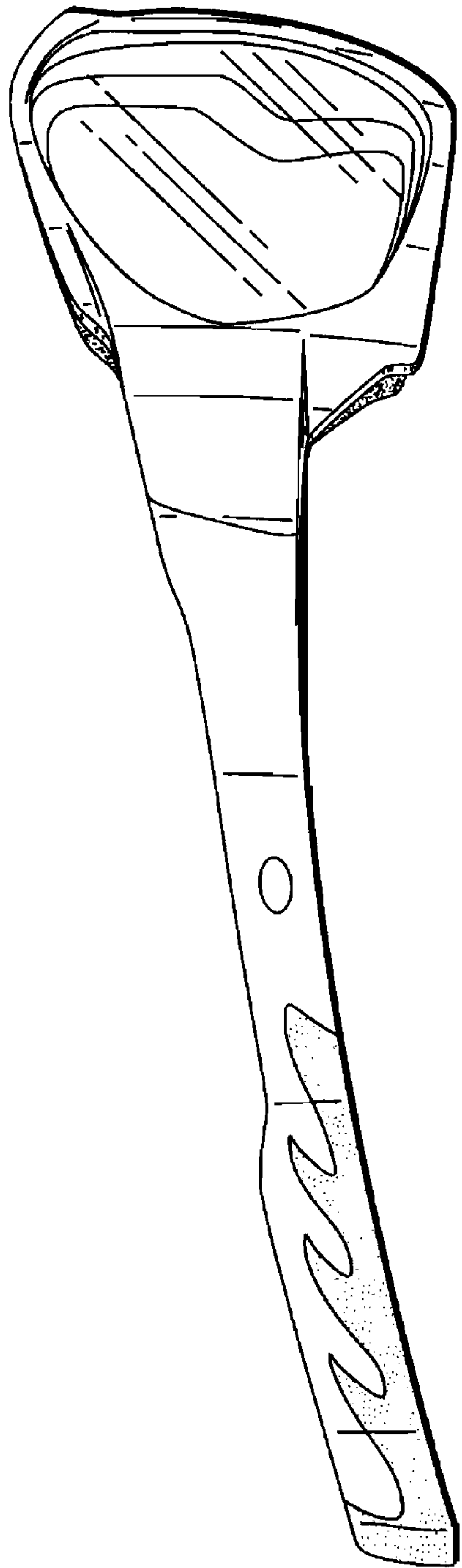

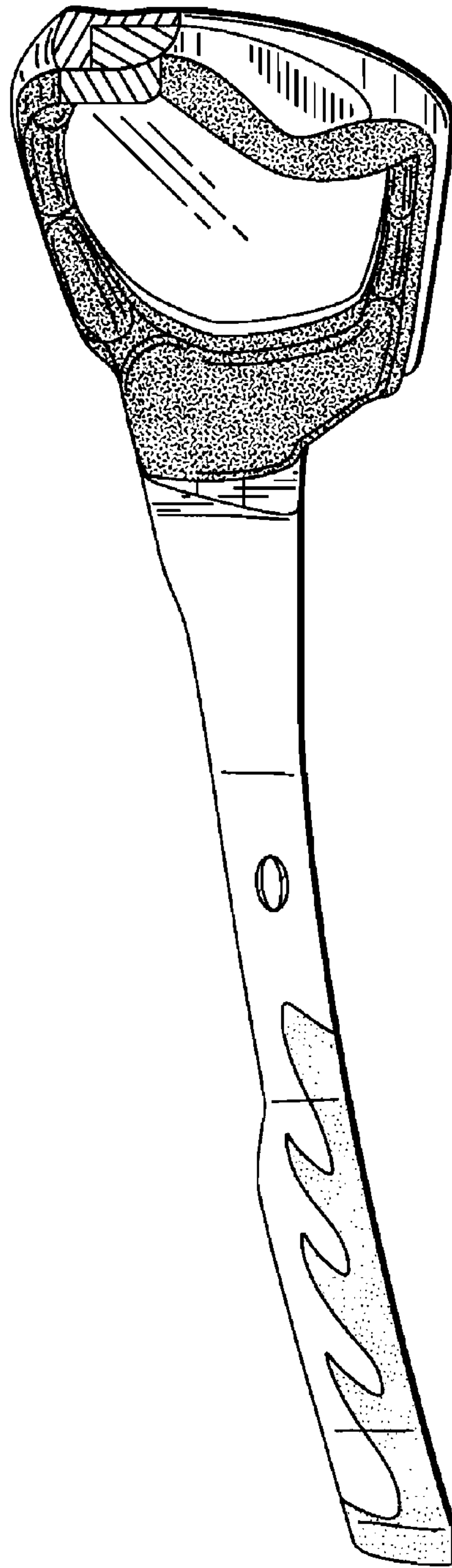

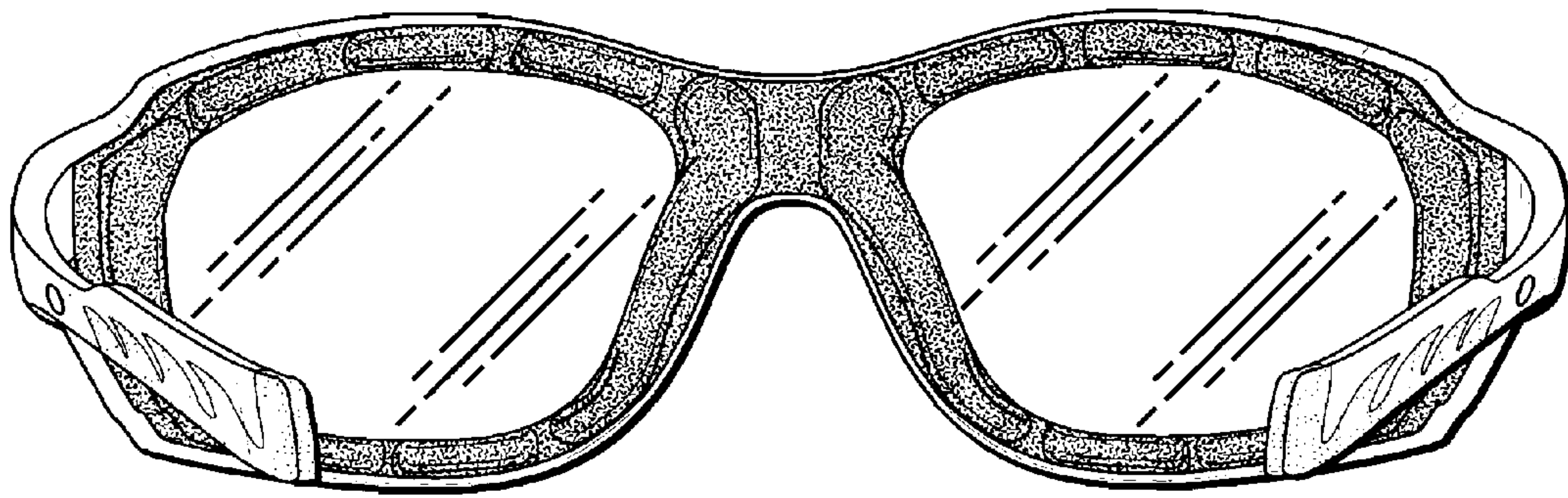




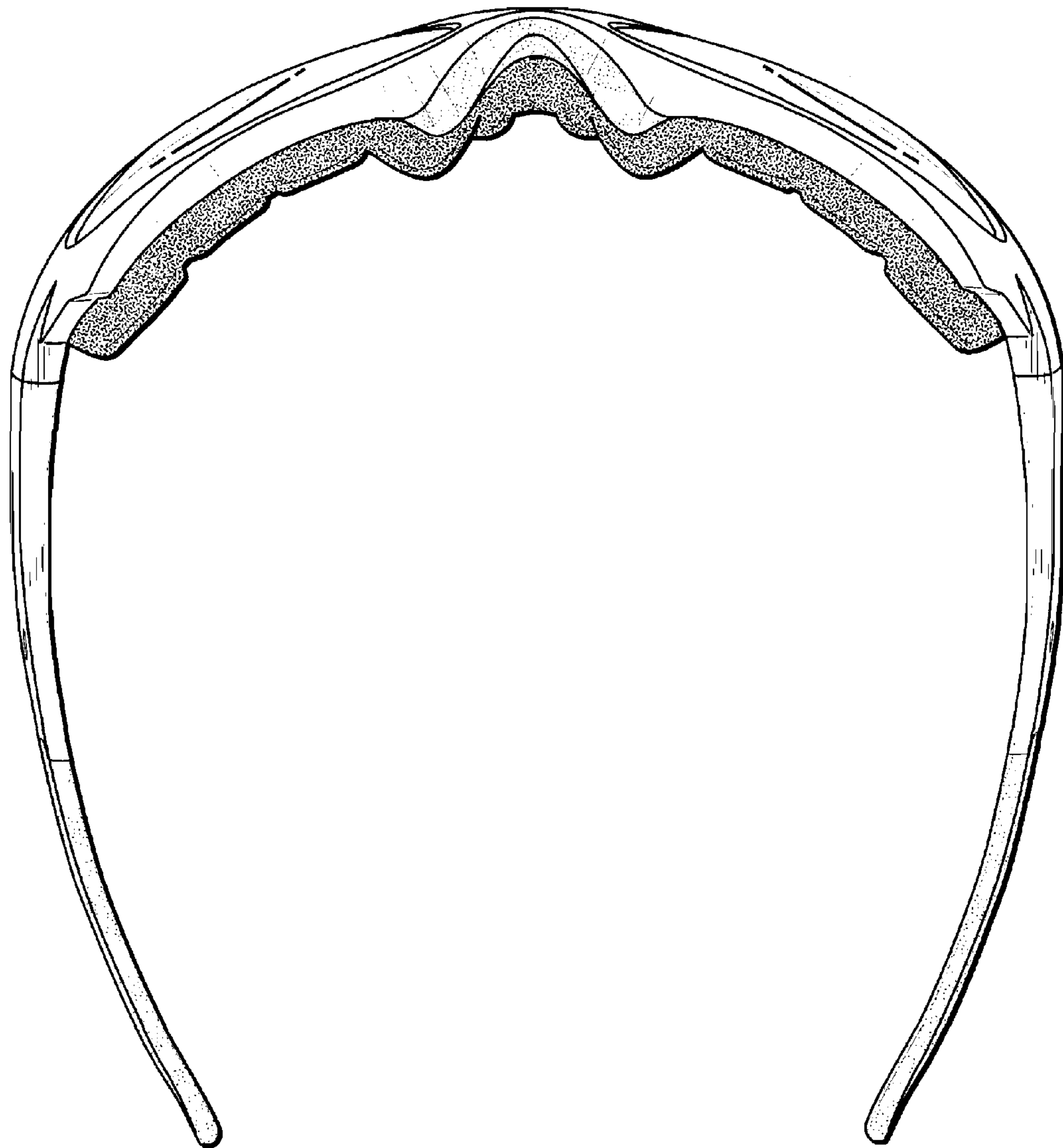

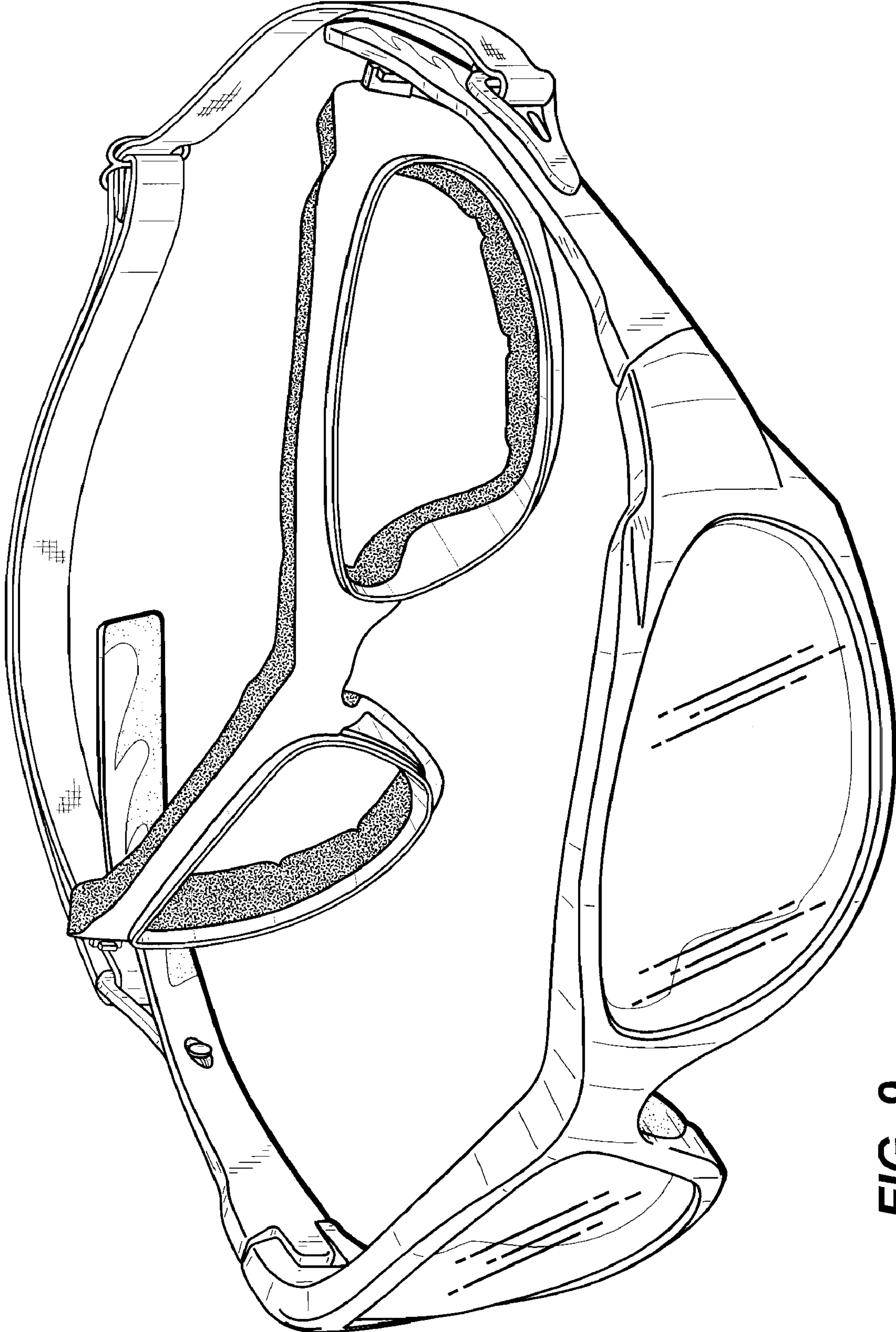
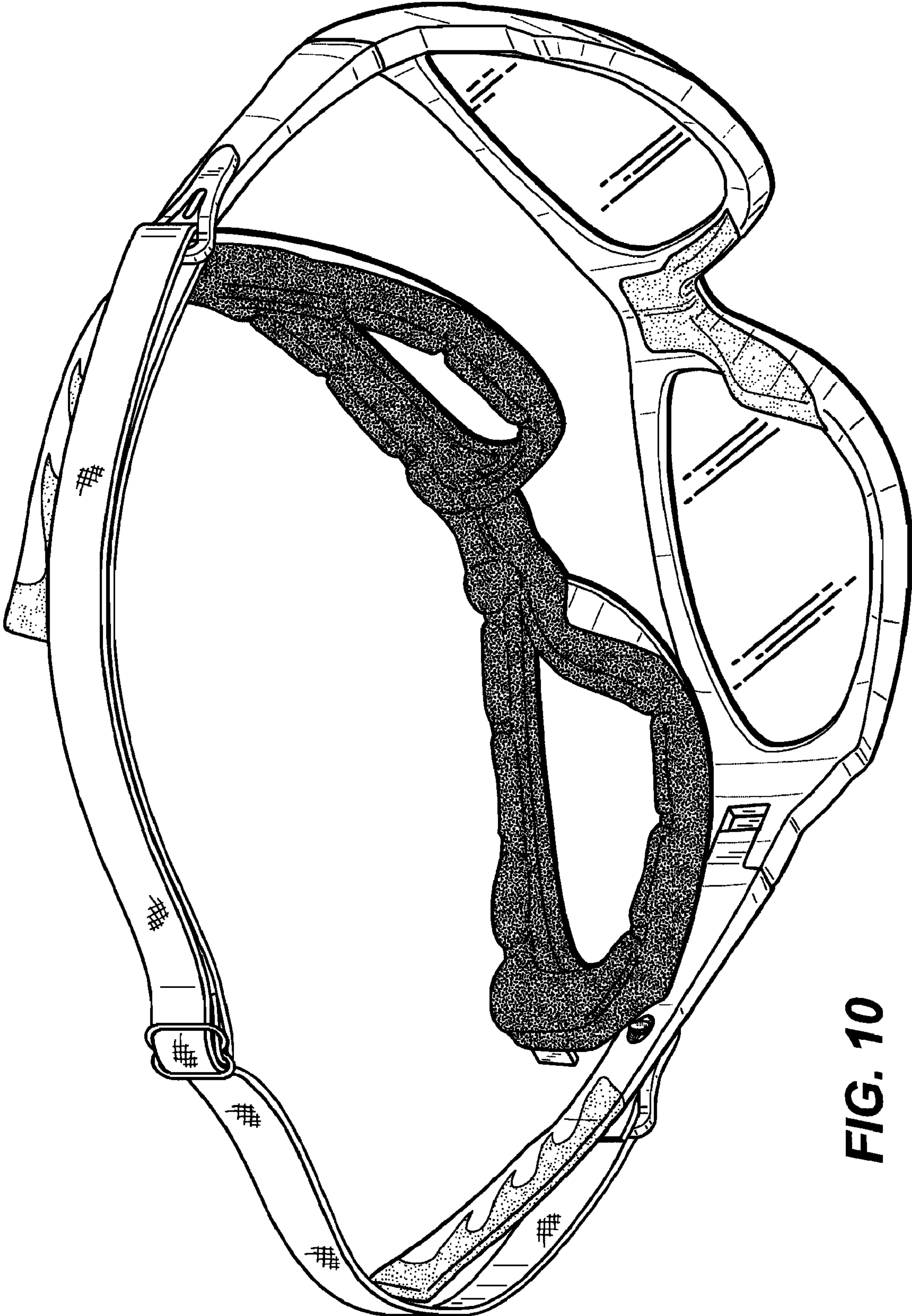
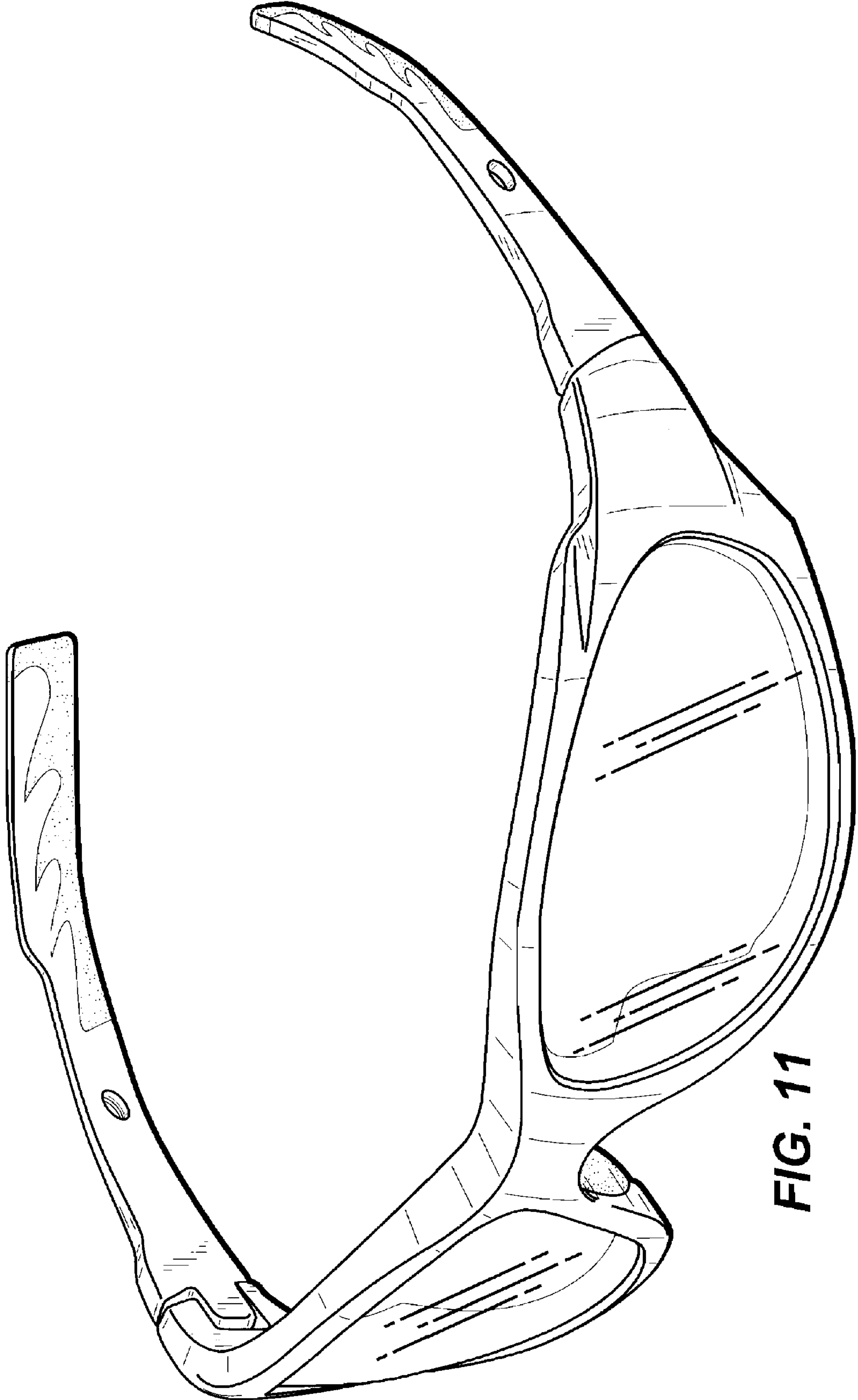

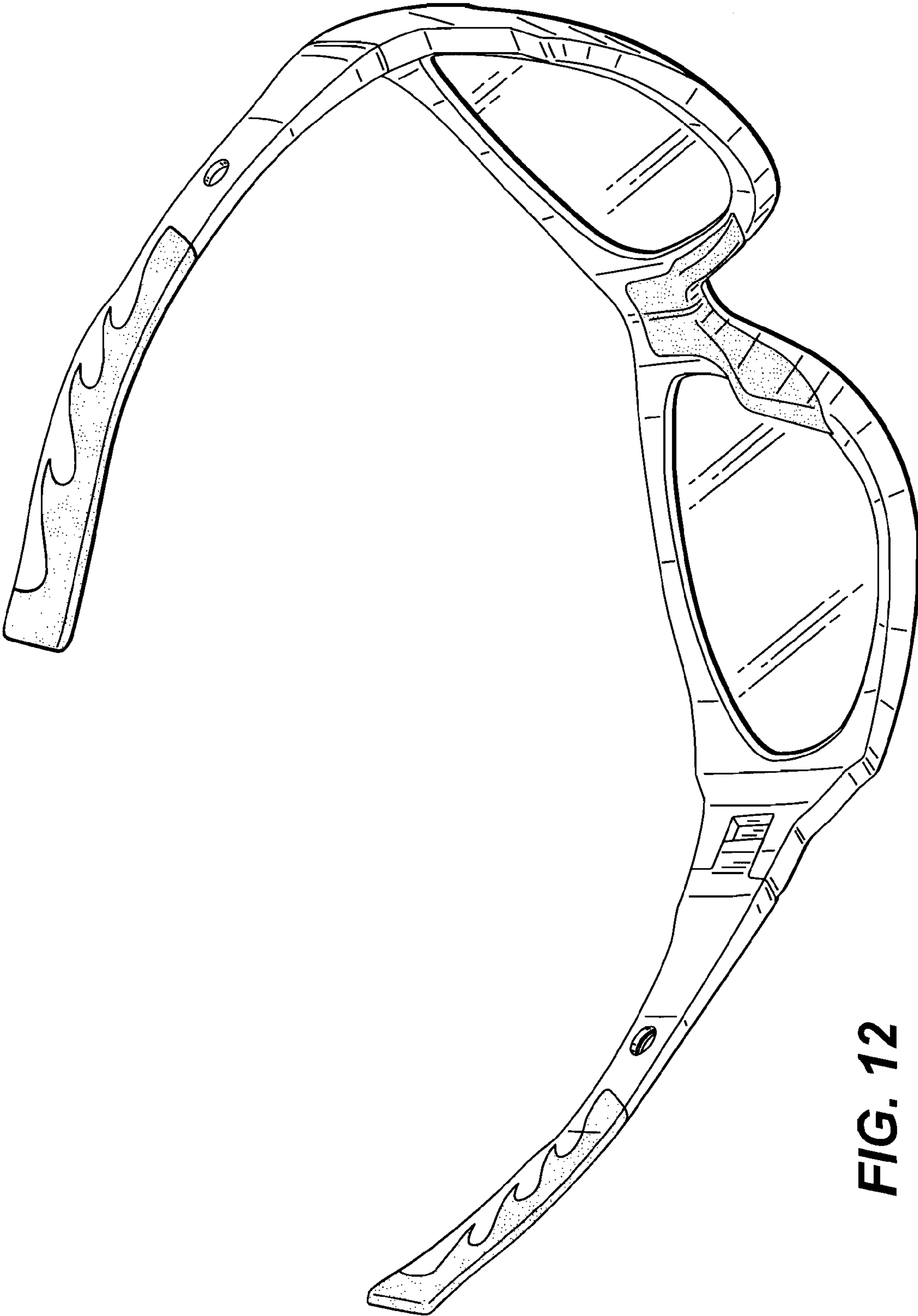

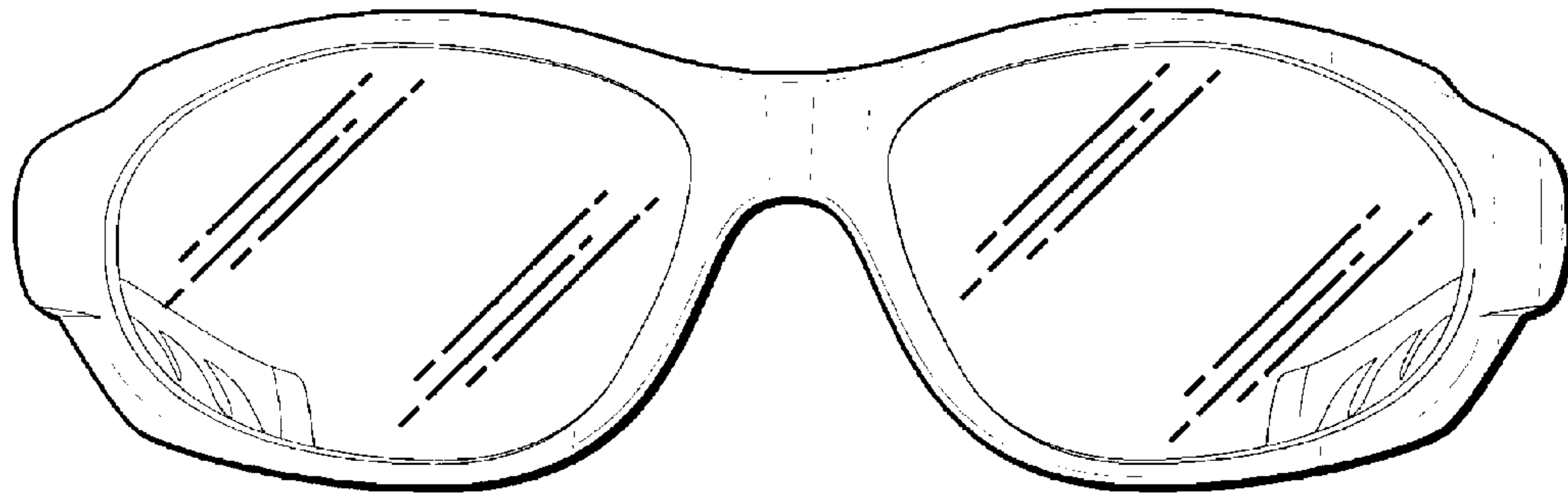

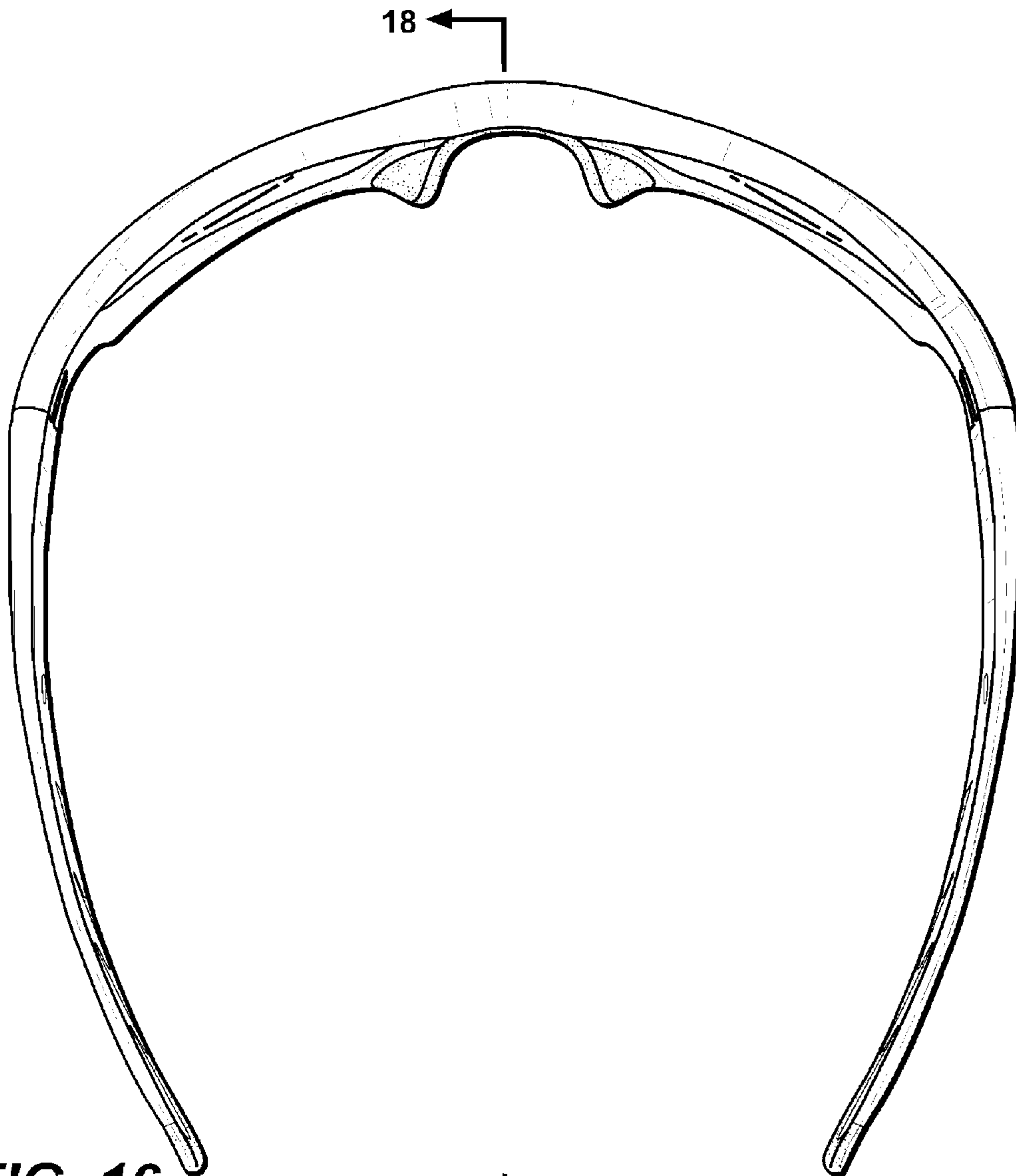

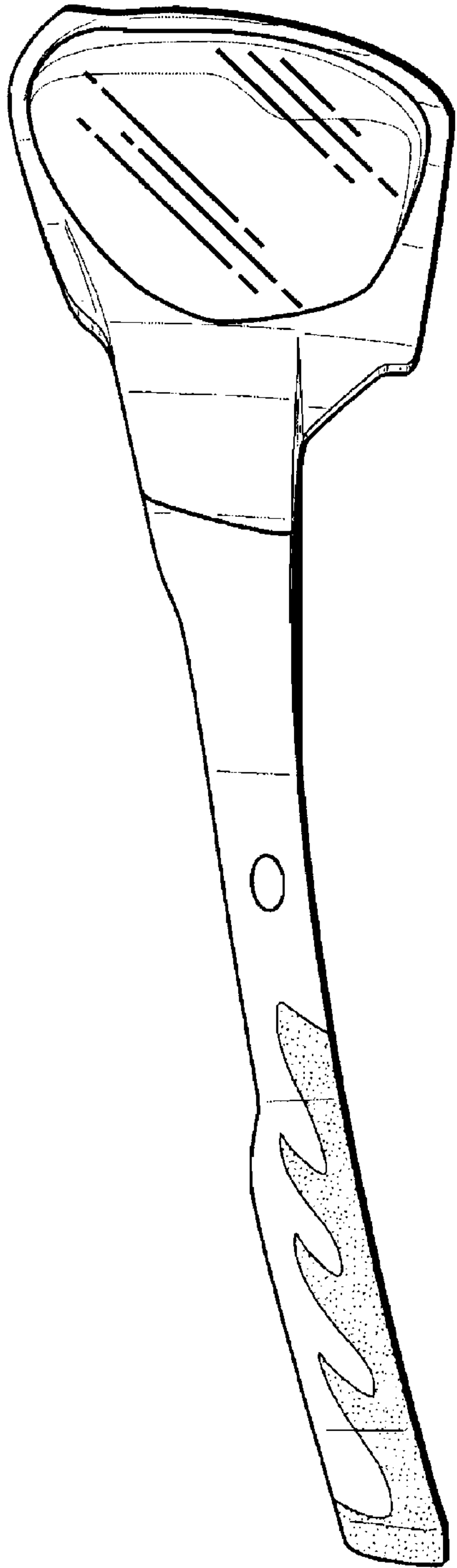

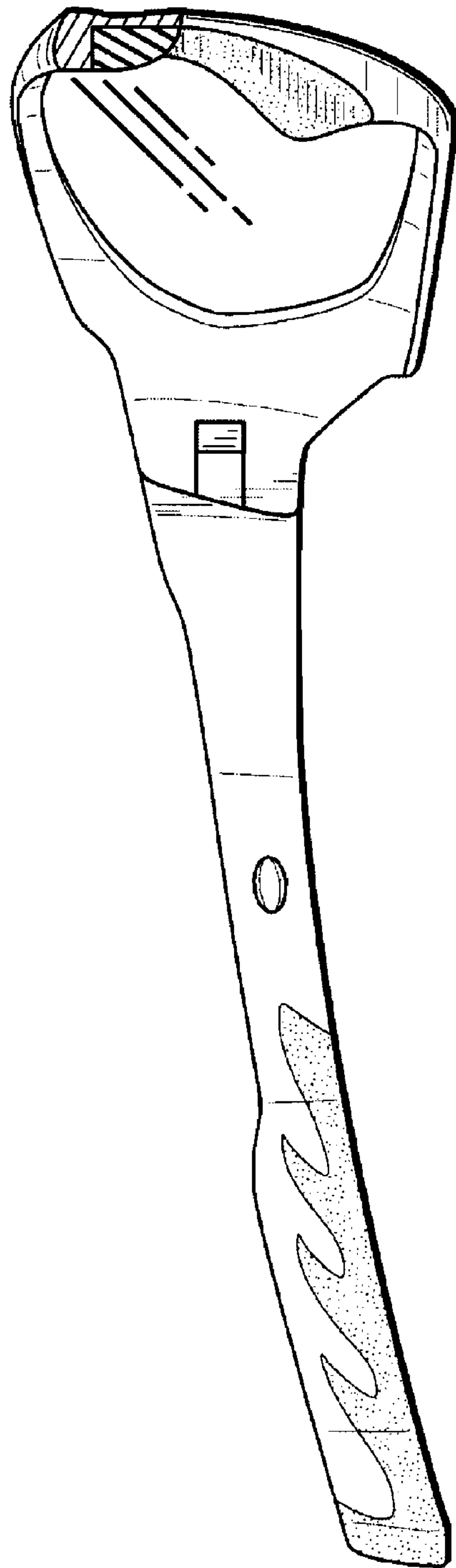

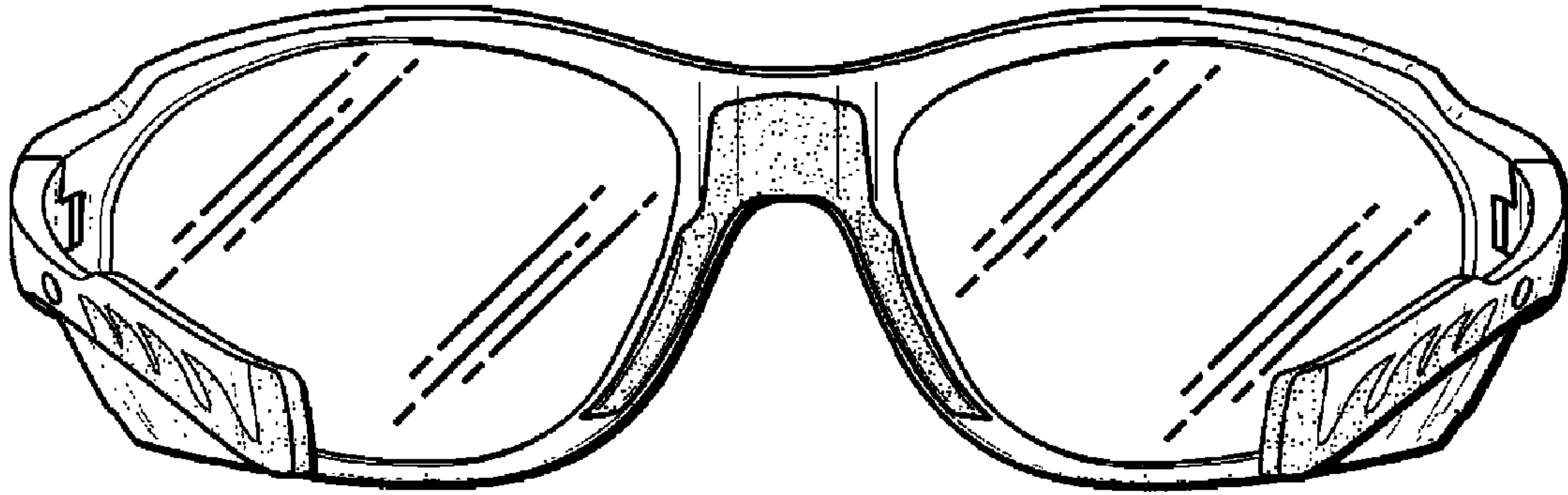




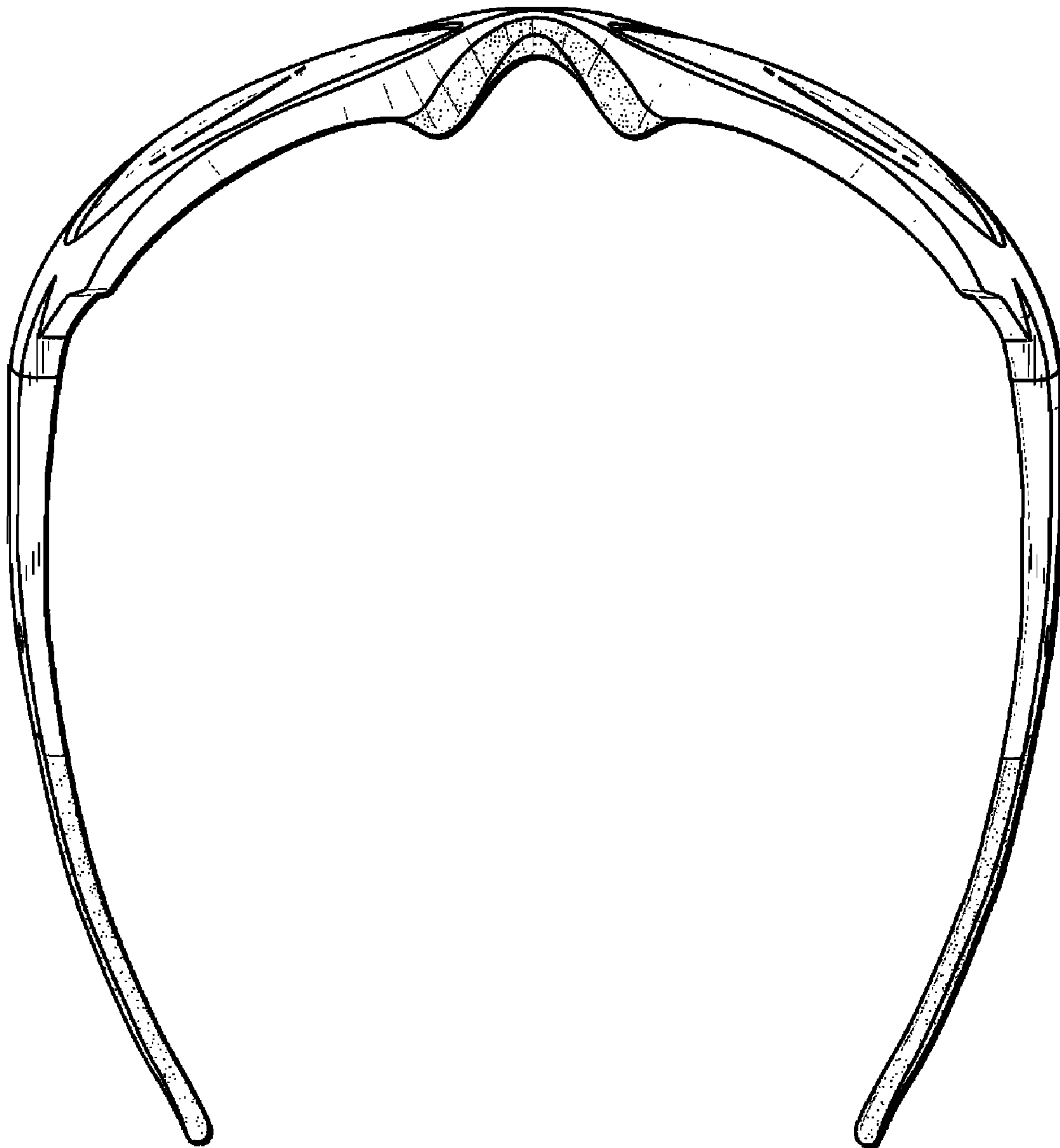

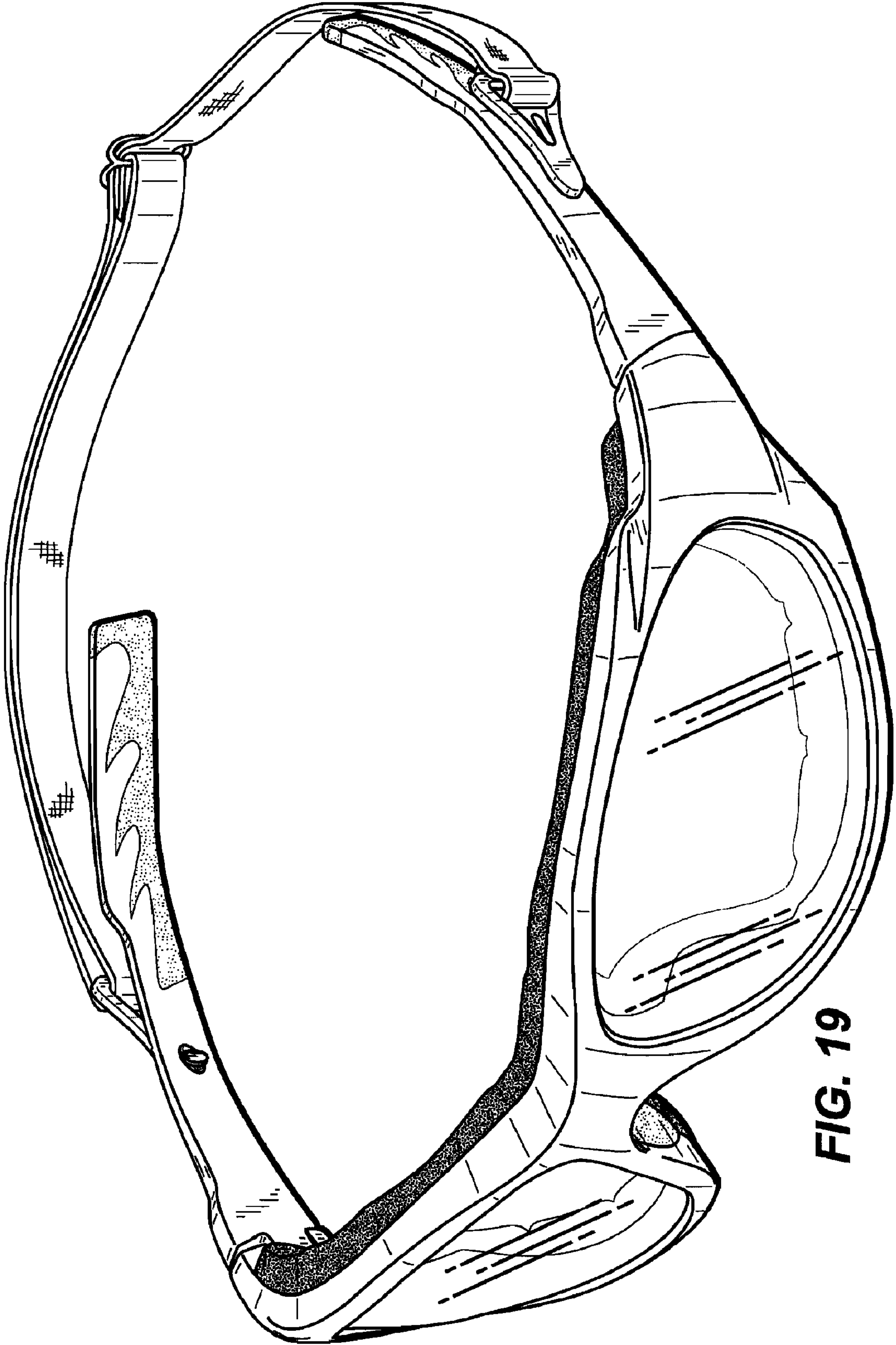

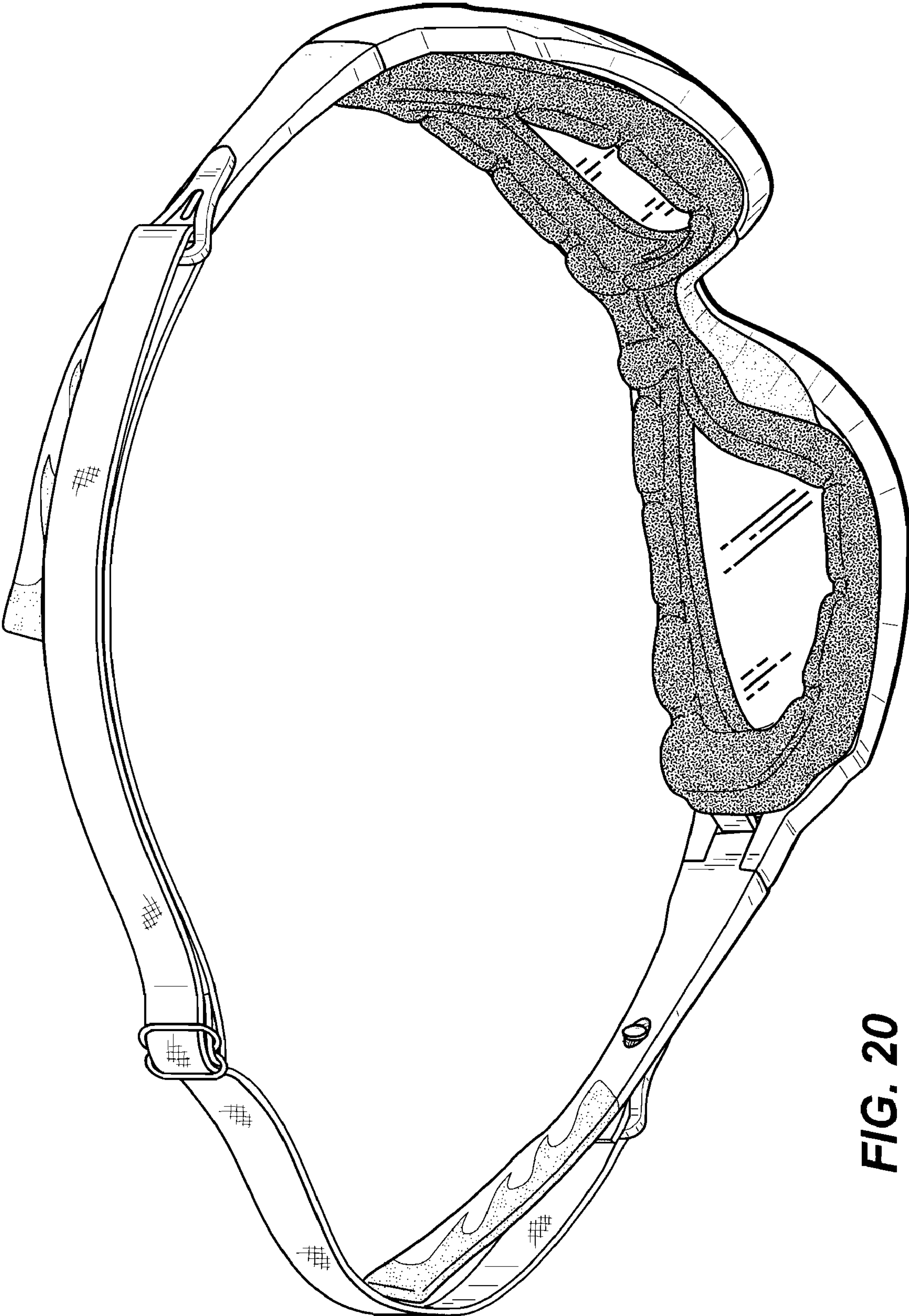
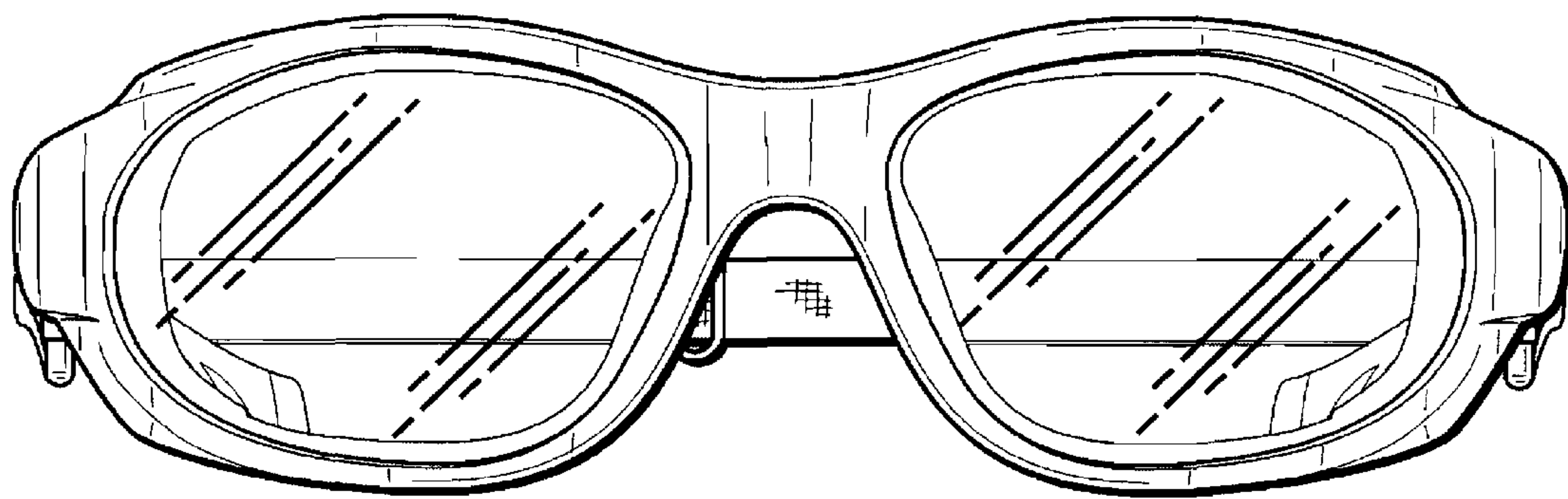
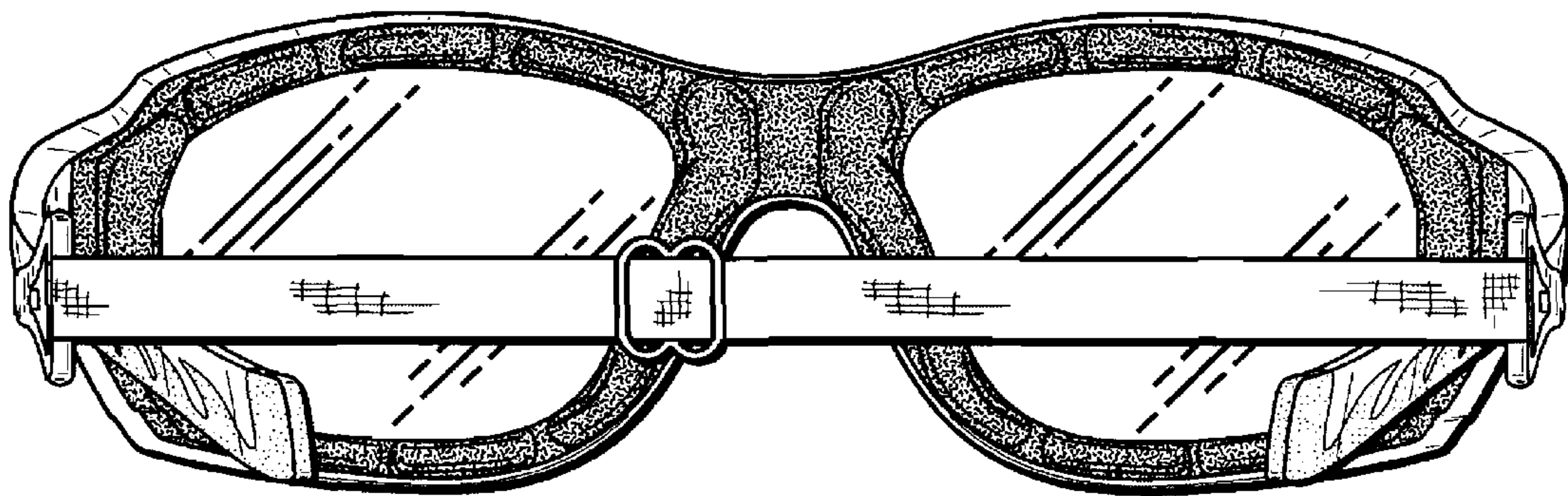

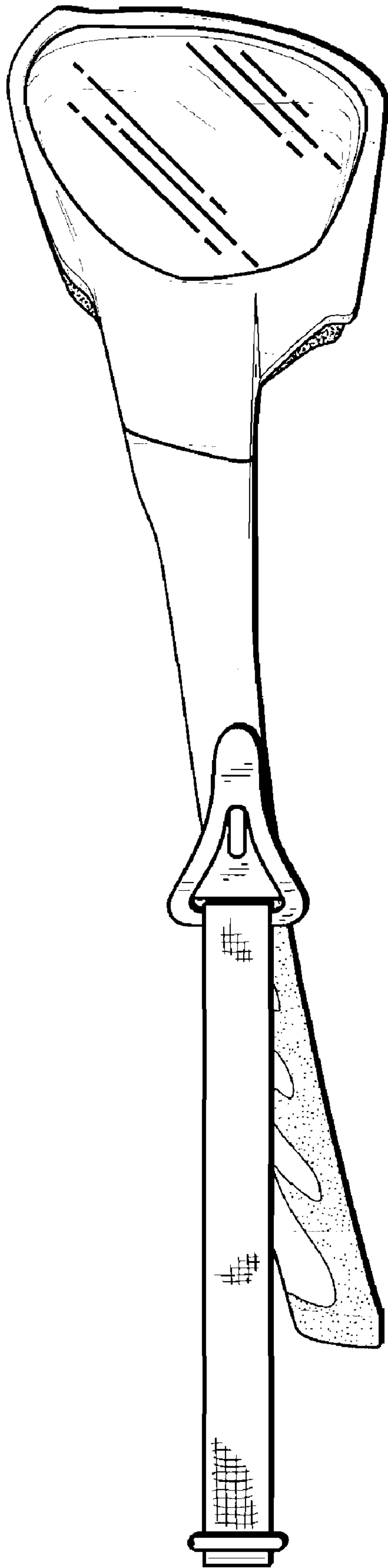

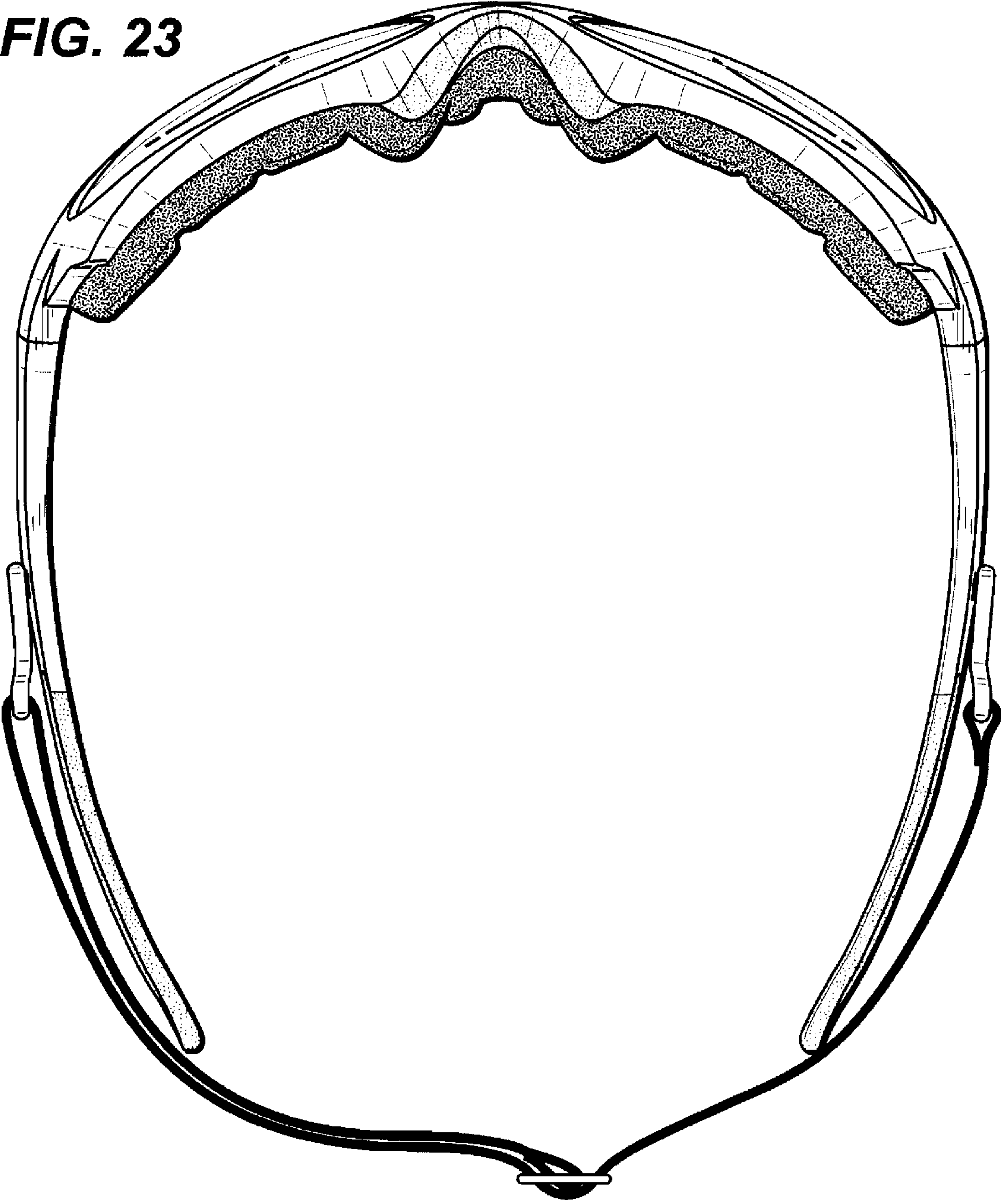

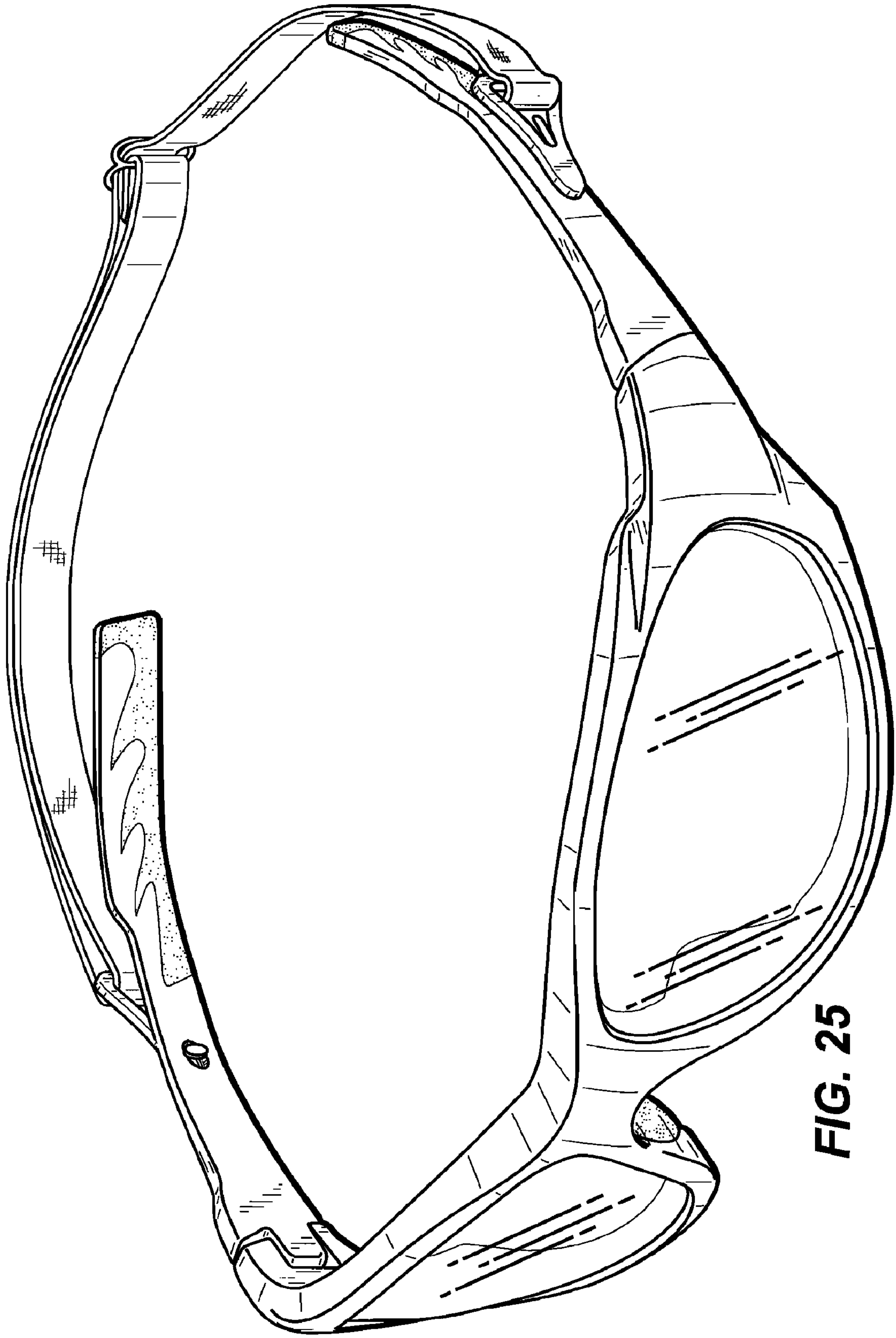

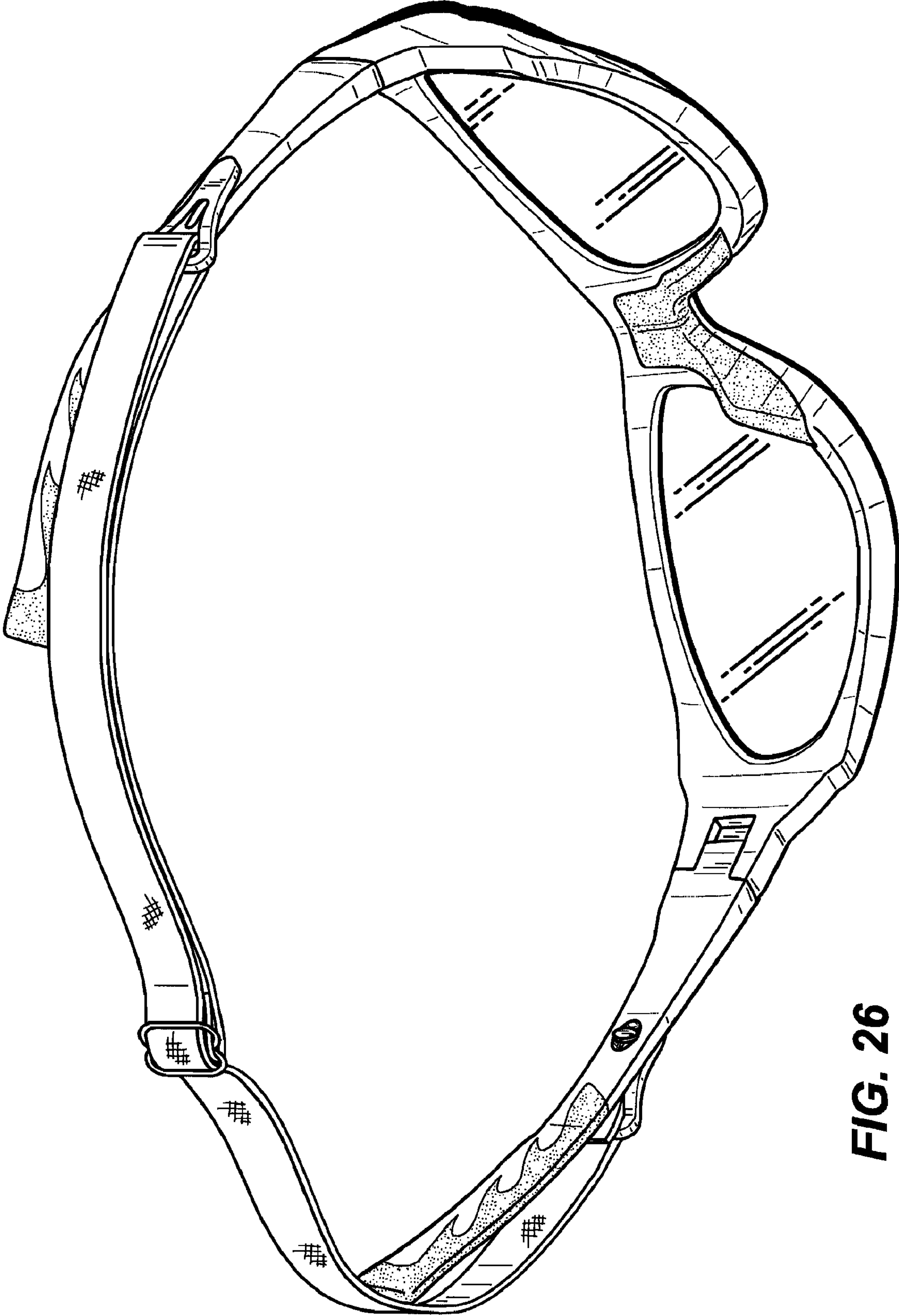
