FIG. 3 is another front elevation view thereof;

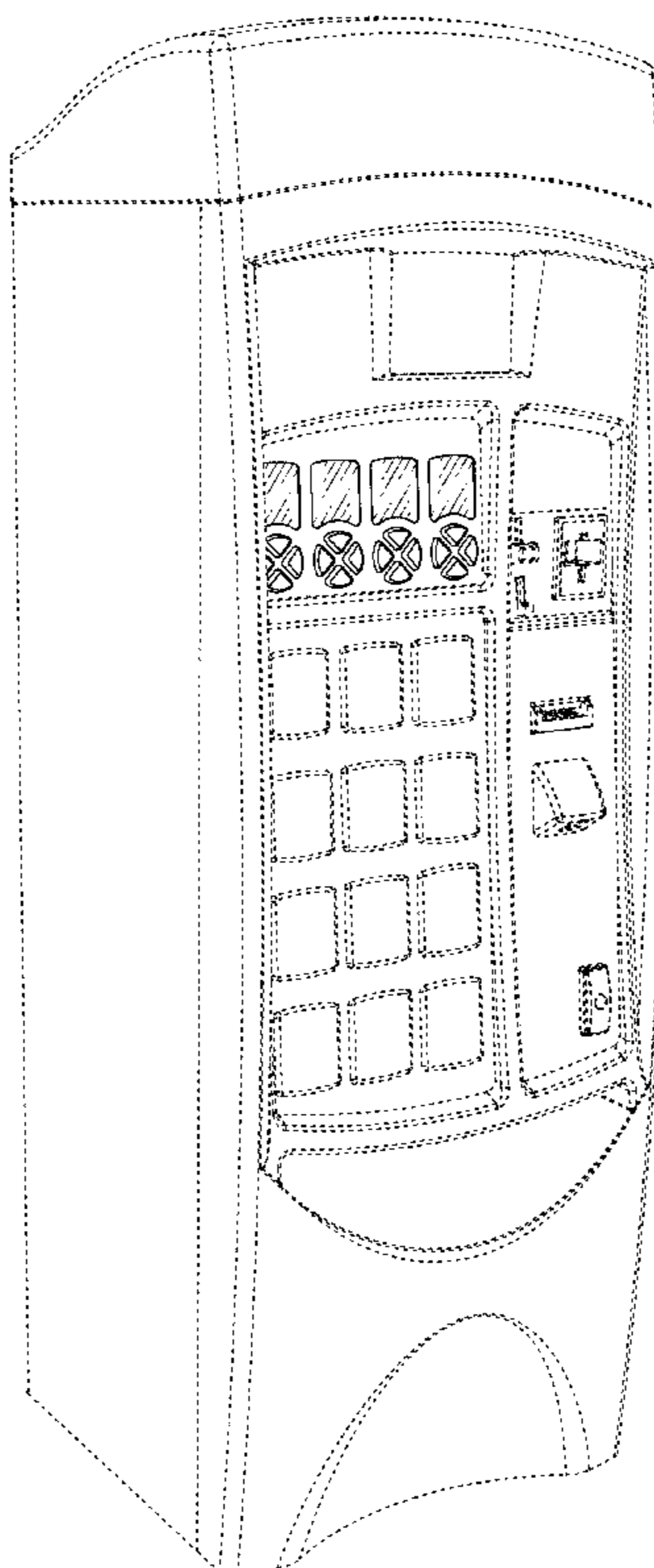
FIG. 4 is an enlarged view showing the claimed features in isolation for clarity;

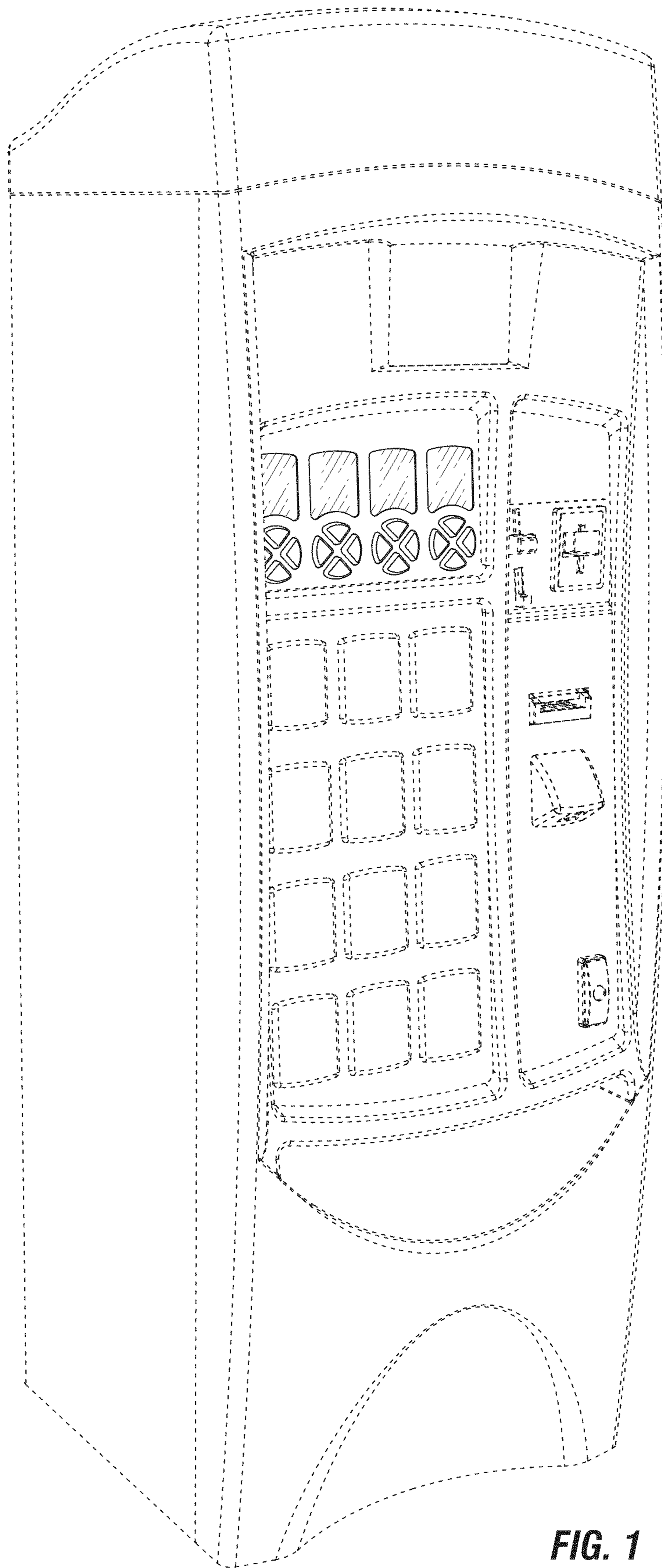

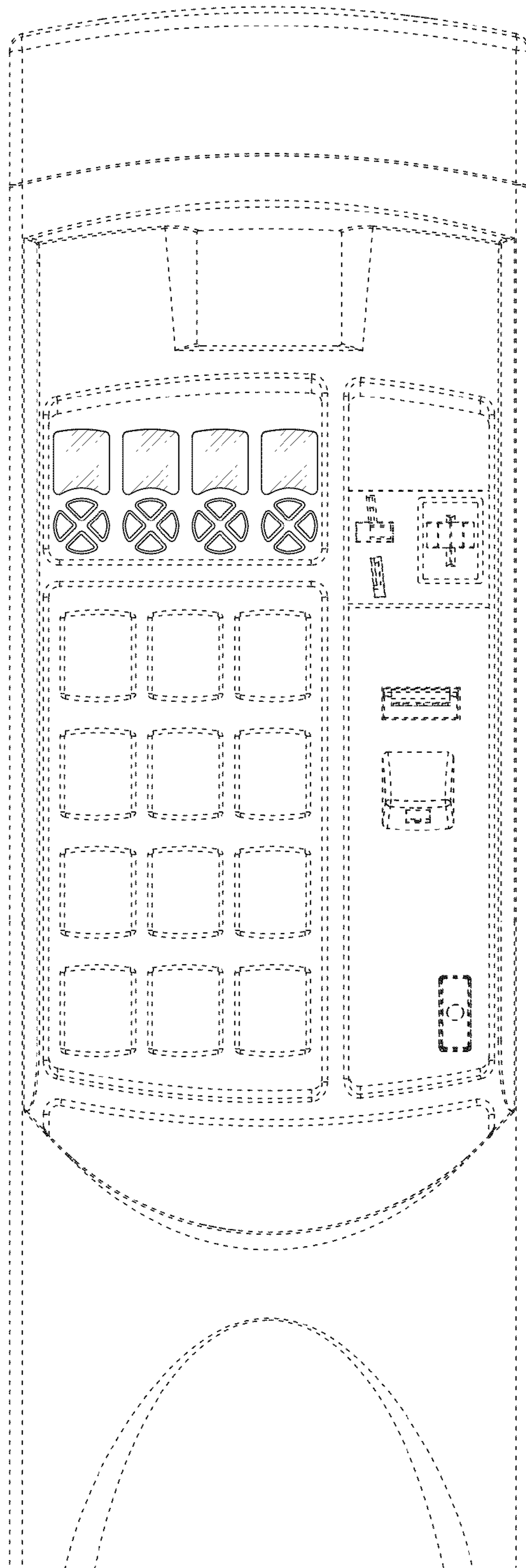

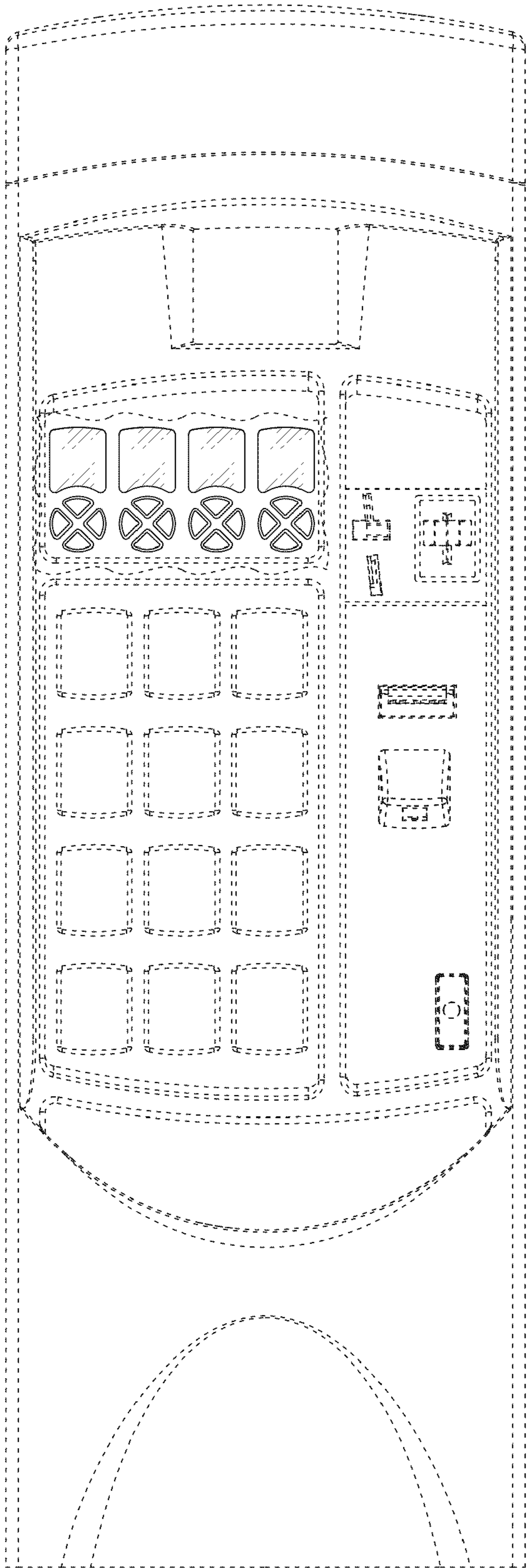

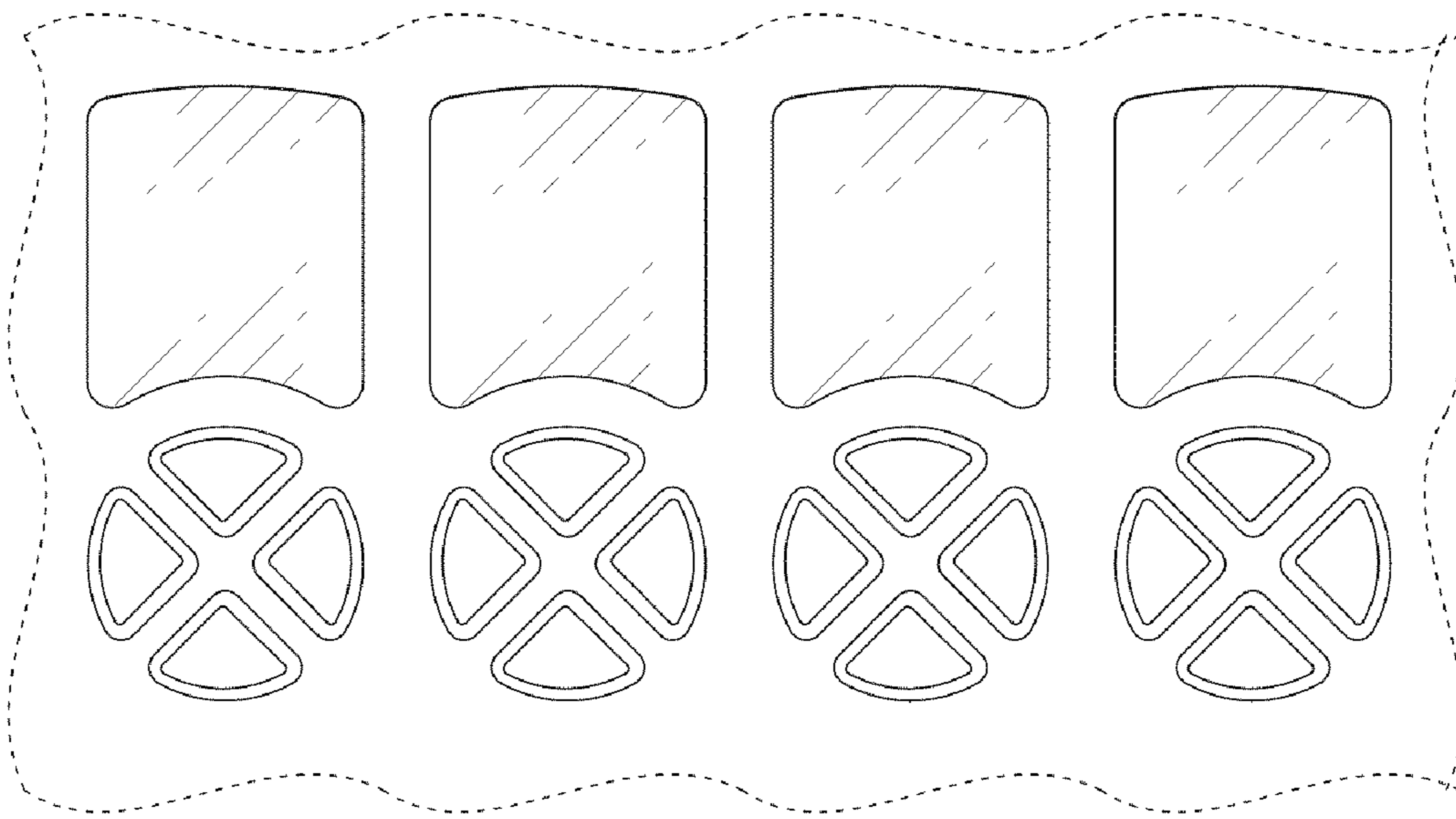

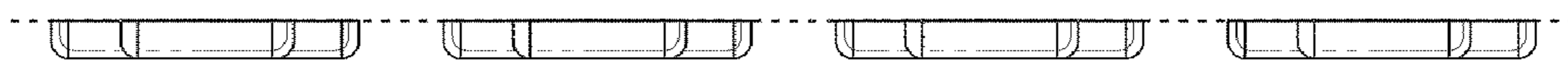
