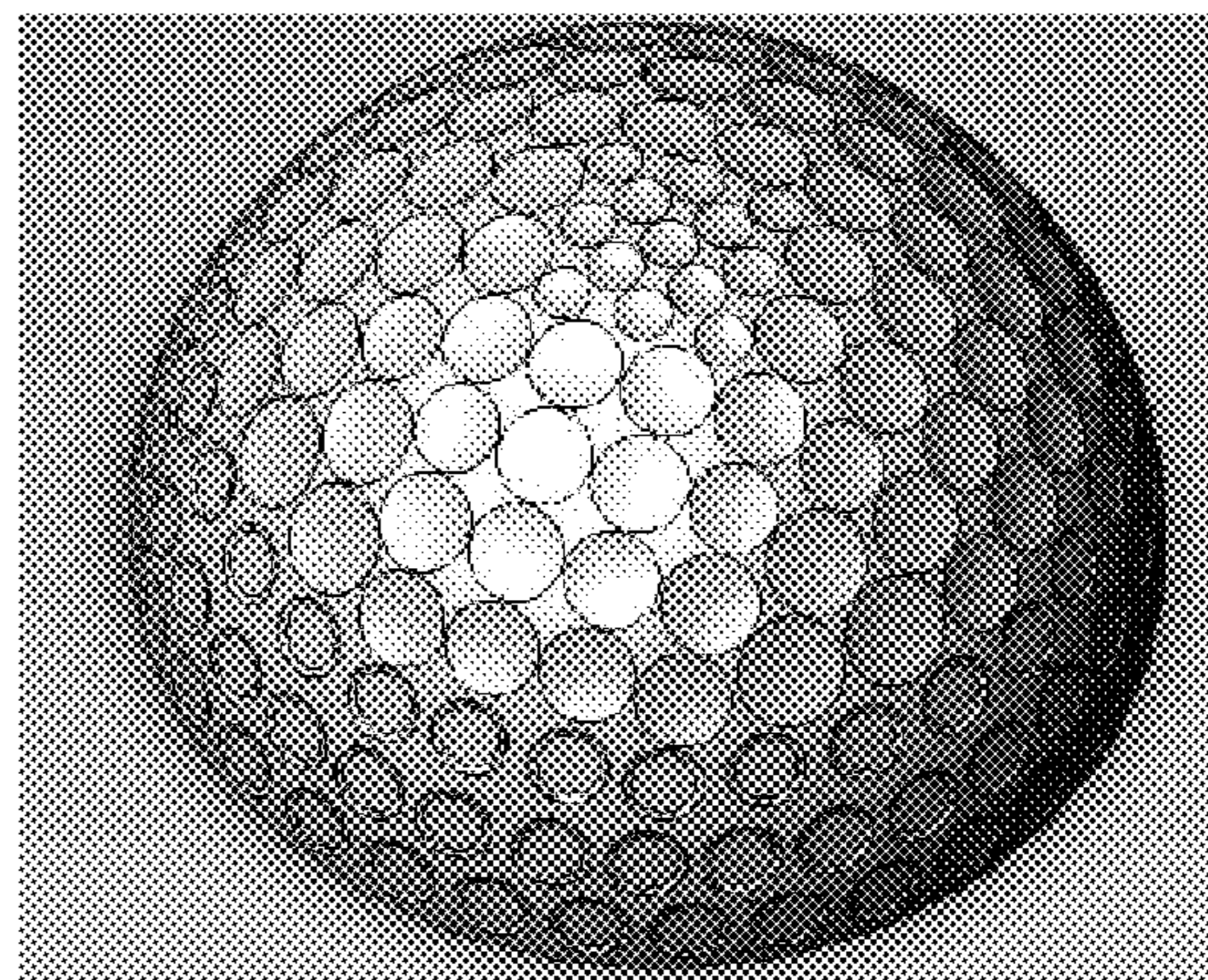
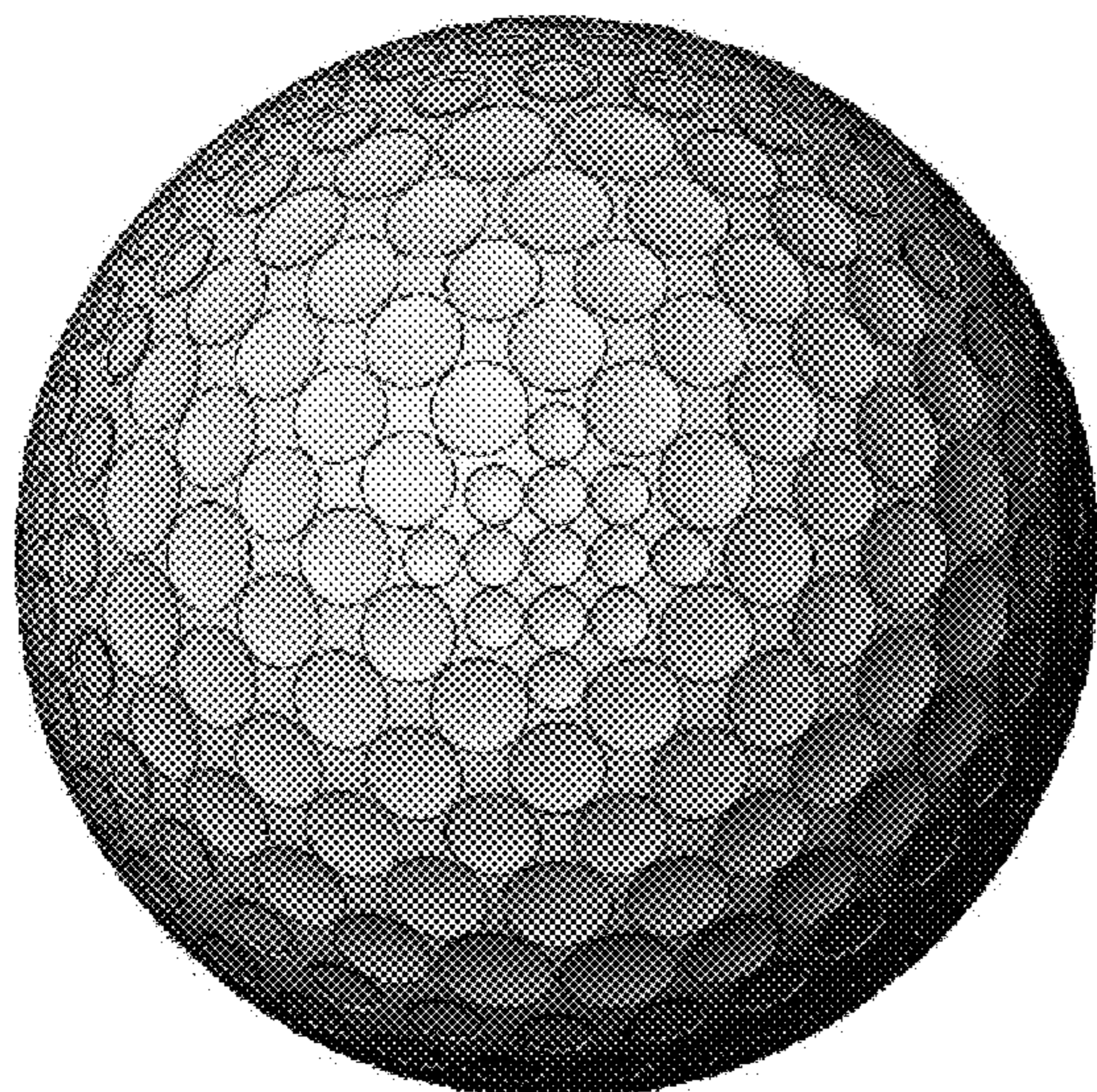
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top perspective view of the new design, the bottom perspective view being the same; and, FIG. 2 is a front perspective view of the upper hemisphere in FIG. 1, shown separately for ease of illustration, the back perspective view and lower hemisphere being the same.

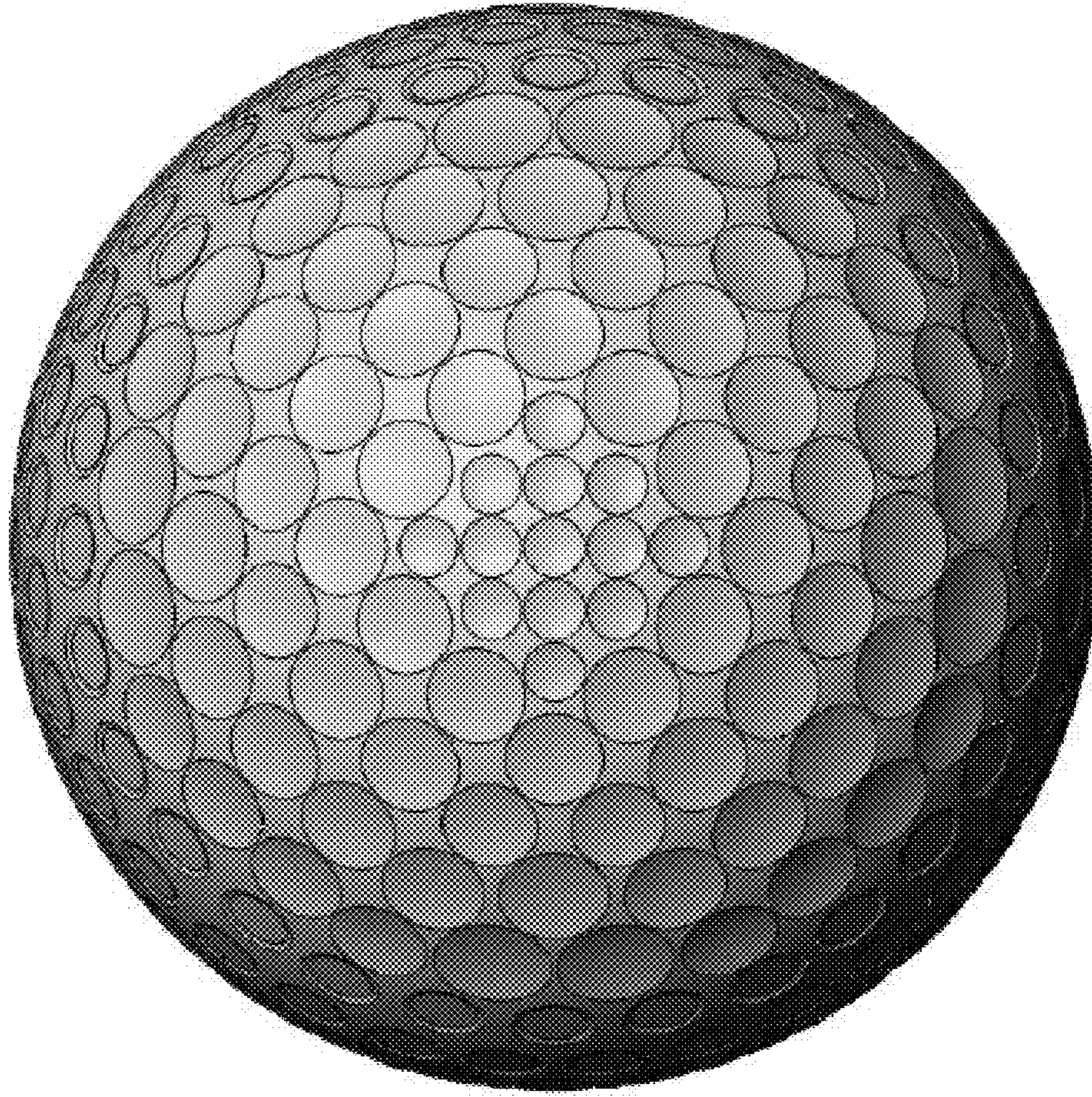

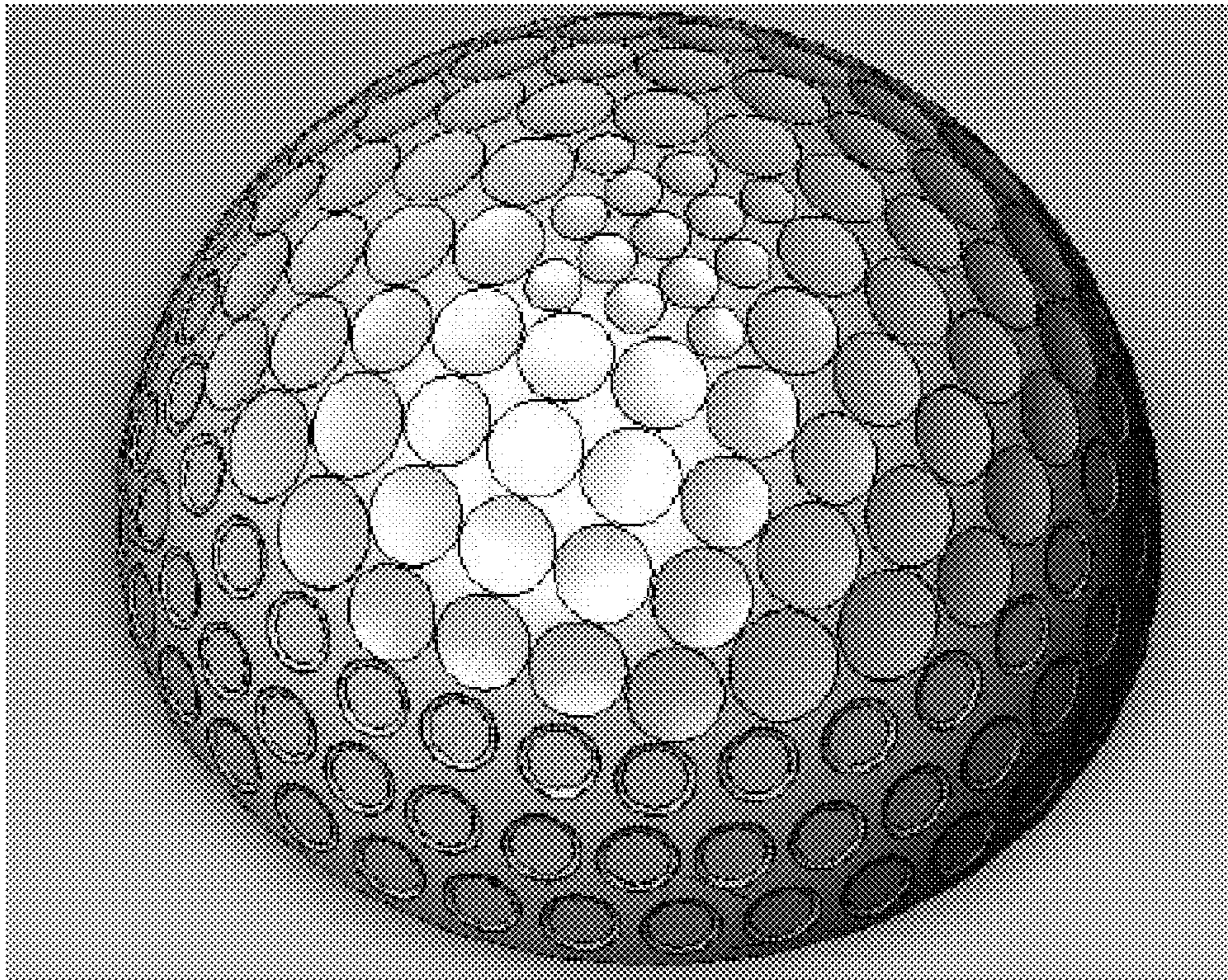
