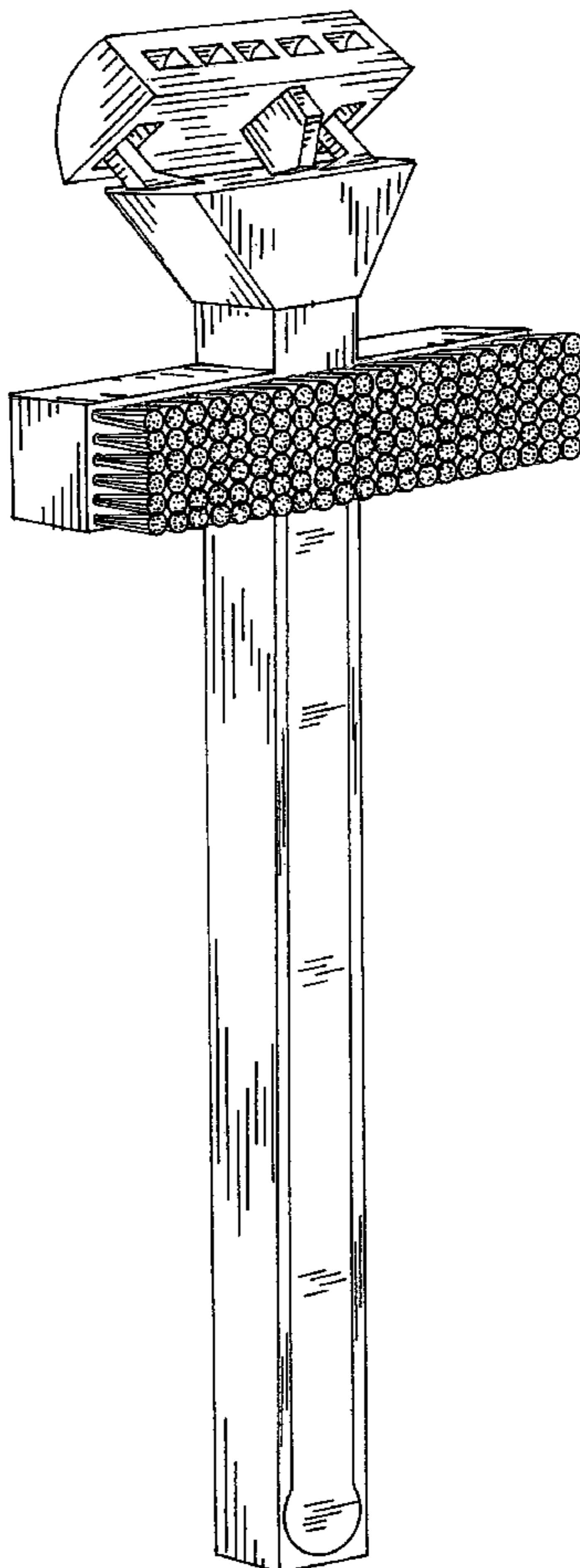
FIG. 1: Top right perspective view;

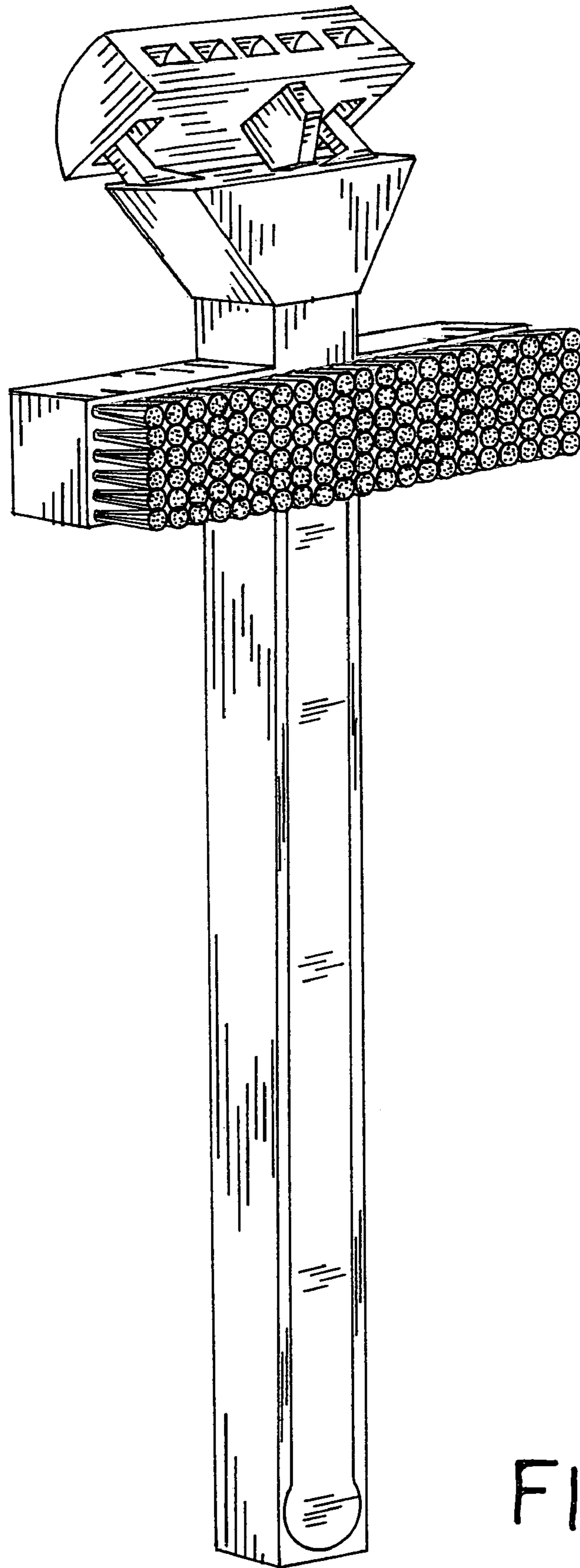

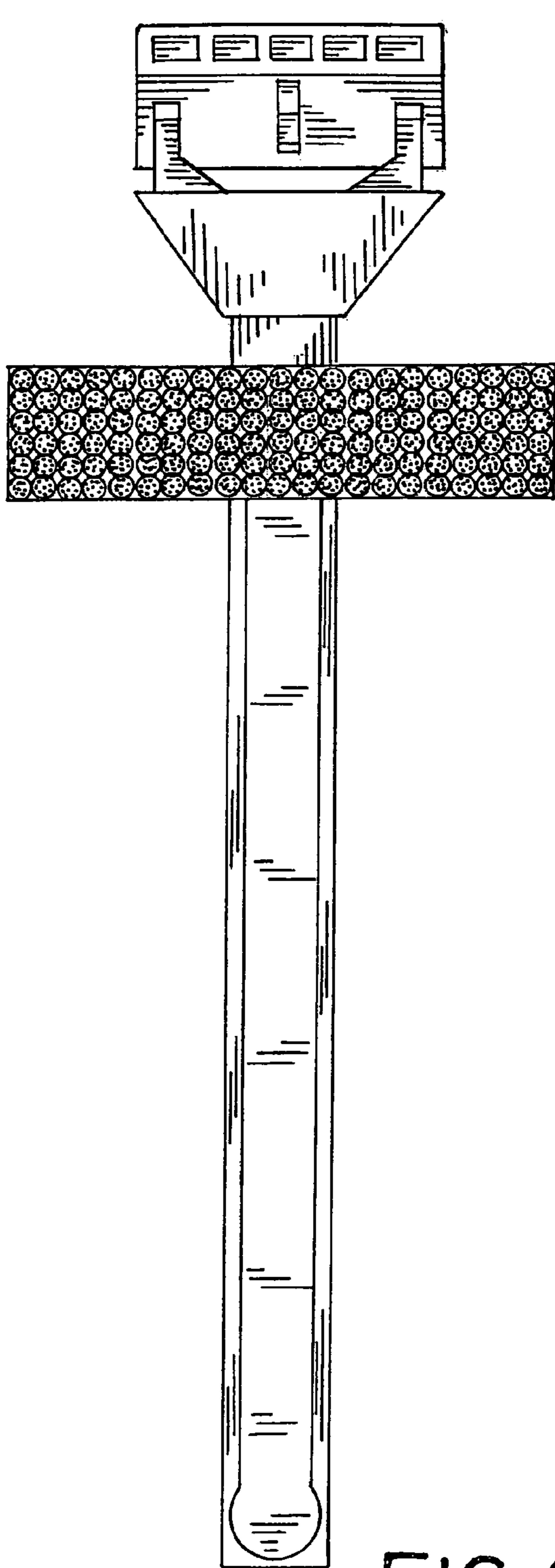

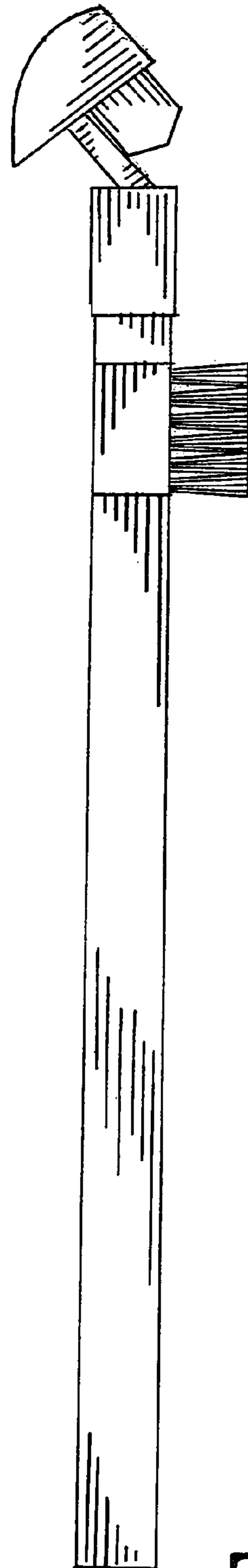
