FIG. 5 illustrates a front view of men's underpants applicable to the designs shown in FIGS. 1 to 4;

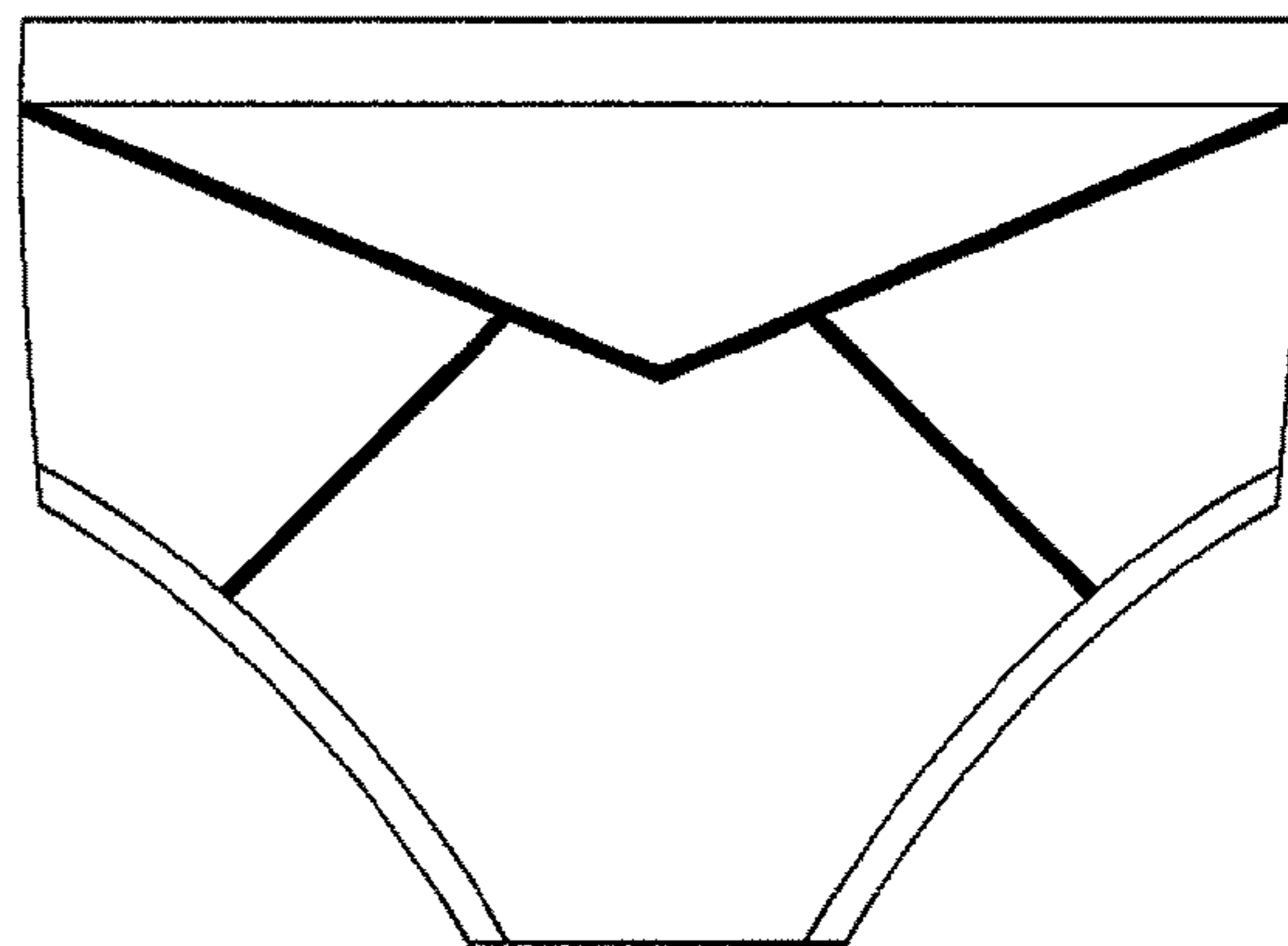
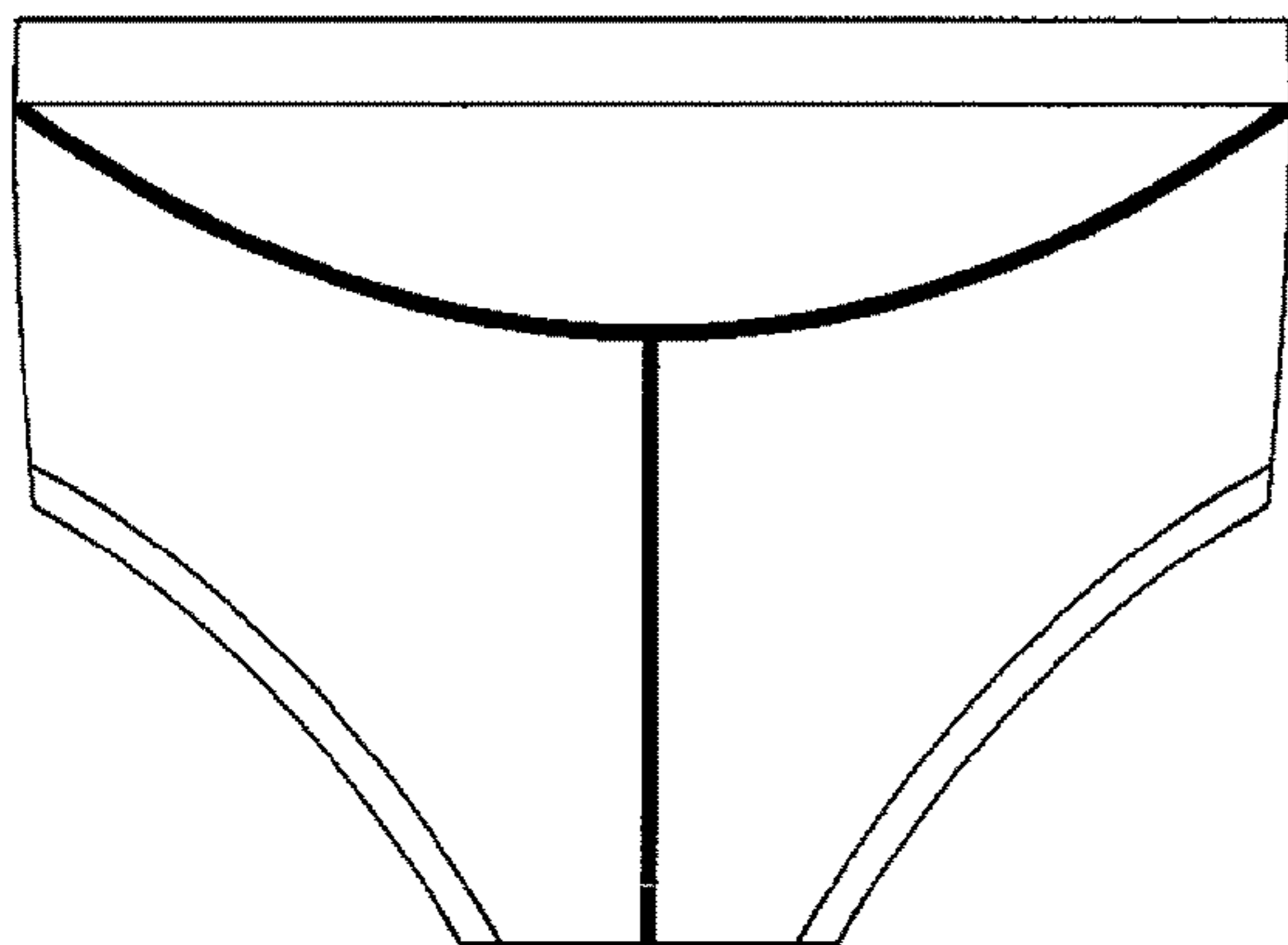
FIG. 6 illustrates a right side view of men's underpants applicable to the designs shown in FIGS. 1 to 4;

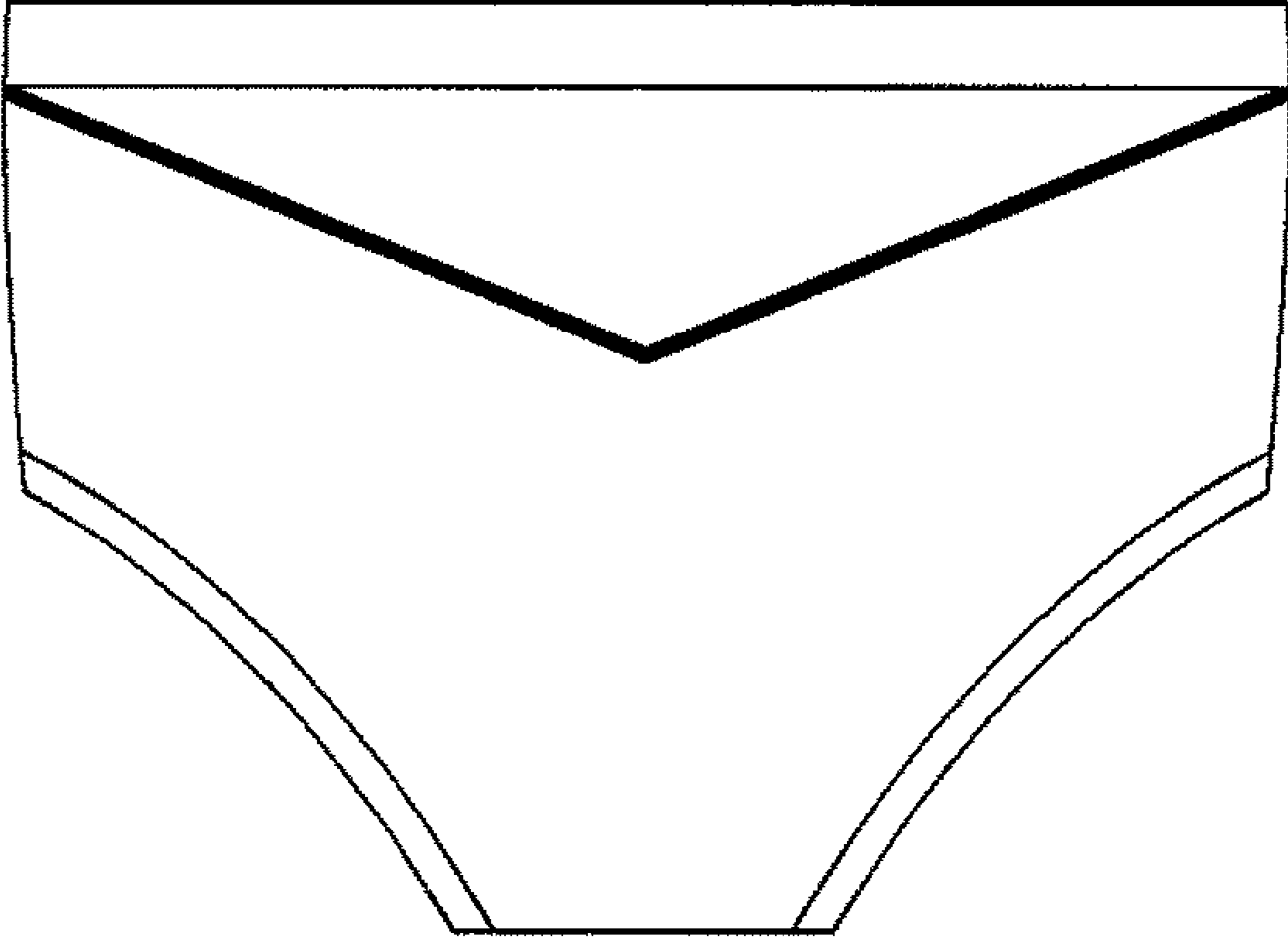

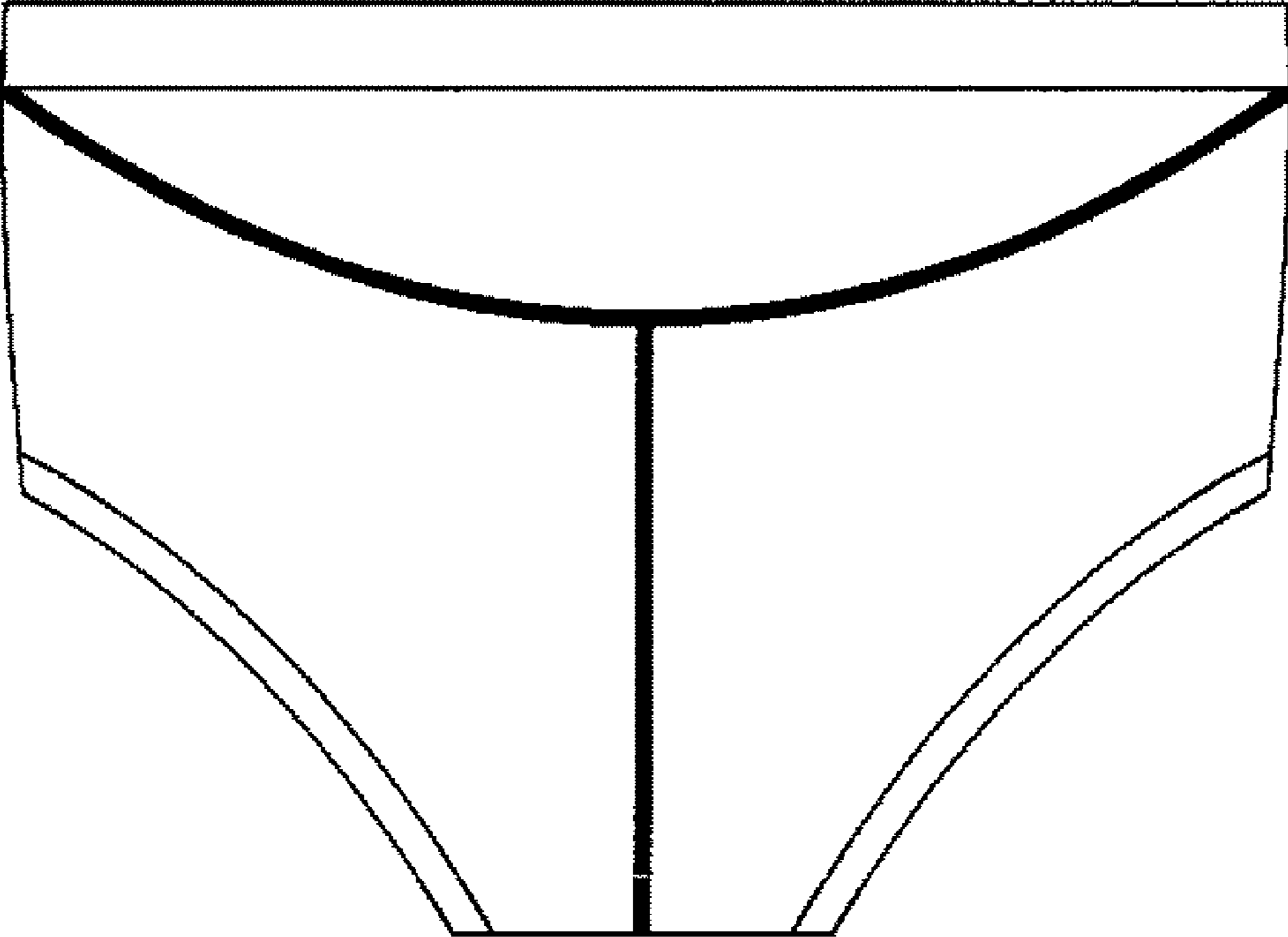

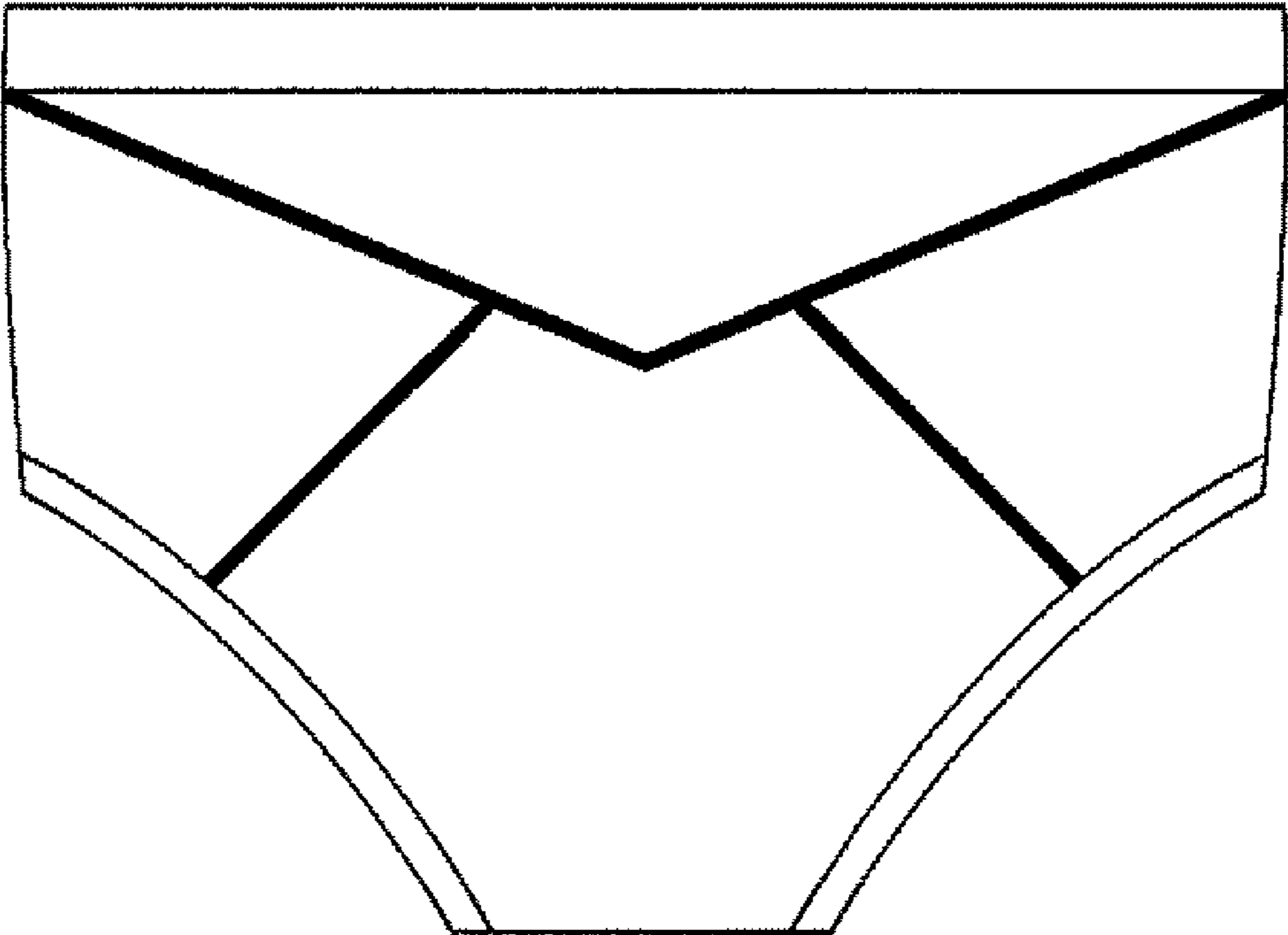
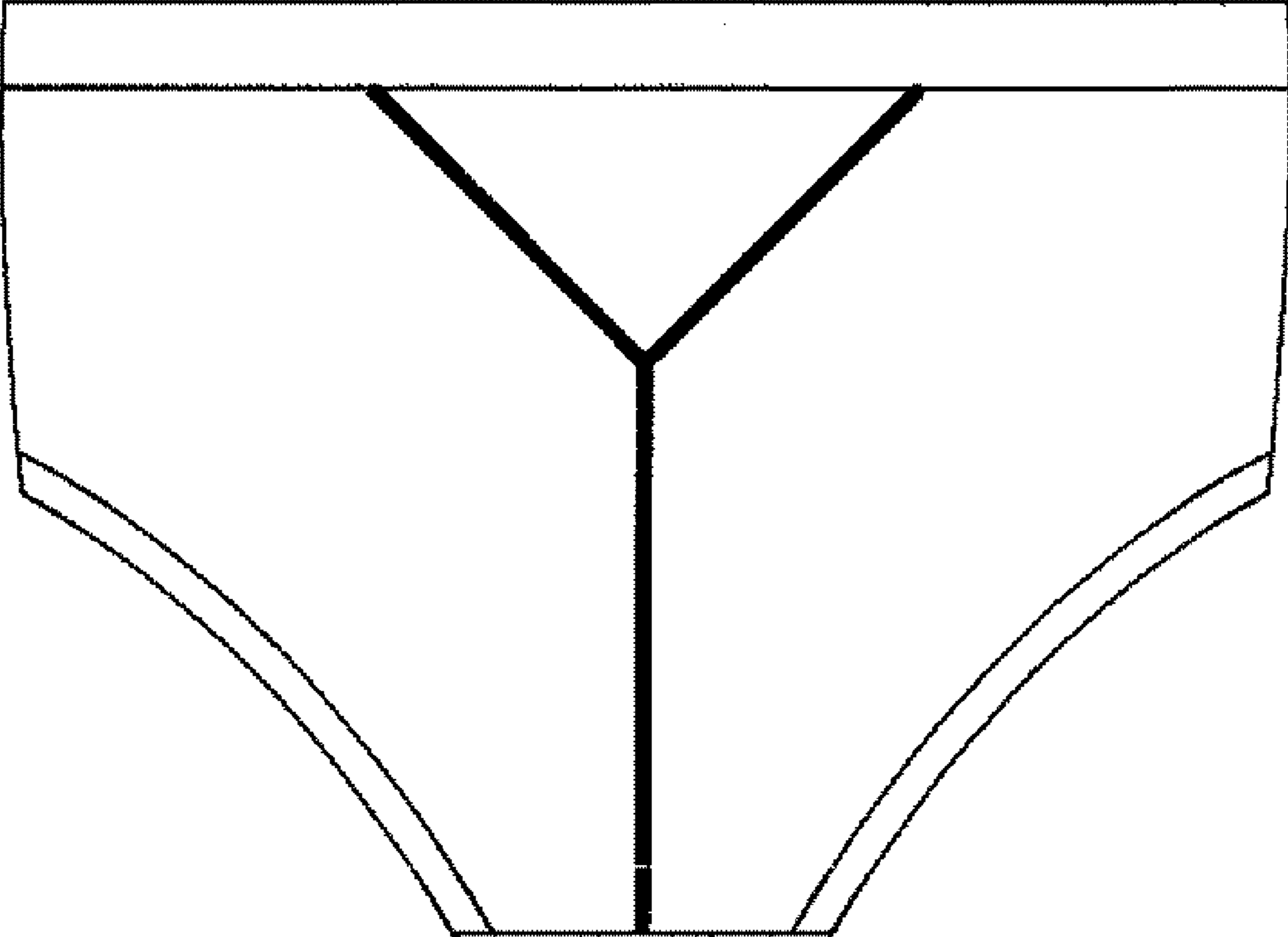

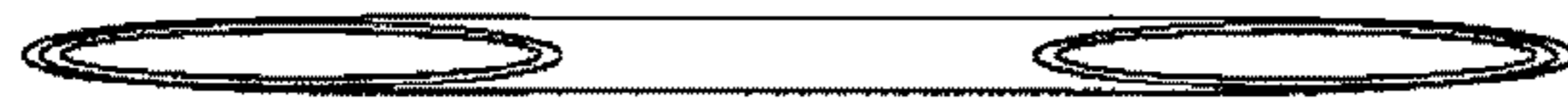

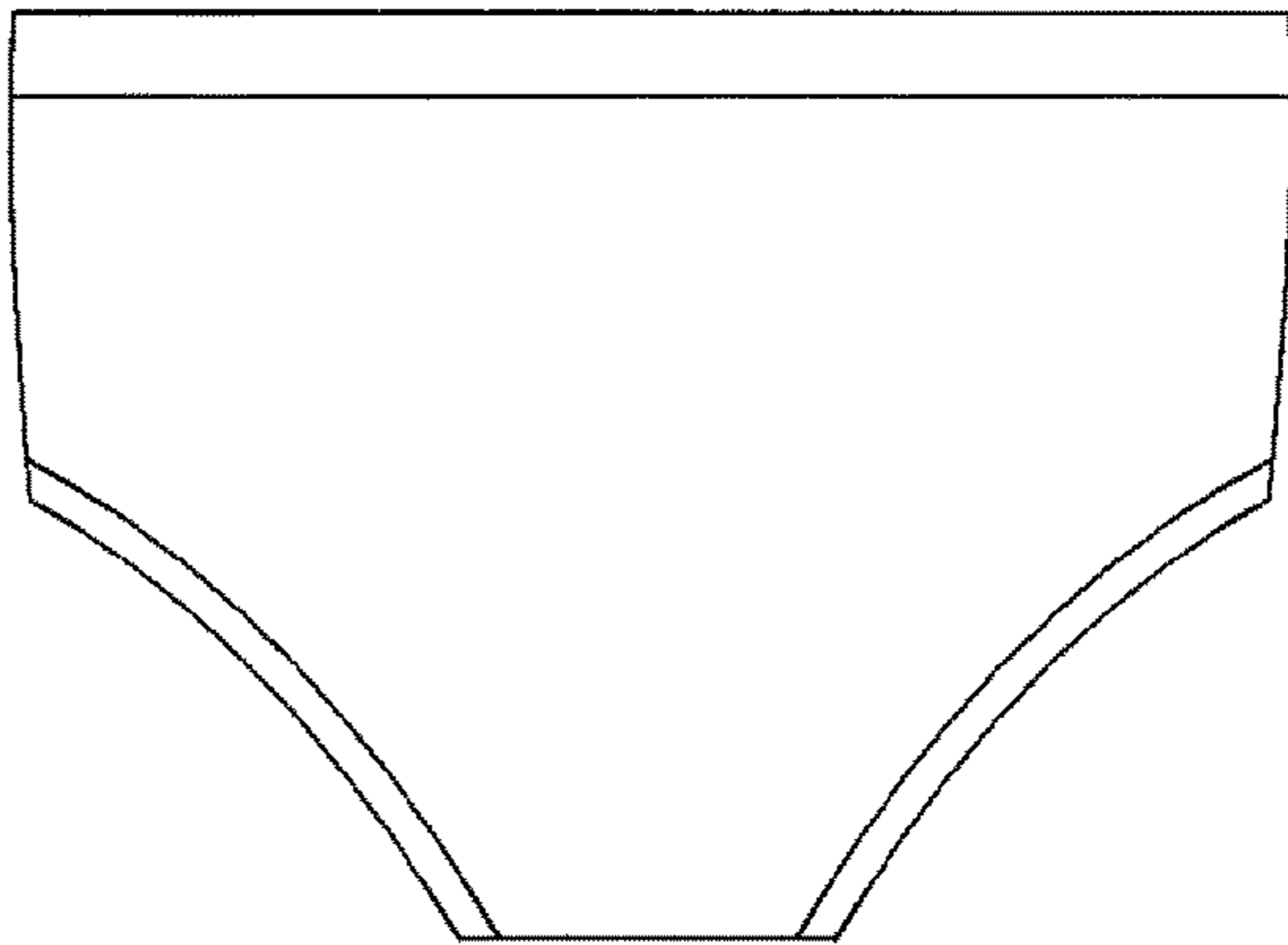
