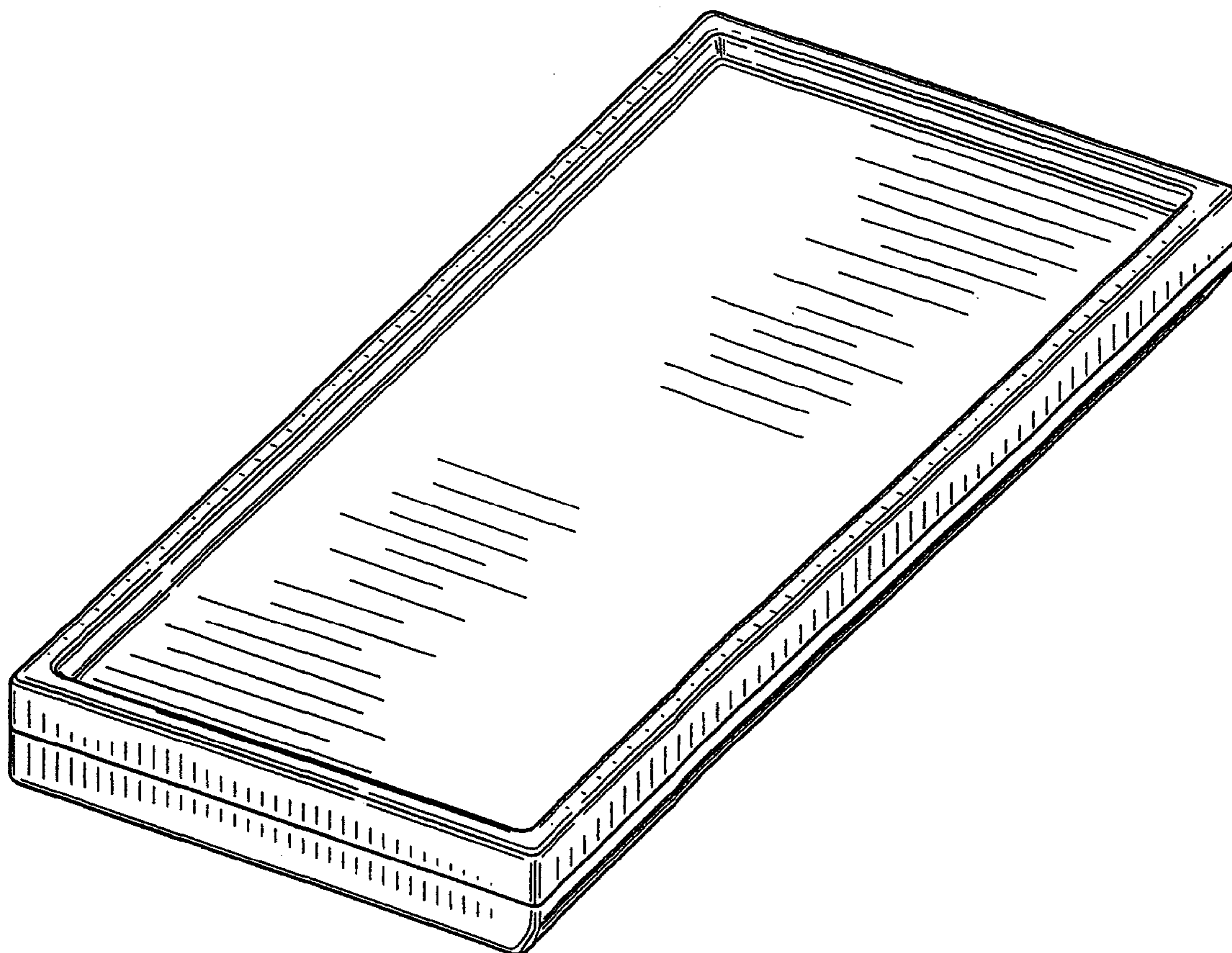

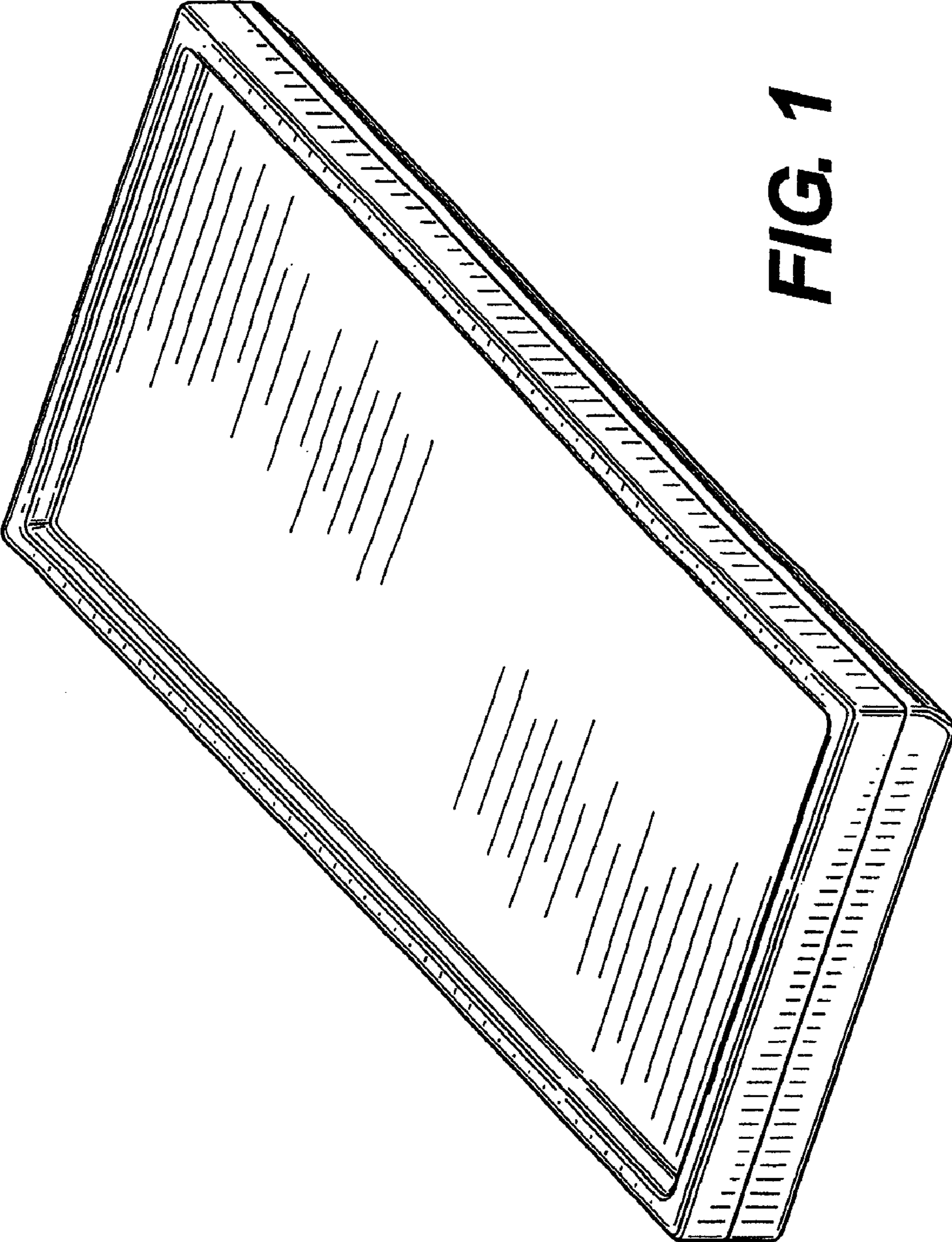
The ornamental design for a bed unit, as shown and described.

**DESCRIPTION**

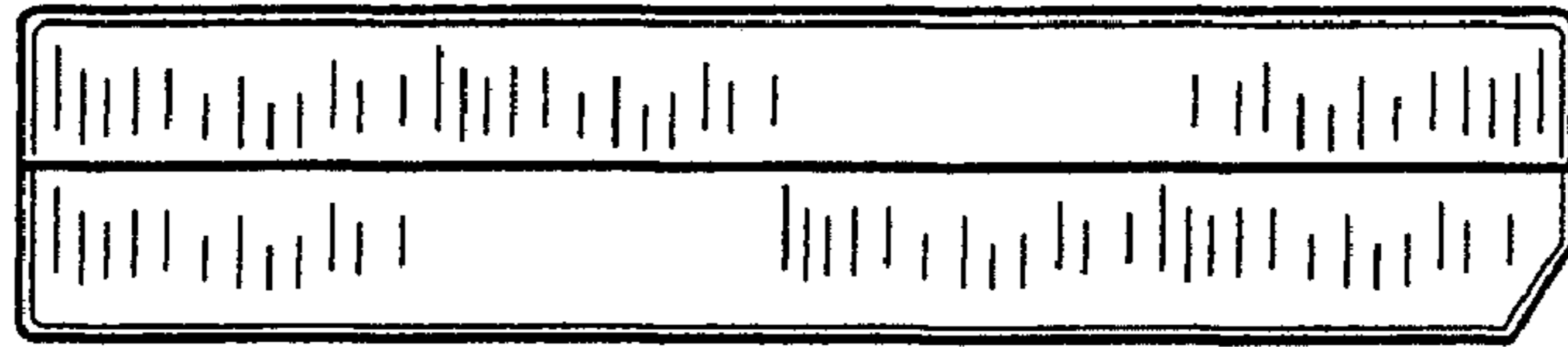
FIG. 1 is a front top perspective view of the bed unit;

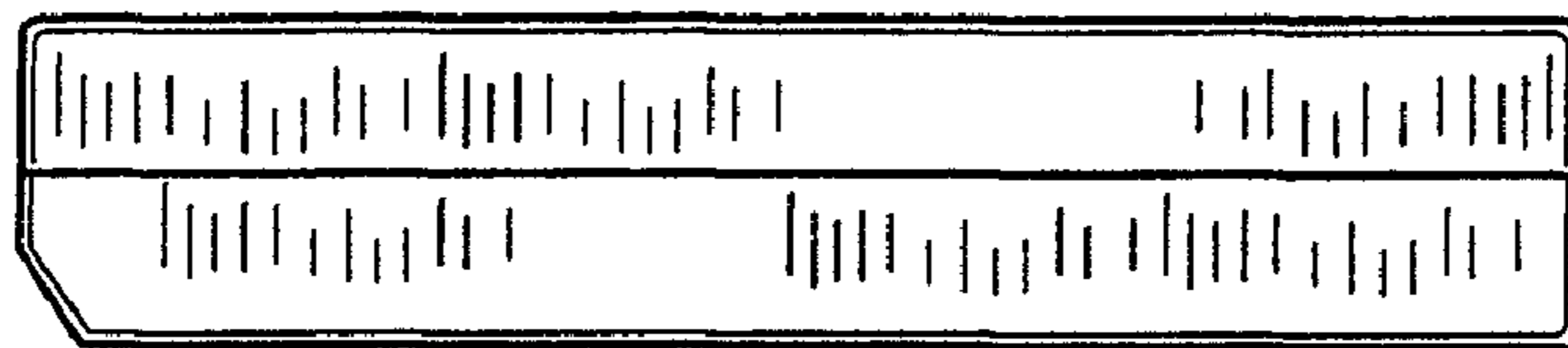




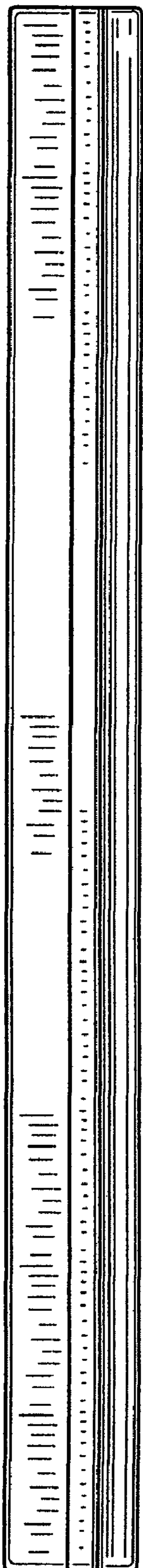

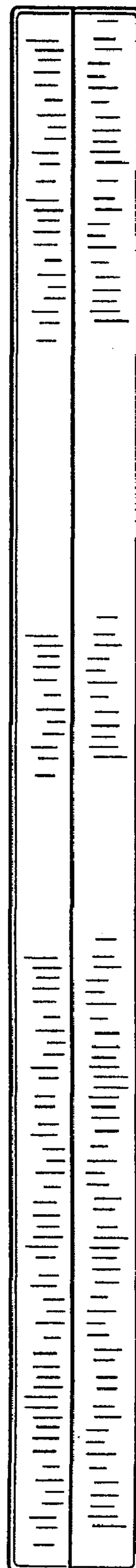

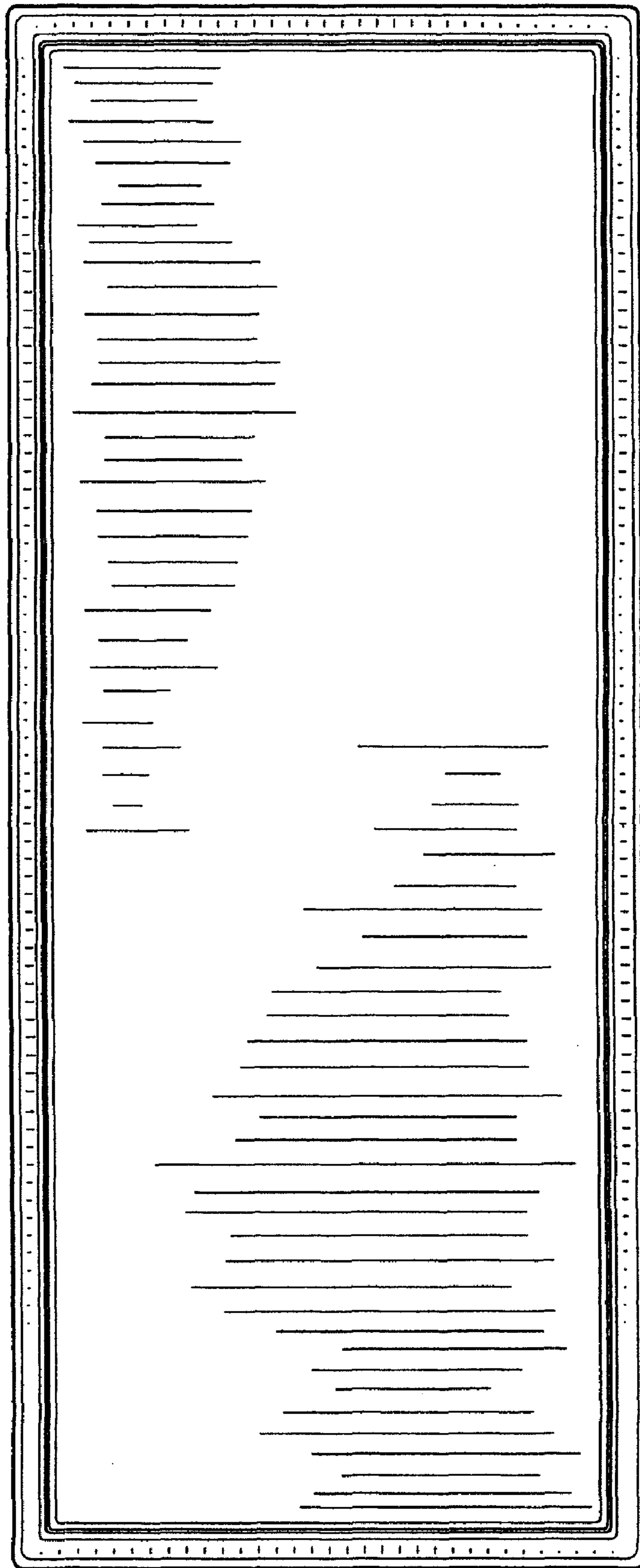

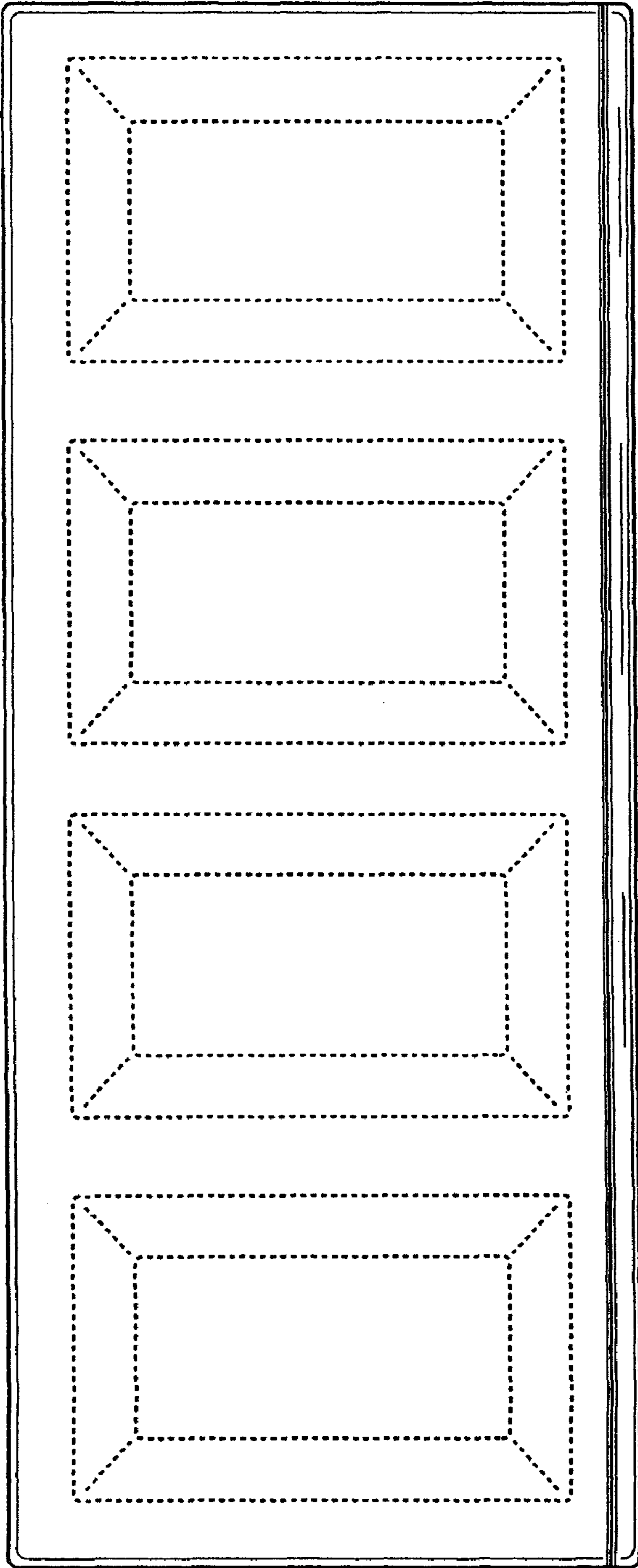
