**DESCRIPTION**

FIG. 5 is an isometric view of another embodiment of the new glassware design showing the entire decorative band in phantom;

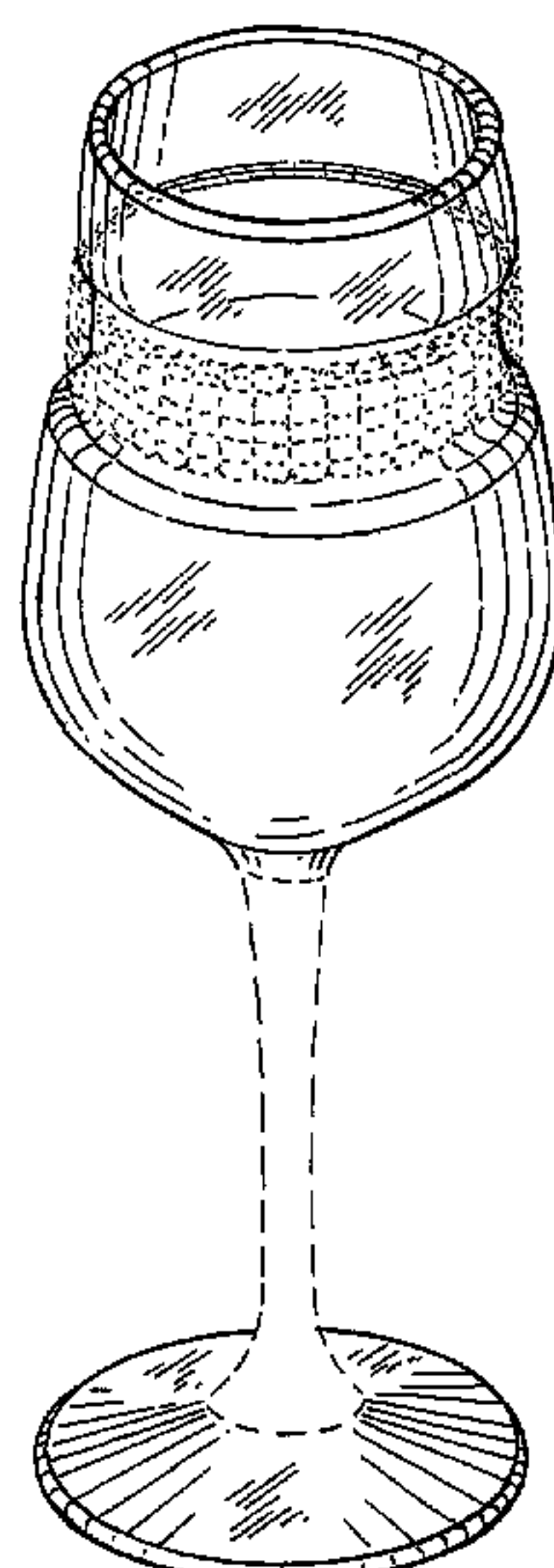
FIG. 6 is a front elevational view of FIG. 5;

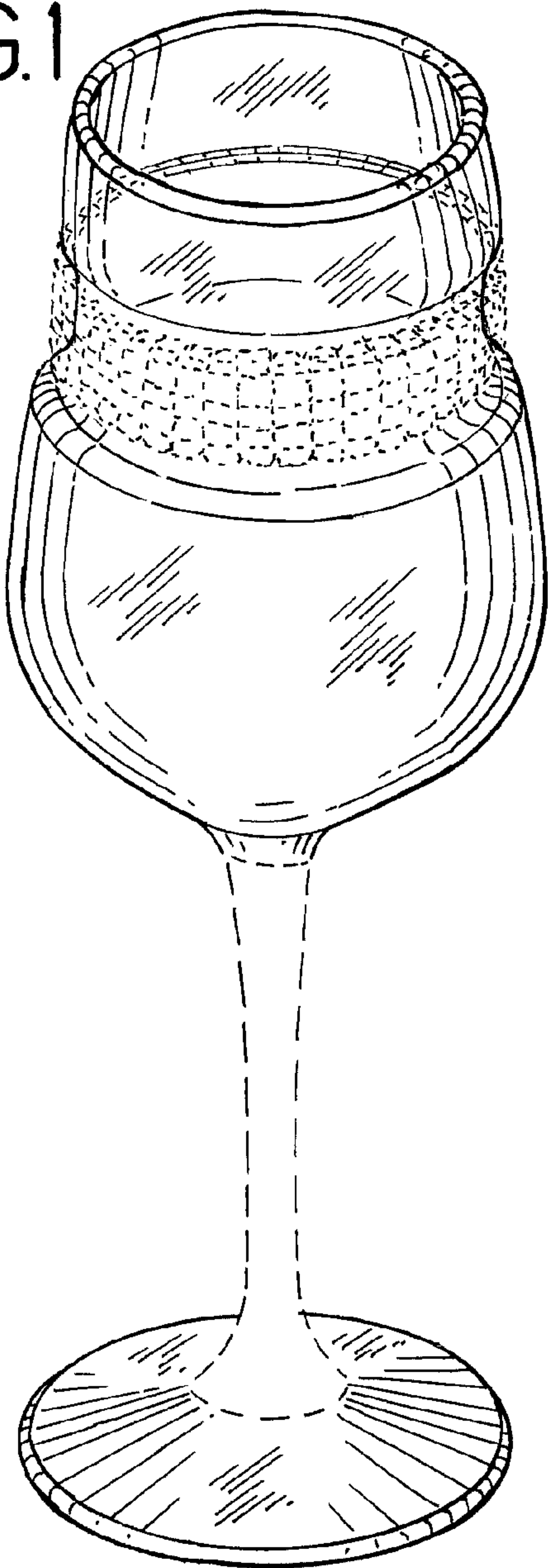

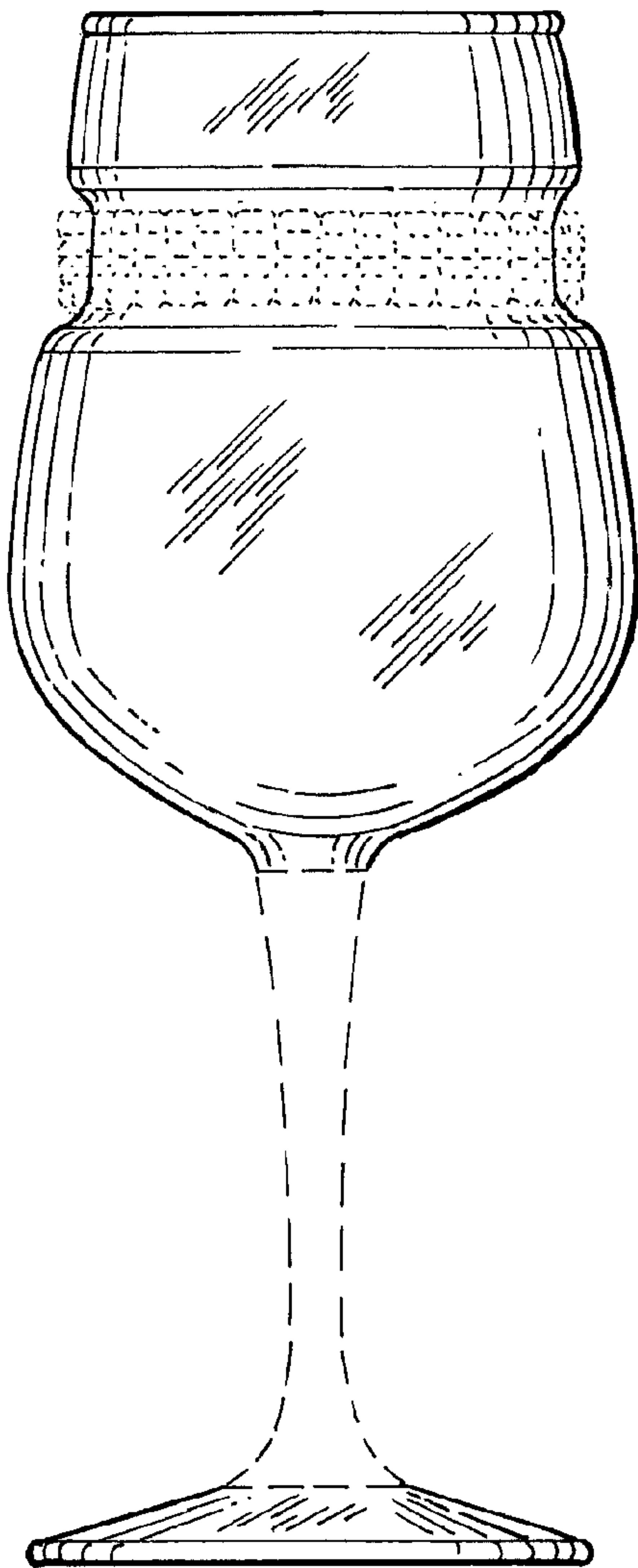

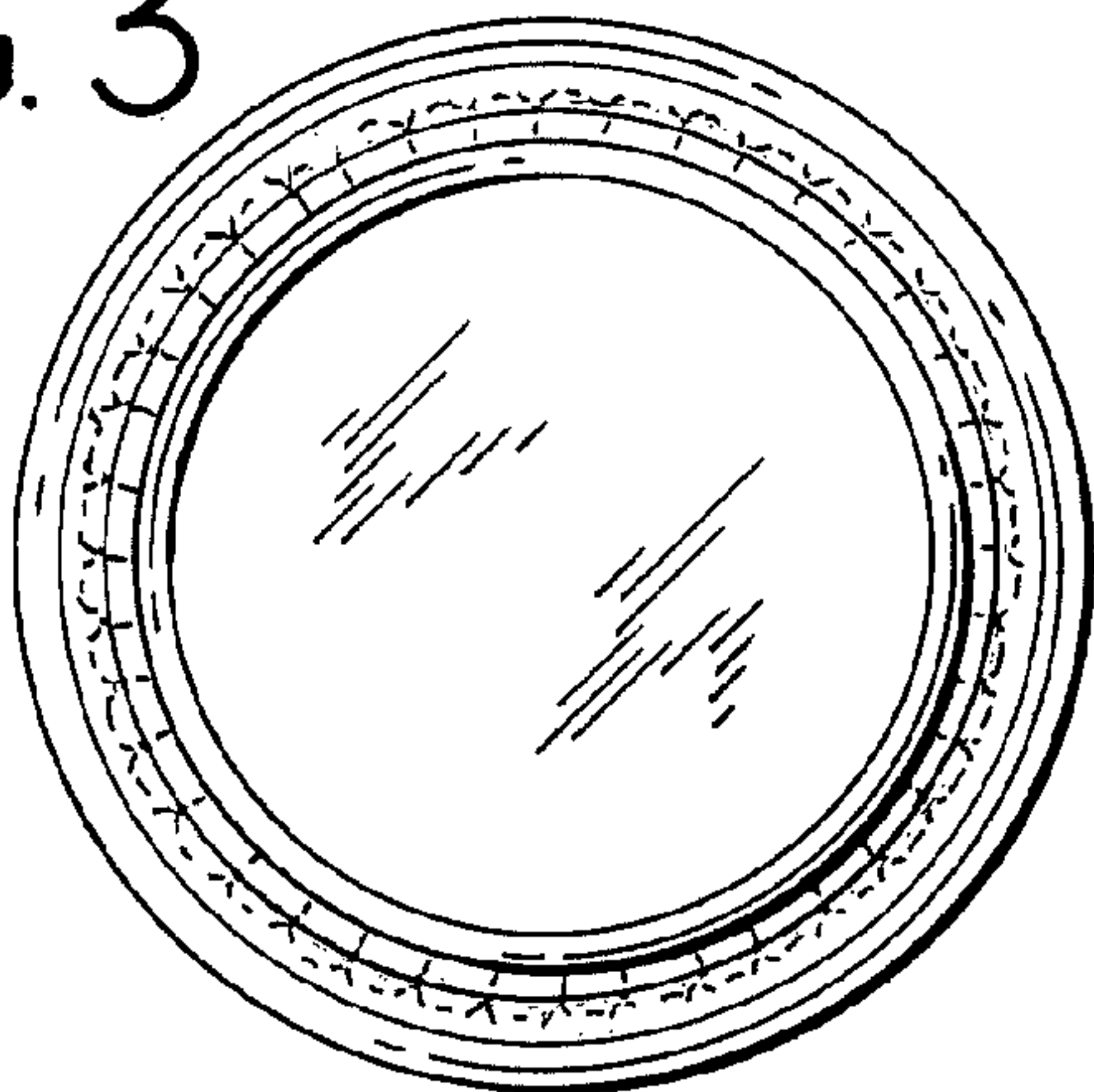

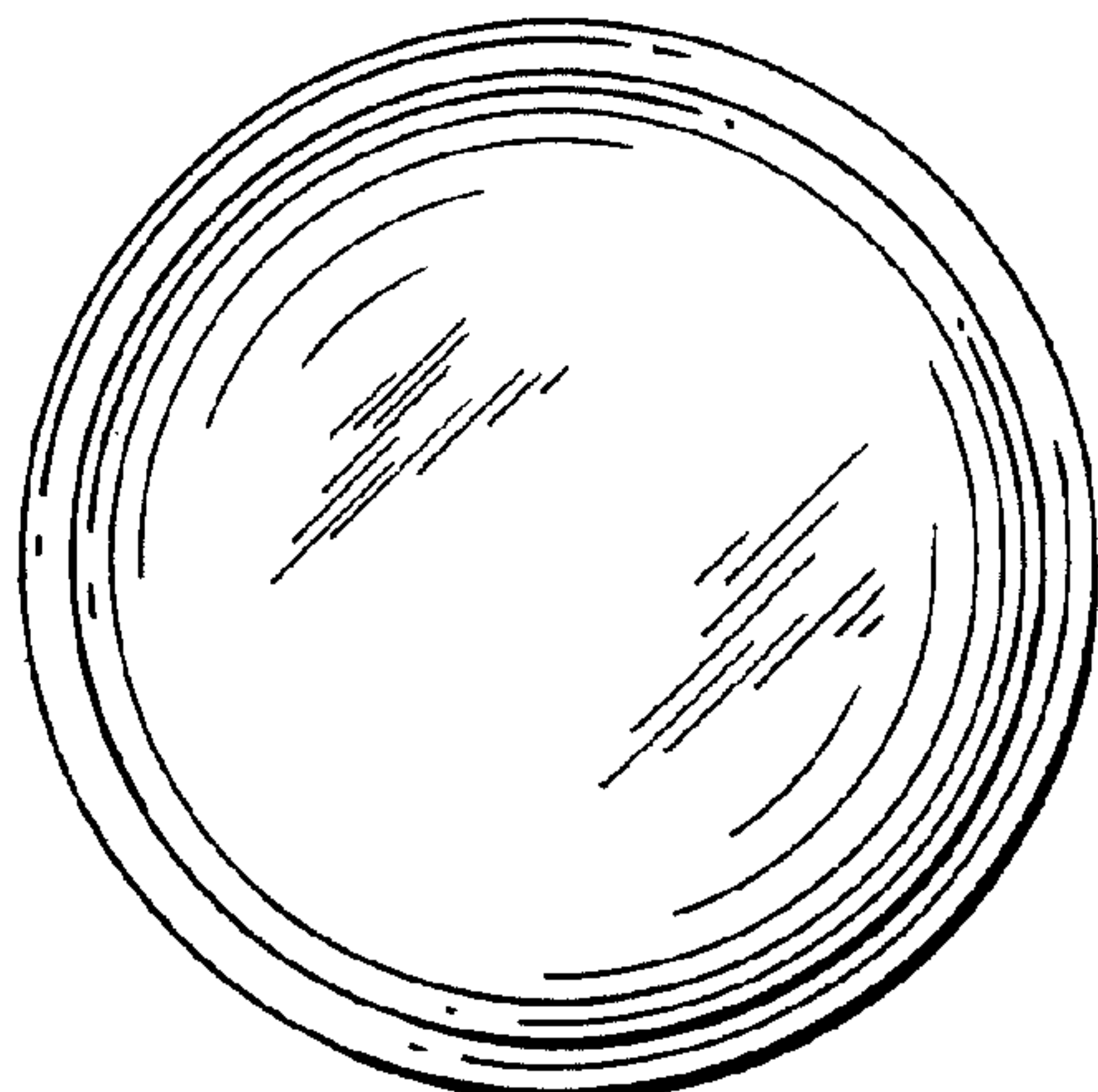

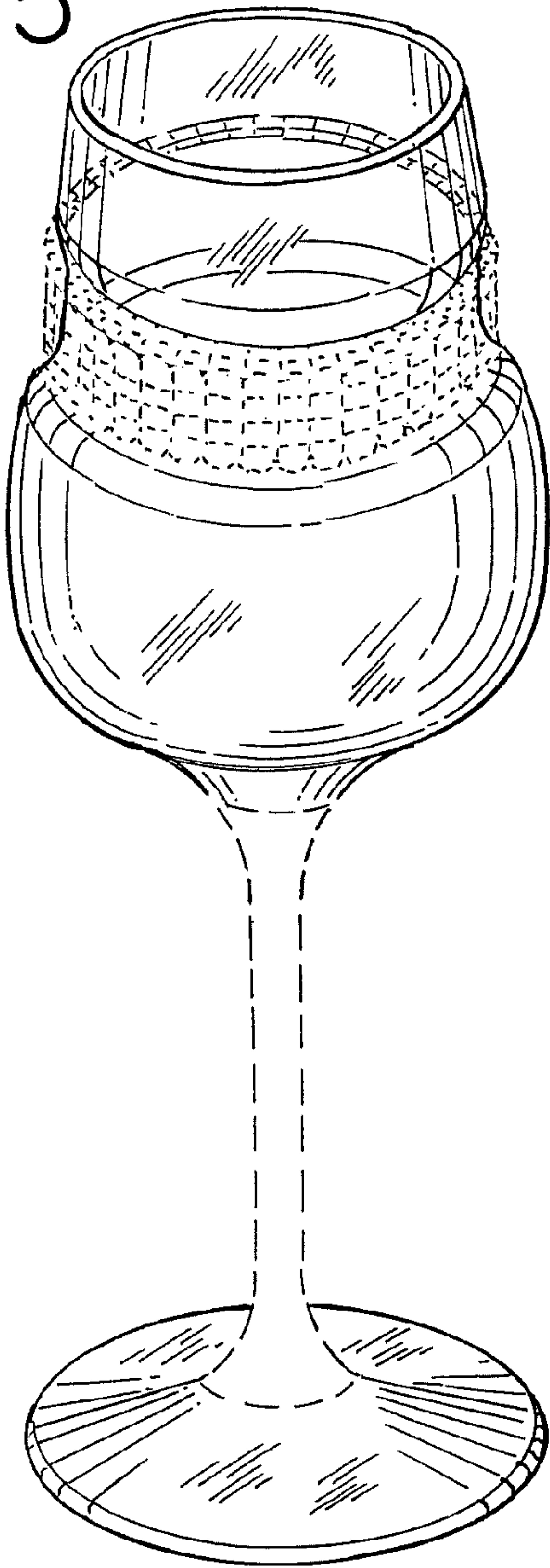

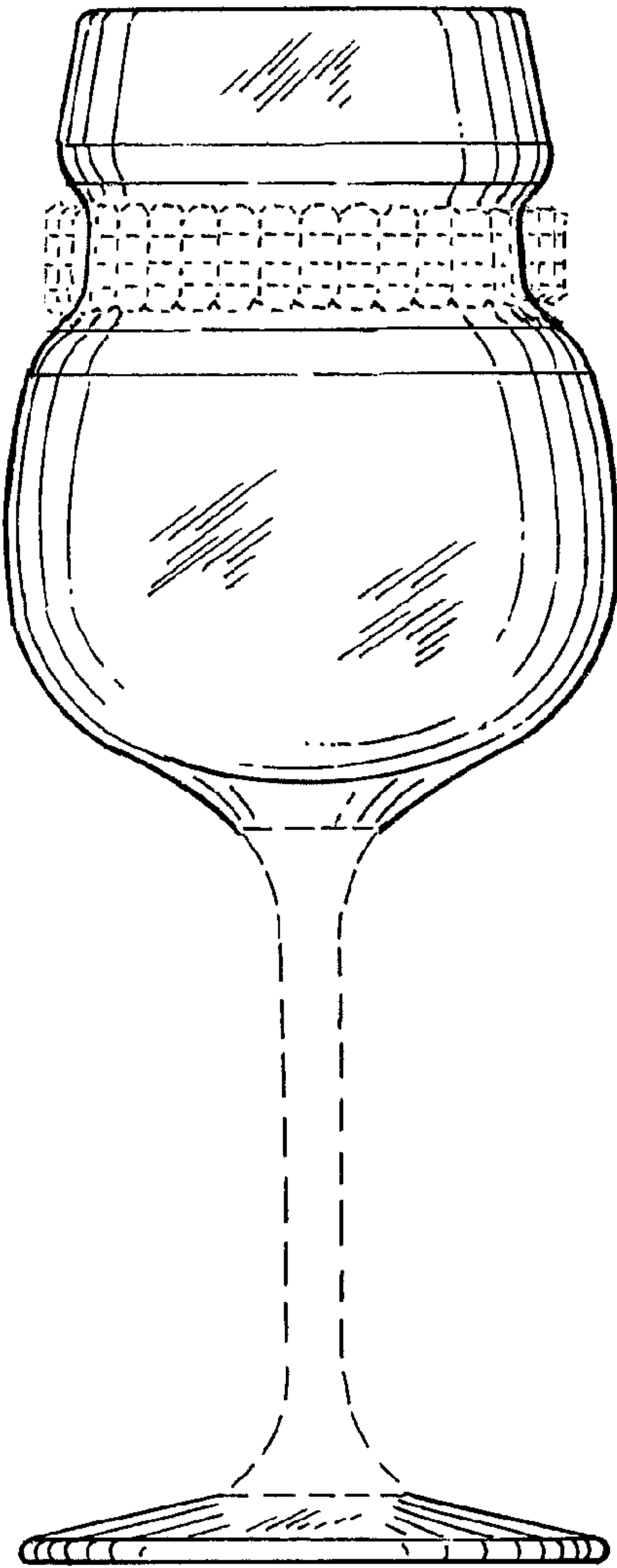

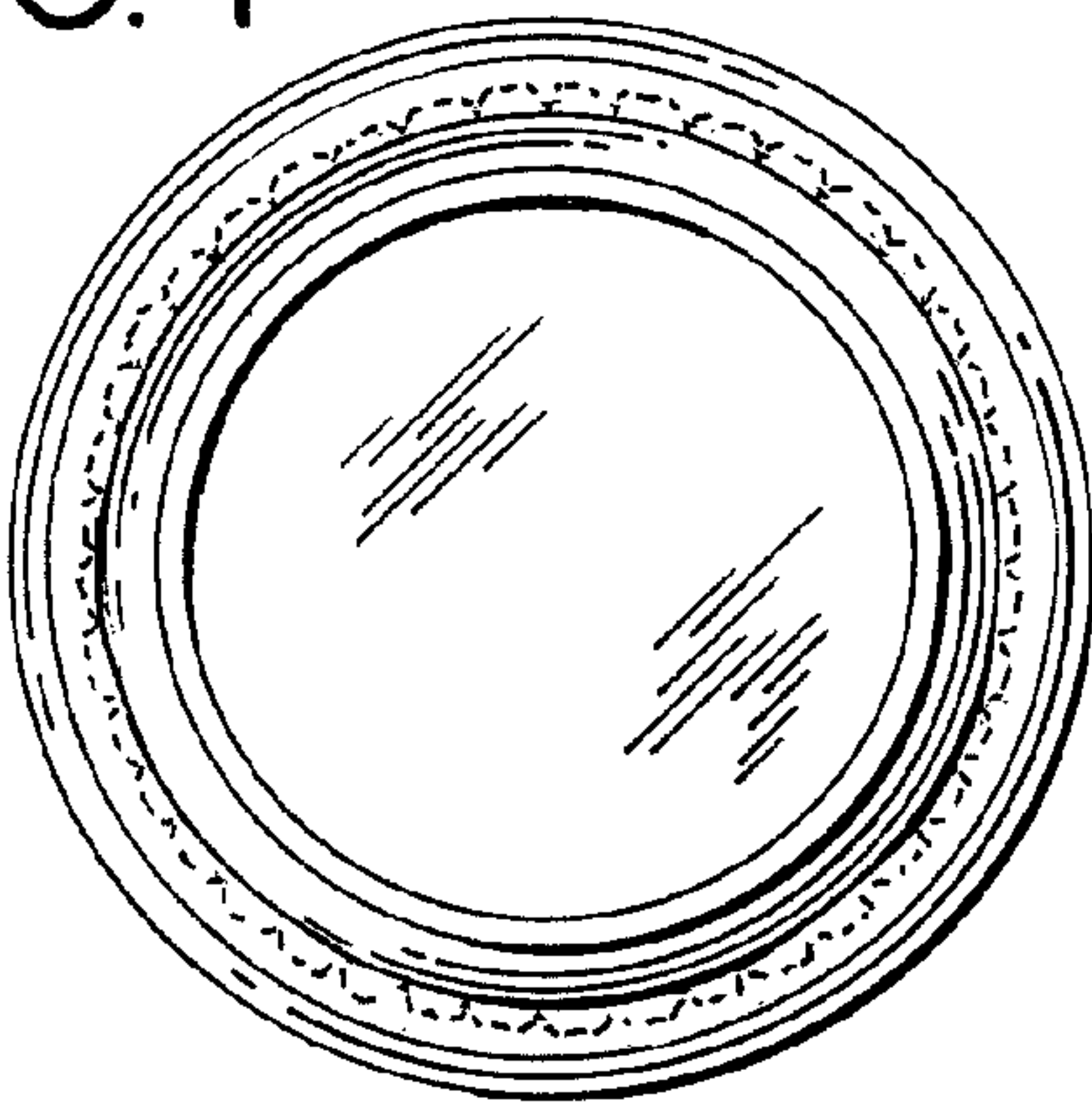
