DESCRIPTION

FIG. 1 is a top plan view of a bottle blade showing our new design;
 FIG. 2 is a bottom plan view thereof;
 FIG. 3 is a side elevation view thereof;
 FIG. 4 is an opposite side elevation view thereof;
 FIG. 5 is a top perspective view thereof; and,

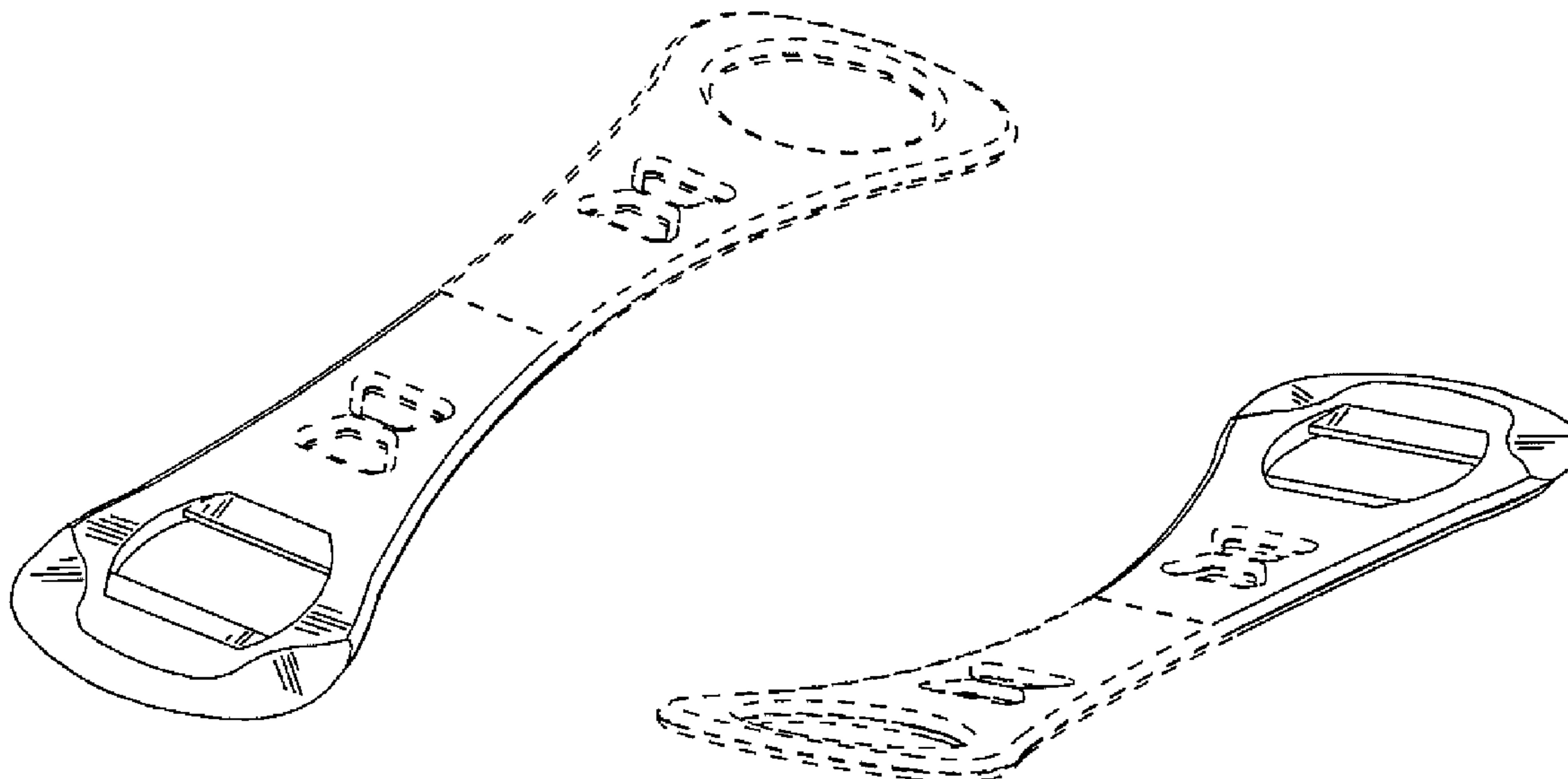

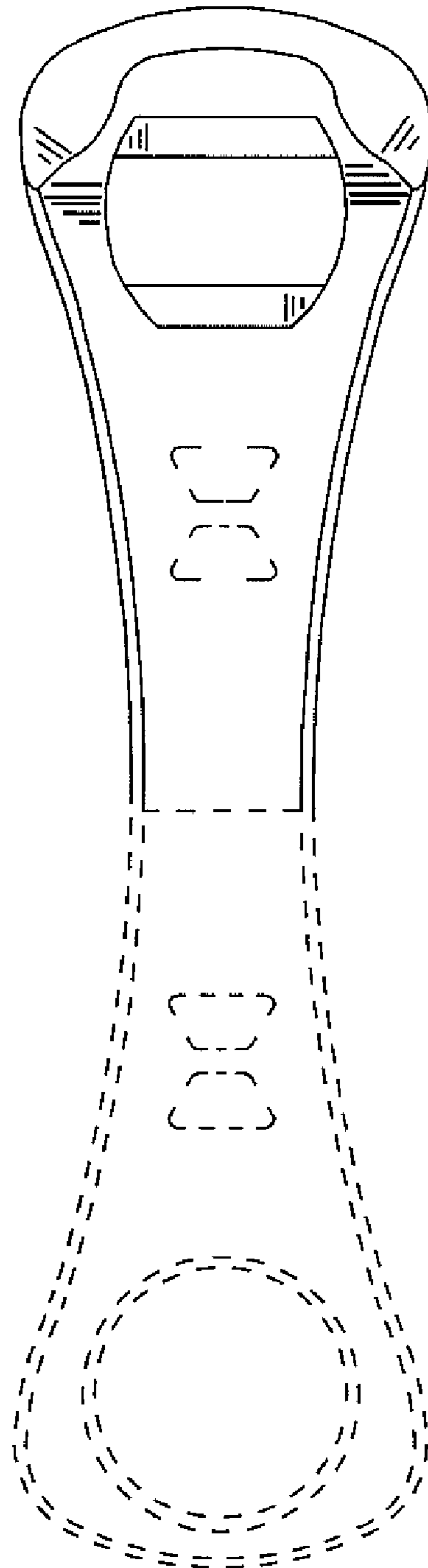

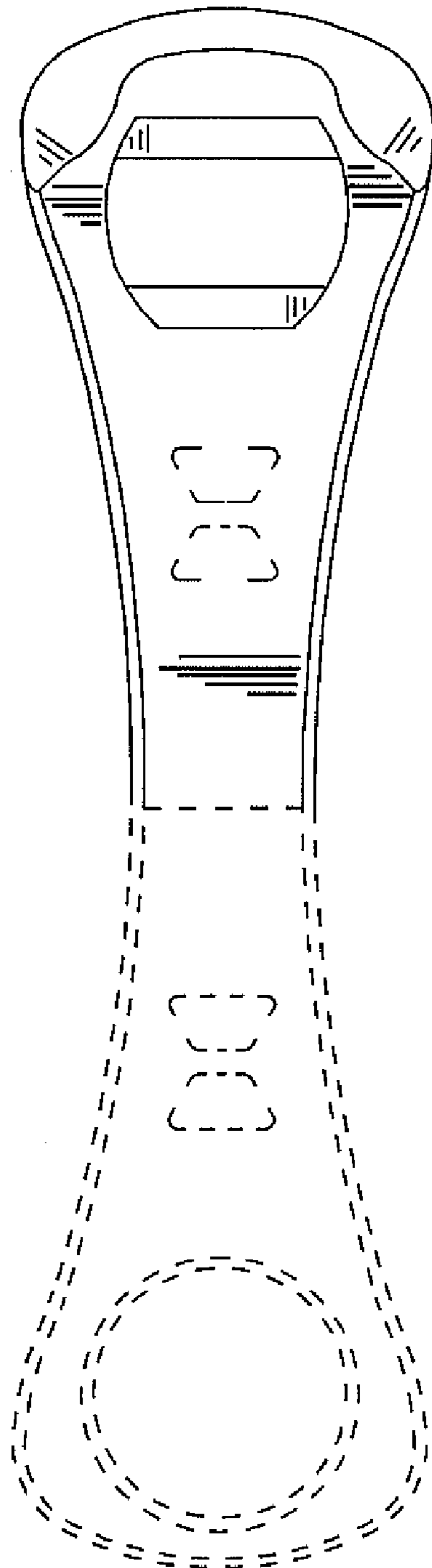

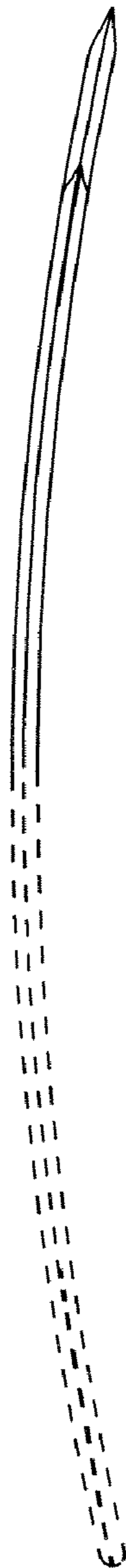

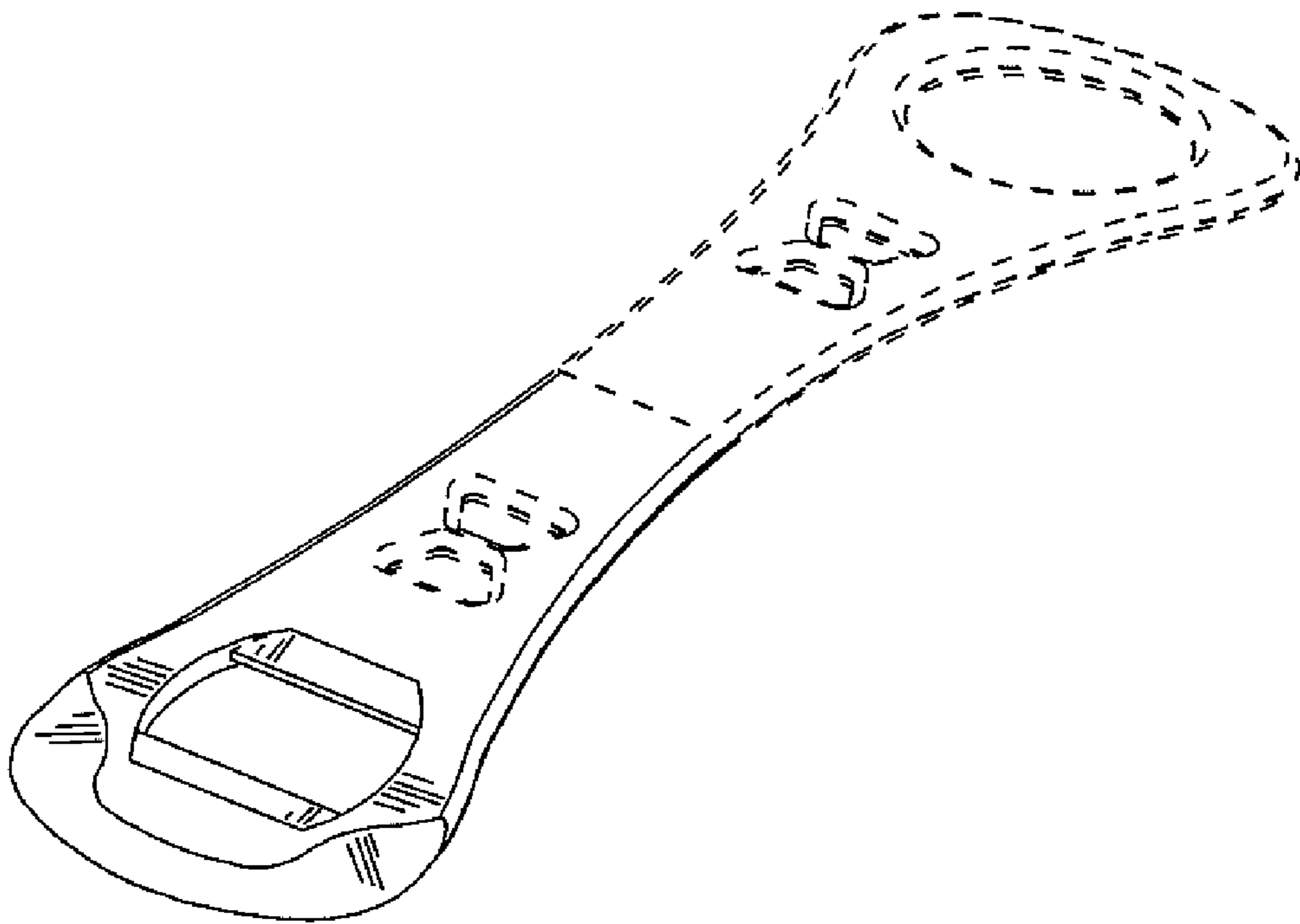
