**DESCRIPTION**

FIG. 1 is a front view of a scissors showing my new design;  
 FIG. 2 is a rear view thereof;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is a left side view thereof;  
 FIG. 6 is a right side view thereof;  
 FIG. 7 is an end view of the sectioned part taken along the  
 arrowed line A-A thereof;  
 FIG. 8 is an end view of the sectioned part taken along the  
 arrowed line B-B thereof;  
 FIG. 9 is an end view of the sectioned part taken along the  
 arrowed line C-C thereof;  
 FIG. 10 is an end view of the sectioned part taken along the  
 arrowed line D-D thereof;  
 FIG. 11 is an enlarged view of the portion indicated by the  
 lines E-E thereof;  
 FIG. 12 is an enlarged view of the portion indicated by the line  
 F-F thereof; and,  
 FIG. 13 is a front view thereof showing the opened state.

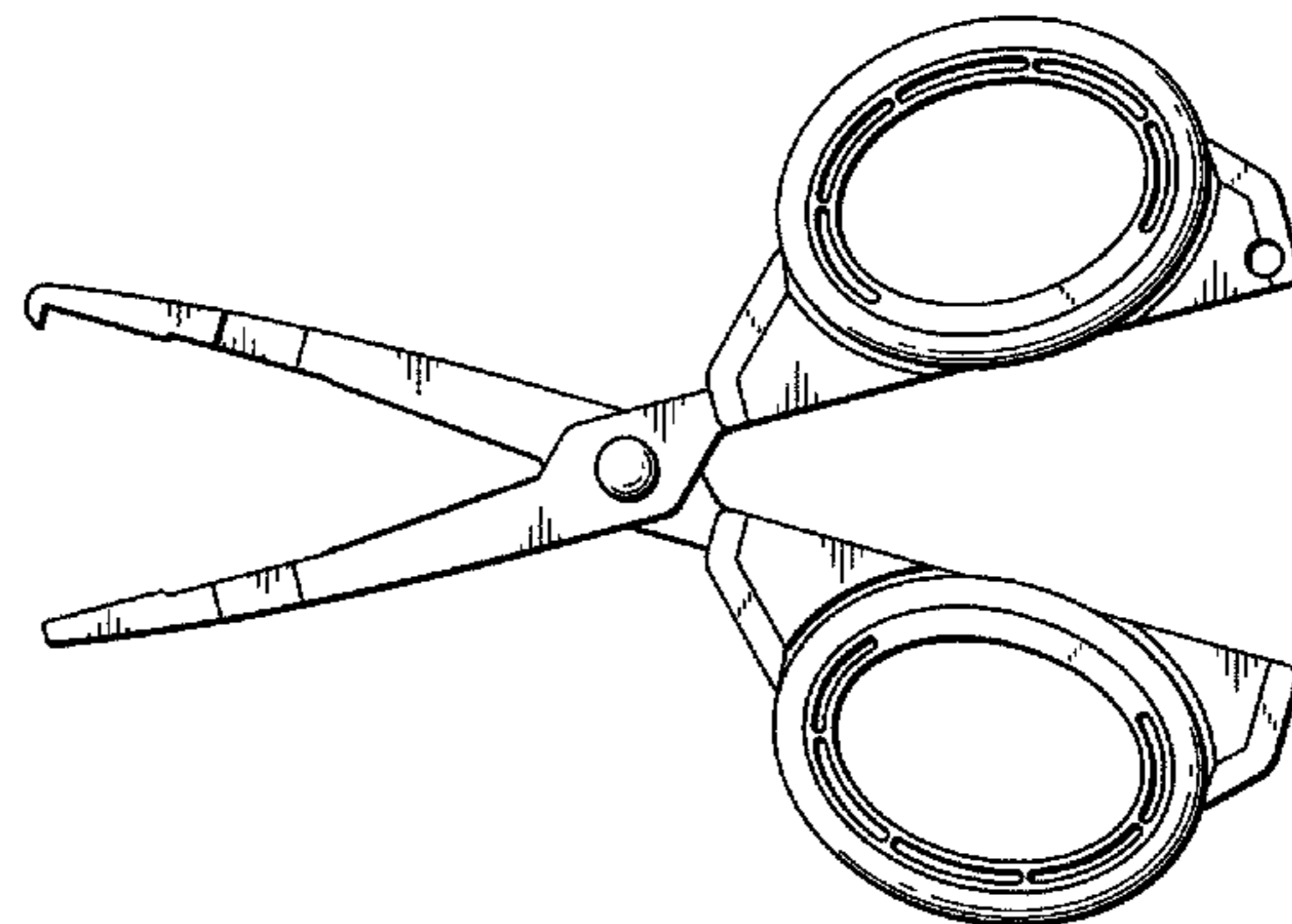
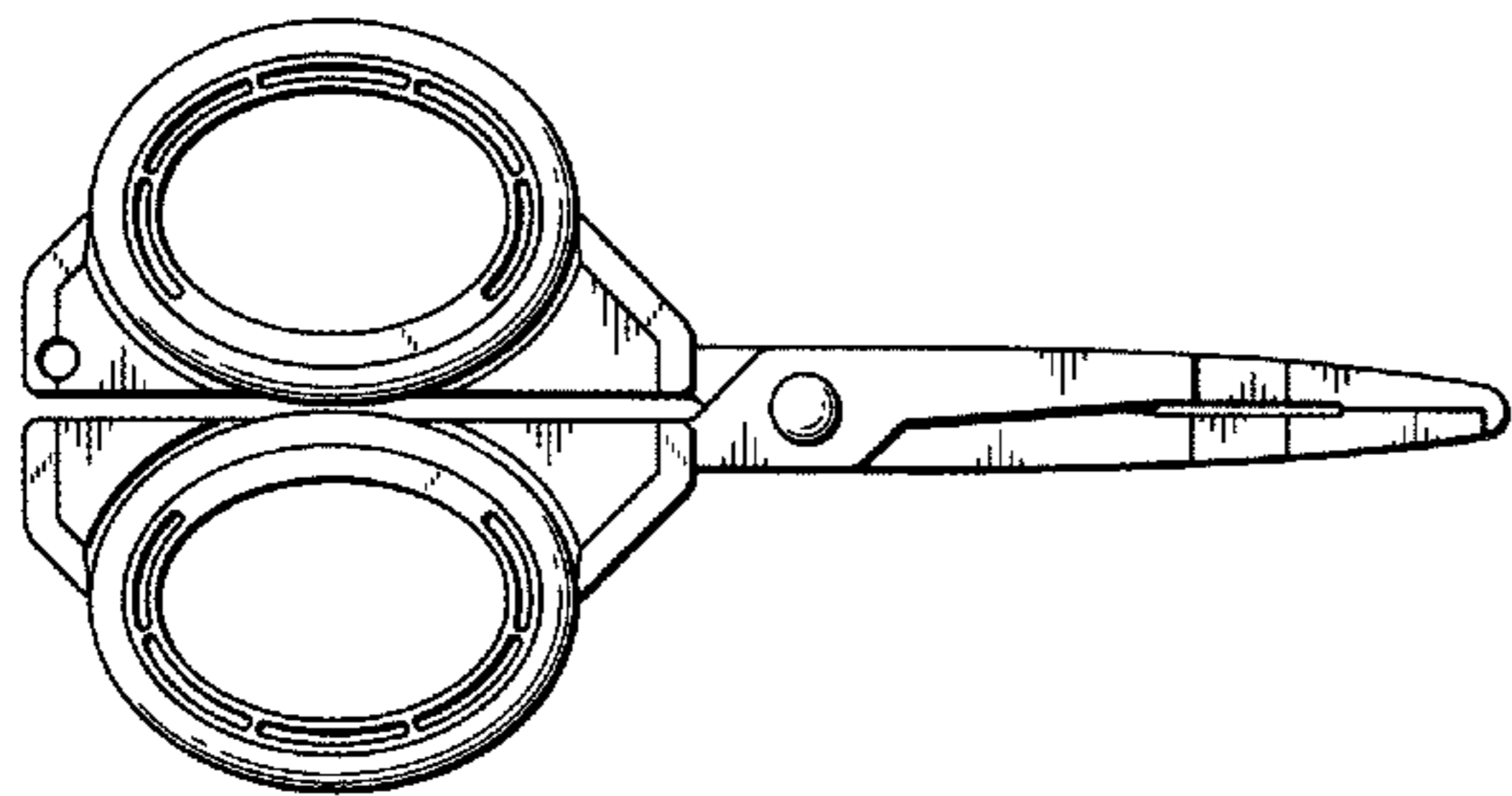

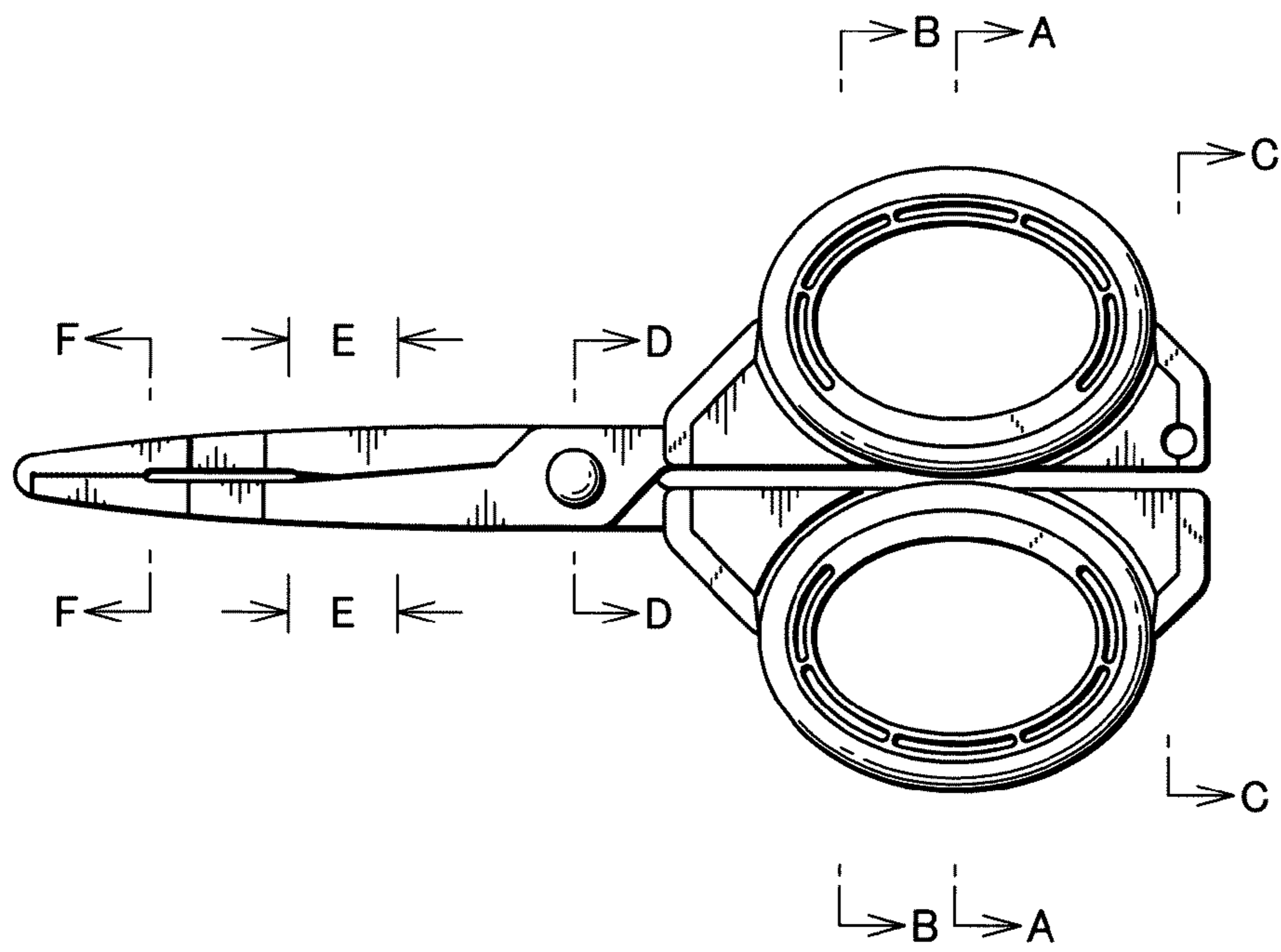

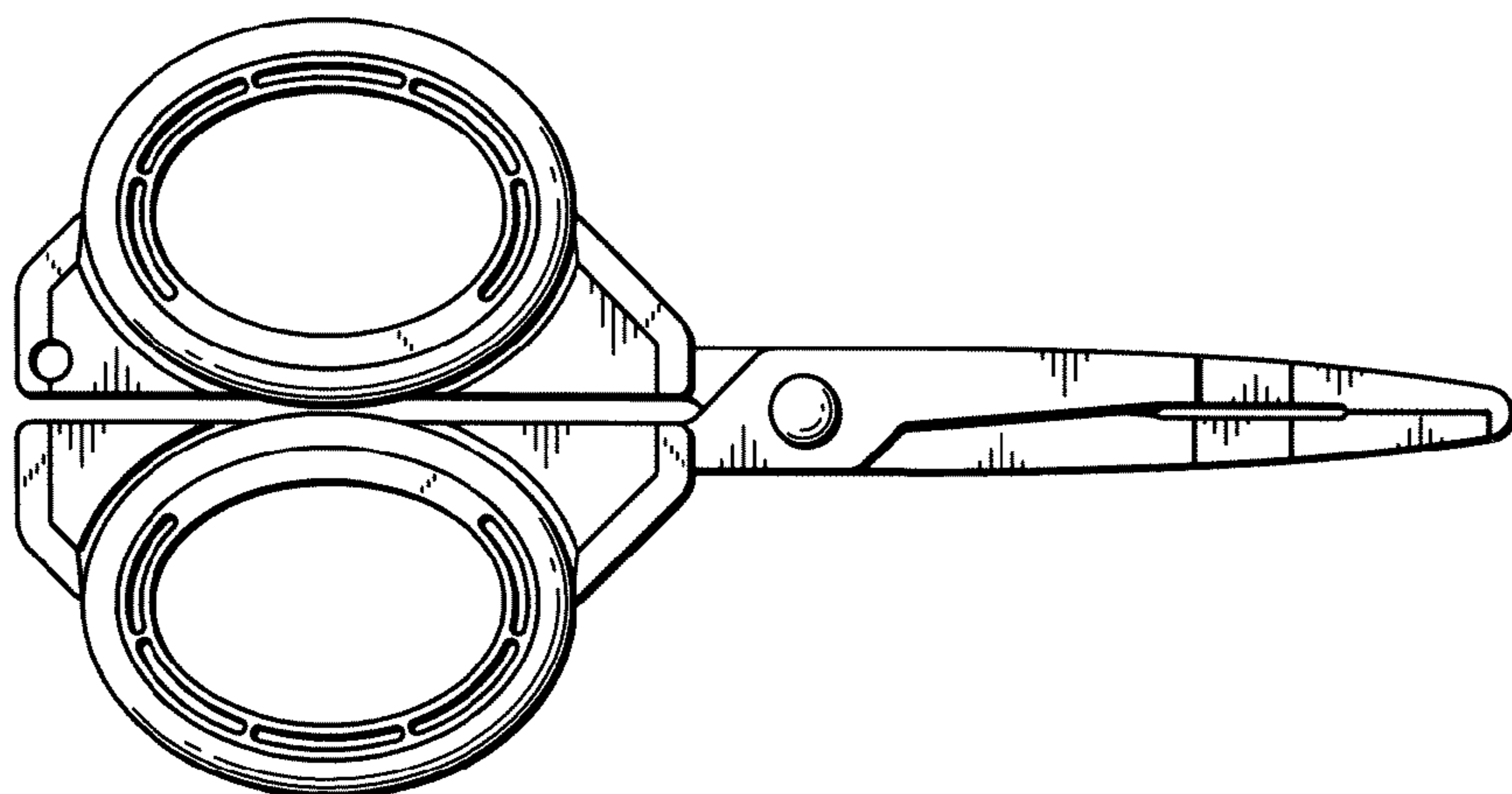

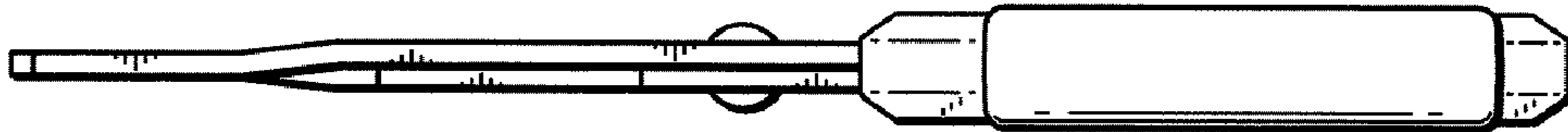

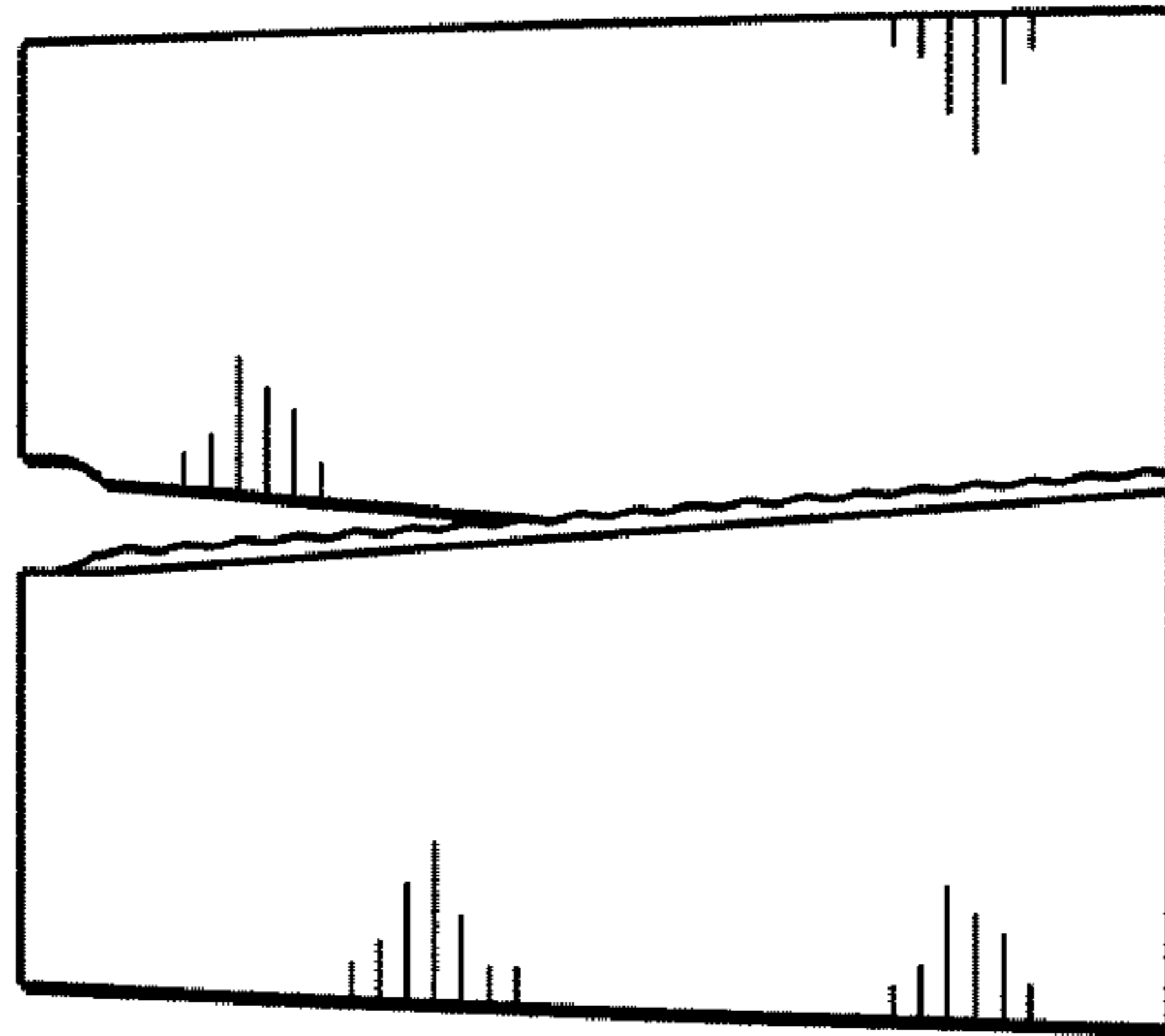

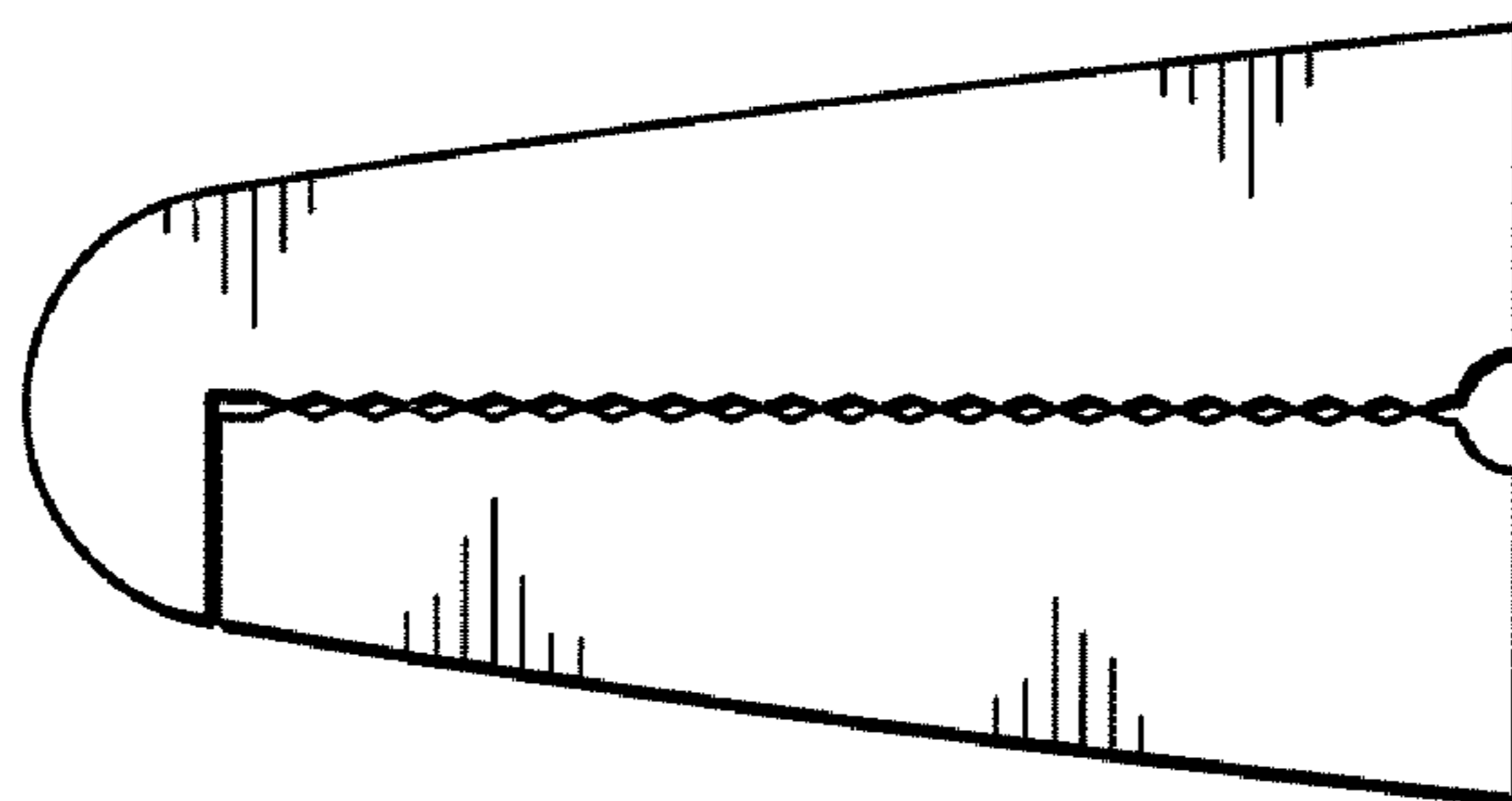
