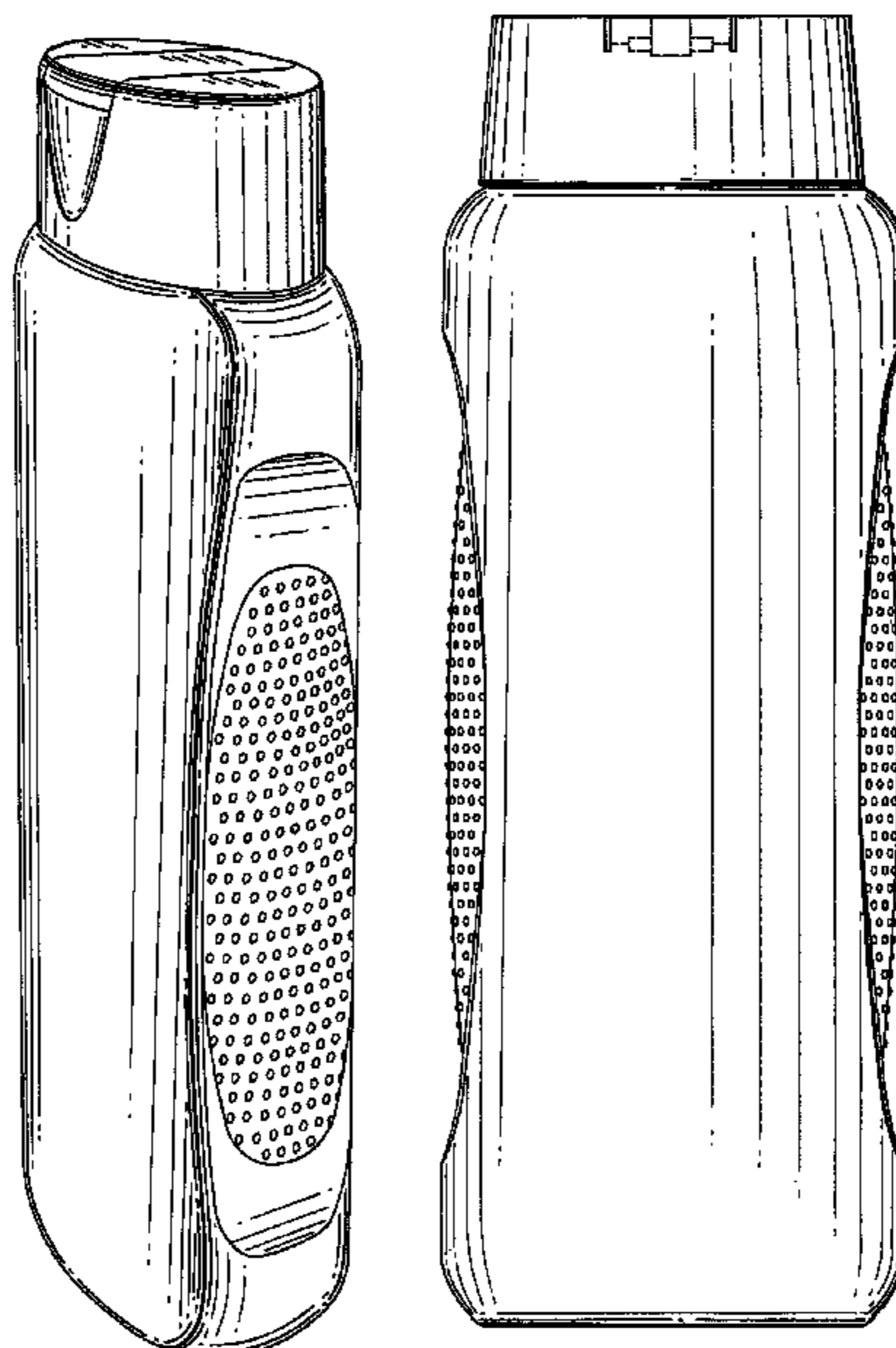
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top, front, and right side perspective view of the invention;  
 FIG. 2 is a front elevation view of FIG. 1.  
 FIG. 3 is a top plan view of FIG. 1.  
 FIG. 4 is a right side elevation view of FIG. 1, the left side being a mirror image thereof.  
 FIG. 5 is a rear elevation view of FIG. 1; and,  
 FIG. 6 is a bottom plan view of FIG. 1.  
 The broken line showing of a cap hinge is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

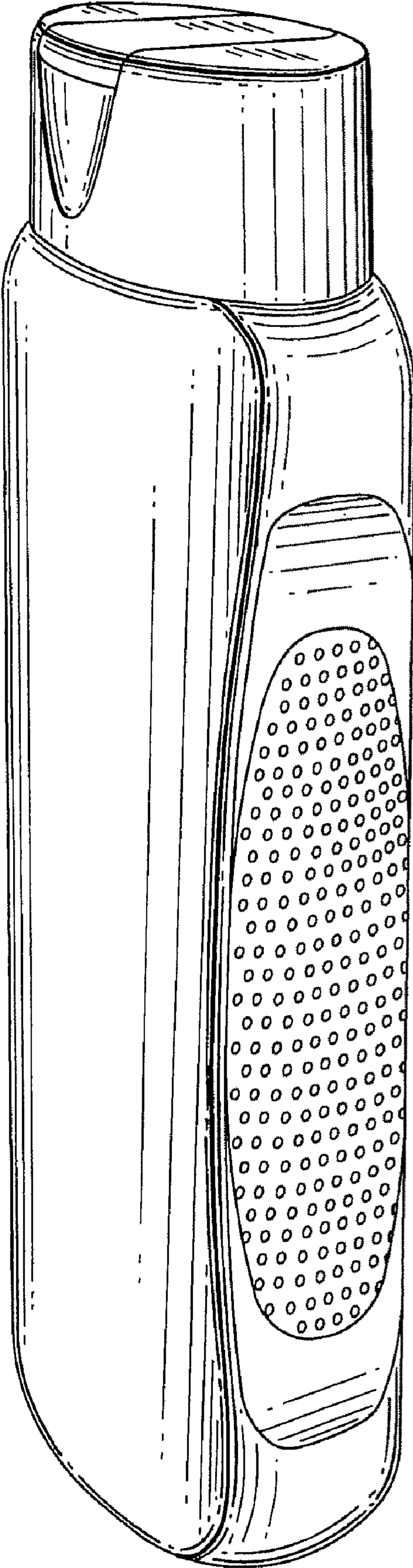

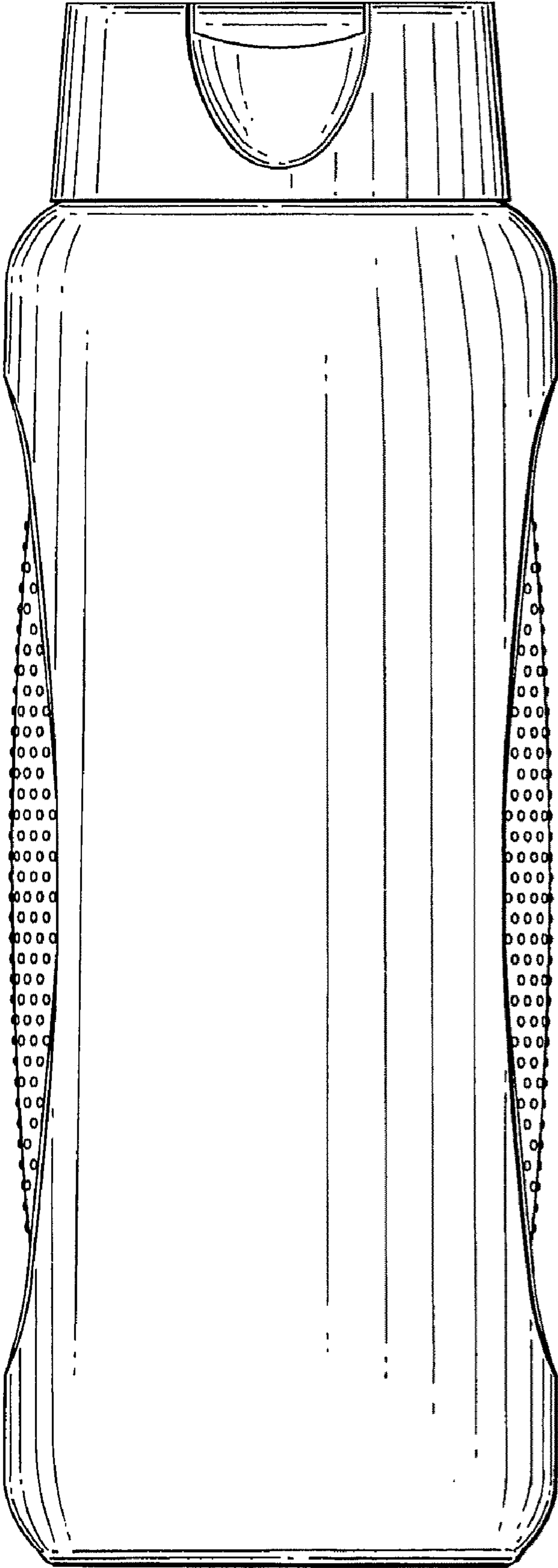
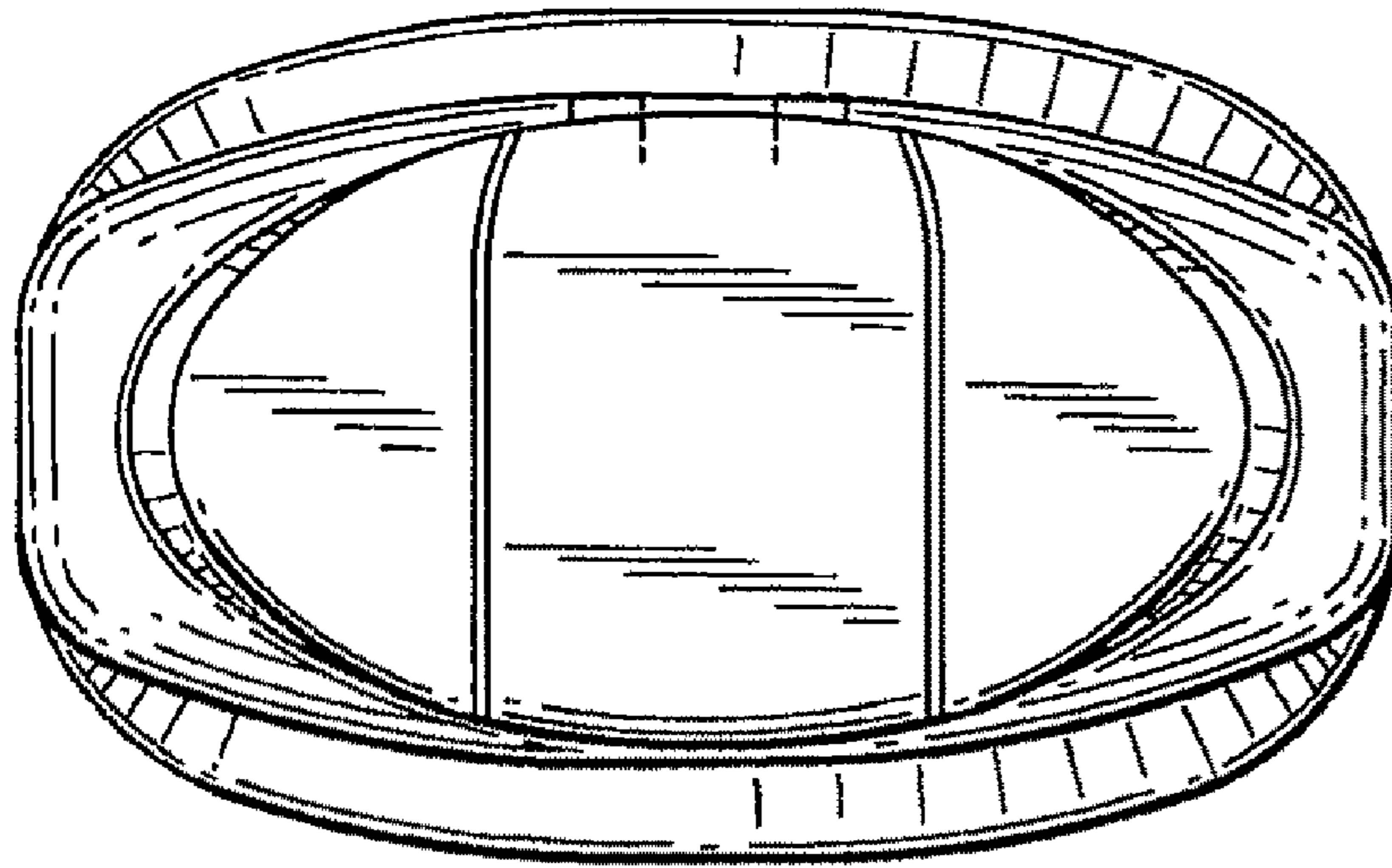
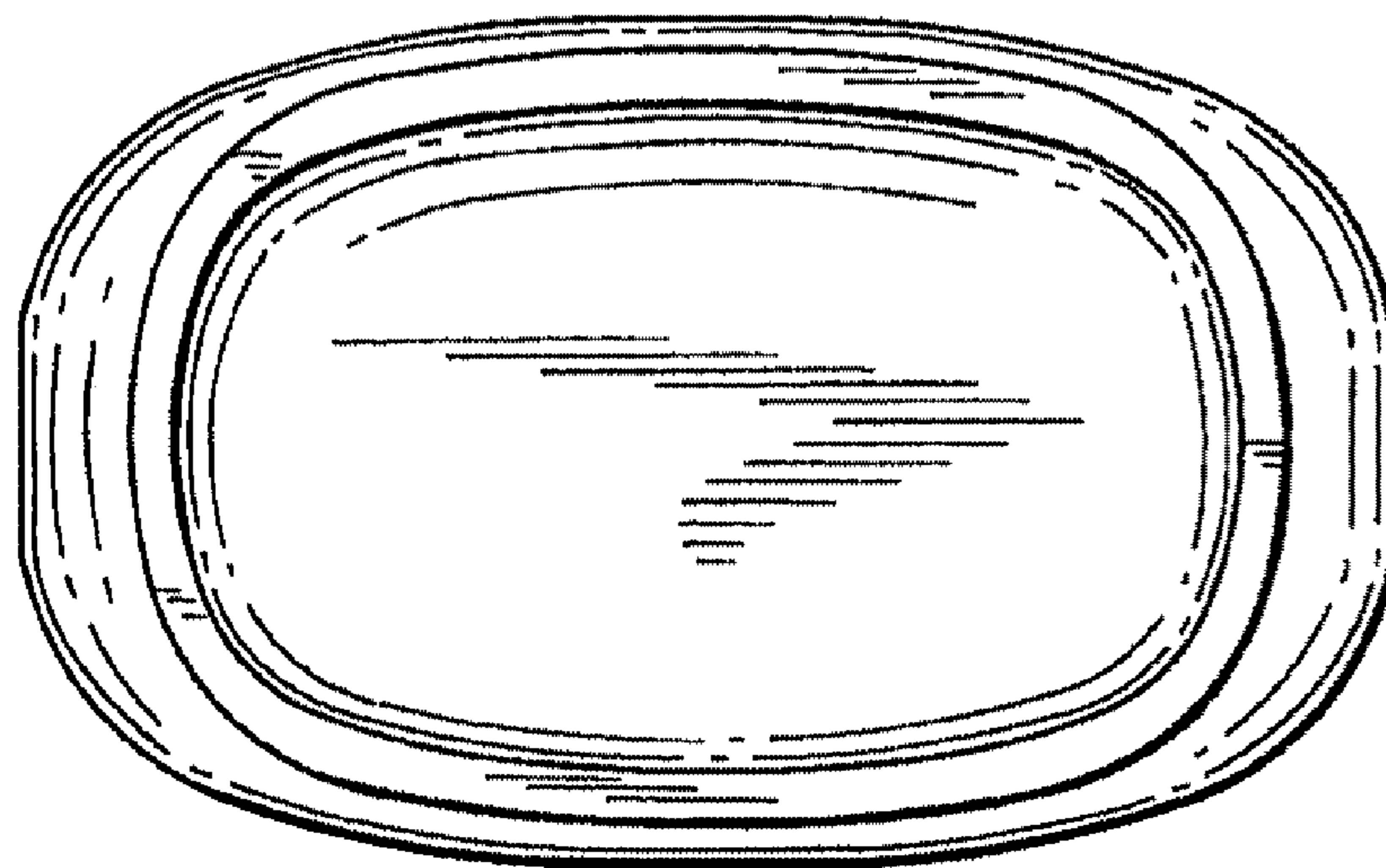

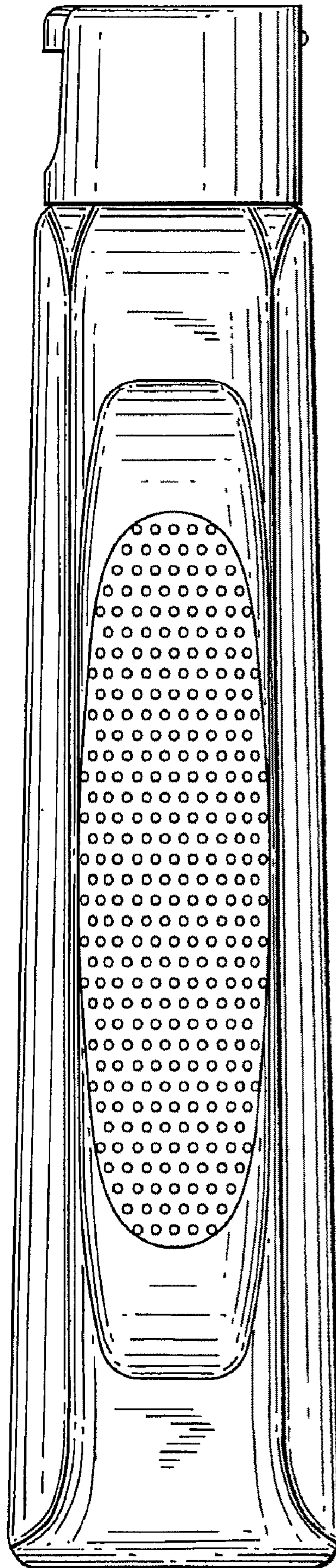

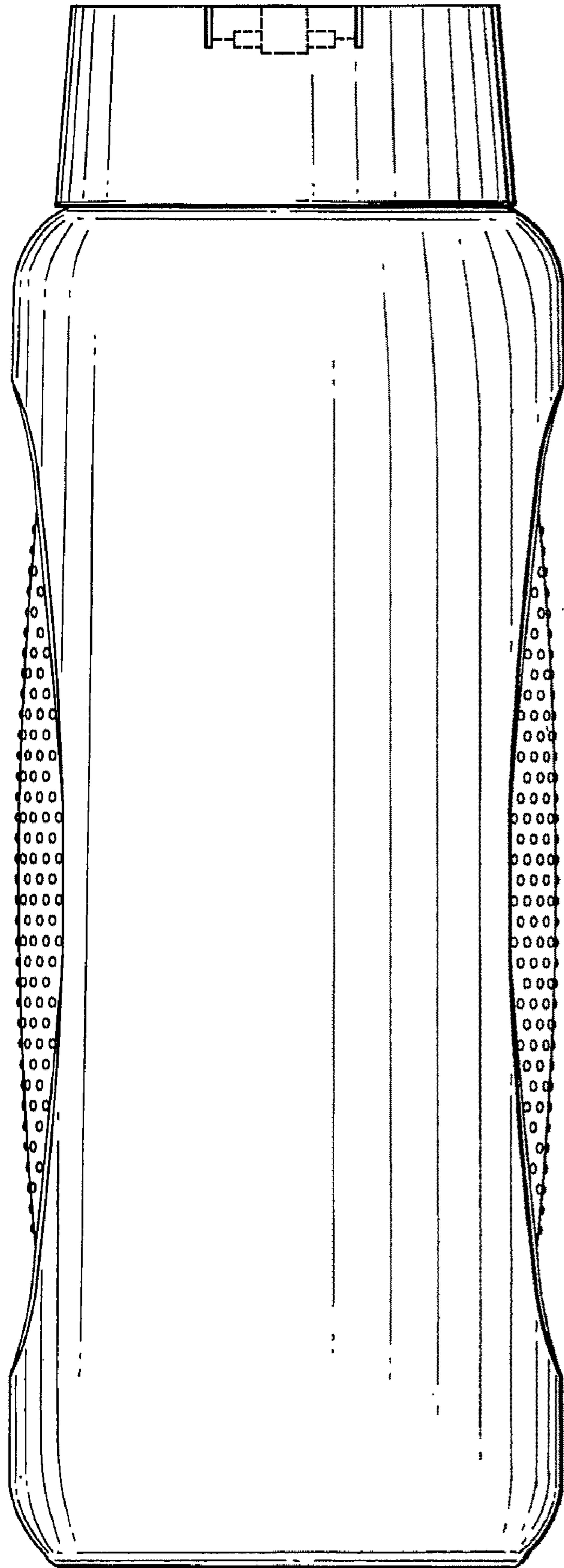
